FIG. 2 is a perspective view of the truck toolbox and cooler combination shown in FIG. 1 as viewed from a rear side of the truck toolbox and cooler combination;  
FIG. 3 is a frontal view of the truck toolbox and cooler combination shown in FIG. 1;  
FIG. 4 is a rear view of the truck toolbox and cooler combination shown in FIG. 1;  
FIG. 5 is a top view of the truck toolbox and cooler combination shown in FIG. 3;  
FIG. 6 is a bottom view of the truck toolbox and cooler combination shown in FIG. 3;  
FIG. 7 is a side view as viewed from the right-hand side of the truck toolbox and cooler combination shown in FIG. 3;  
FIG. 8 is a side view as viewed from the left-hand side of the truck toolbox and cooler combination shown in FIG. 3; and,  
FIG. 9 is a perspective view of the truck toolbox and cooler combination shown in FIG. 1 as viewed with the primary toolbox lid in an open position, and the secondary cooler lid in an open position.  
The broken lines shown in the drawings illustrate portions of the truck toolbox and cooler combination that forms no part of the claimed design.

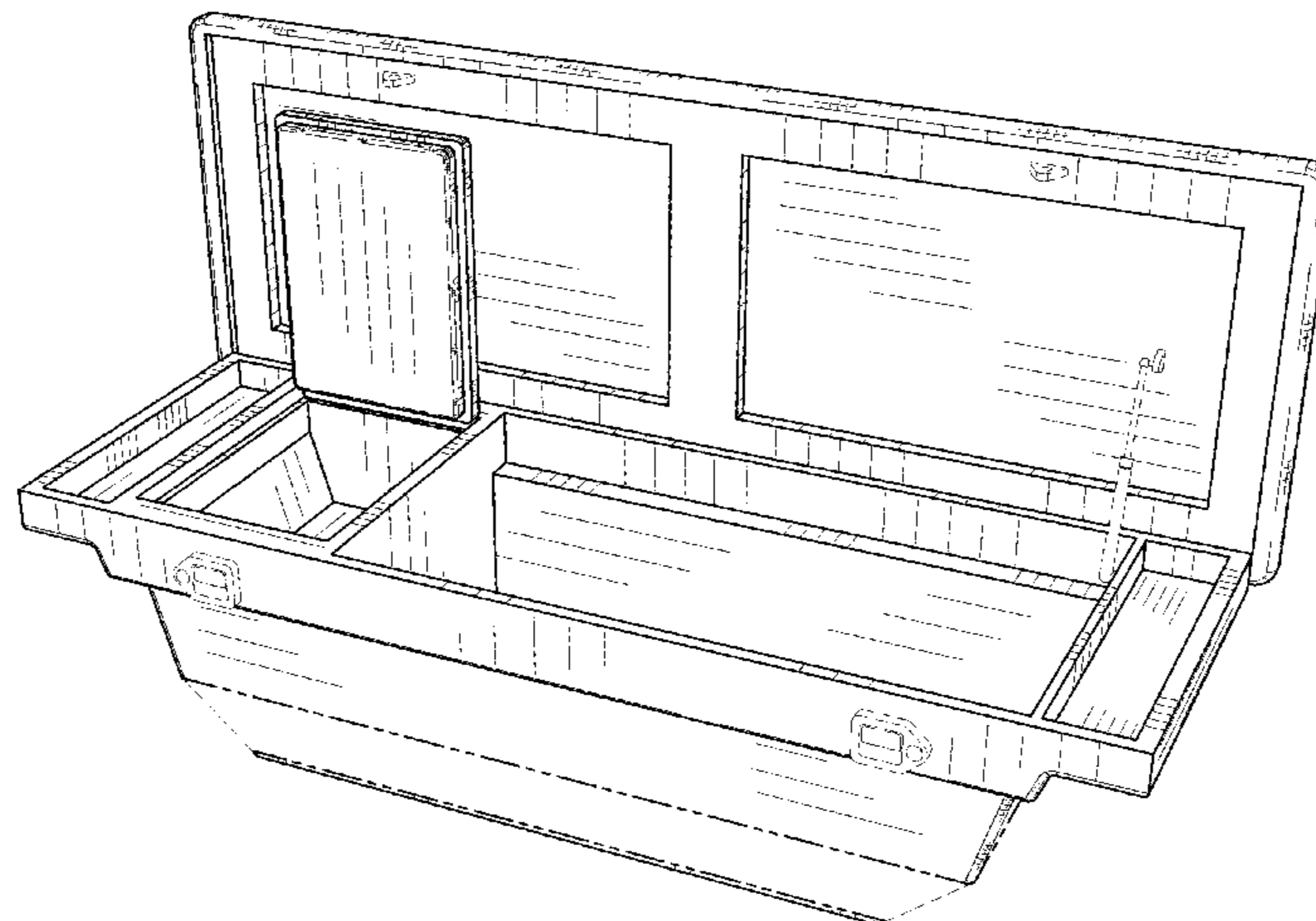

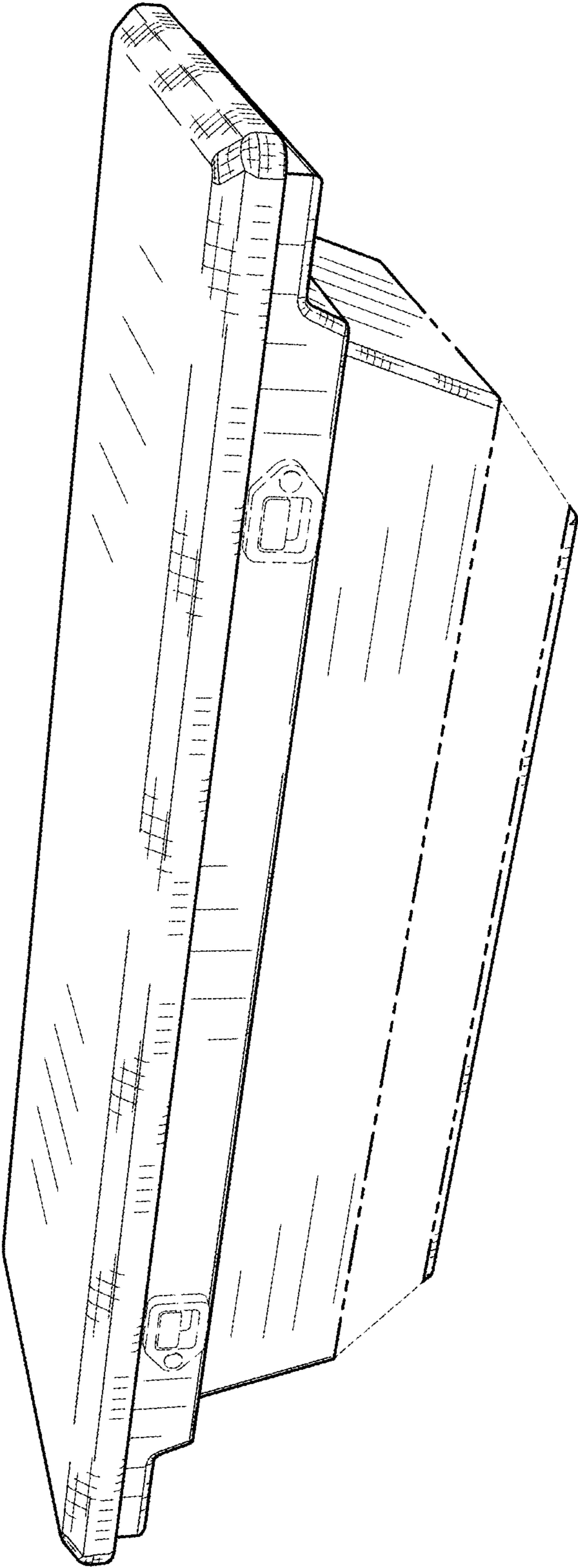

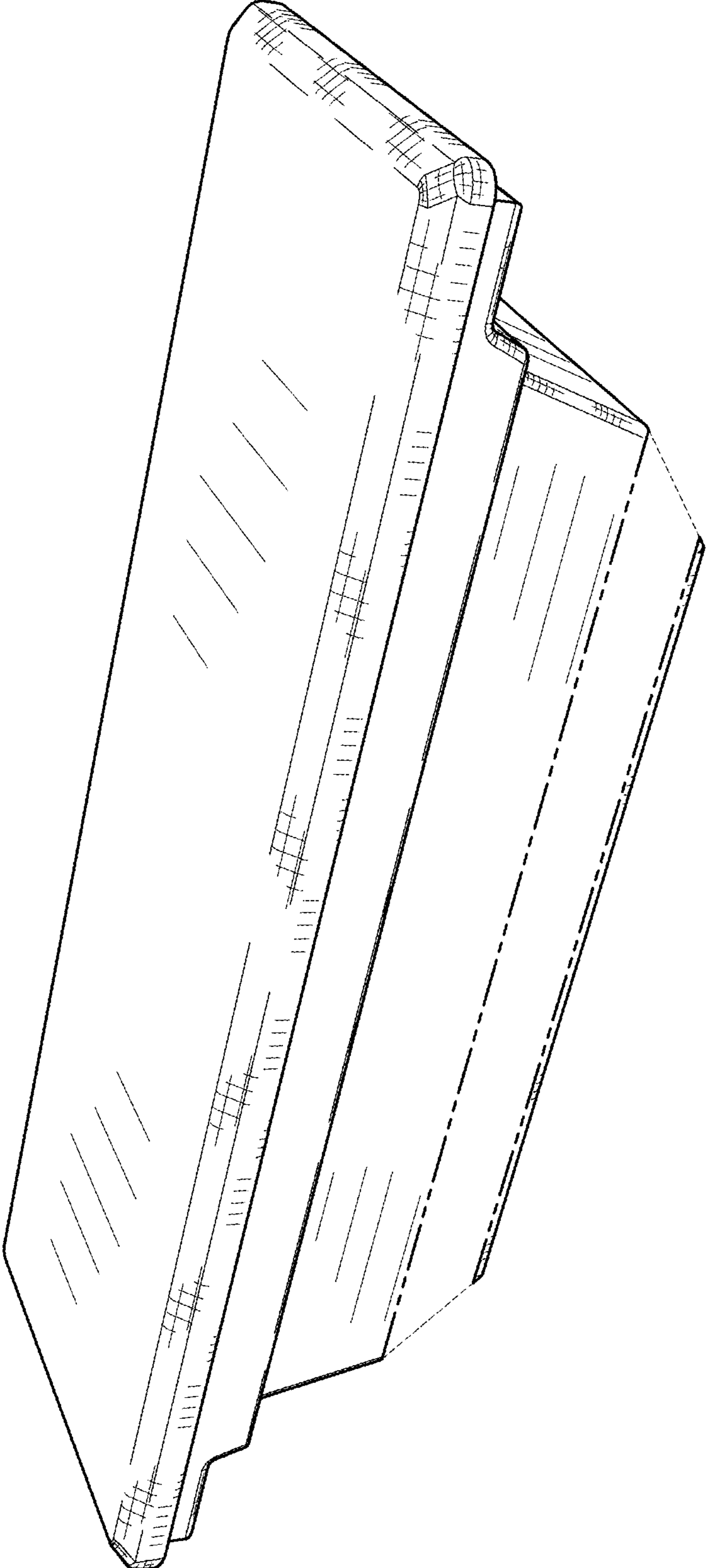

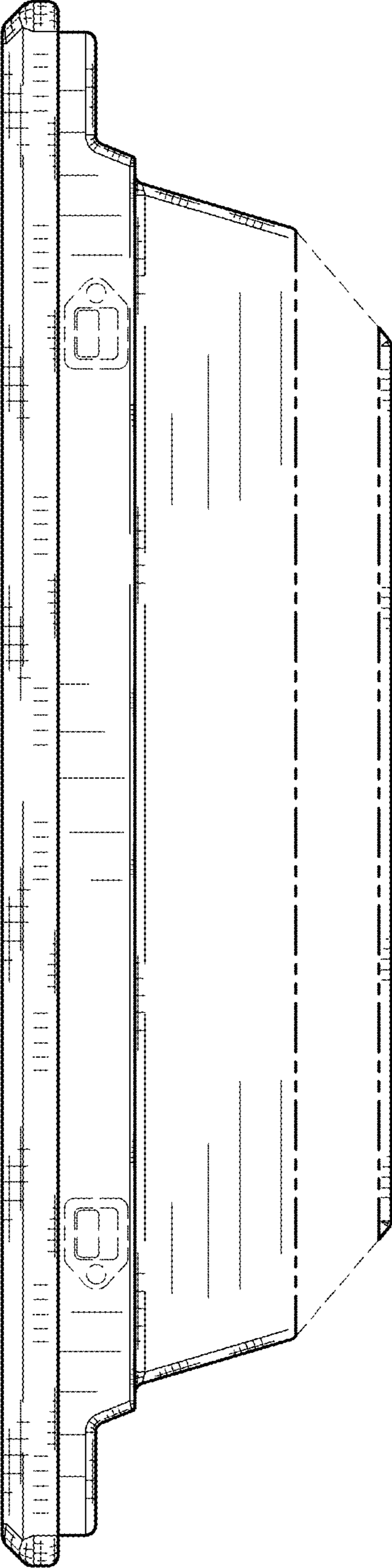

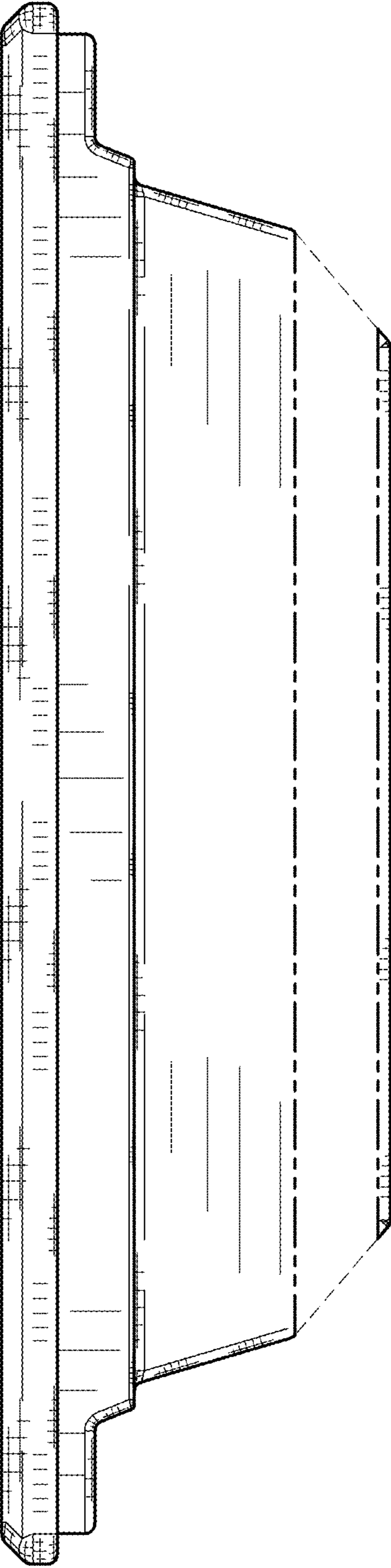

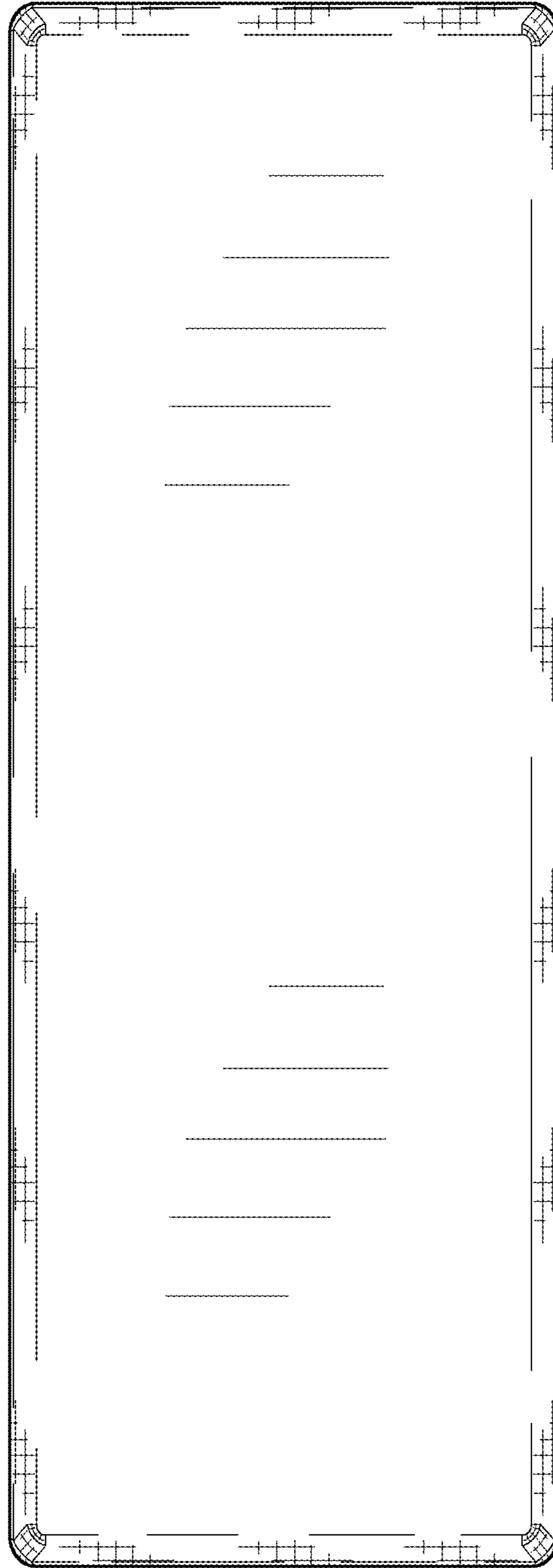

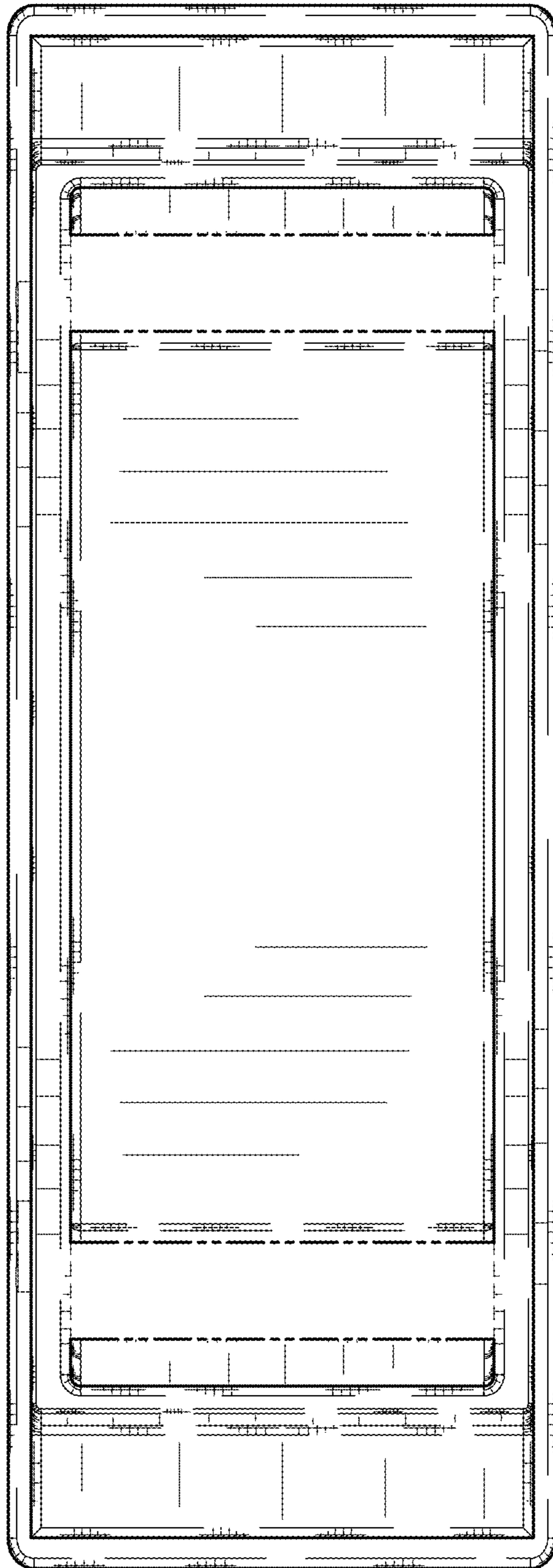

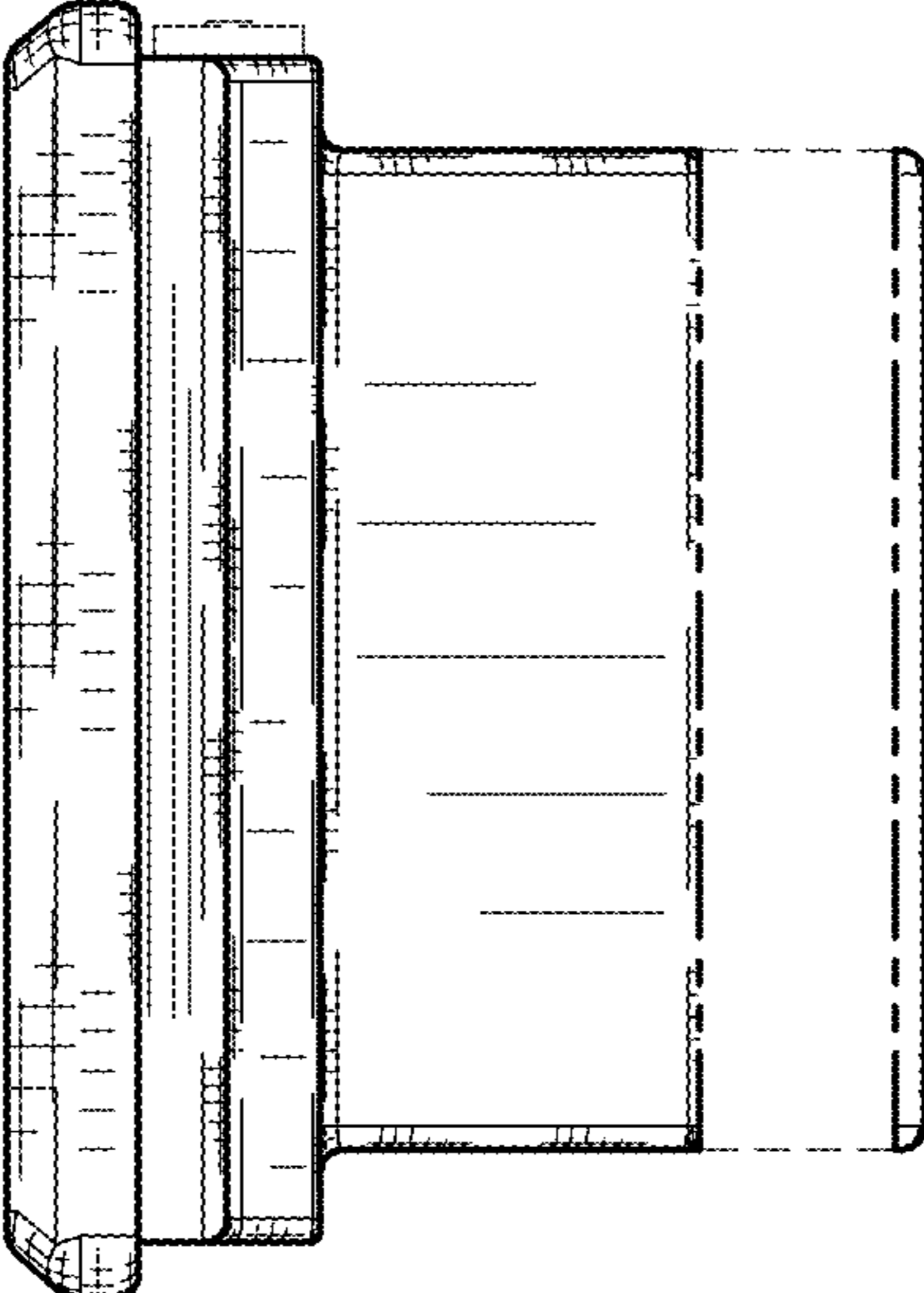

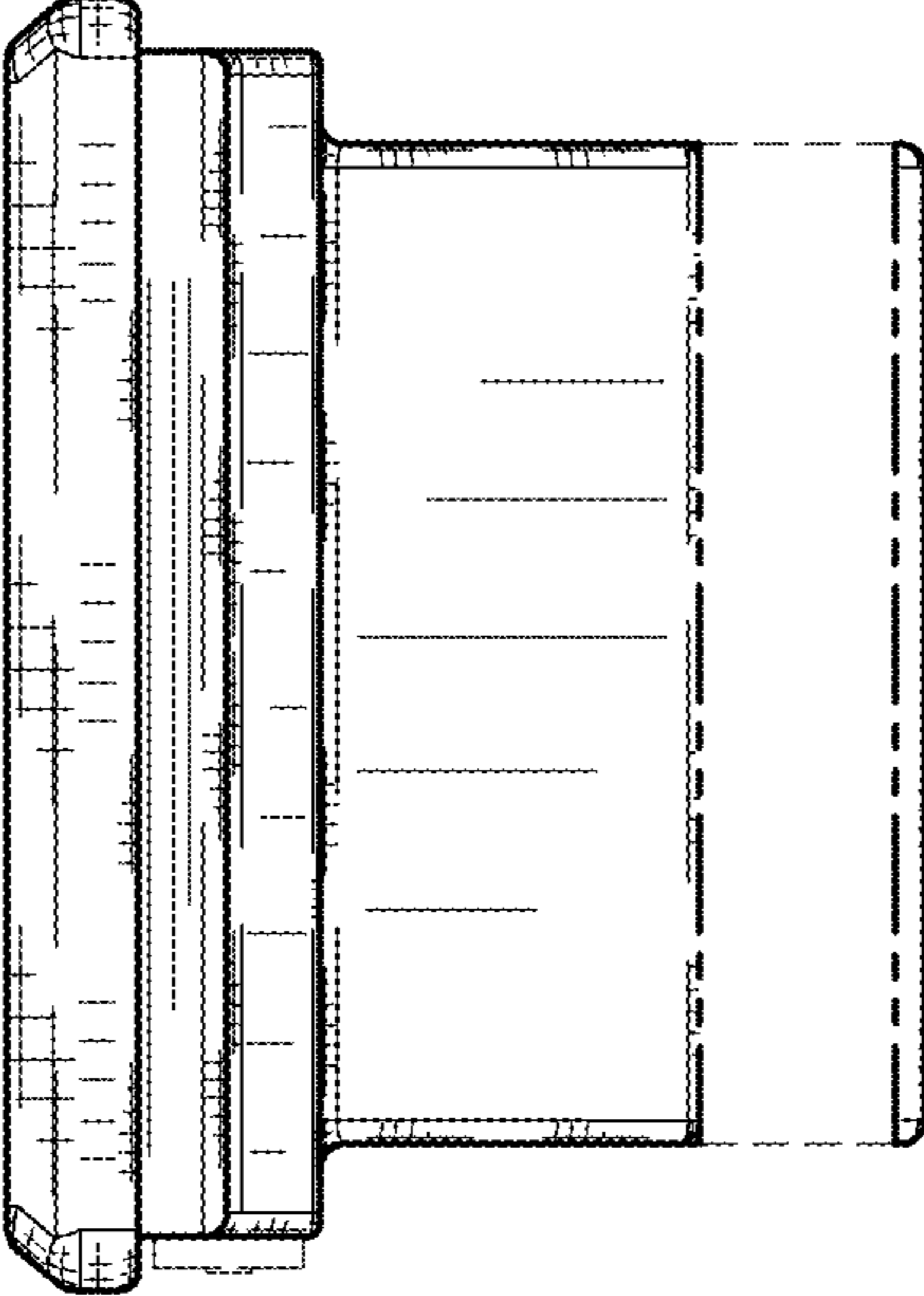

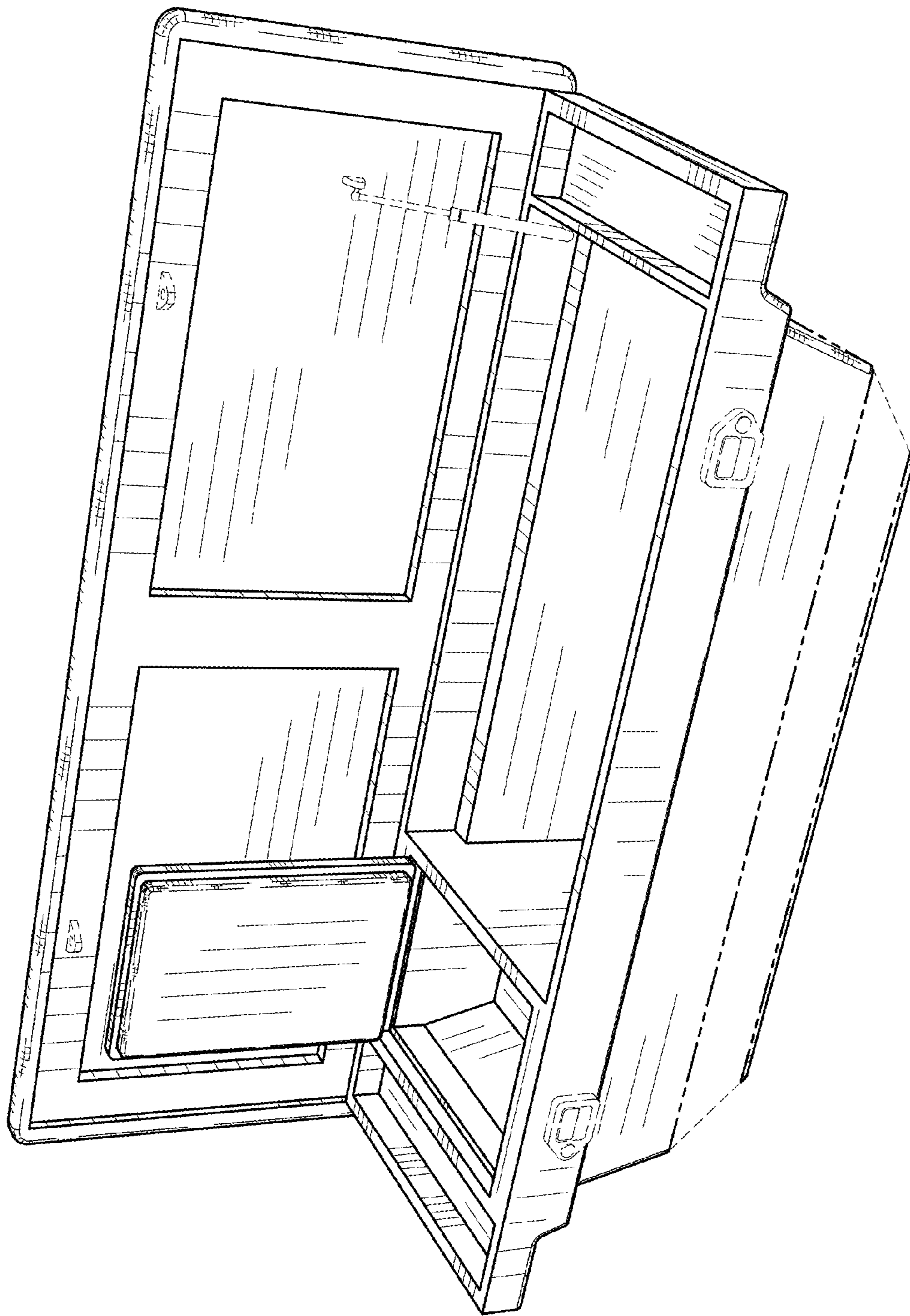
