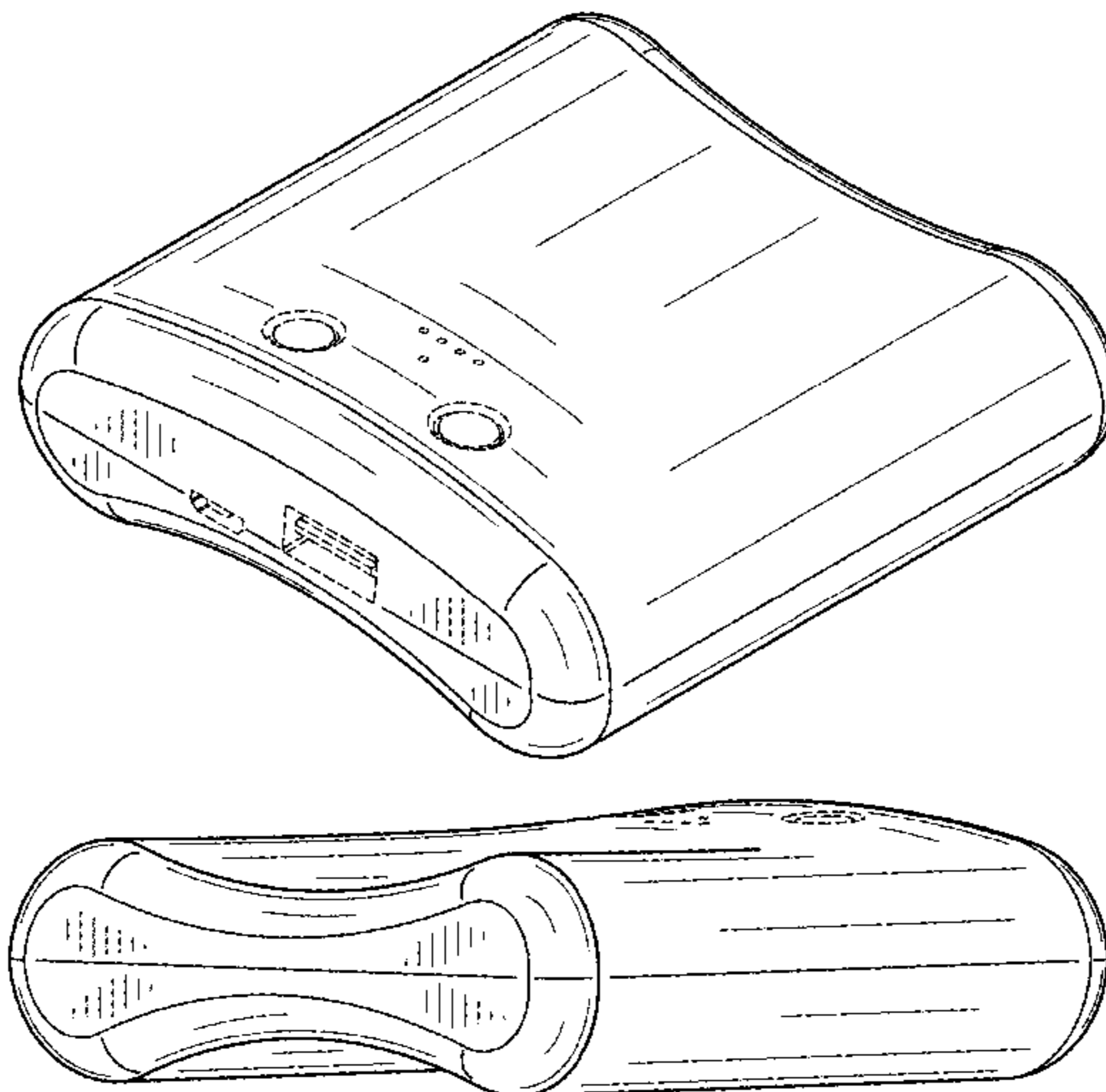
The ornamental design for a battery, as shown and described.

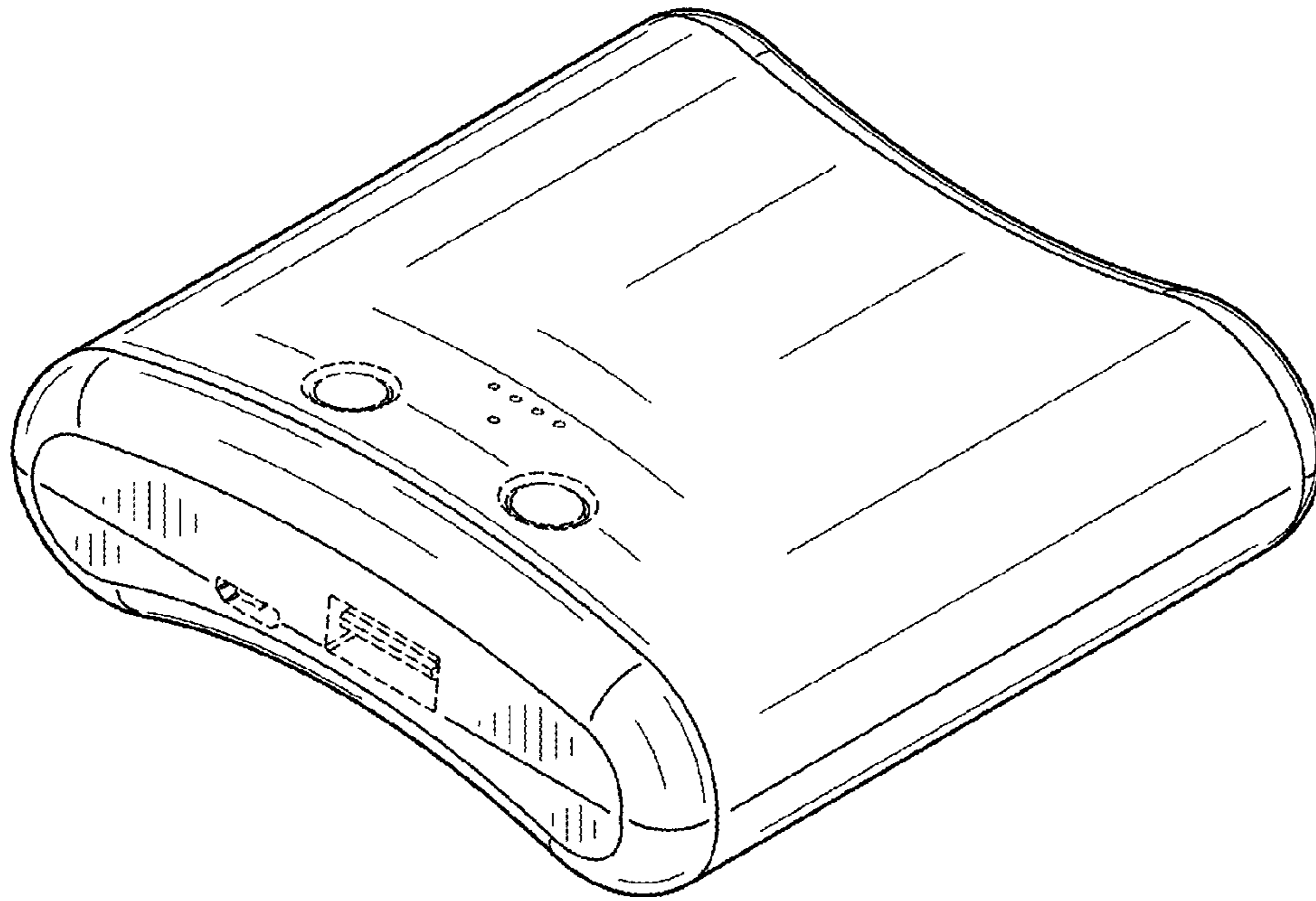

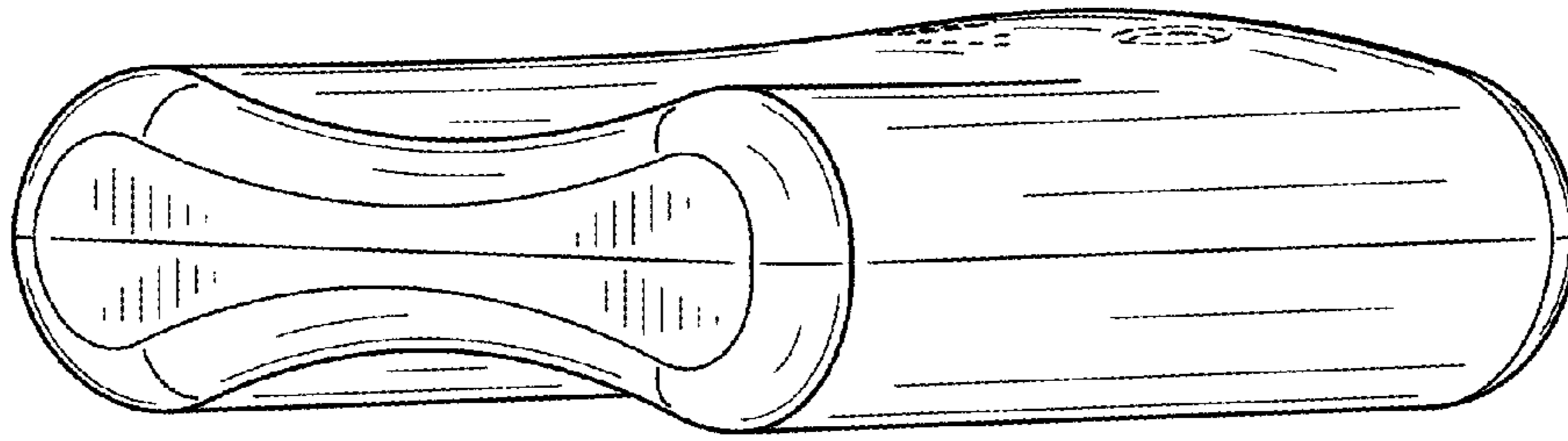

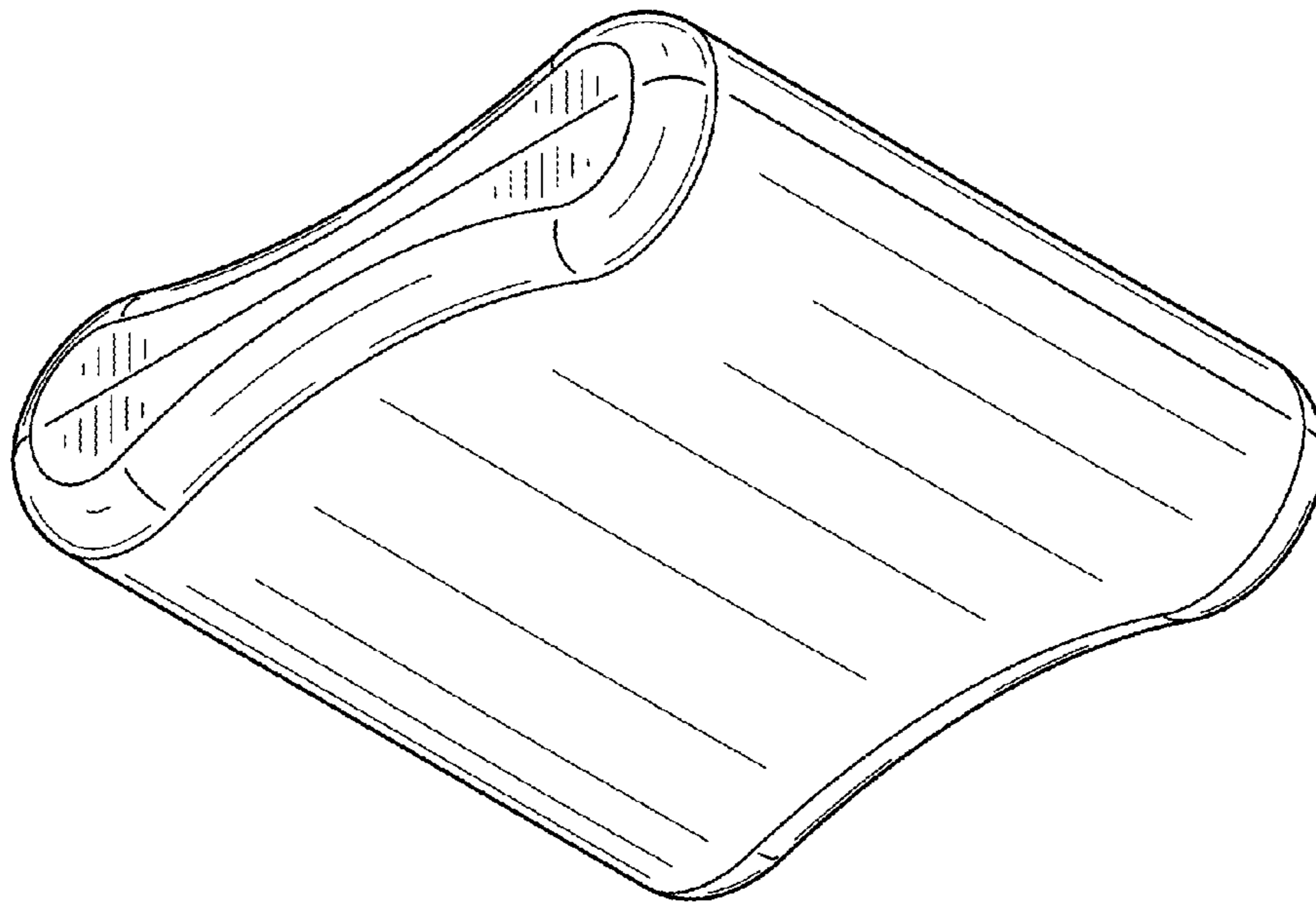

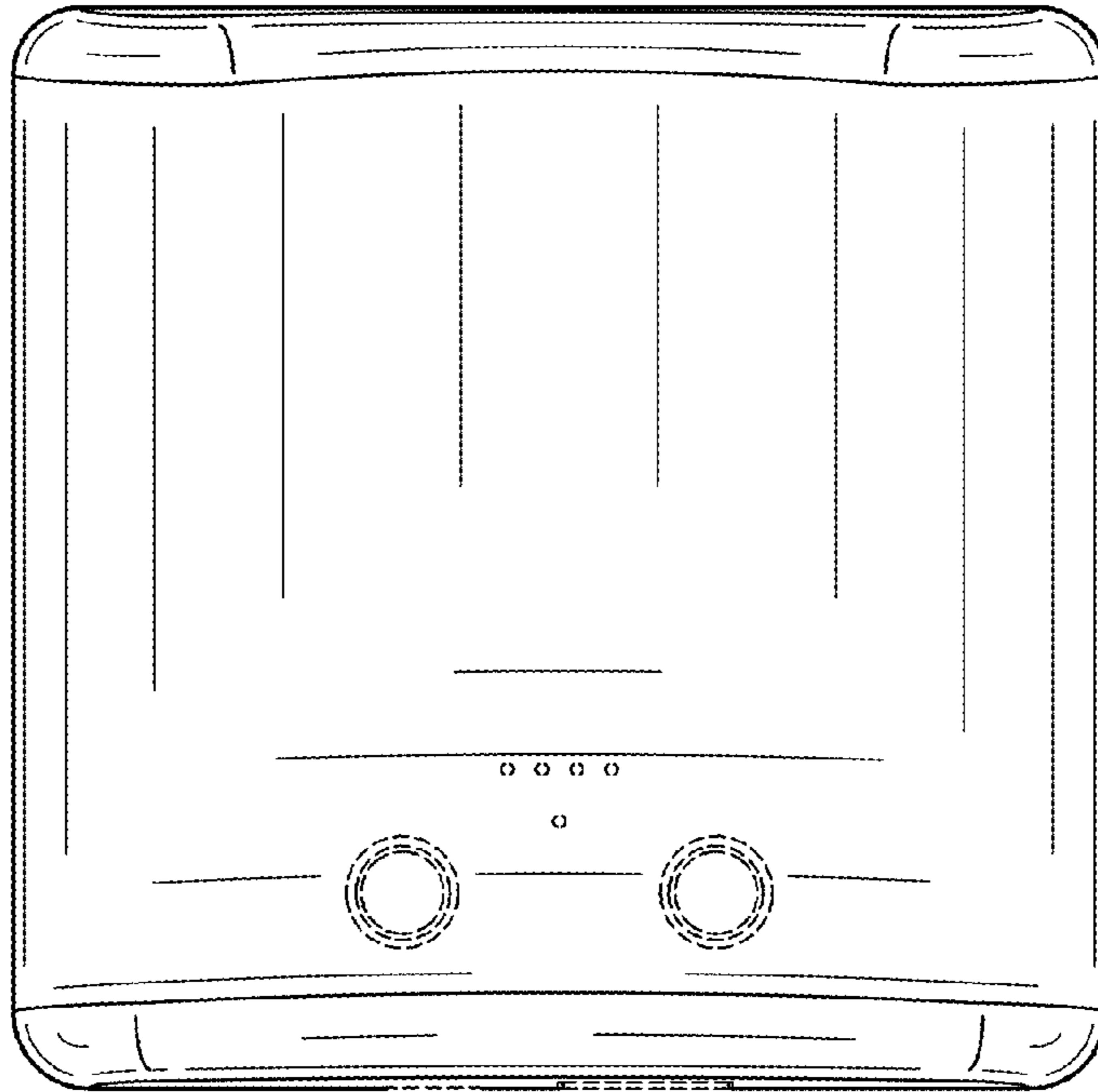

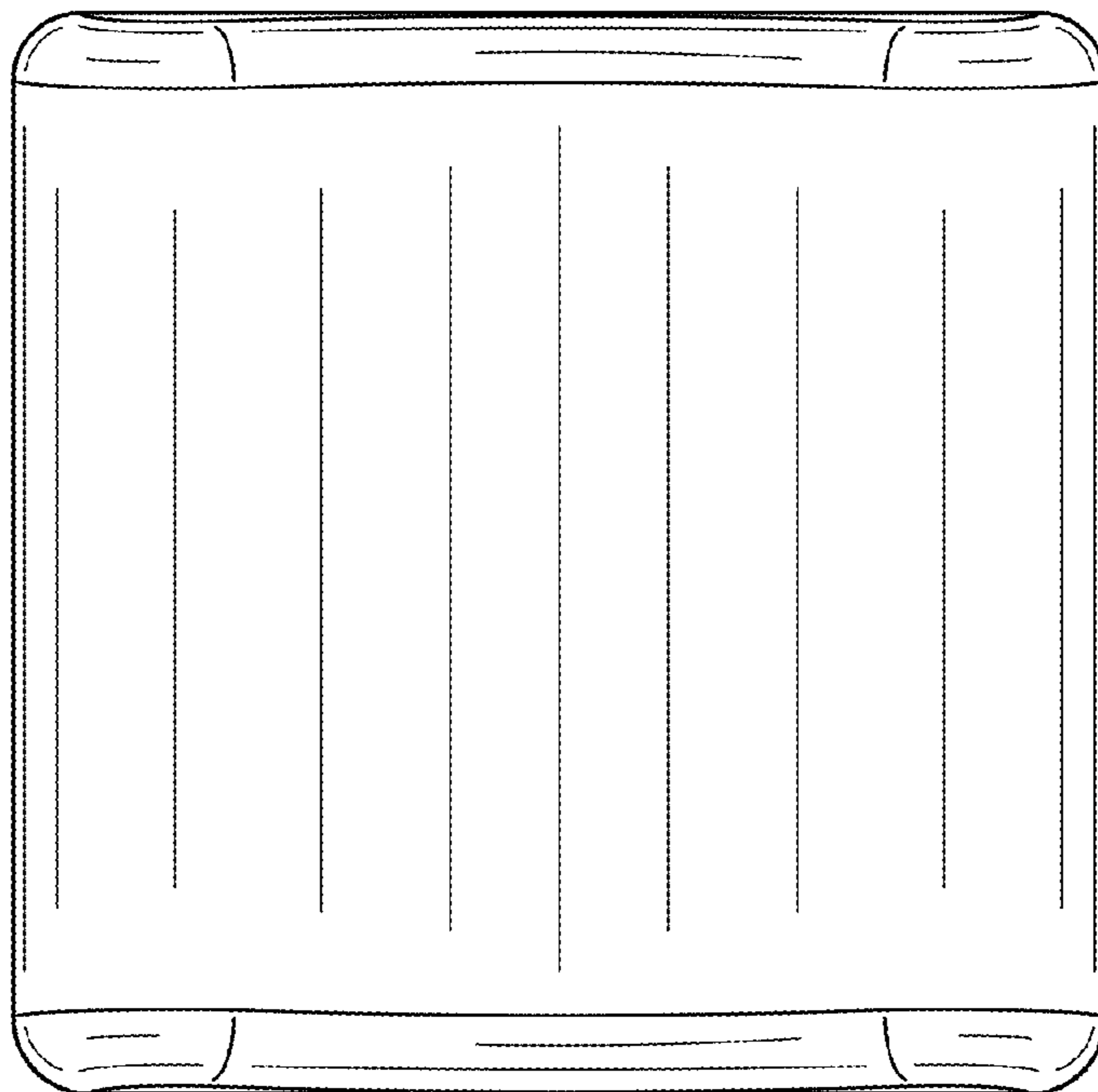

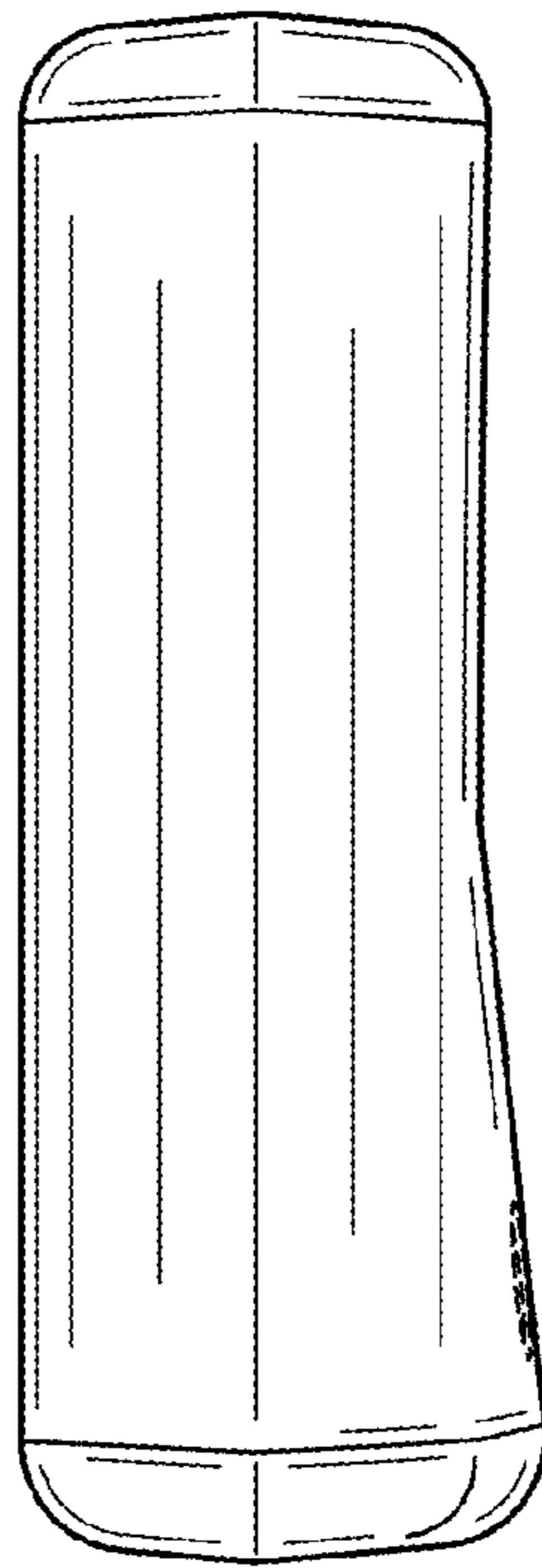

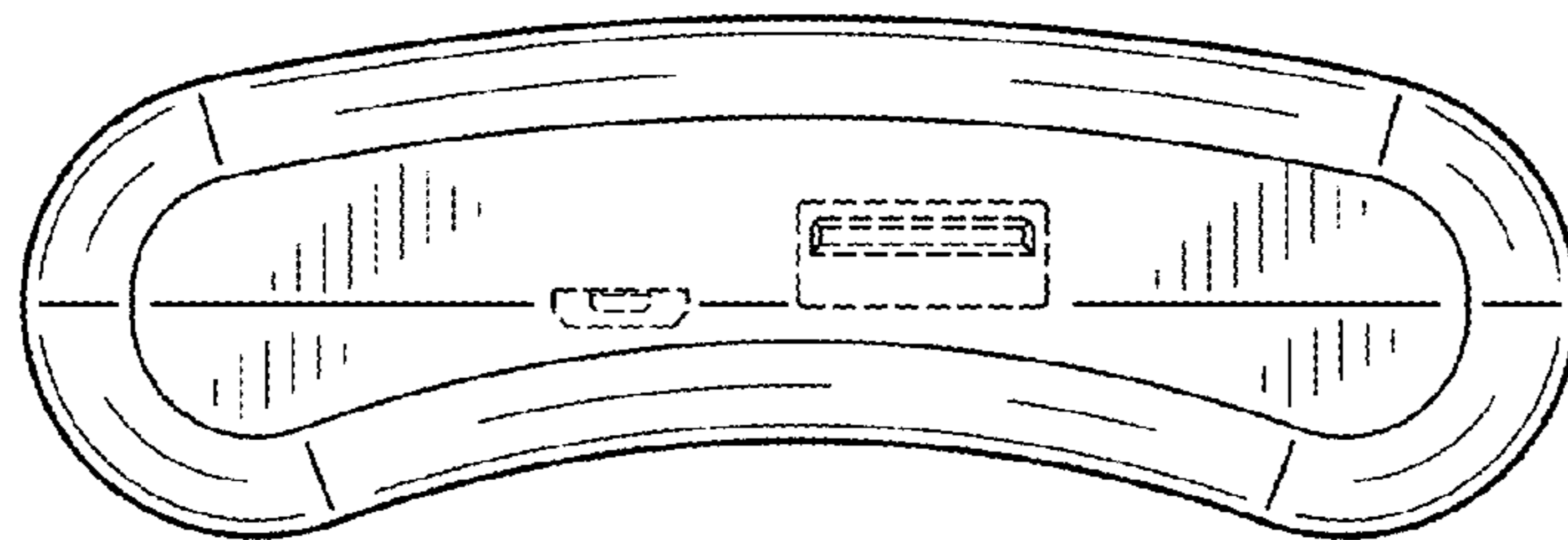

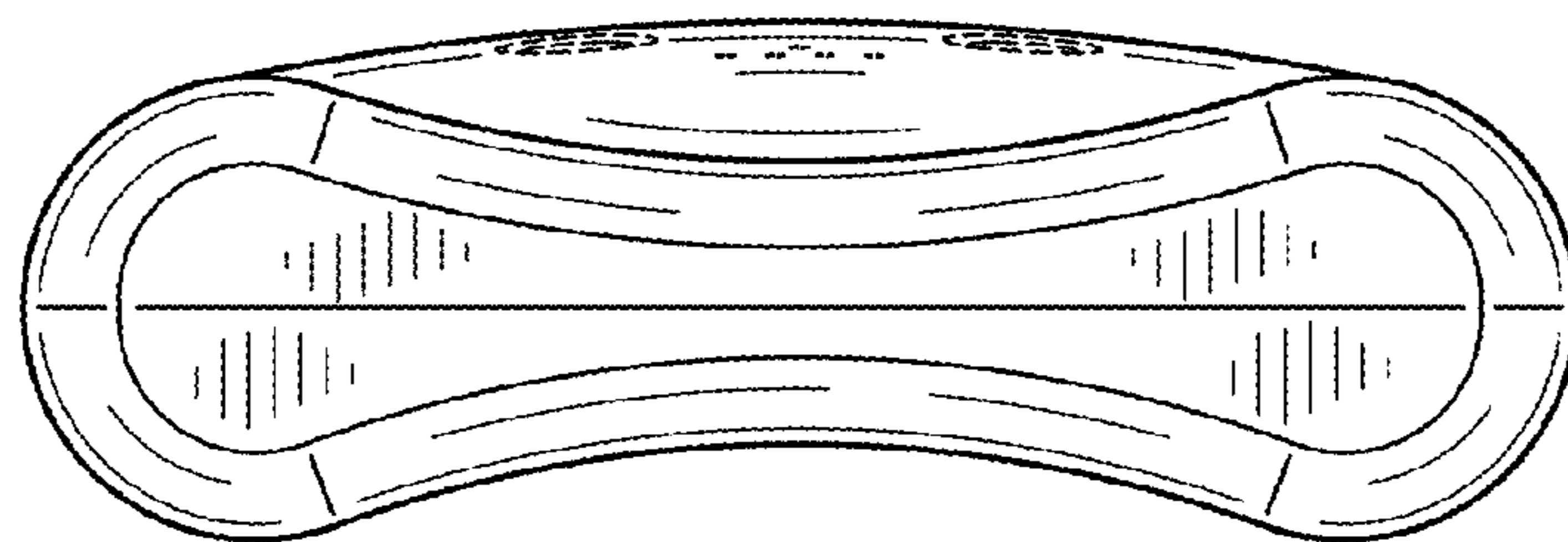

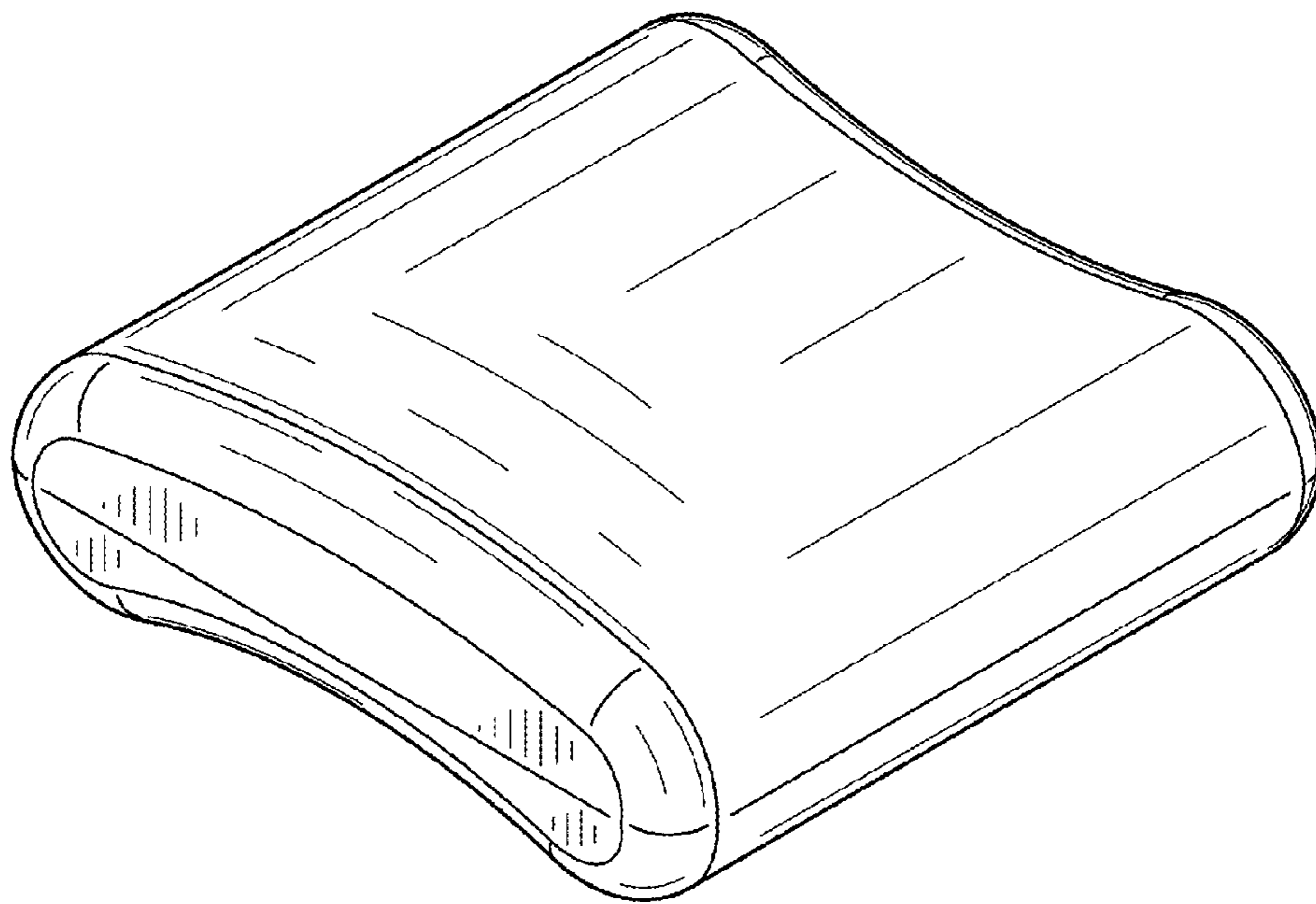

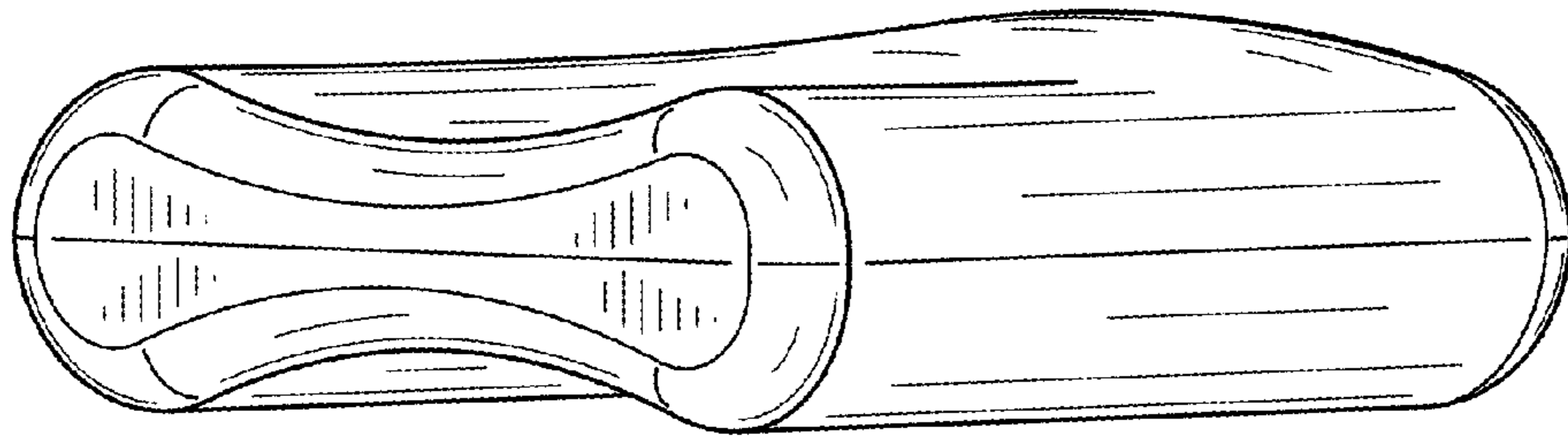

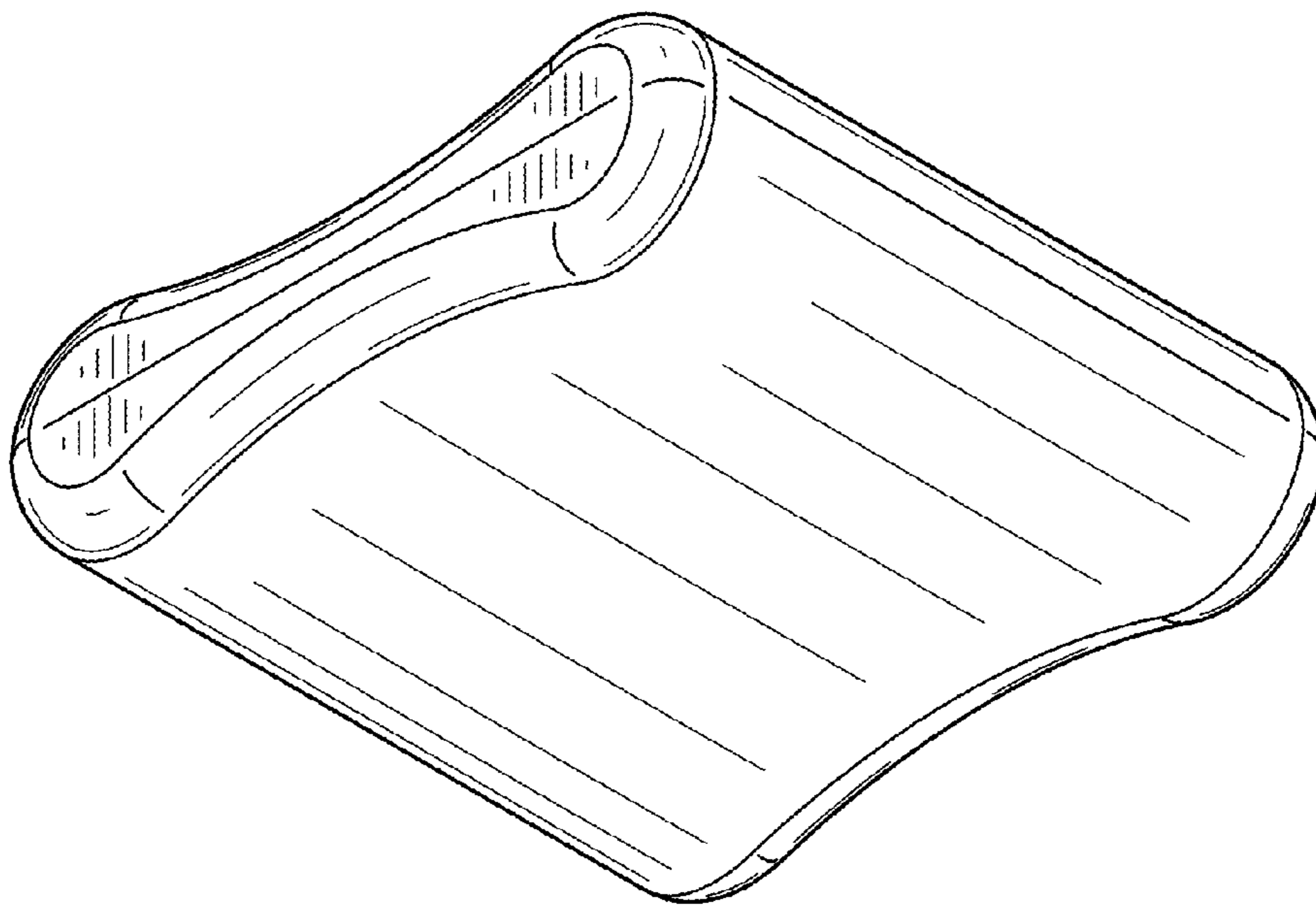

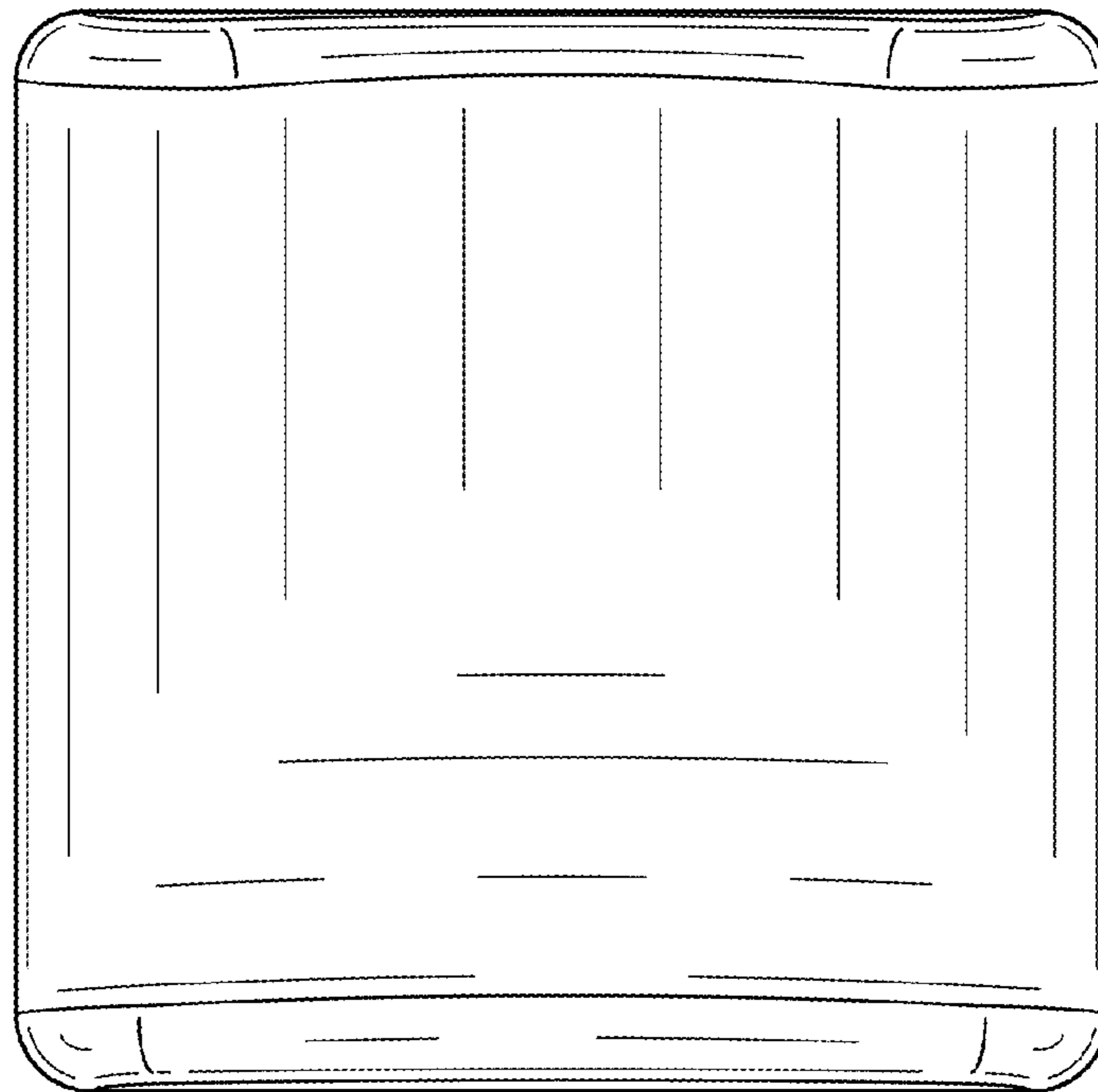

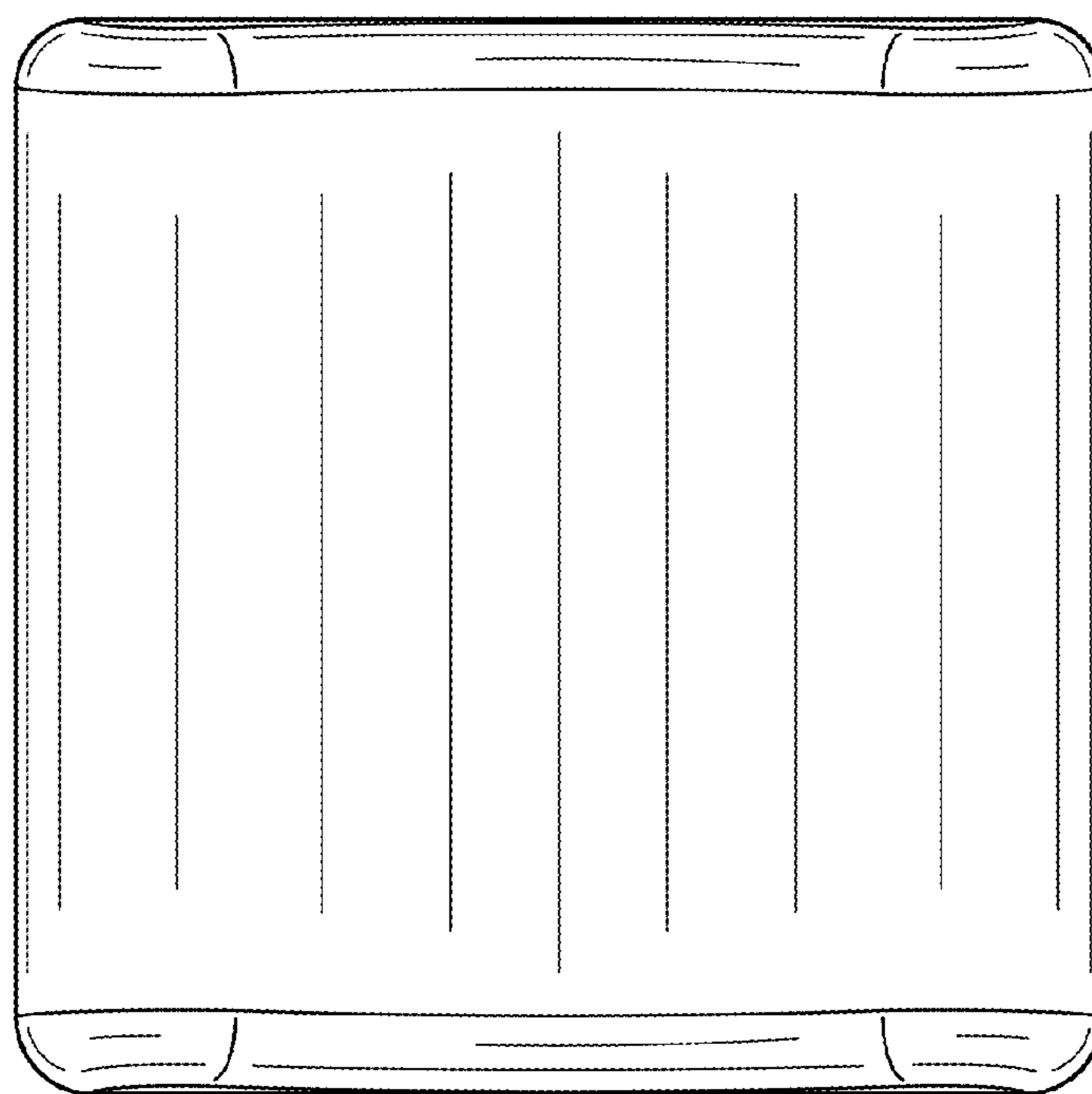

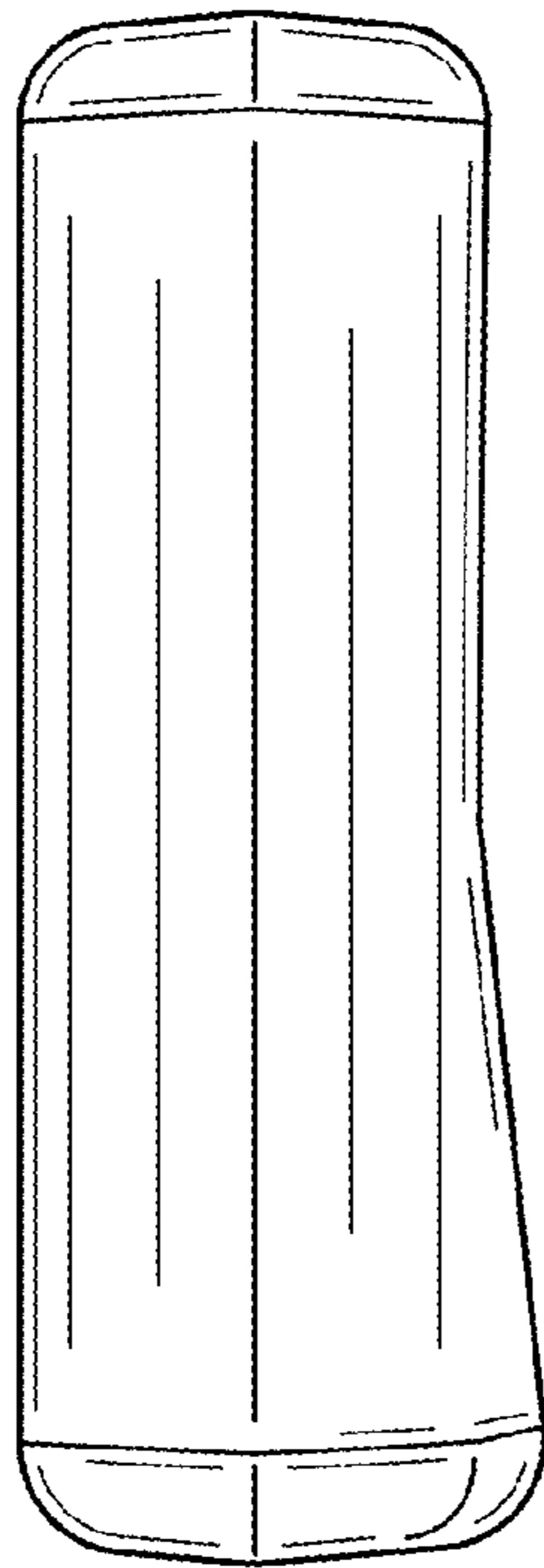

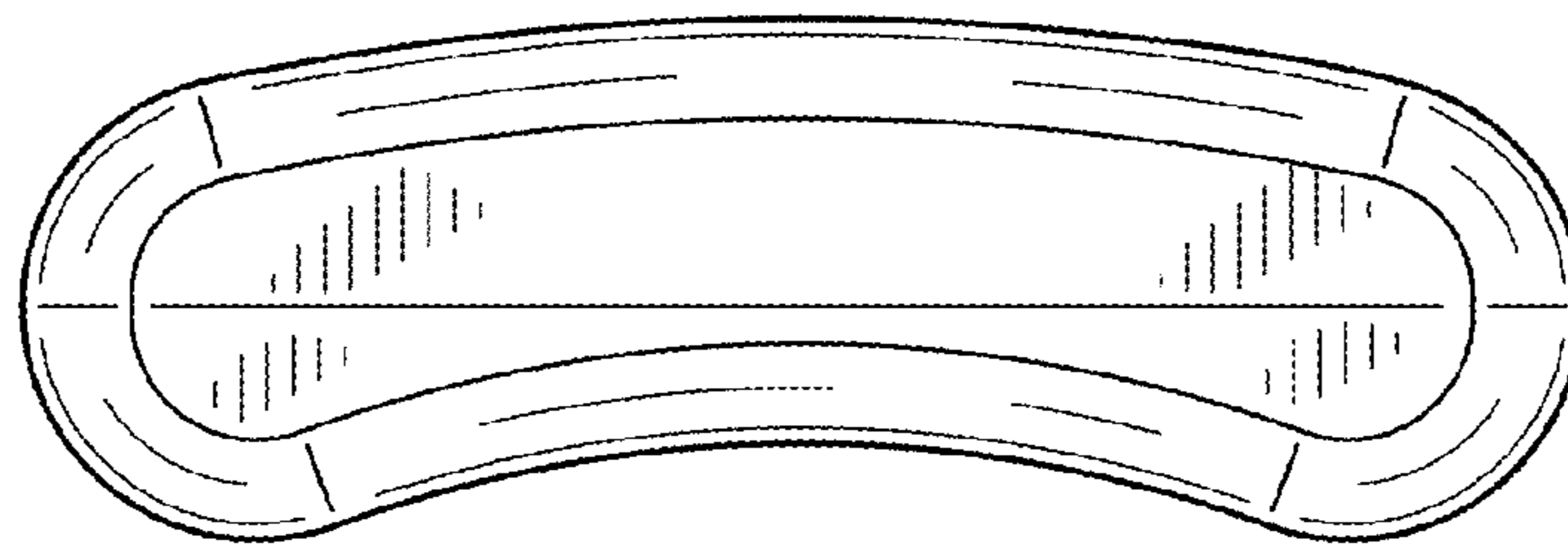

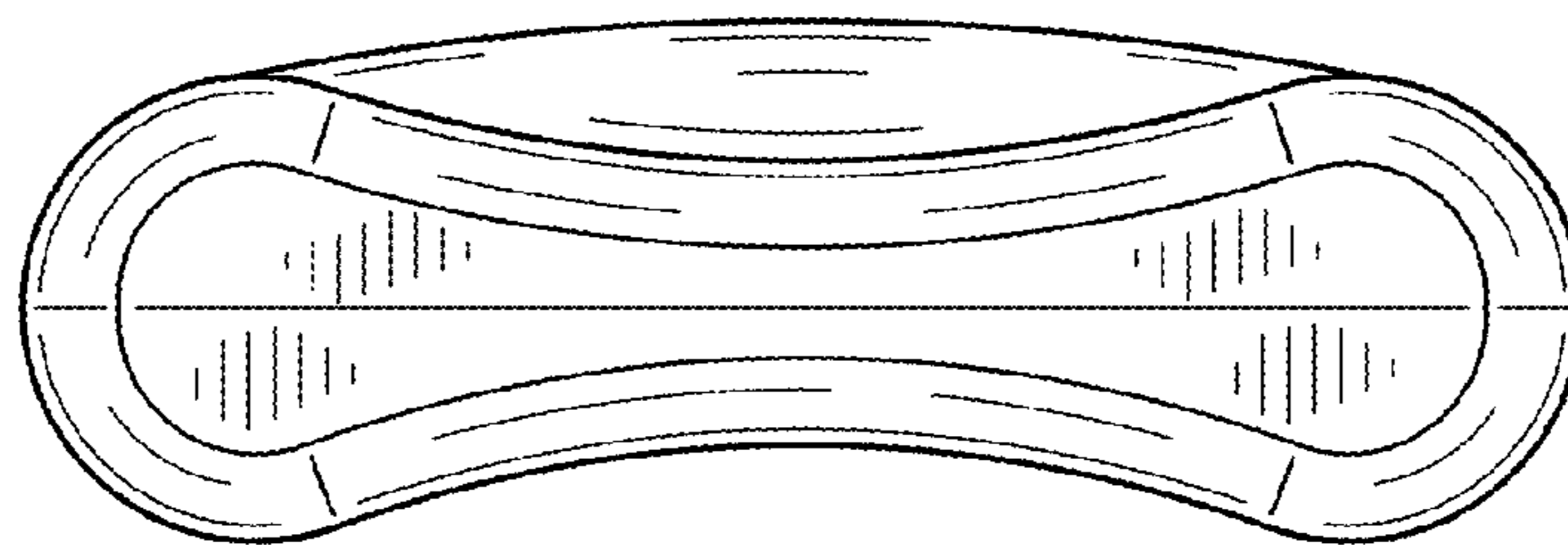
