(57) **CLAIM**

The ornamental design for a triple foot pedal control, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the triple foot pedal control showing my new design;
FIG. 2 is a front view of the triple foot pedal control of FIG. 1;
FIG. 3 is a rear view of the triple foot pedal control of FIG. 1;
FIG. 4 is a left side view of the triple foot pedal control of FIG. 1;
FIG. 5 is a right side view of the triple foot pedal control of FIG. 1;
FIG. 6 is a top view of the triple foot pedal control of FIG. 1; and,
FIG. 7 is a bottom view of the triple foot pedal control of FIG. 1.
The broken lines in FIG. 7 are illustrative of environmental structure only and form no part of the claimed design.

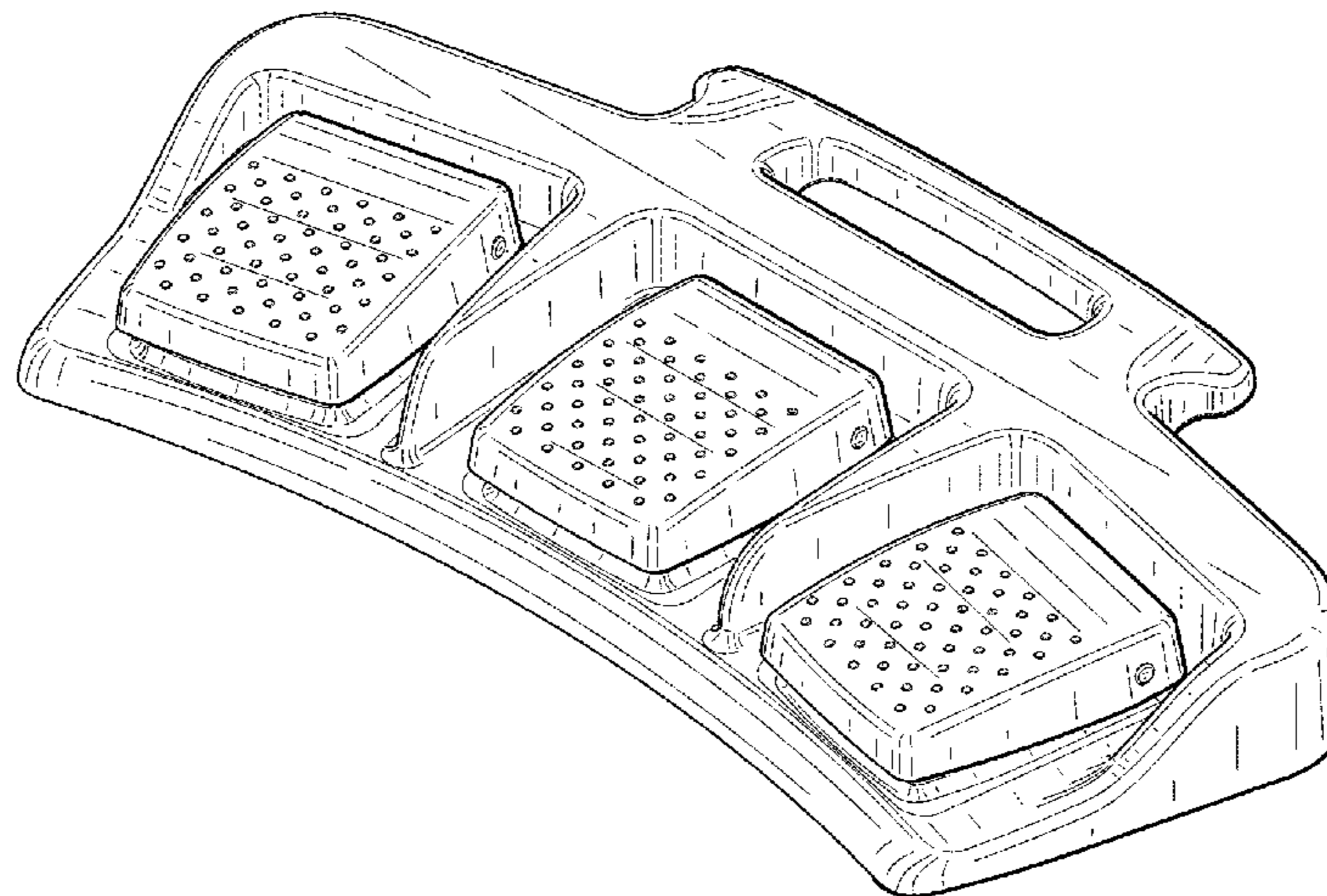

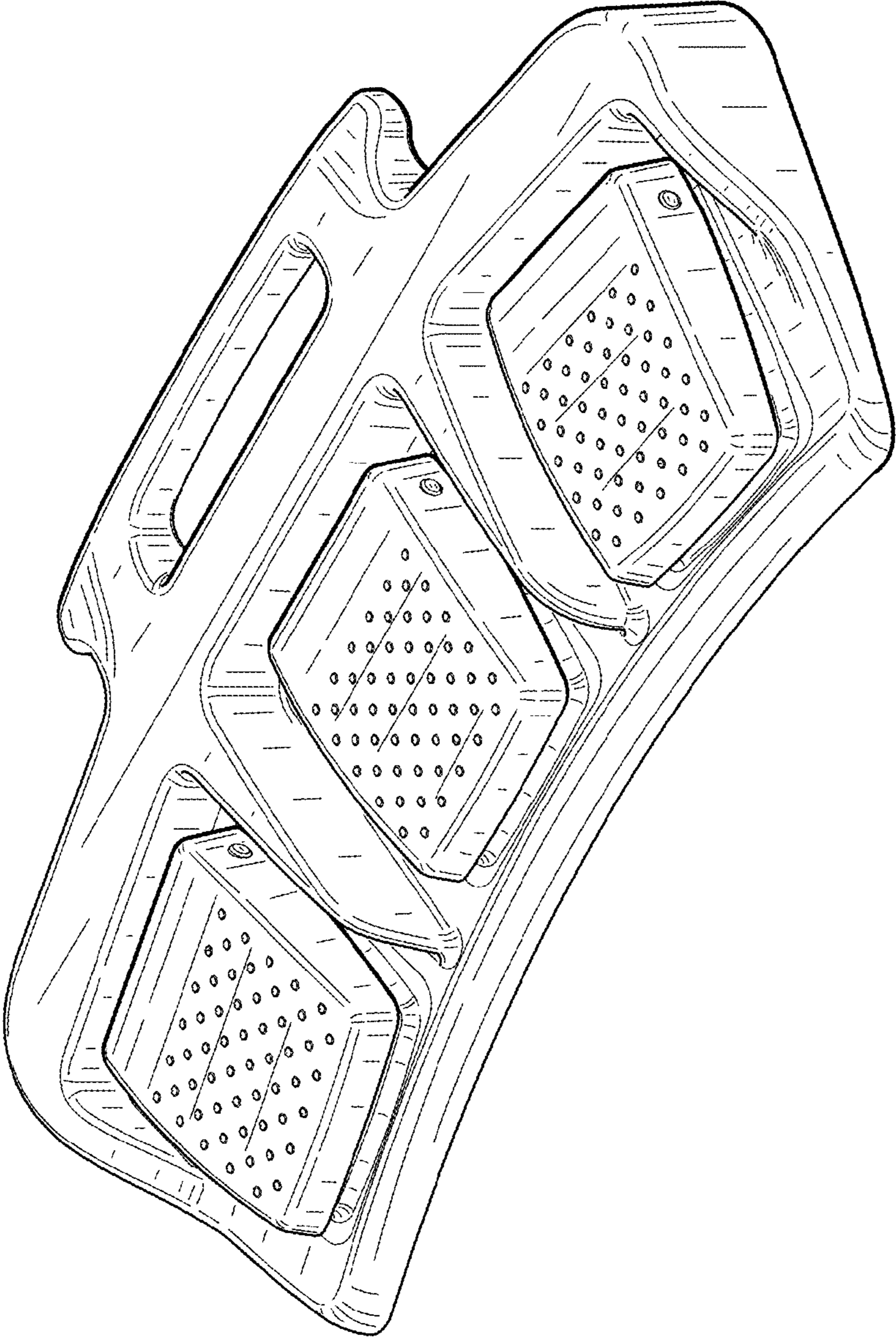

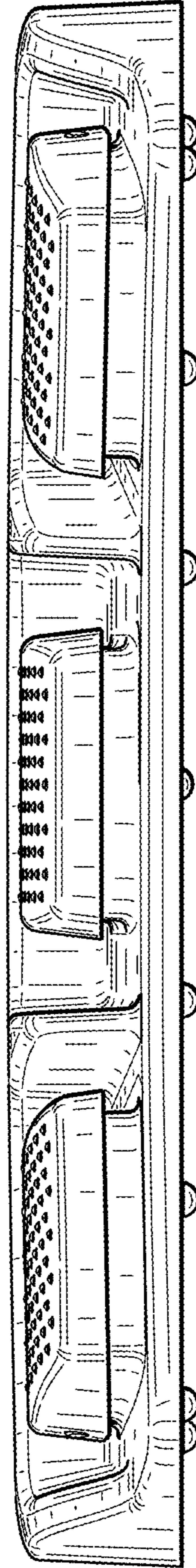

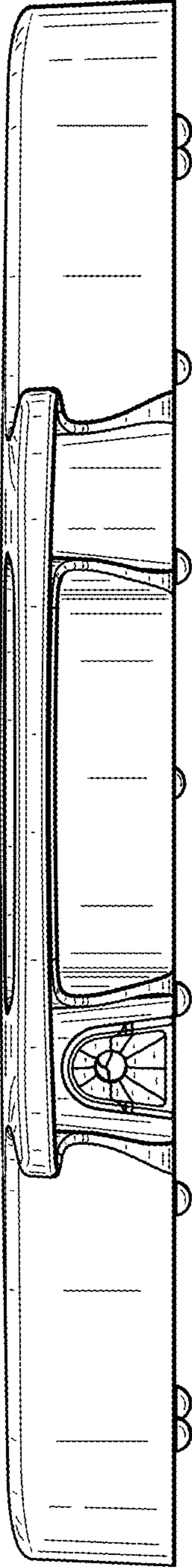

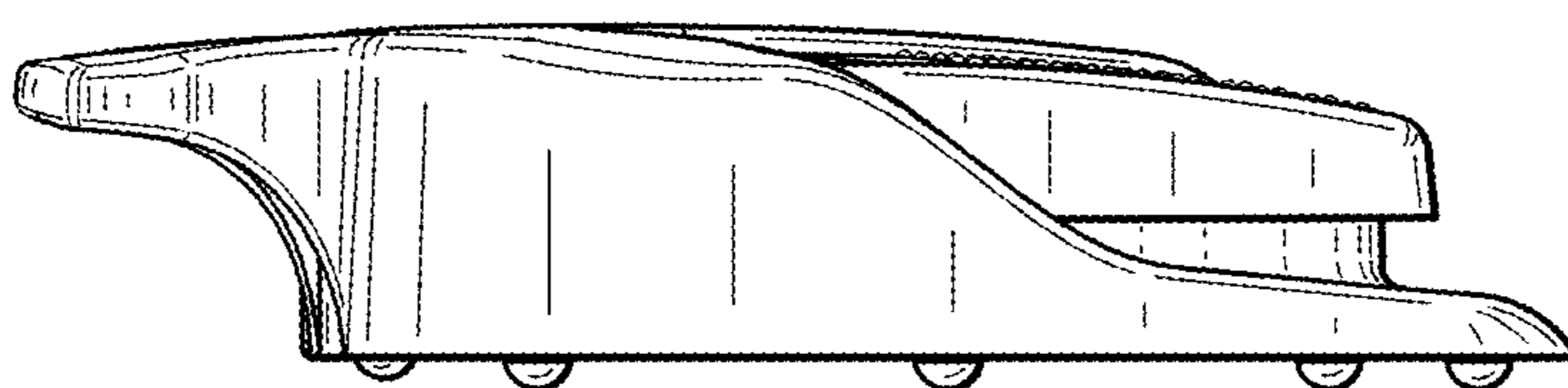

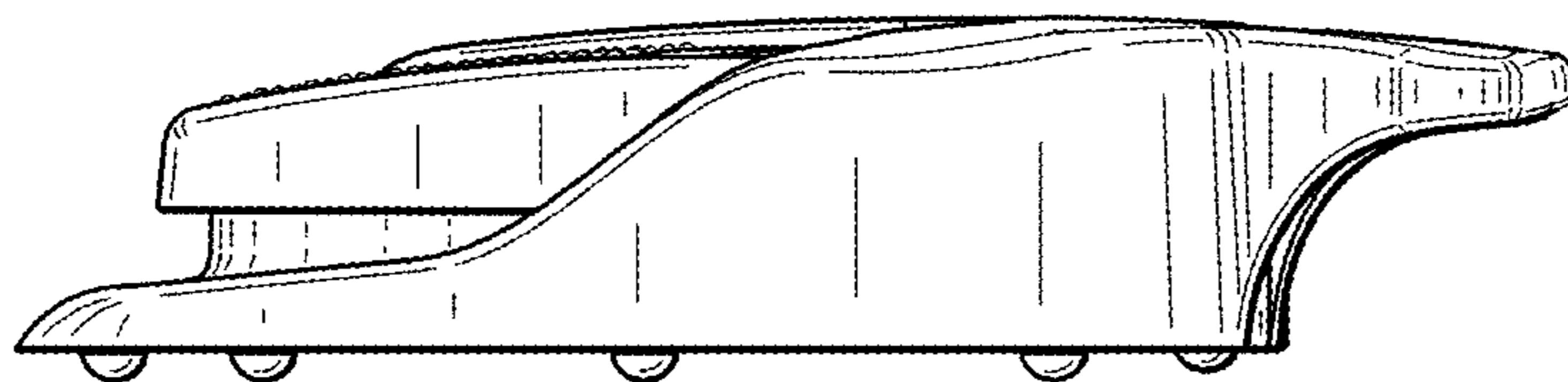

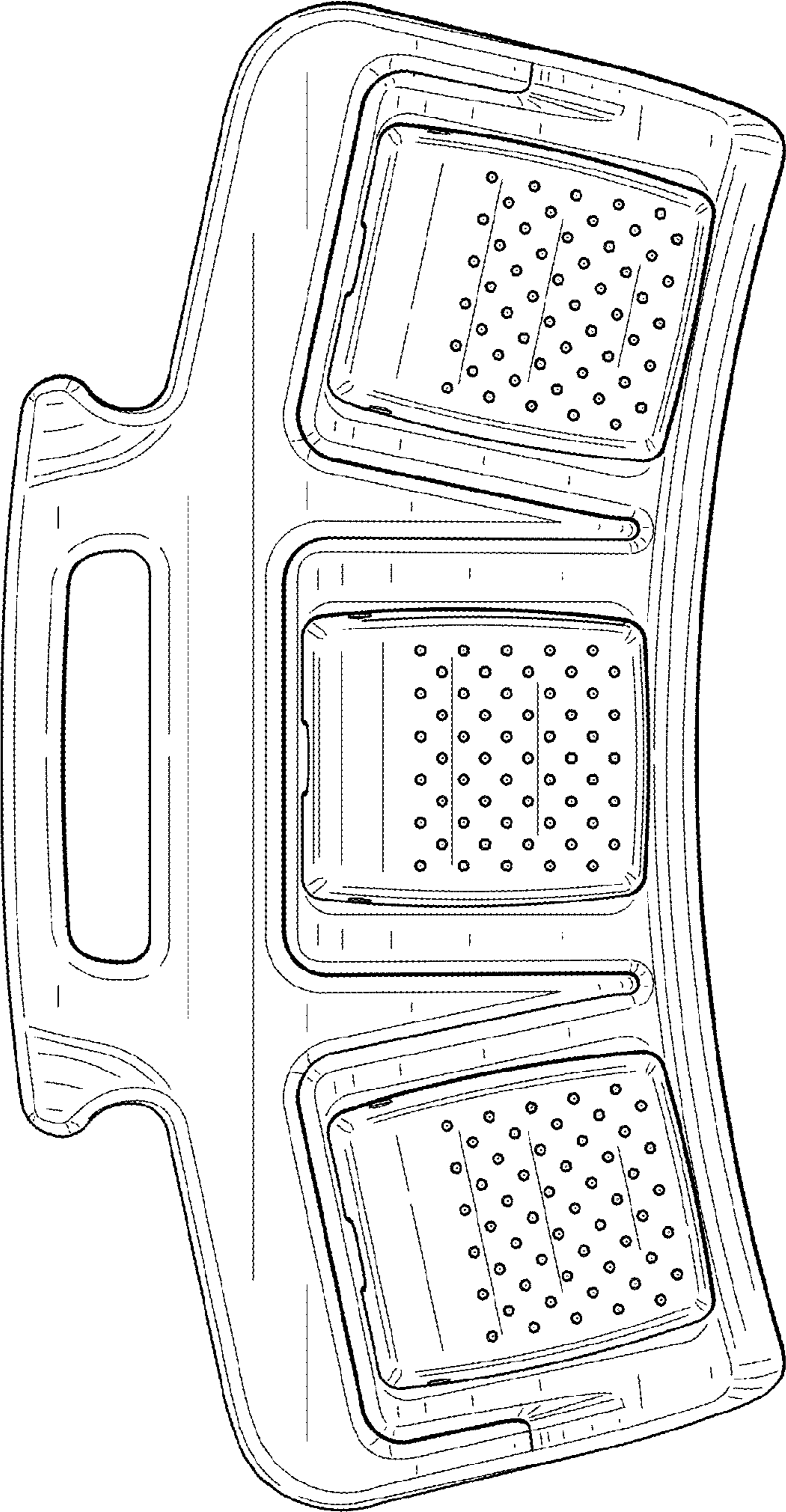
