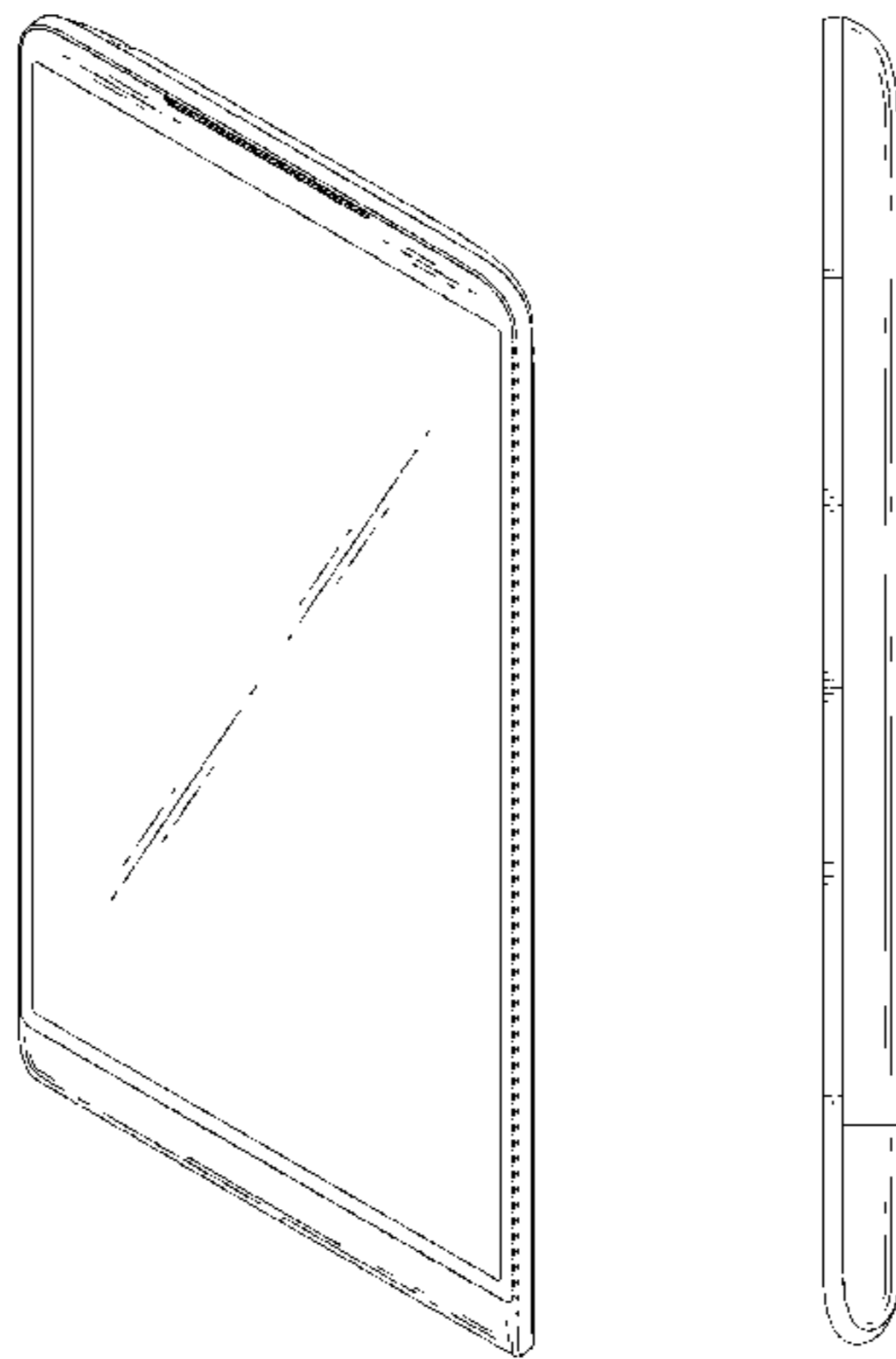
The ornamental design for a cellular phone, as shown and

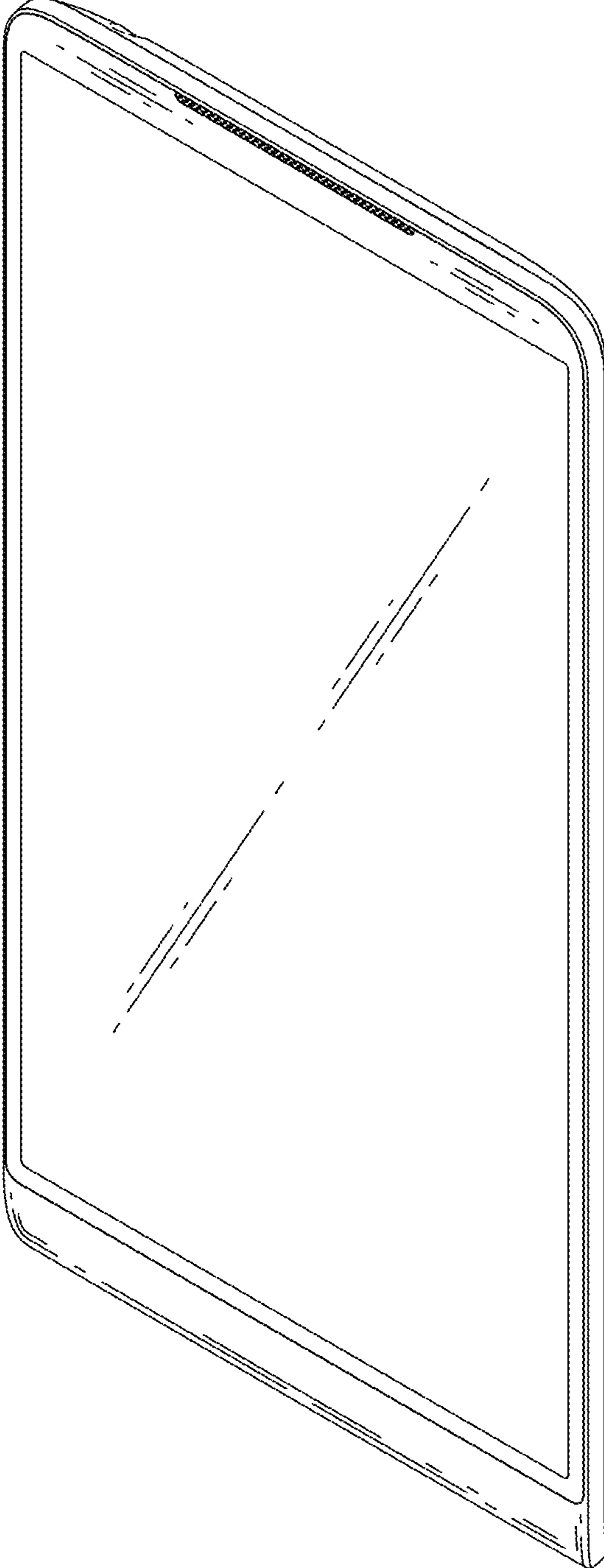

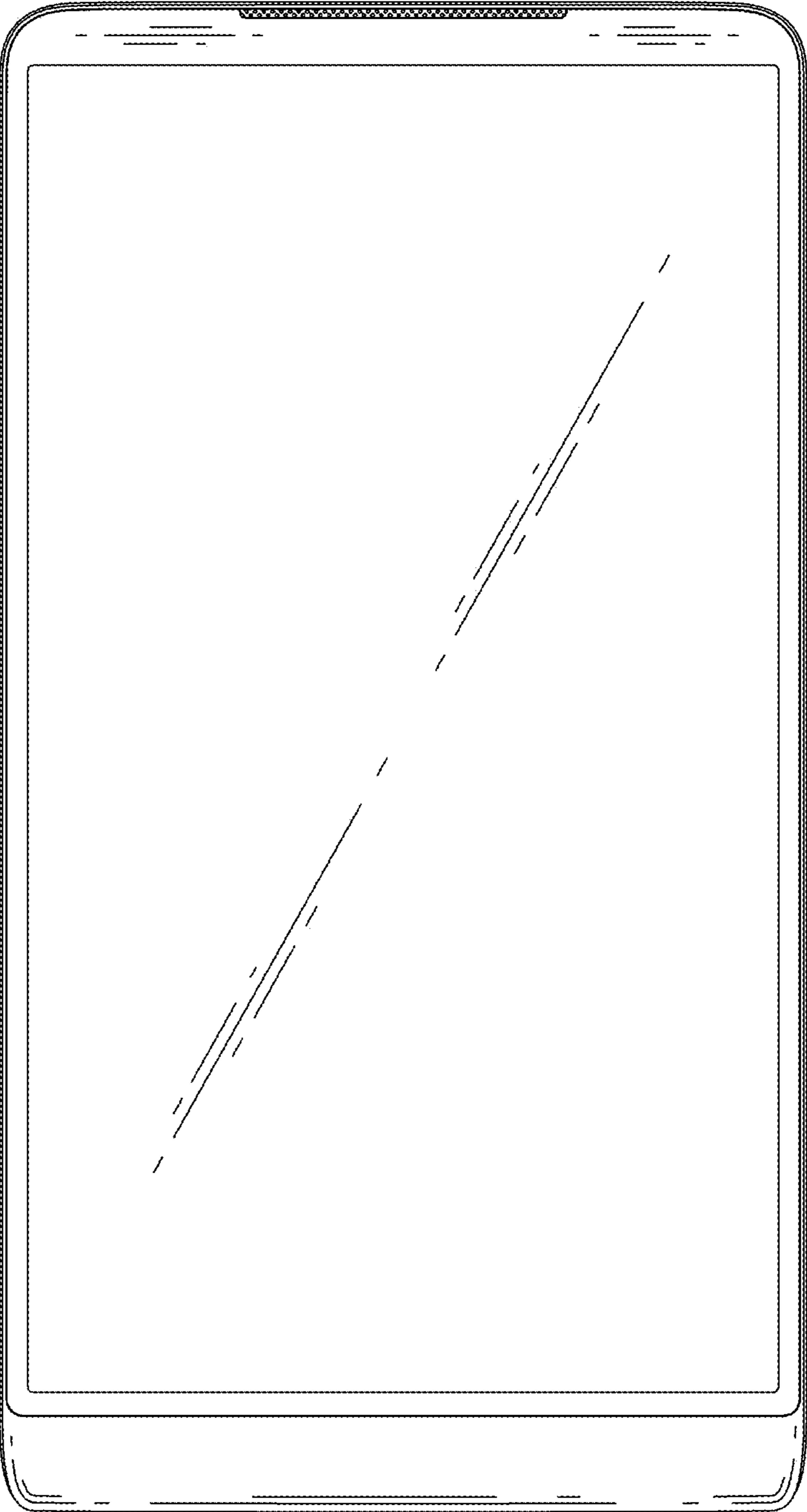

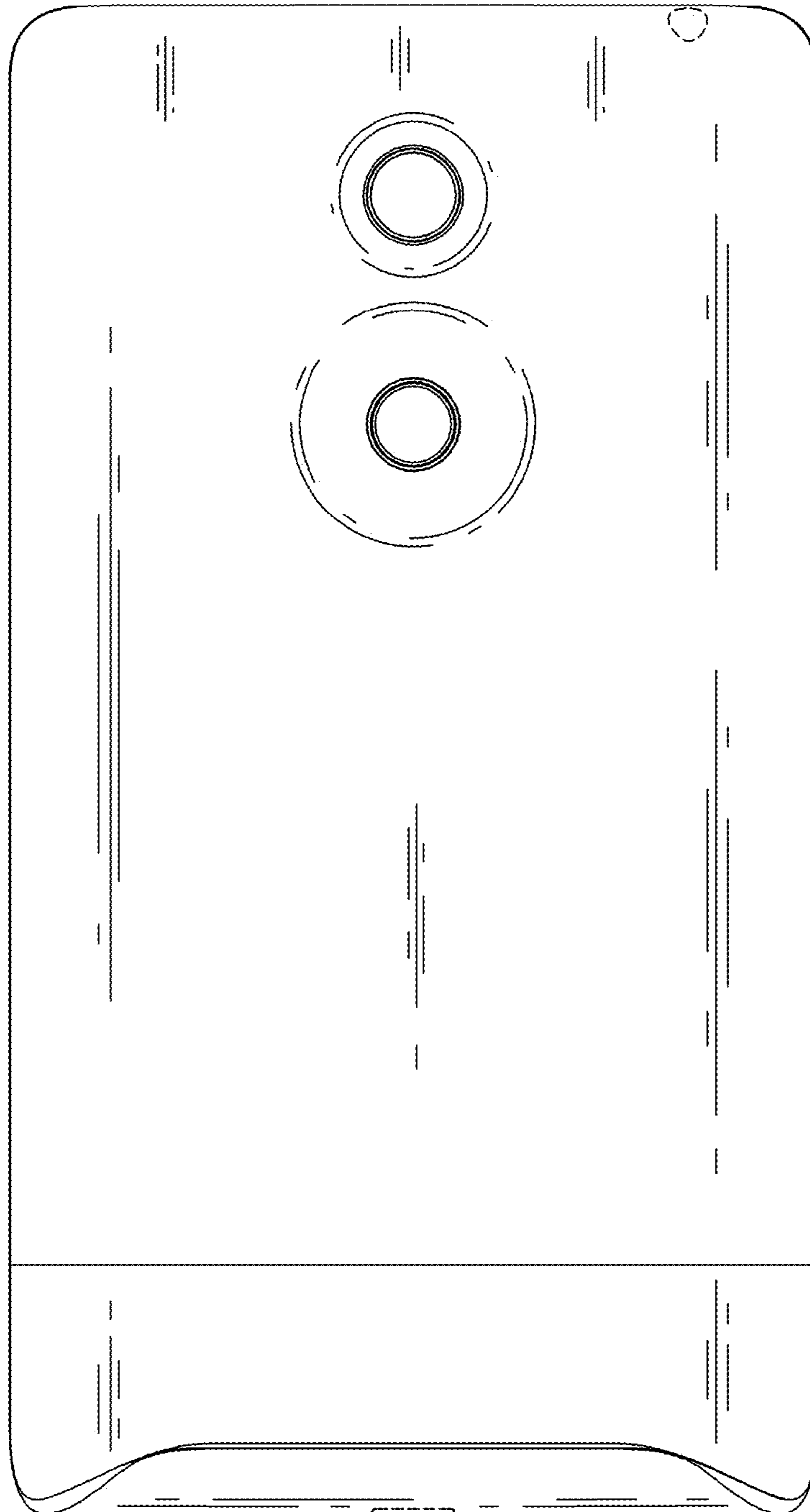

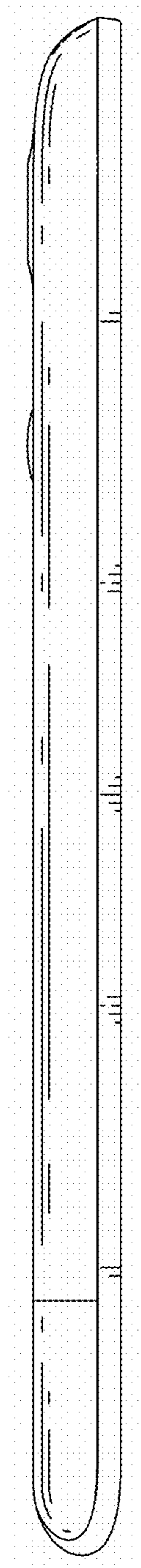

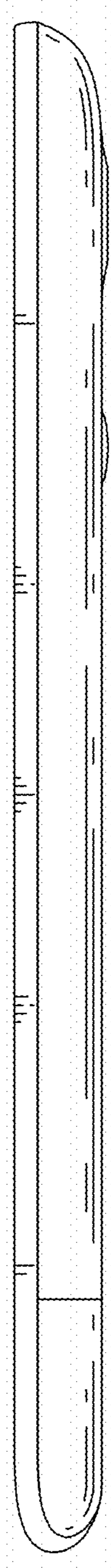

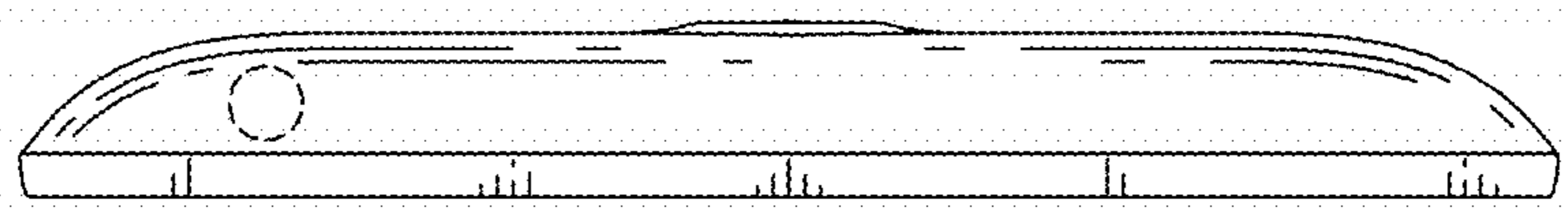

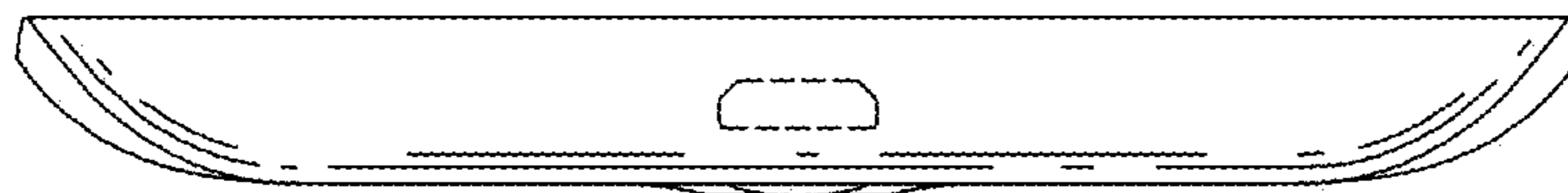
