DESCRIPTION

FIG. 1 is a front perspective view of an amplifier with a rotatable front door showing my new design, with the front door closed;

FIG. 7 is a bottom plan view thereof;

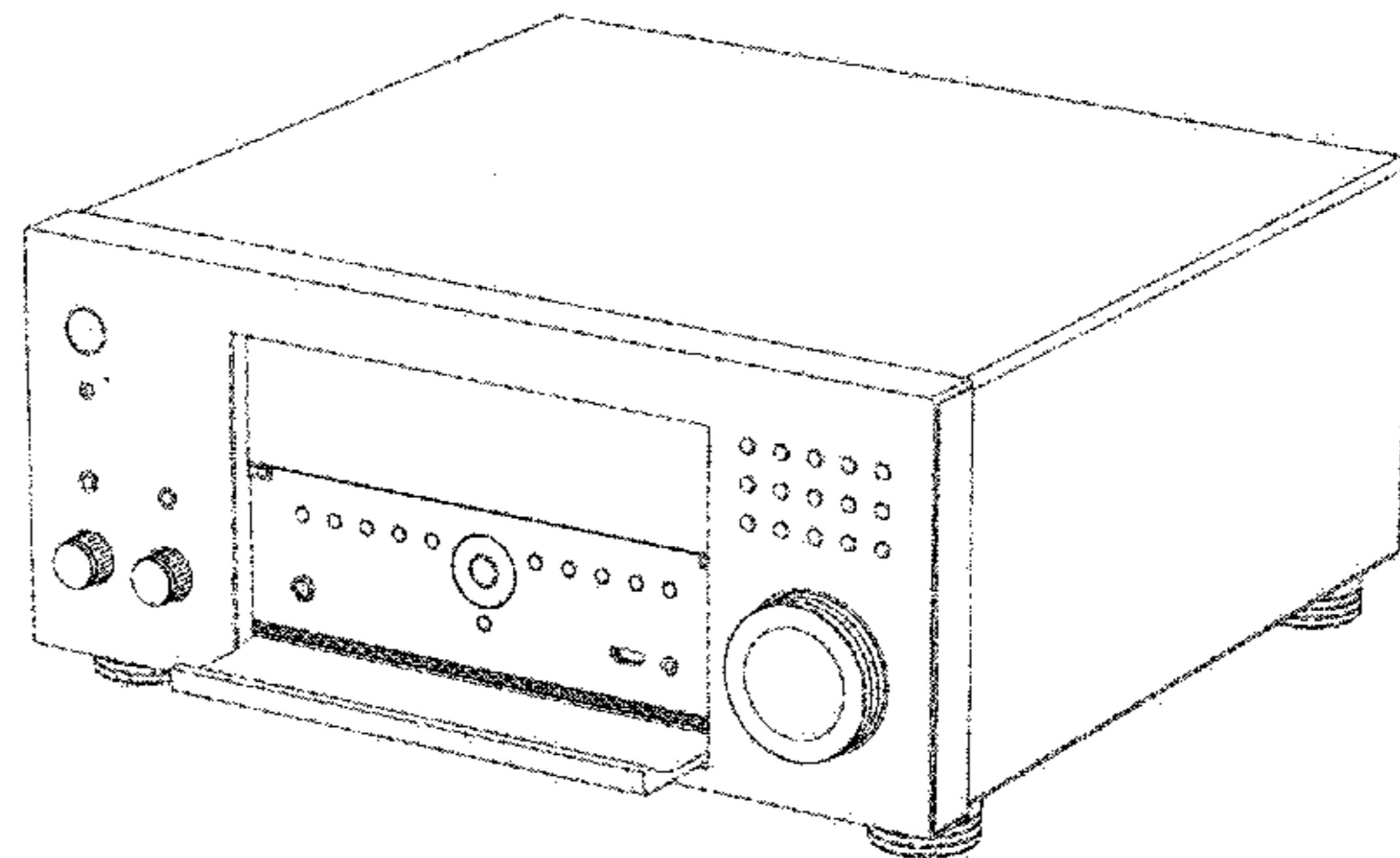
FIG. 8 is a front perspective view of the amplifier, with the front door open;

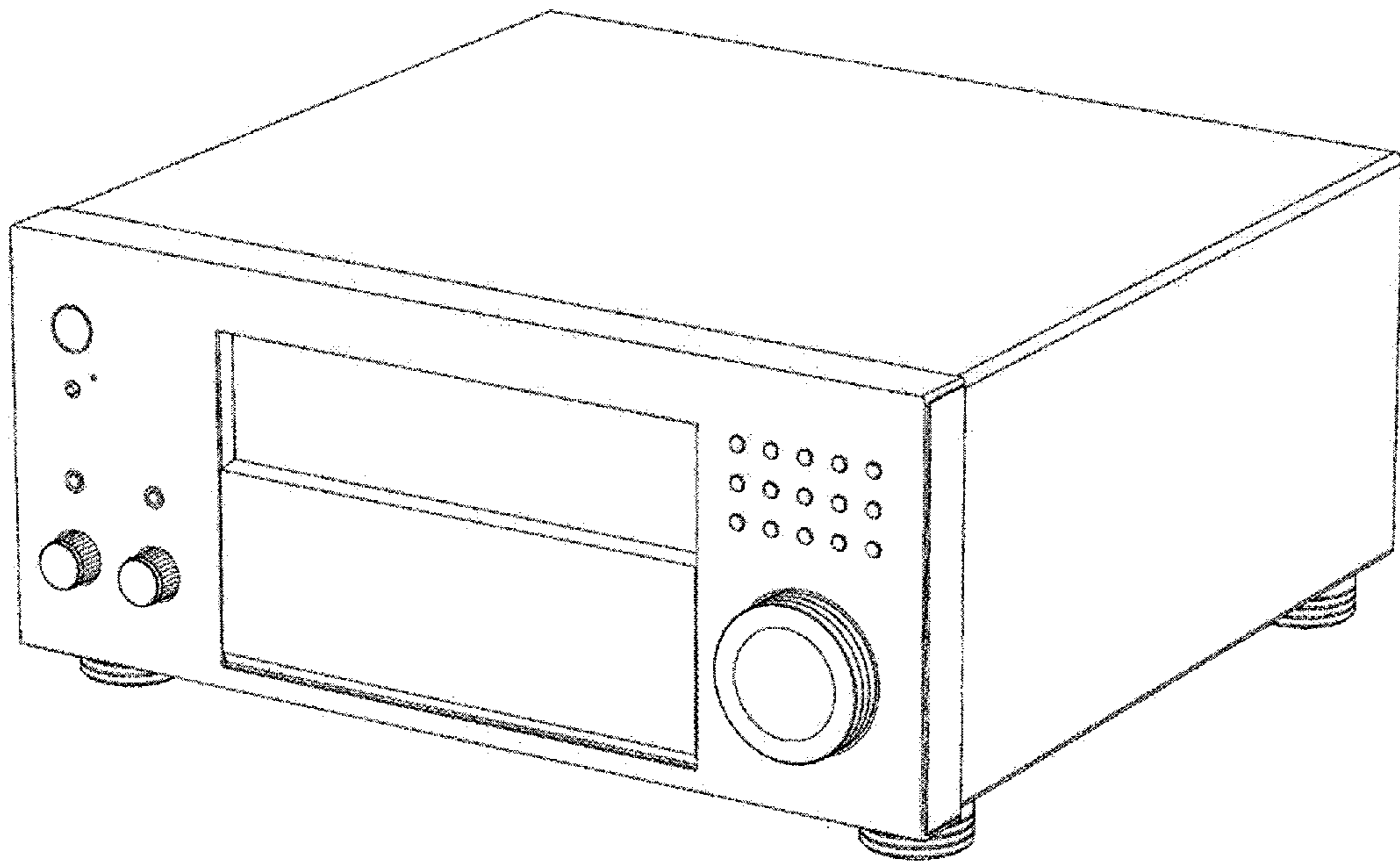

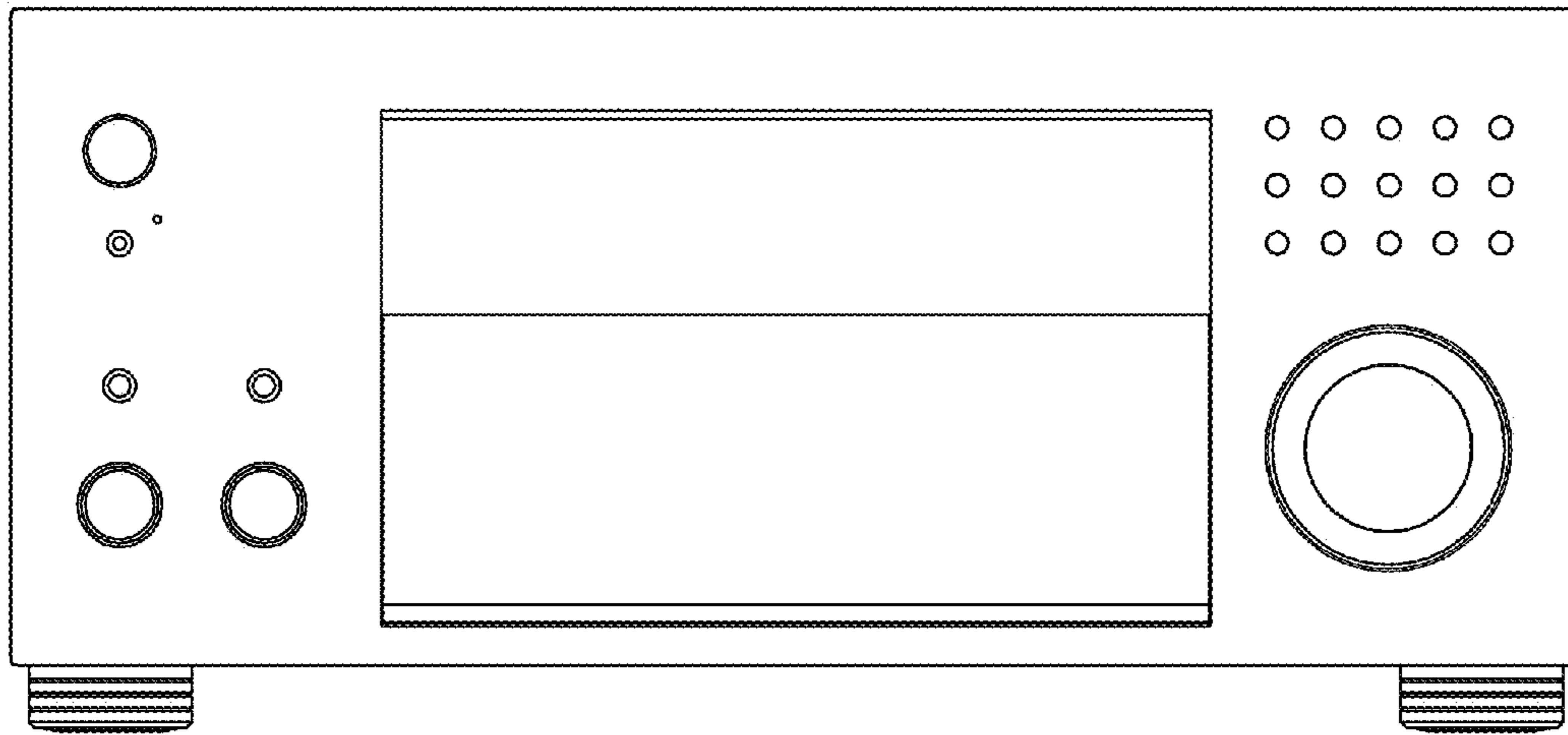

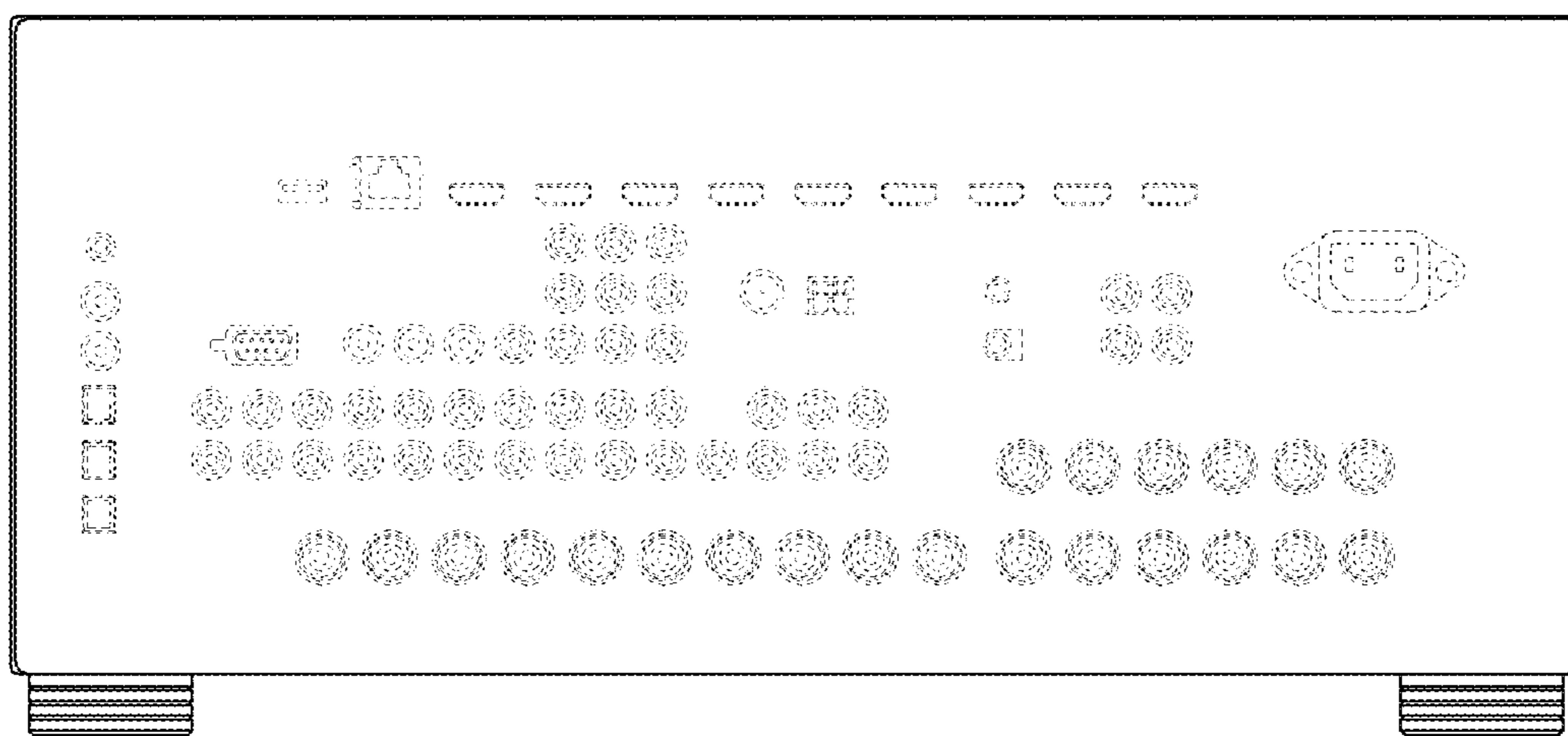

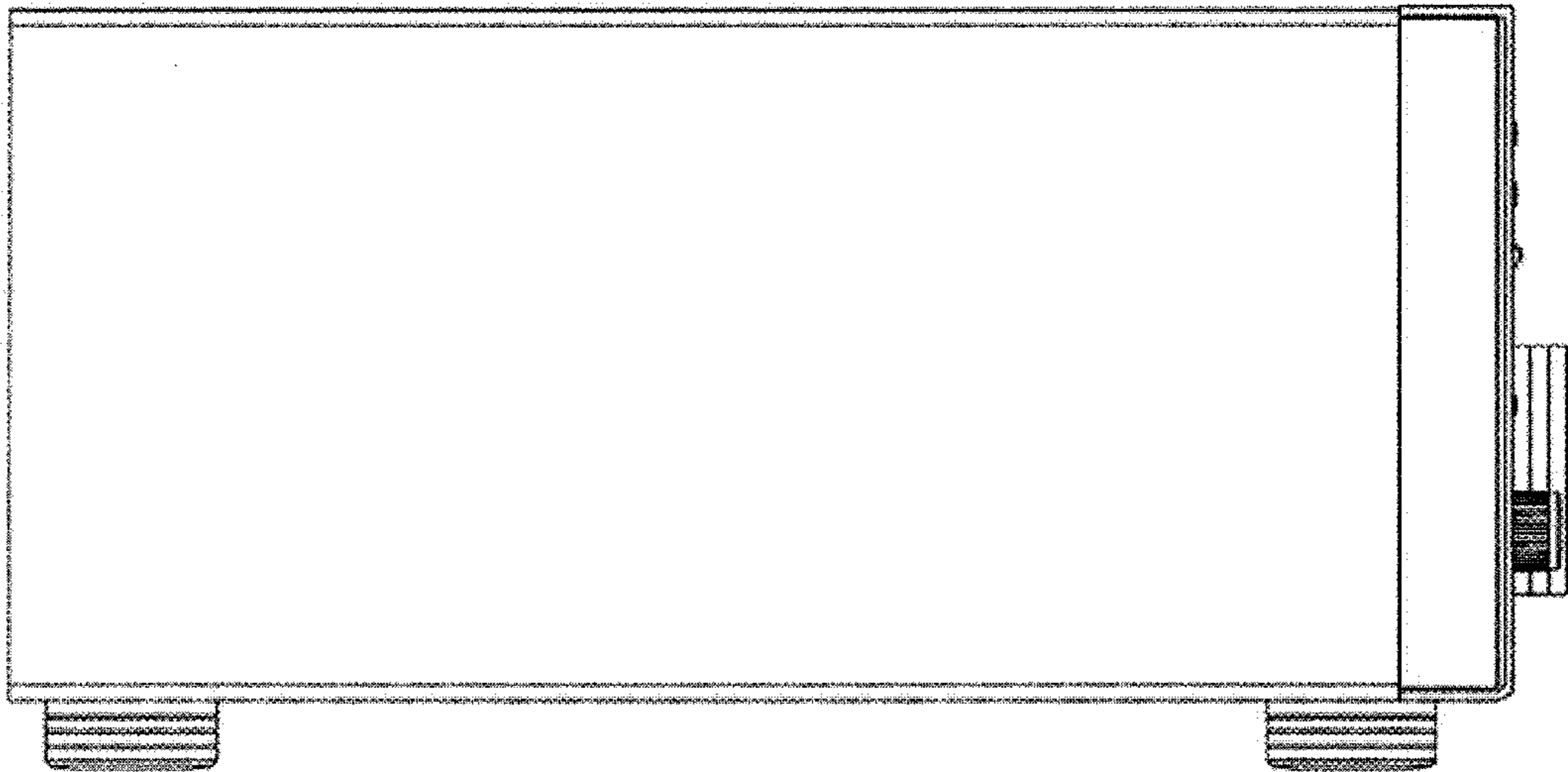

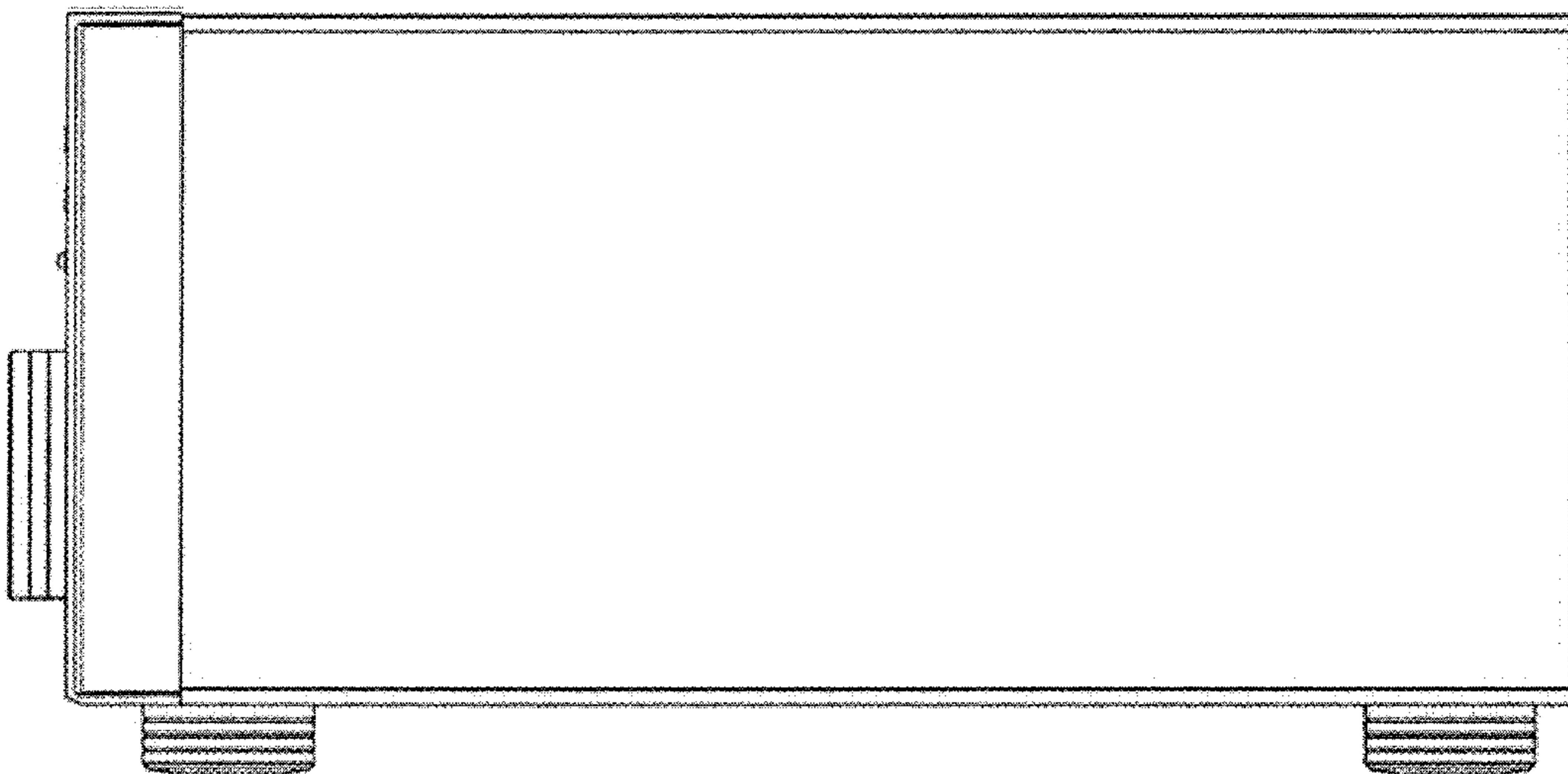

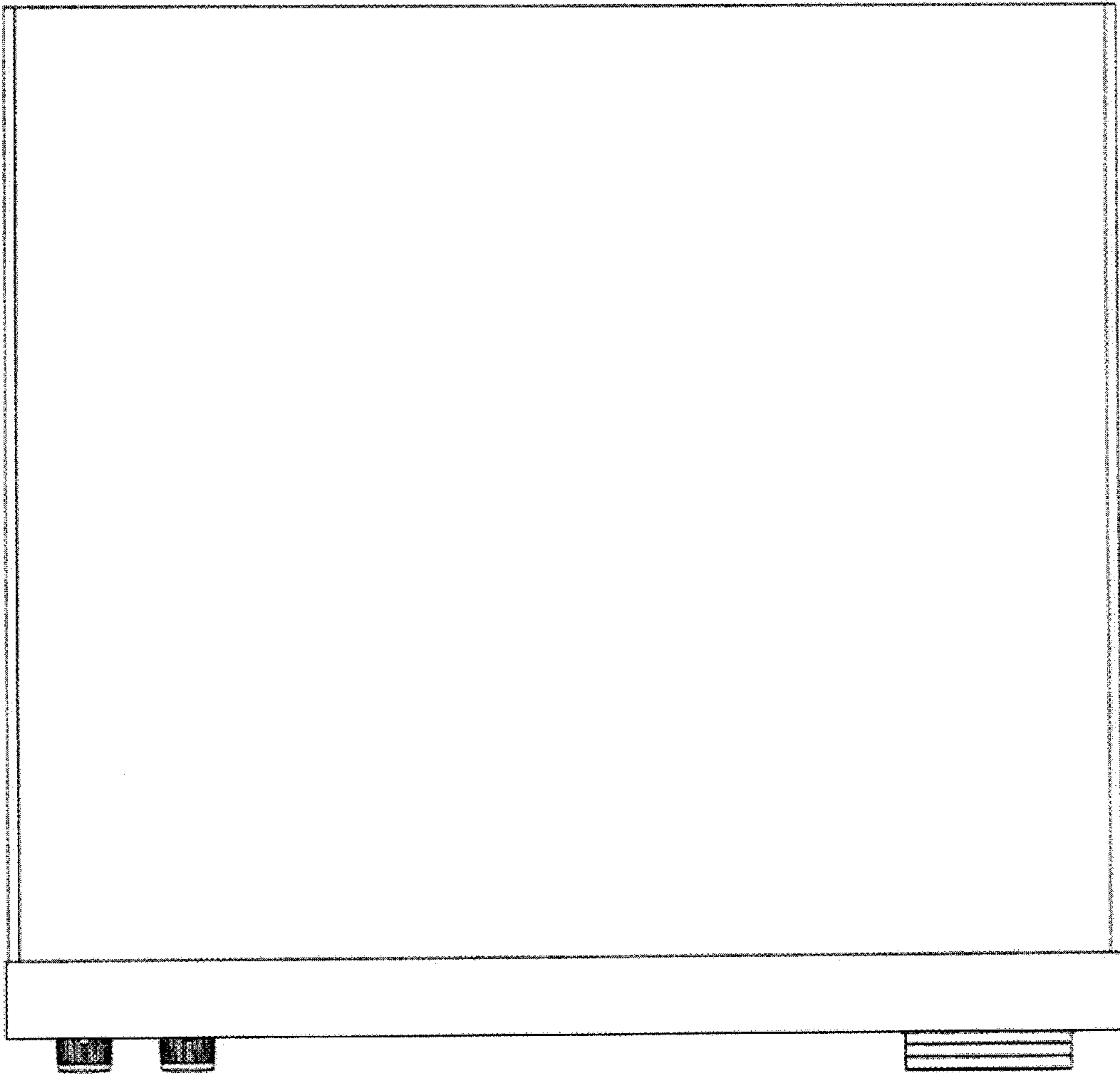

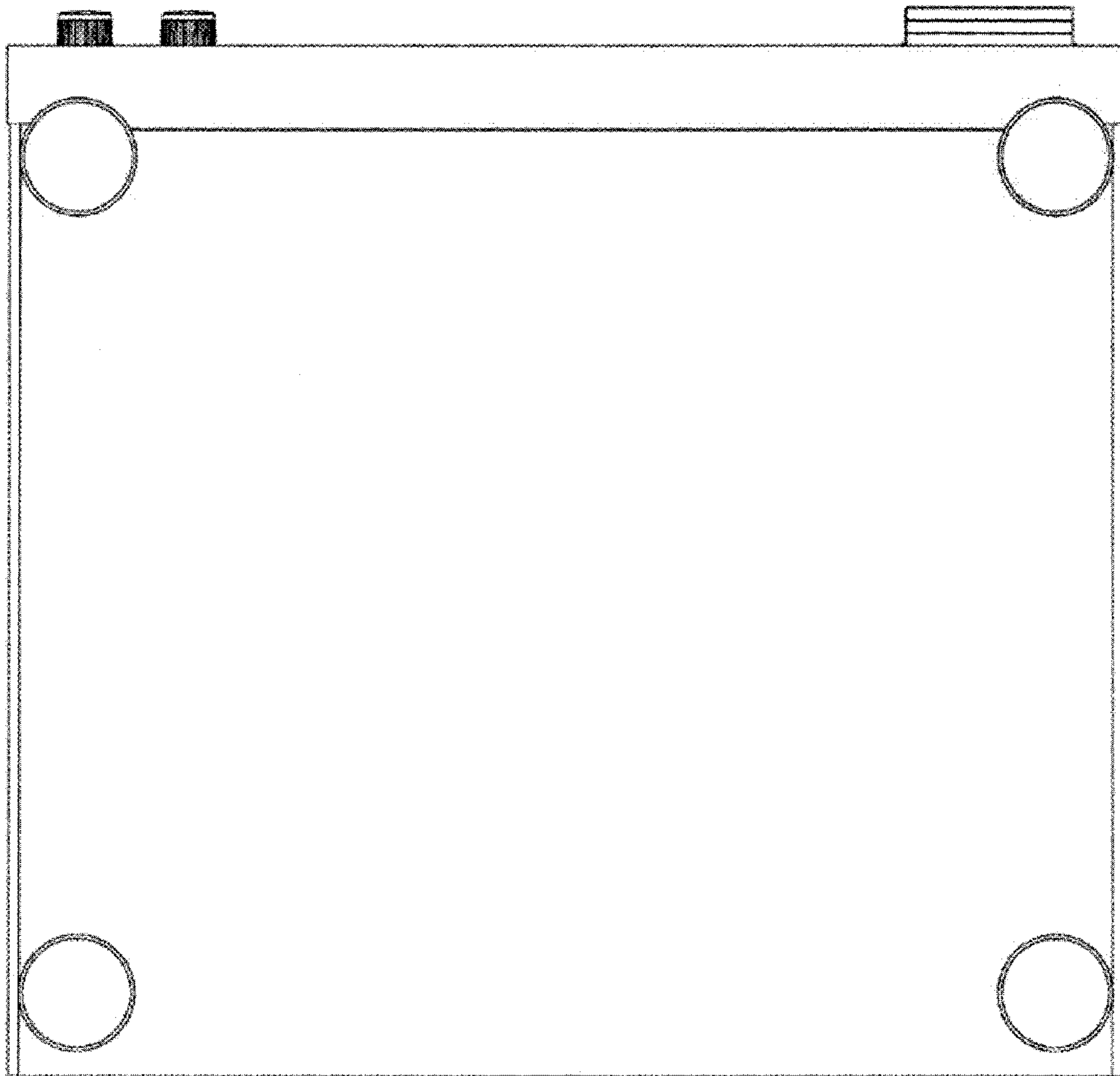

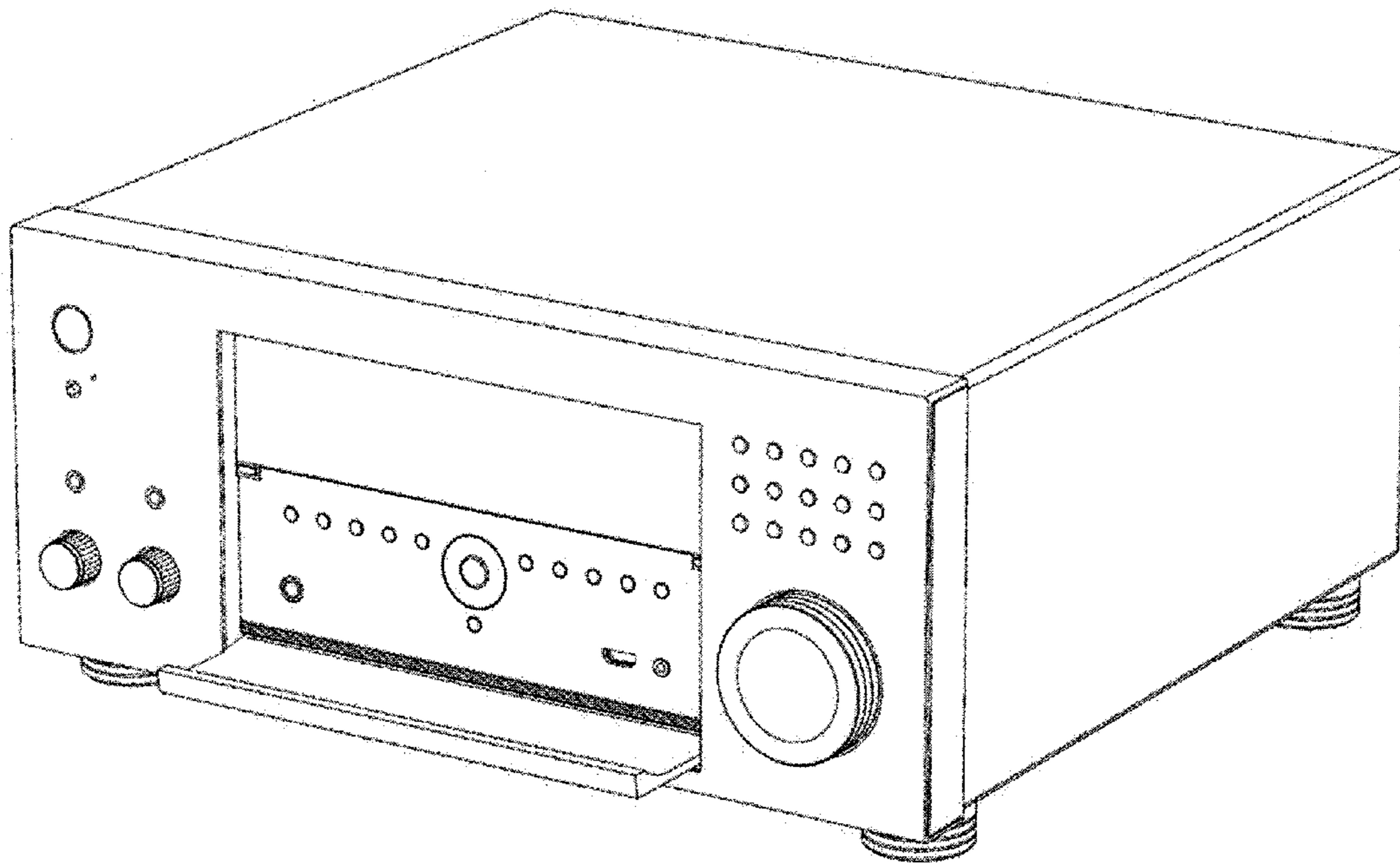

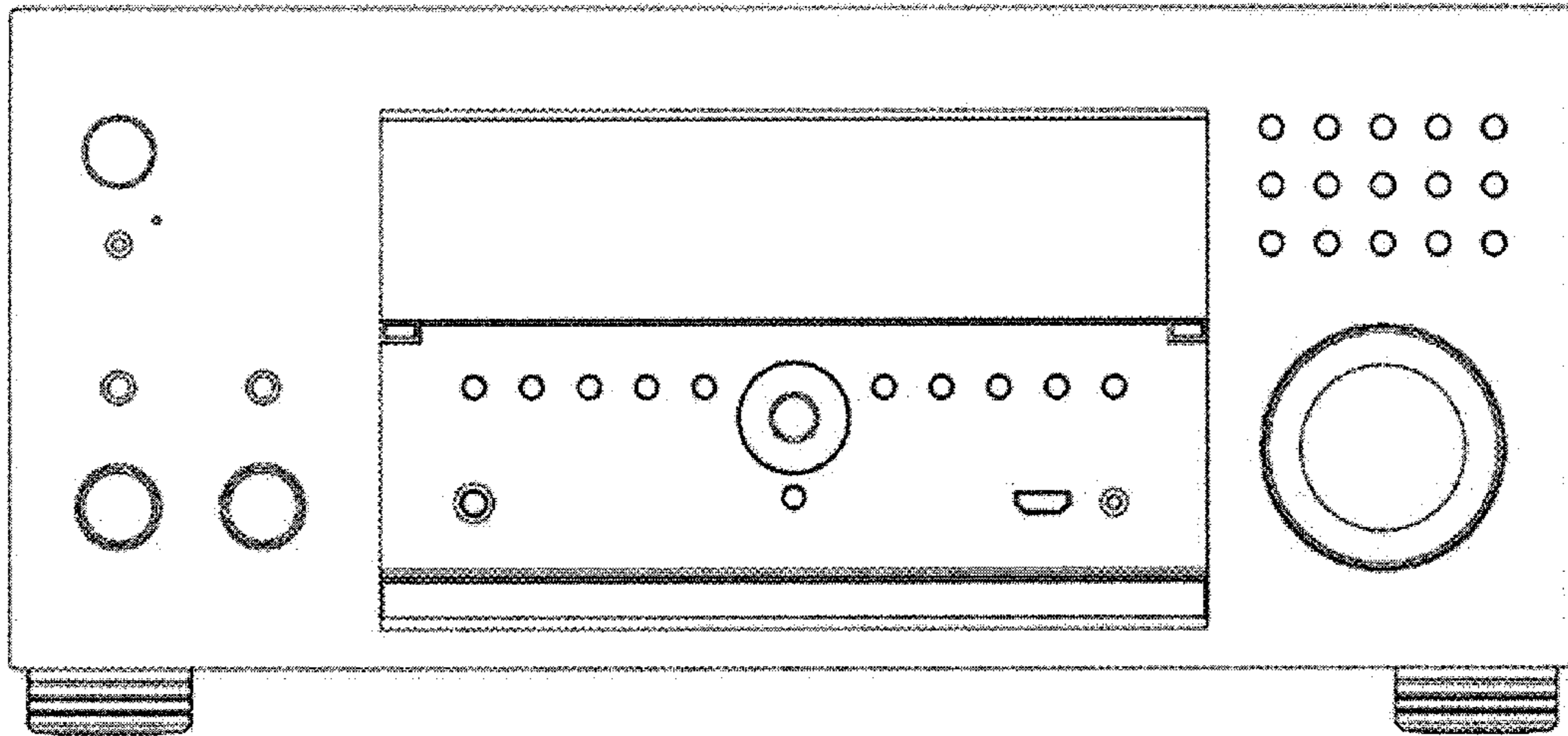

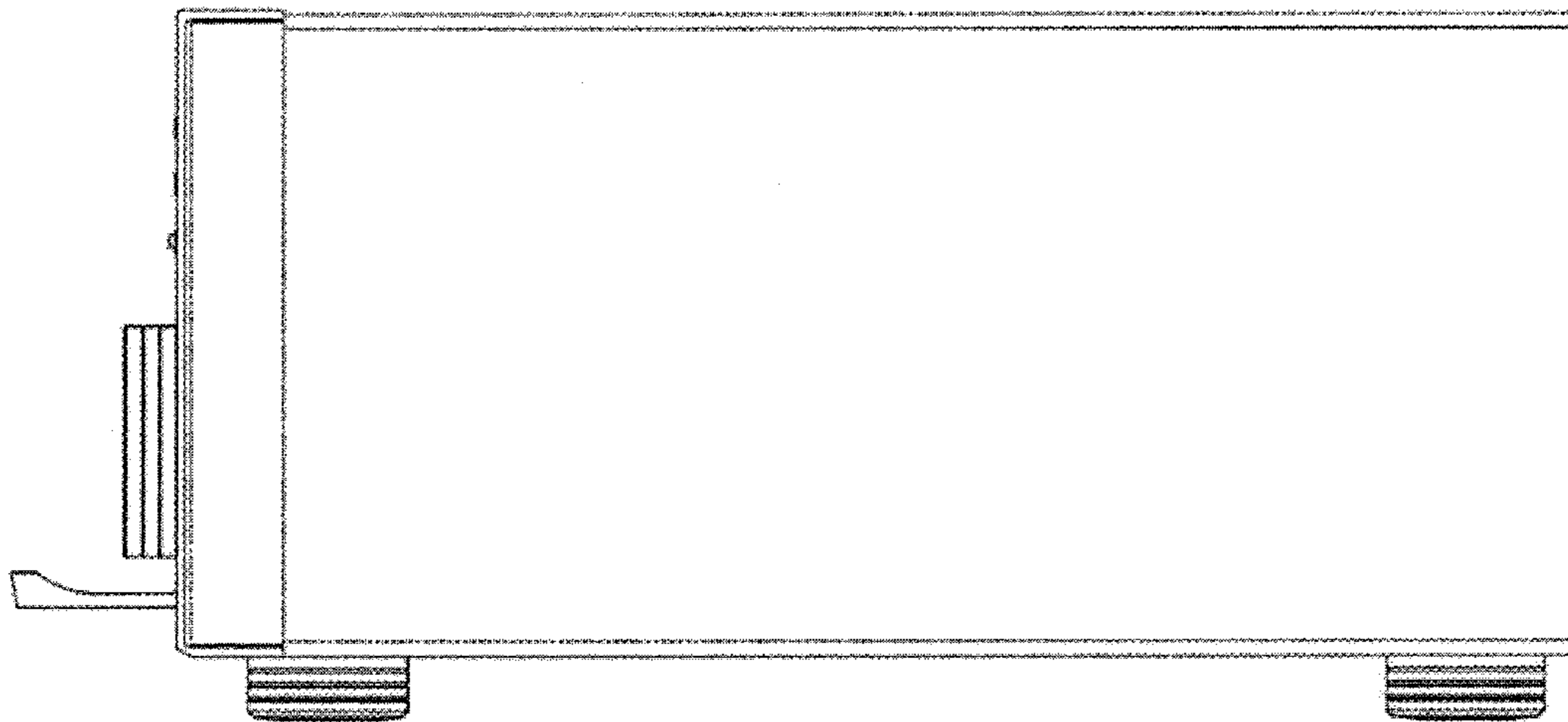
