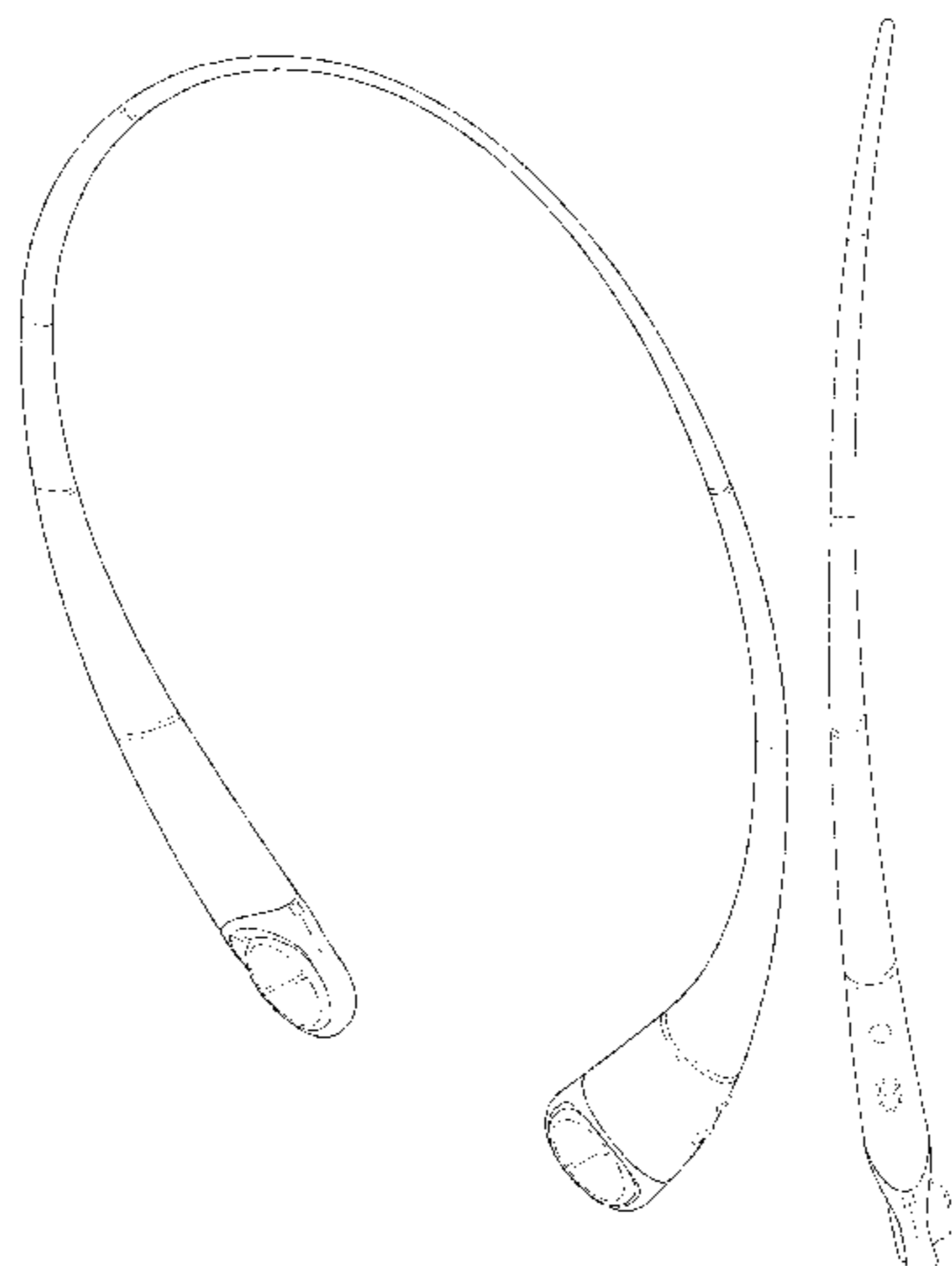
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a wireless headset showing our new design;

 FIG. 9 is a reference view thereof showing that the earphone part can be detached; and,
 FIG. 10 is a reference view thereof showing an example of the usage of the subject design in which the earphone part has been detached.

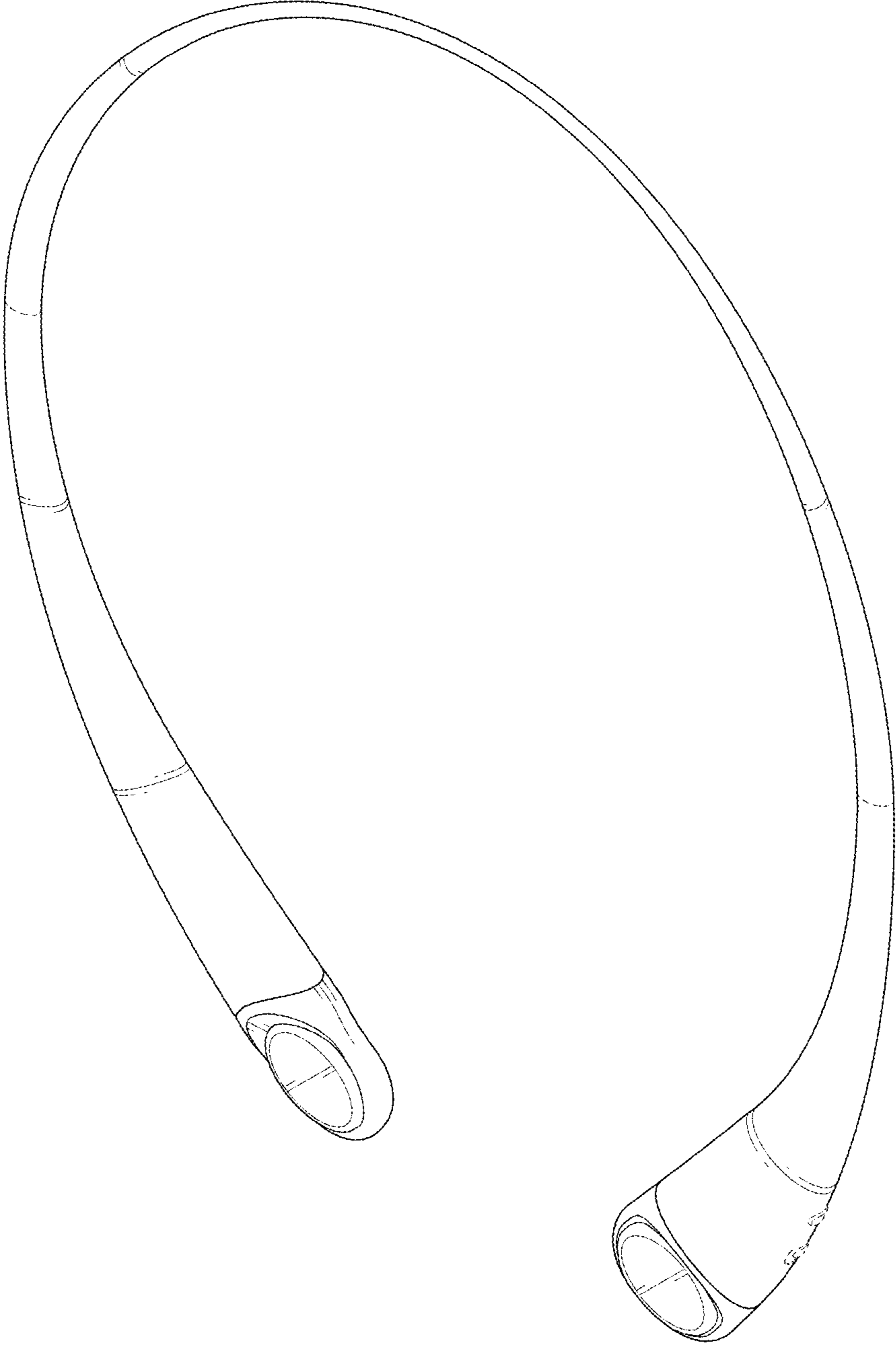

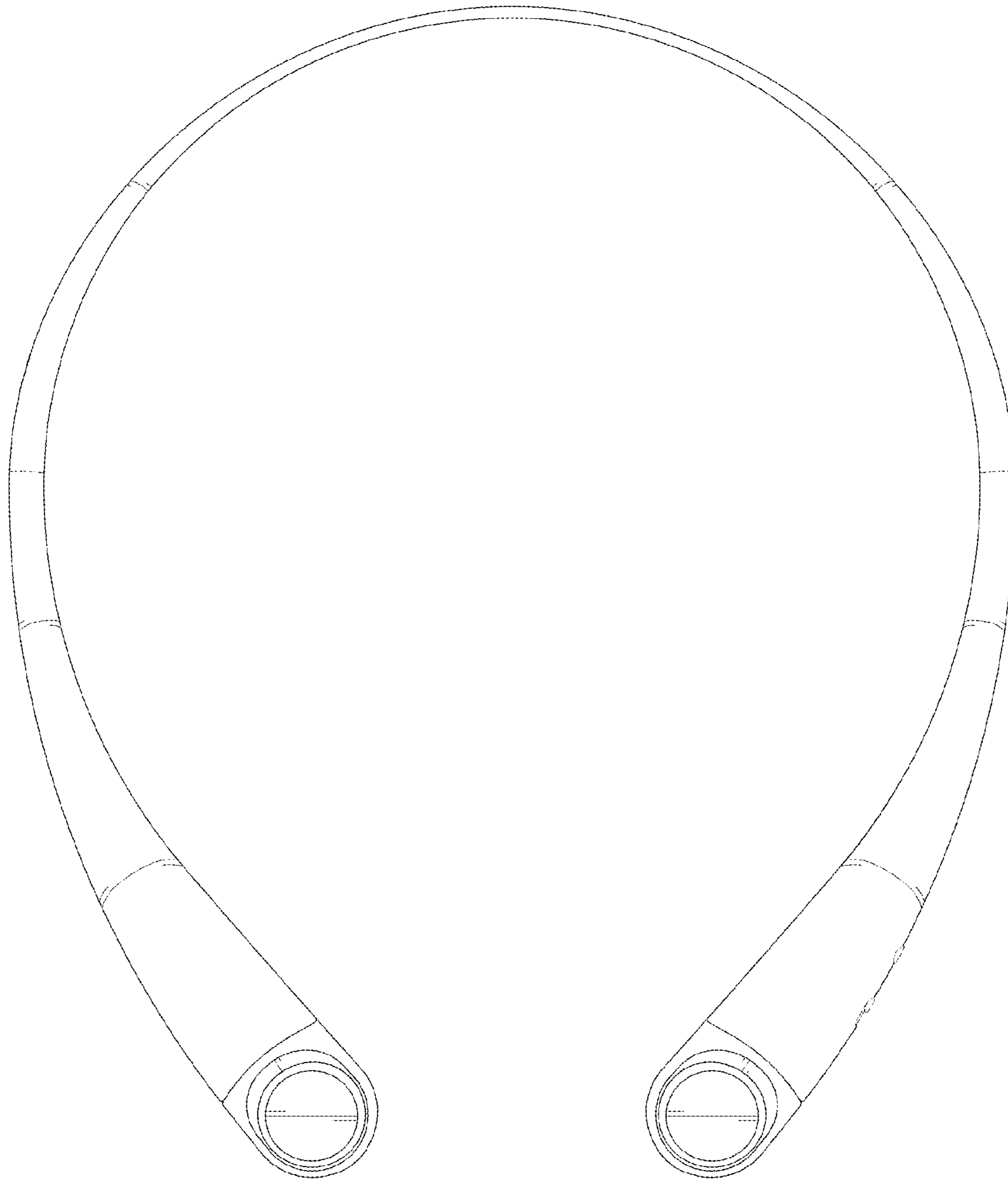

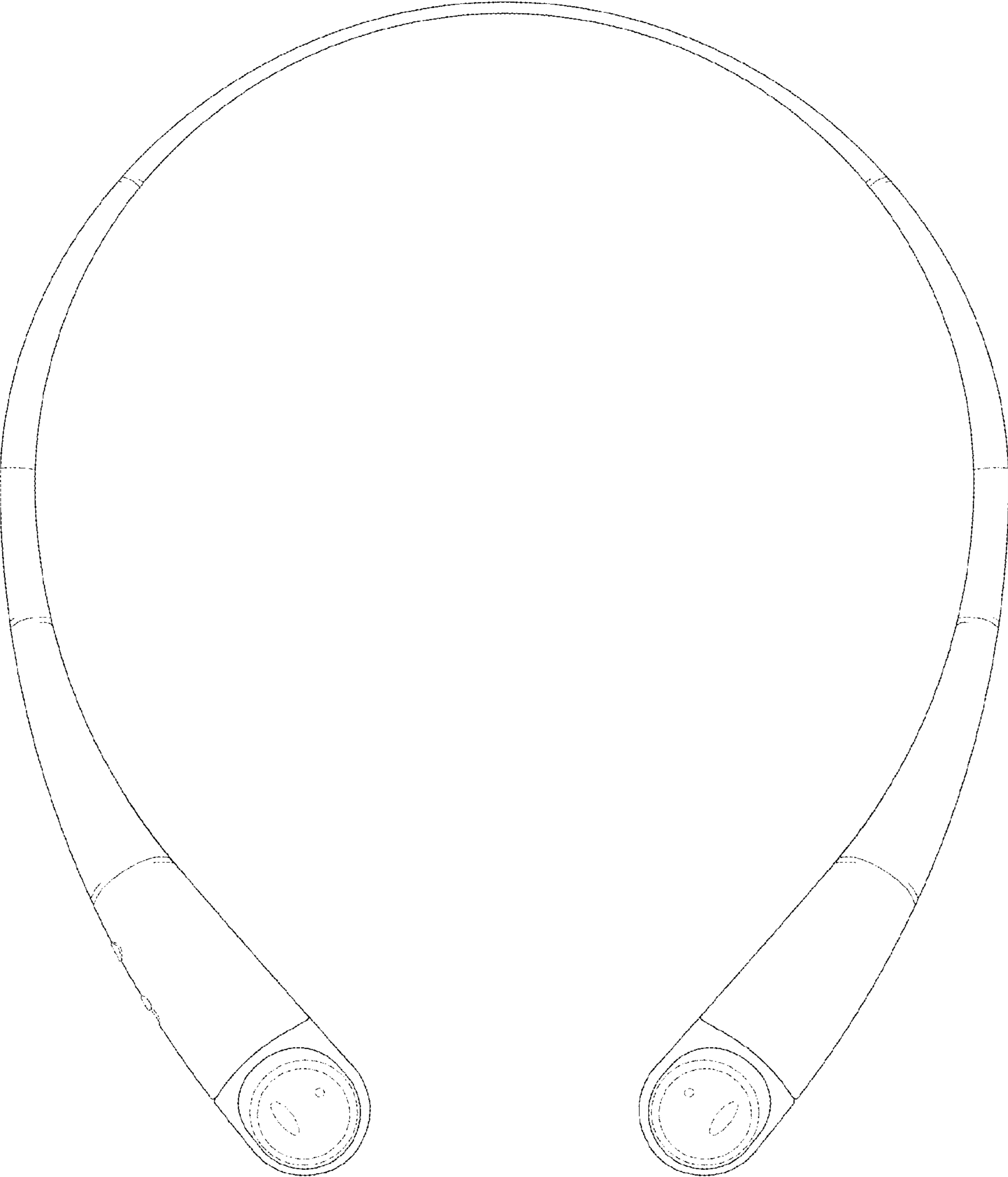

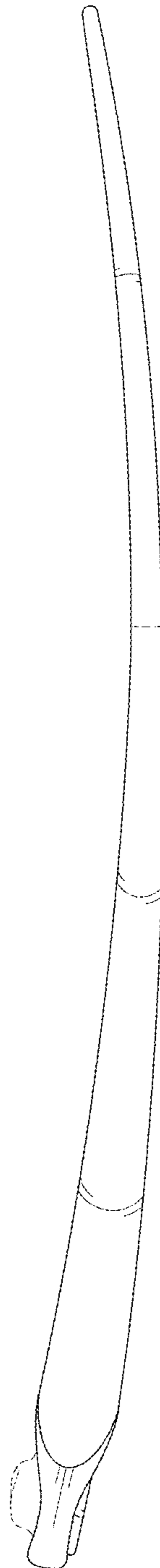

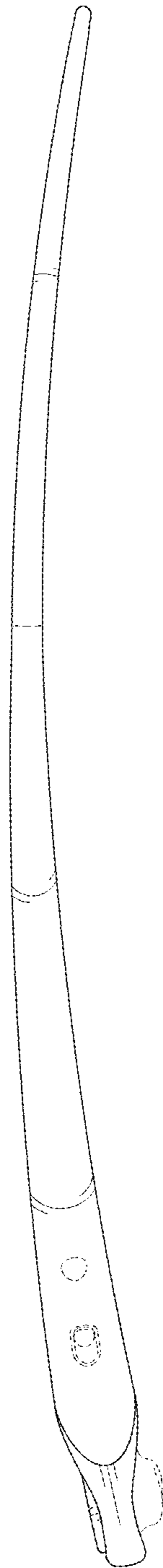

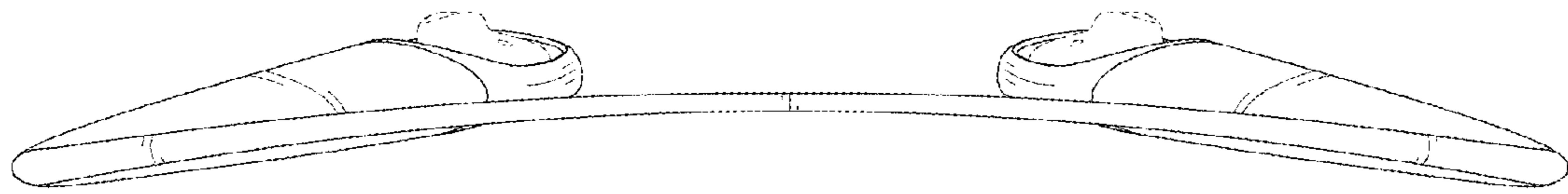

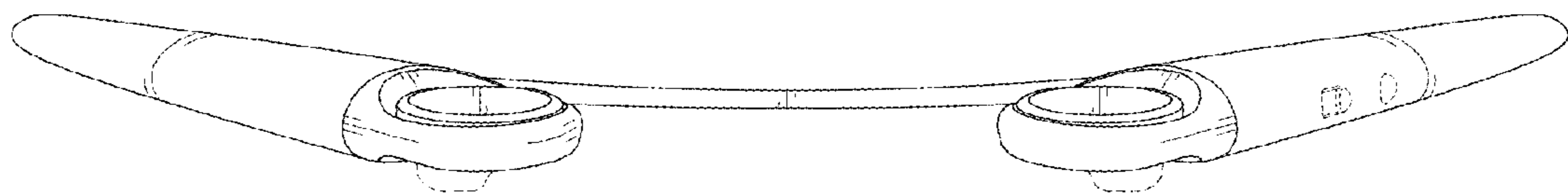

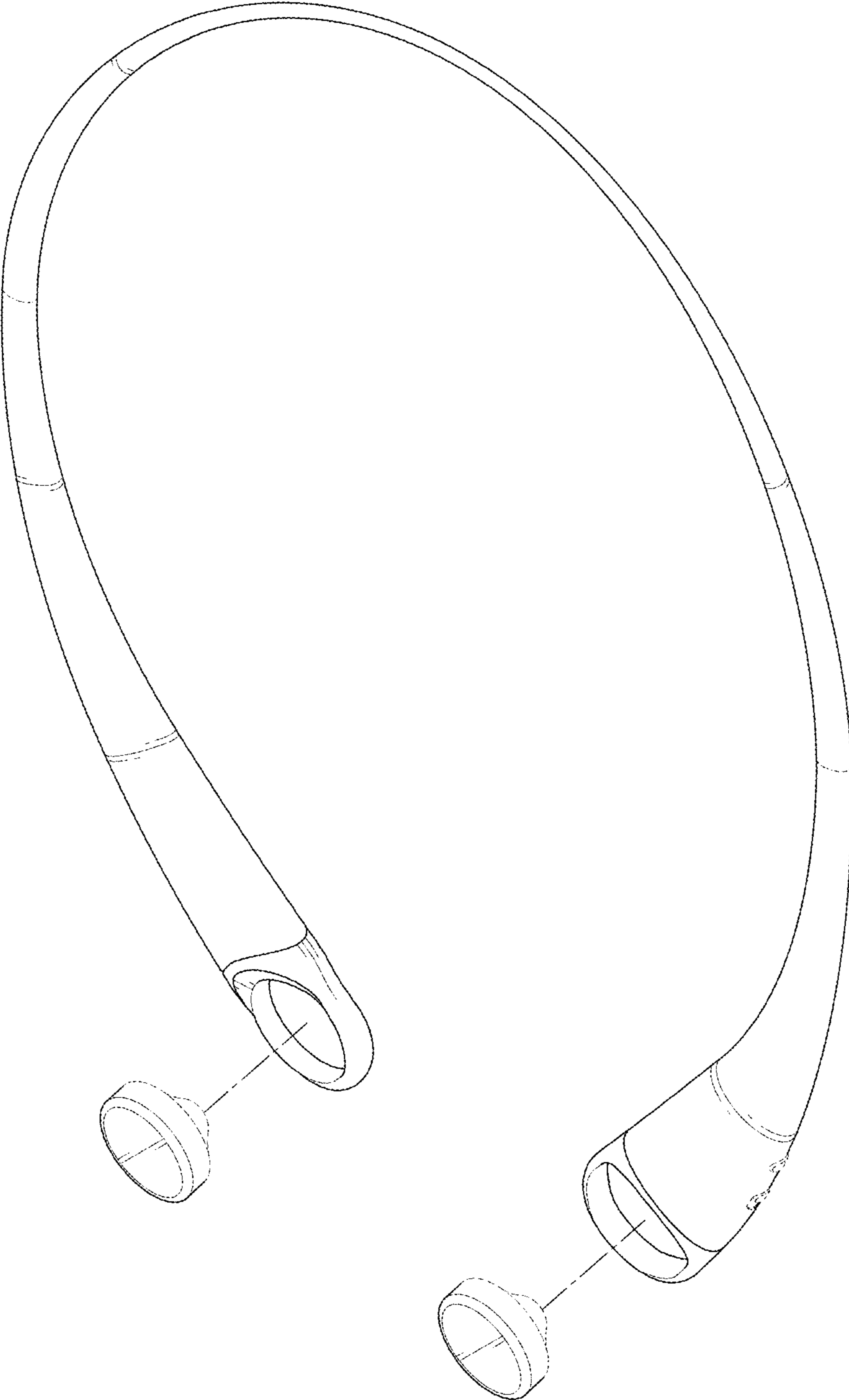

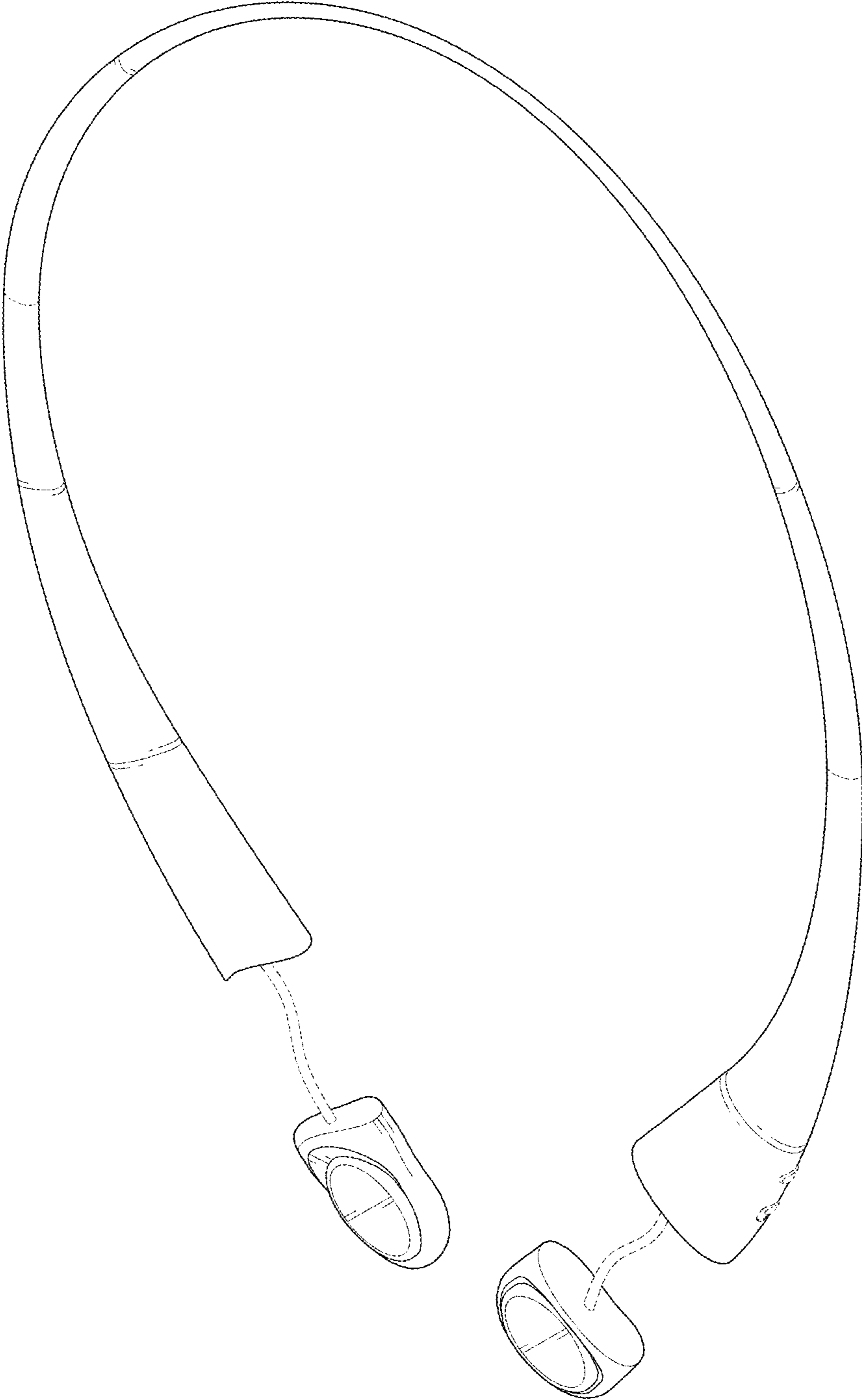
