(57) **CLAIM**

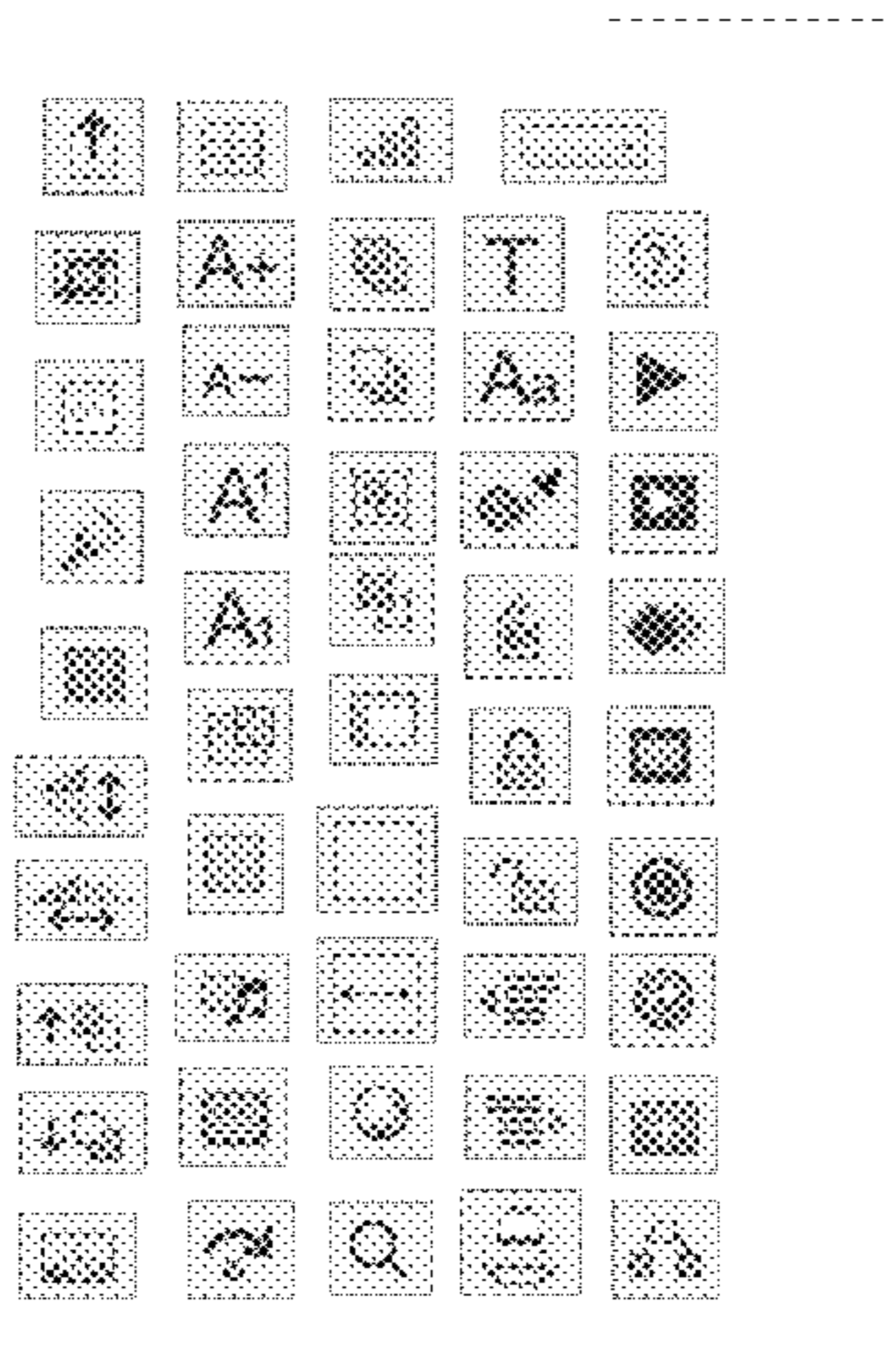
The ornamental design for a display screen or portion thereof with graphical user interface(s), as shown and described.

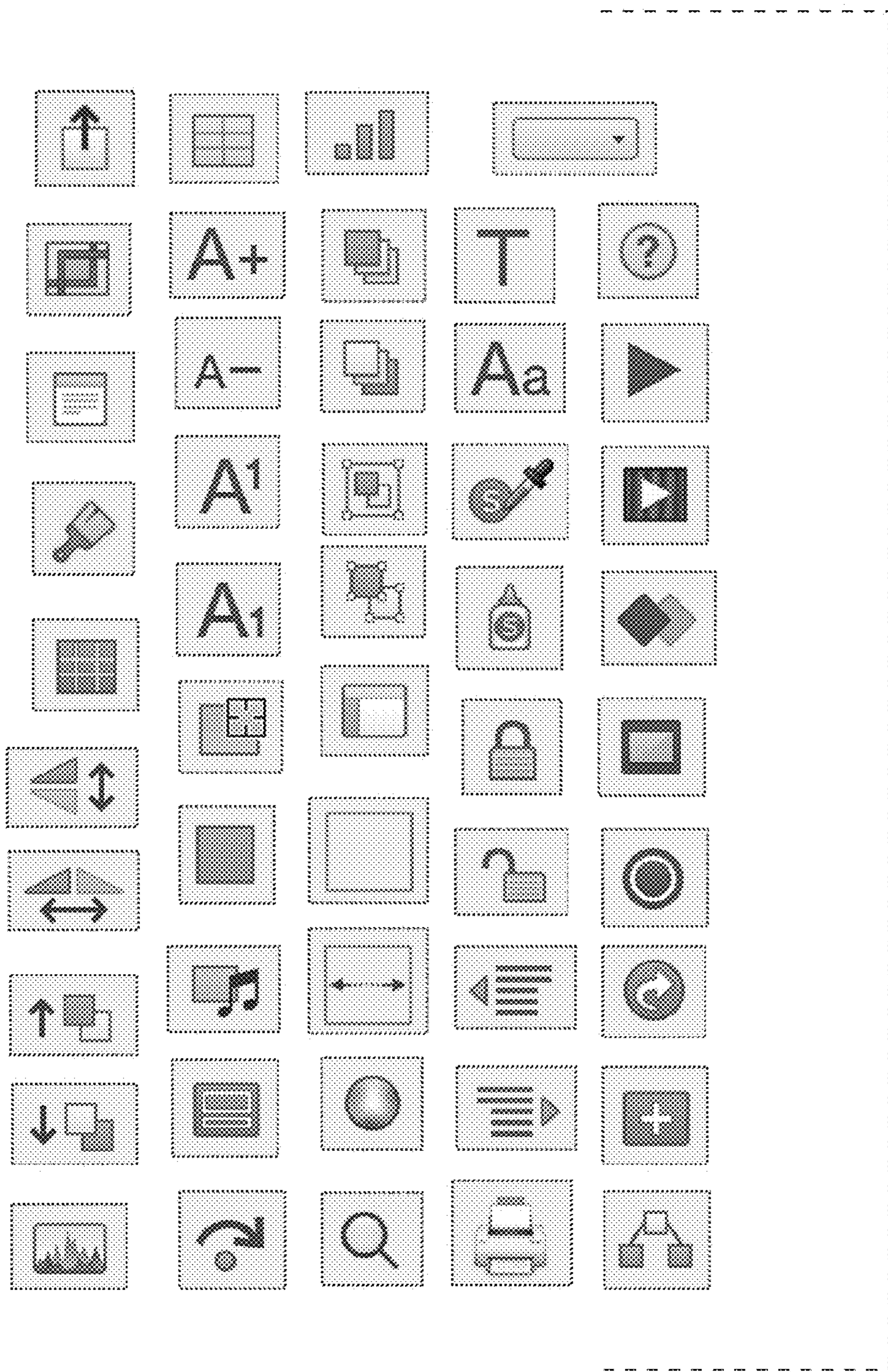

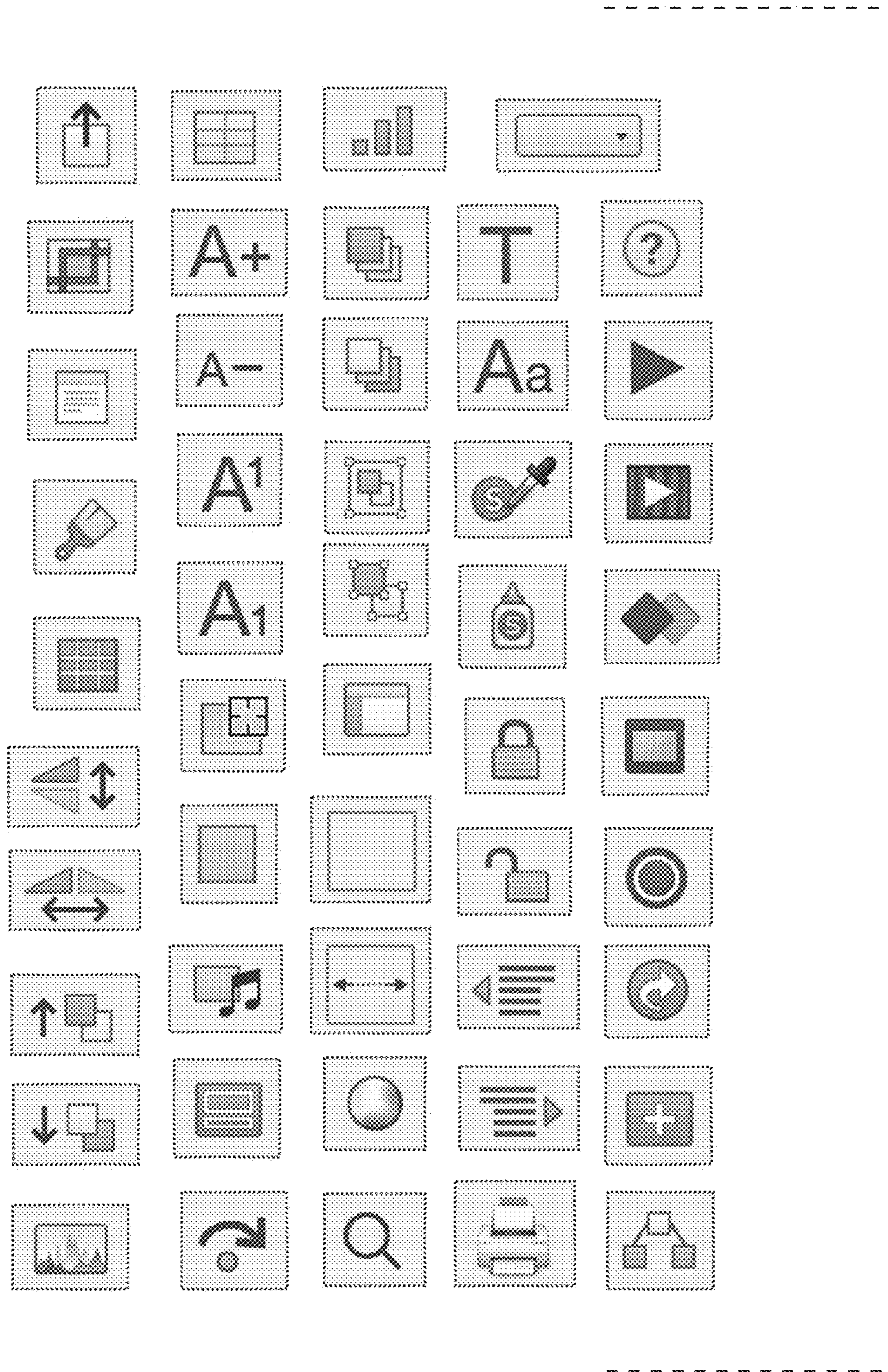
