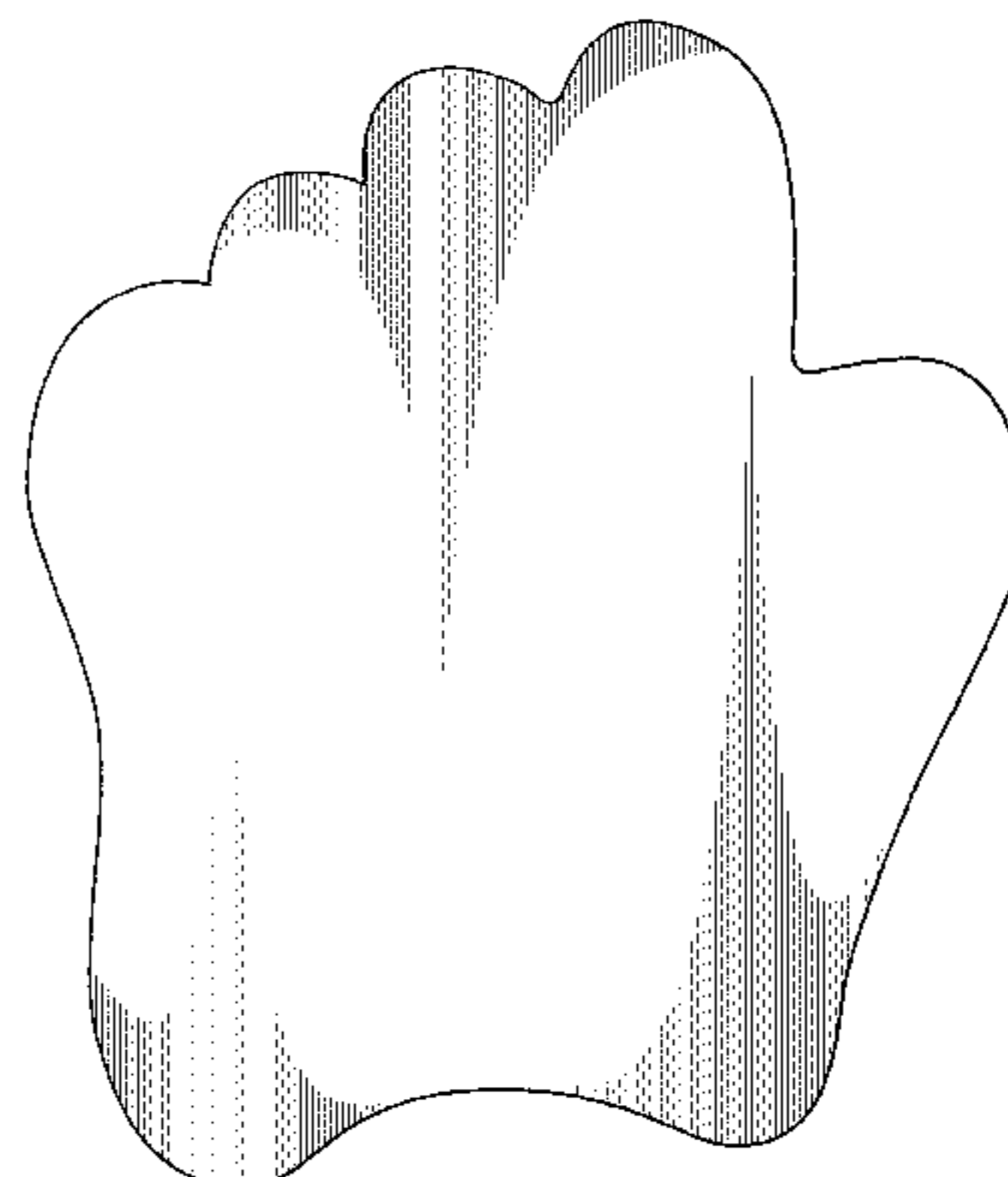
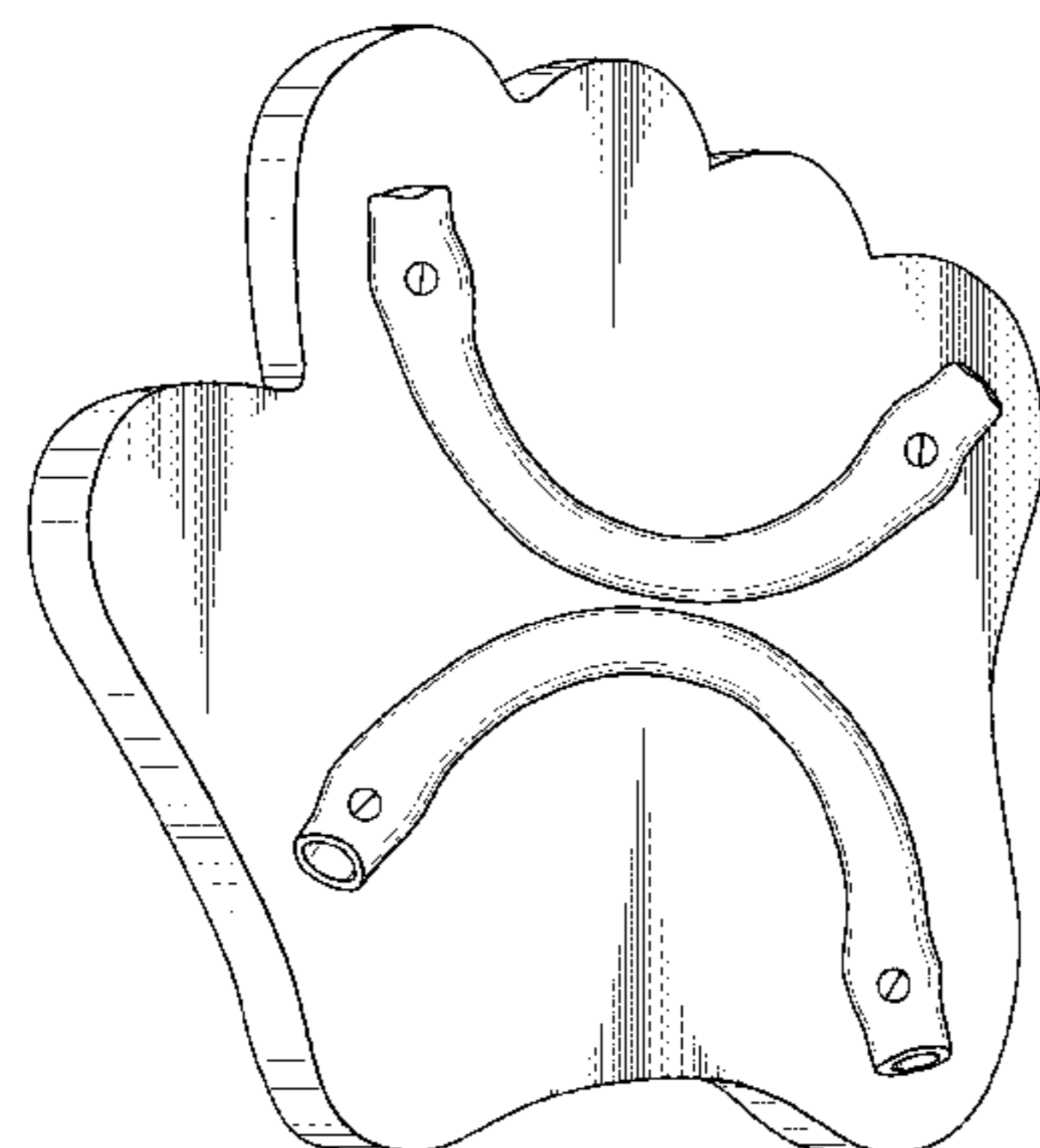
(57) **CLAIM**

The ornamental design for a racket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the racket taken from the back side thereof;

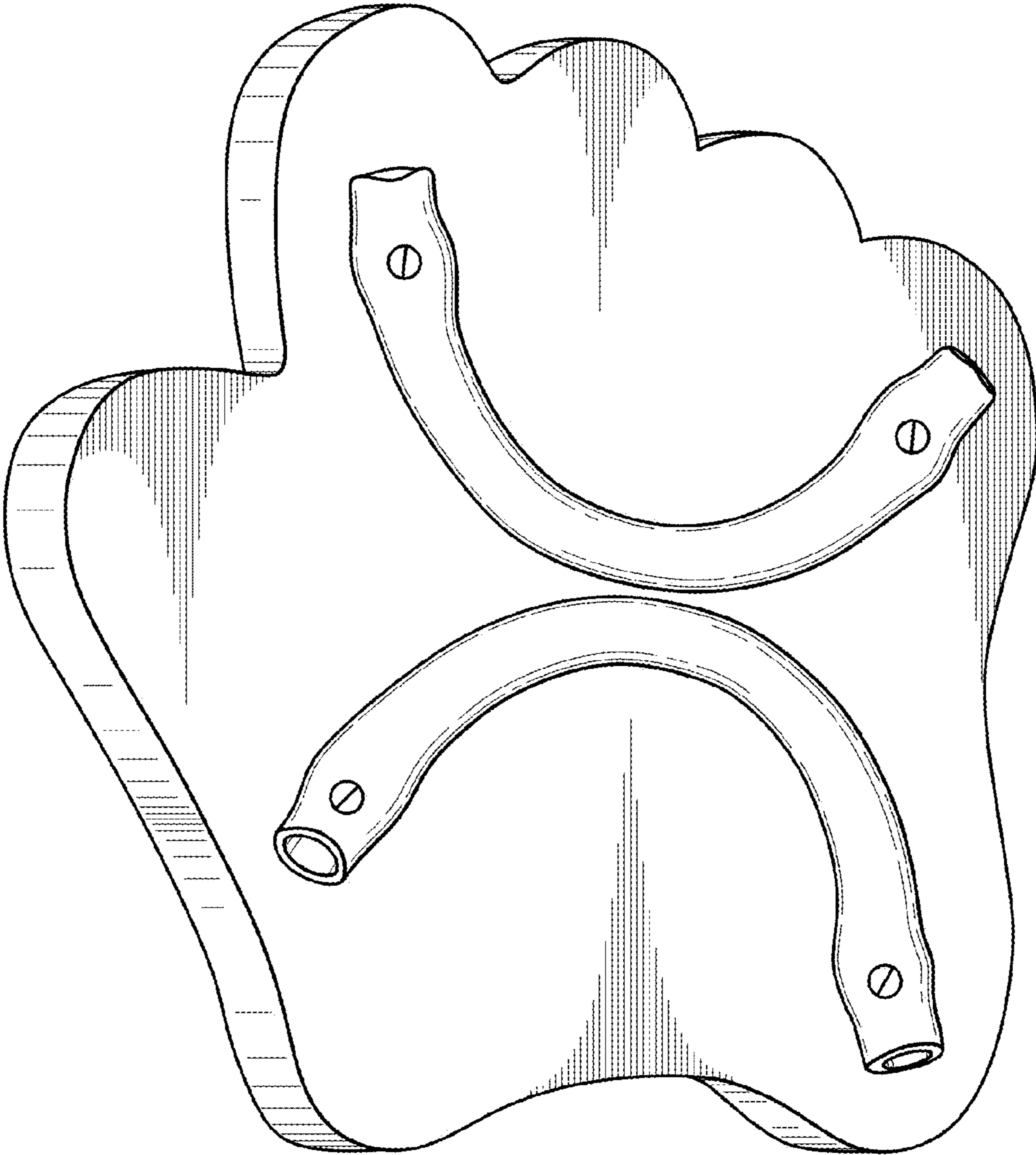

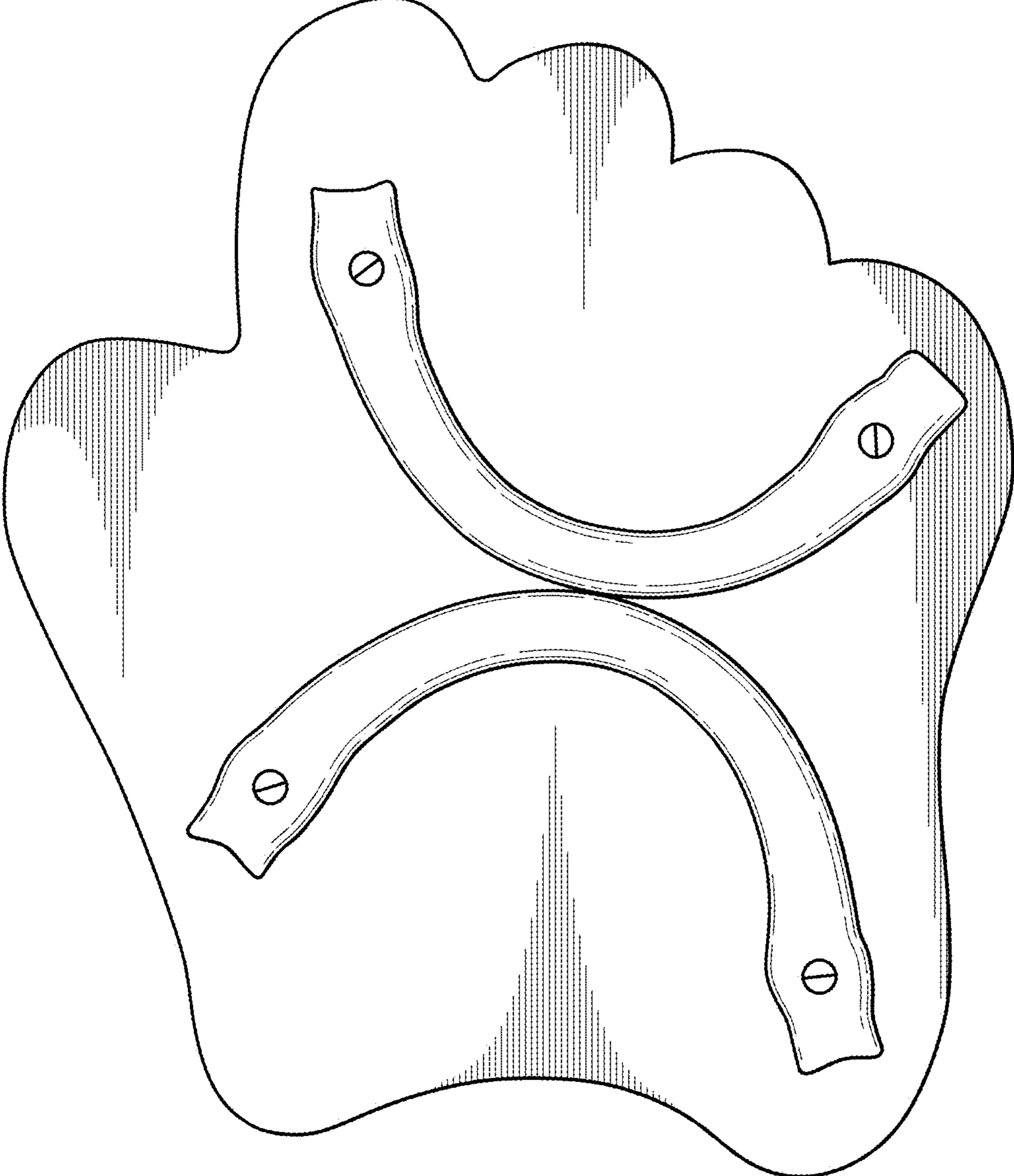

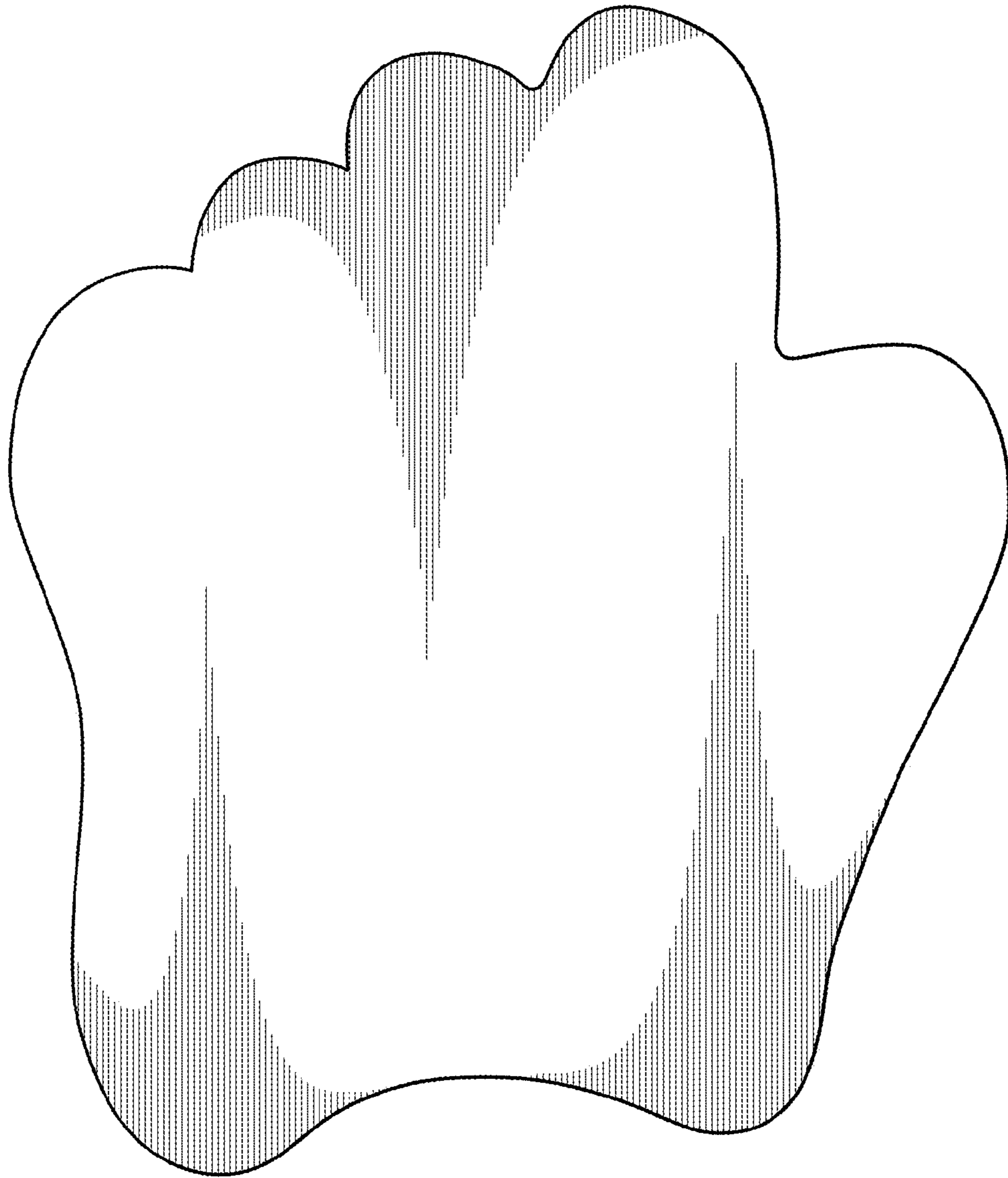

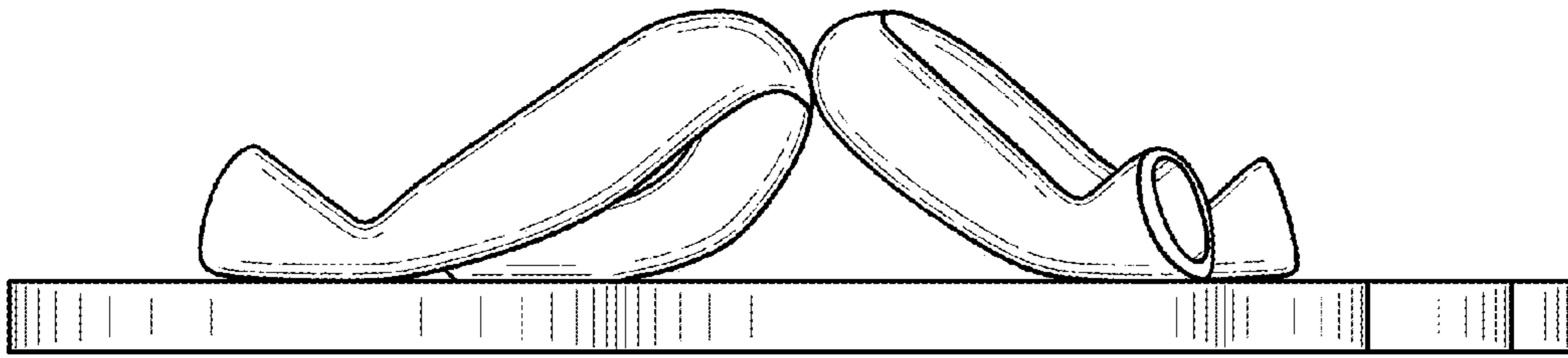

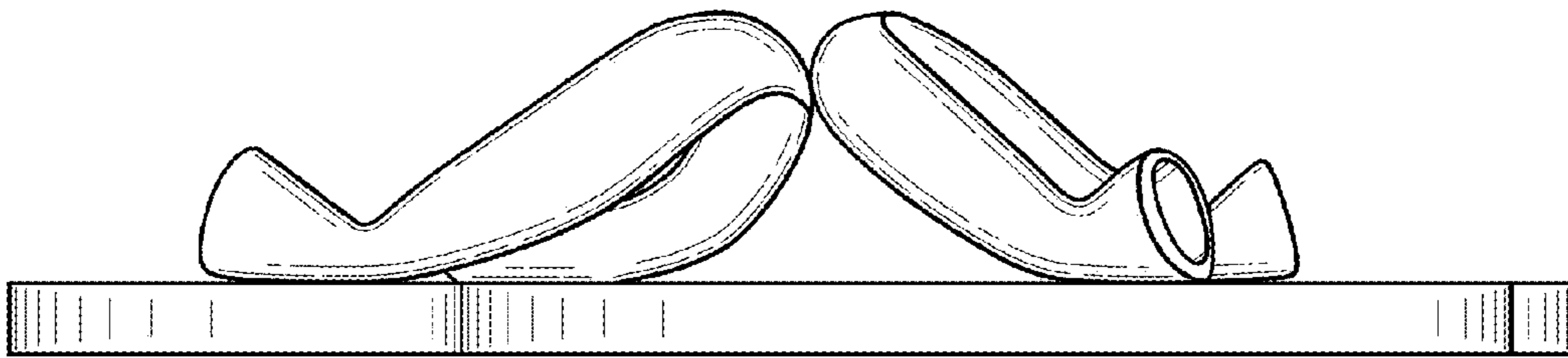

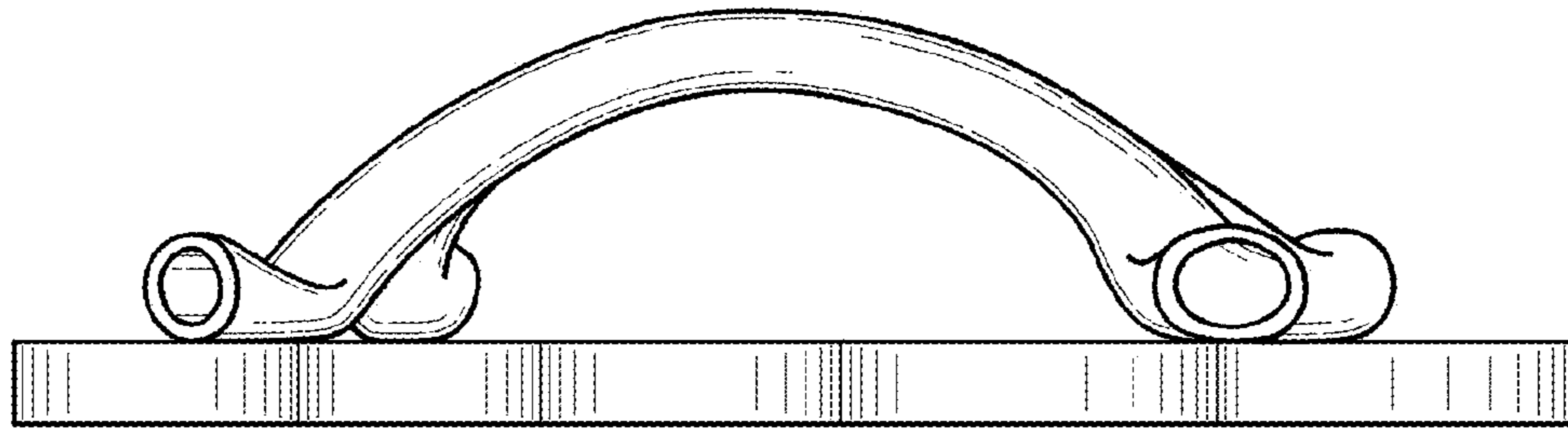

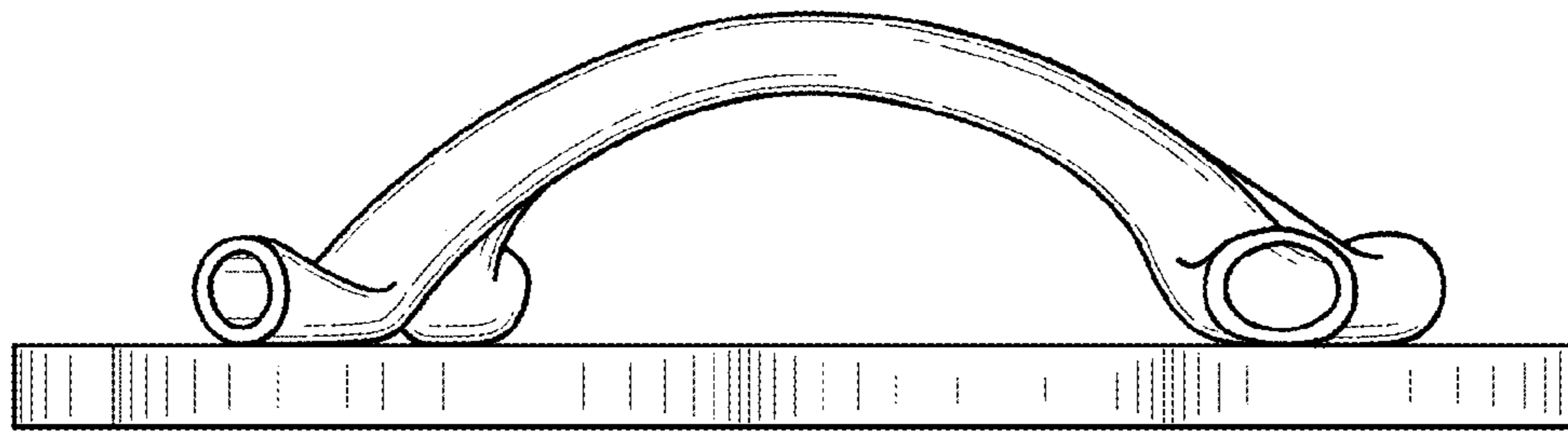

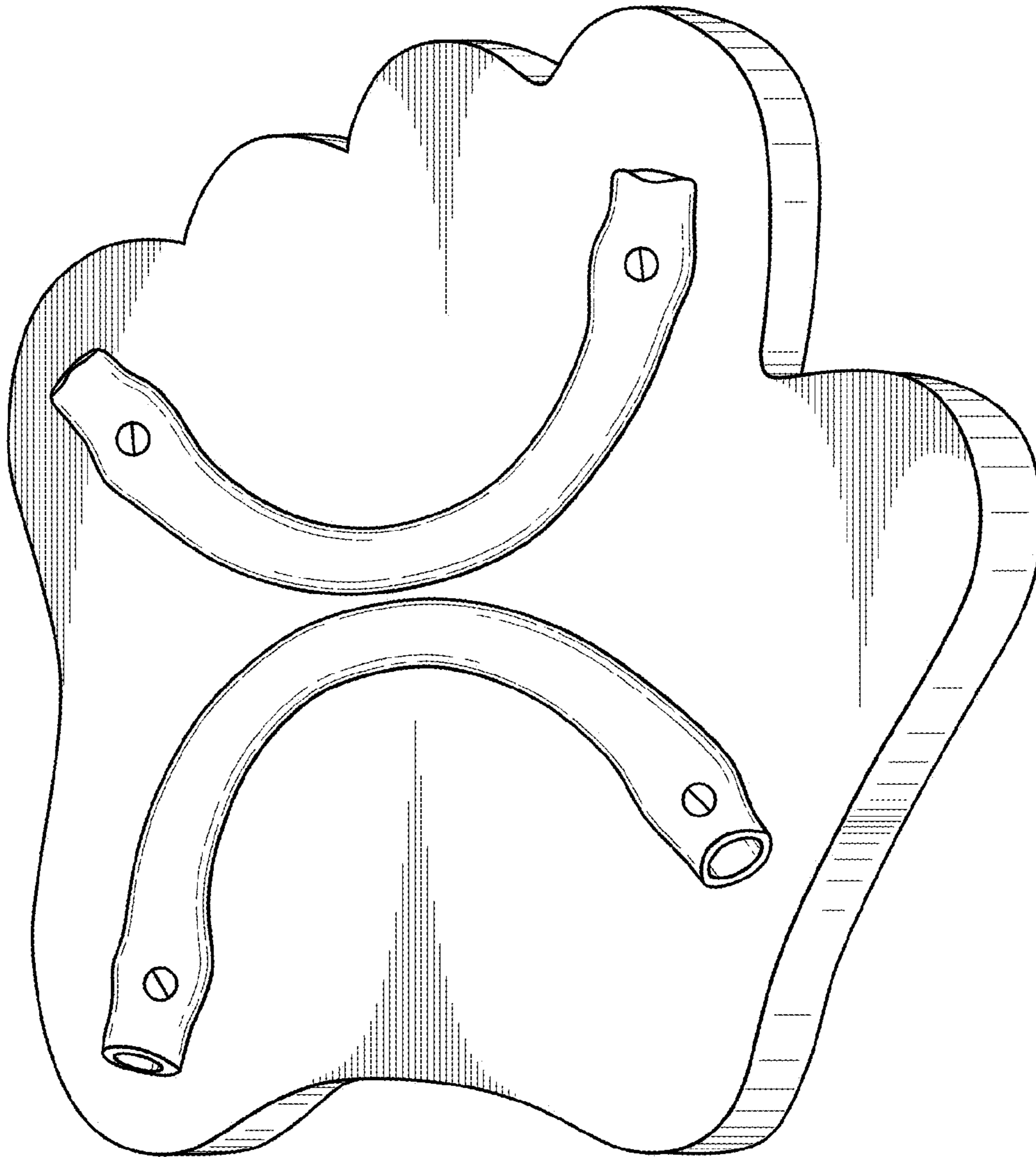

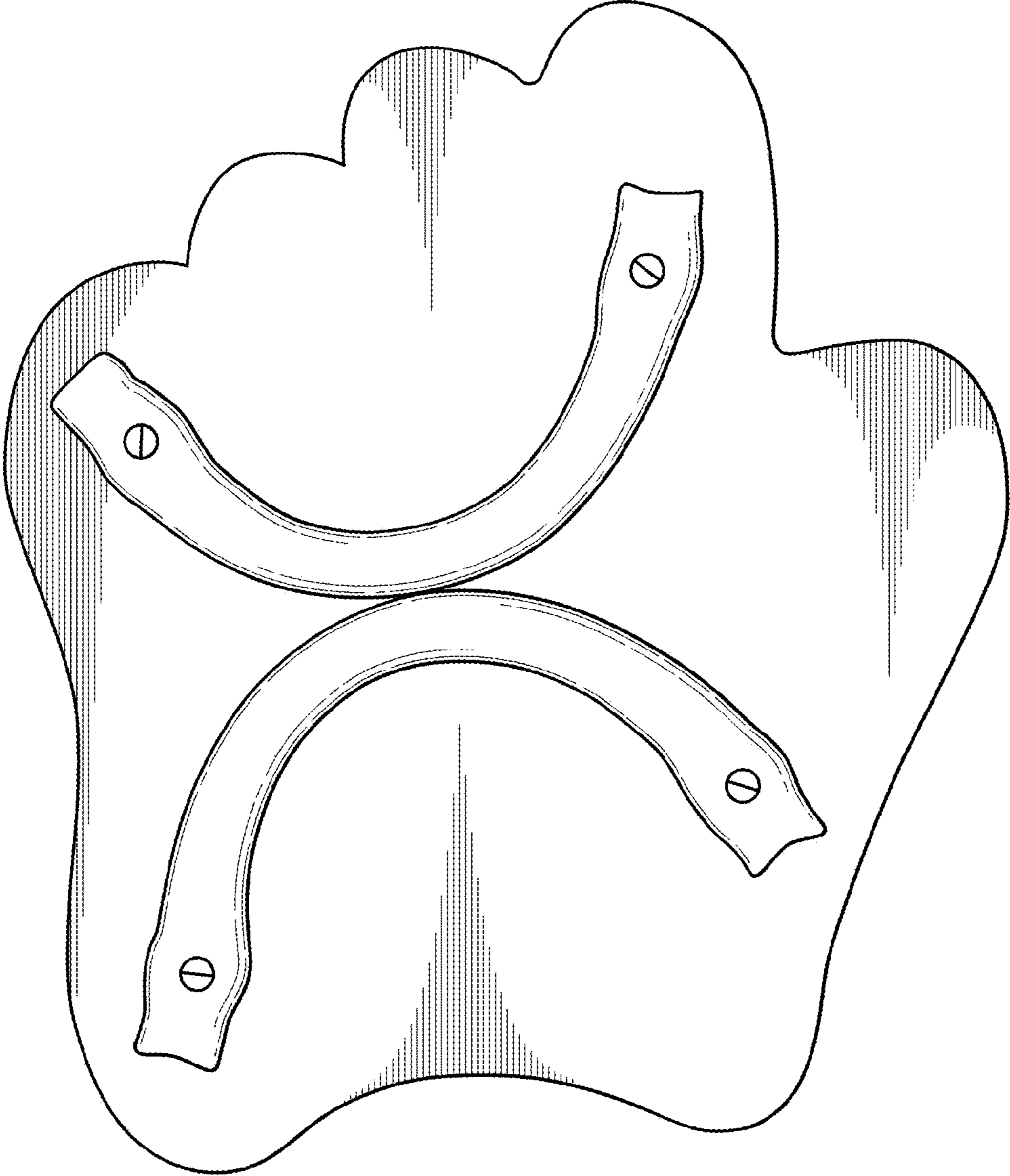

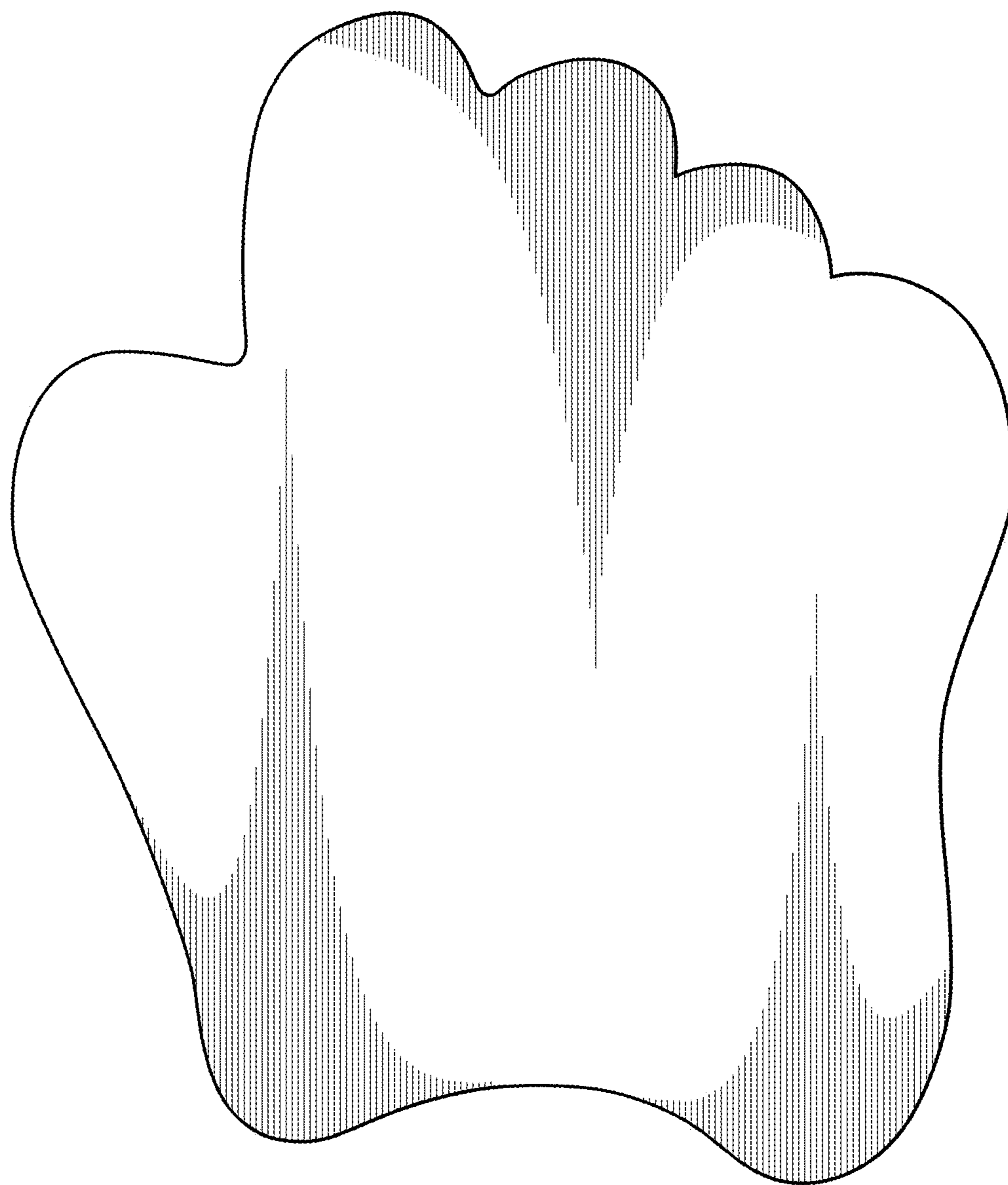

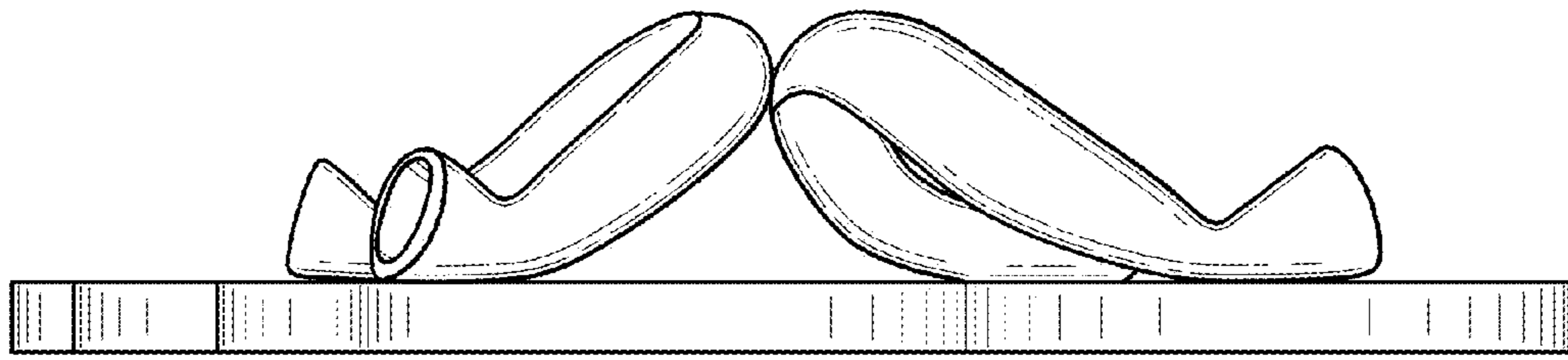

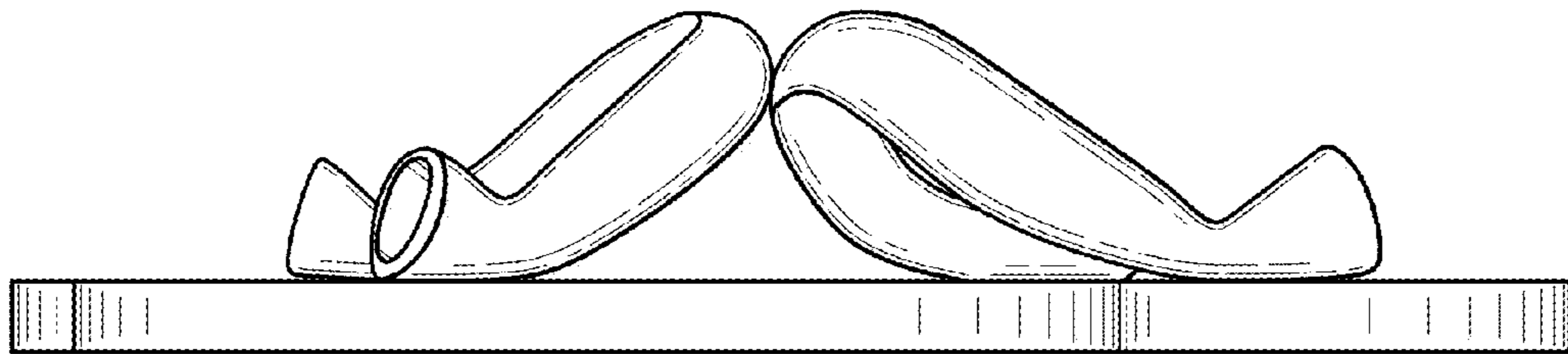

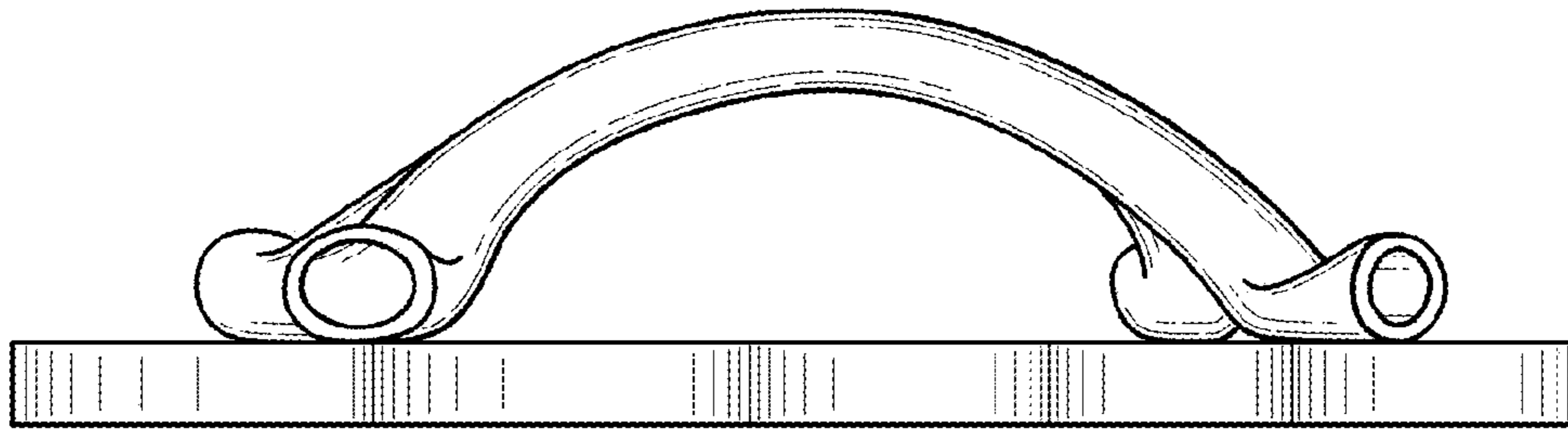

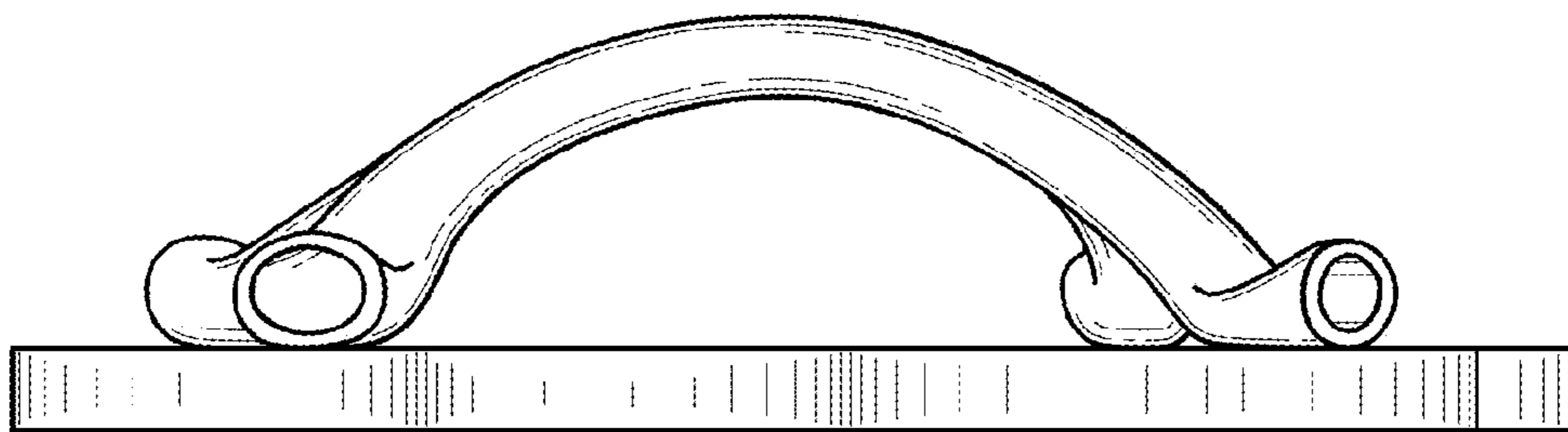

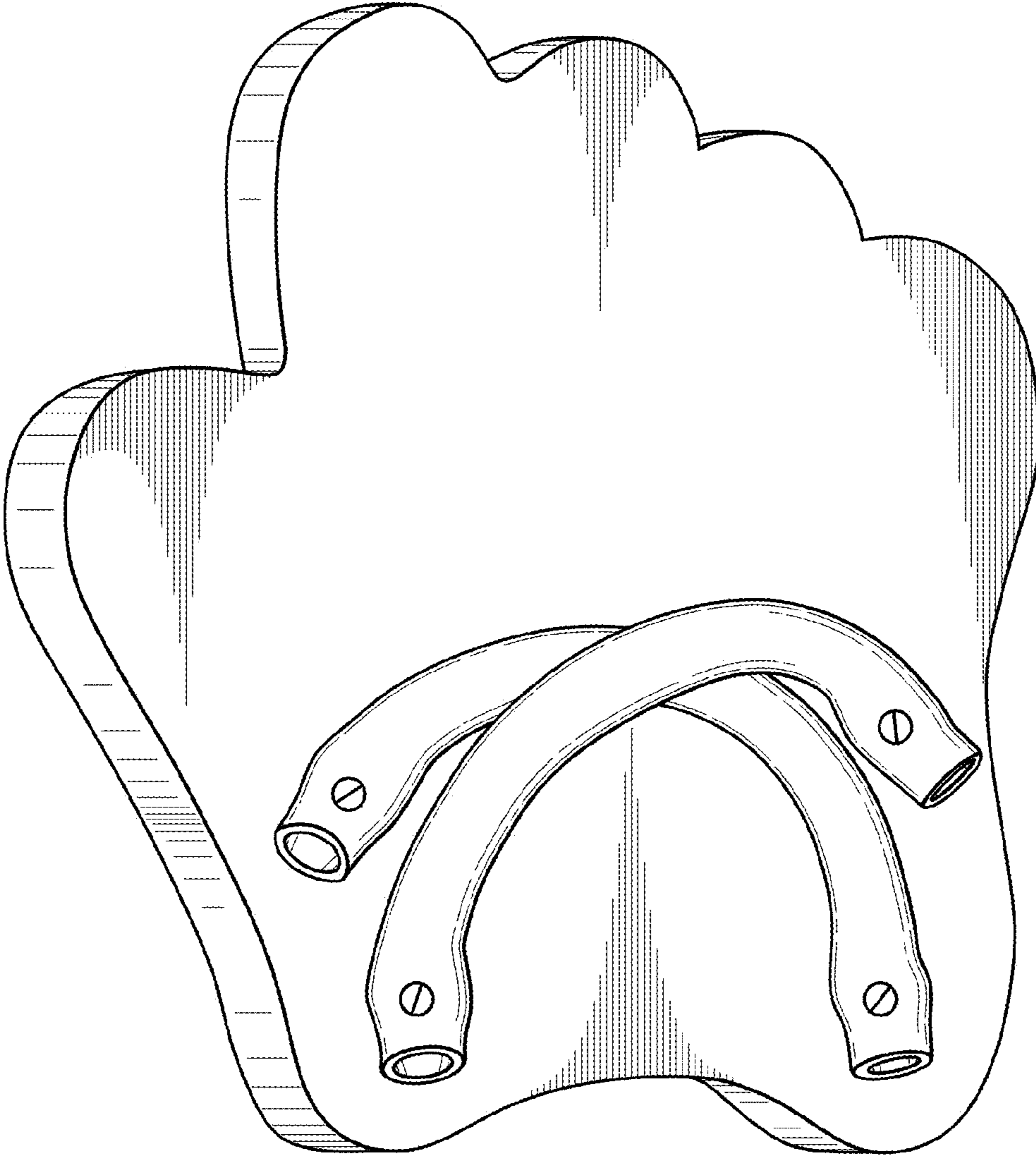

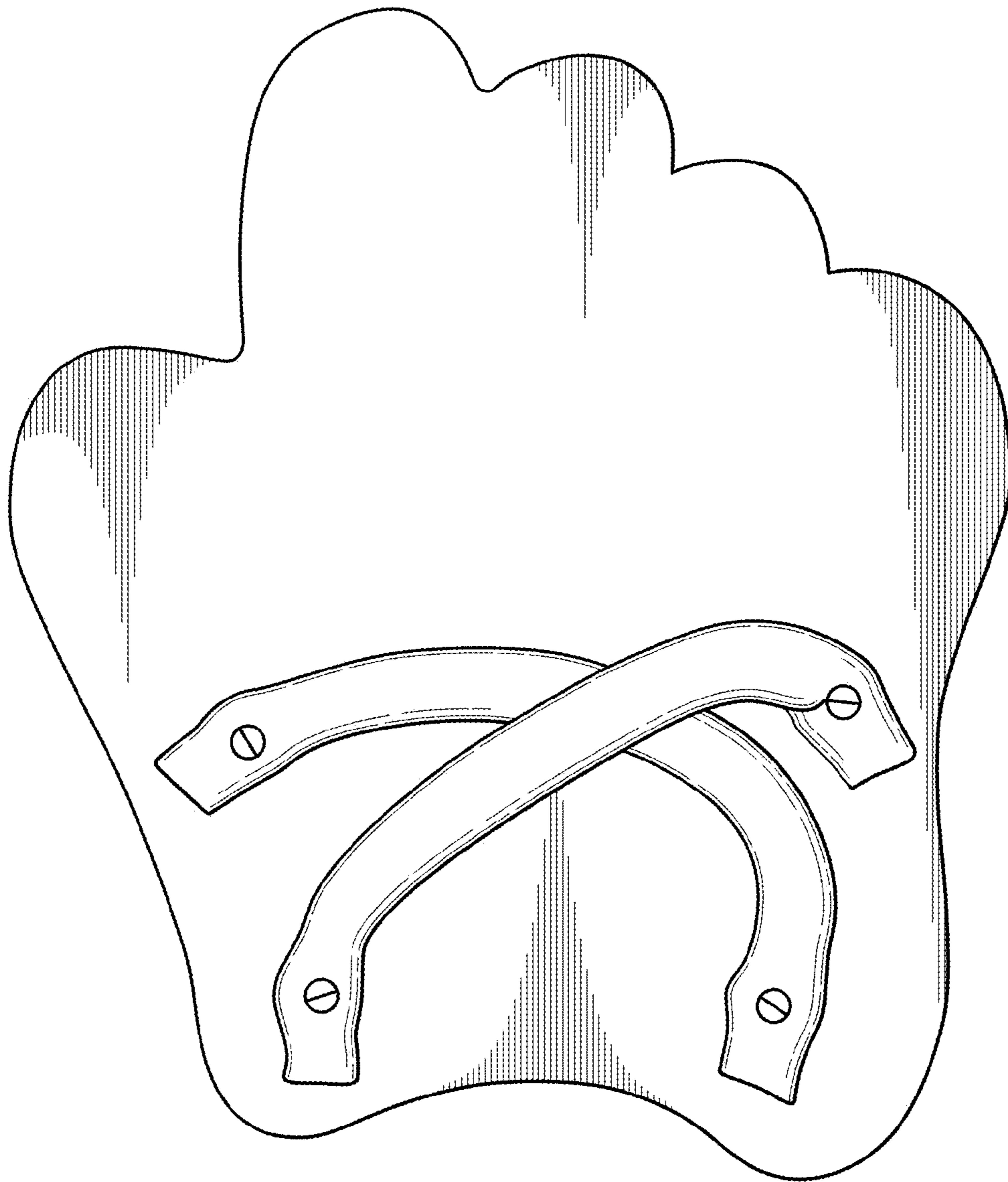

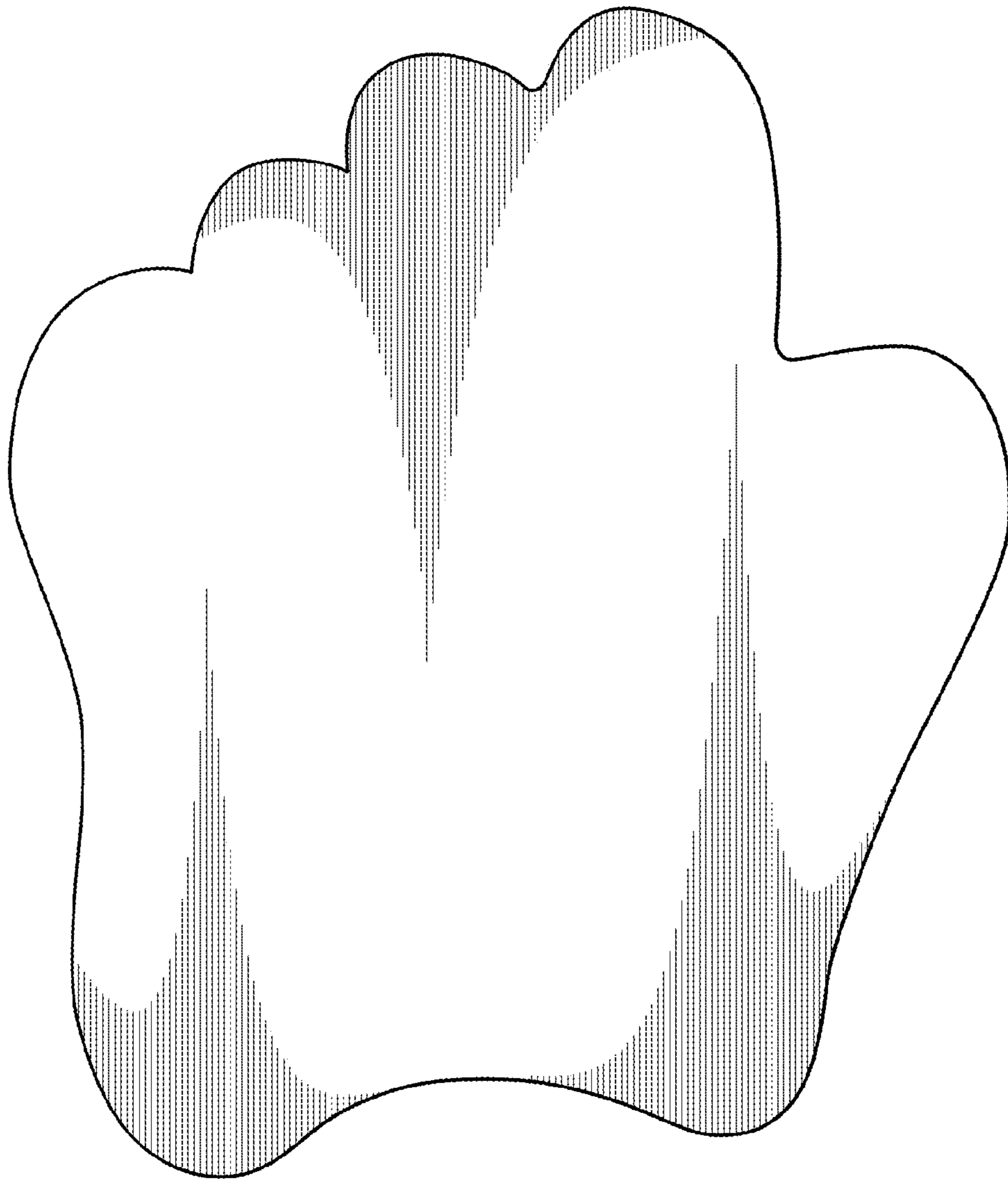

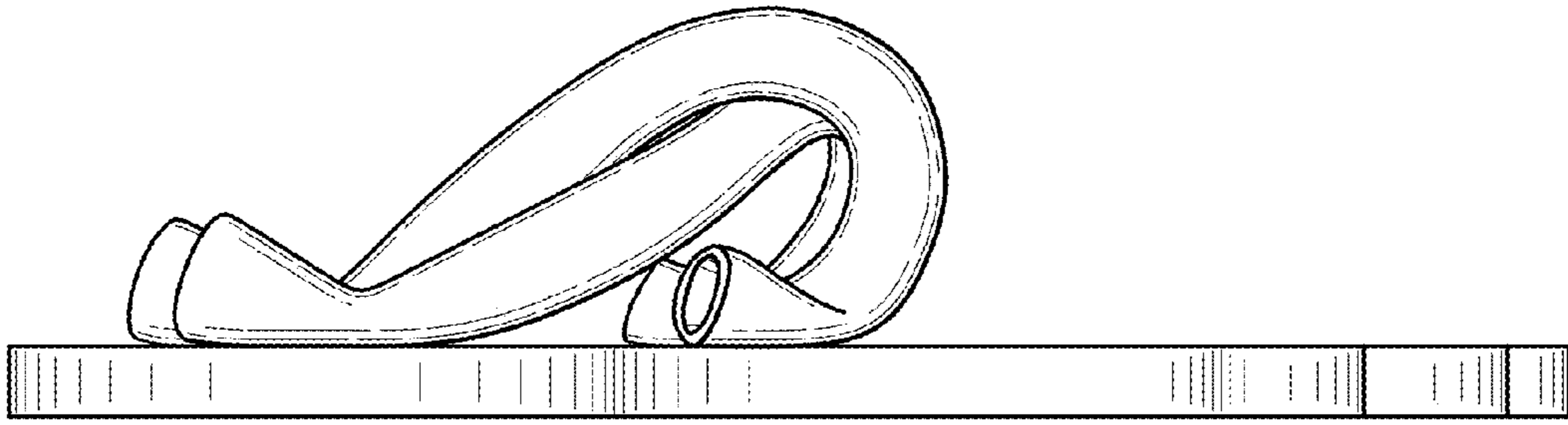

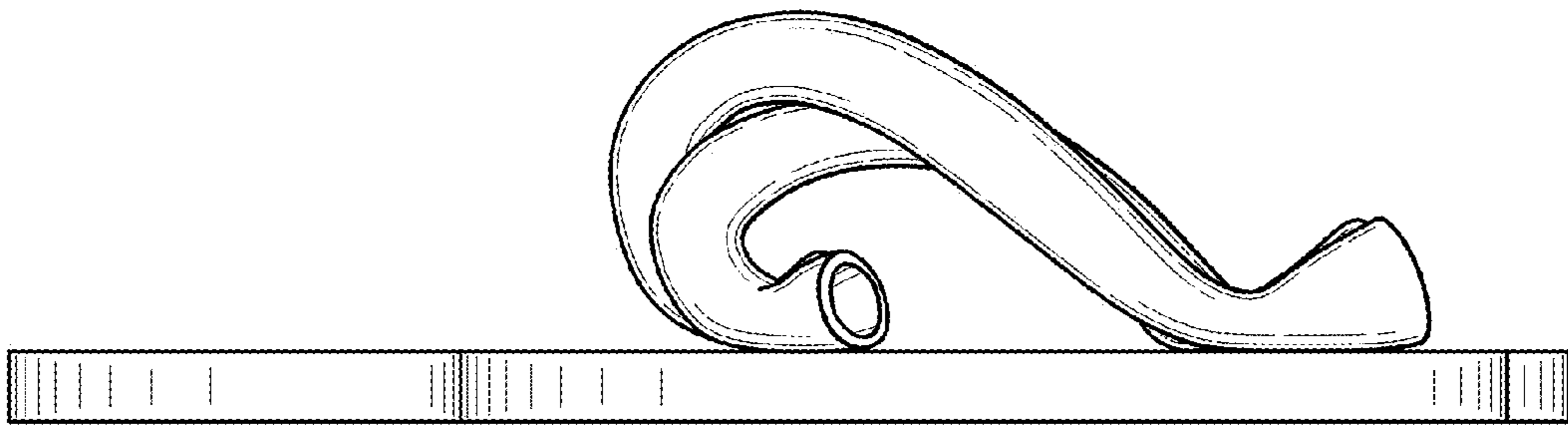

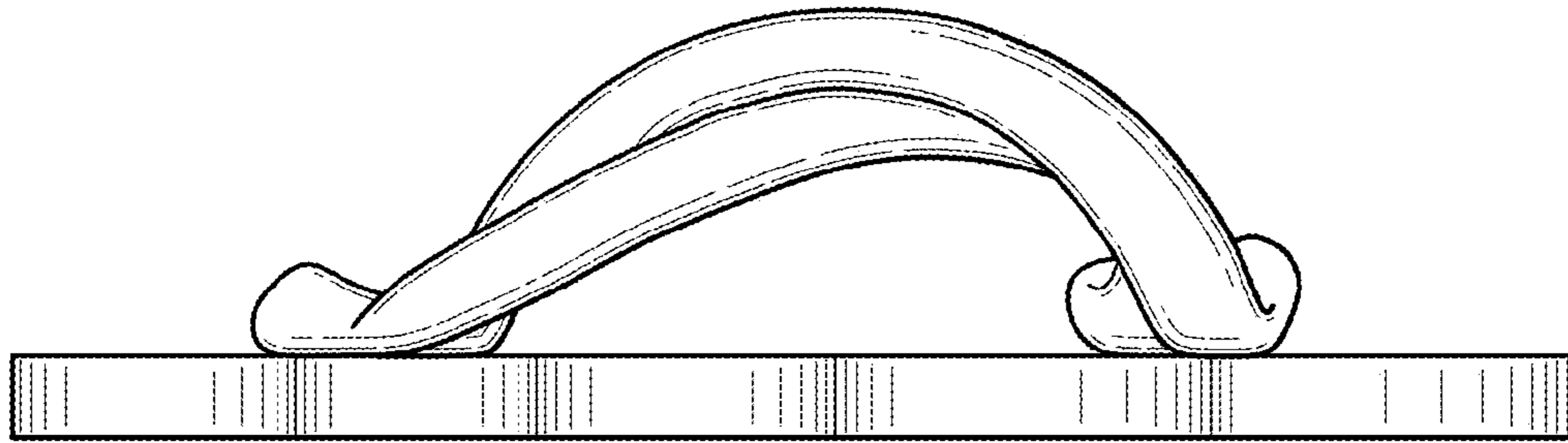

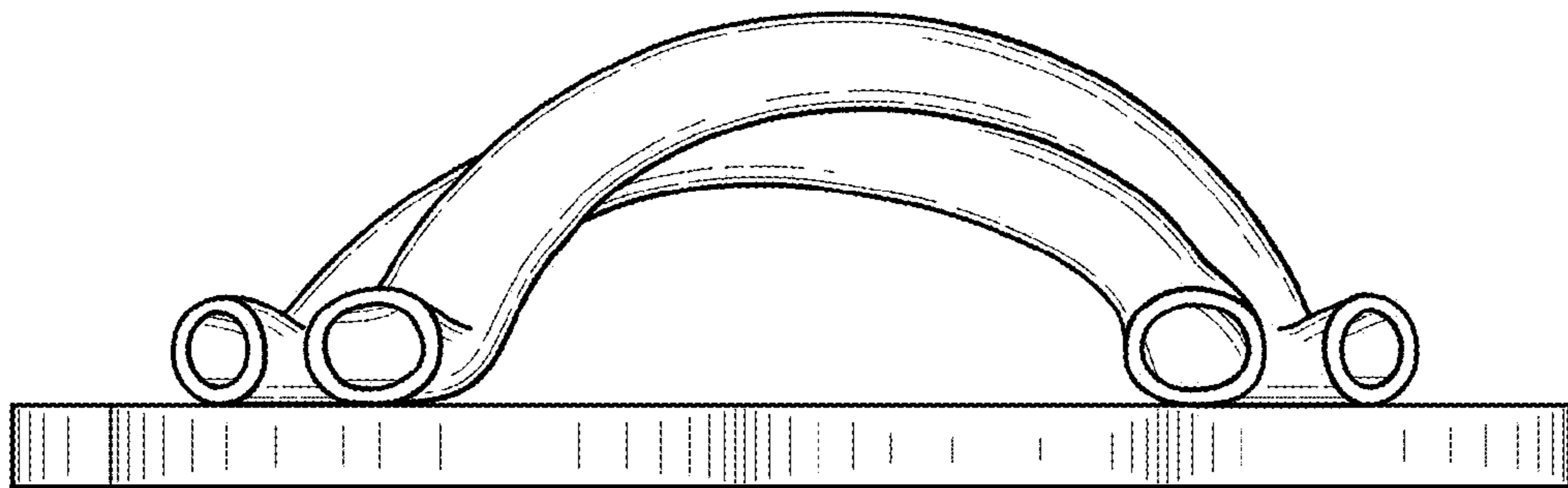

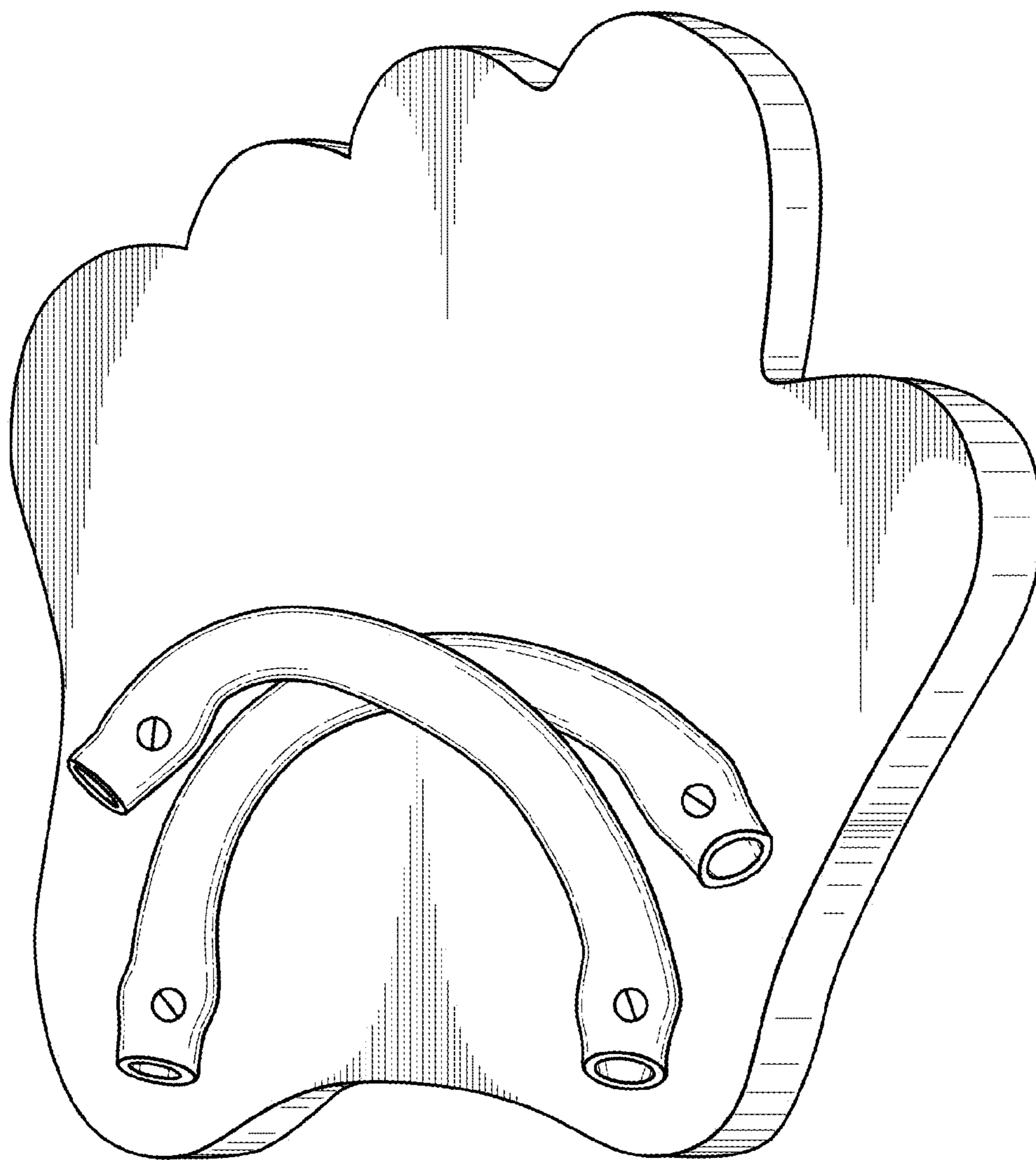

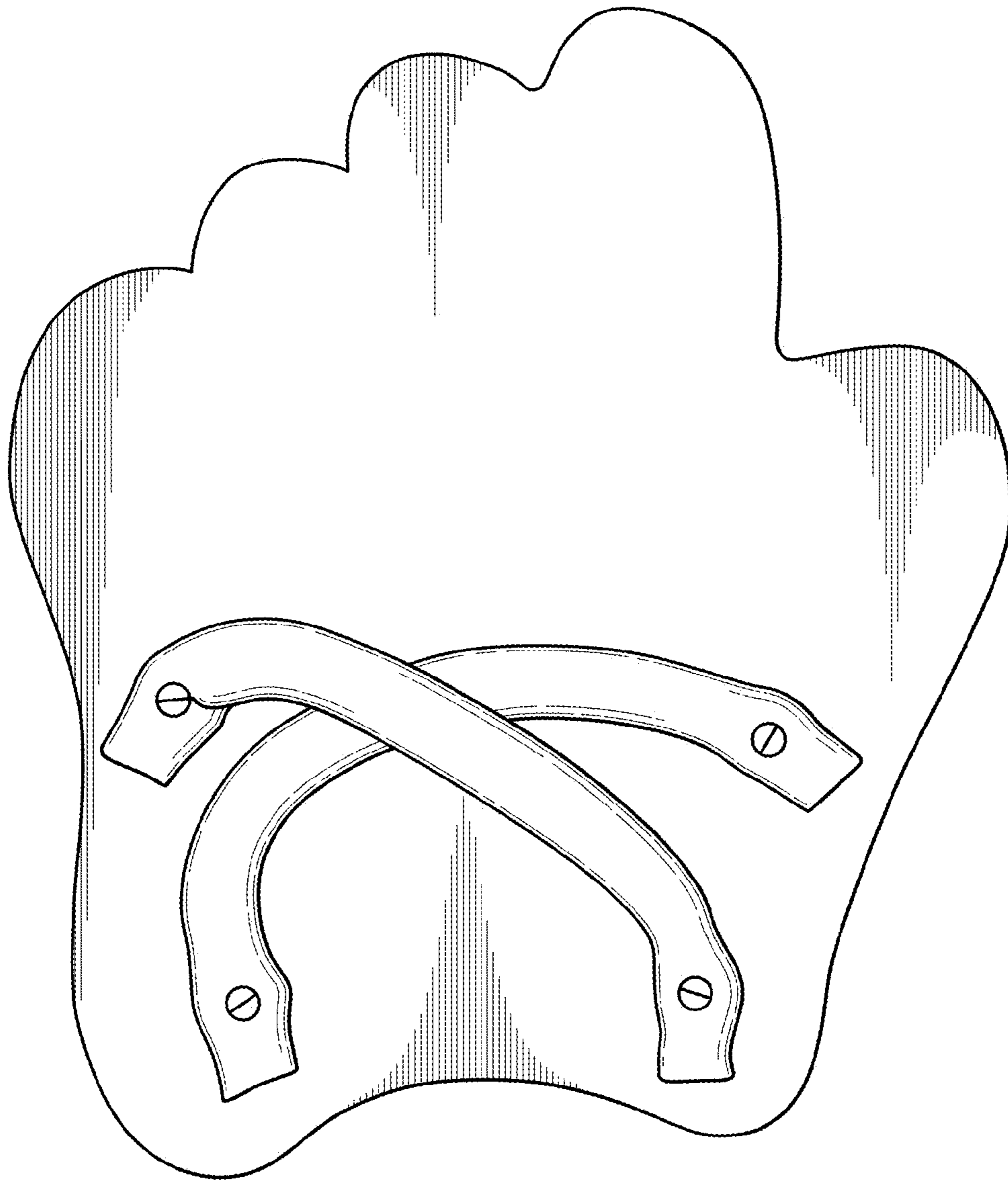

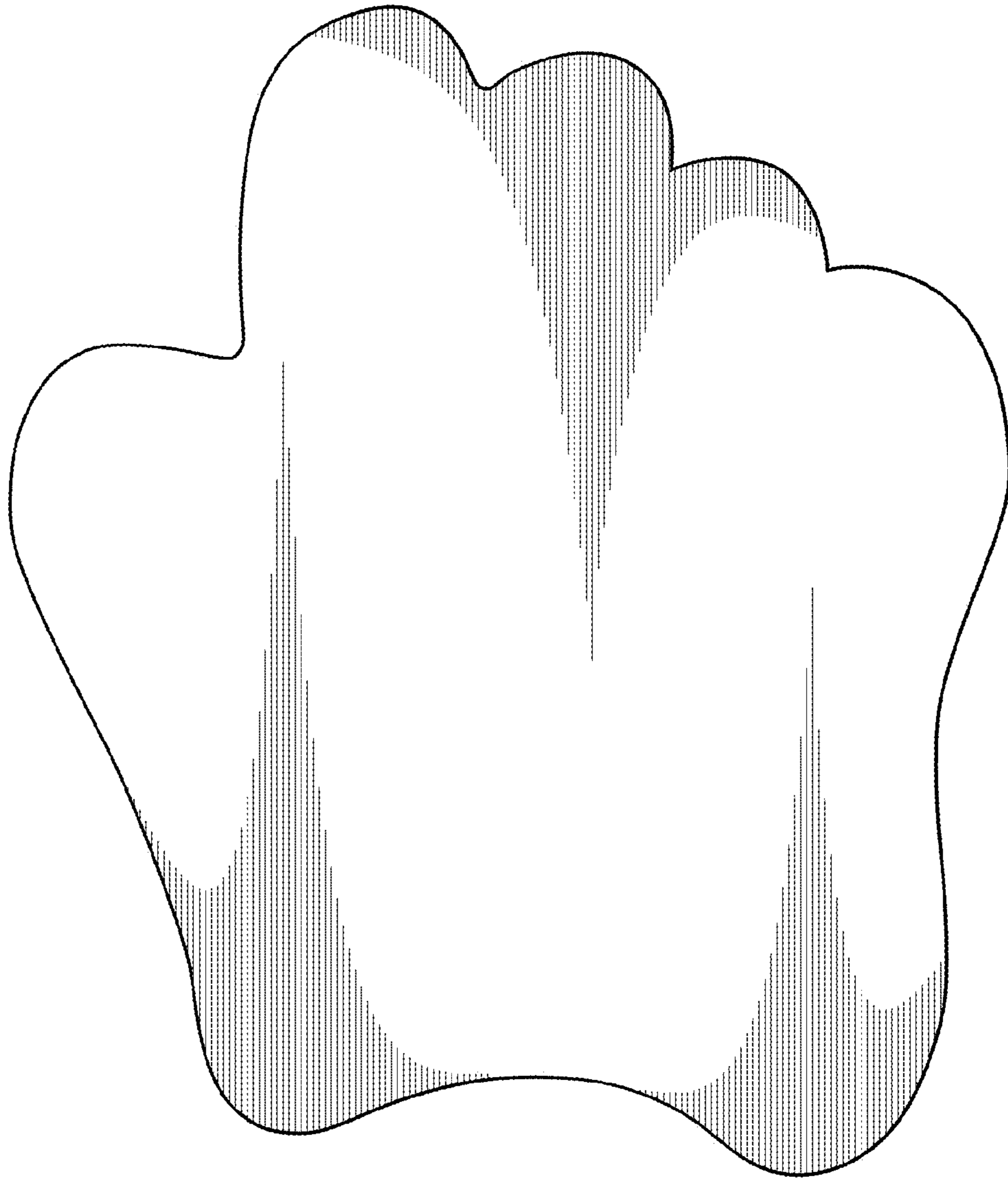

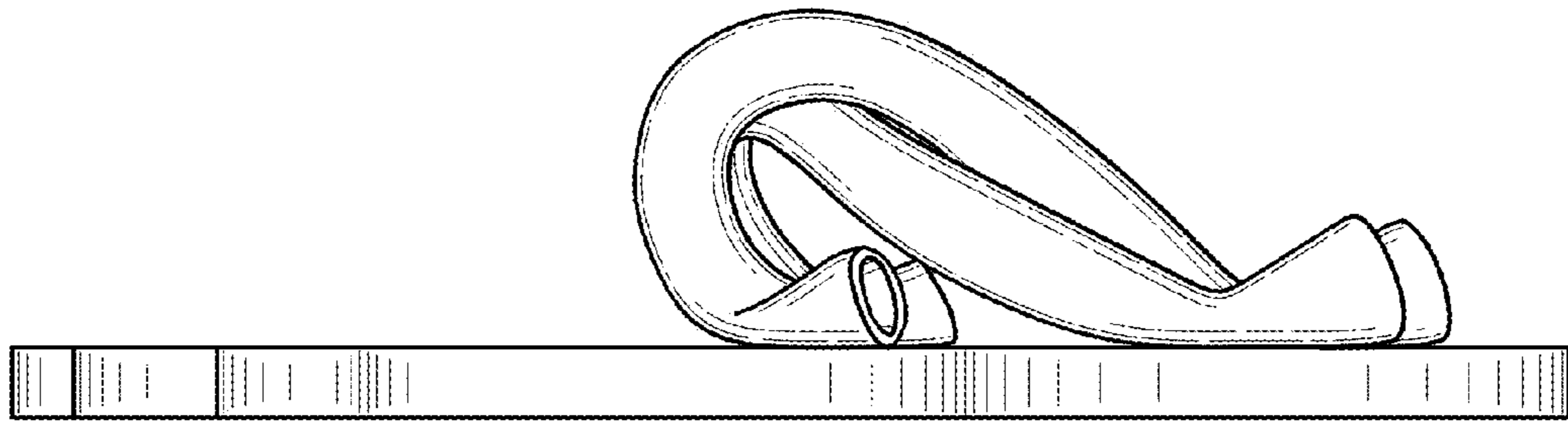

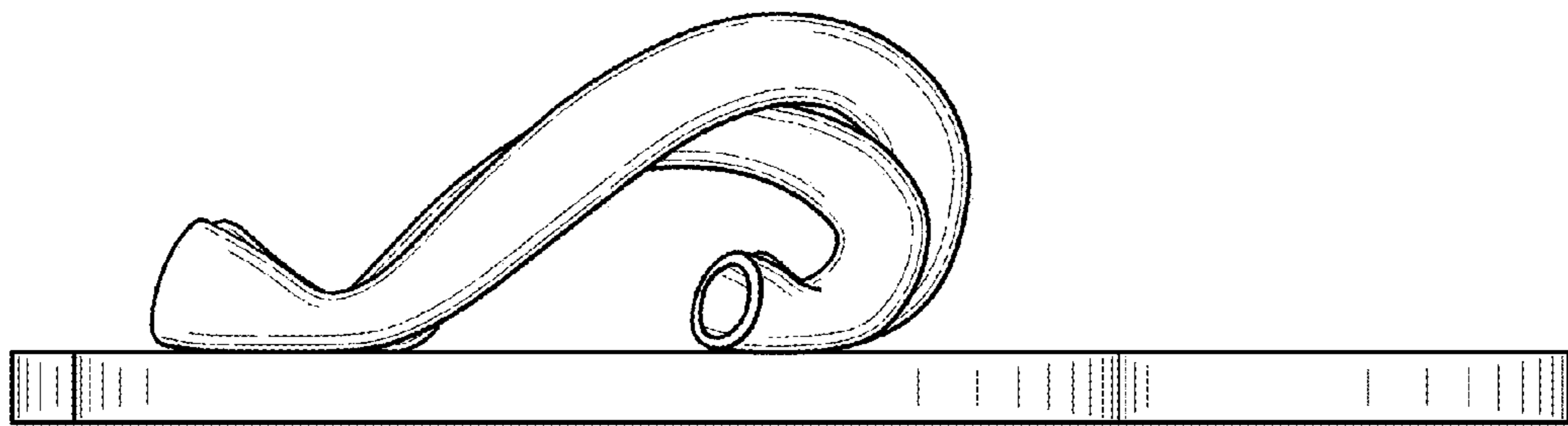

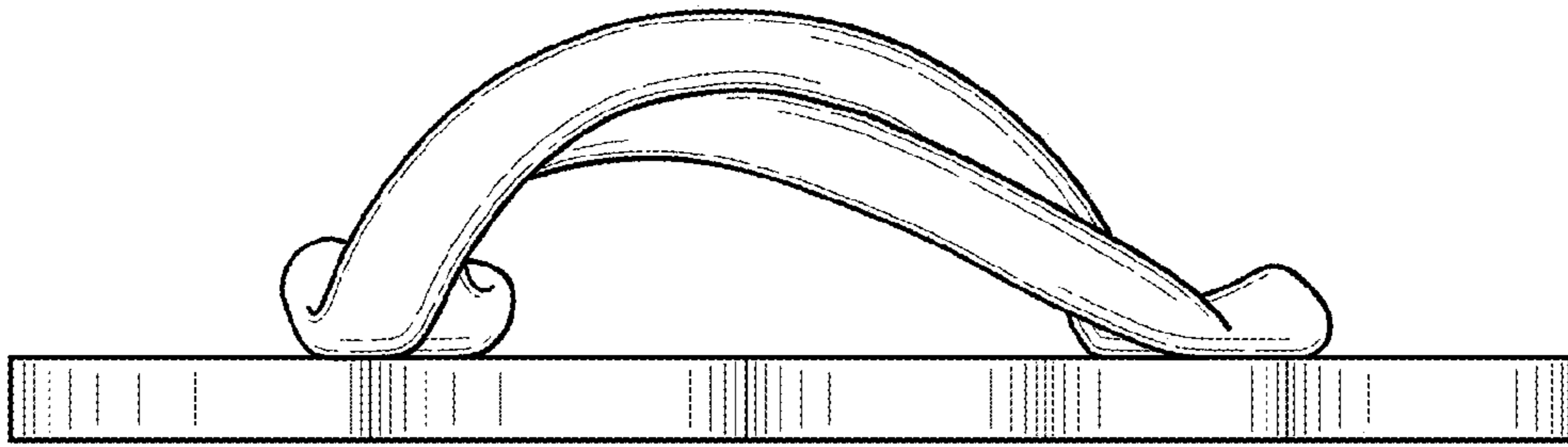

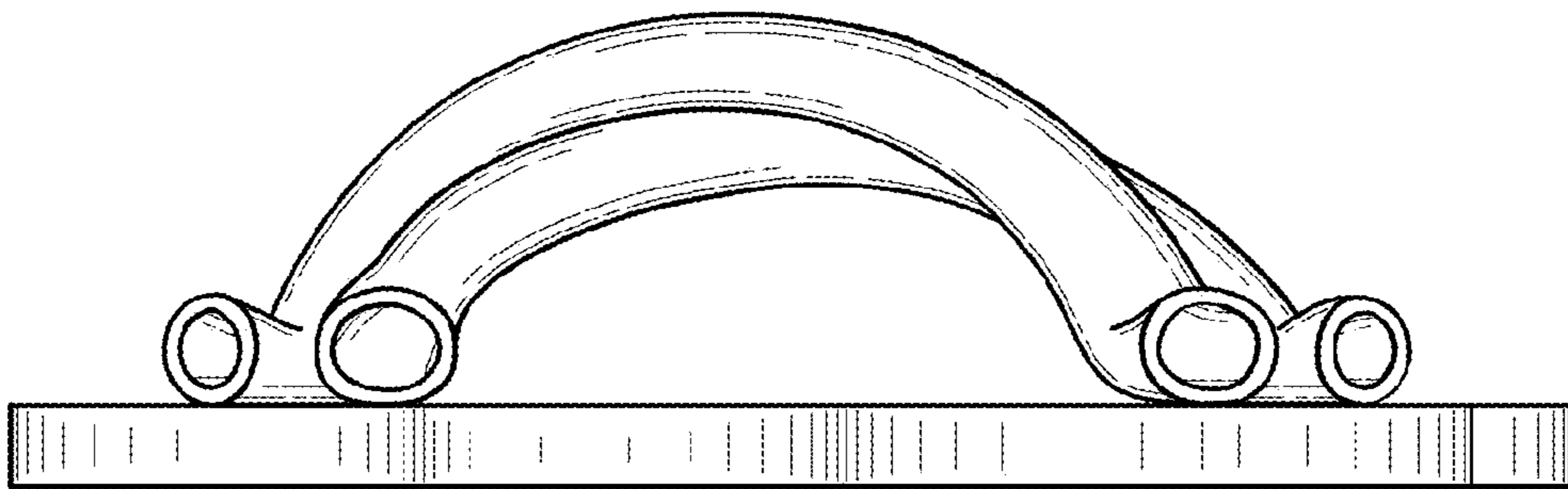
