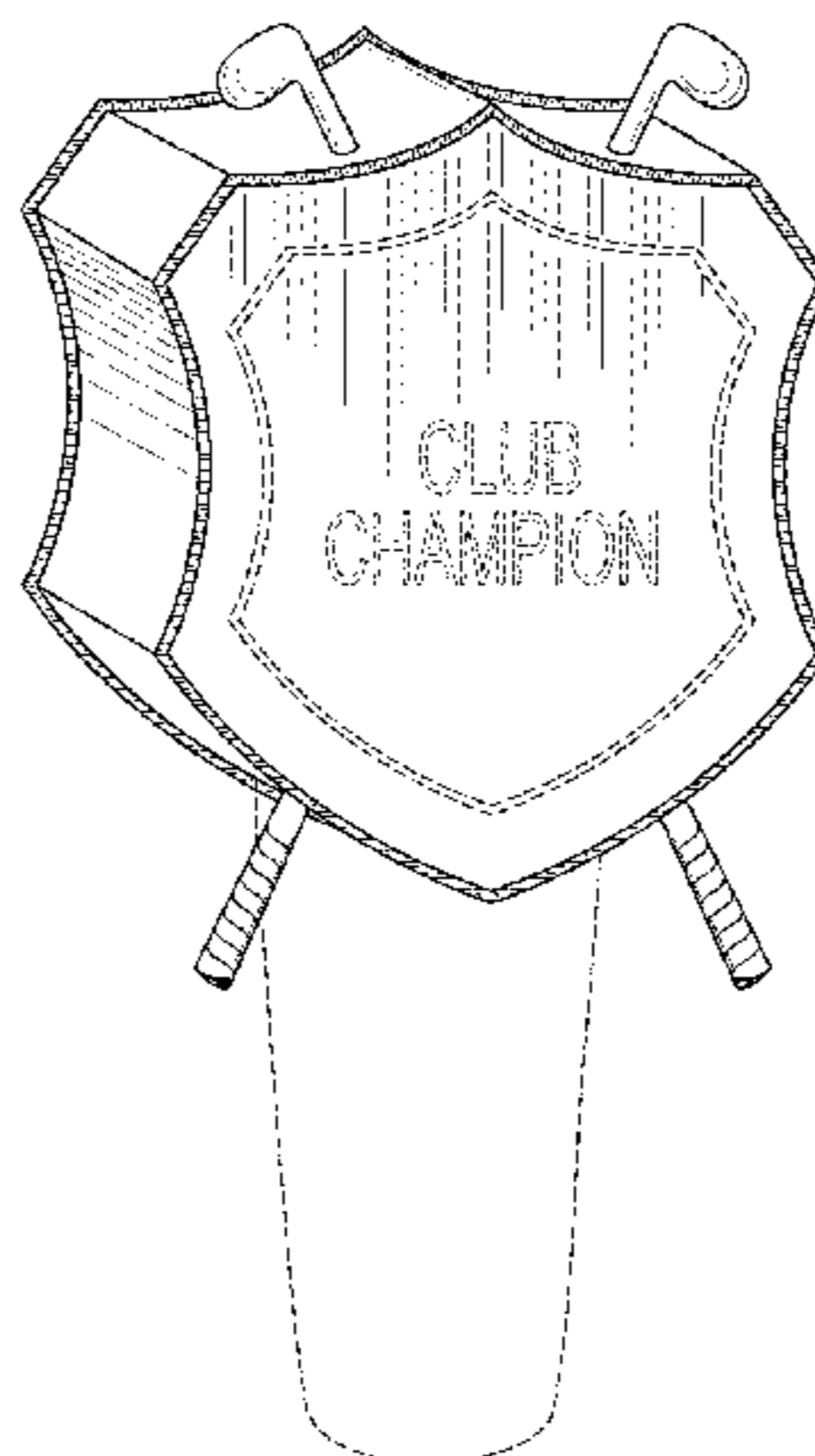

The ornamental design for a golf club head cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a golf club head cover;
FIG. 2 is a perspective view of a golf club head cover shown exploded from an unclaimed golf club head;
FIG. 3 is a perspective view of a golf club head cover shown attached to an unclaimed trophy base;
FIG. 4 is a front view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a top view thereof; and,
FIG. 9 is a bottom view thereof.

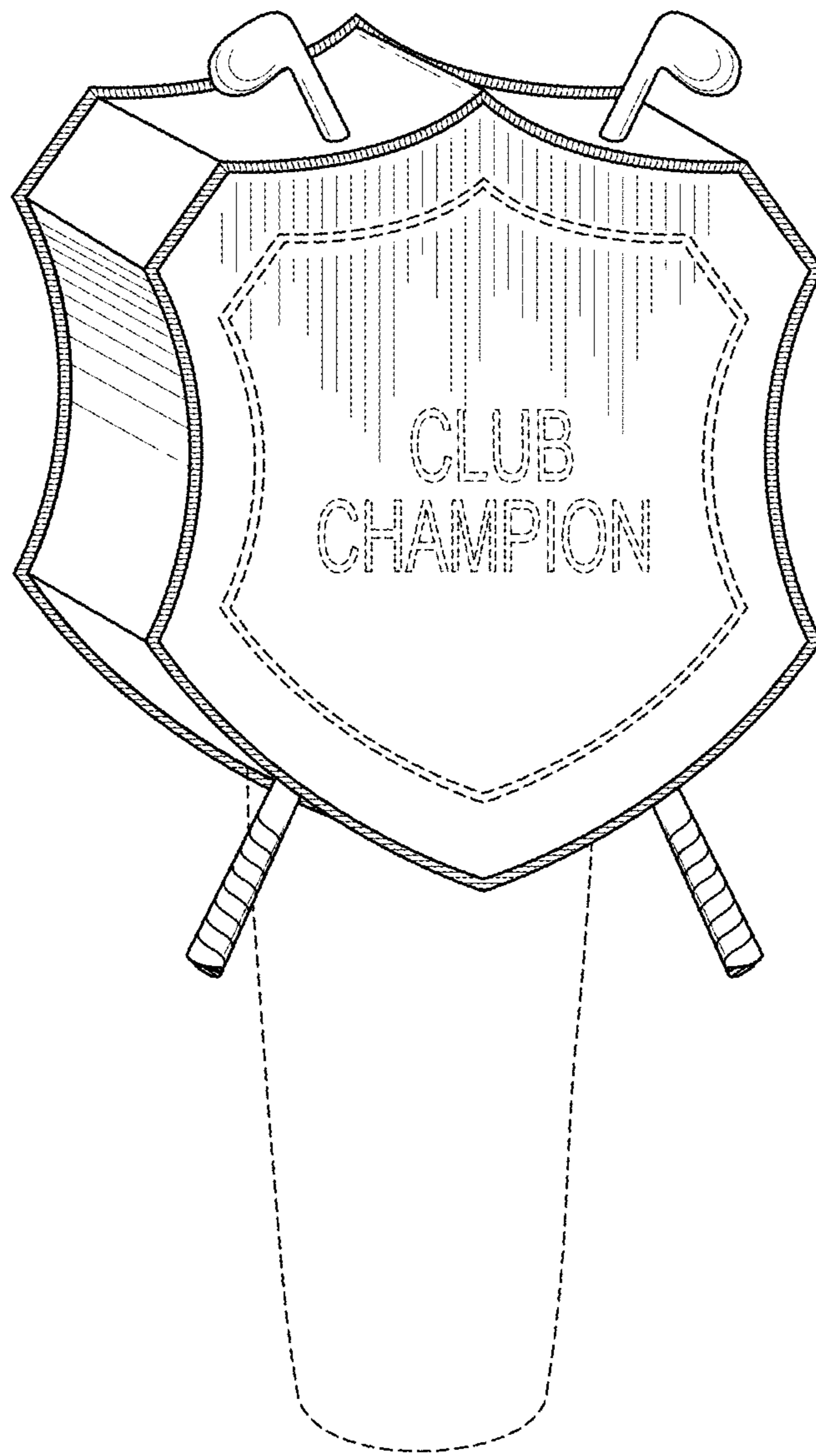

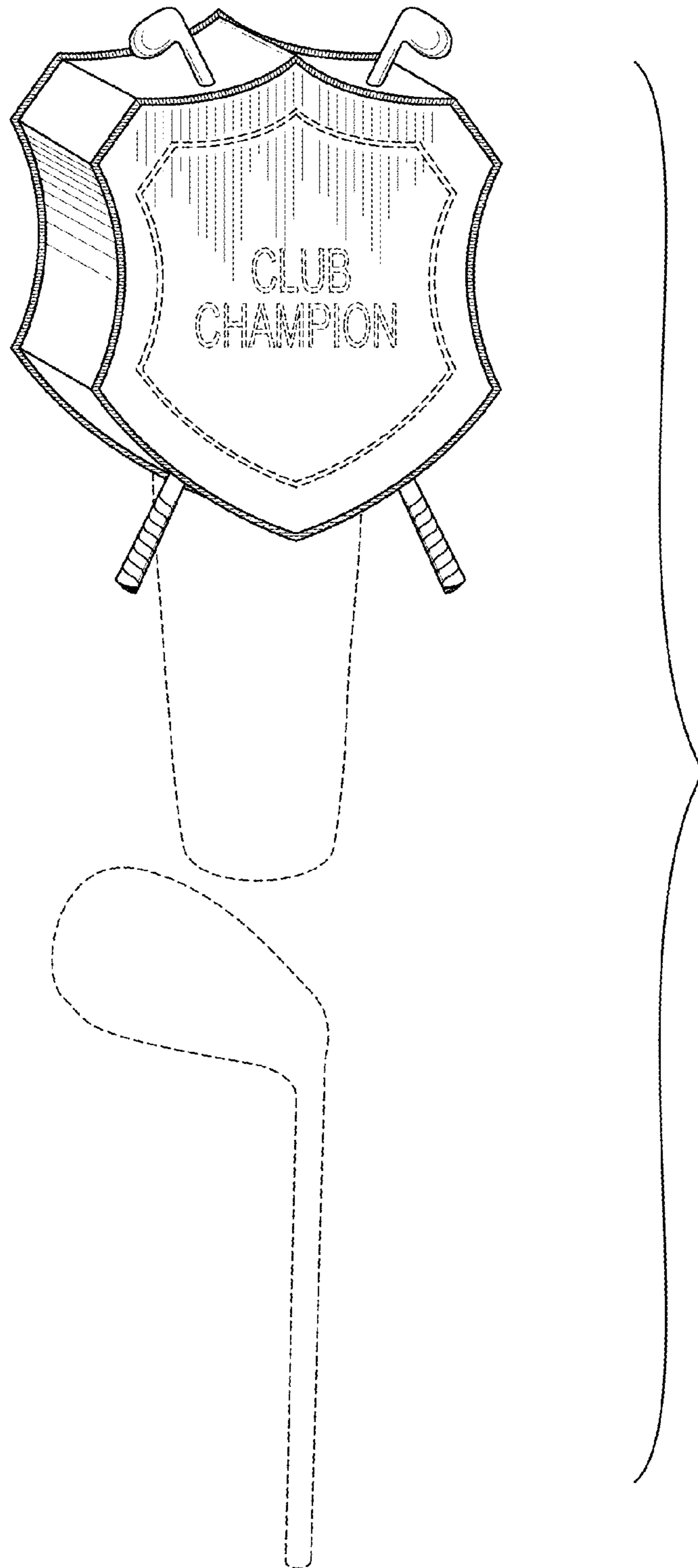

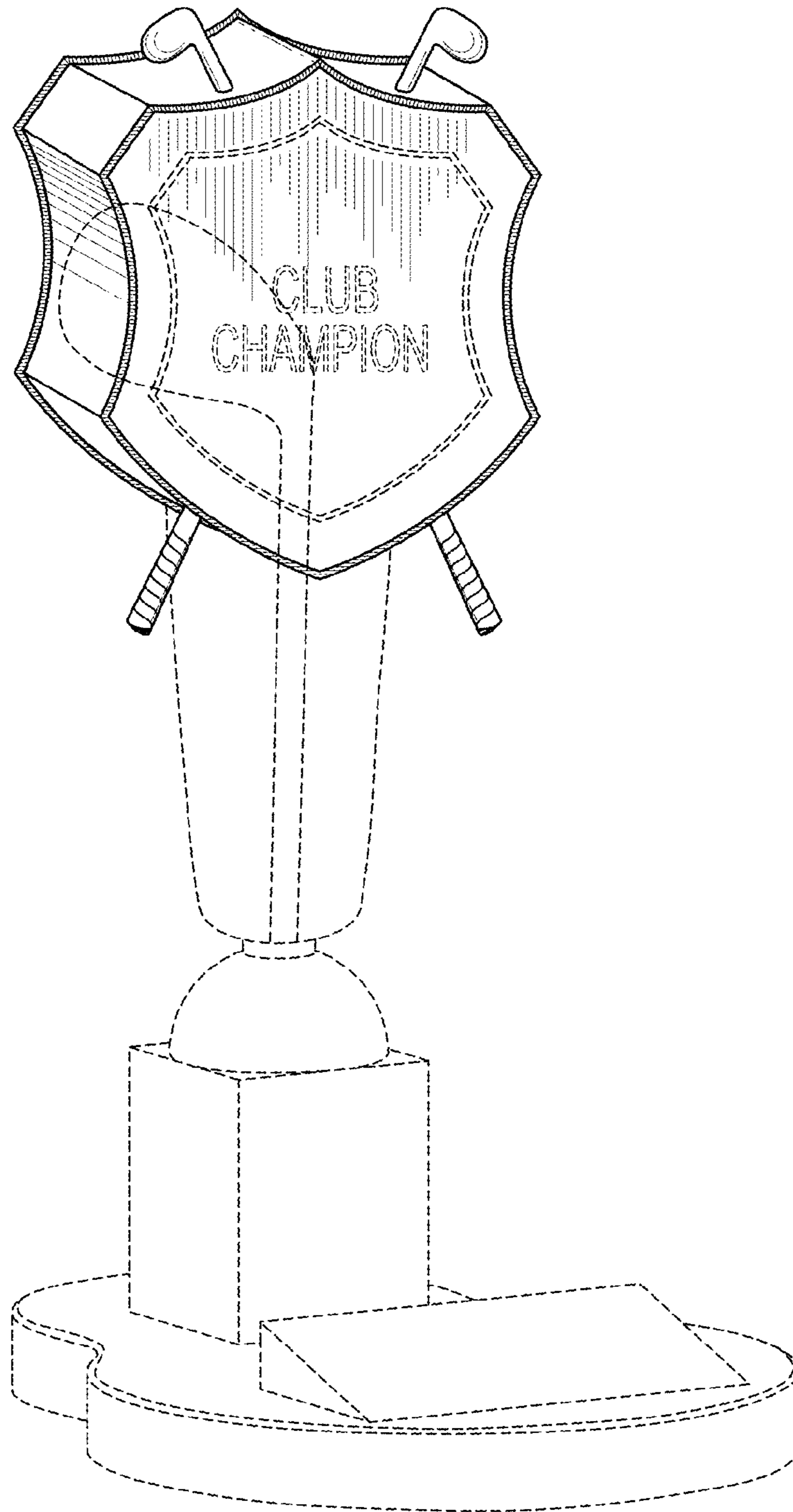

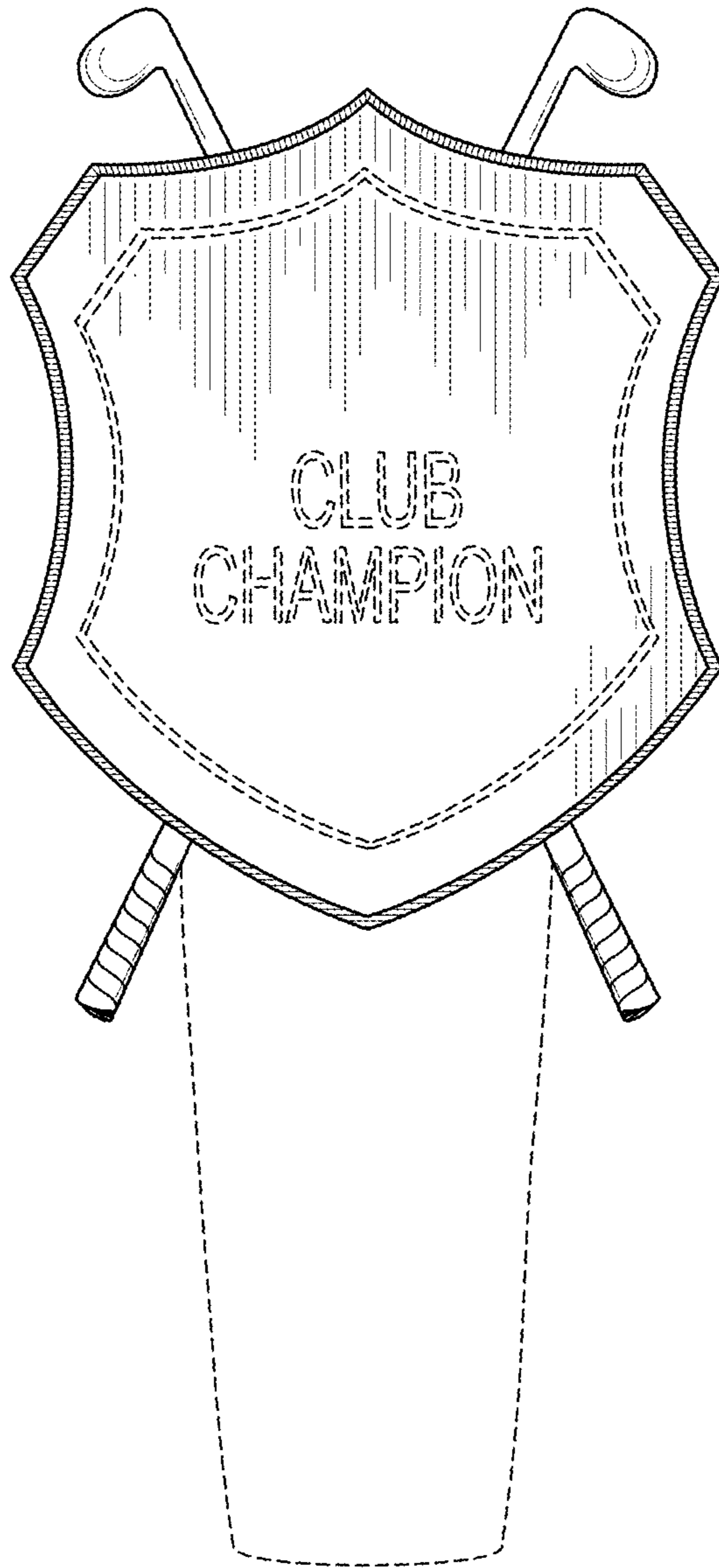

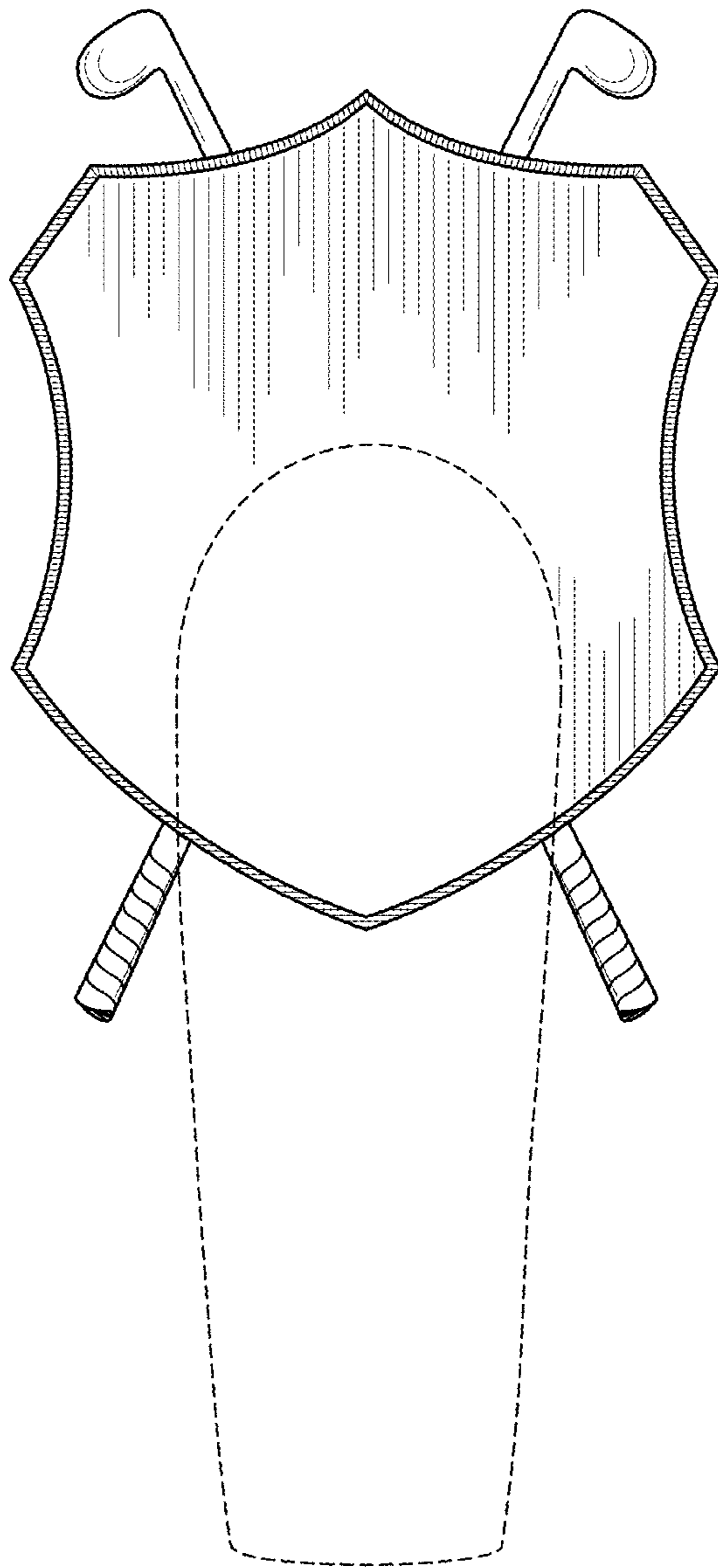

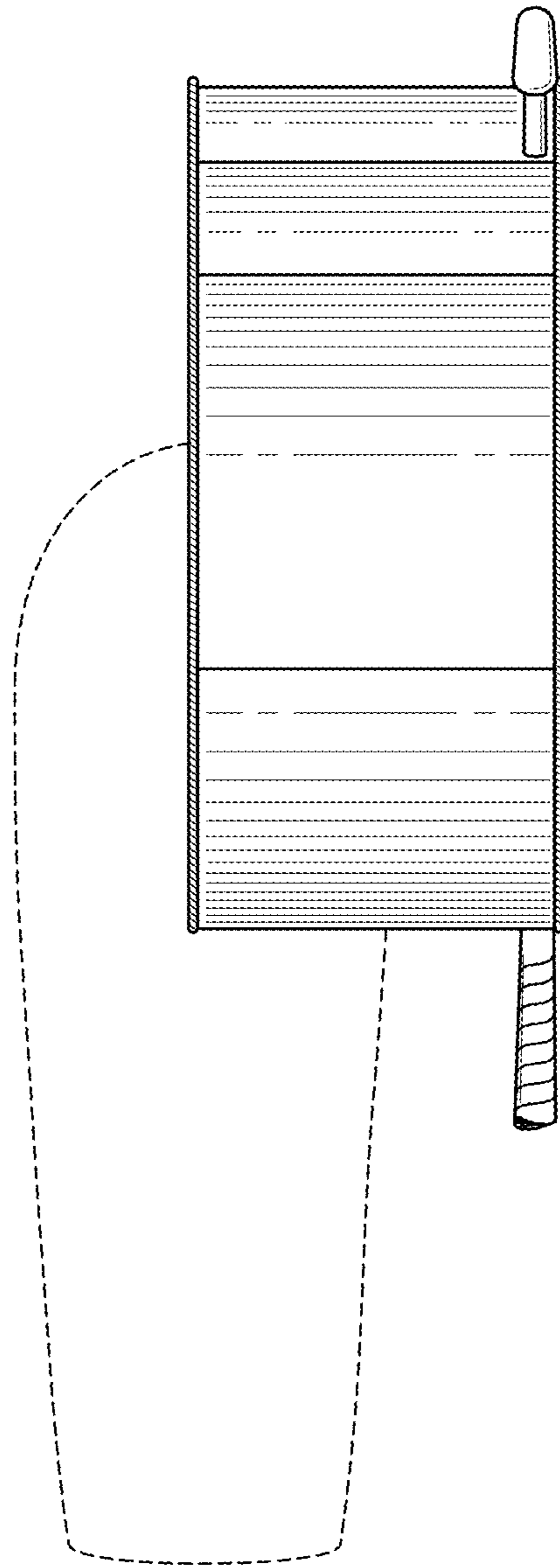

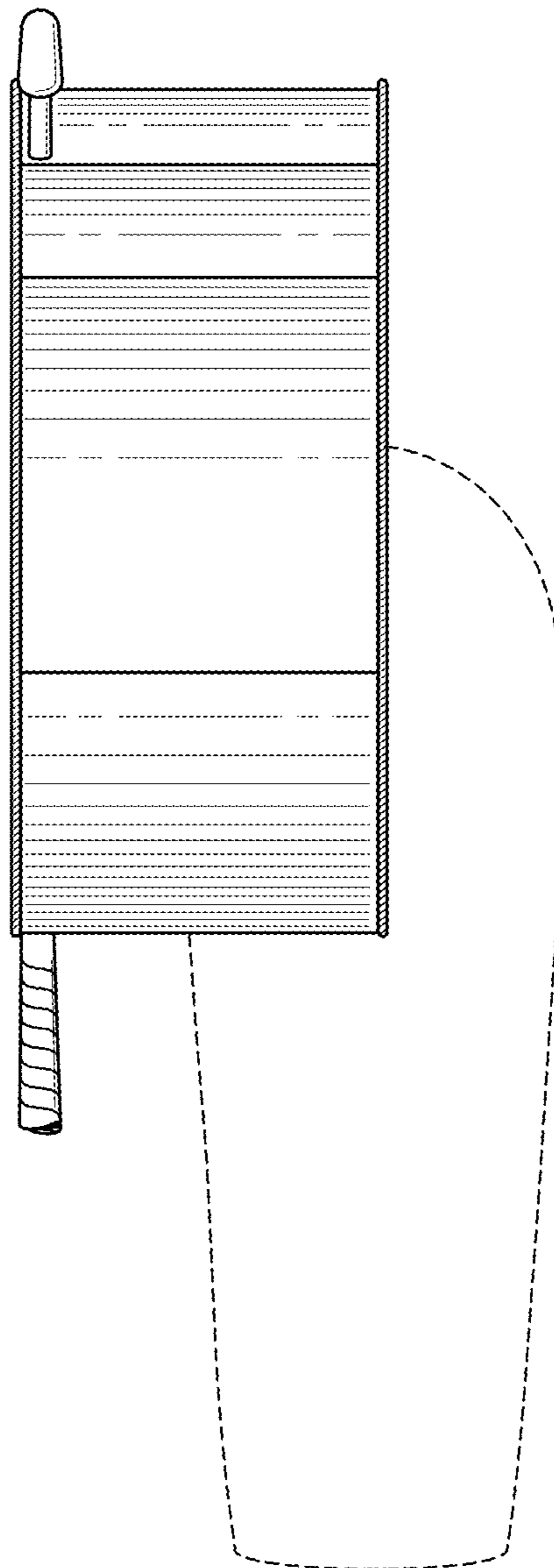

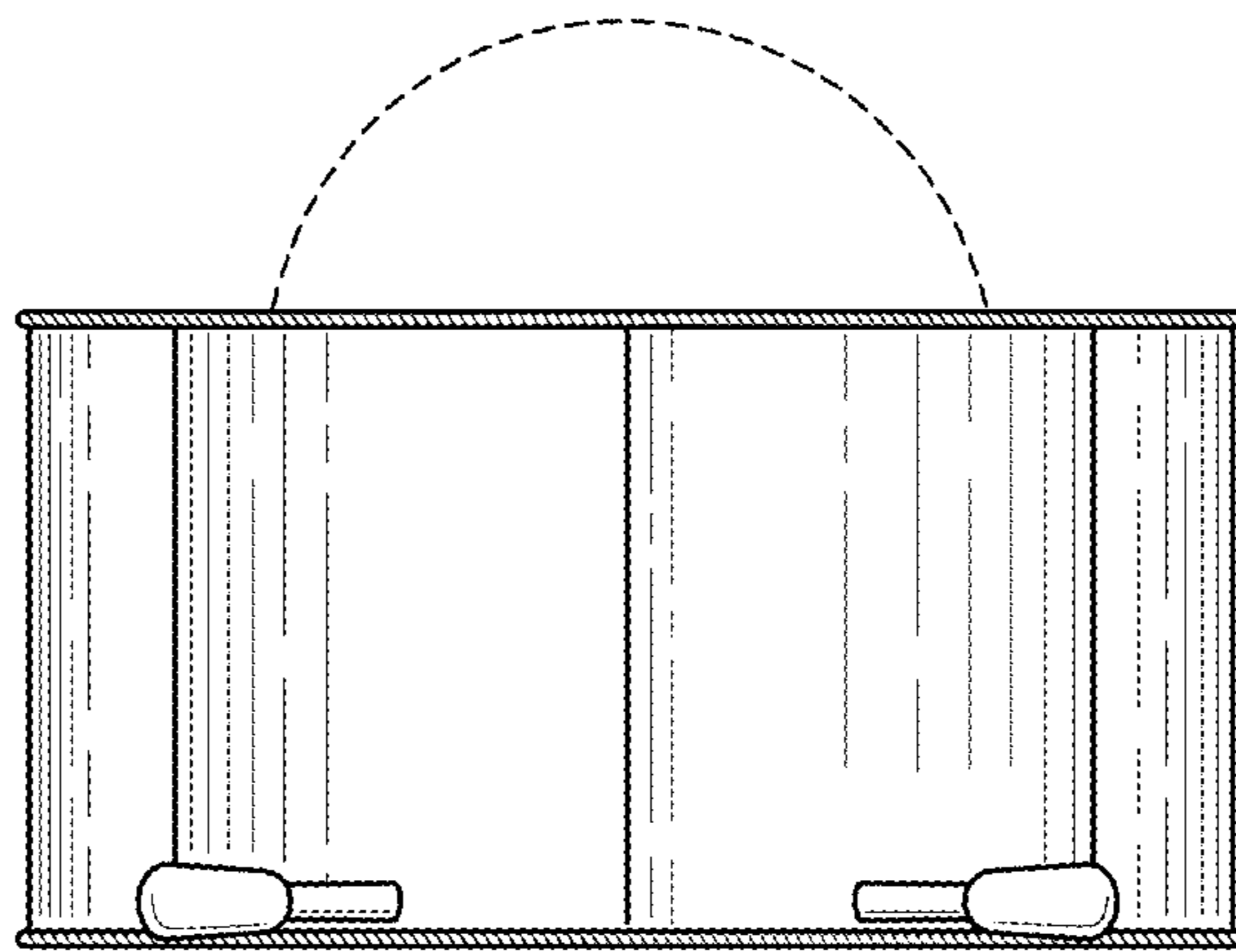

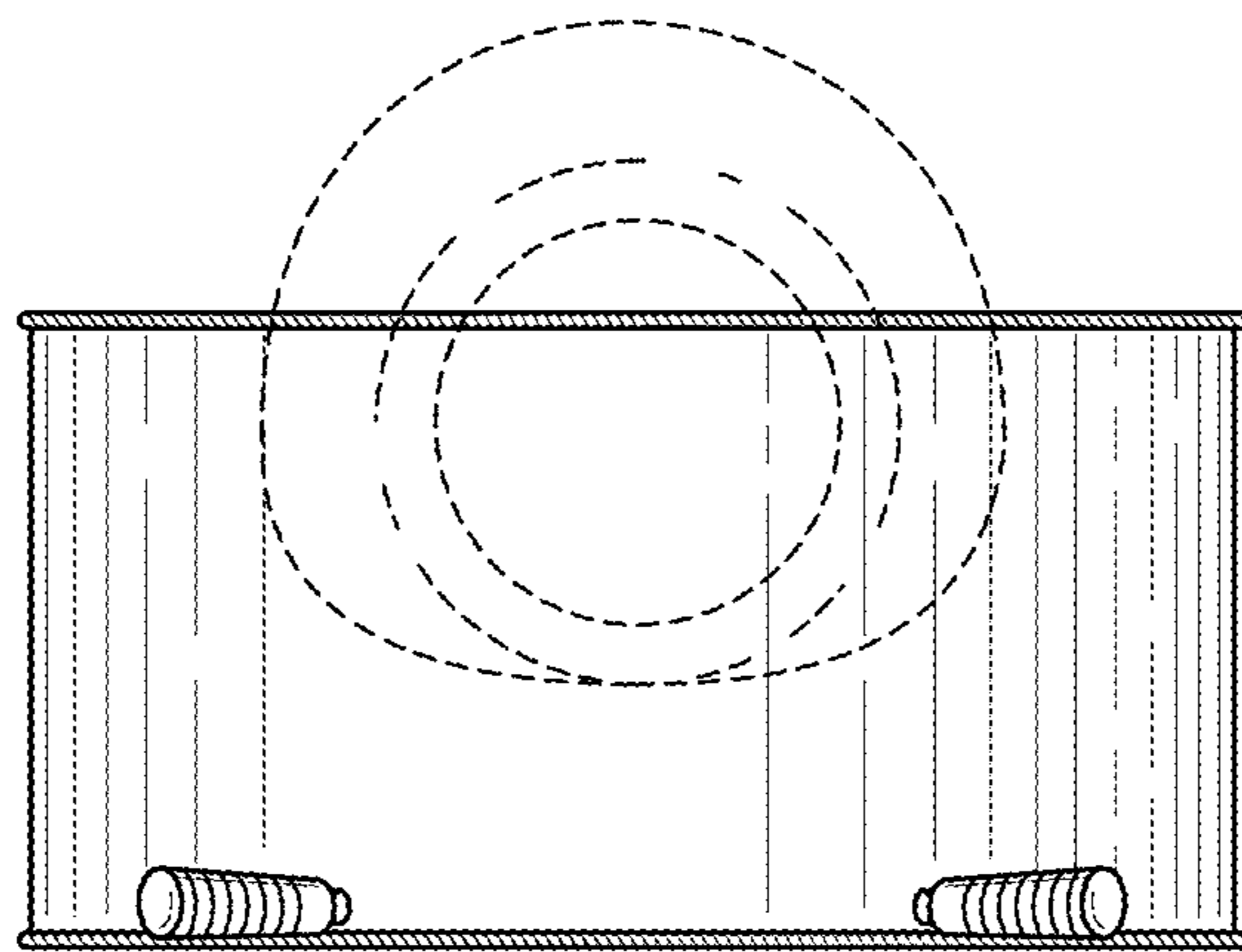
