(57) **CLAIM**

The ornamental design for the firearm barrel with dimpled surface, as shown and described.

DESCRIPTION

FIG. 1 is a left side view of a firearm barrel with dimpled surface as positioned within a firearm with a slide in a rear position;

FIG. 2 is a right side view of the firearm barrel of FIG. 1;

FIG. 3 is a top side view of the firearm barrel of FIG. 1;

FIG. 4 is a bottom side view of the firearm barrel of FIG. 1;

FIG. 5 is a front side view of the firearm barrel of FIG. 1;

FIG. 6 is a left side view of the firearm barrel of FIG. 1 with the slide of the firearm in a forward position;

FIG. 7 is a right side view of the firearm barrel of FIG. 6;

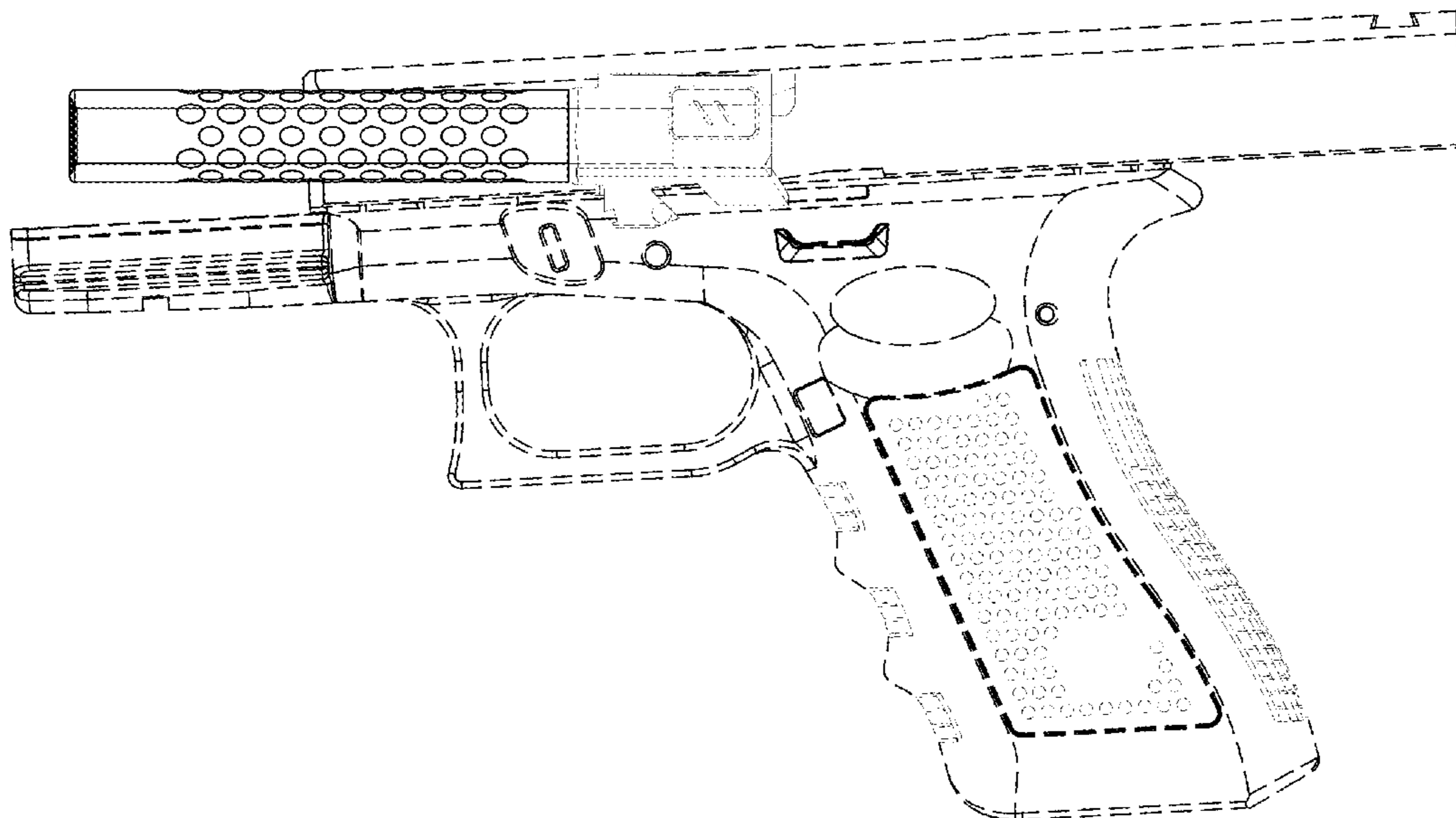
FIG. 8 is a top side view of the firearm barrel of FIG. 6;

FIG. 9 is a bottom side view of the firearm barrel of FIG. 6; and,

FIG. 10 is a front side view of the firearm barrel of FIG. 6.

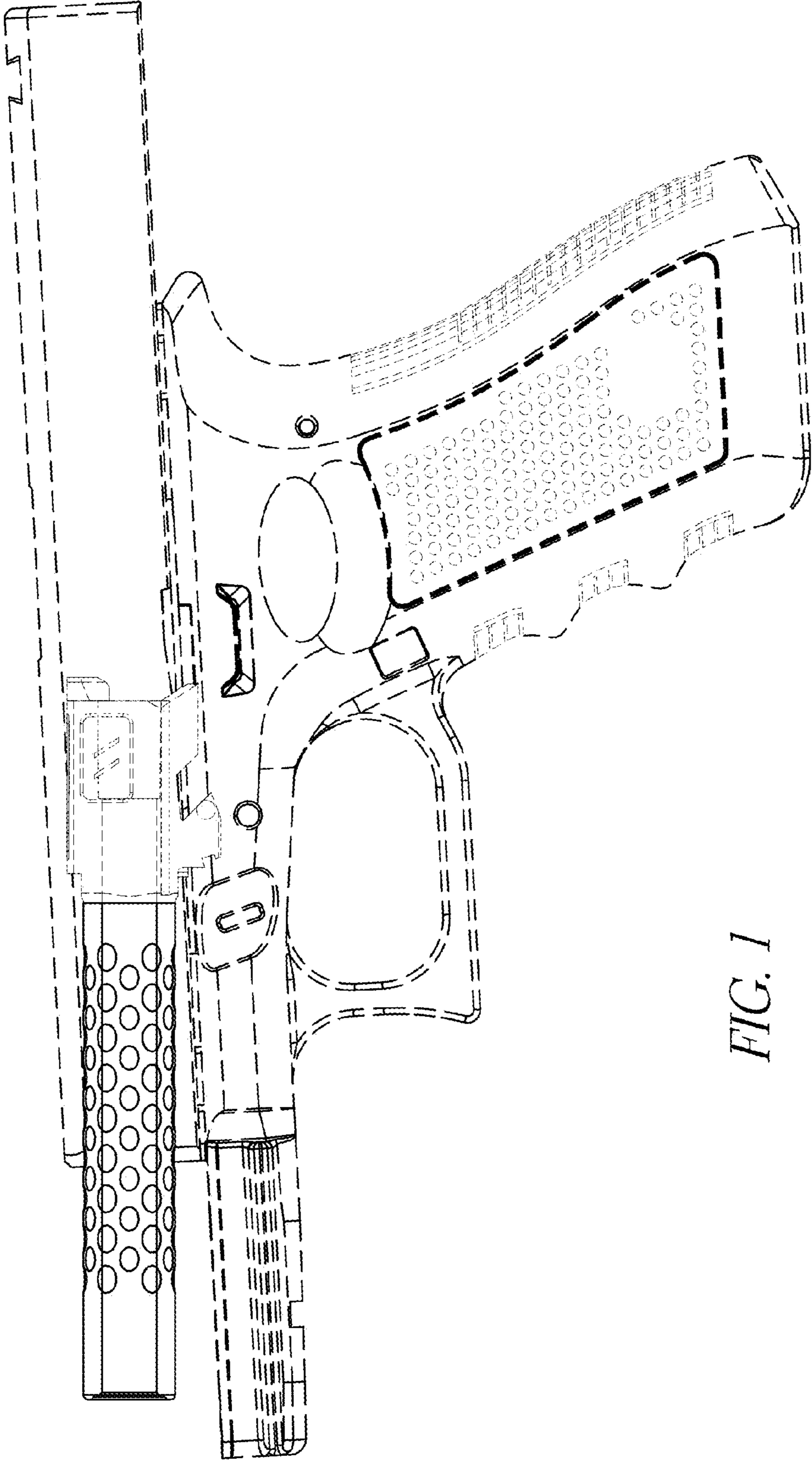

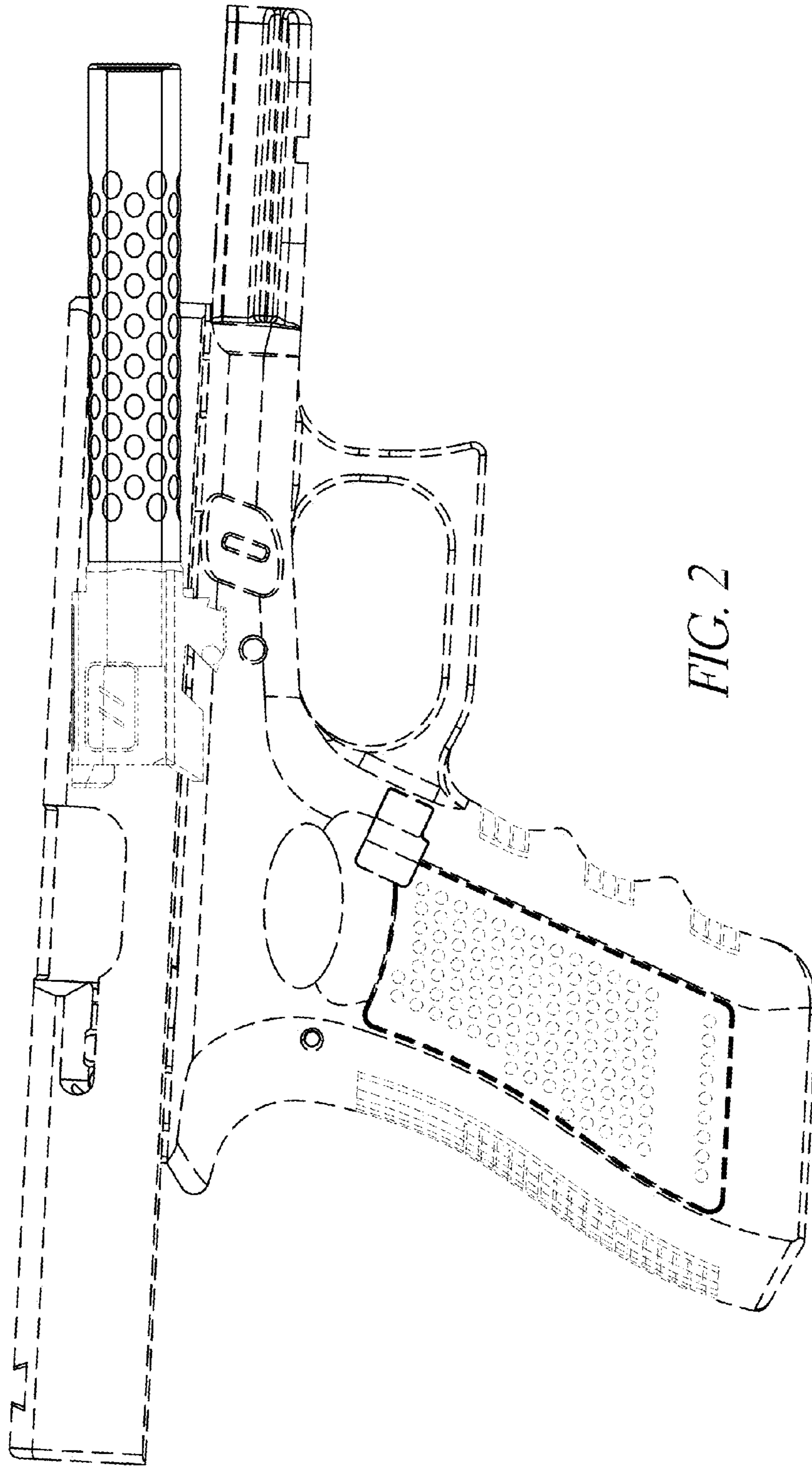

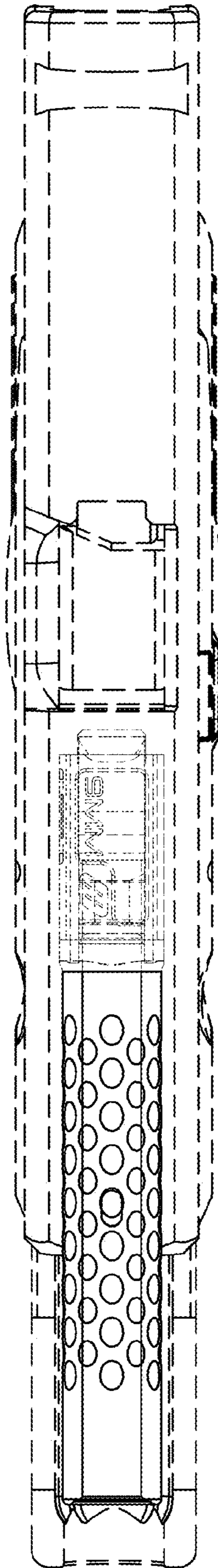

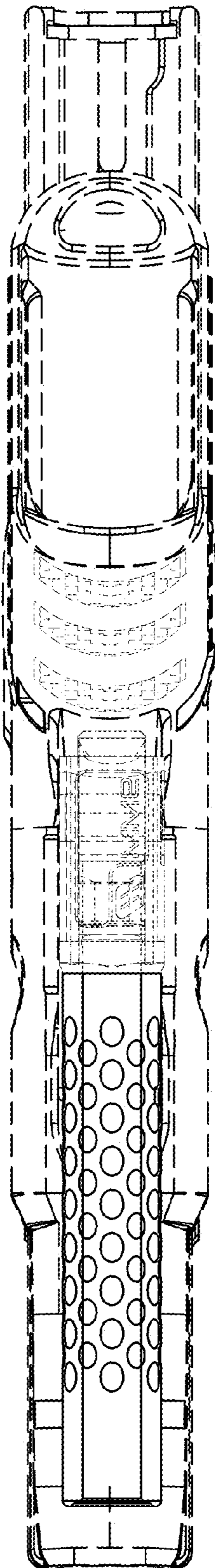

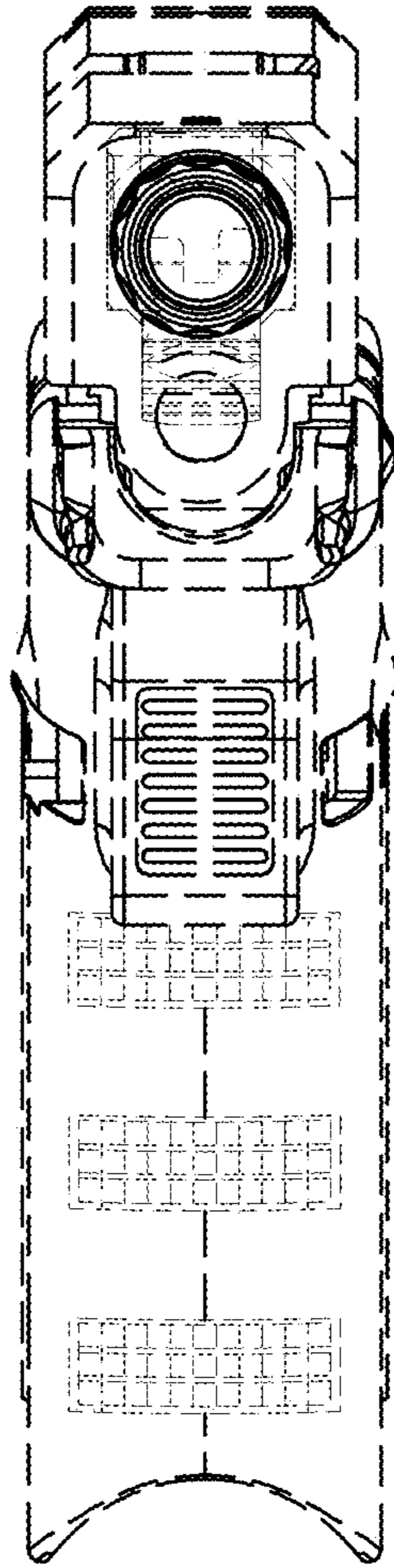

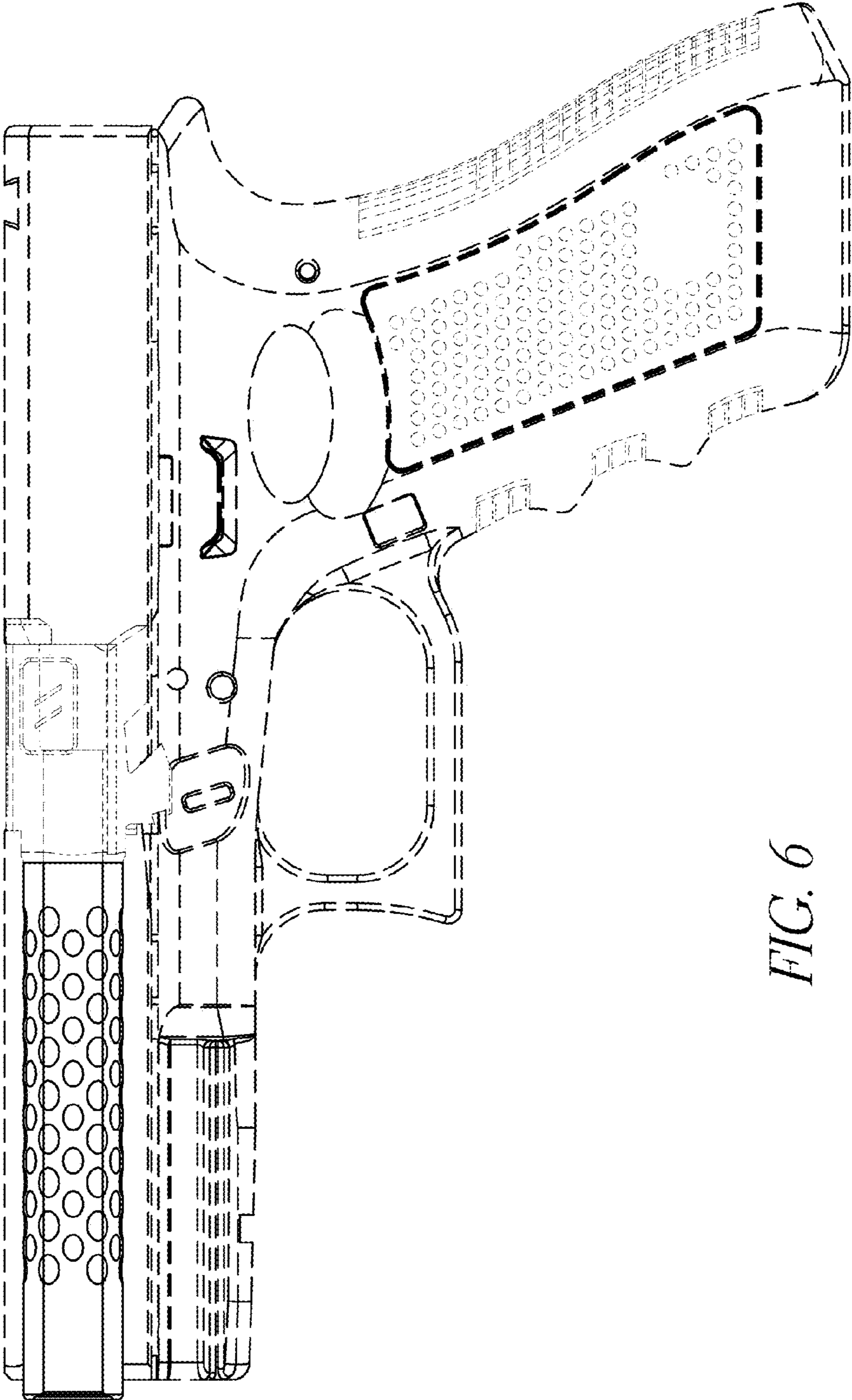

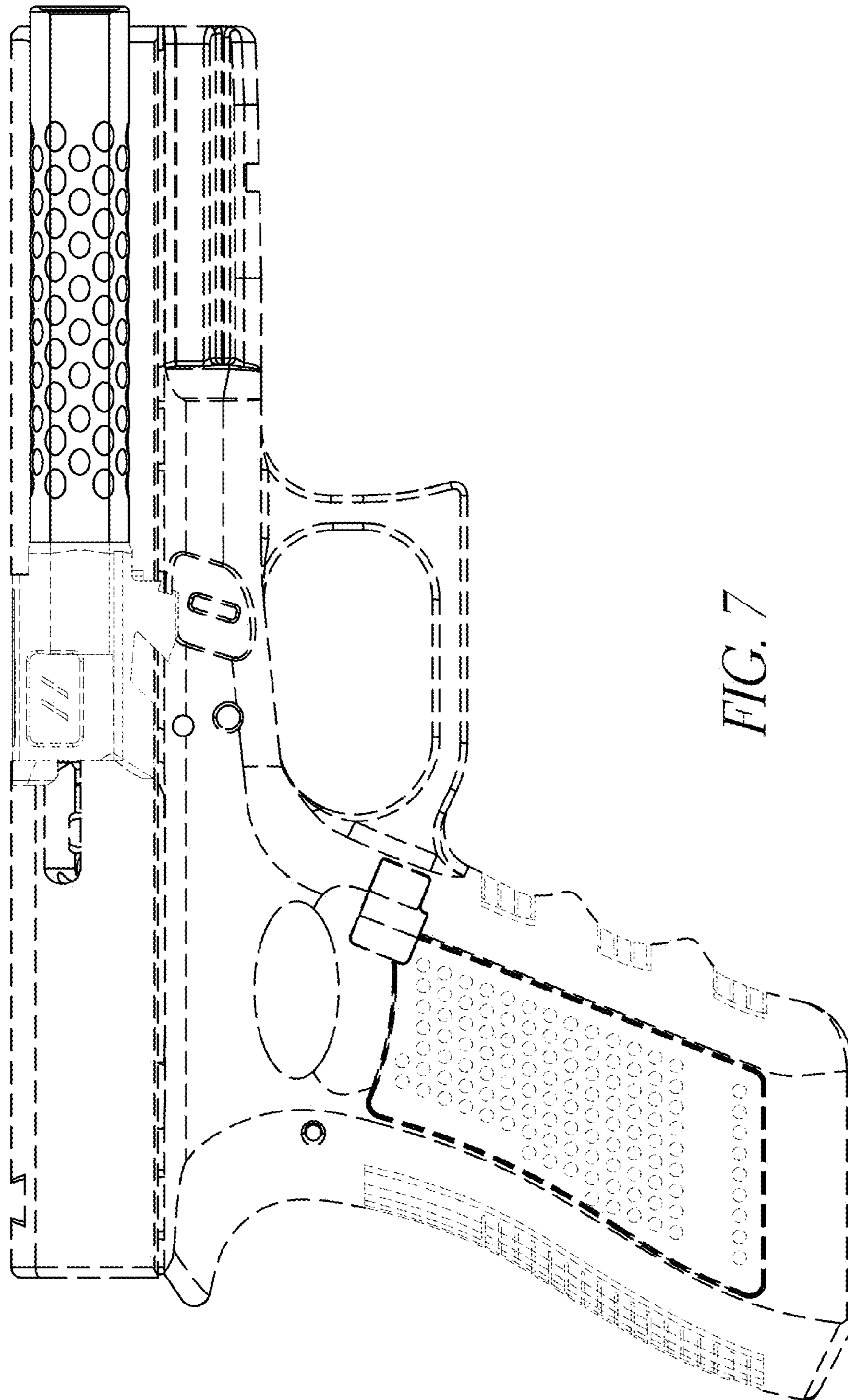

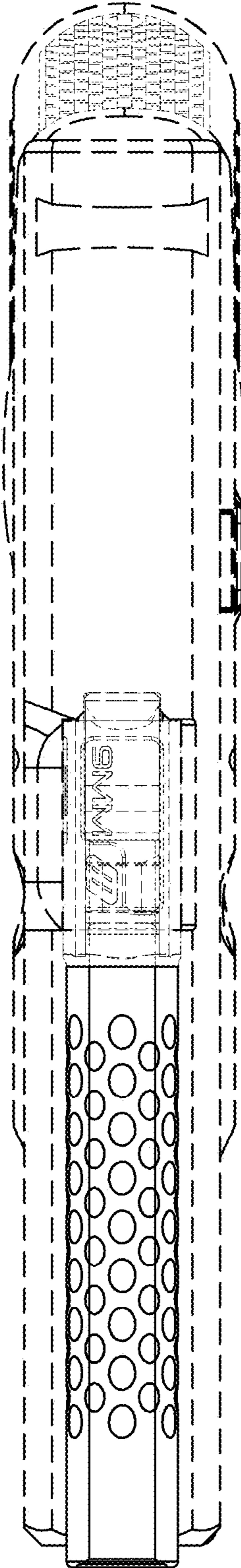

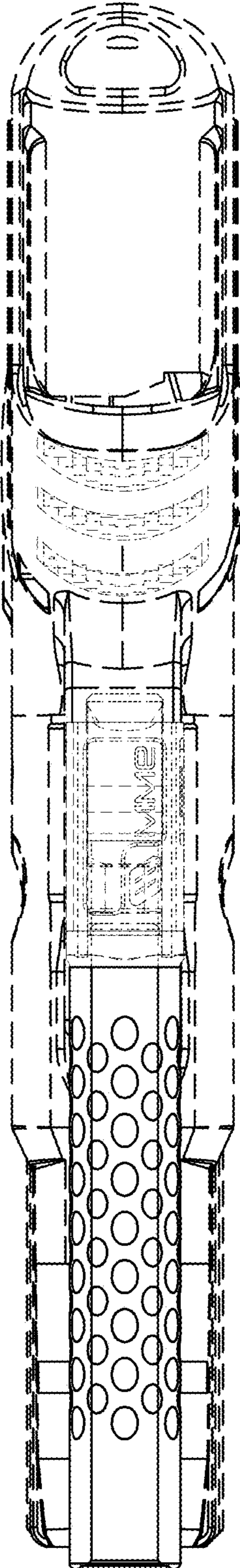

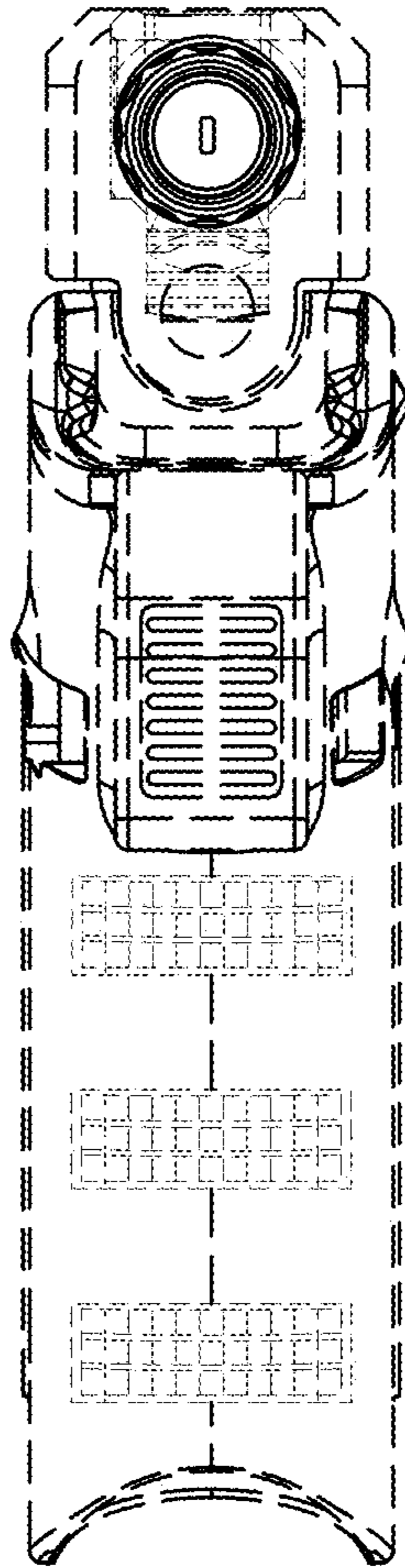
