**DESCRIPTION**  
FIG. 1 is a front perspective view of the Z-closure member for mounting a vent cap on a raised seam roof showing my design;  
FIG. 2 is a rear perspective view thereof with a filter installed, the filter being shown in broken lines;  
FIG. 3 is a left side elevational view thereof with a filter installed;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a rear elevational view thereof with a filter installed;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken lines are shown for environmental purposes only and form no part of the claimed design.

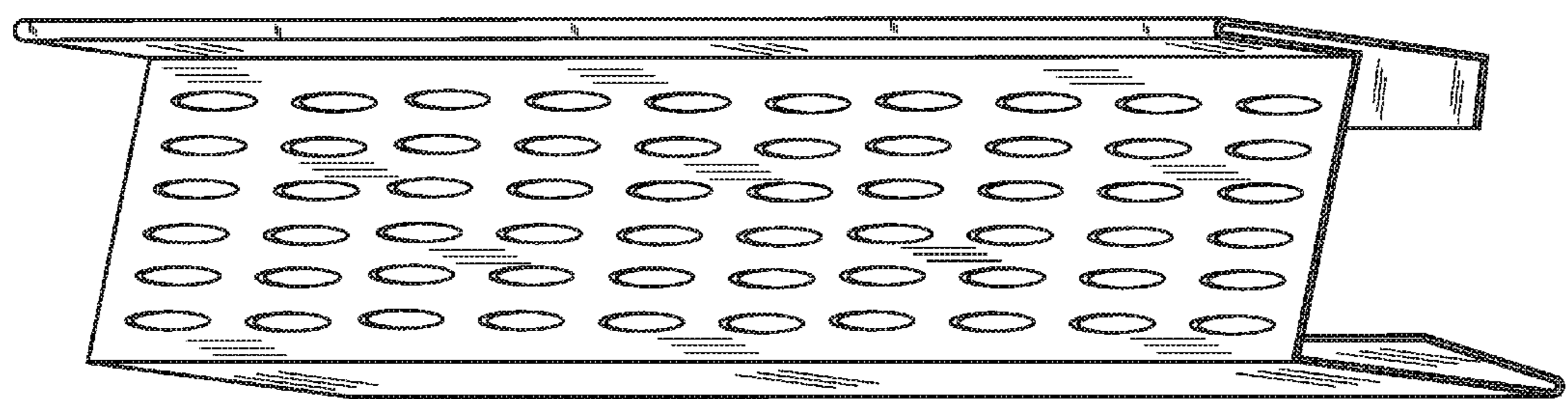

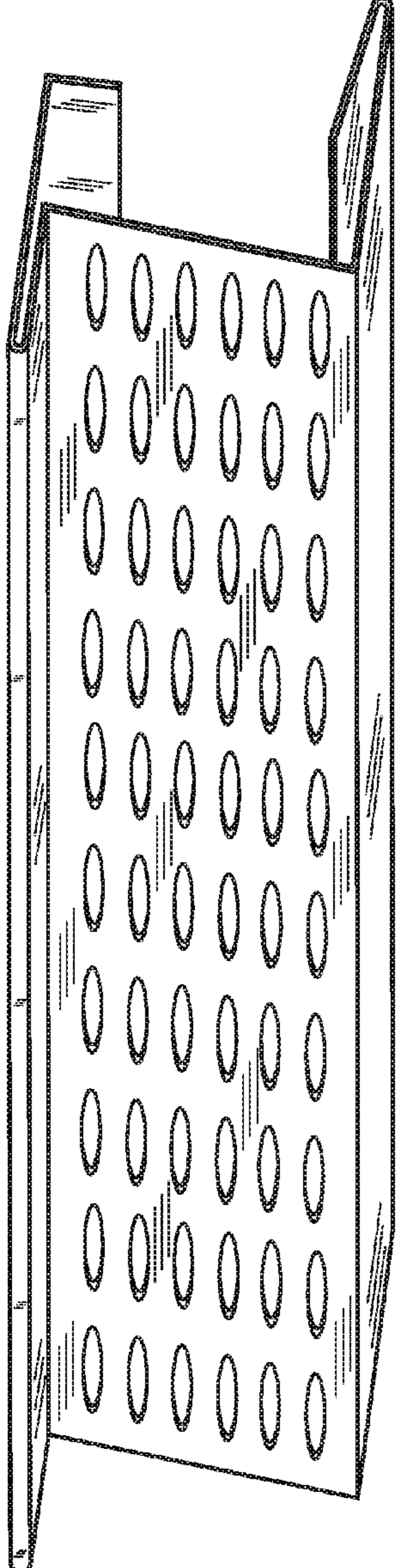

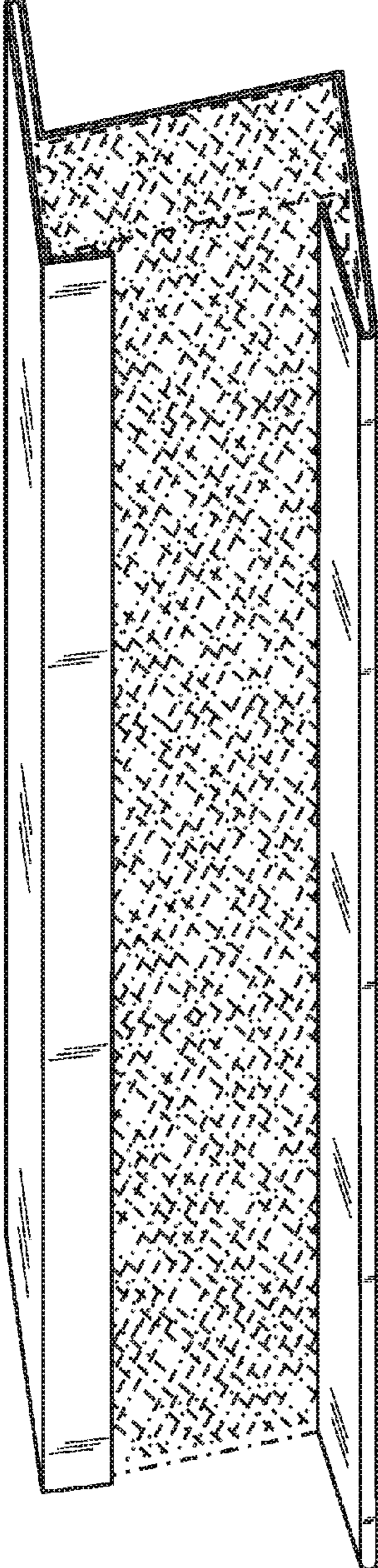

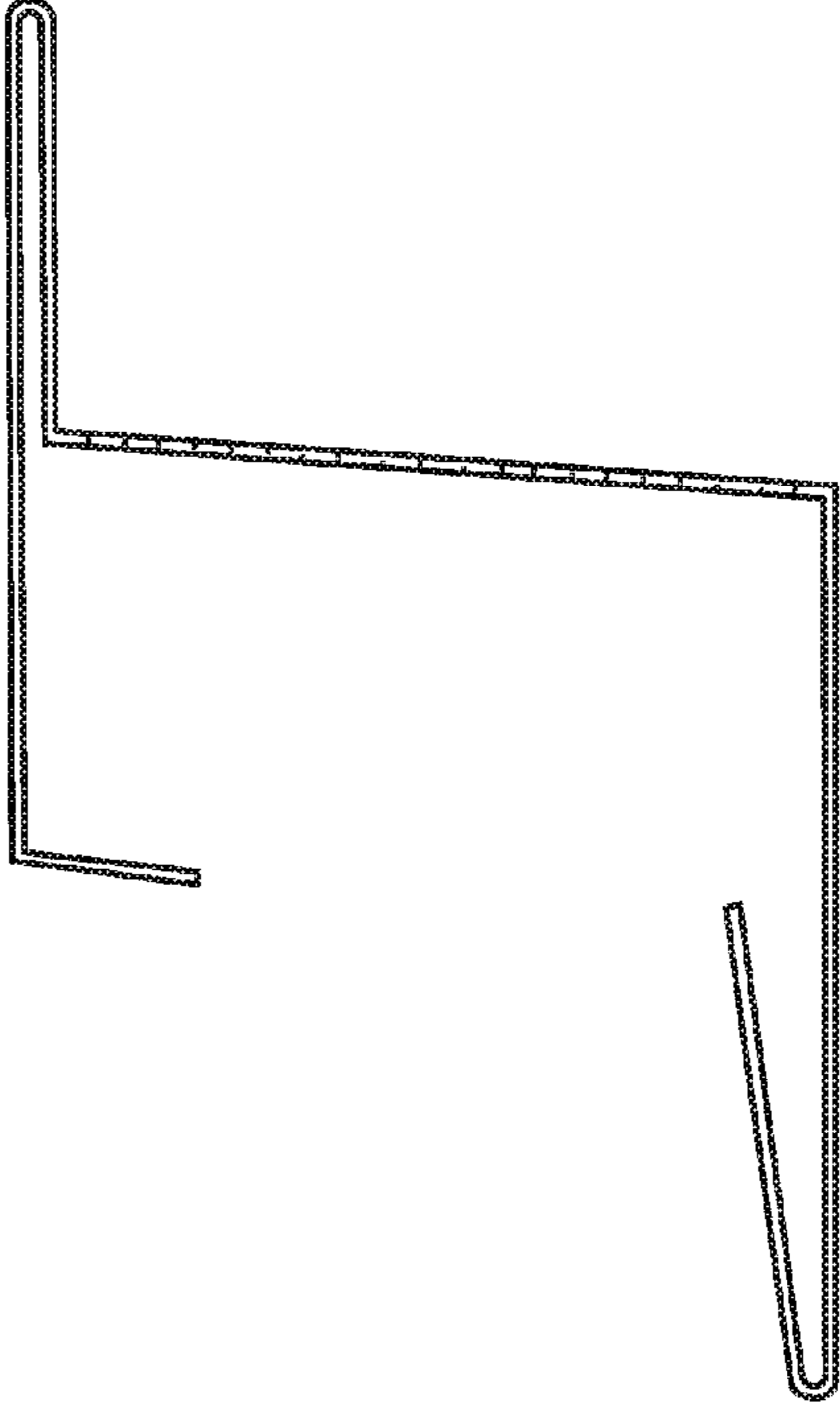
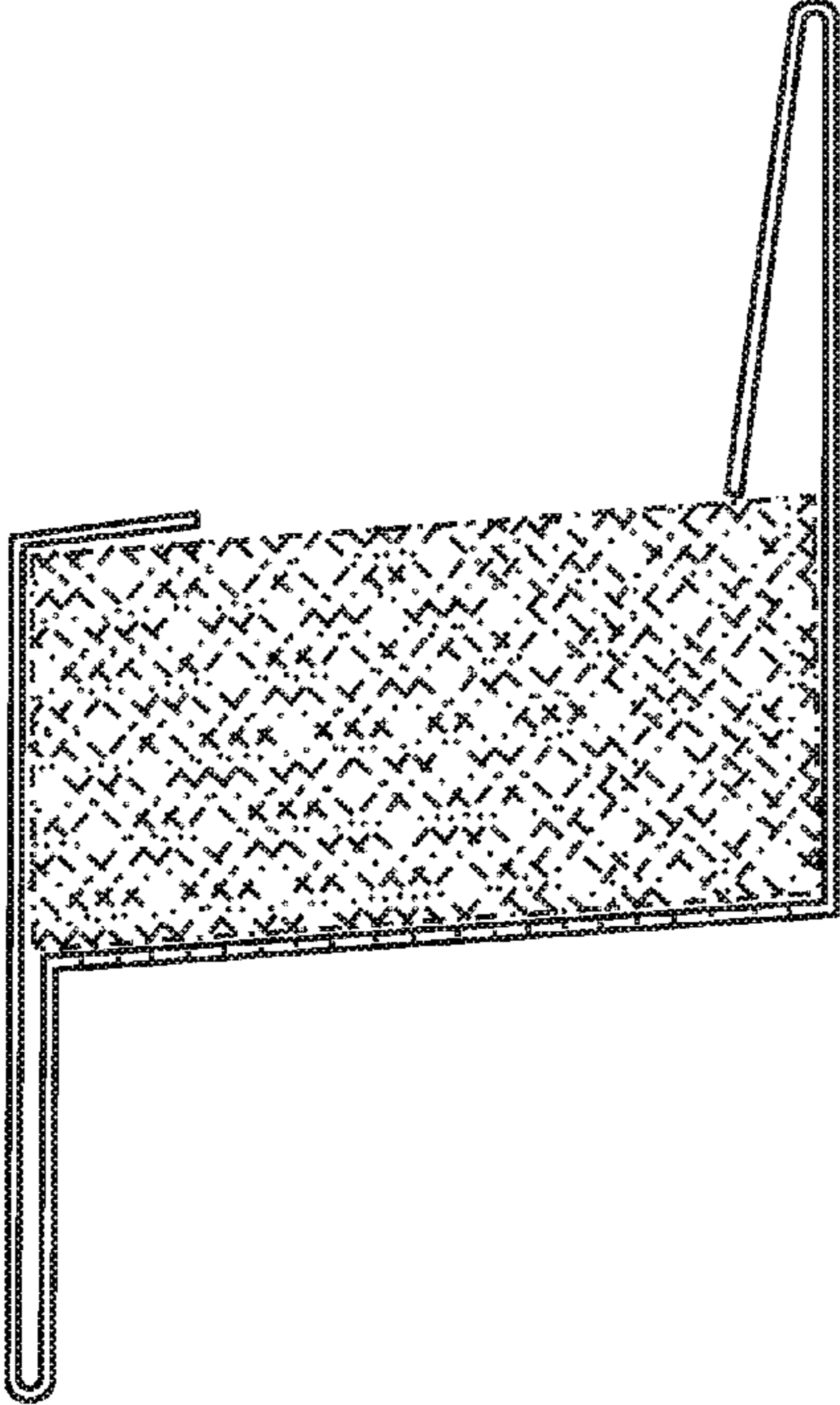

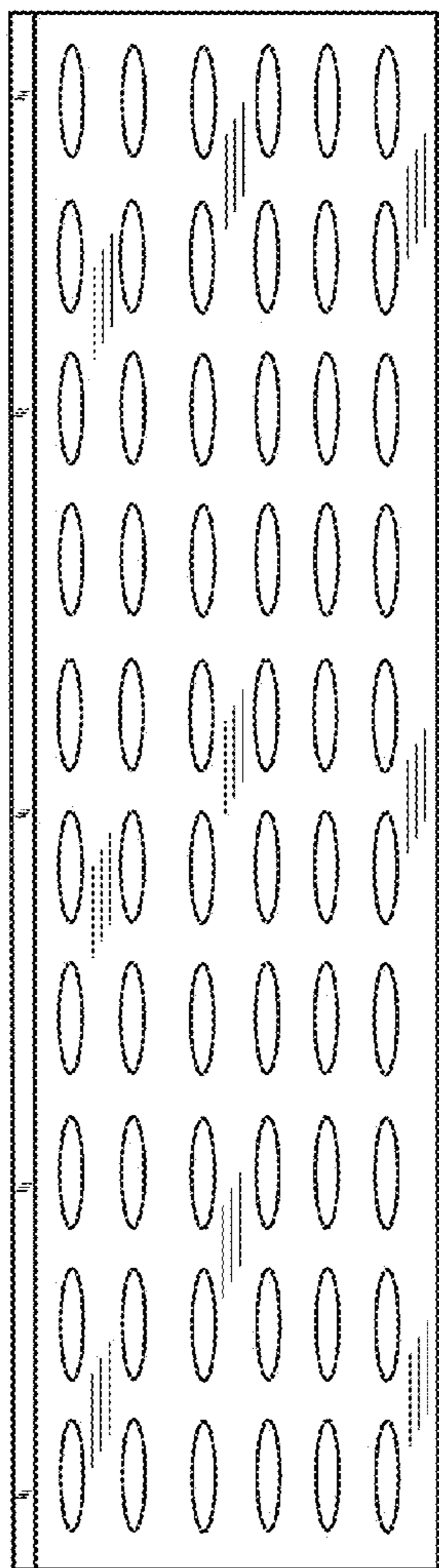

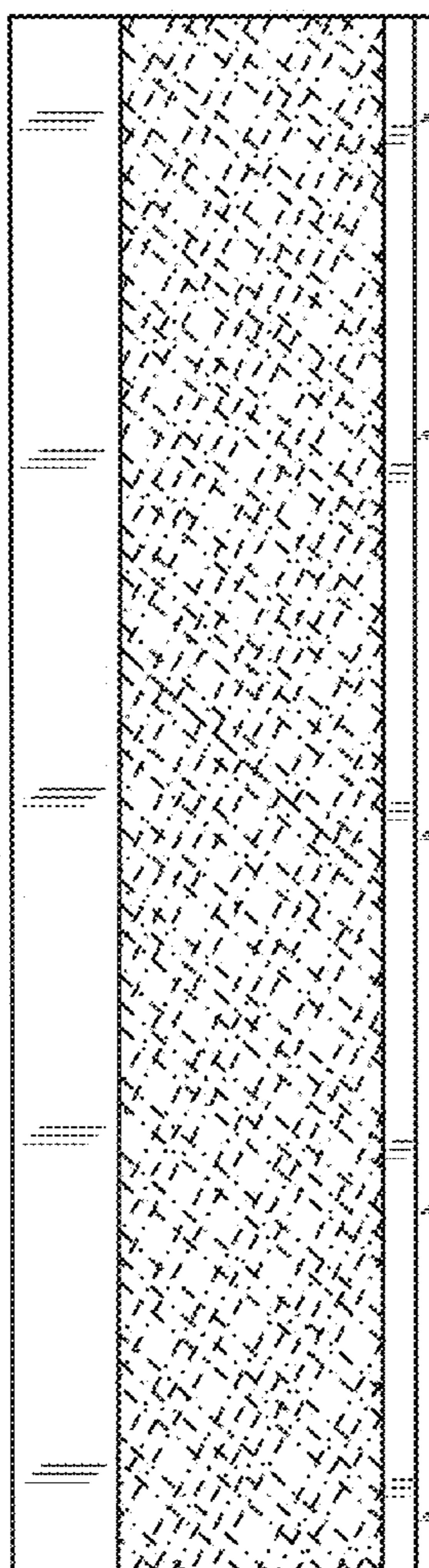

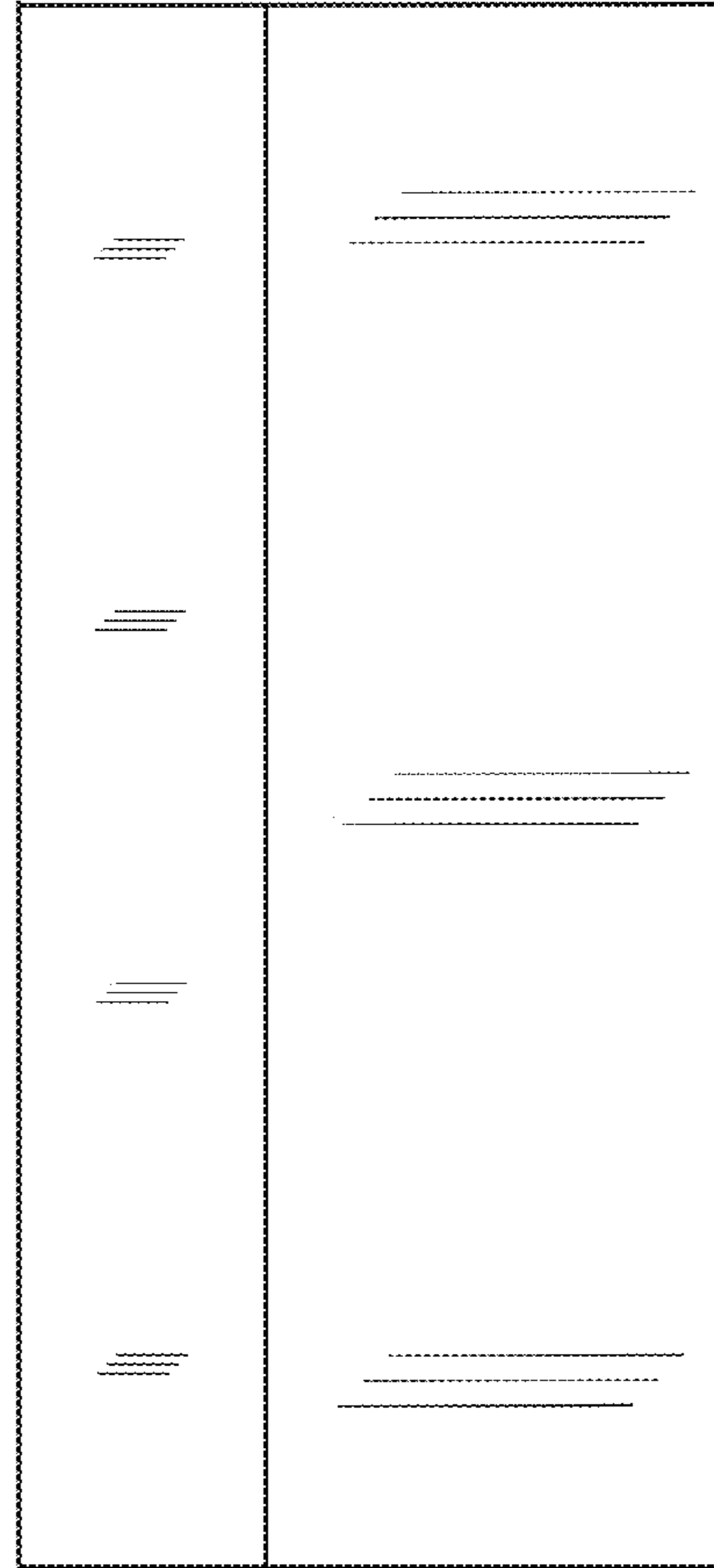
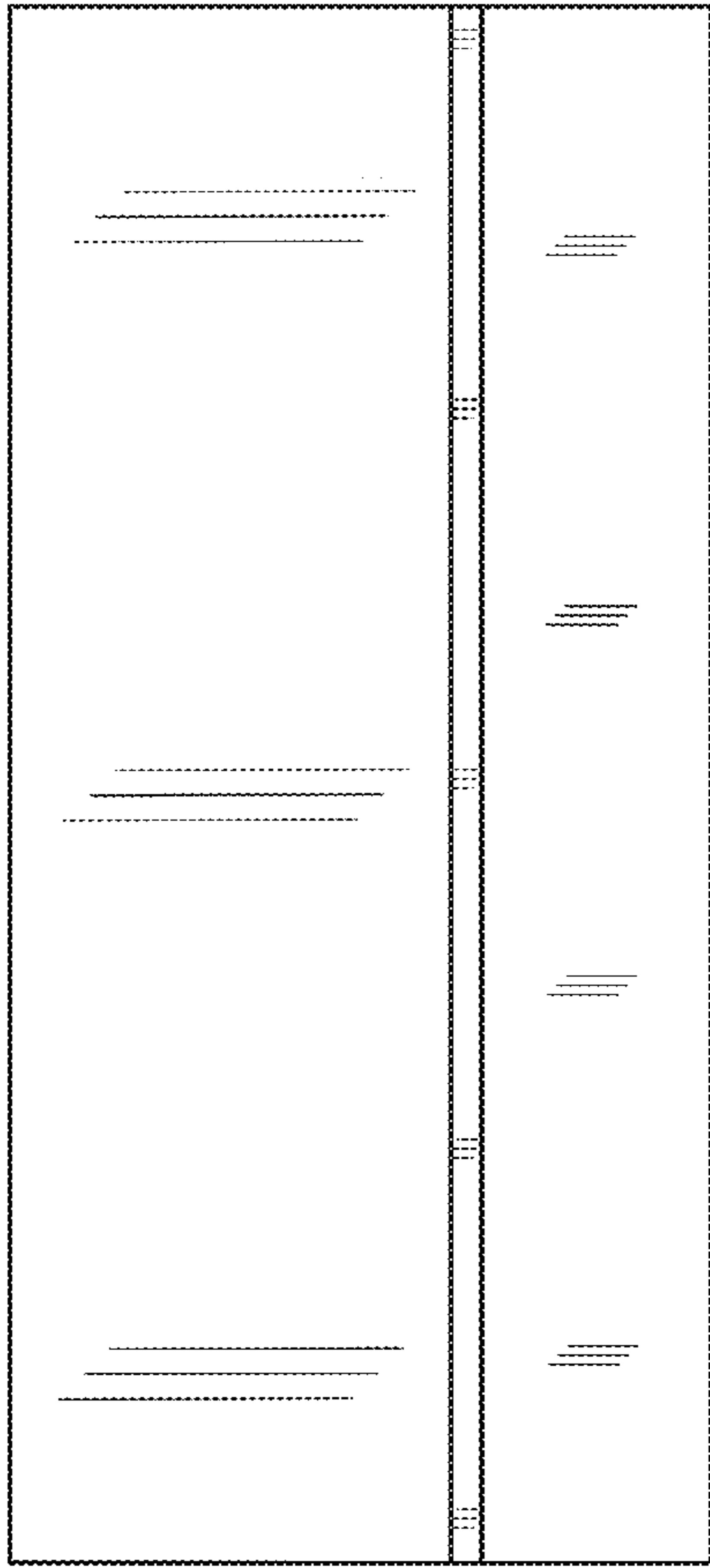
