The ornamental design for an autoinjector, as shown and described.

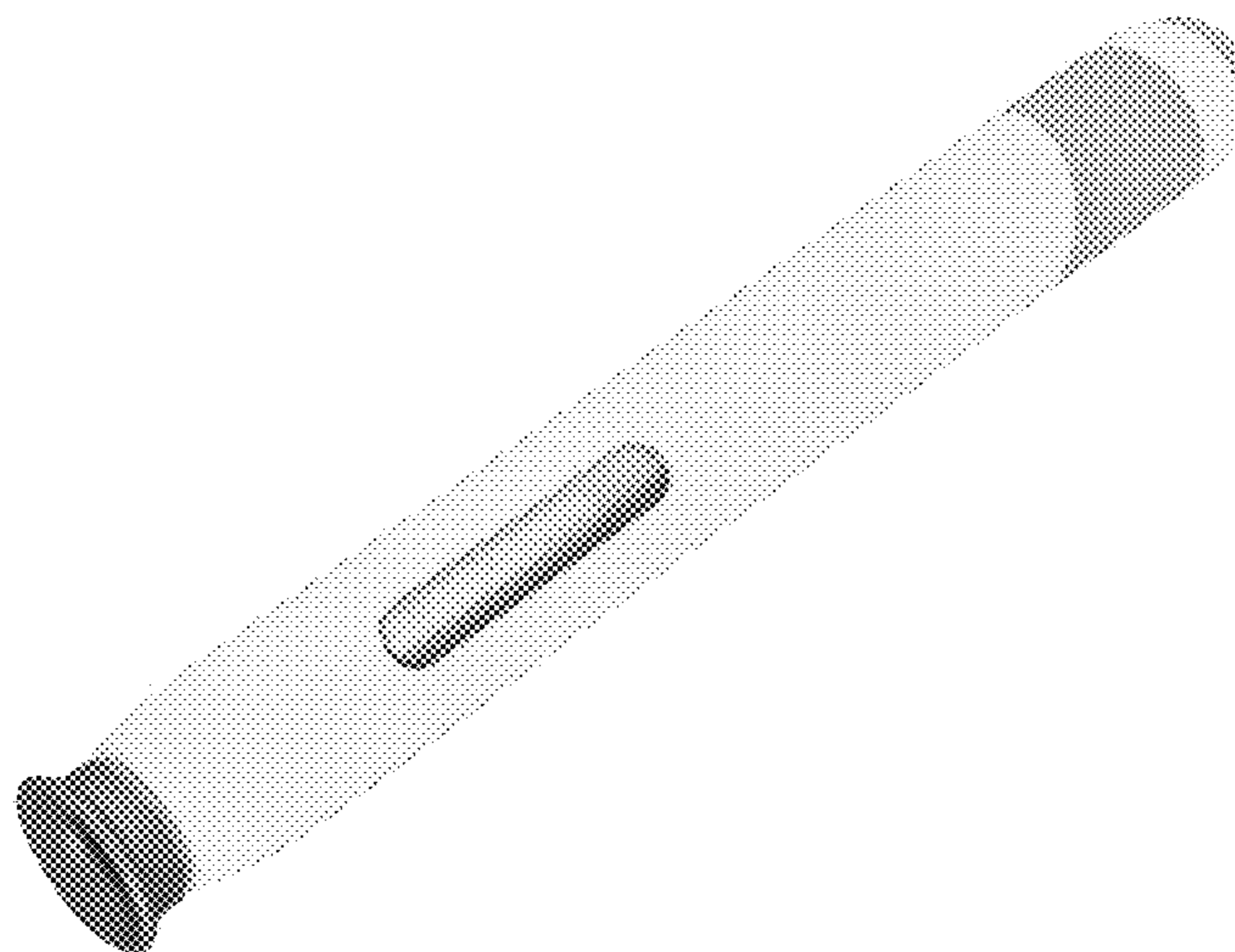
**DESCRIPTION**

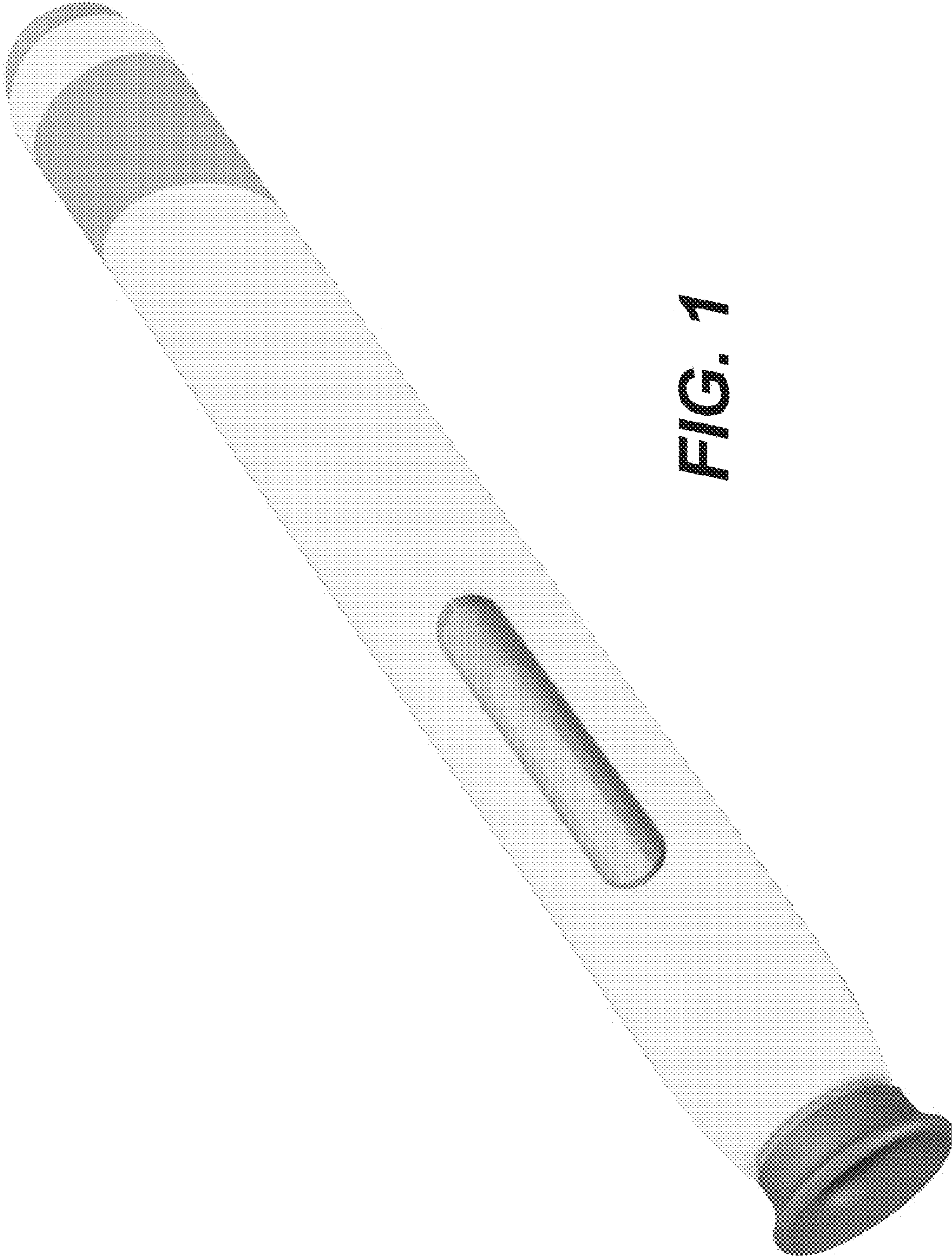

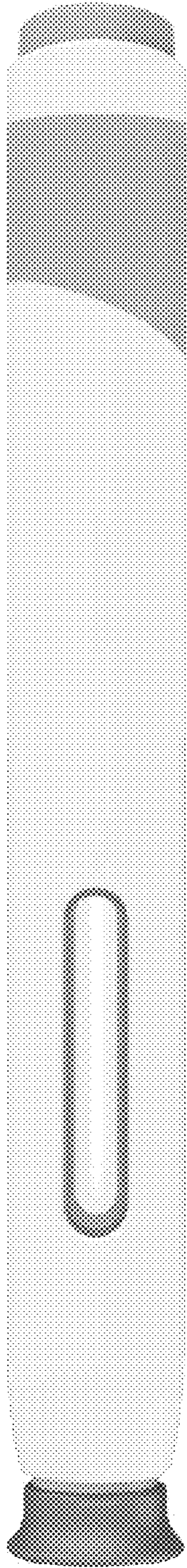

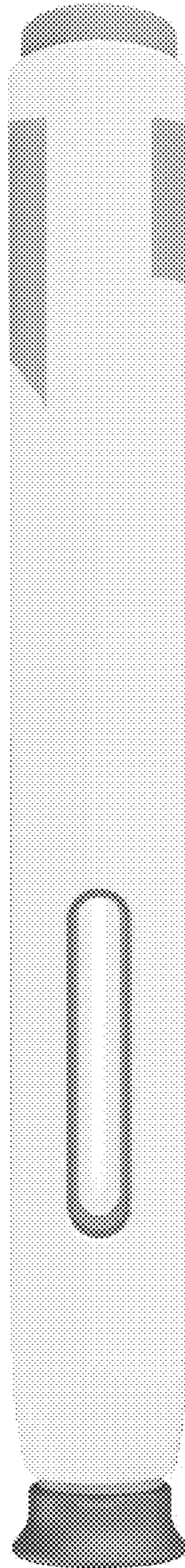

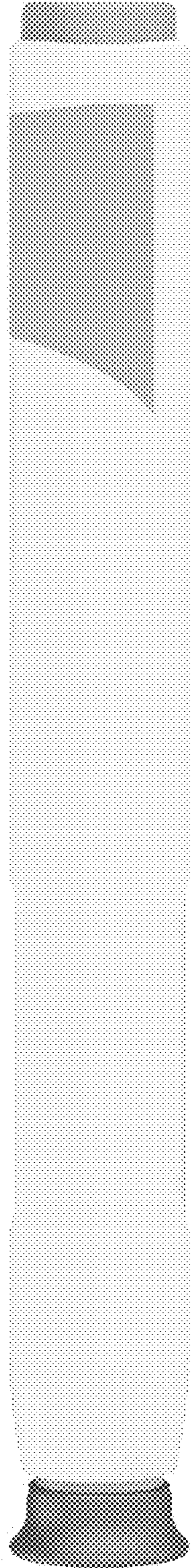

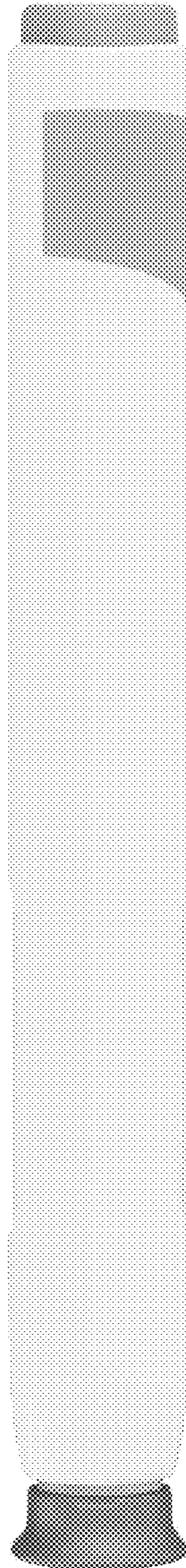

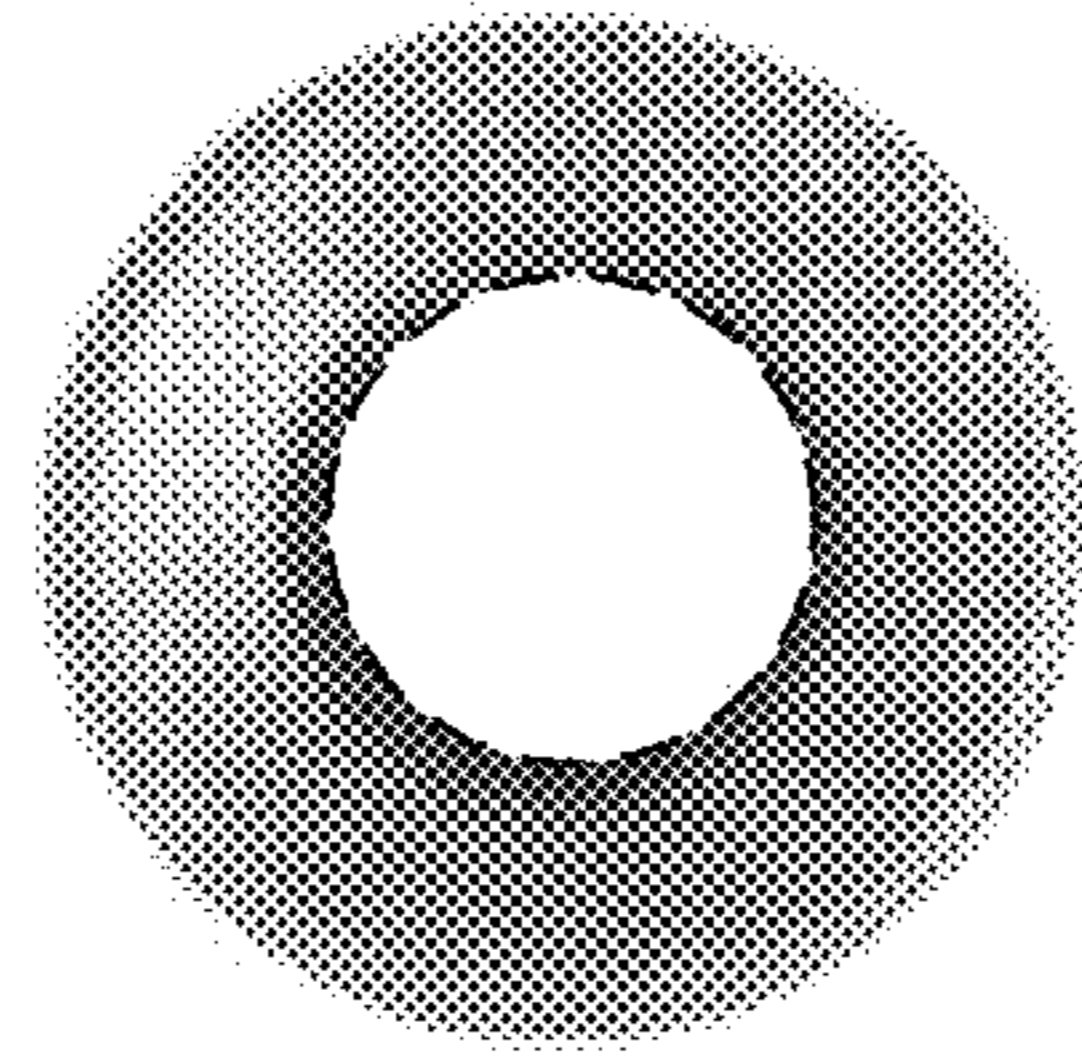

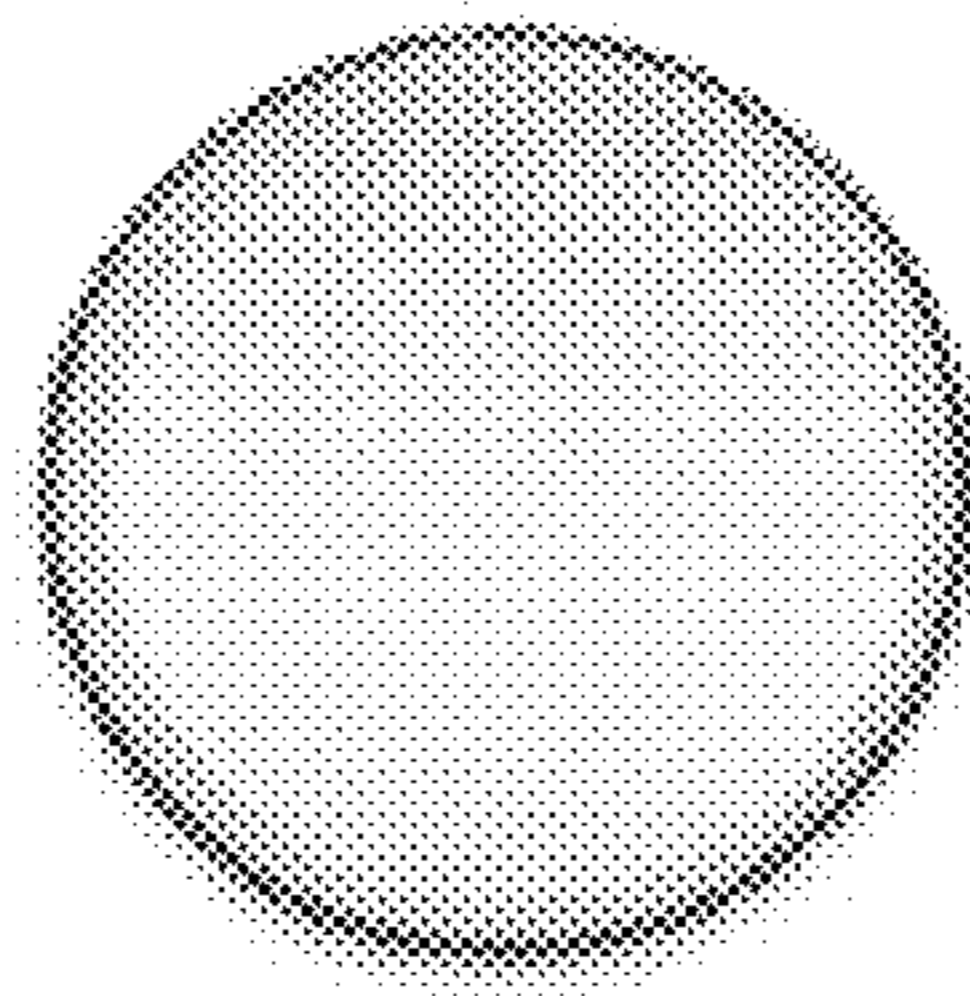
