(57) **CLAIM**
The ornamental design for a diaper, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of the diaper showing our new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;
FIG. 6 is a vertical cross-sectional view taken along the line 6-6 in FIG. 1; and,
FIG. 7 is a referential perspective view of the diaper with the bag part for excretions opened for use.
The broken lines in the drawings illustrate portions of the diaper that form no part of the claimed design.

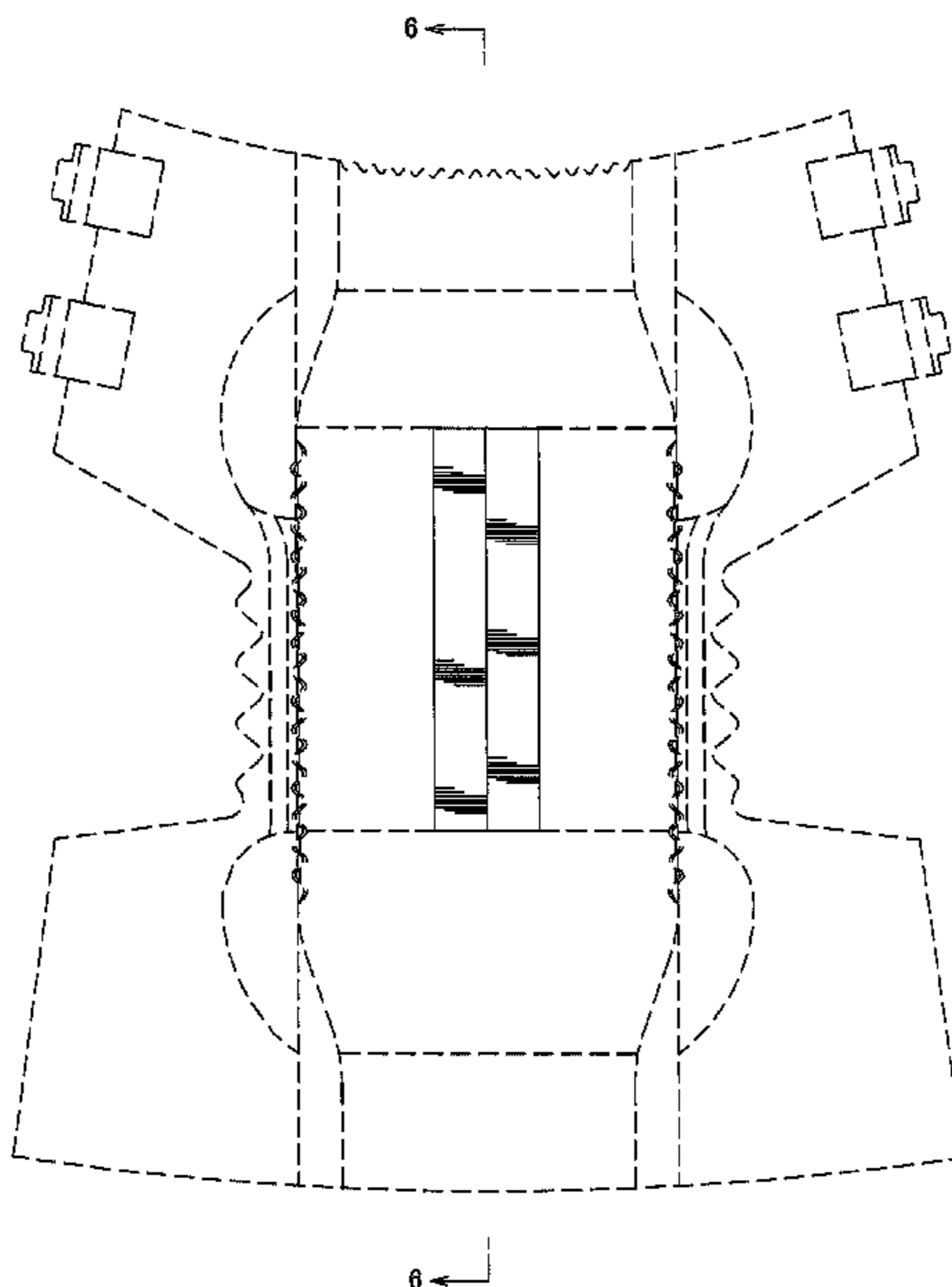

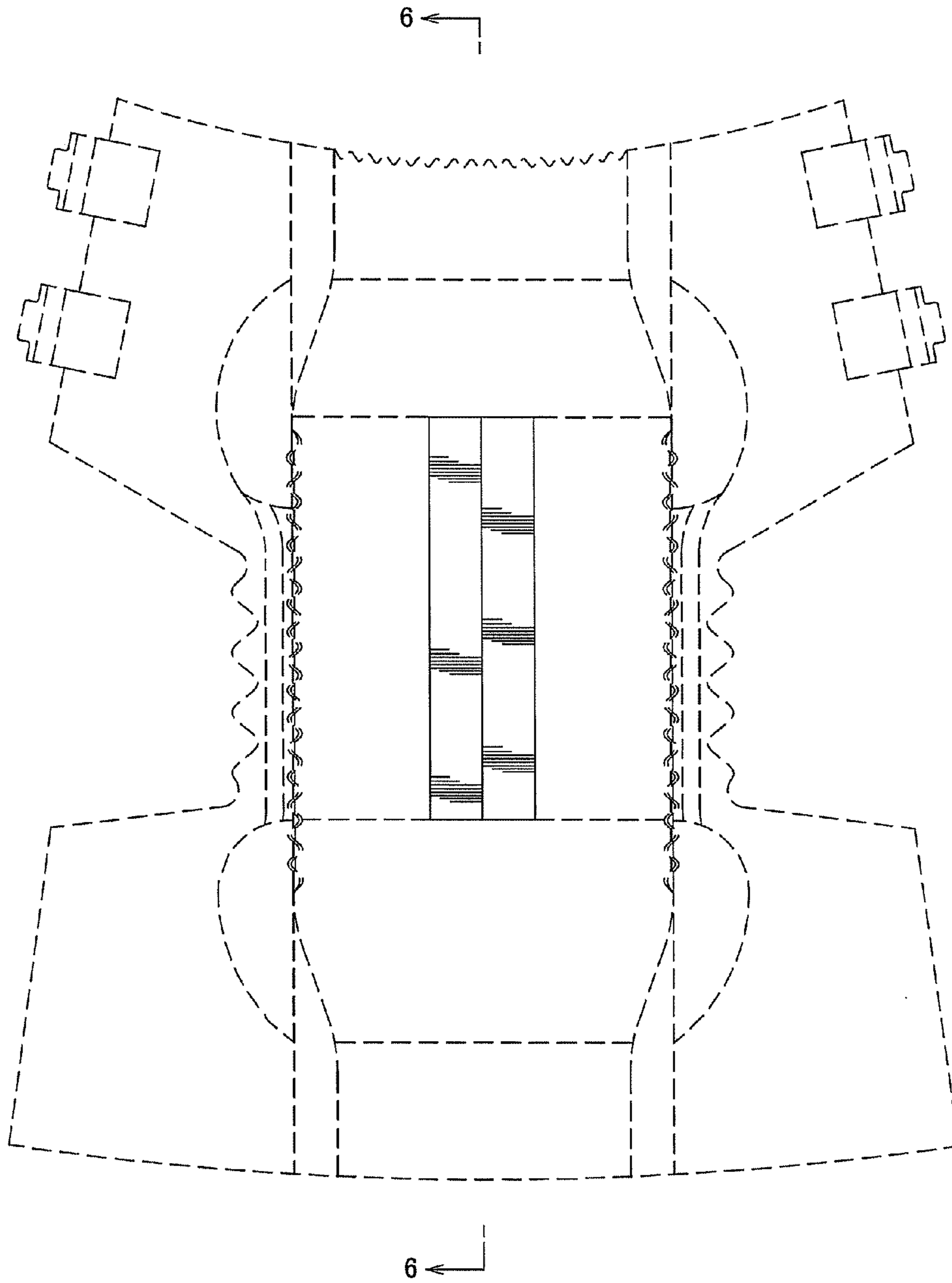

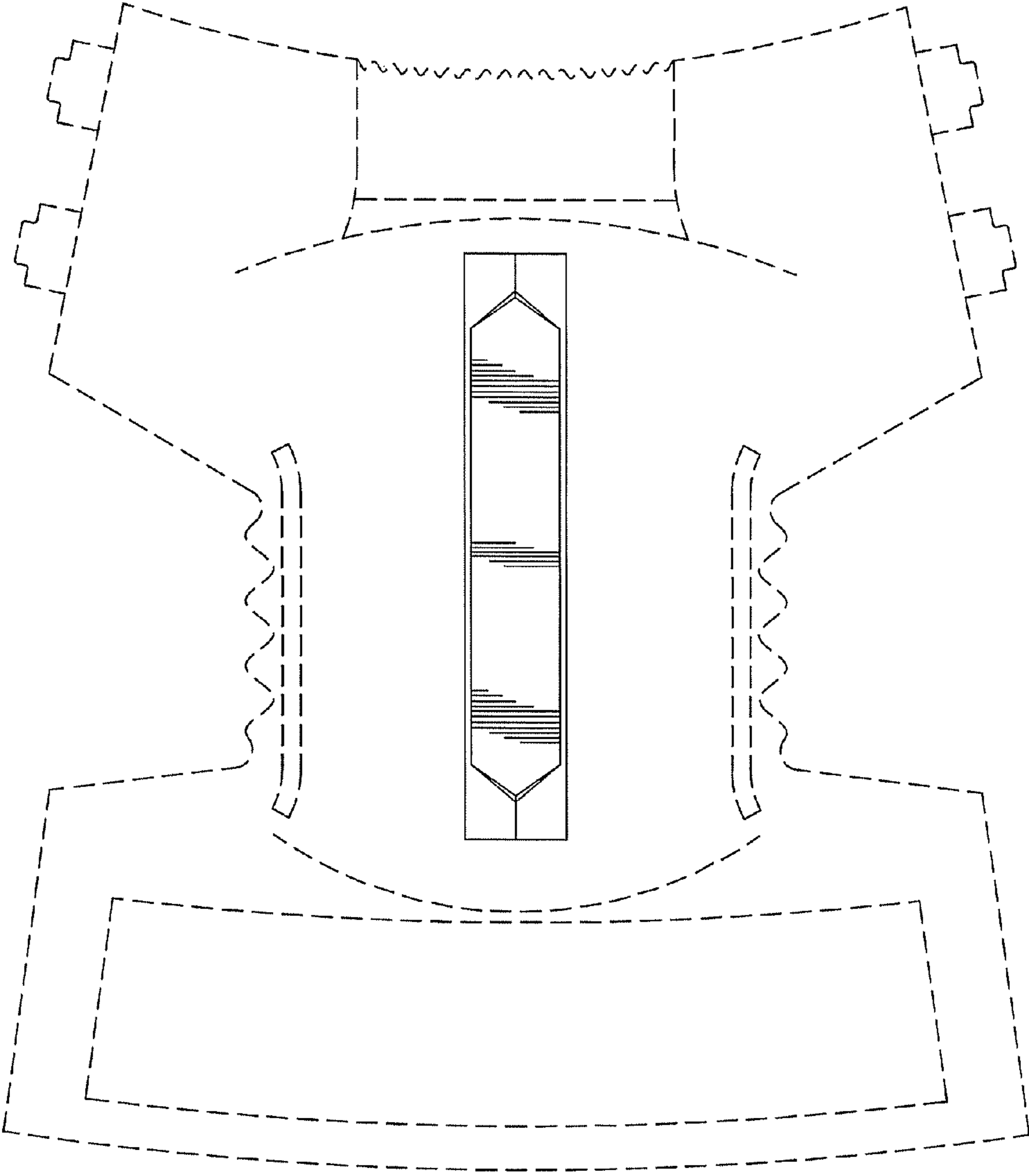

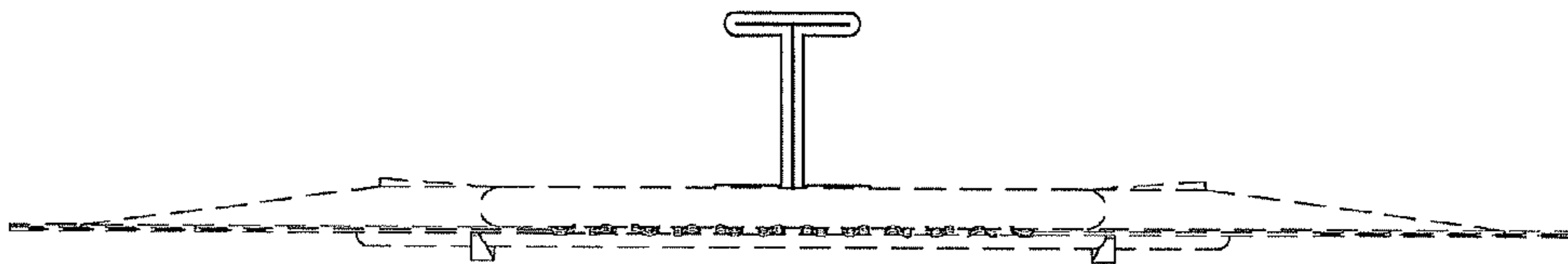

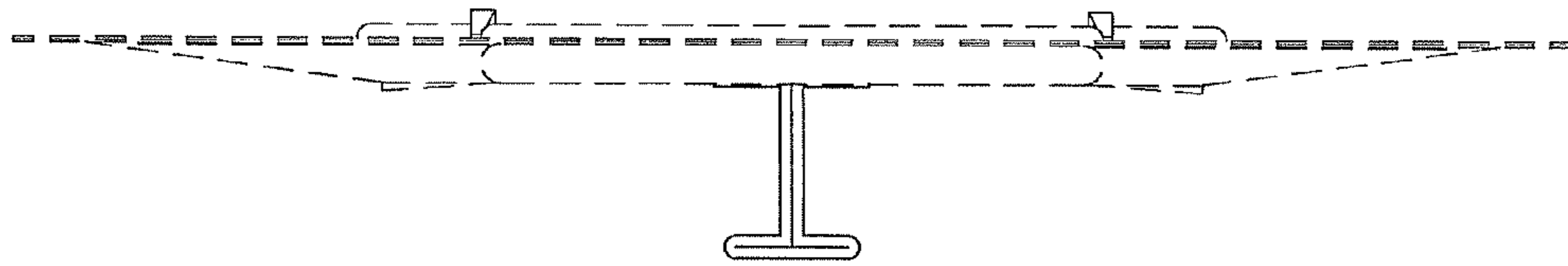

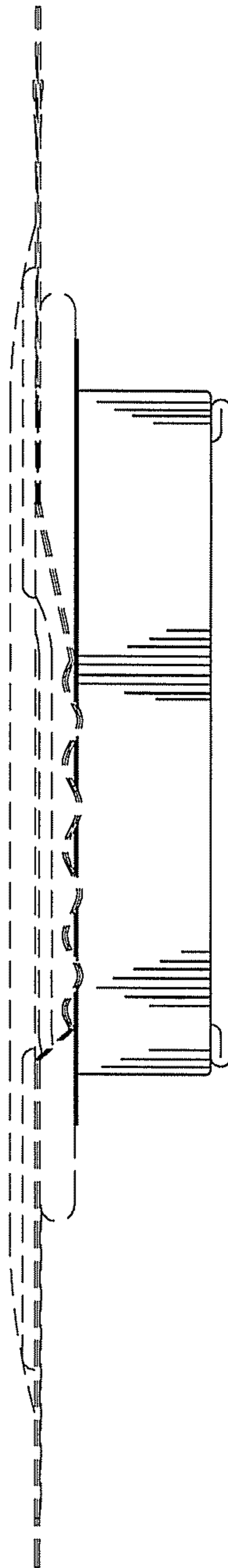

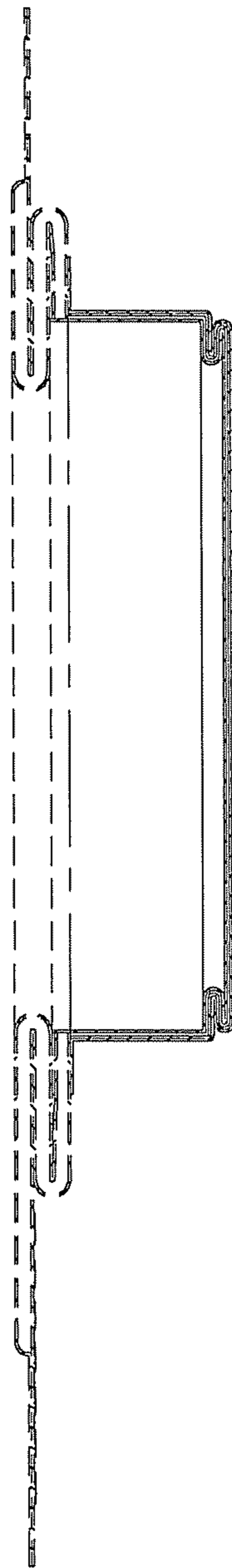
