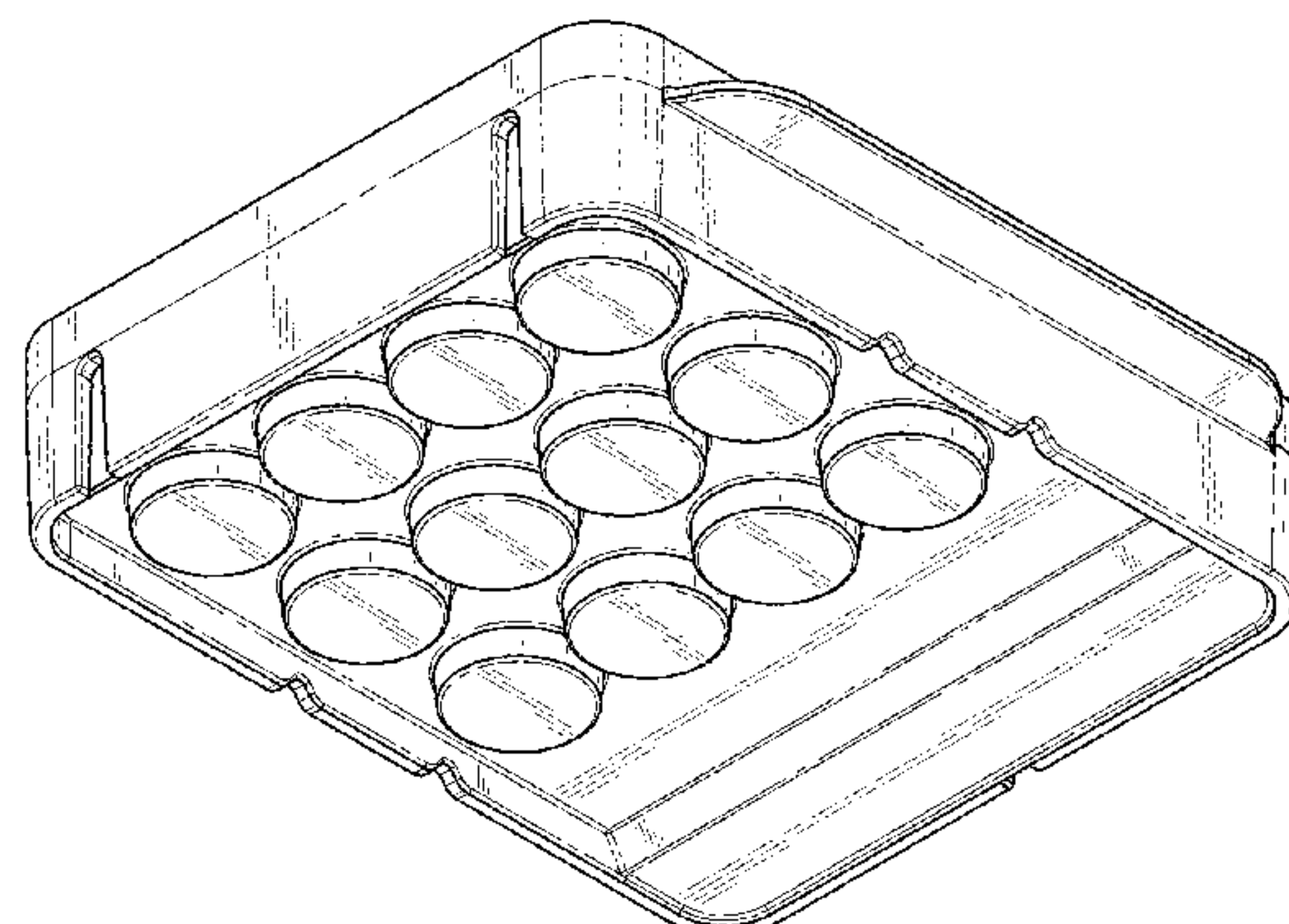
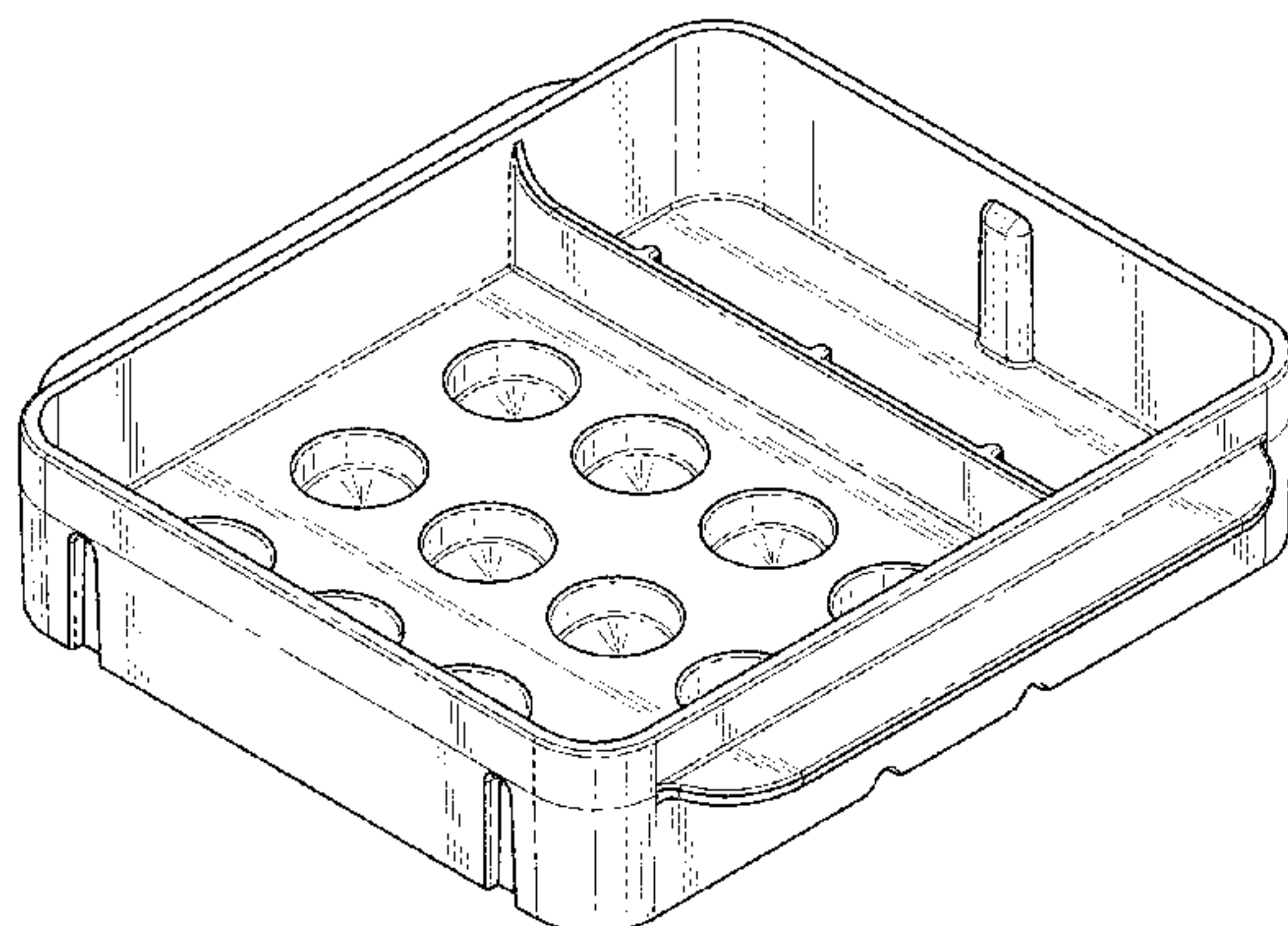
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of the culture dish;
FIG. 2 is a bottom perspective view of the culture dish;
FIG. 3 is a left side elevation view of the culture dish;
FIG. 4 is a right side elevation view of the culture dish;
FIG. 5 is a front elevation view of the culture dish;

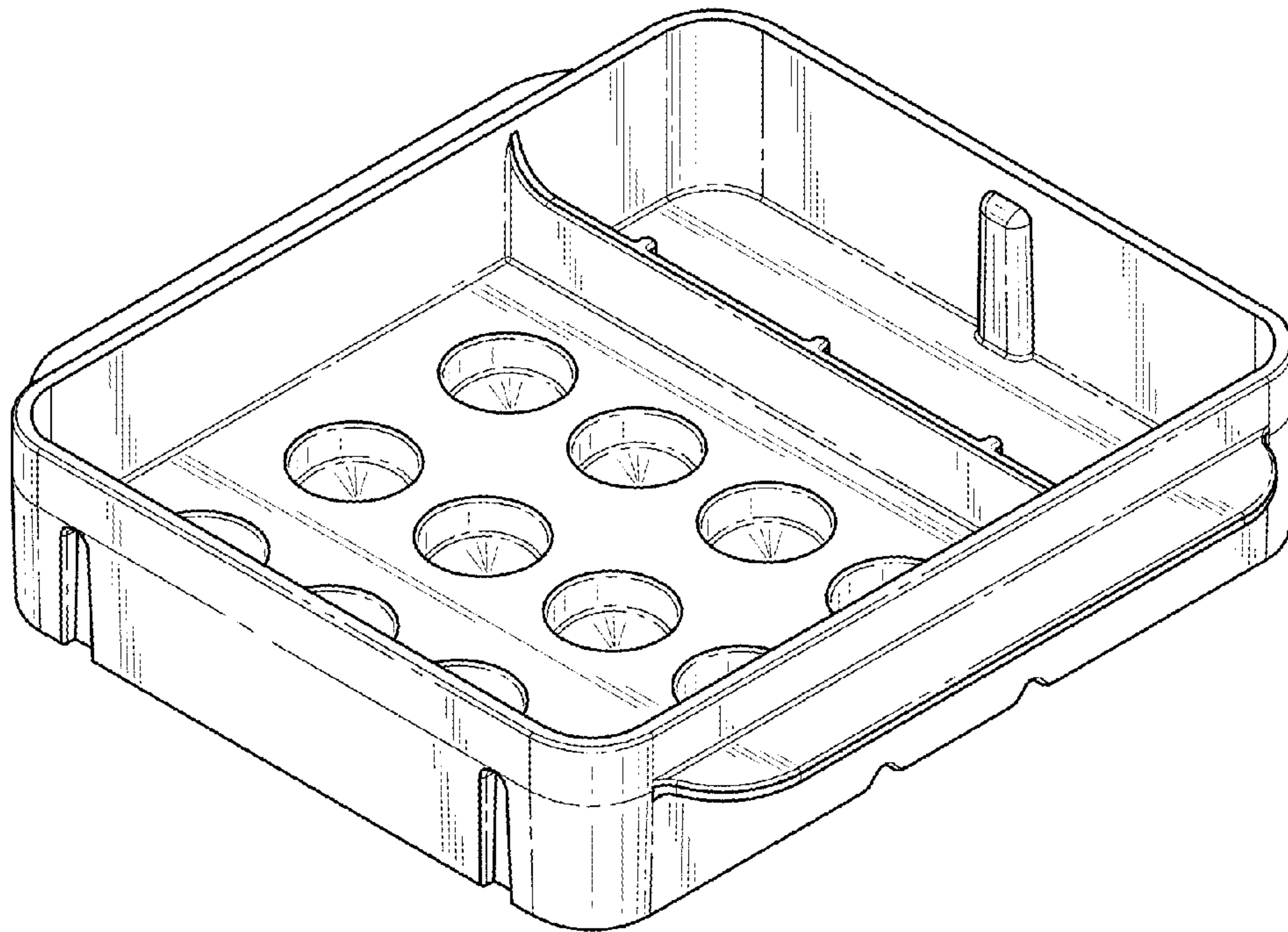

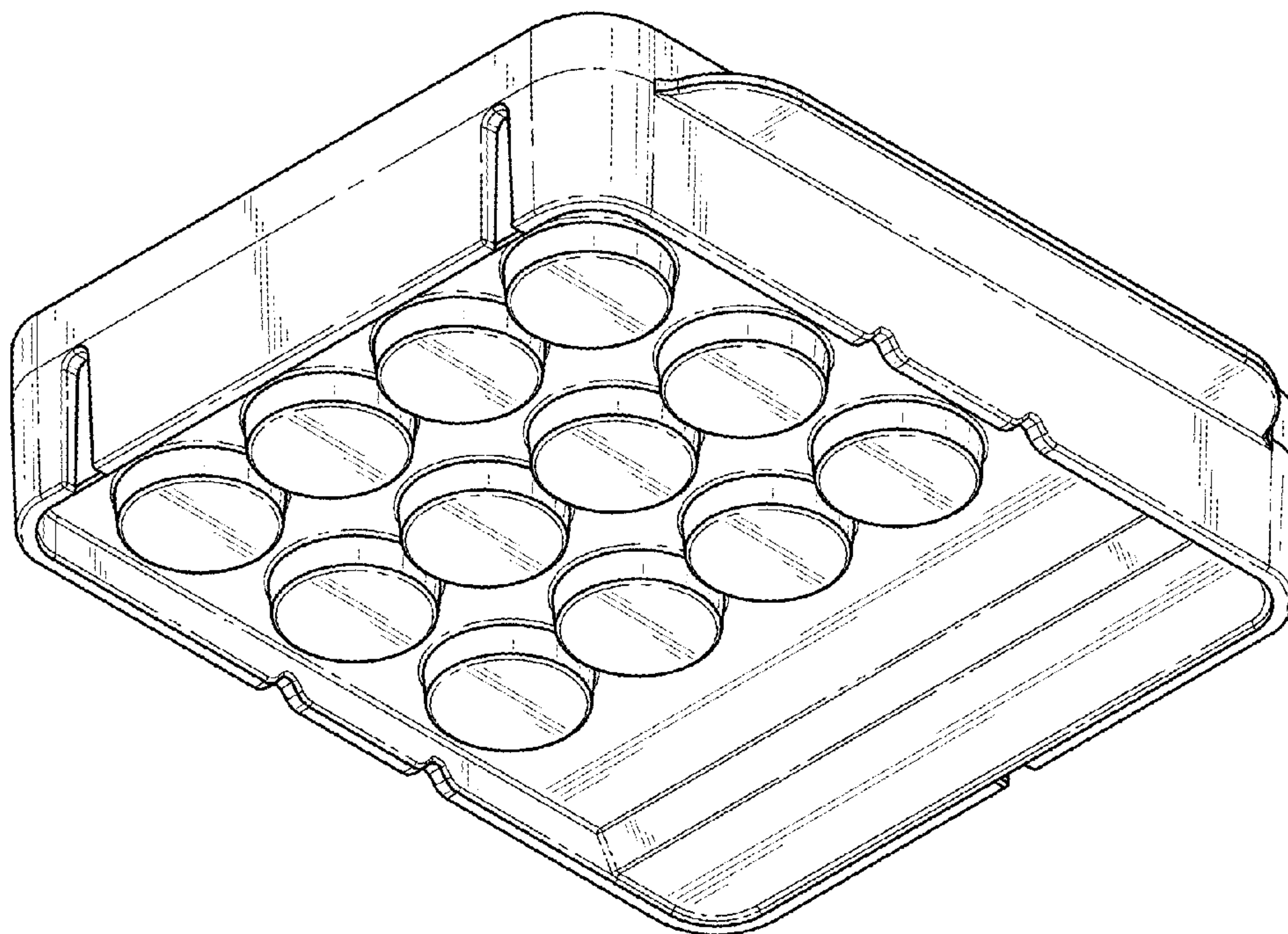

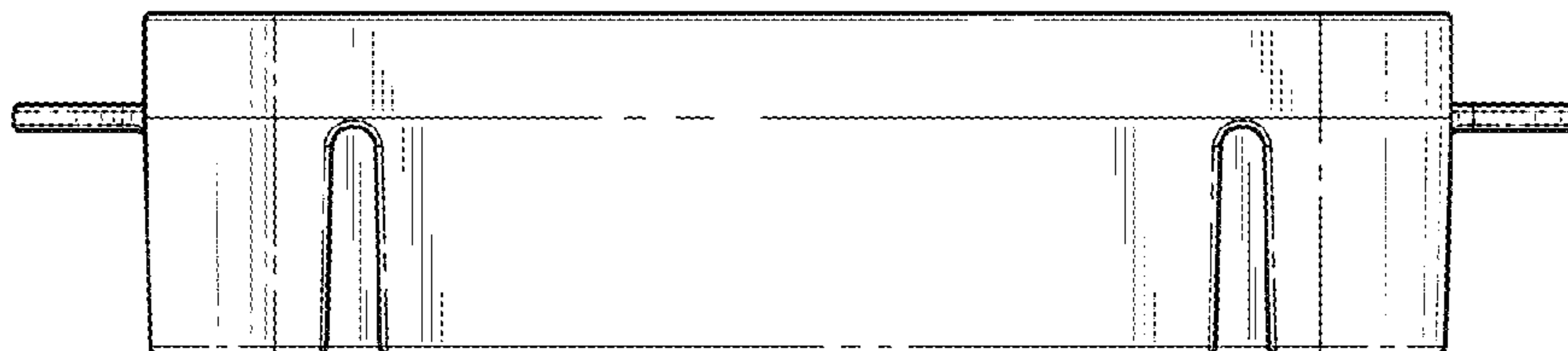

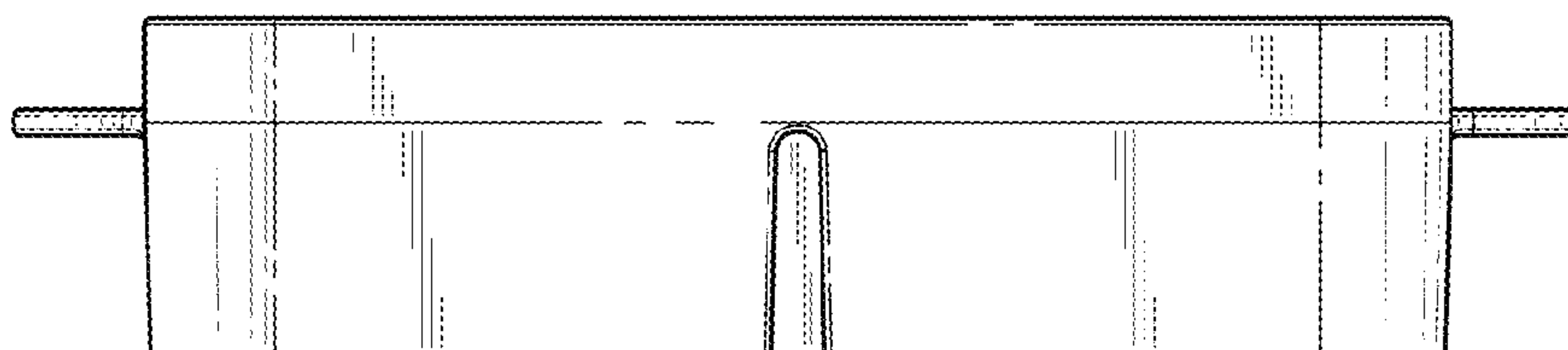

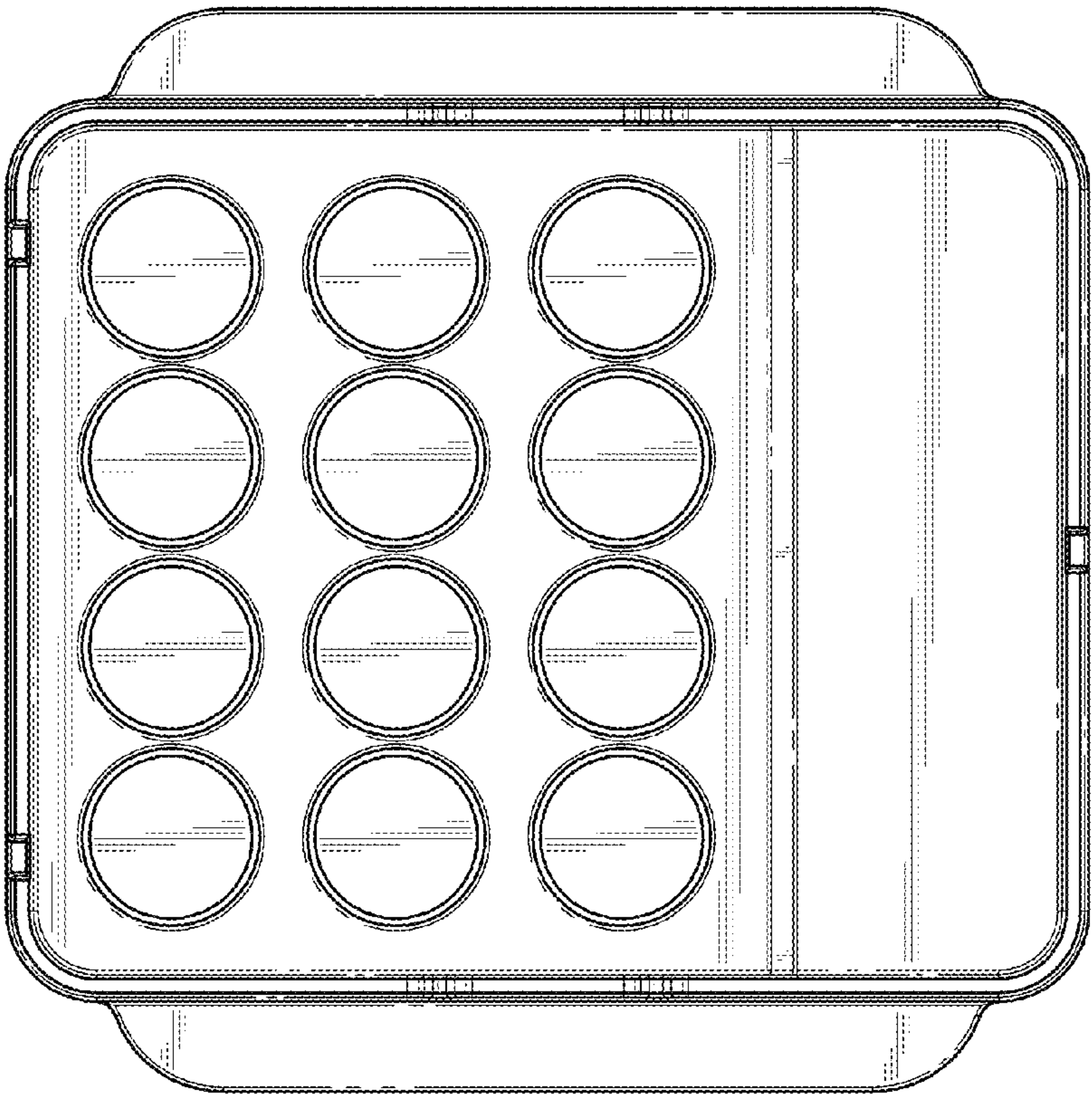

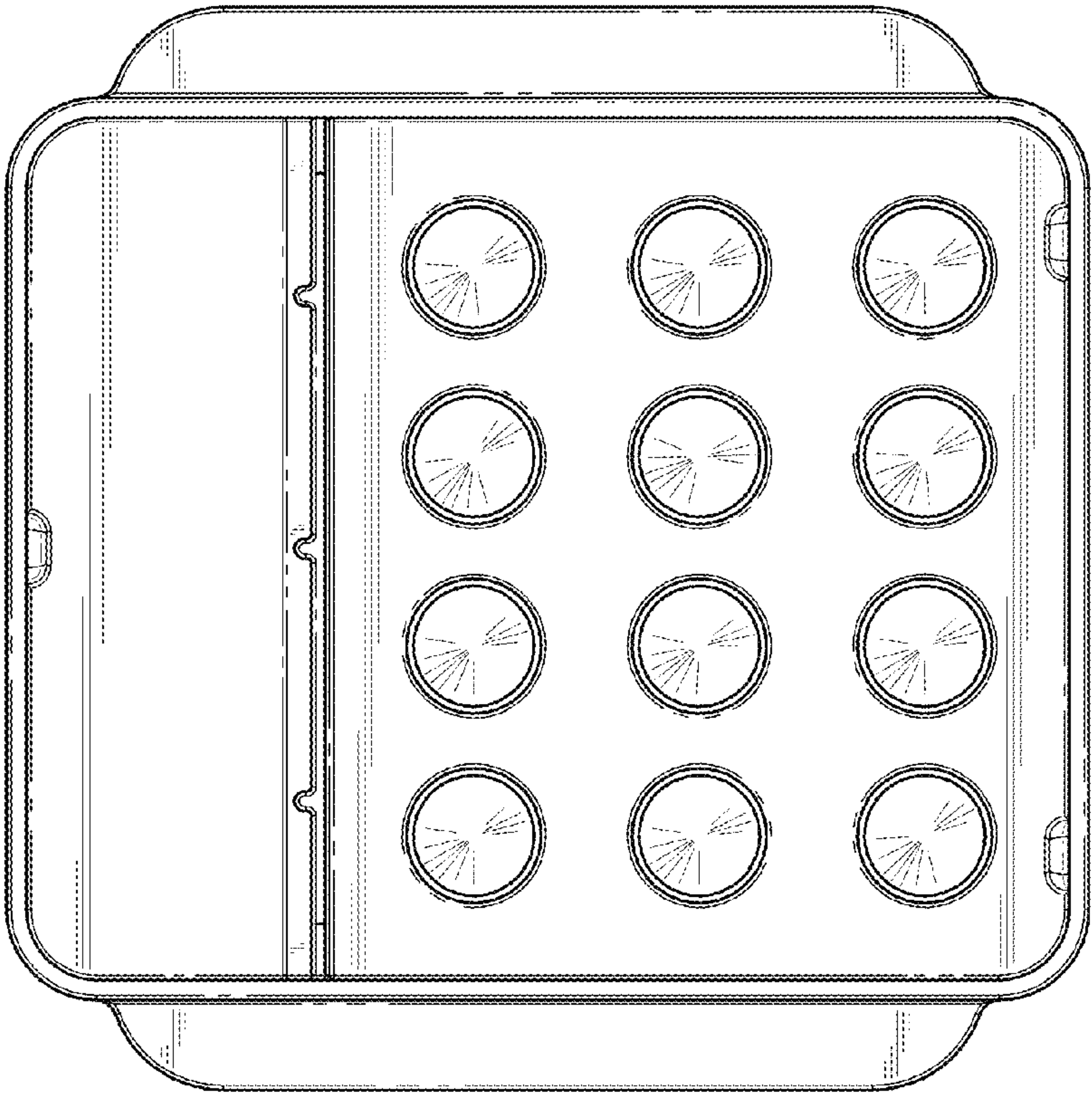
