The ornamental design for a mobile food storage cabinet, as shown and described.

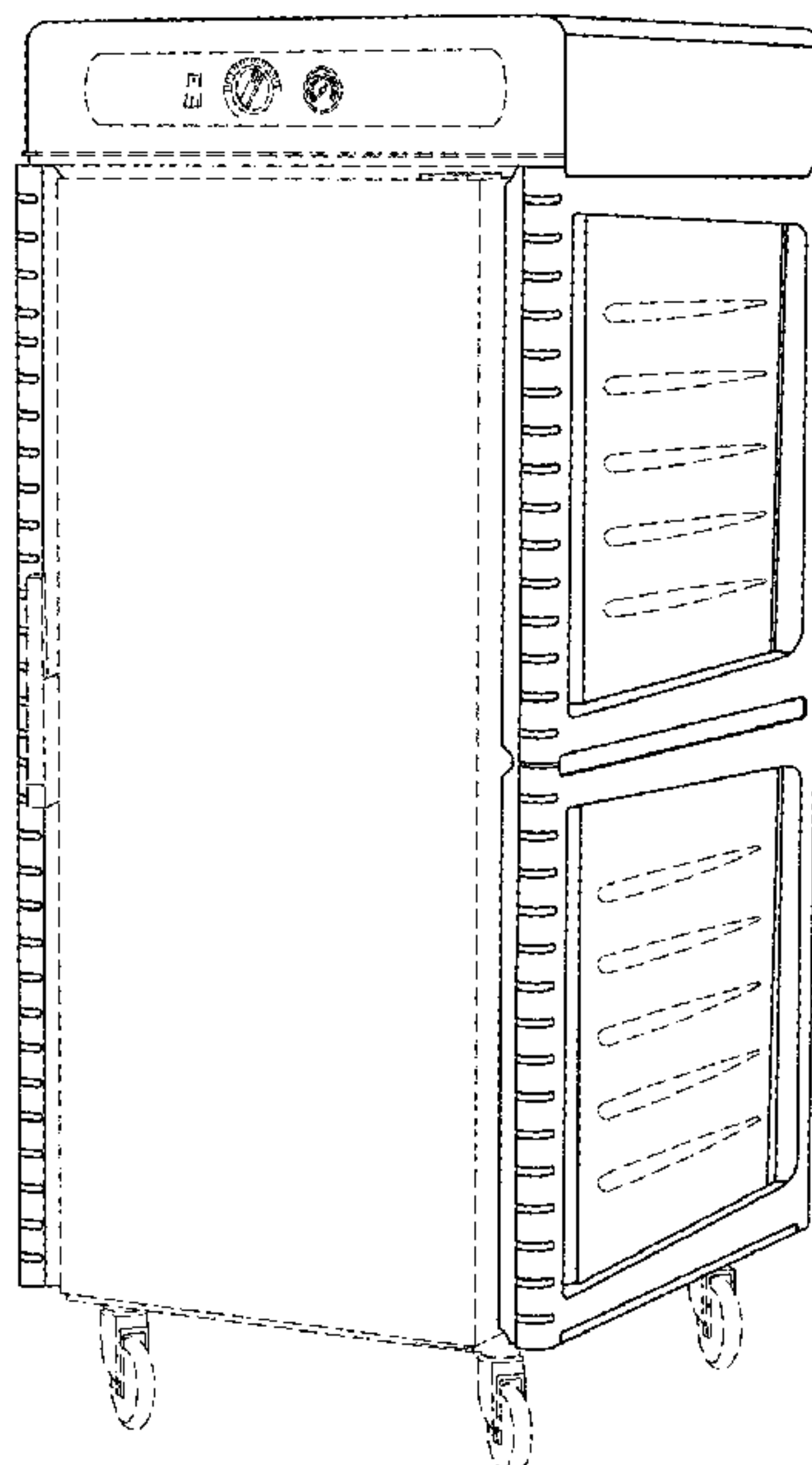
DESCRIPTION

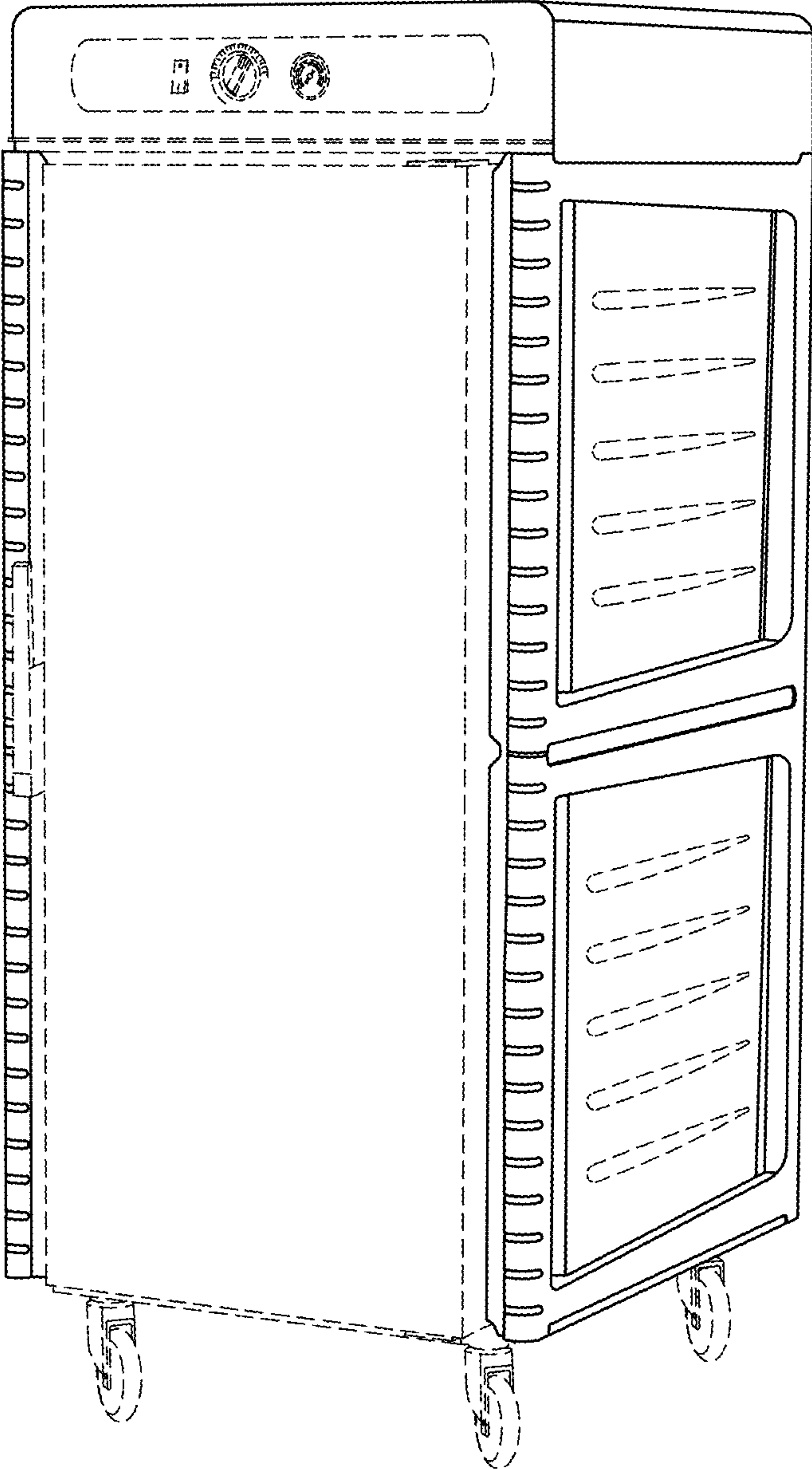

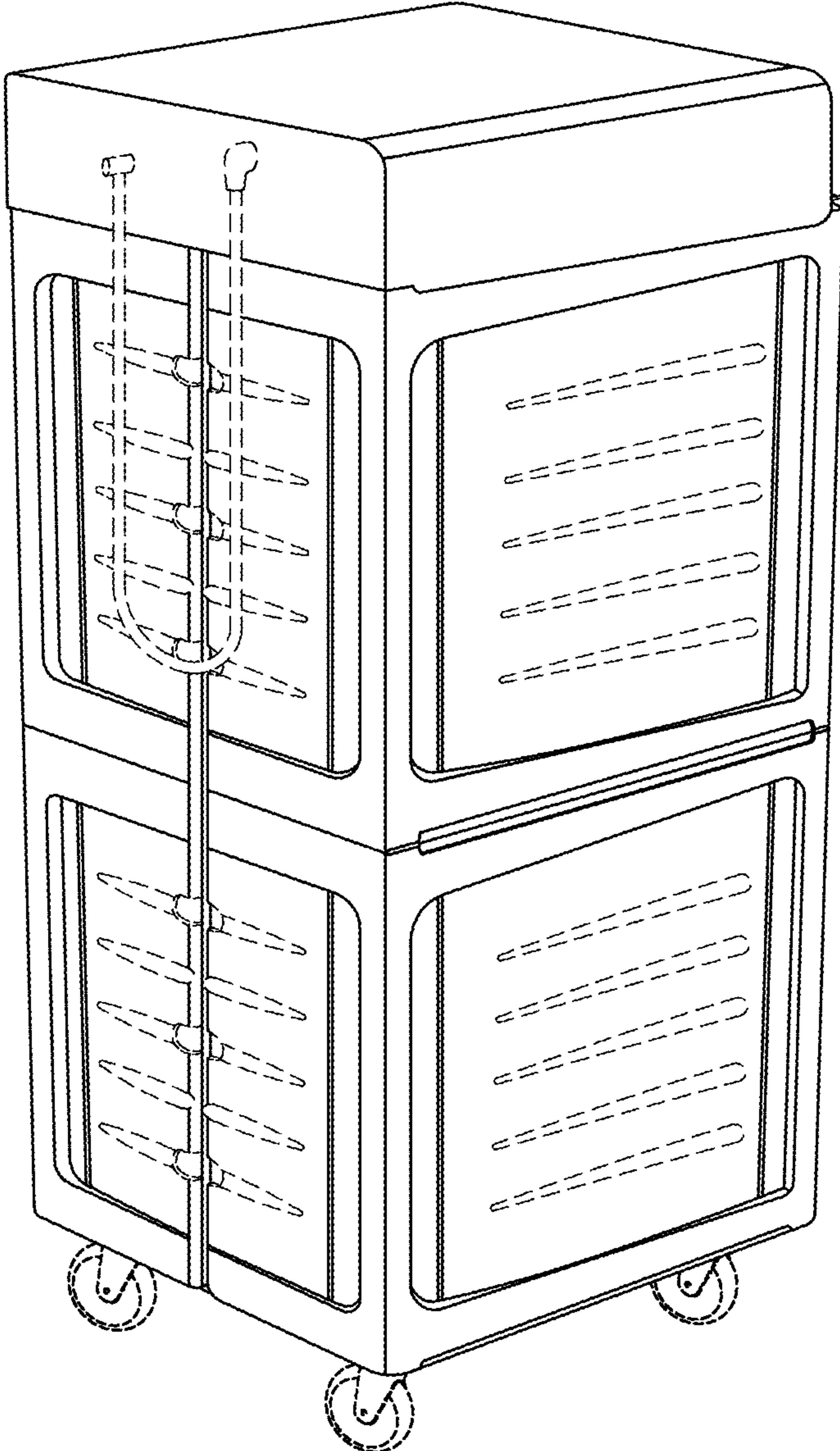

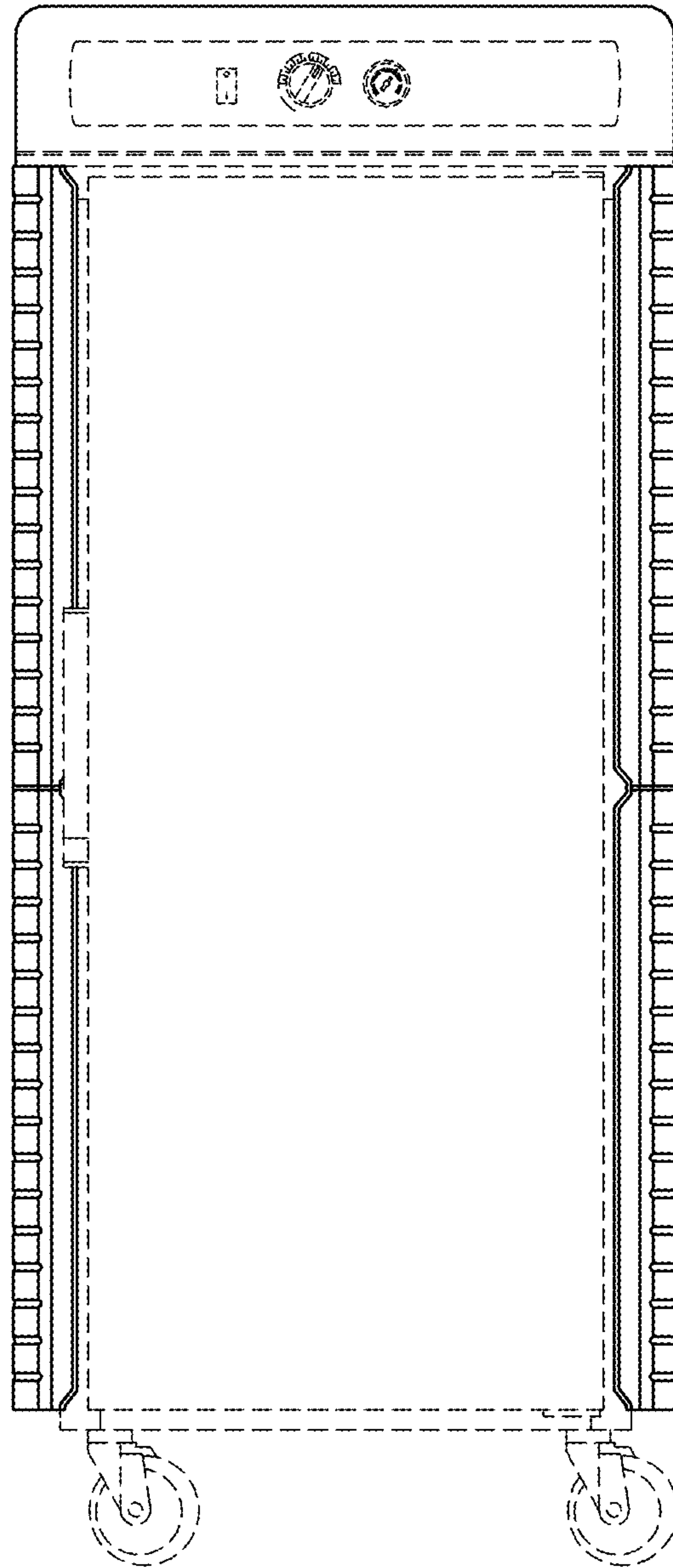

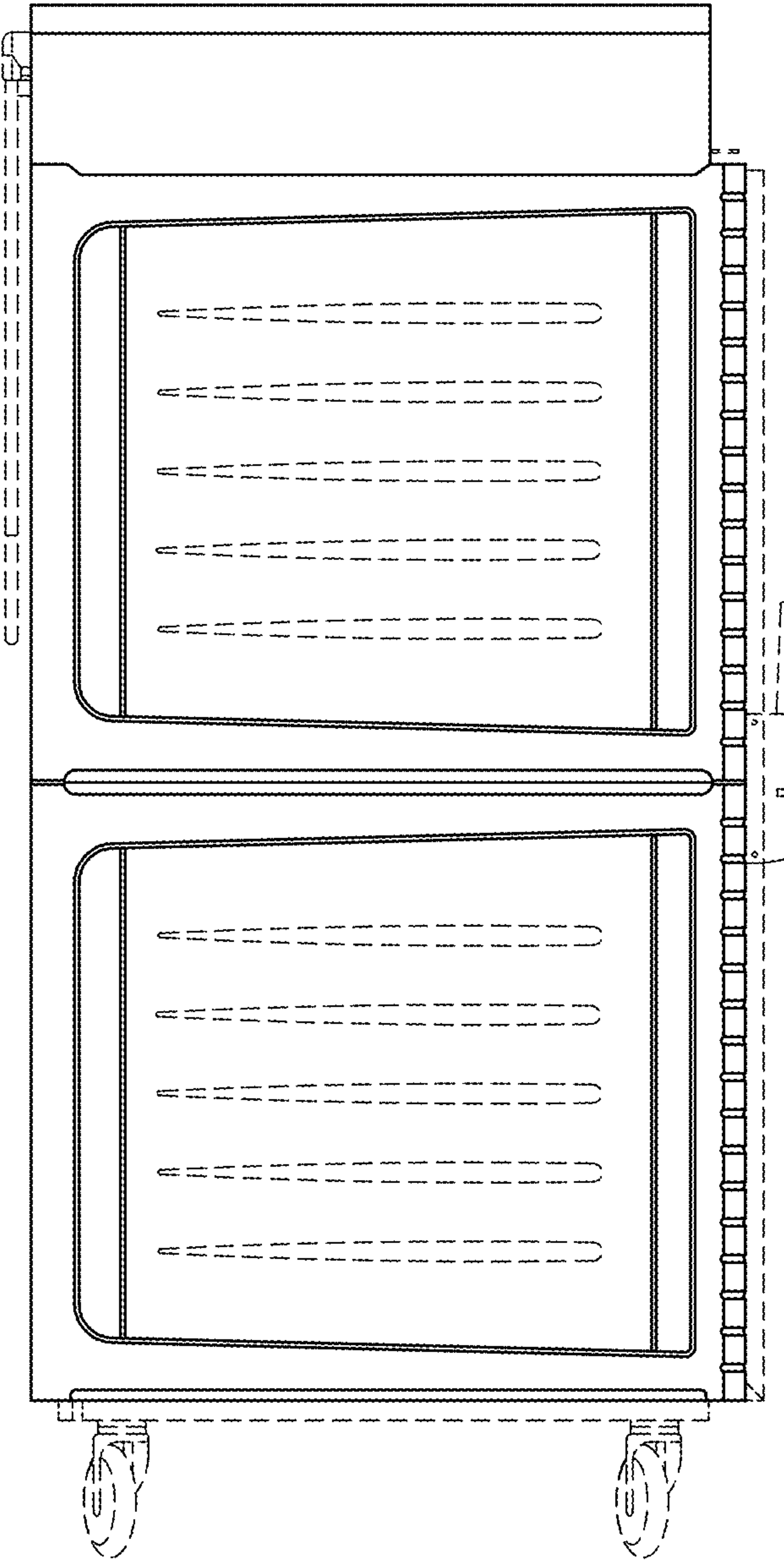

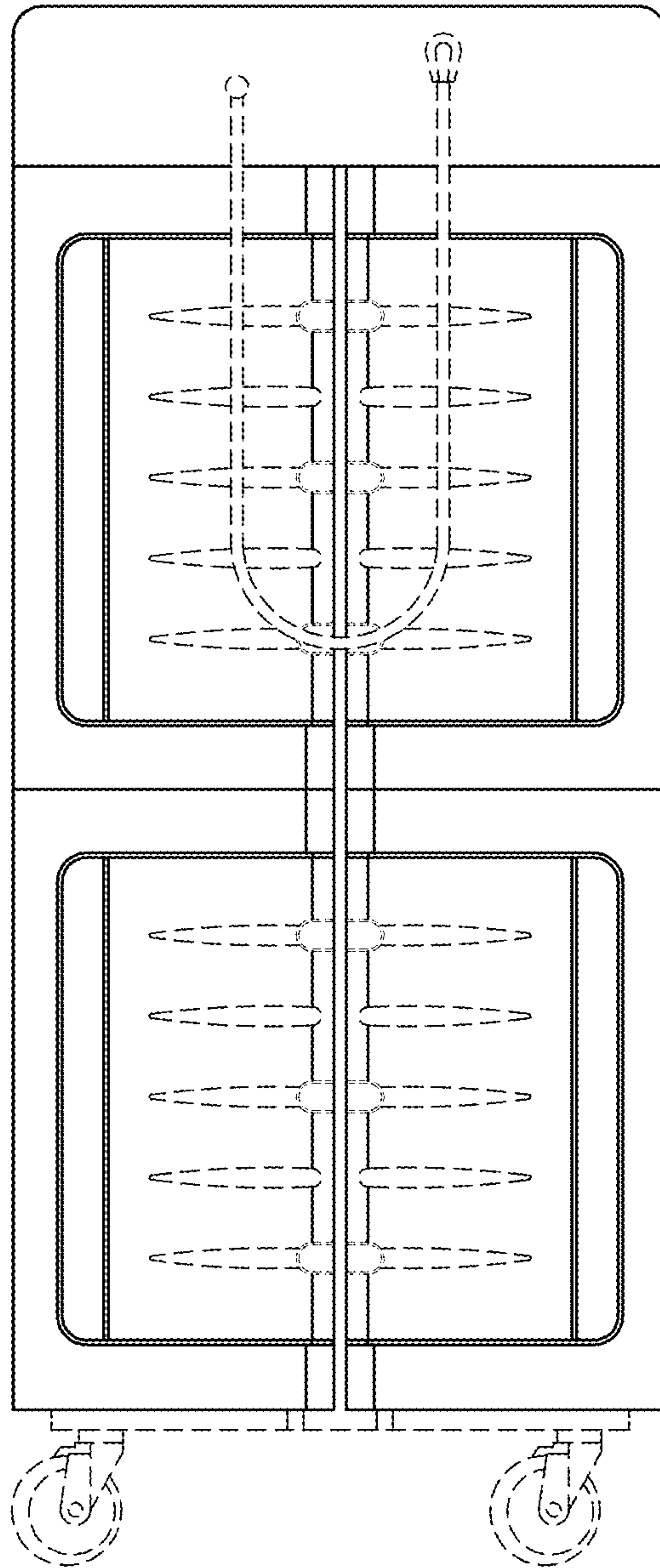

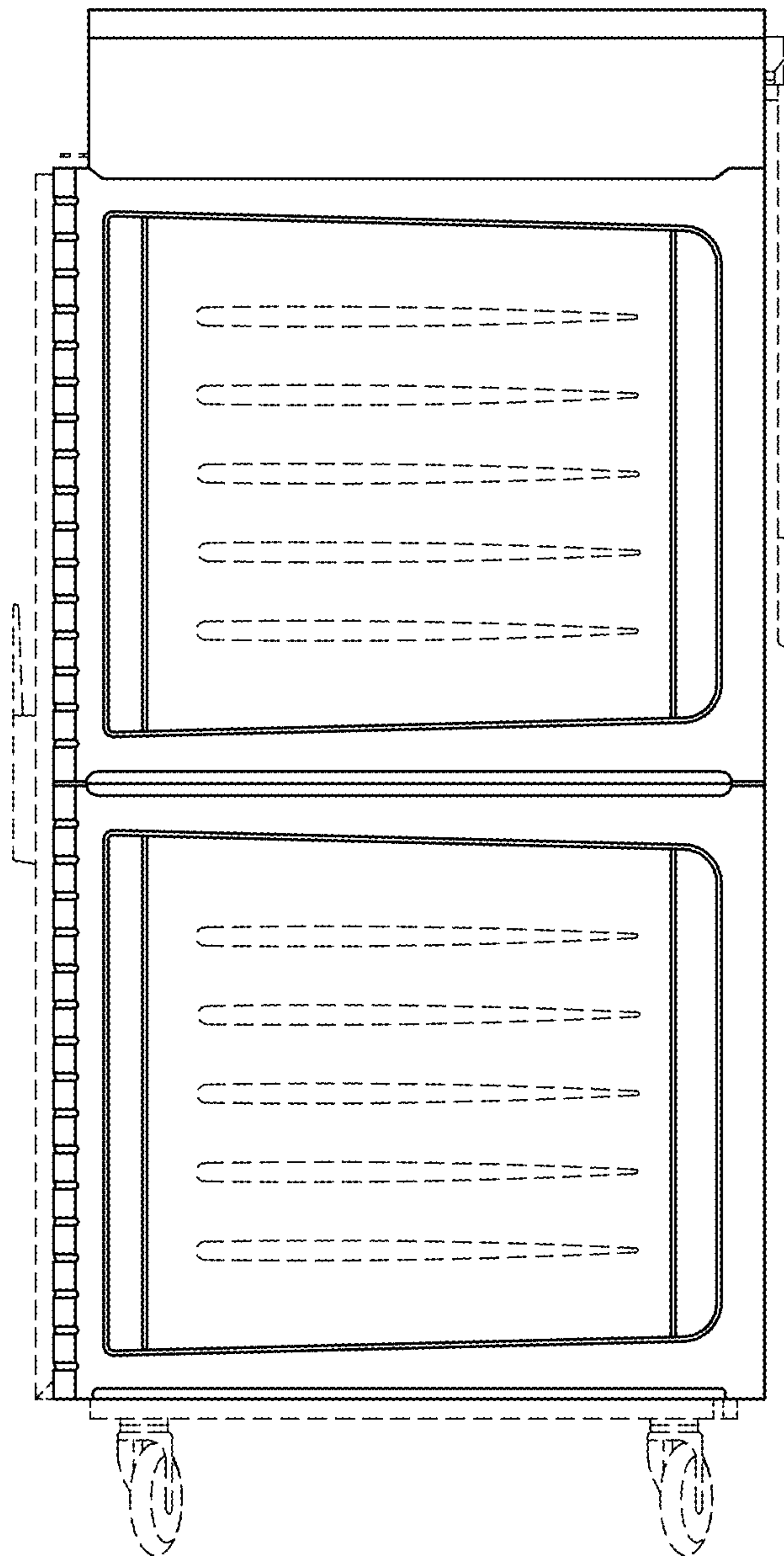

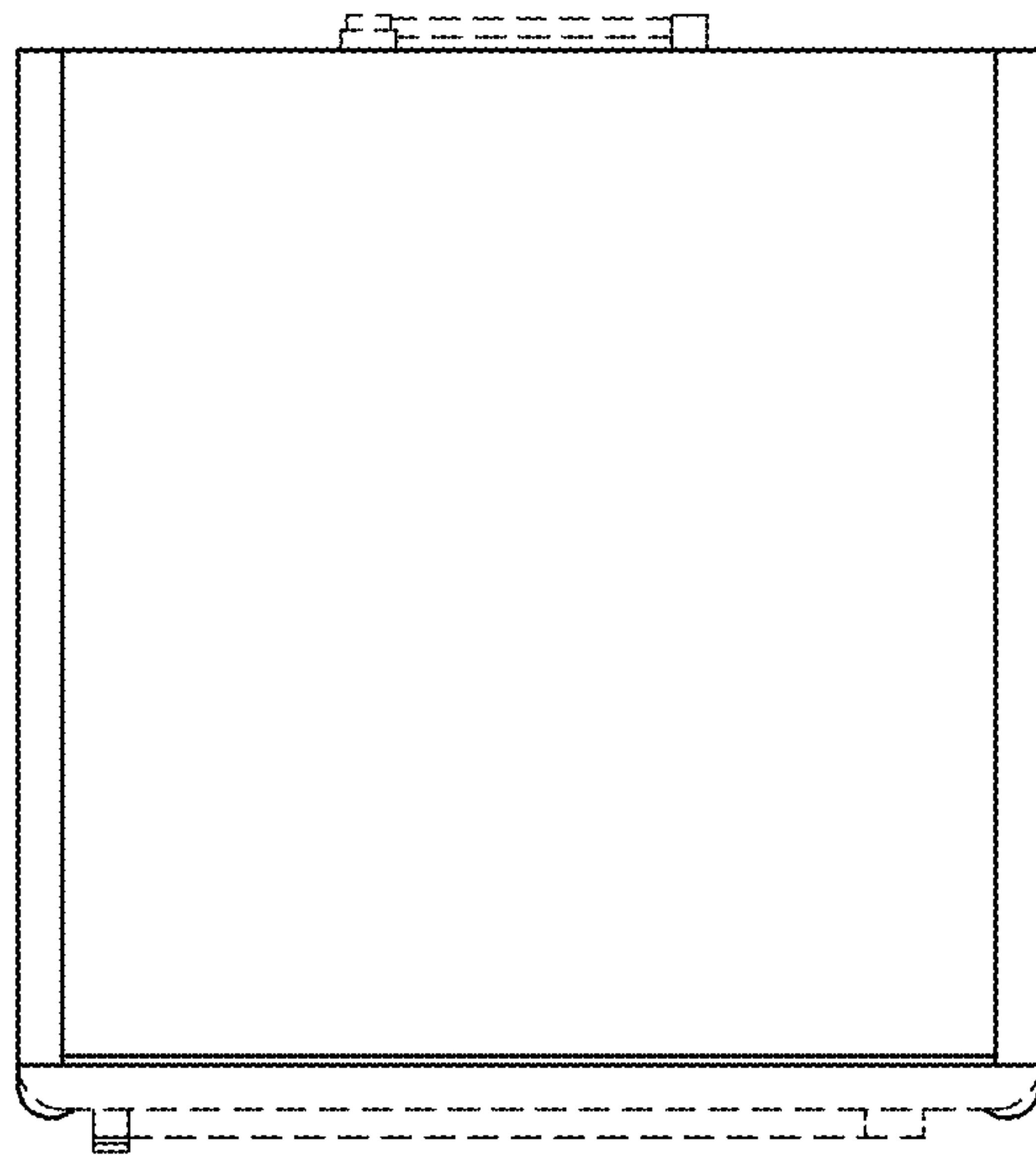

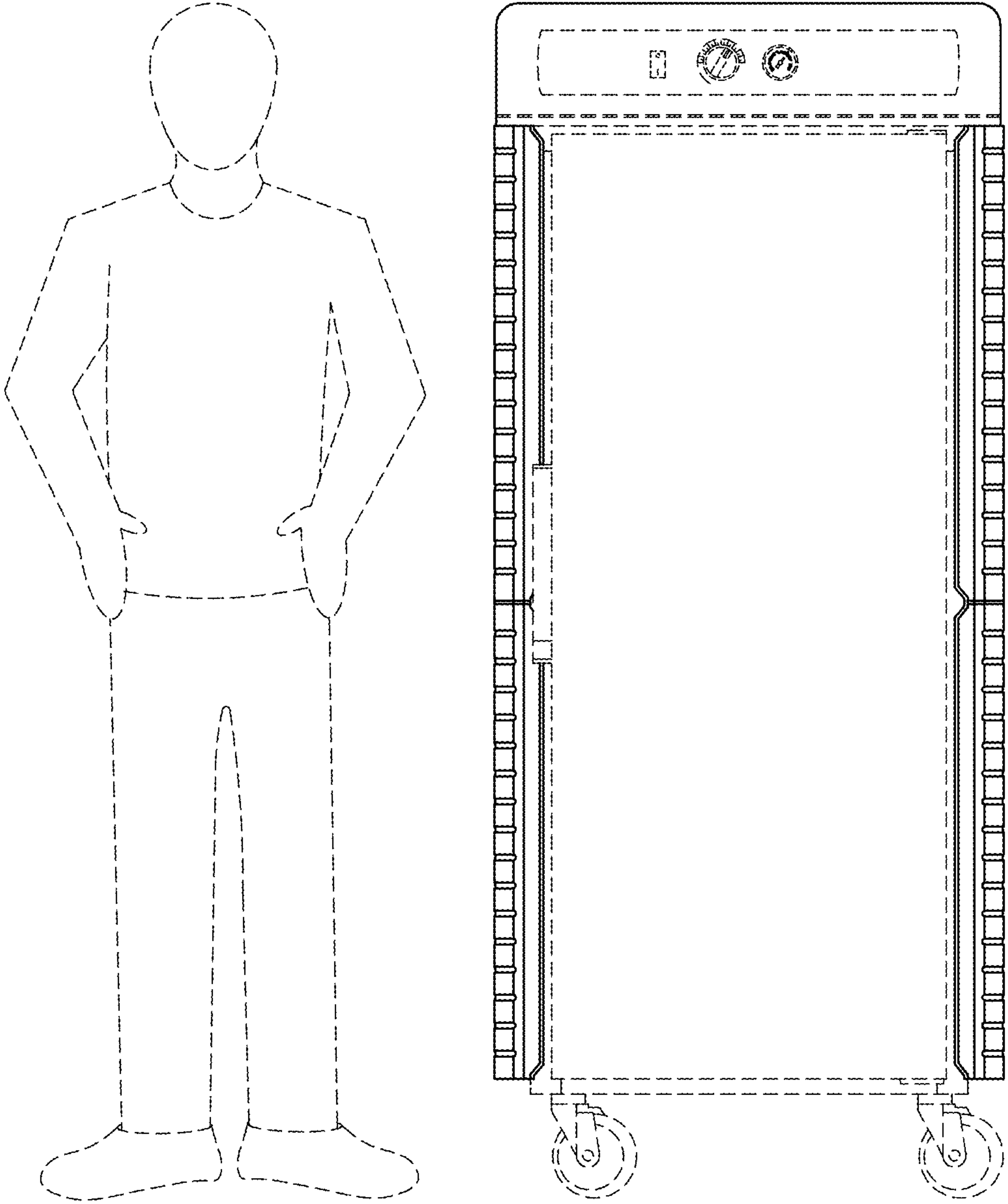
