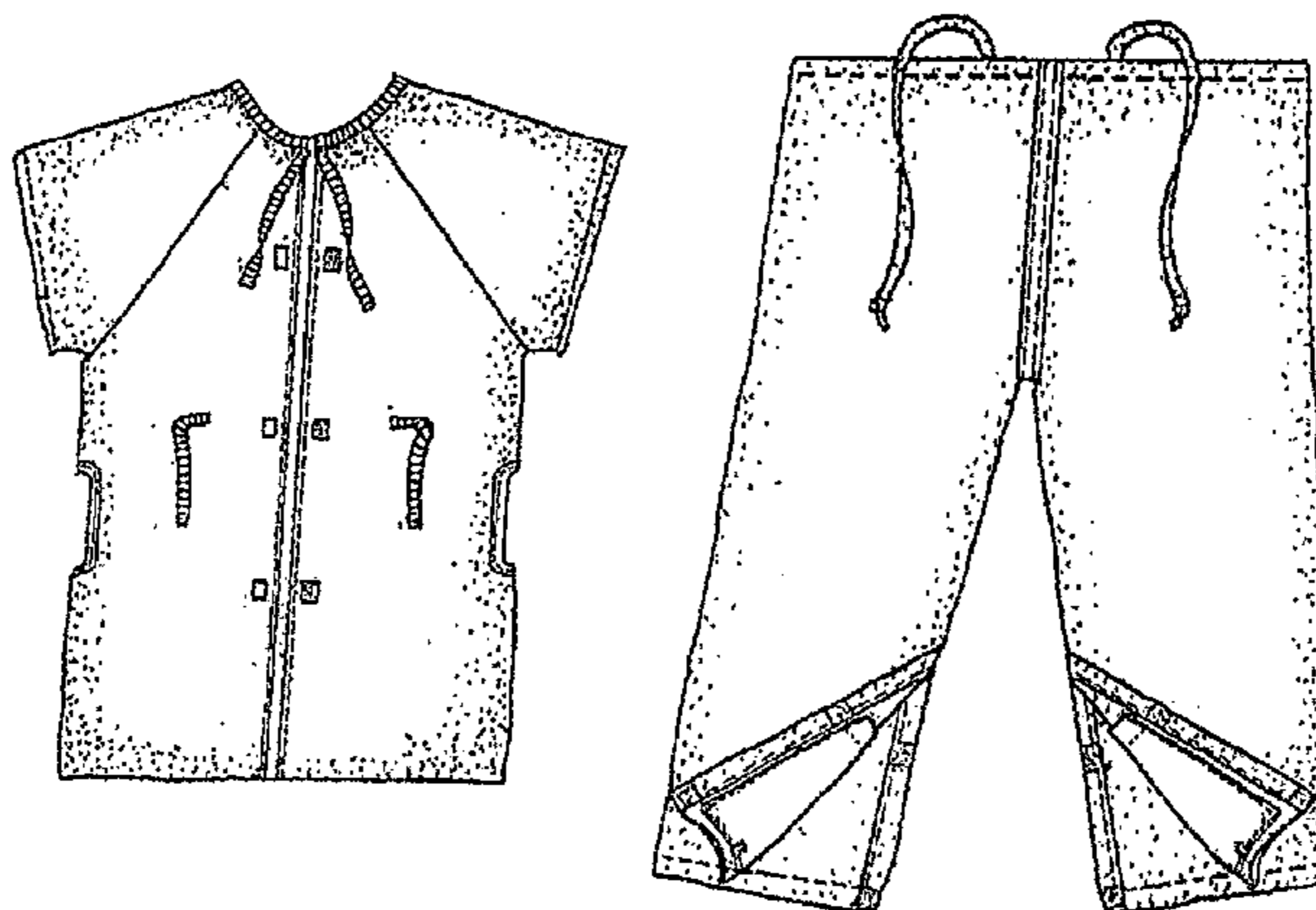
(57) **CLAIM**

The ornamental design for an after surgery clothing set, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an after surgery clothing set showing my new design;
FIG. 2 is a rear elevation view thereof;
FIG. 3 is an enlarged front elevation view of the gown in FIG. 1; the pants are omitted for ease of illustration;
FIG. 4 is an enlarged rear elevation view of the gown in FIG. 2; the pants are omitted for ease of illustration;
FIG. 5 is an enlarged front elevation view of the pants in FIG. 1; the gown is omitted for ease of illustration; and,
FIG. 6 is an enlarged rear elevation view of the pants in FIG. 2; the gown is omitted for ease of illustration.
The dash-dash lines illustrate stitching that forms part of the claimed design.

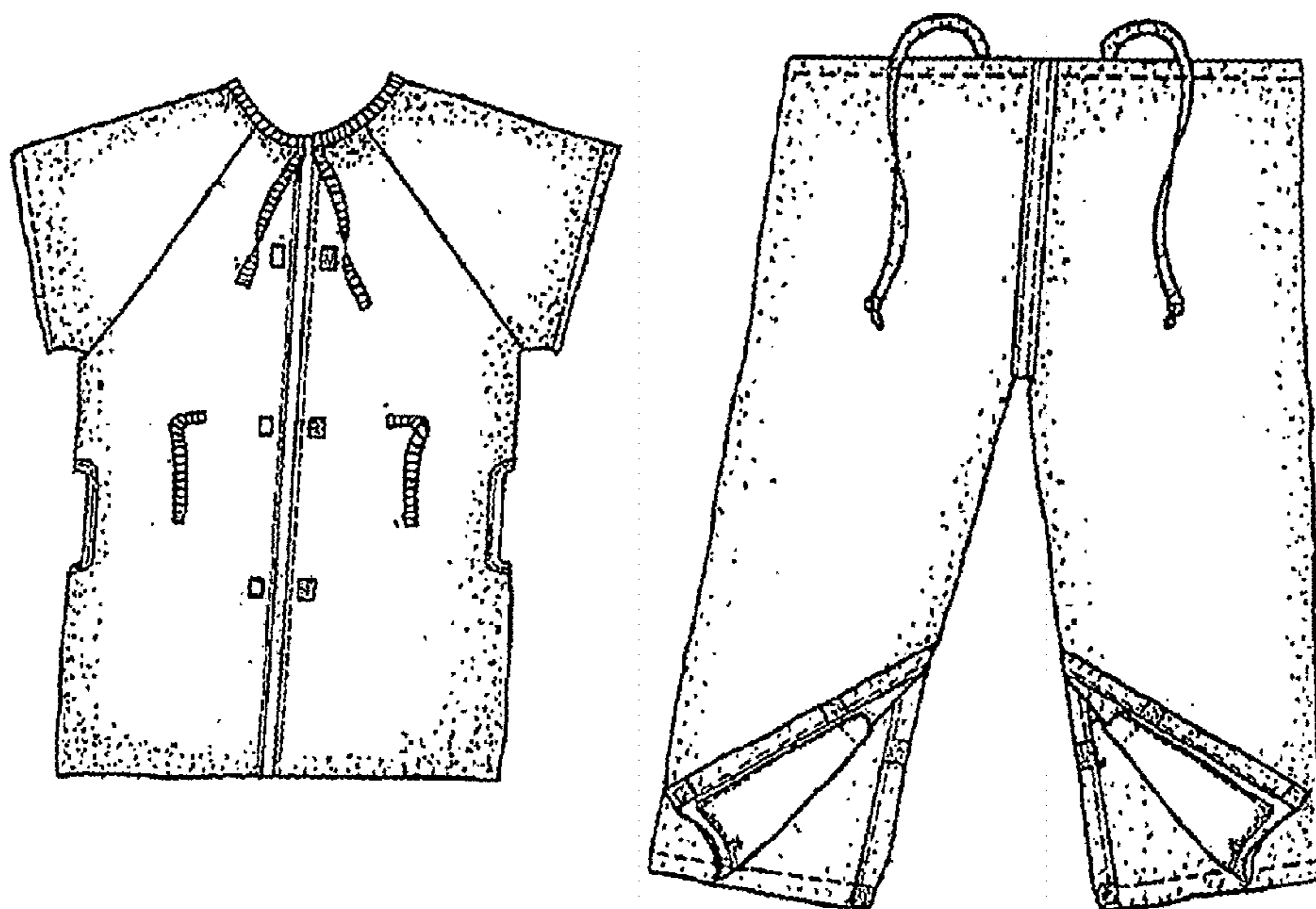

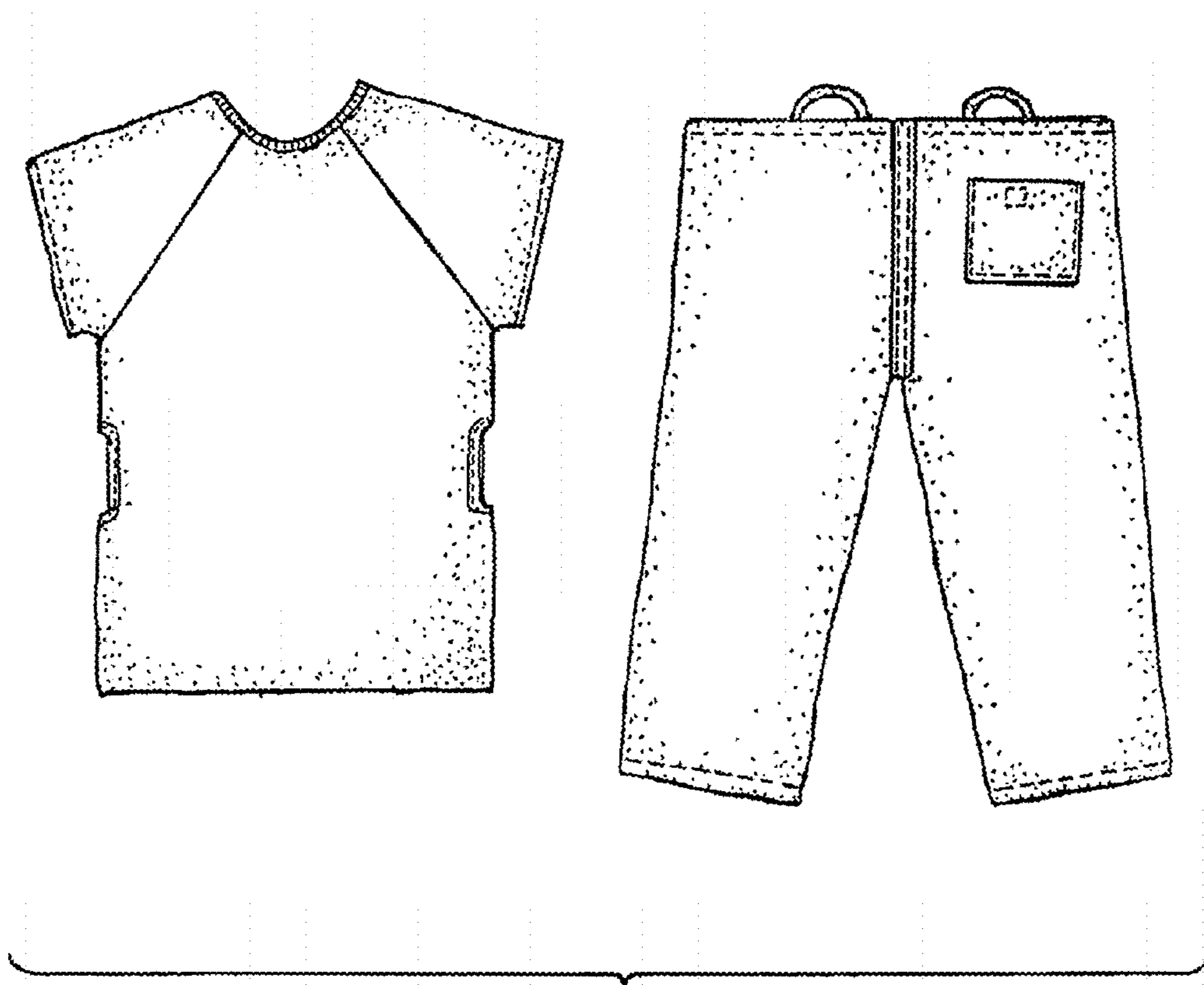

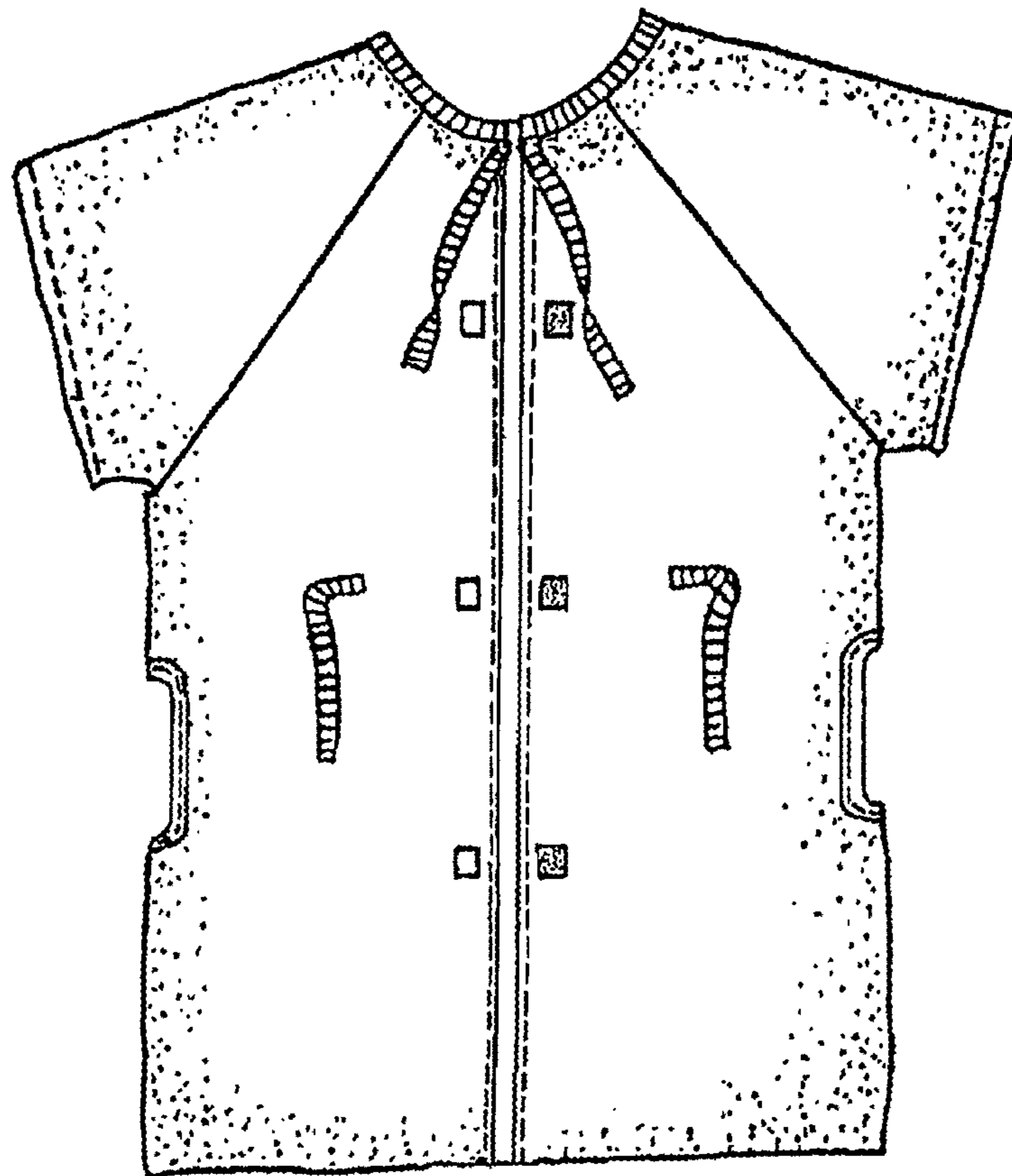

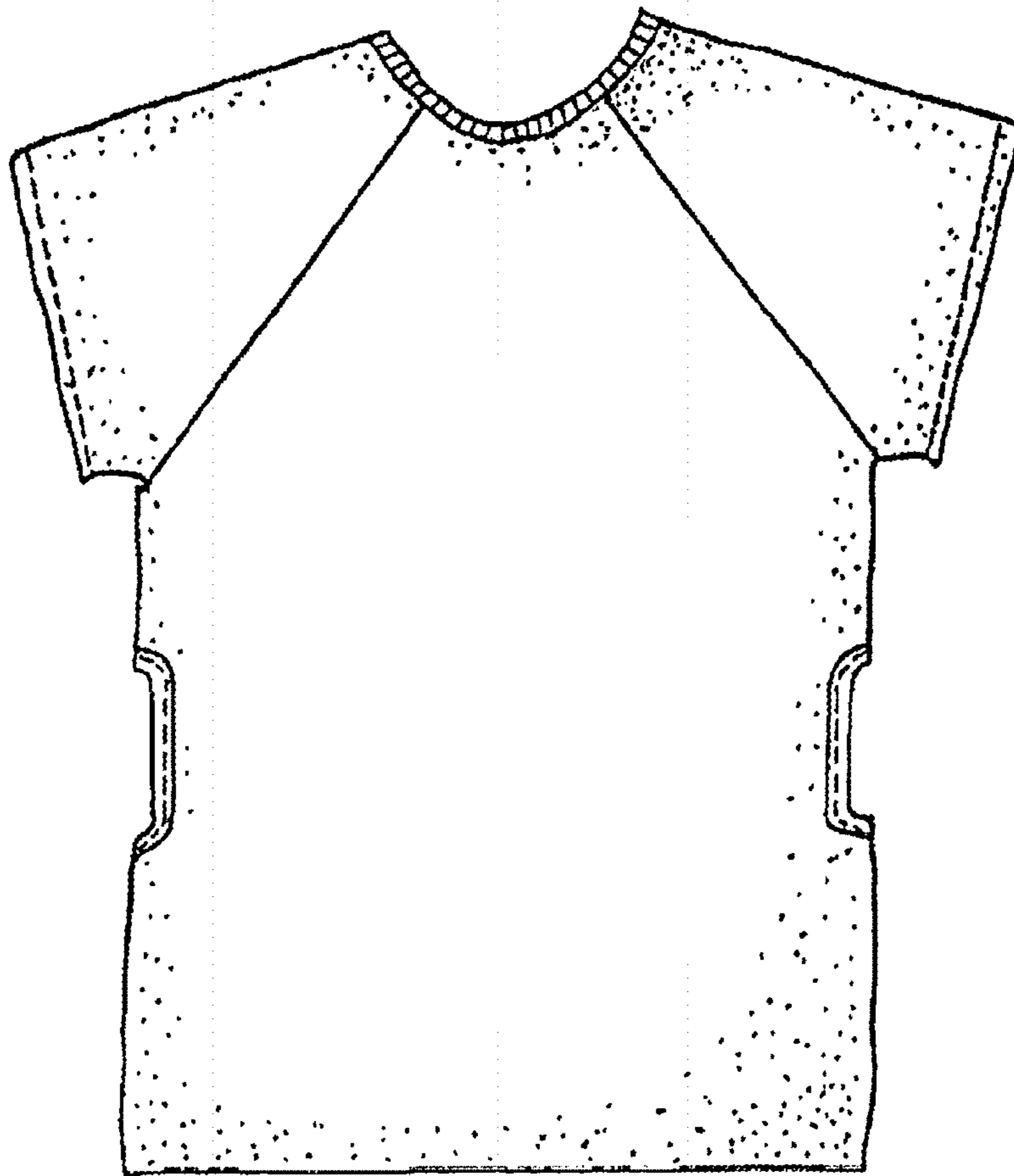

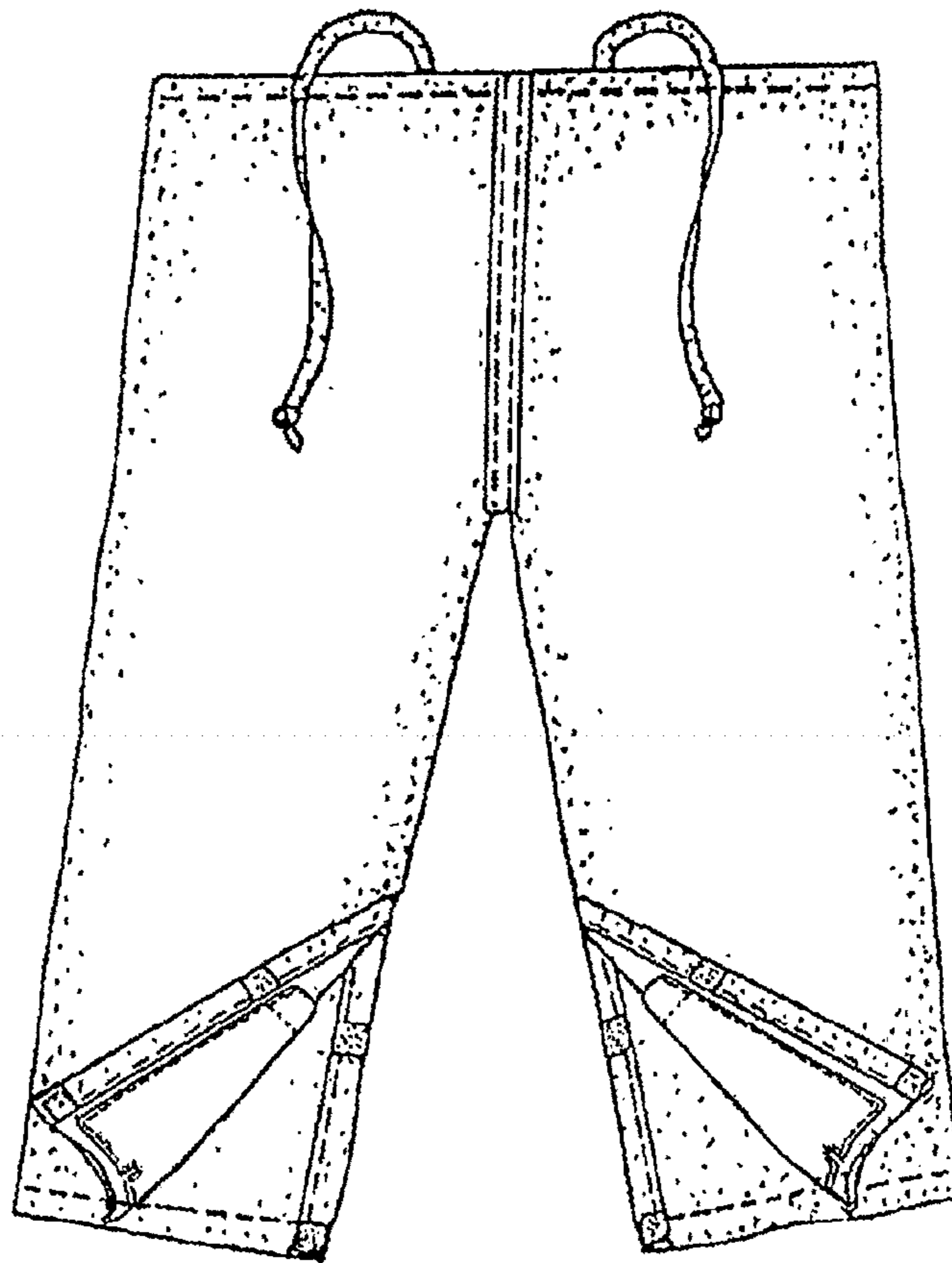

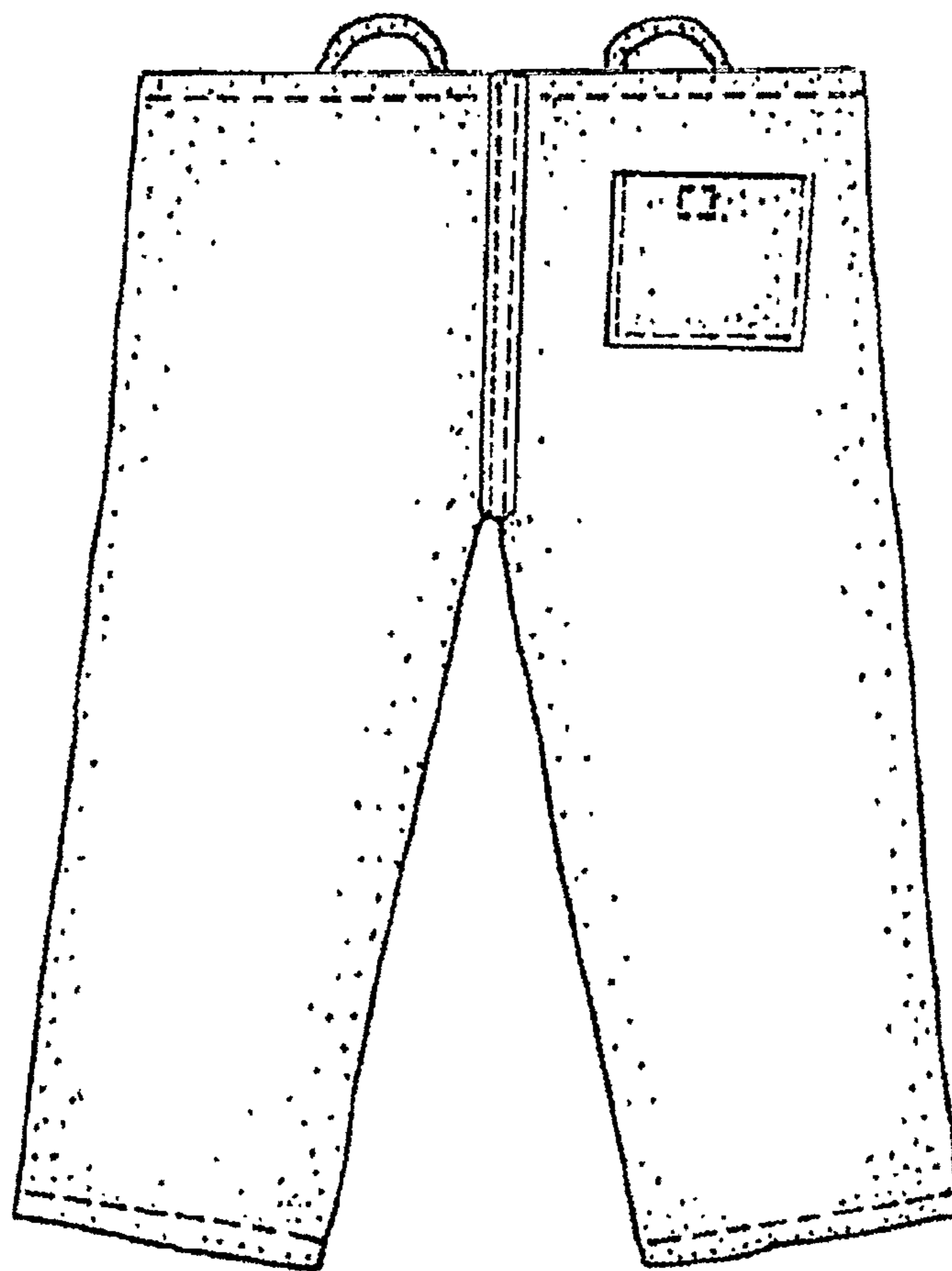
