(57) **CLAIM**

The ornamental design for a putter pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the putter pocket attached to an article of clothing with an individual inserting a flying disc, or disc golf putter, into the pocket;

FIG. 2 is a front view of the invention with the putter pocket in an open position;

FIG. 3 is a front view of the invention with the putter pocket held in a closed position with a suitable fastener such as hook and loop material;

FIG. 4 is a rear view of the invention;

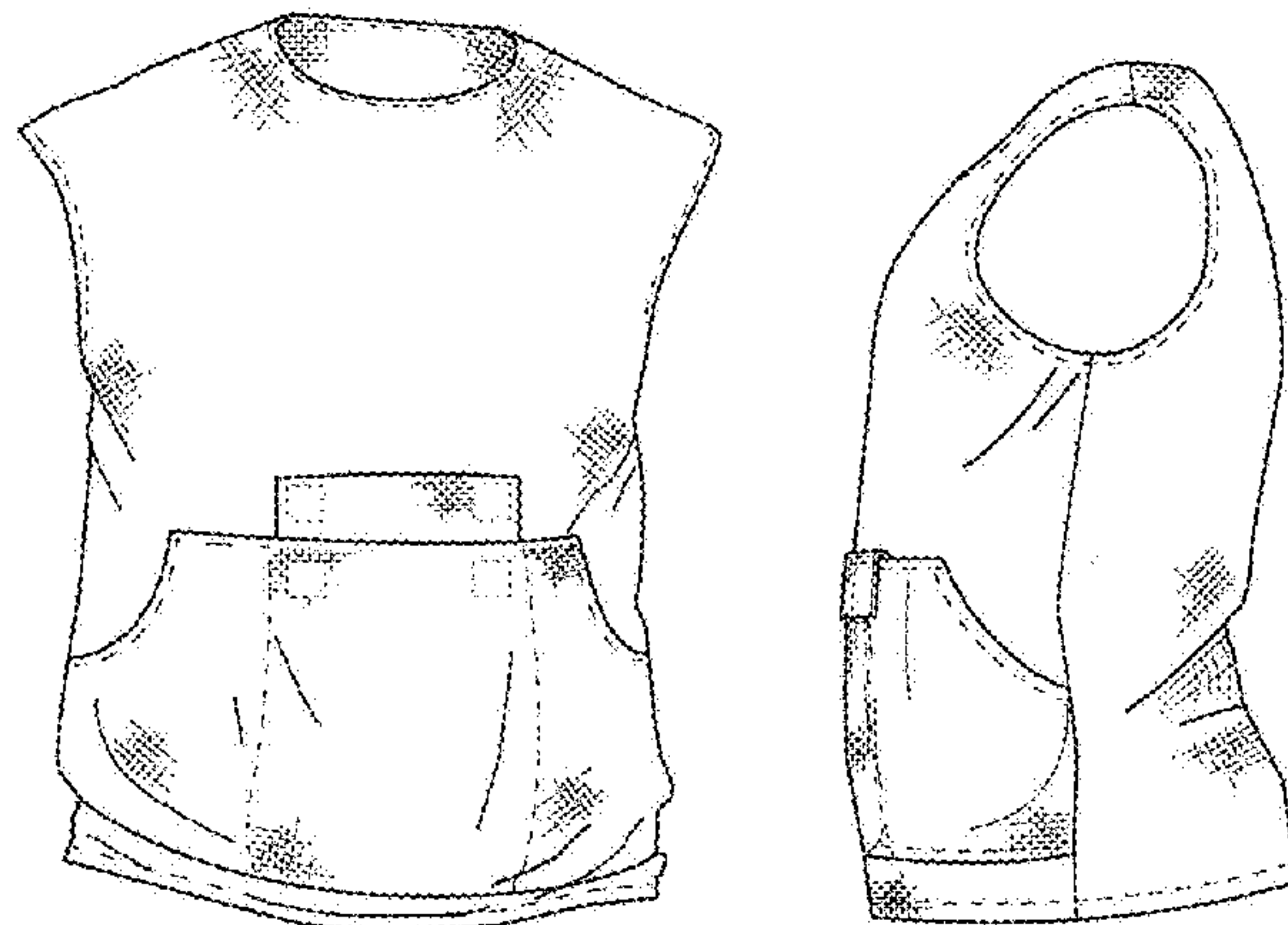
FIG. 5 is a right side view of the invention with the putter pocket in a closed position with a suitable fastener such as hook and loop material;

FIG. 6 is a left side view of the invention with the putter pocket in a closed position with a suitable fastener such as hook and loop material; and,

FIG. 7 is a perspective, exploded view of the invention showing the individual parts of an article of clothing and the putter pocket.

The broken lines are included for the purpose of illustrating portions of the putter pocket that form no part of the claimed design. Cross-hatch marks are used only to indicate fabric and contour and are not part of the claimed design.

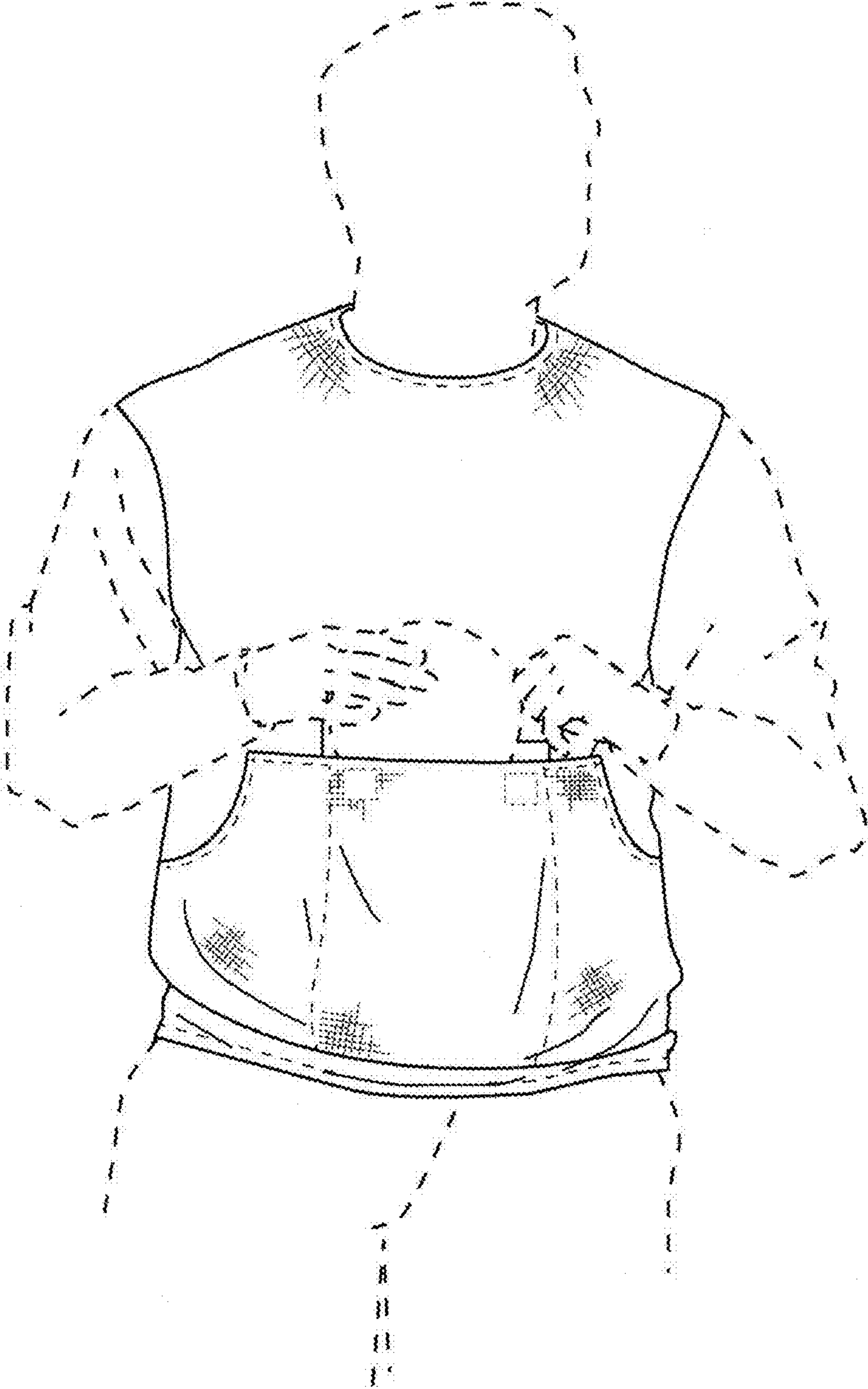

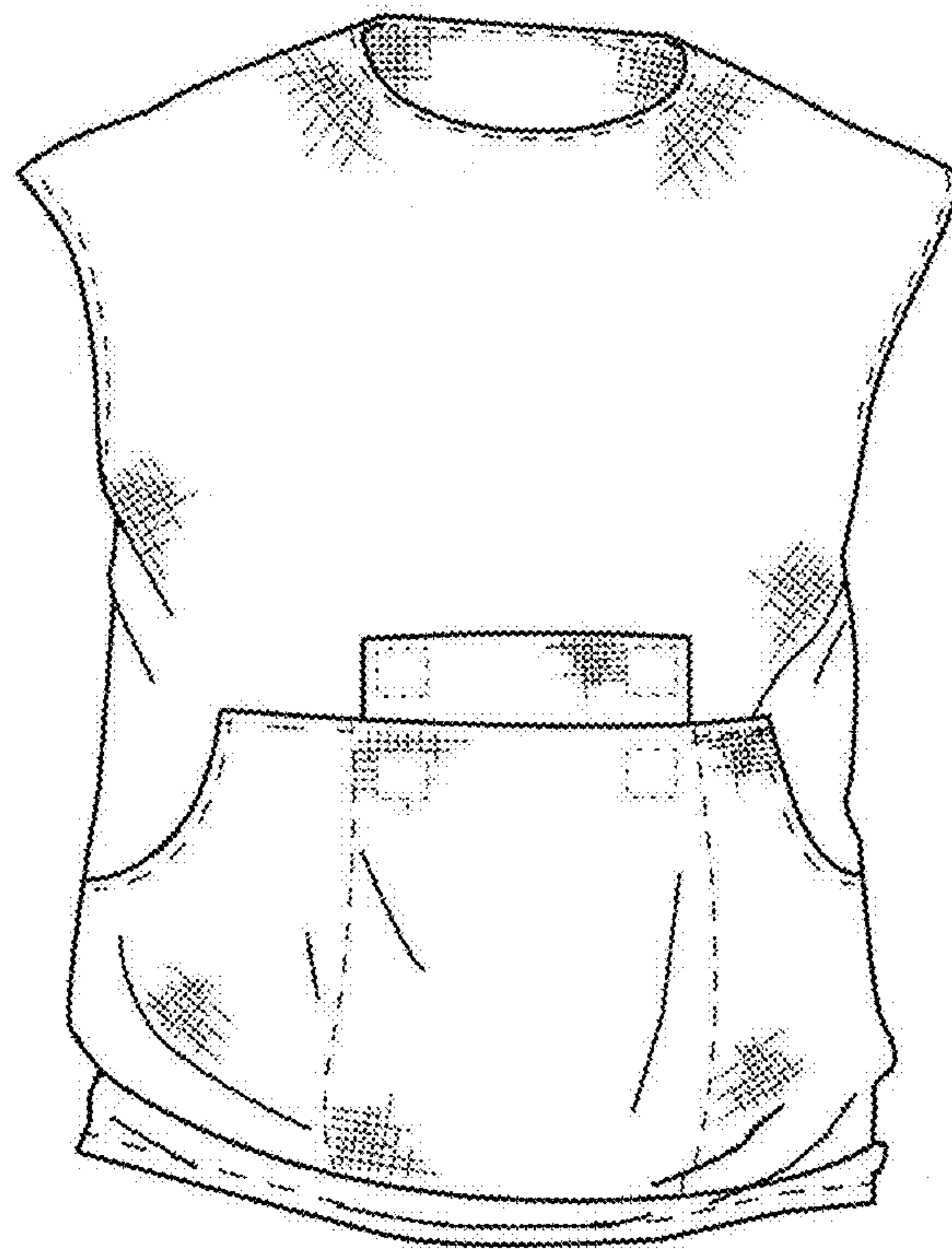

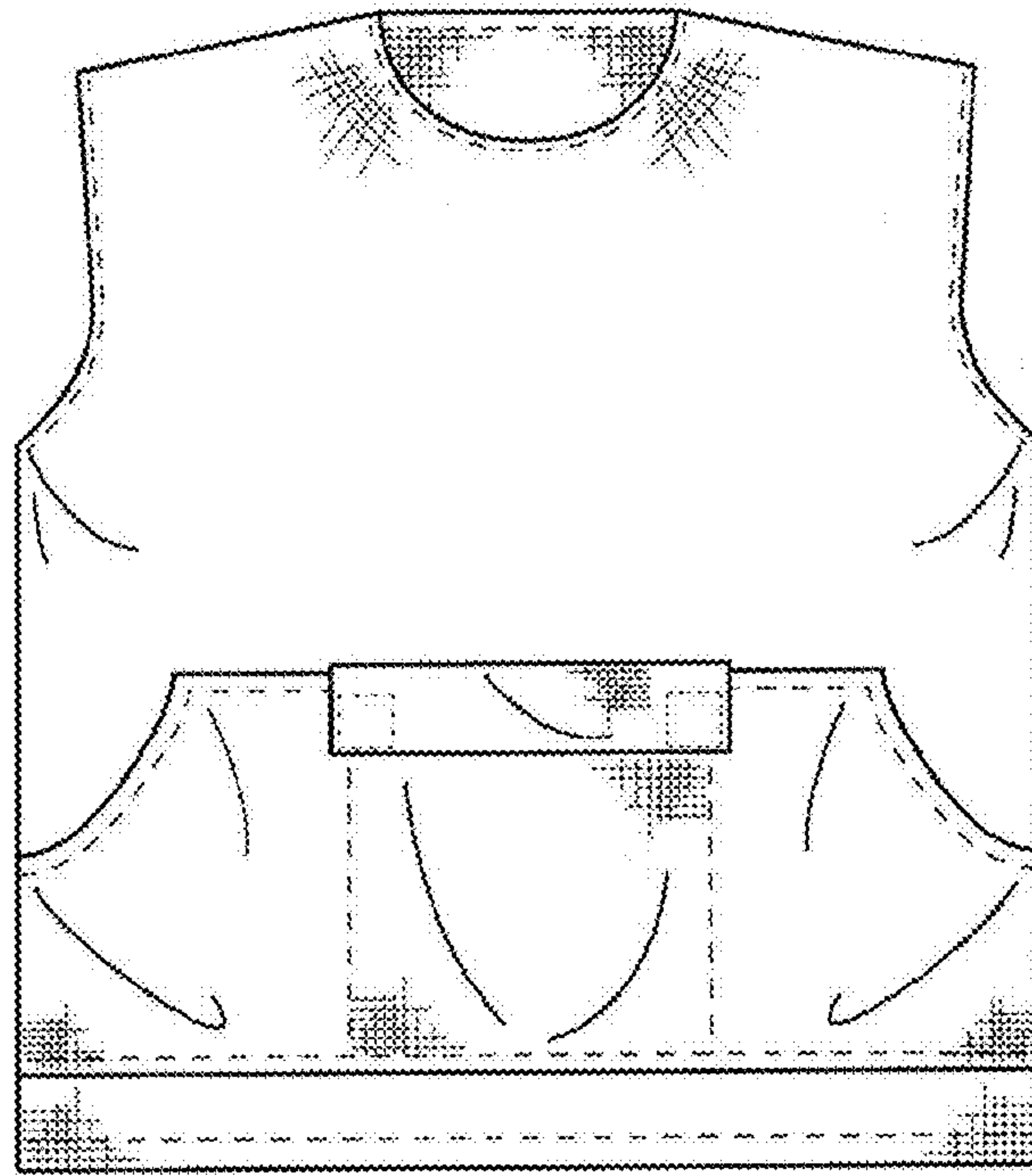

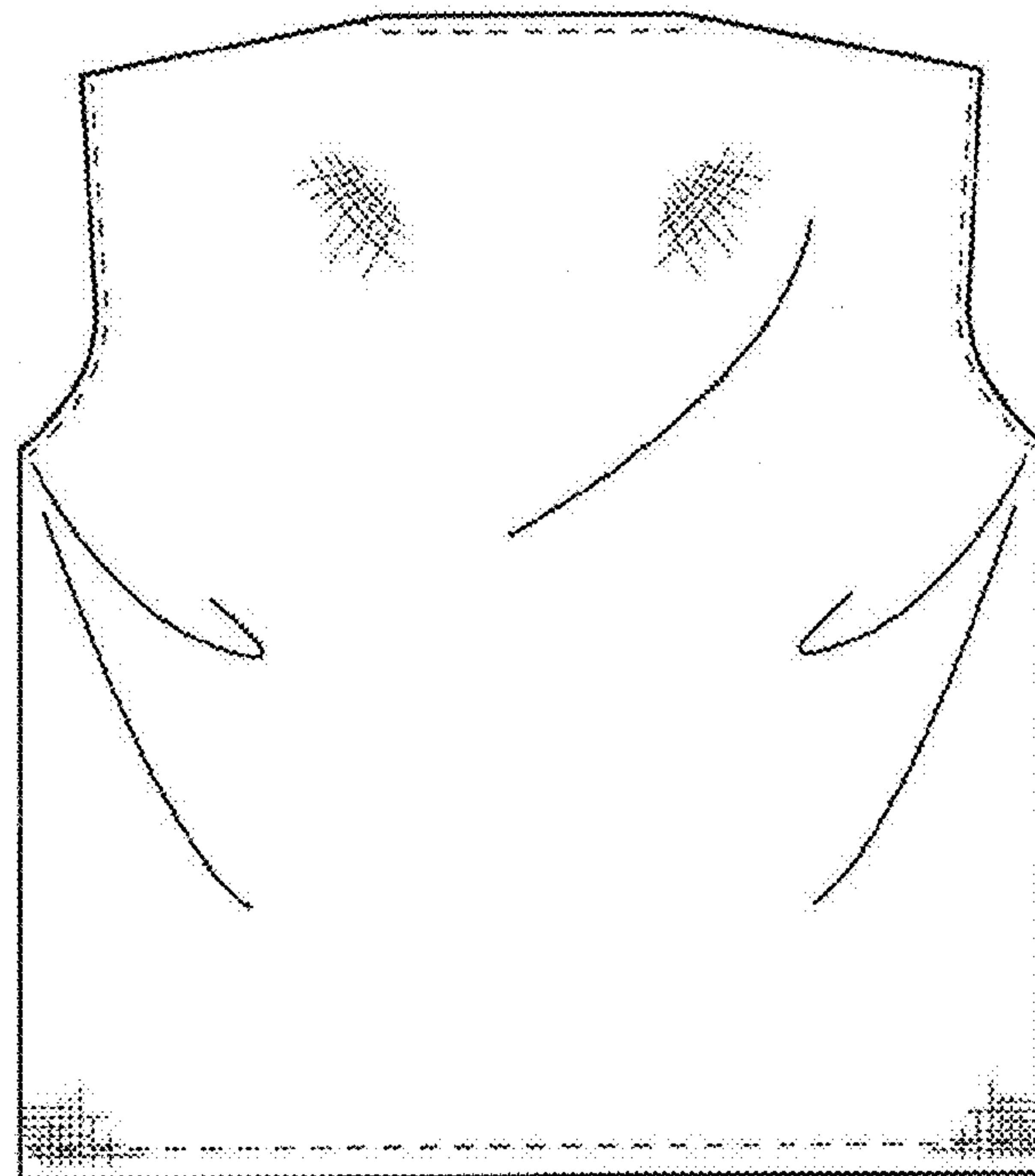

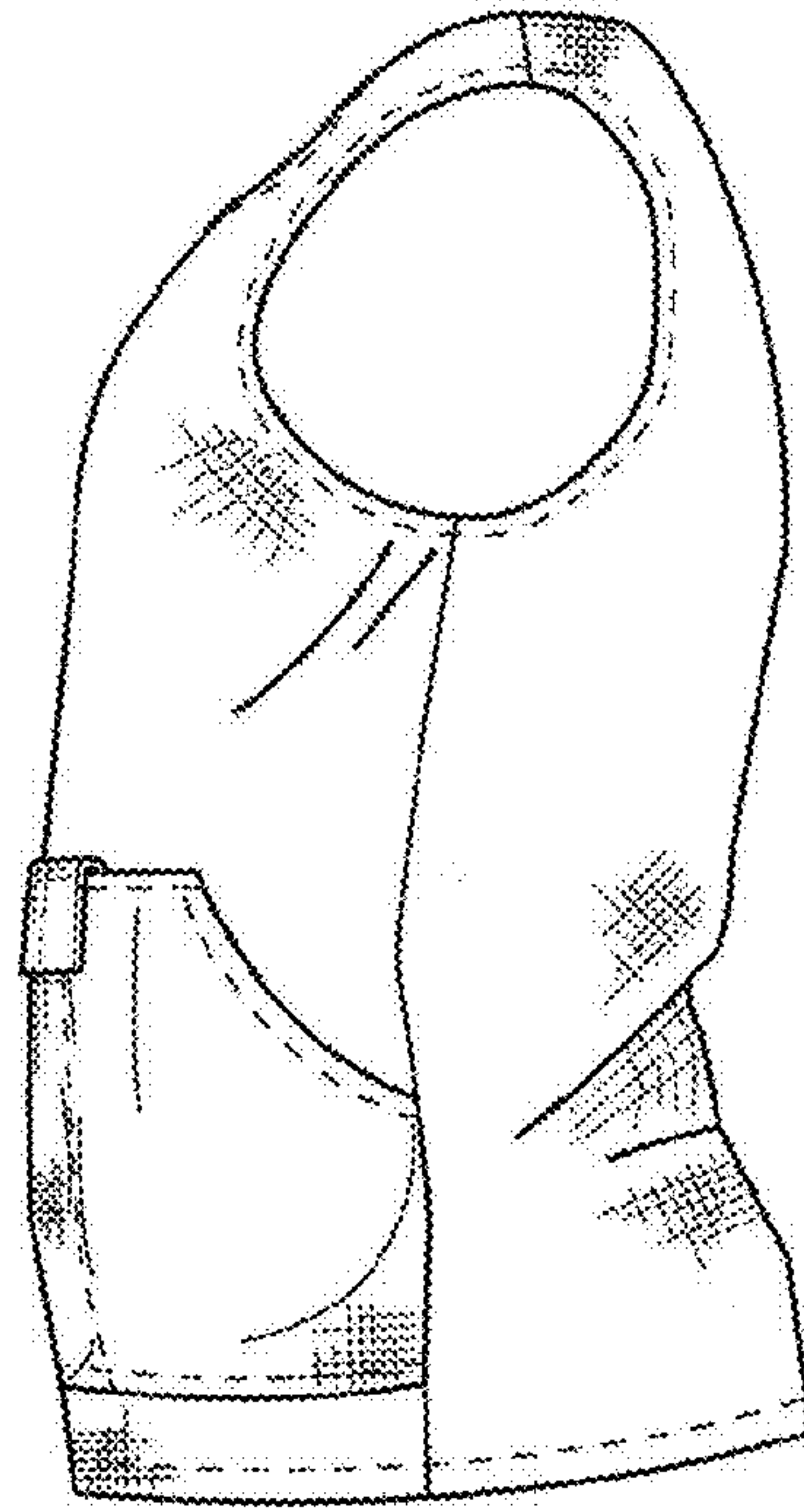

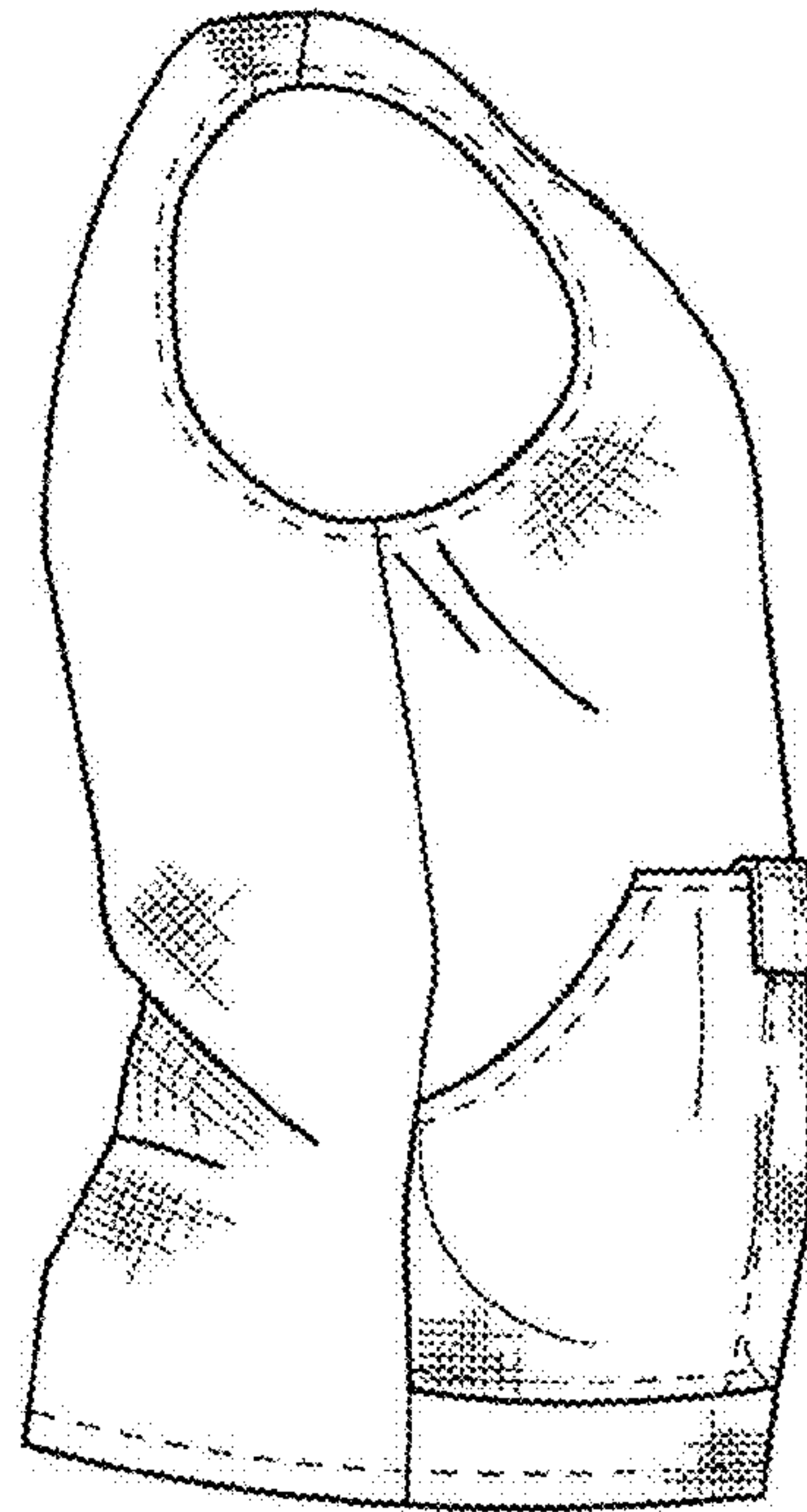

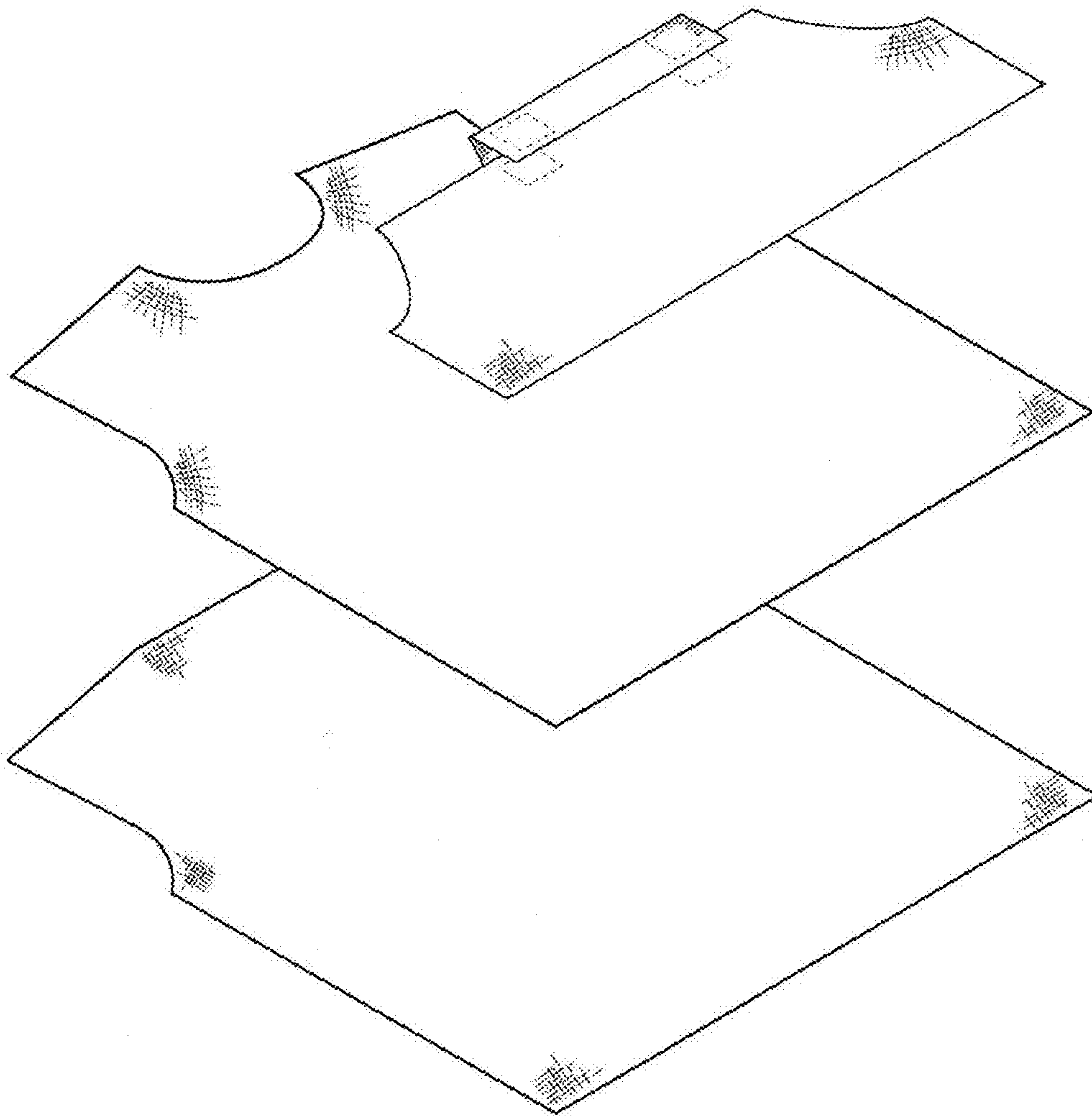
