The ornamental design for a wig carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wig carrier;

FIG. 2 is a front view of the wig carrier;

FIG. 8 is a perspective view of the wig and hair piece carrier in an opened position showing the inner bag;

FIG. 9 is a front view of the wig and hair piece carrier in an opened position showing the inner bag;

FIG. 11 is a left view of the wig and hair piece carrier;

FIG. 21 is a bottom view of the wig and hair piece carrier in an opened position;

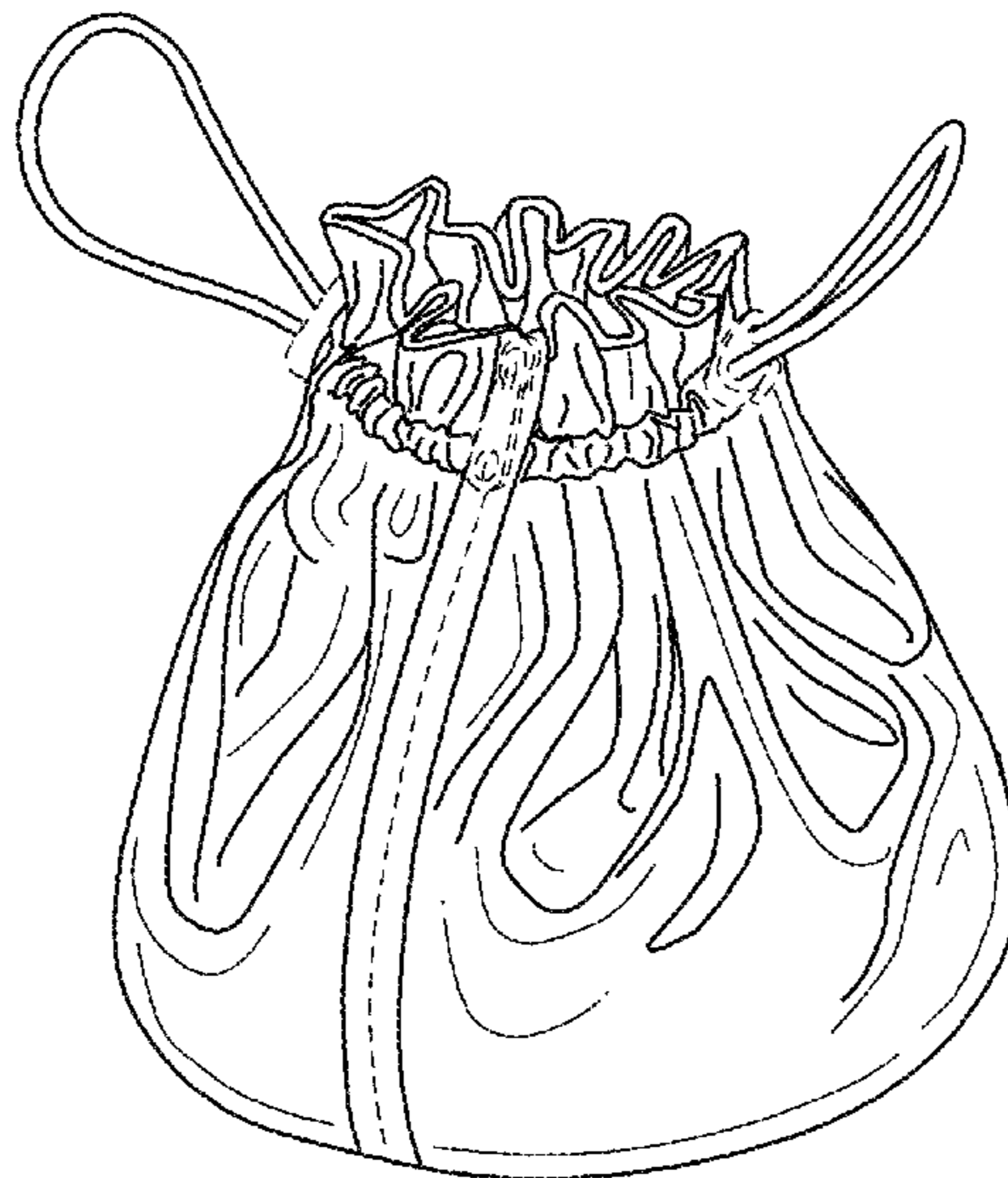
FIG. 22 is a sectional view of the wig and hair piece carrier along line 22-22 of FIG. 15;

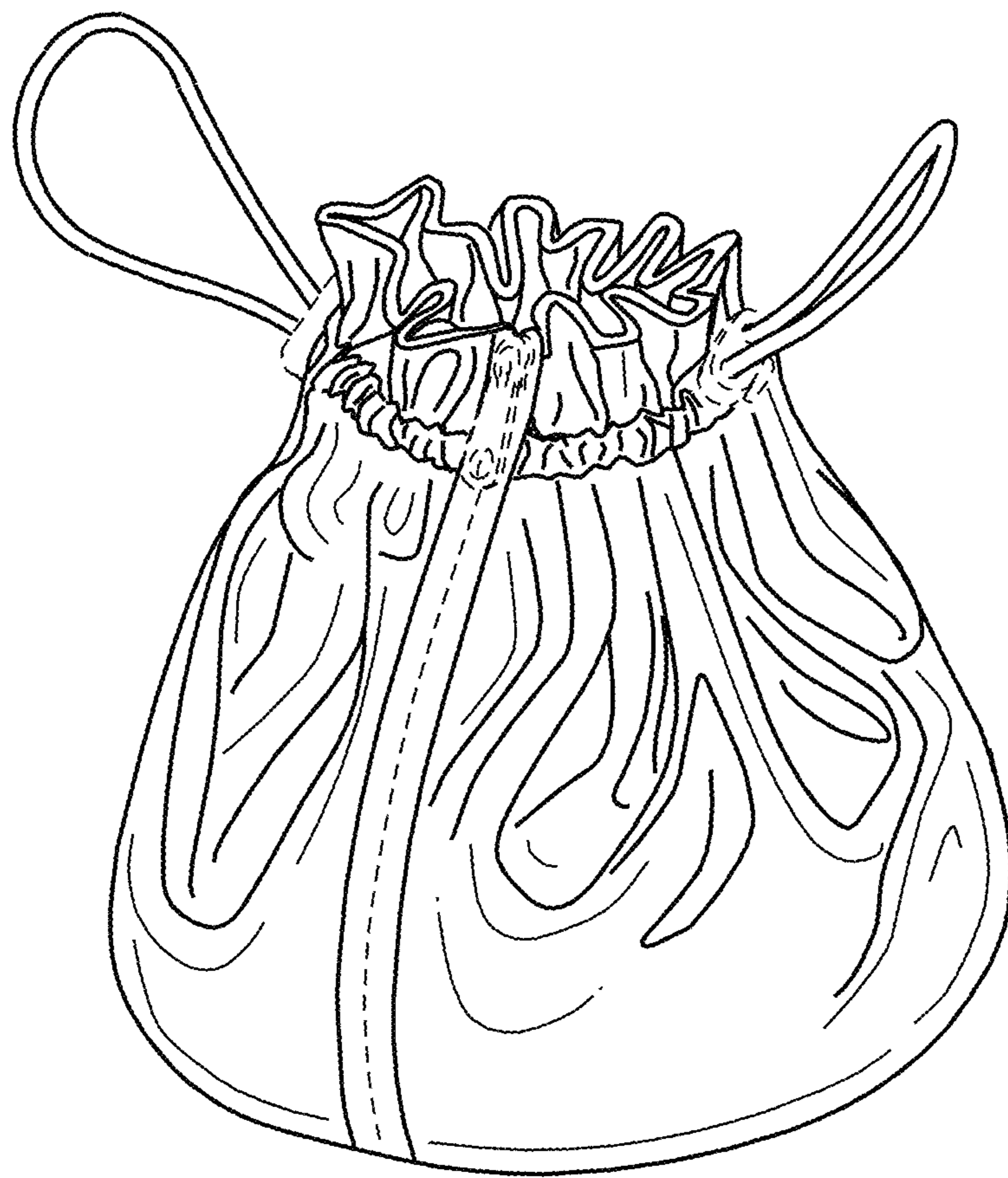

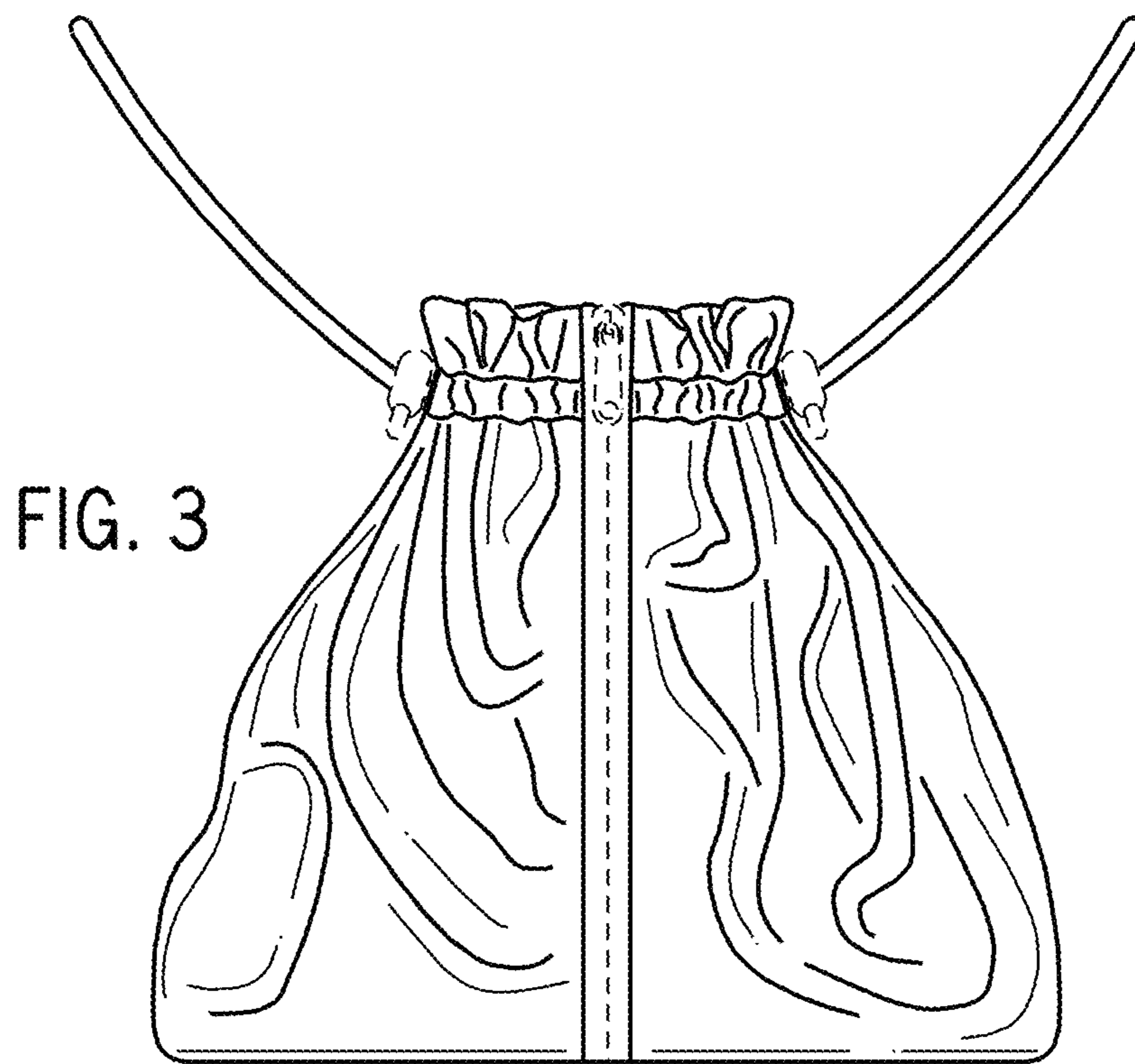
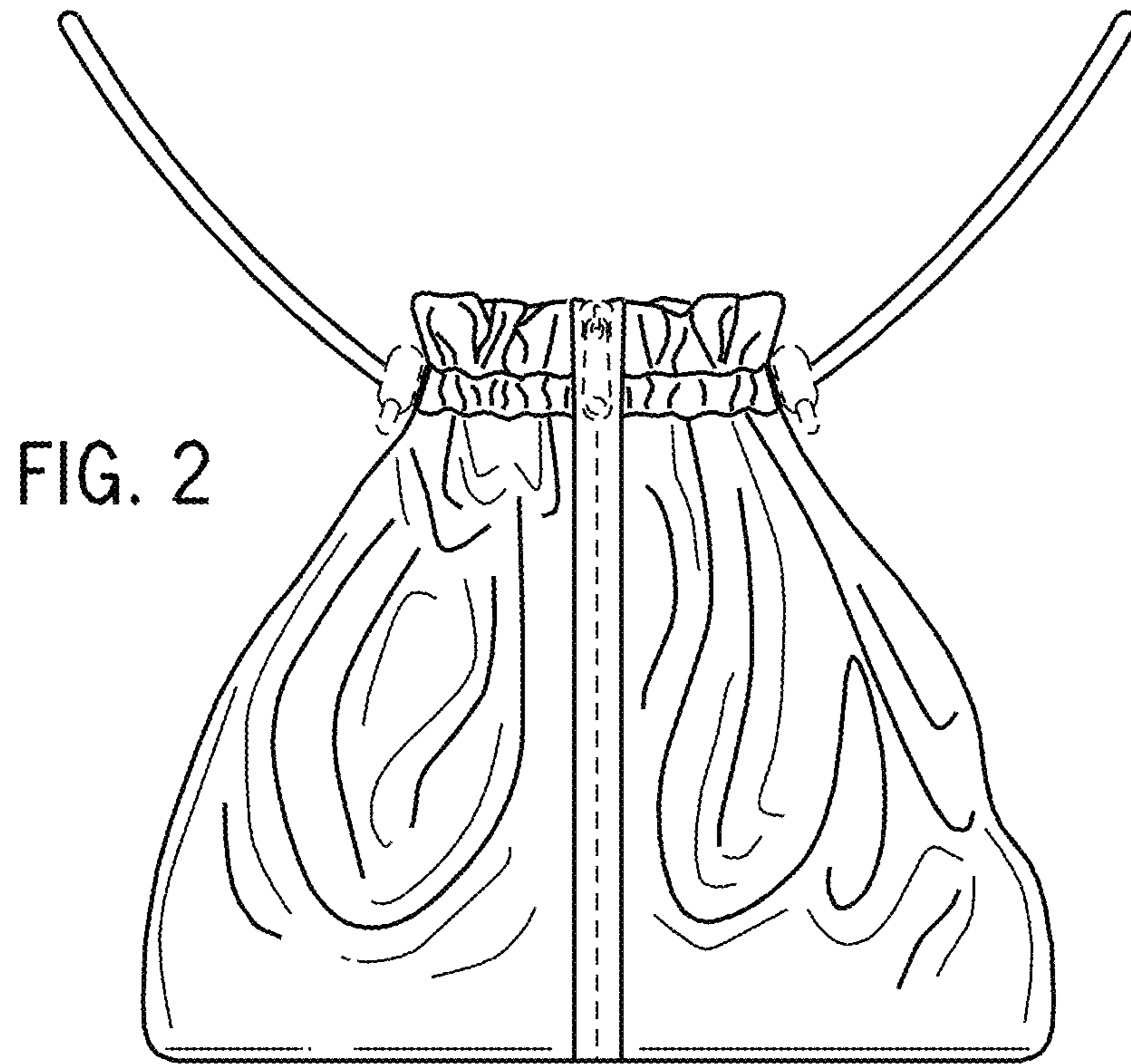

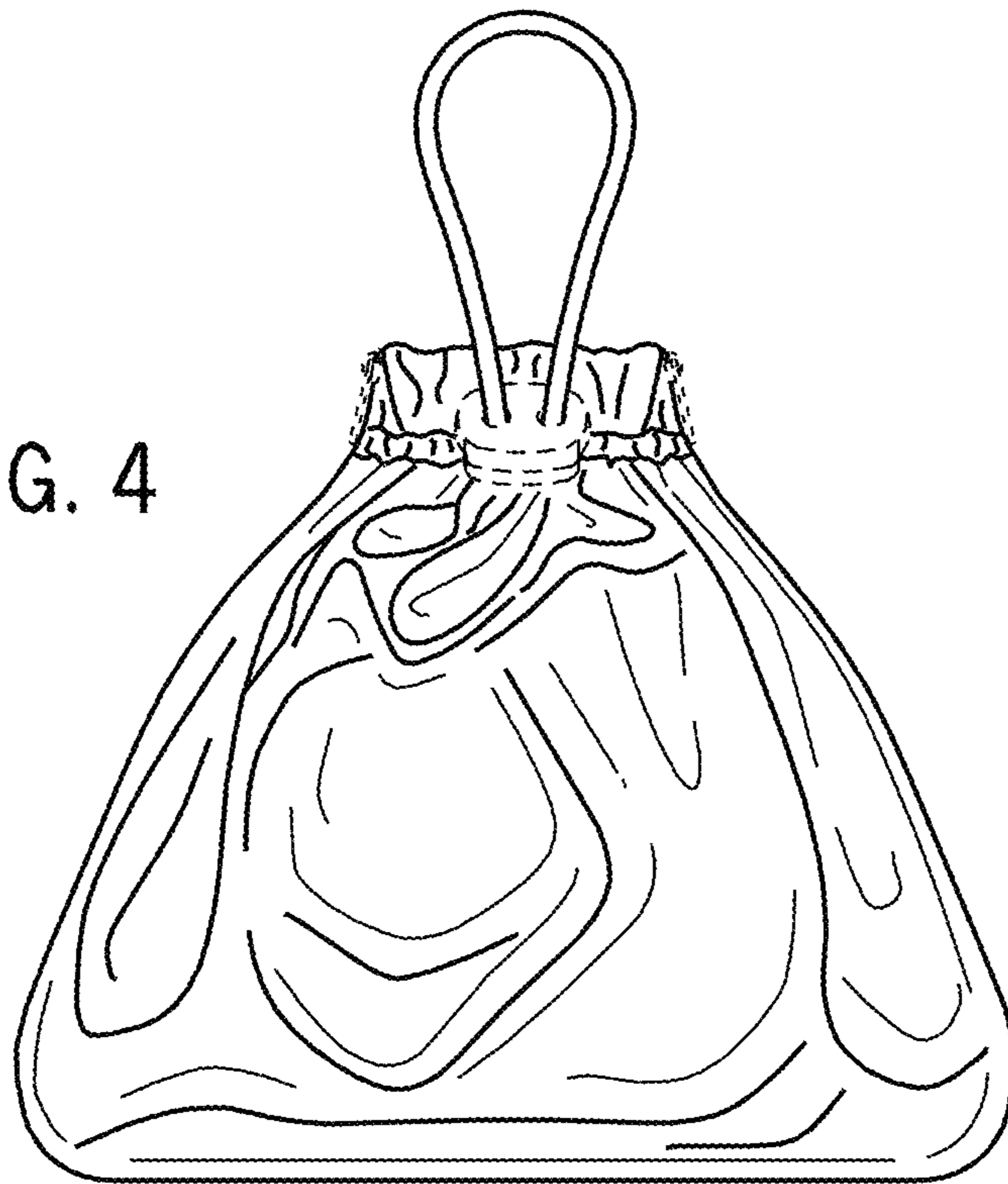

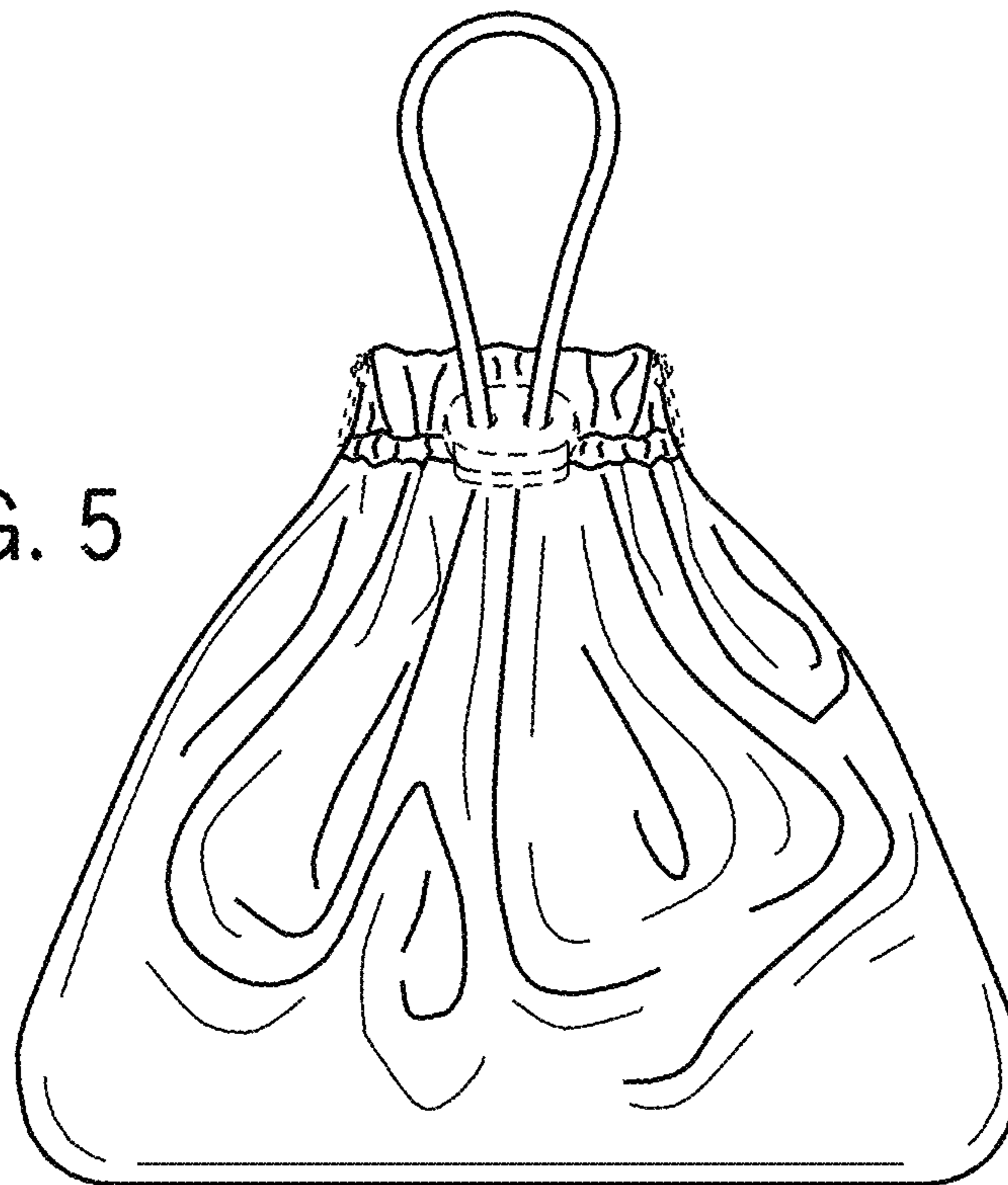

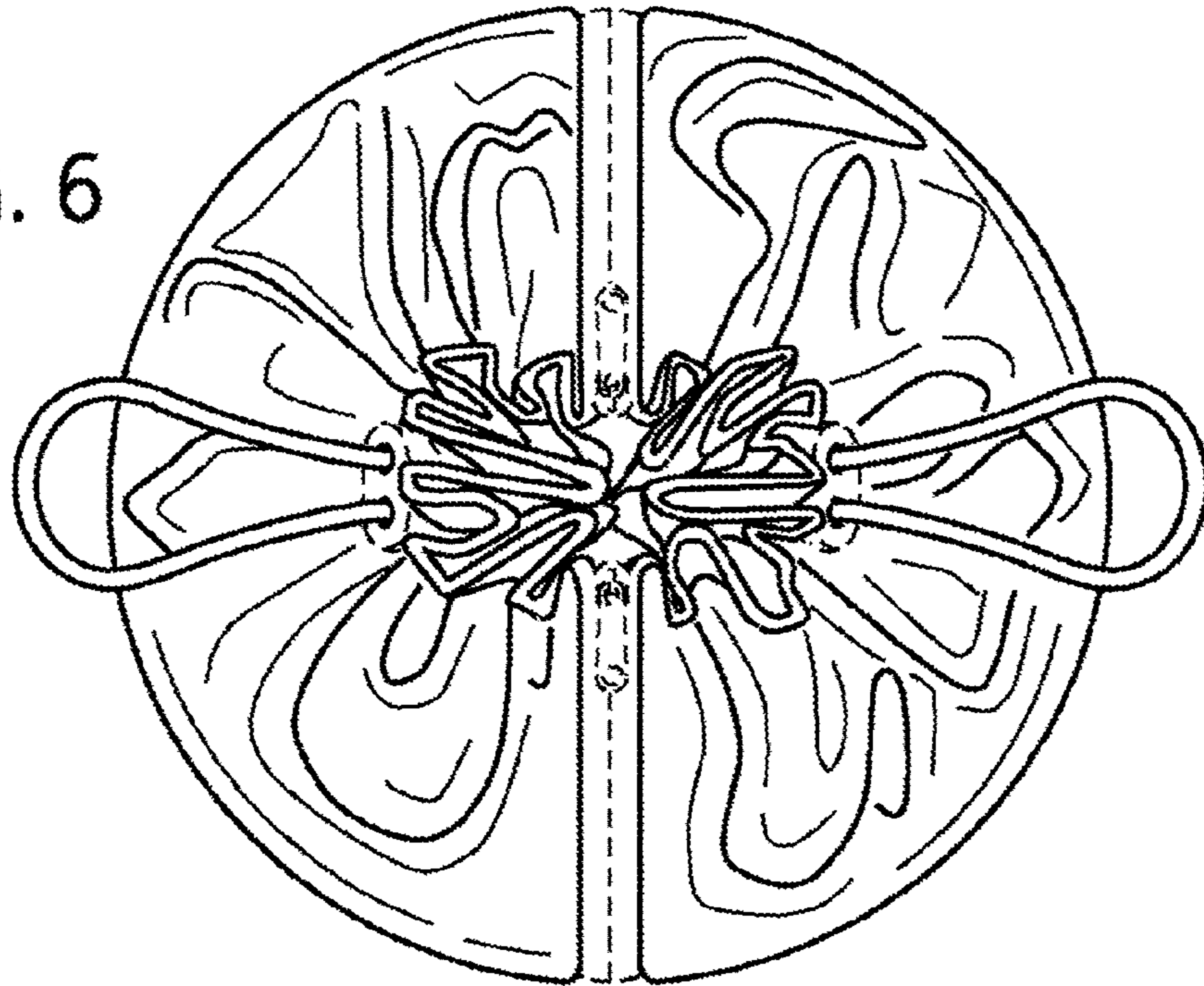
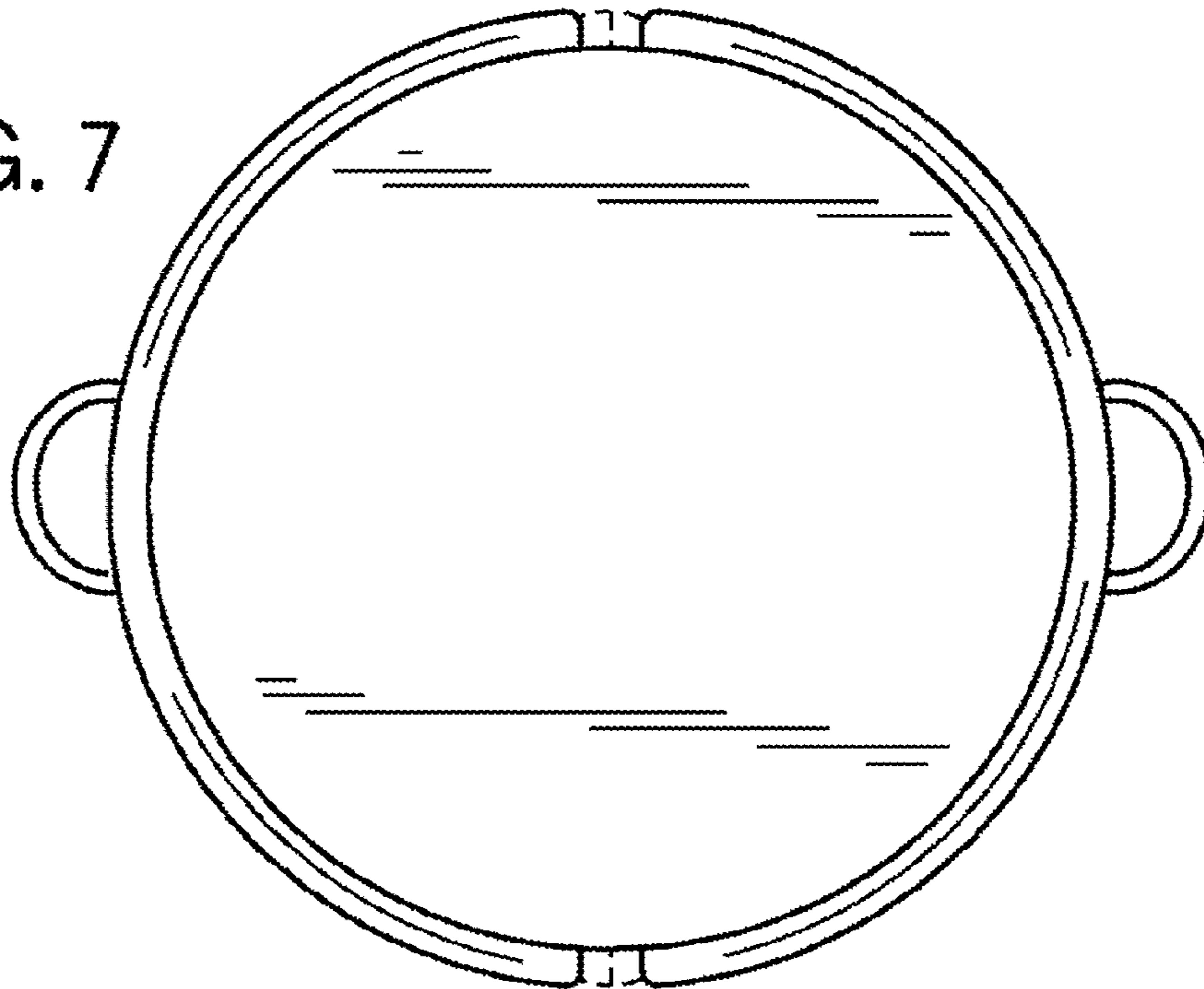

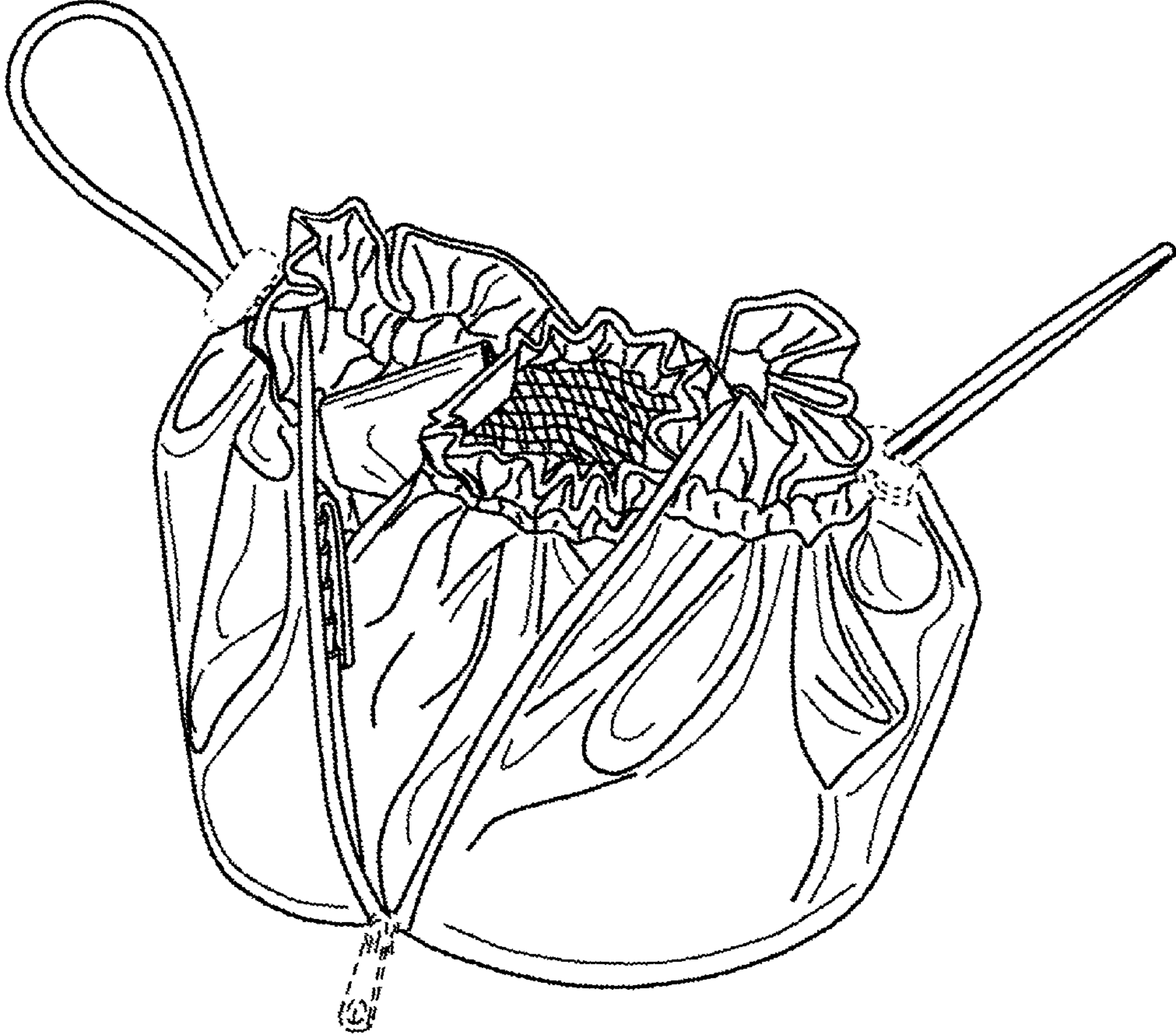

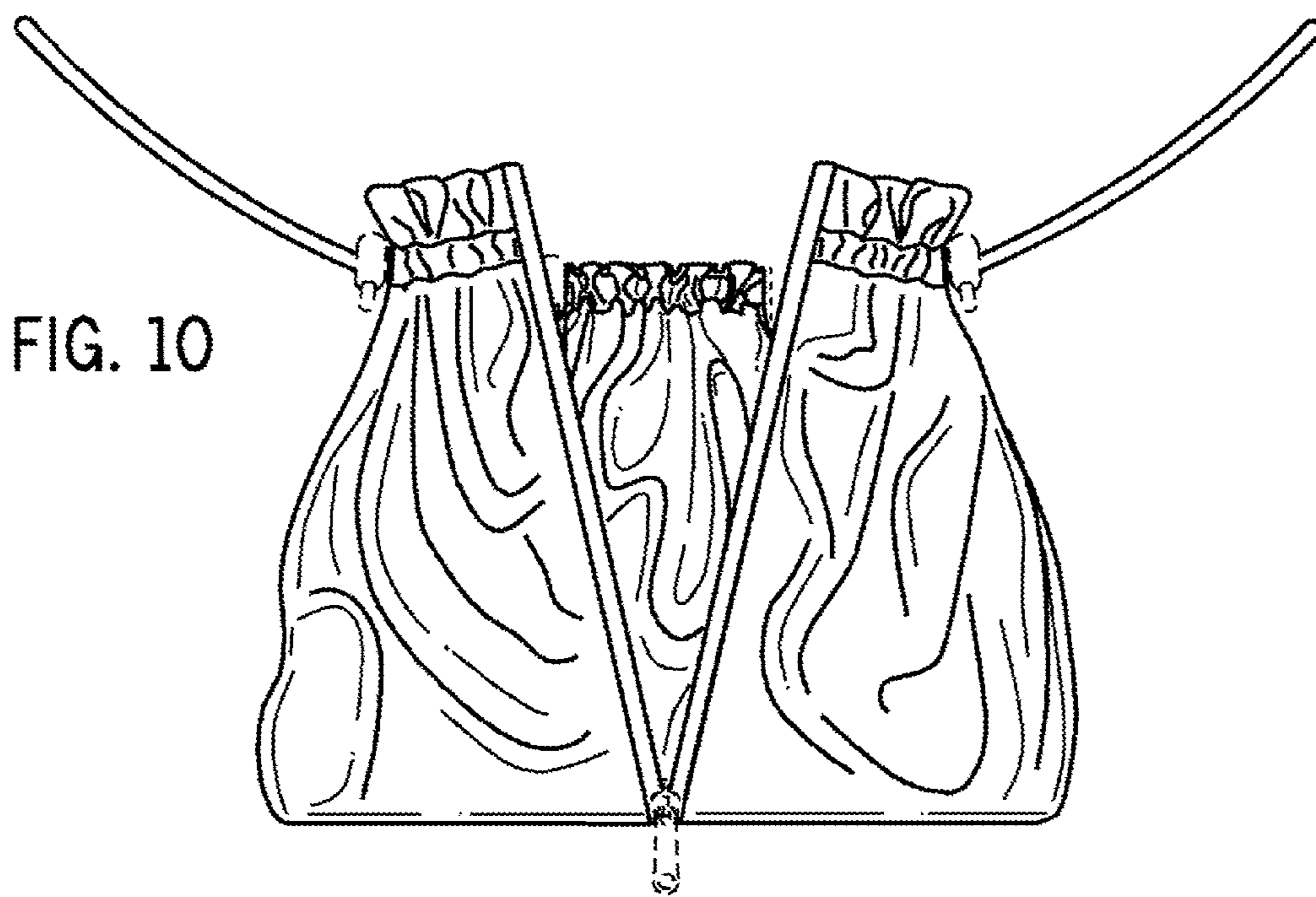
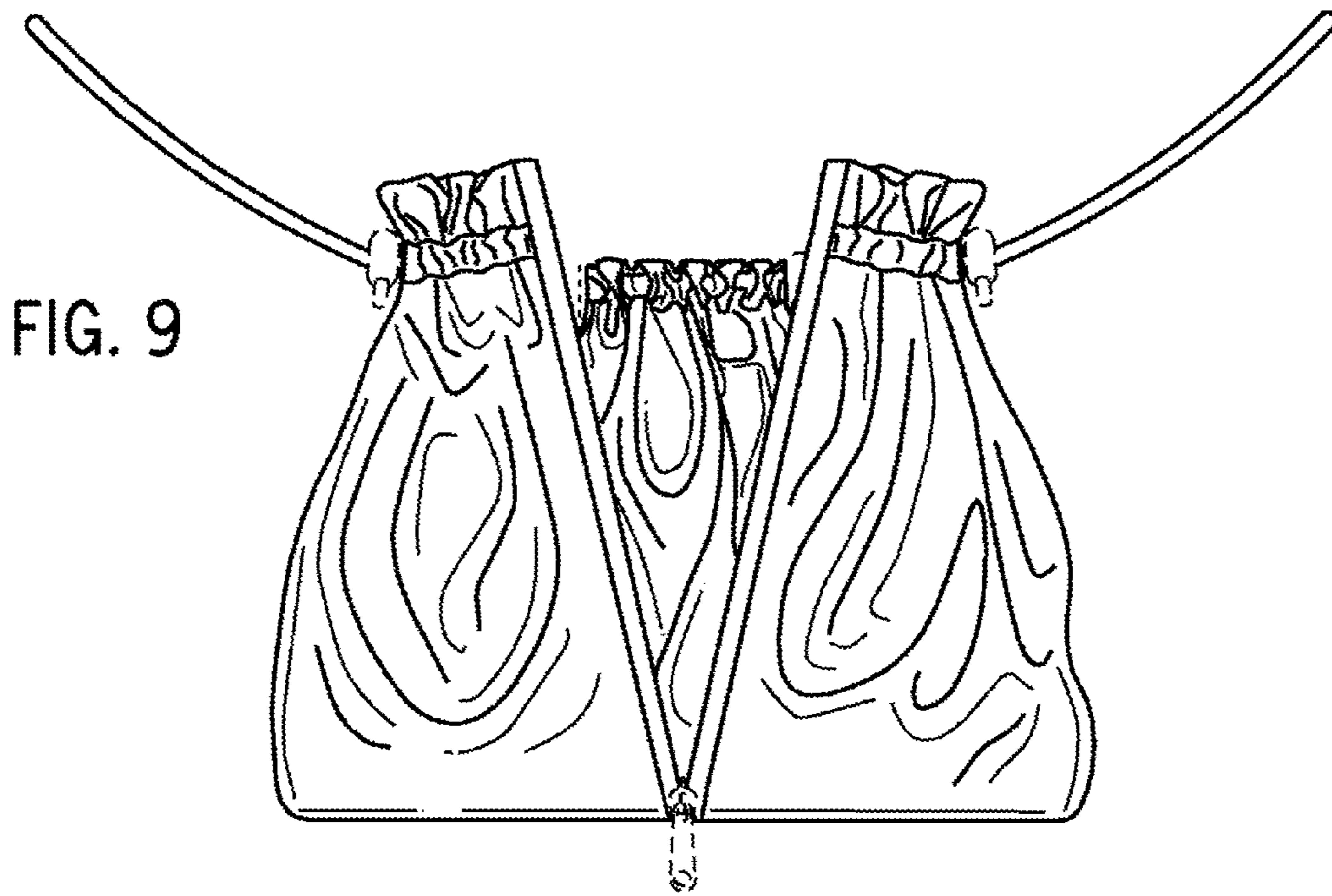

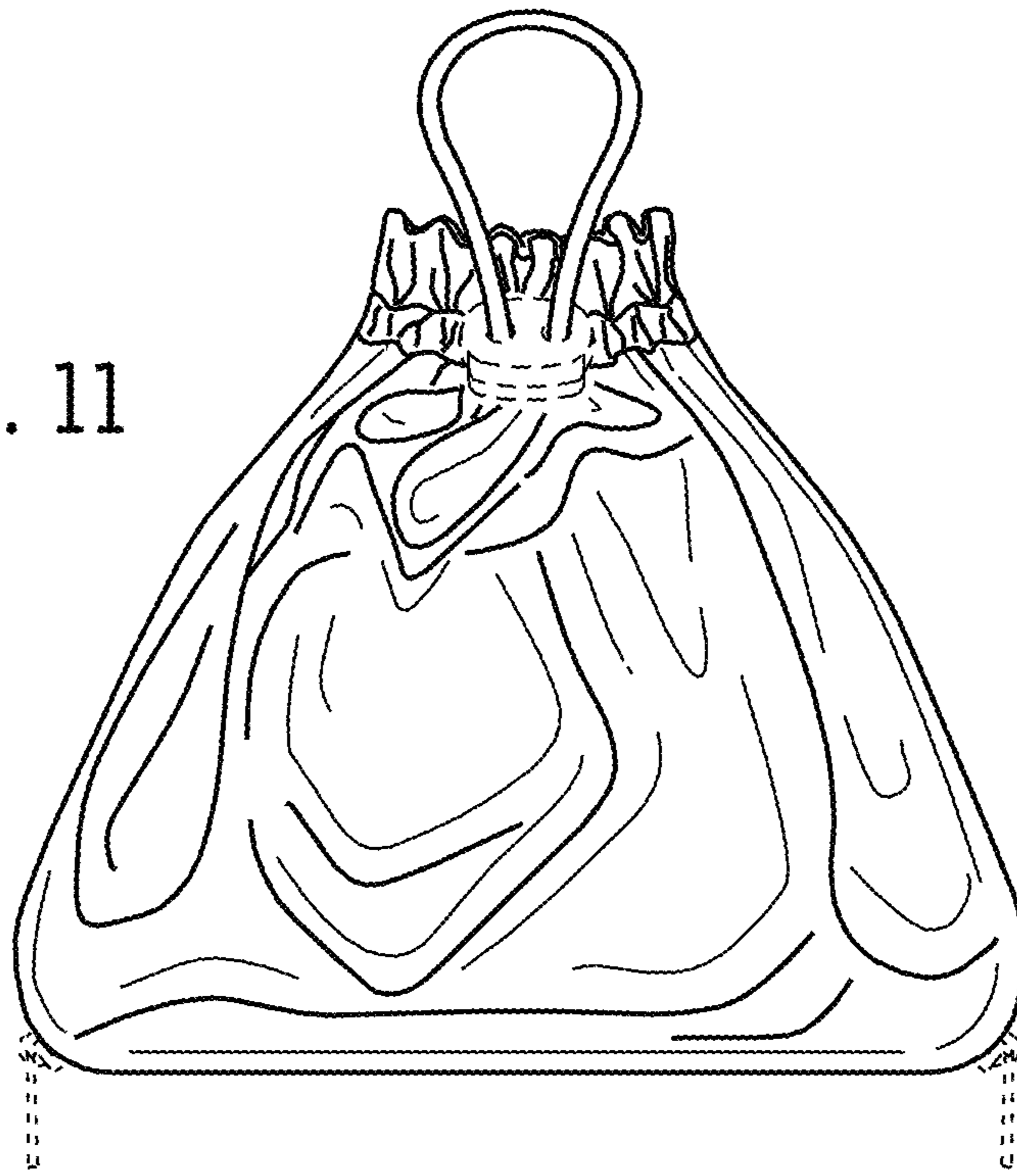
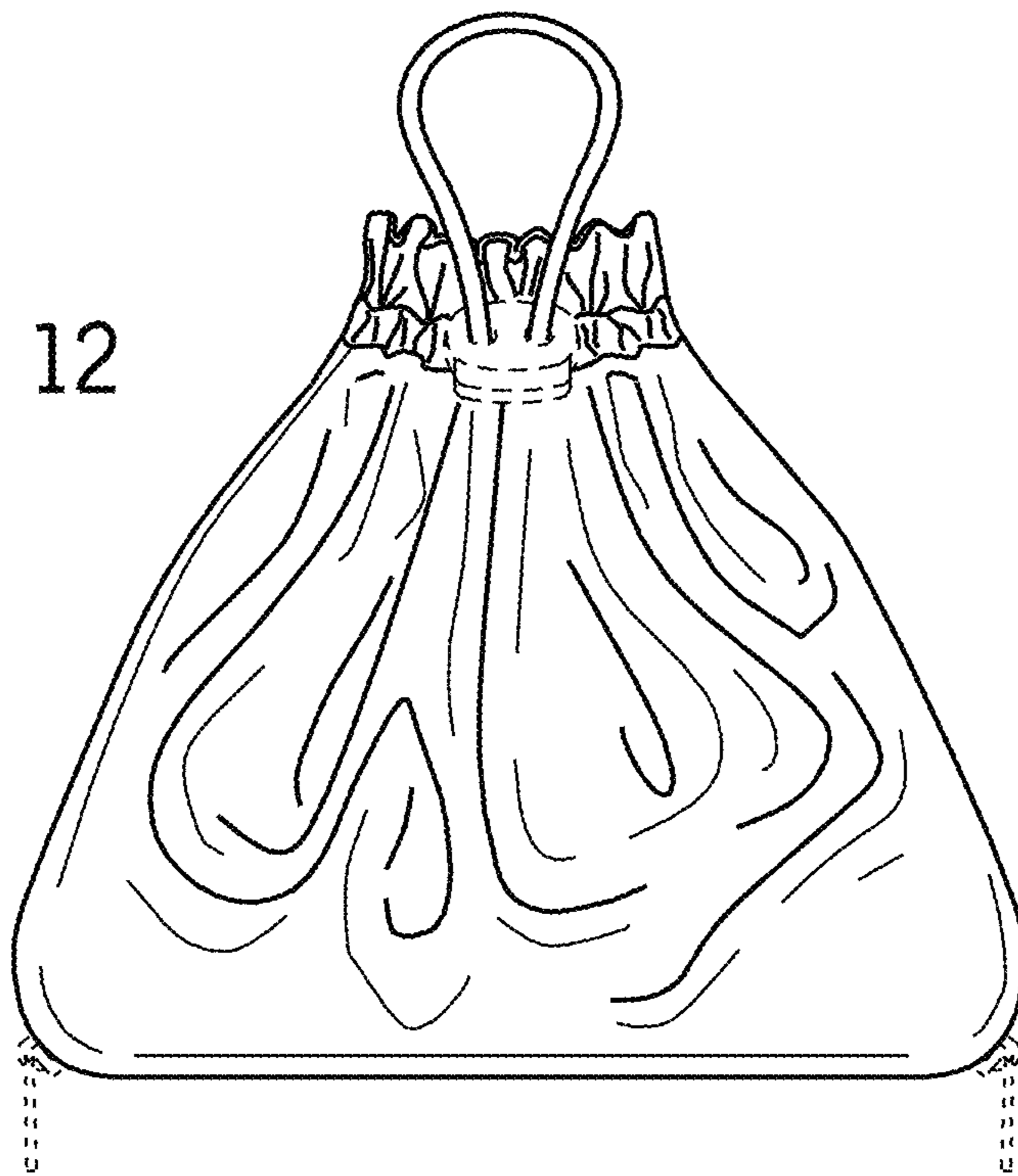
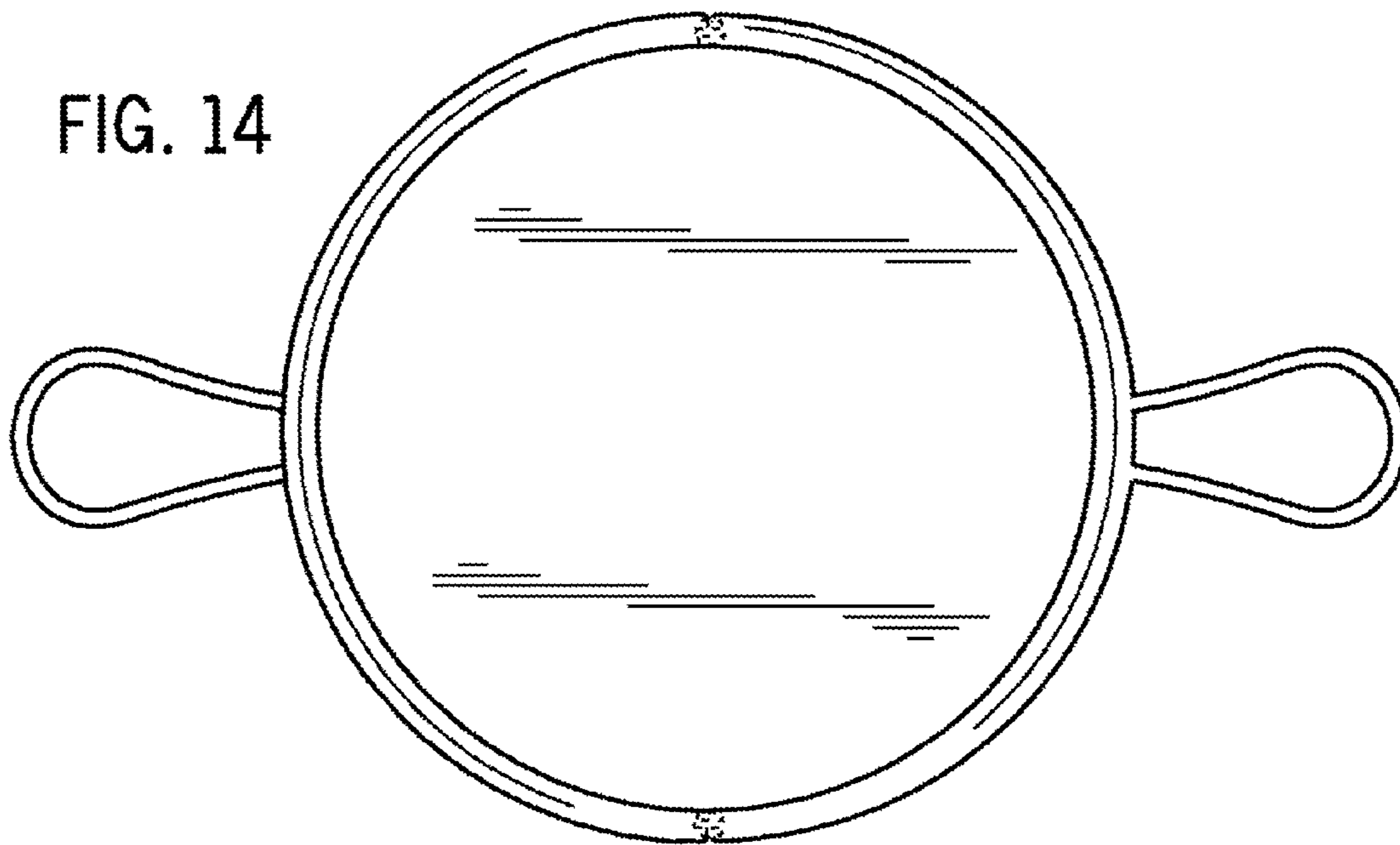
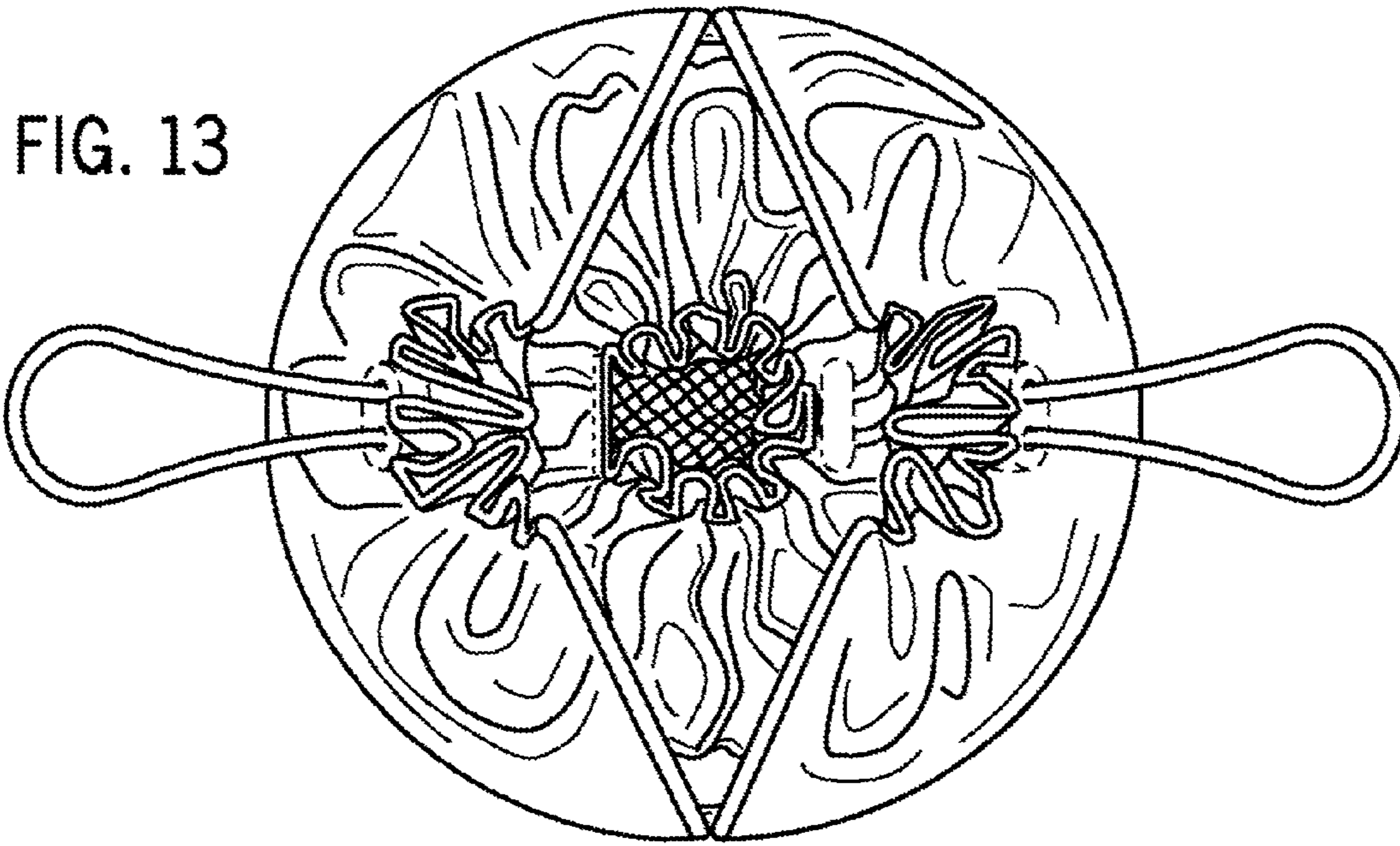

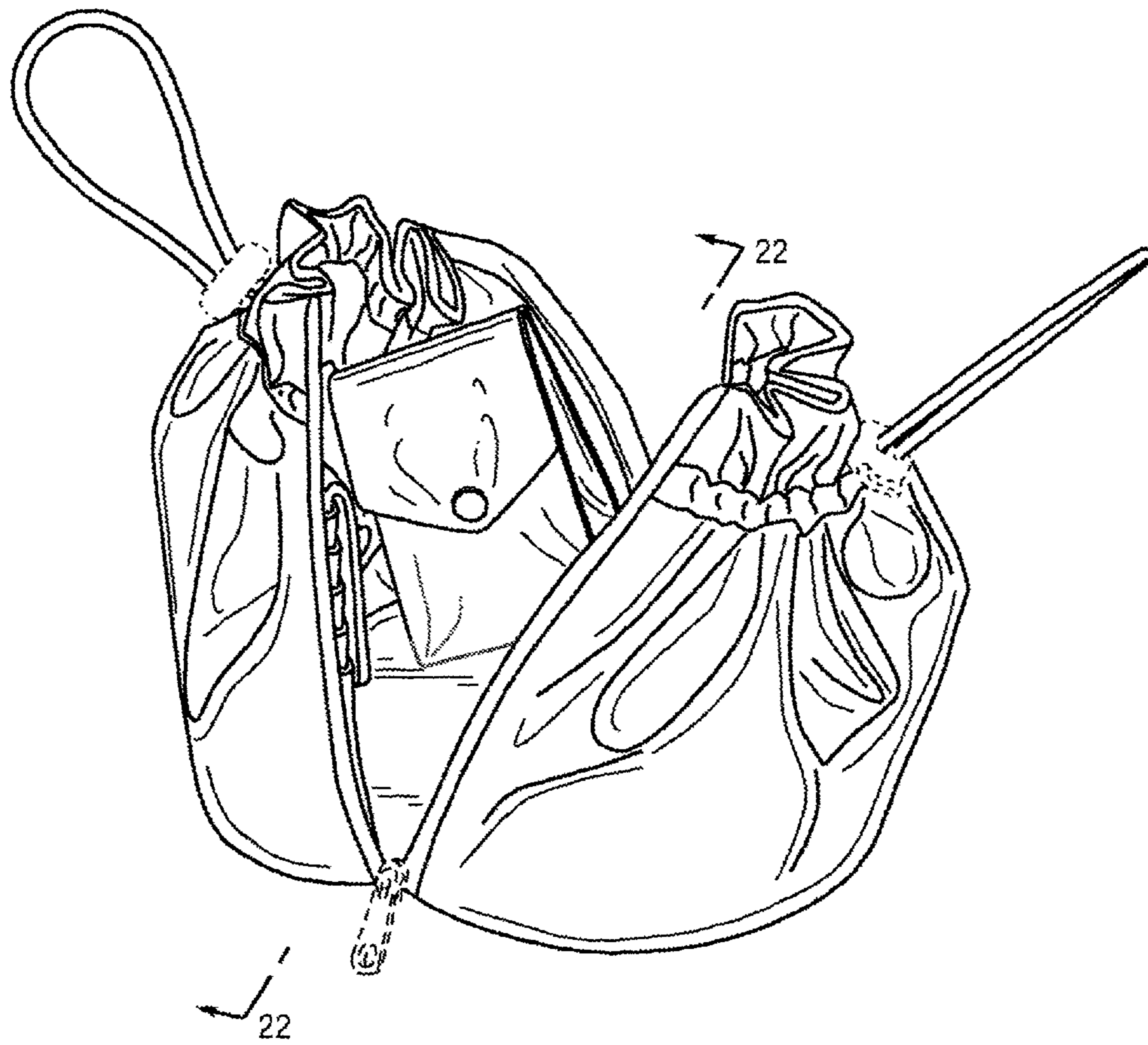

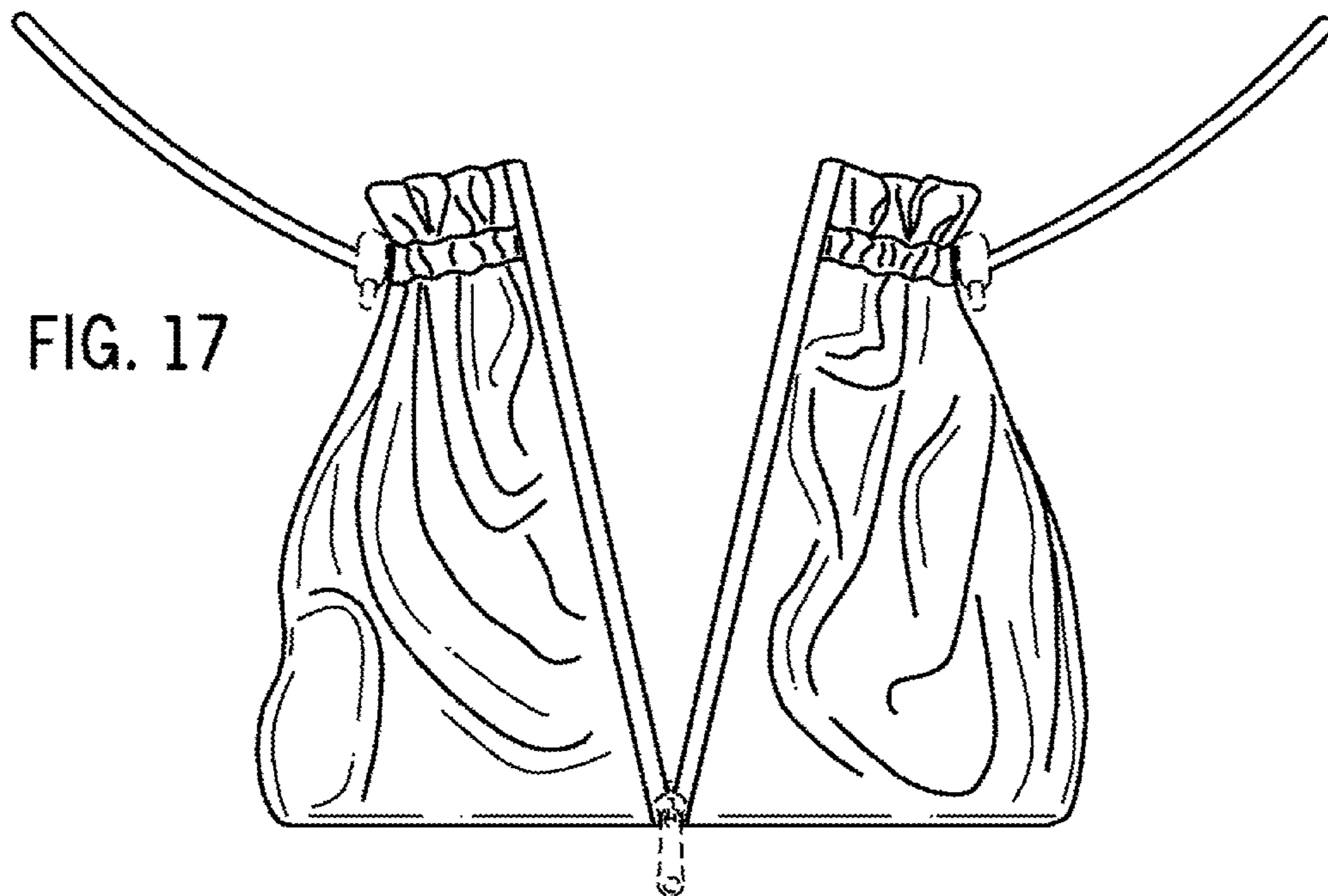
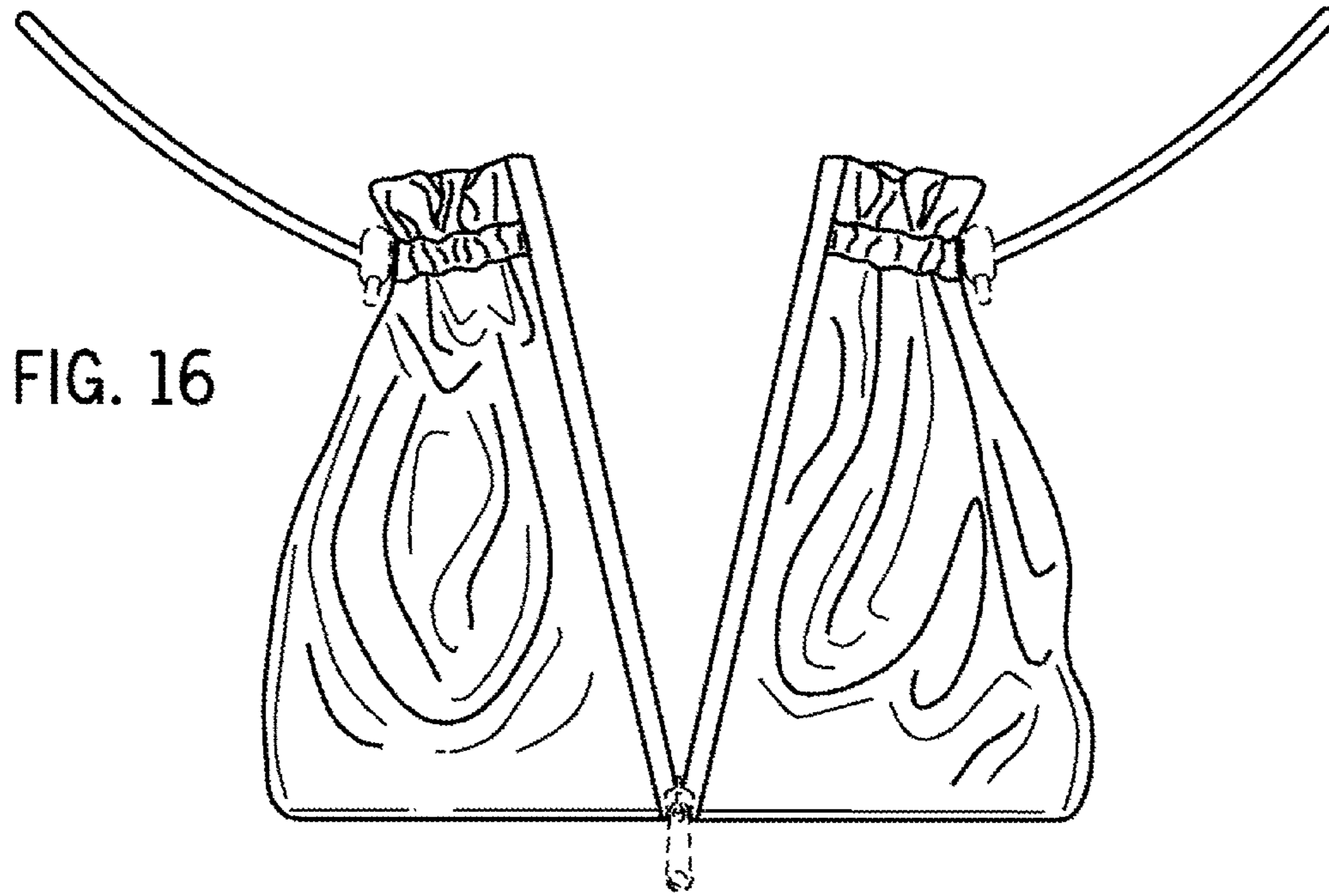

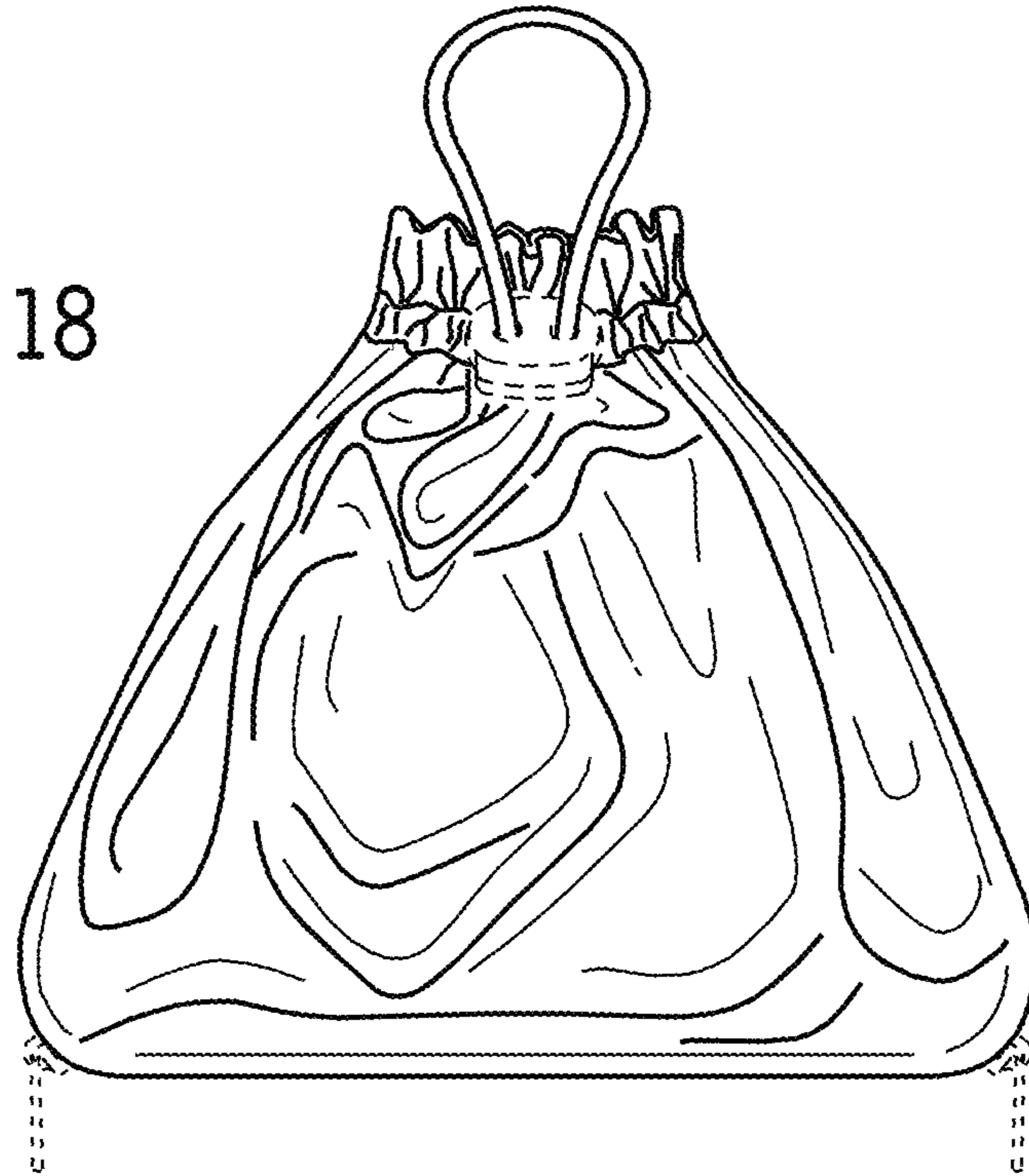

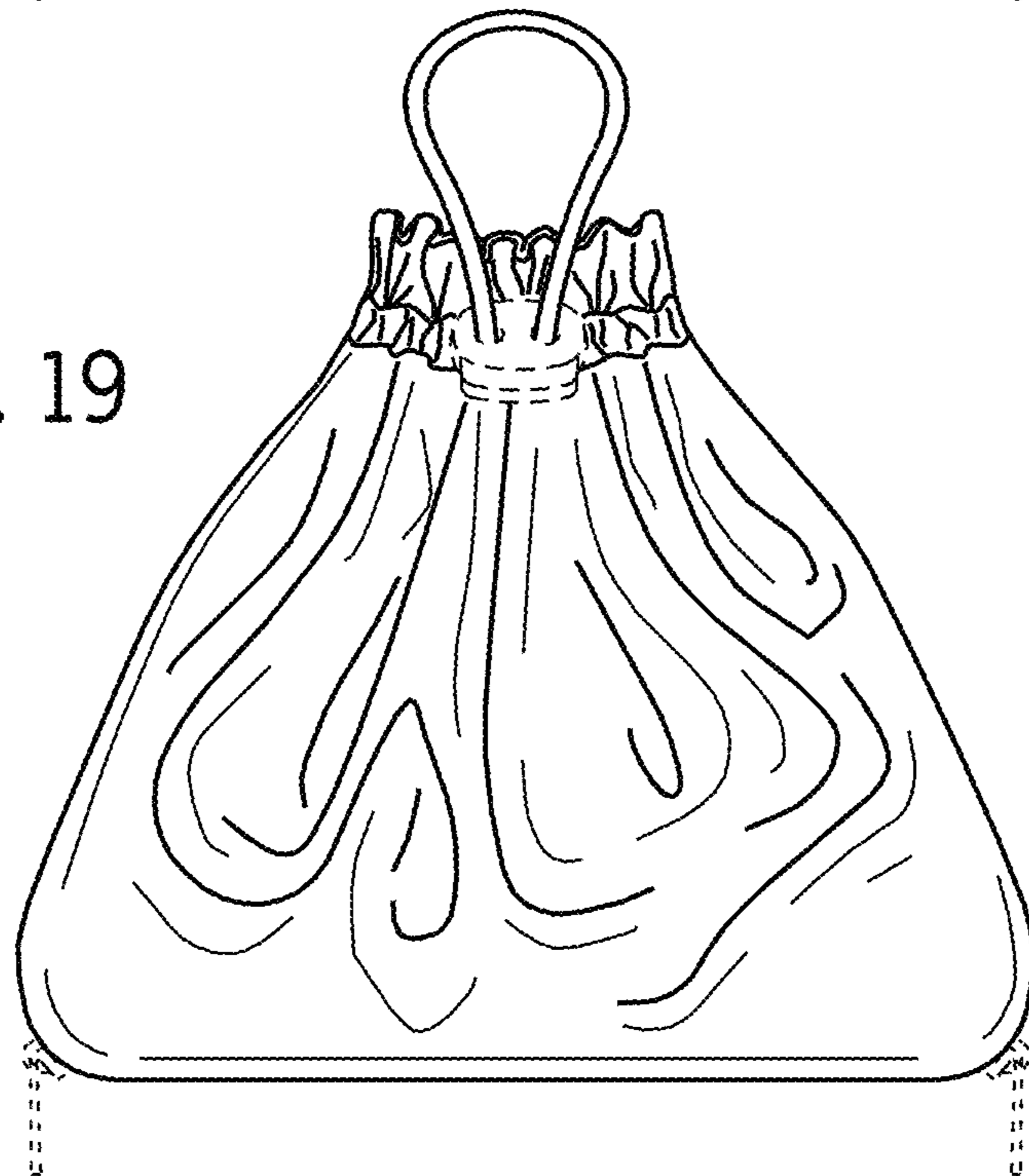

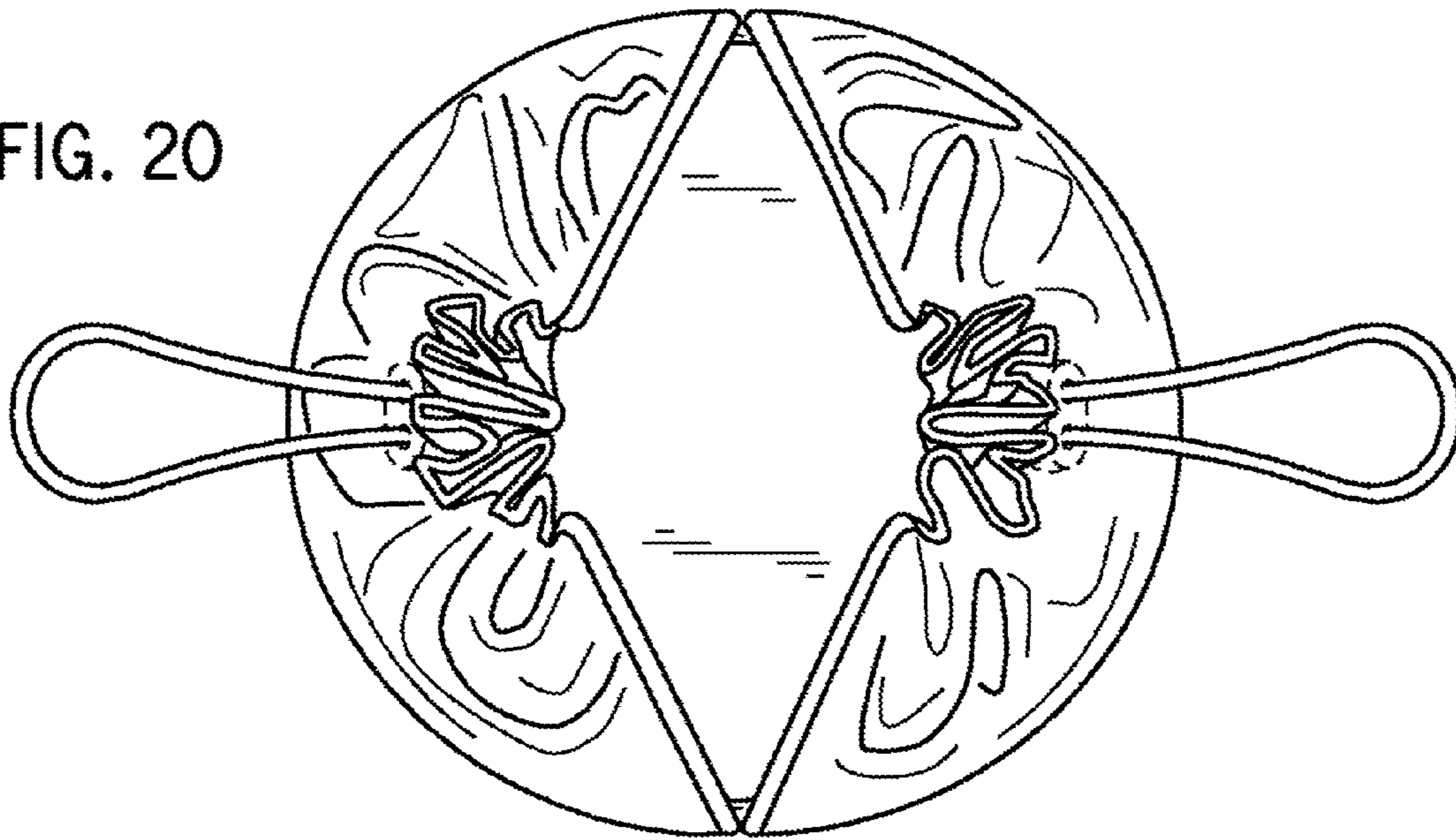

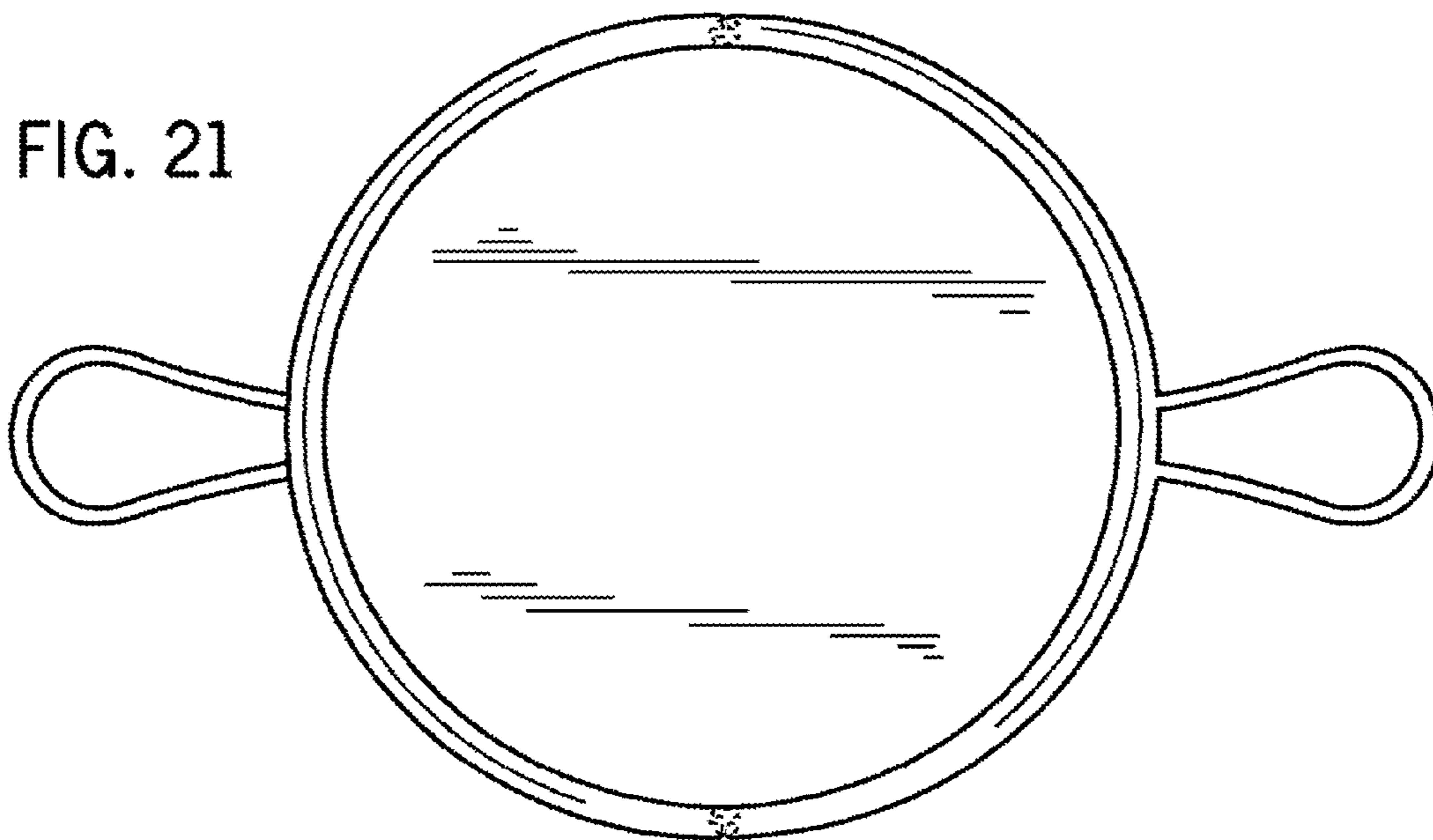

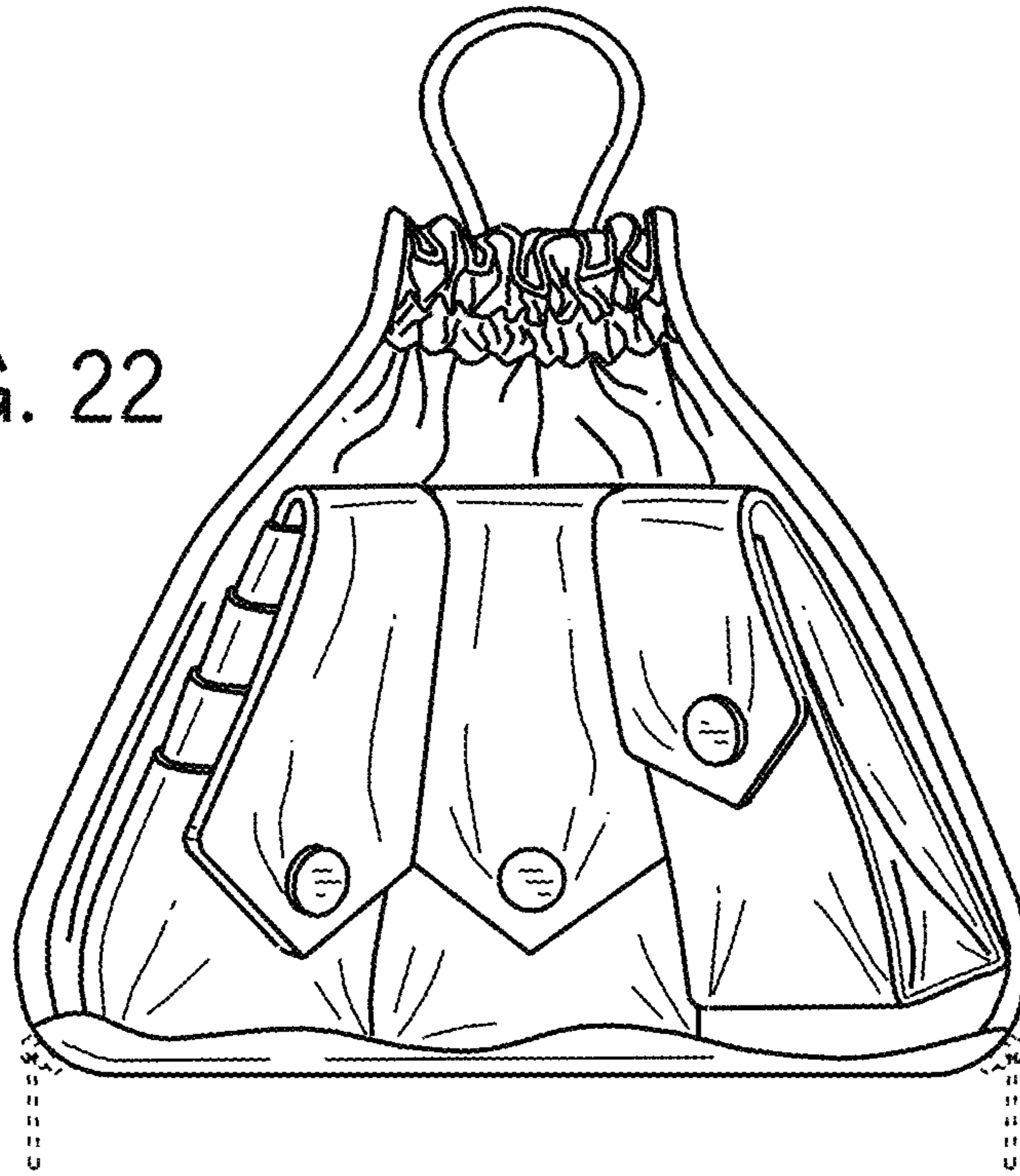
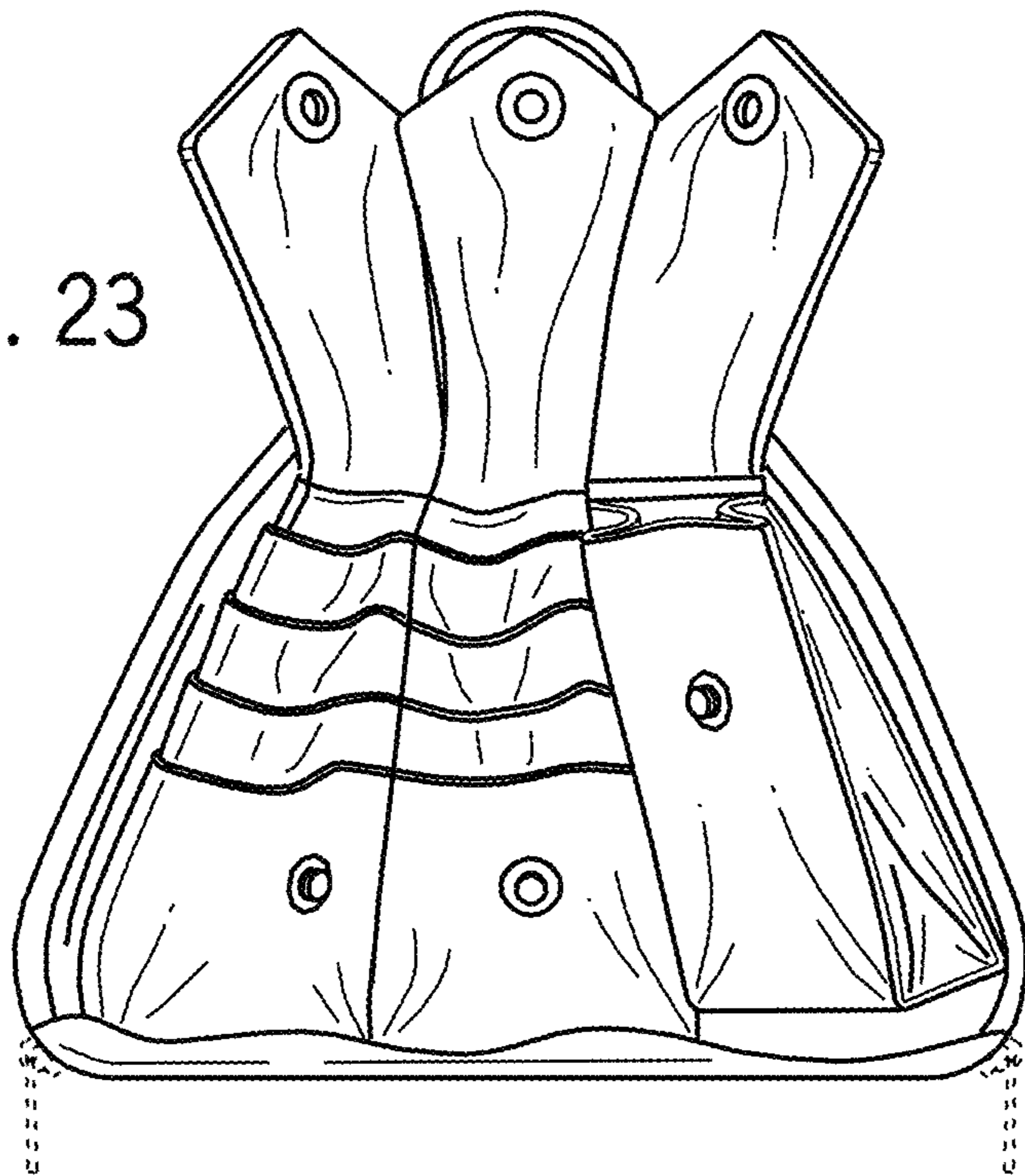

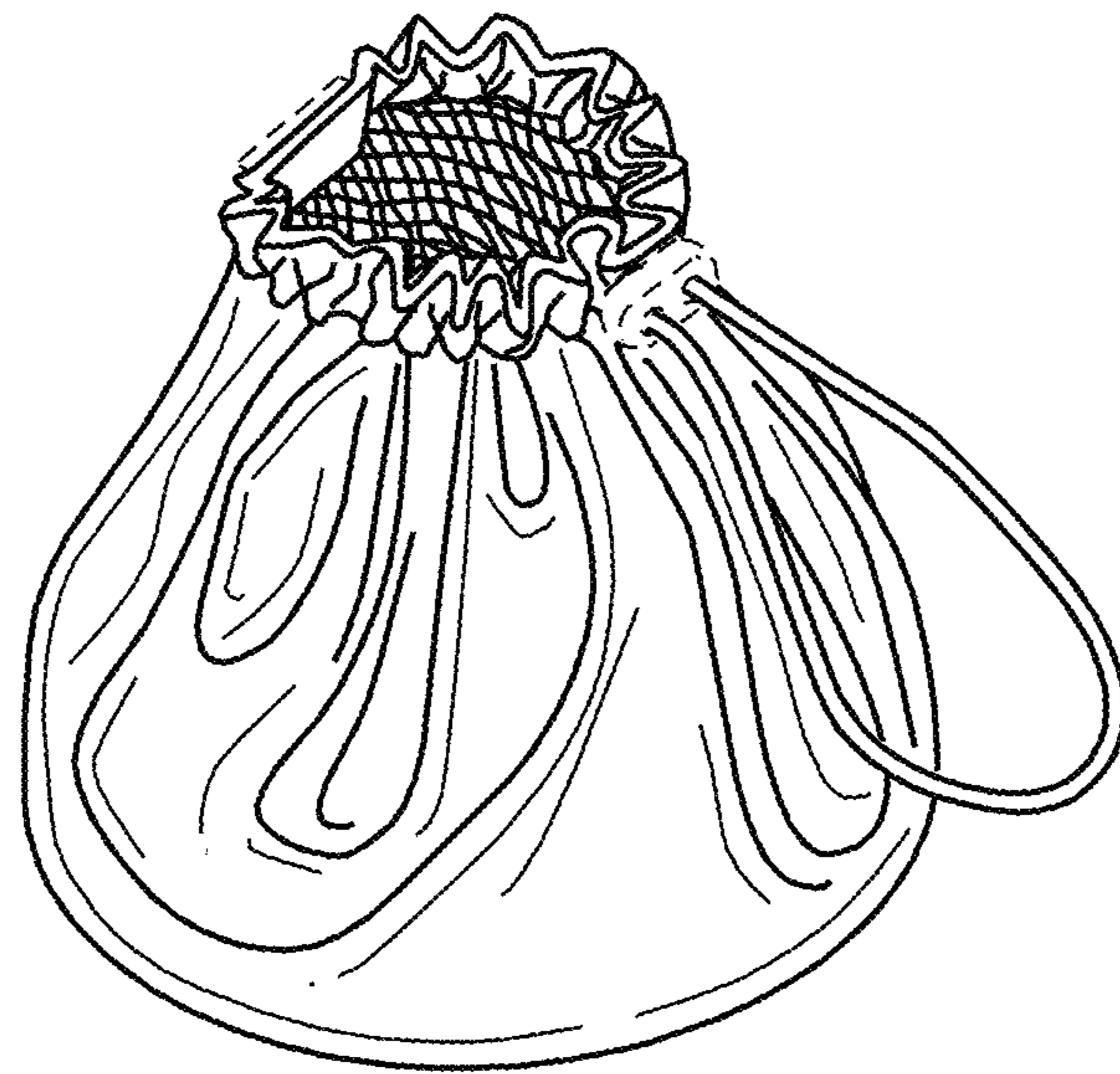
