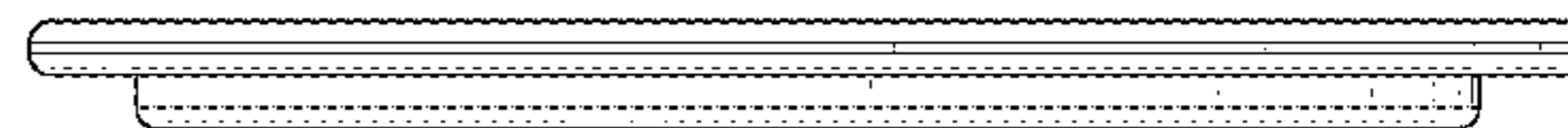
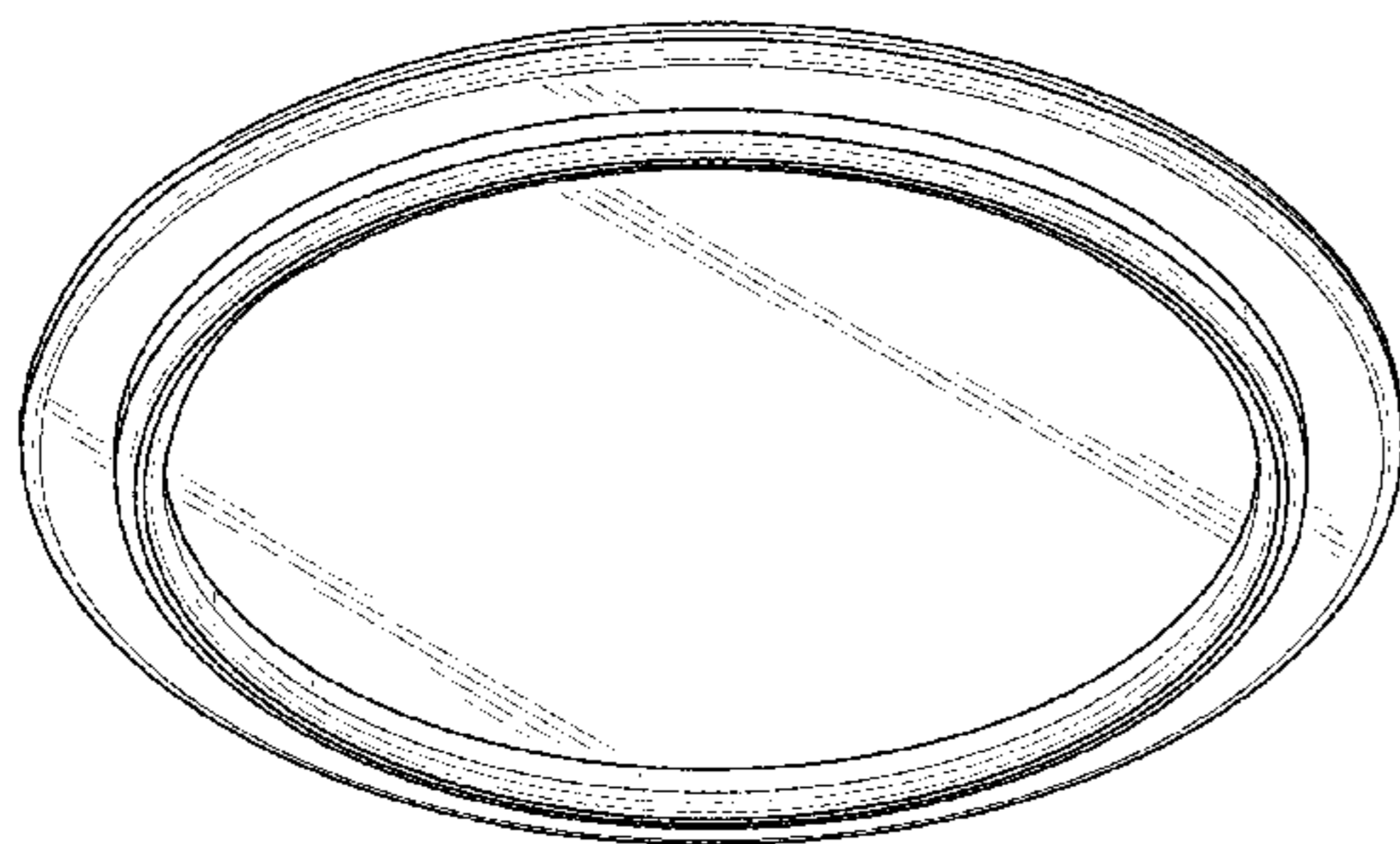
(57) **CLAIM**

The ornamental design for a fitted plate lid, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a fitted plate lid, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a side elevation view thereof; and,
FIG. 4 is a bottom plan view thereof.
The broken lines illustrate portions of the fitted plate lid that form no part of the claimed design.

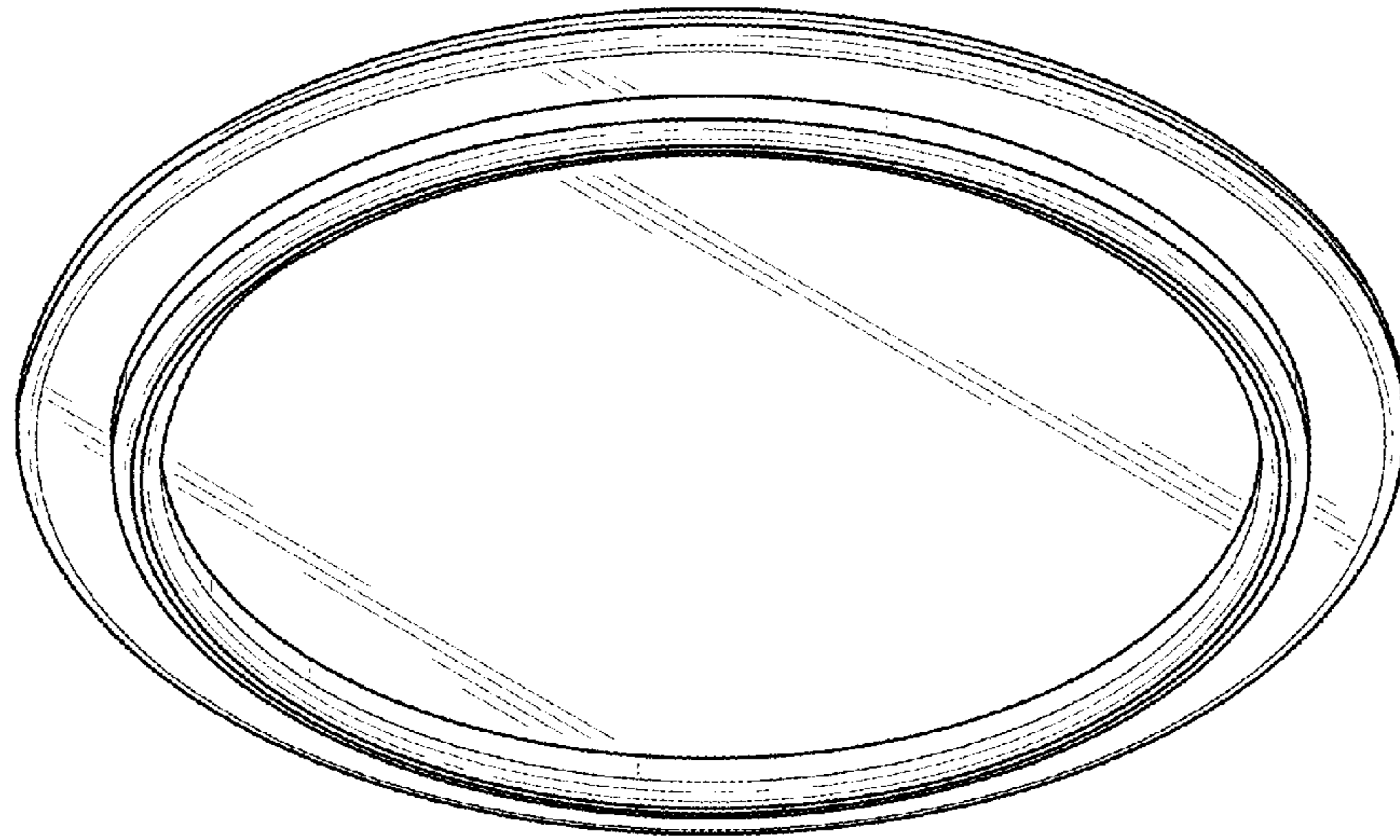

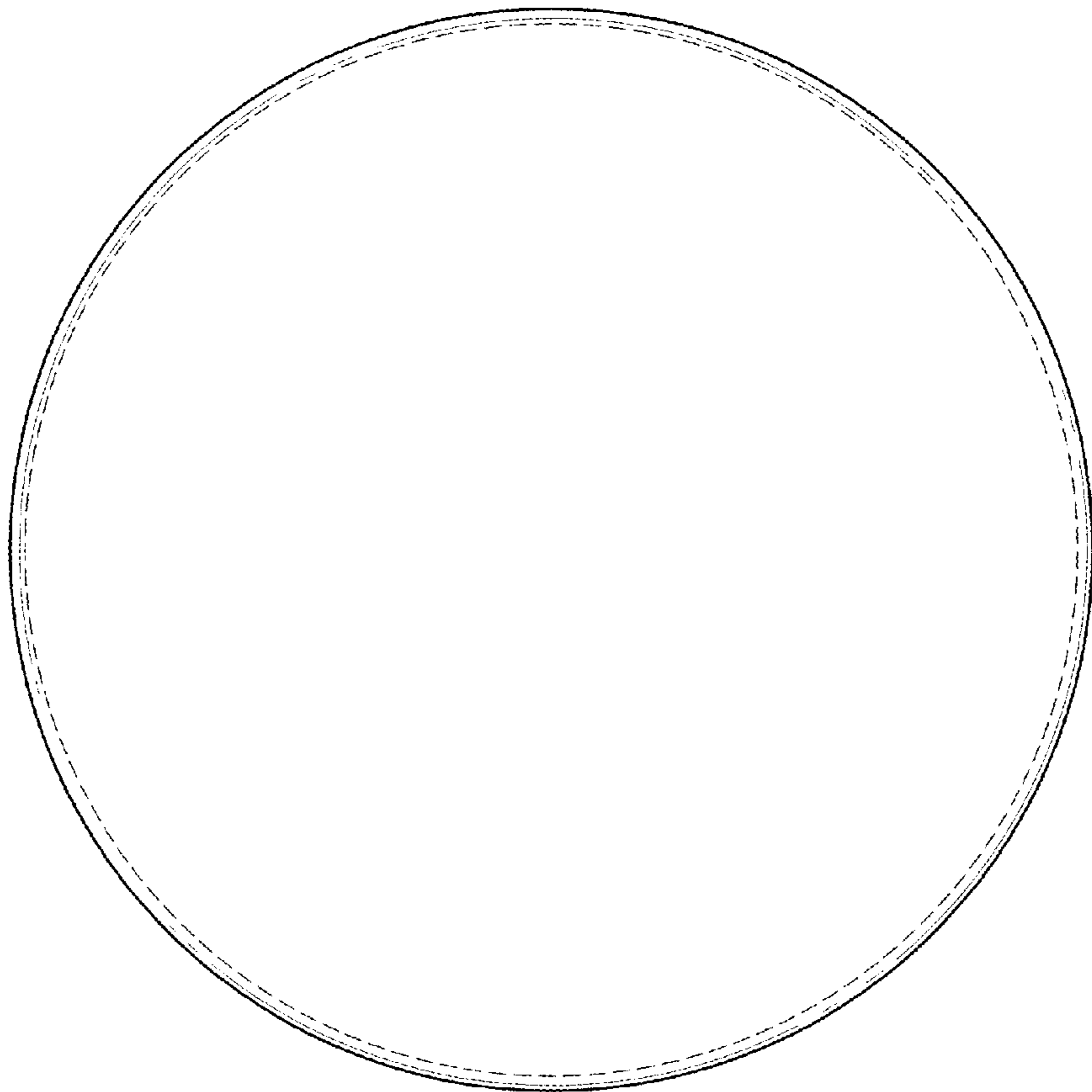

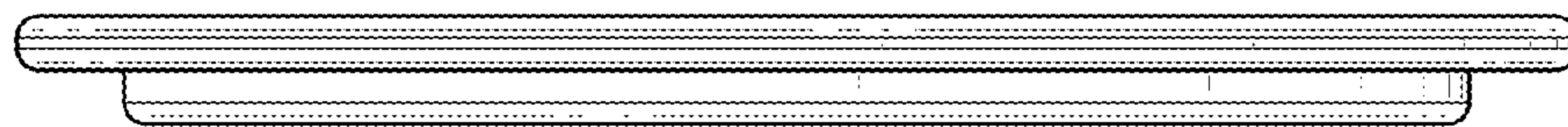

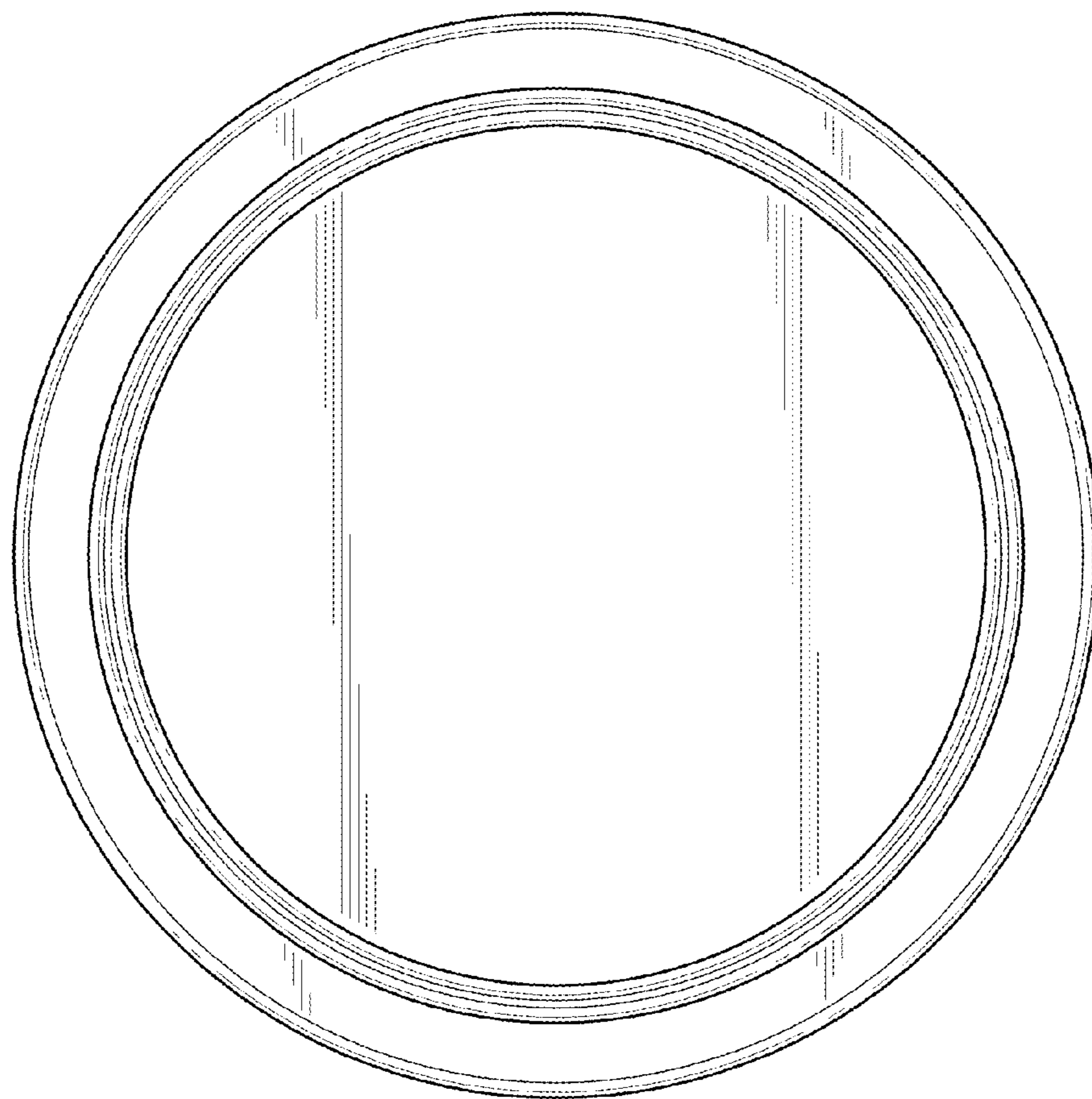
