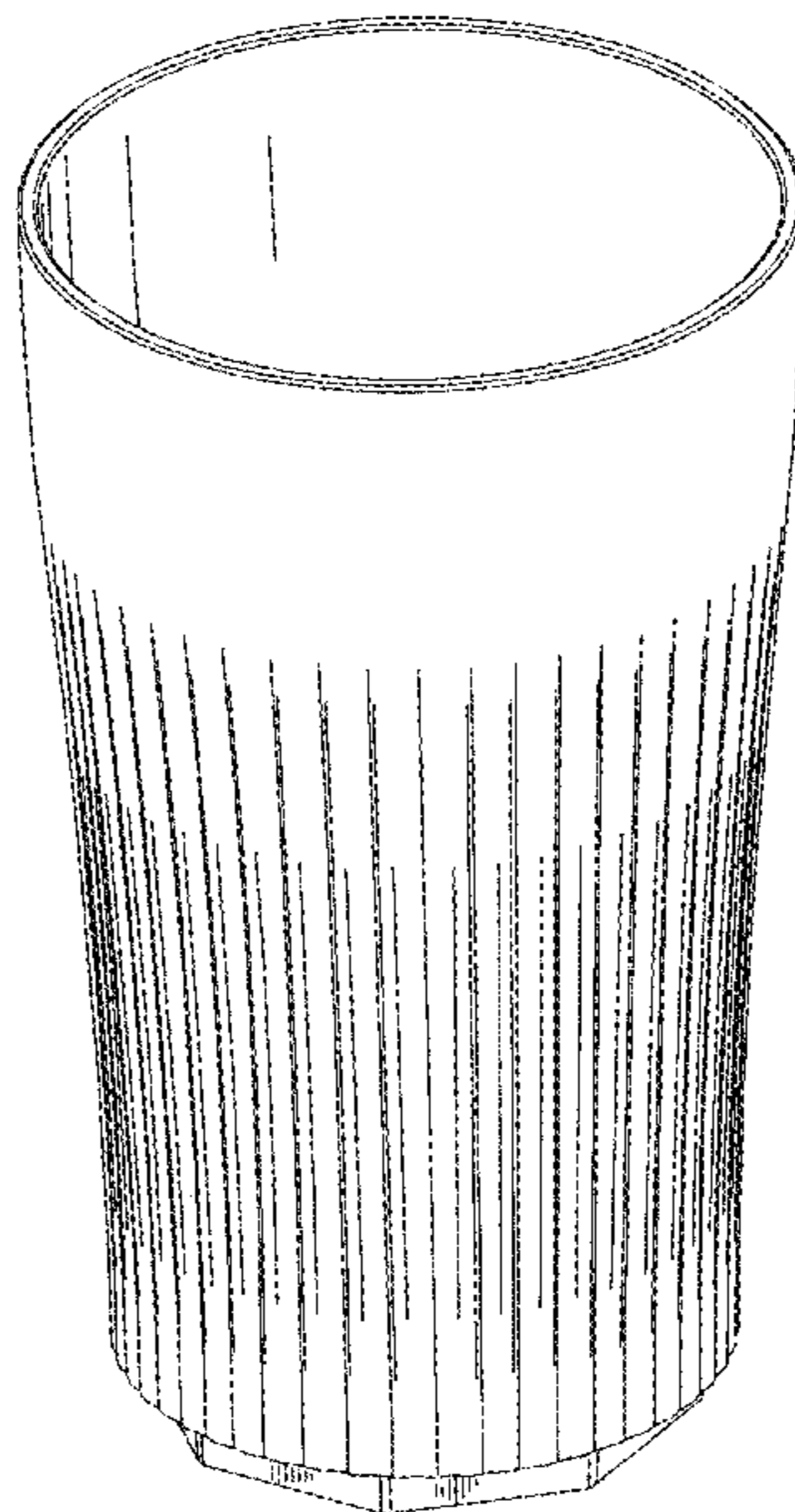
The ornamental design for a mixing/drinking cup, as shown and described.

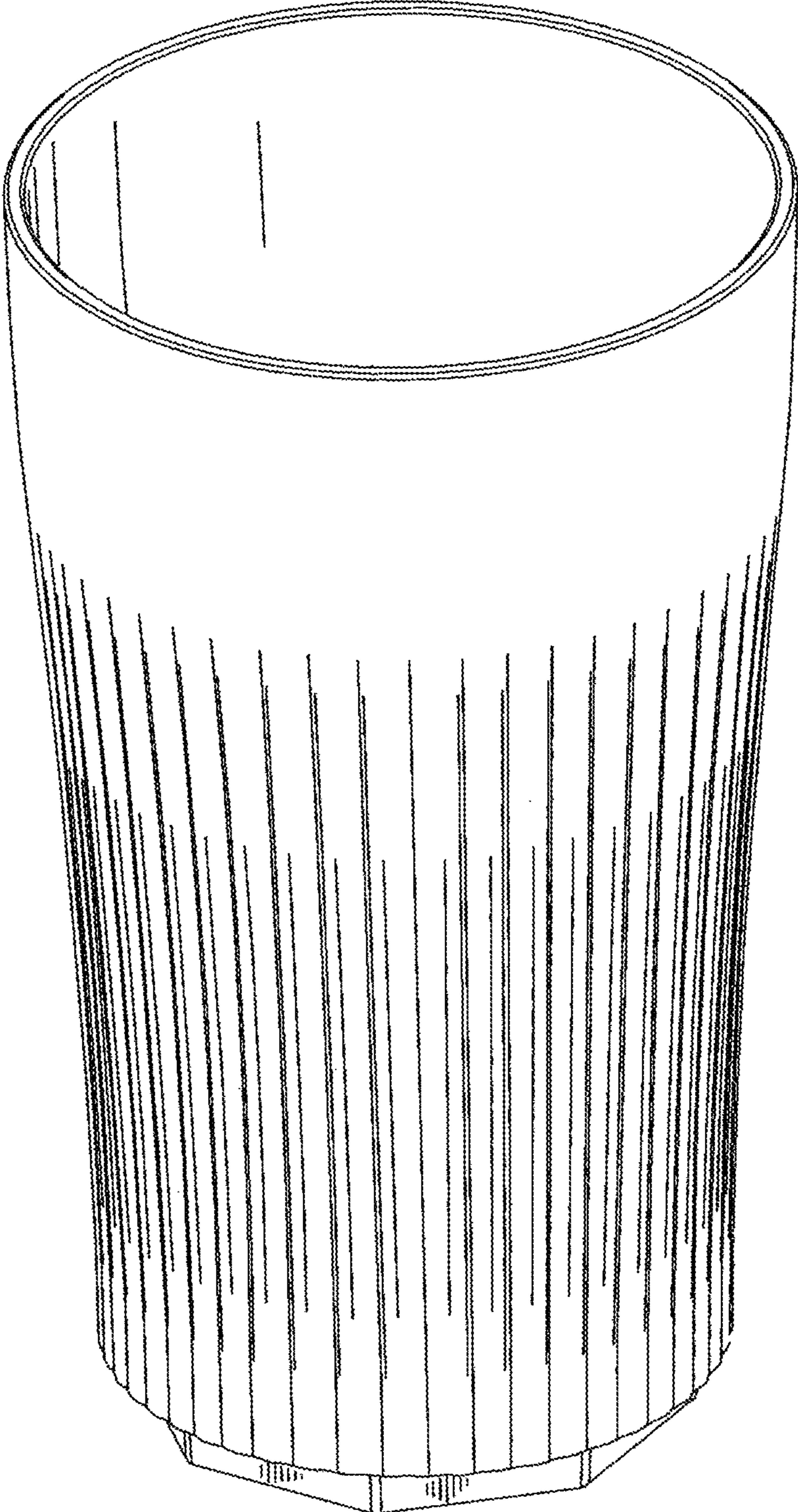

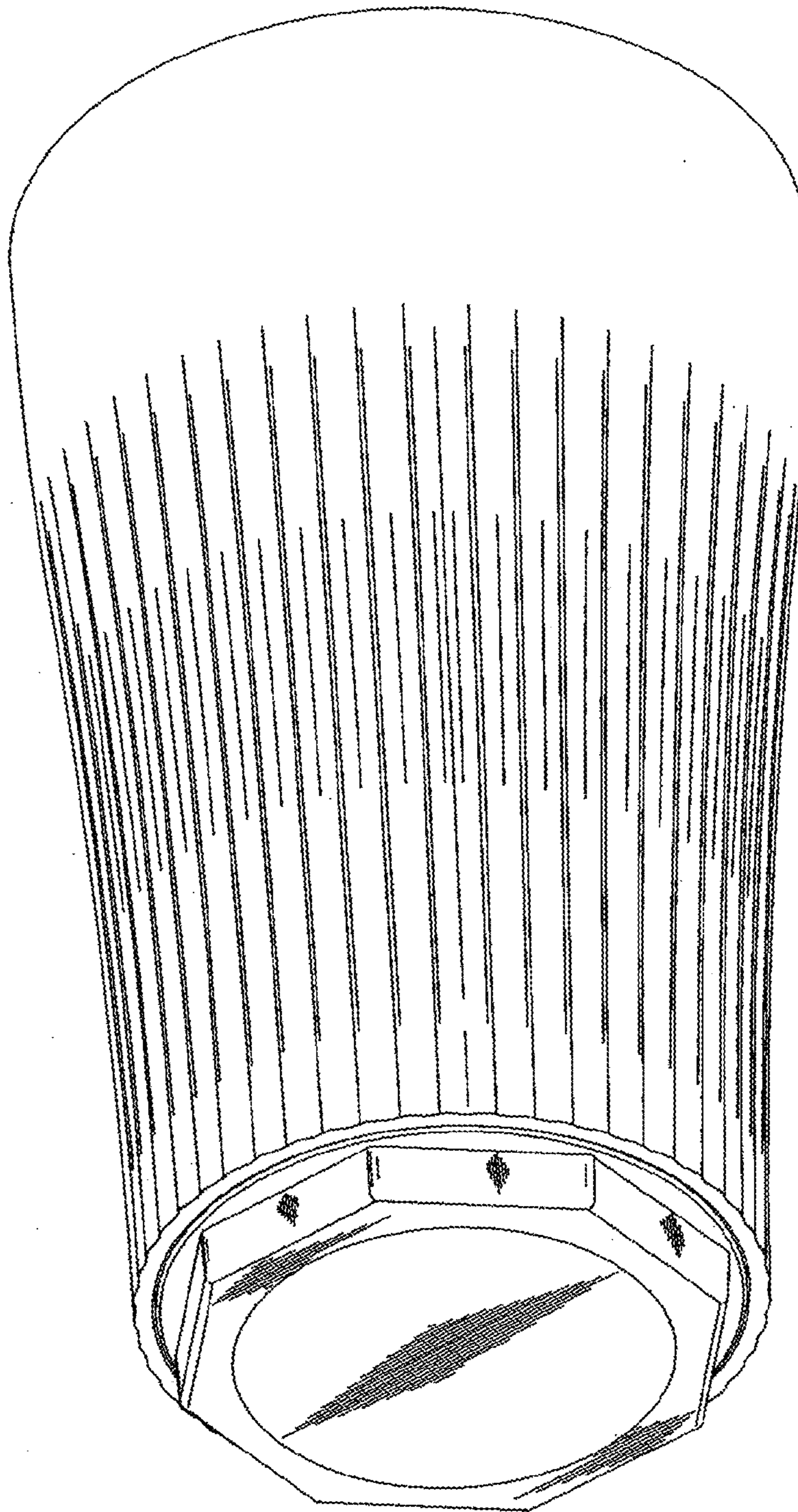

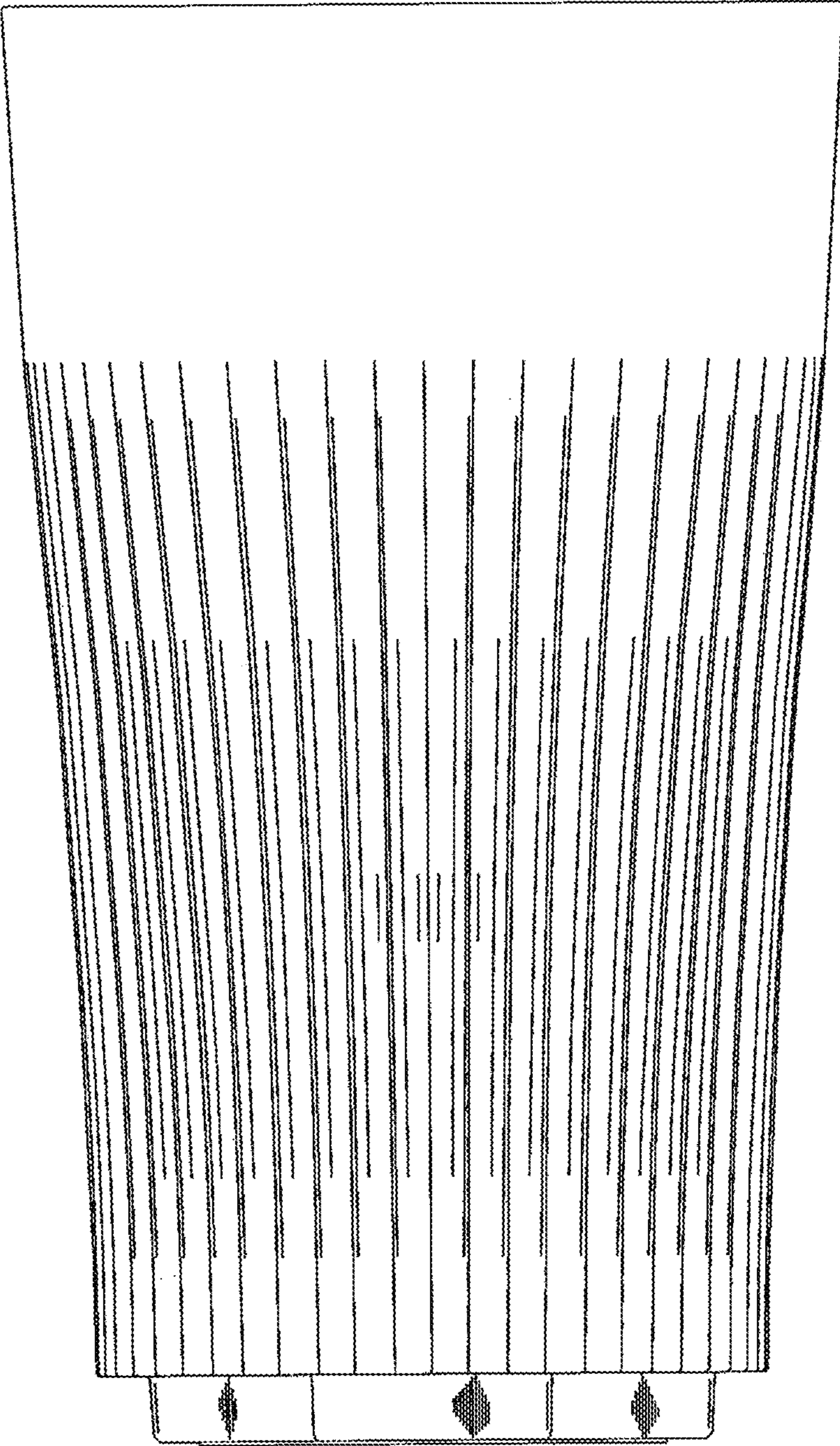

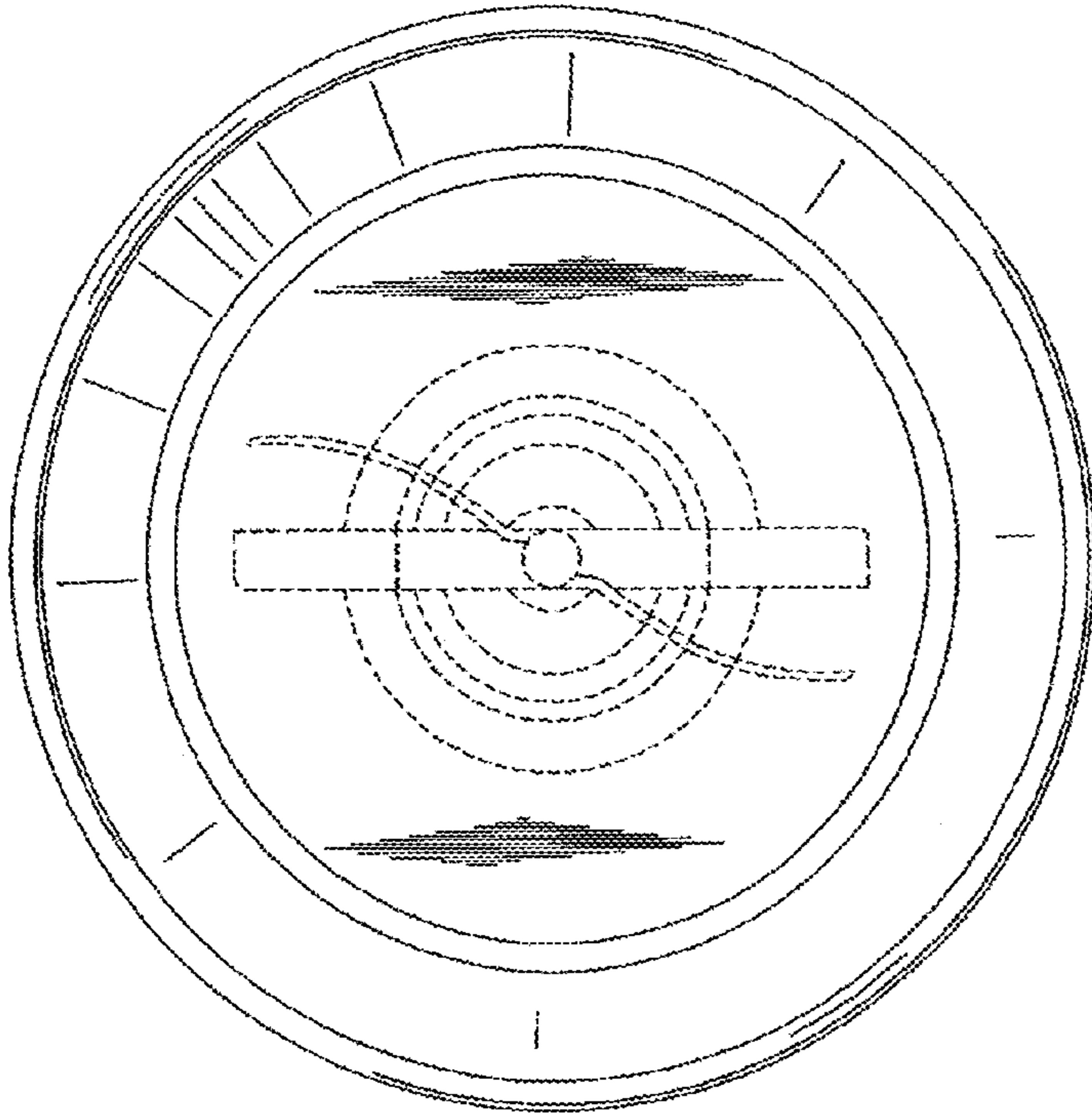

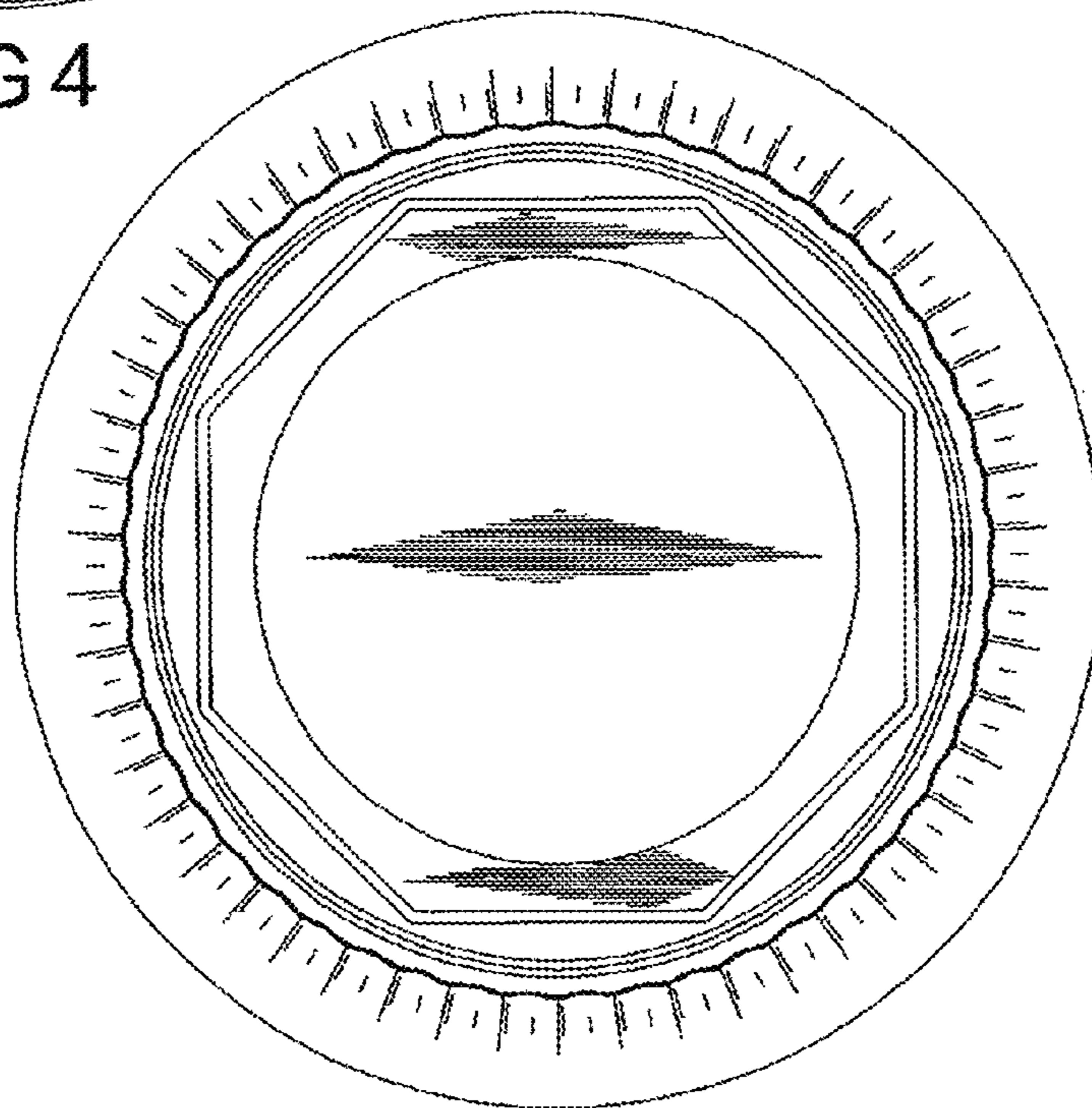
