FIG. 14 is a right side view of the beverage container of FIG. 9;

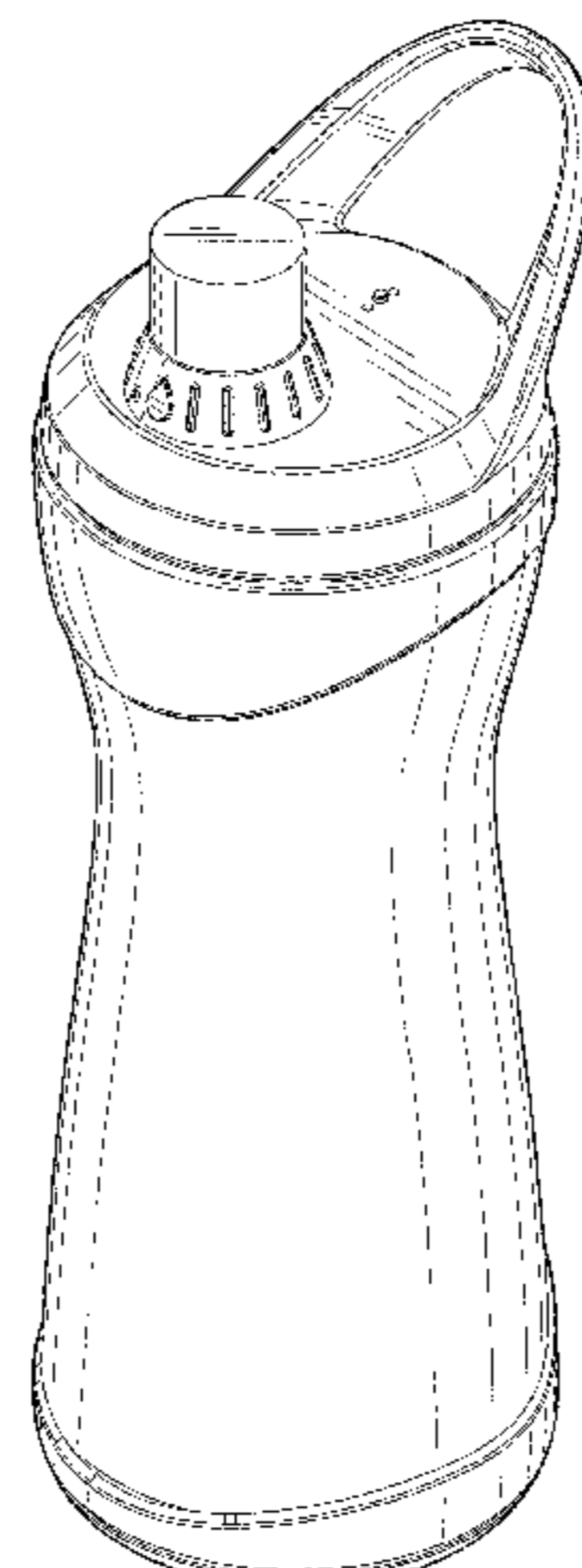
FIG. 15 is a top view of the beverage container of FIG. 9;

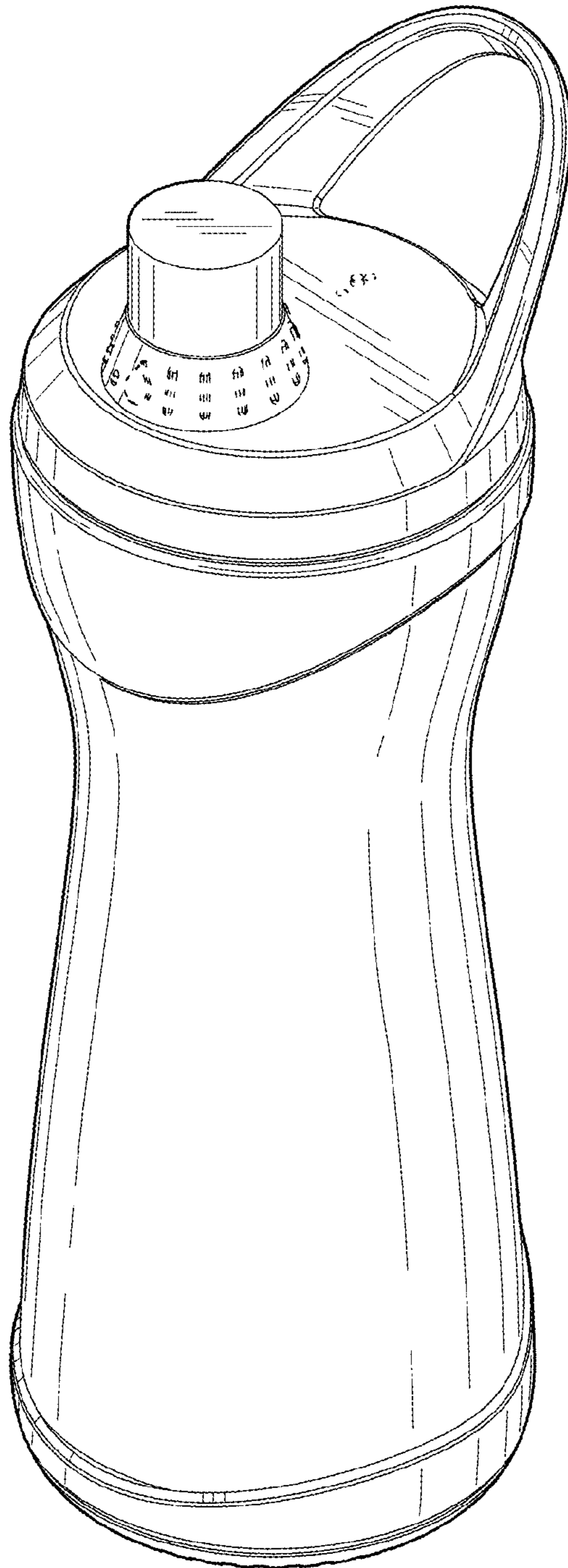

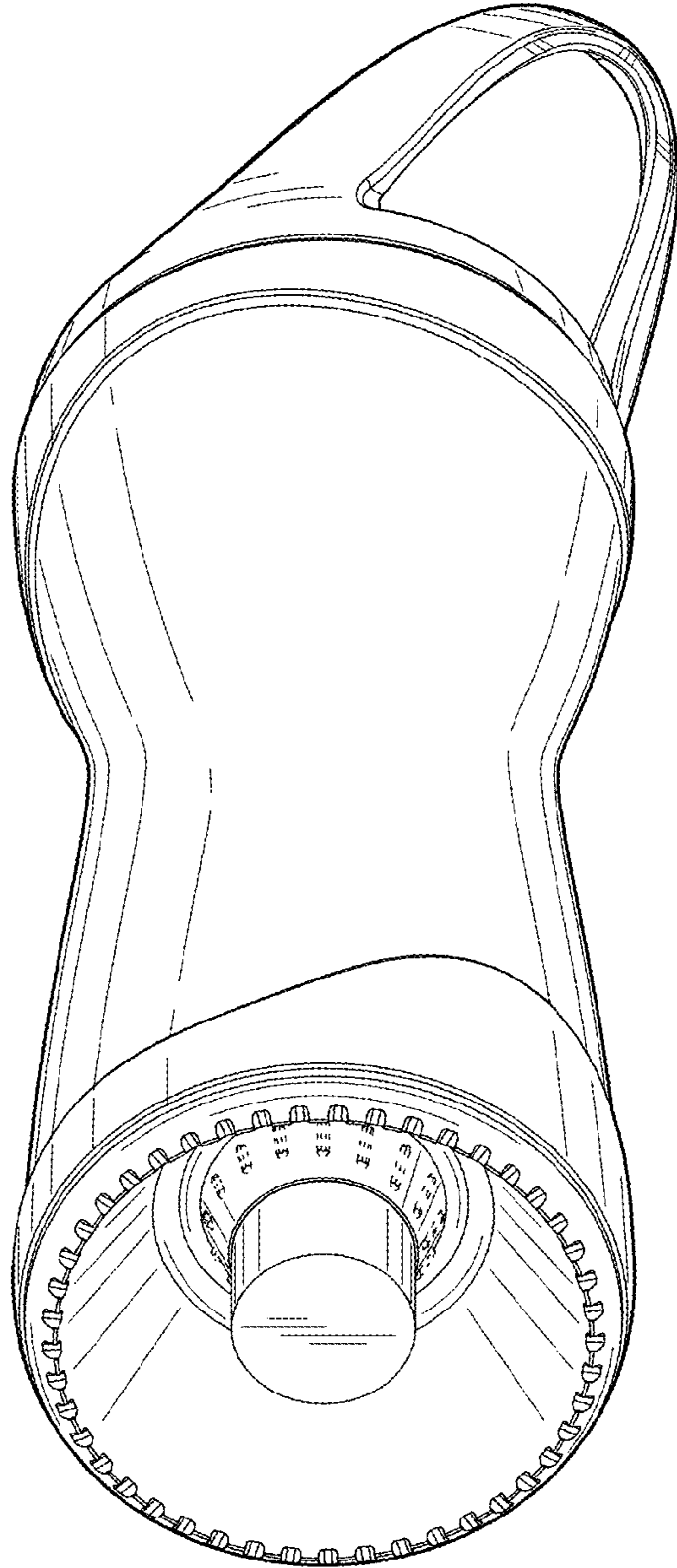

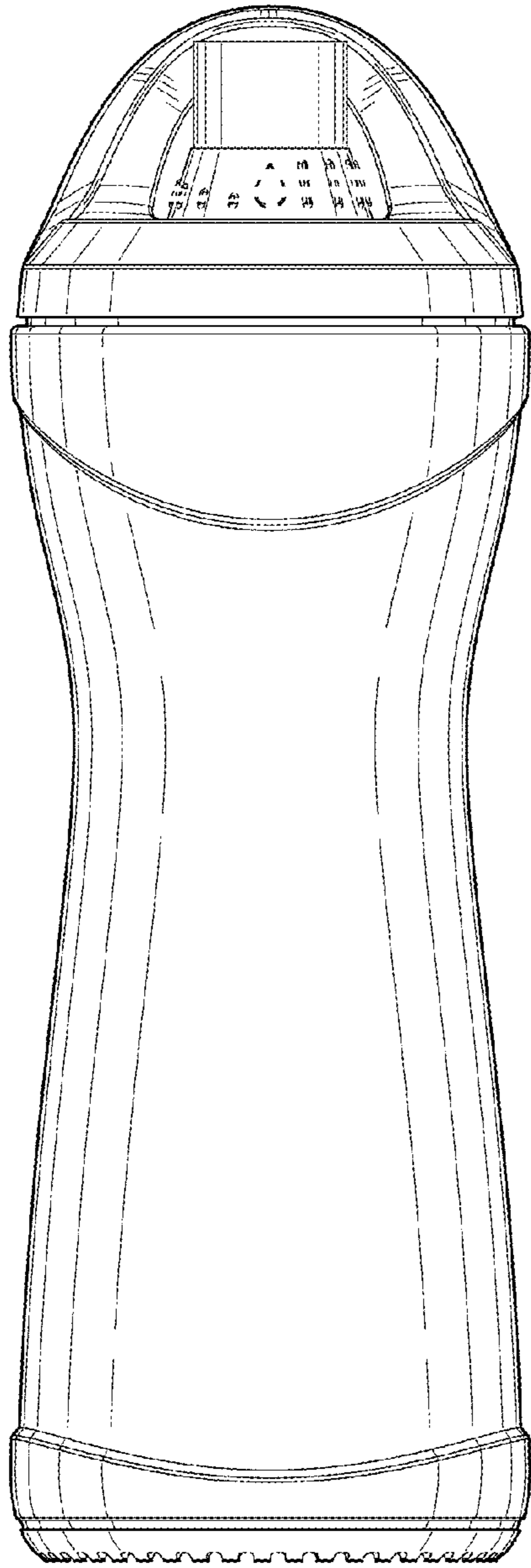

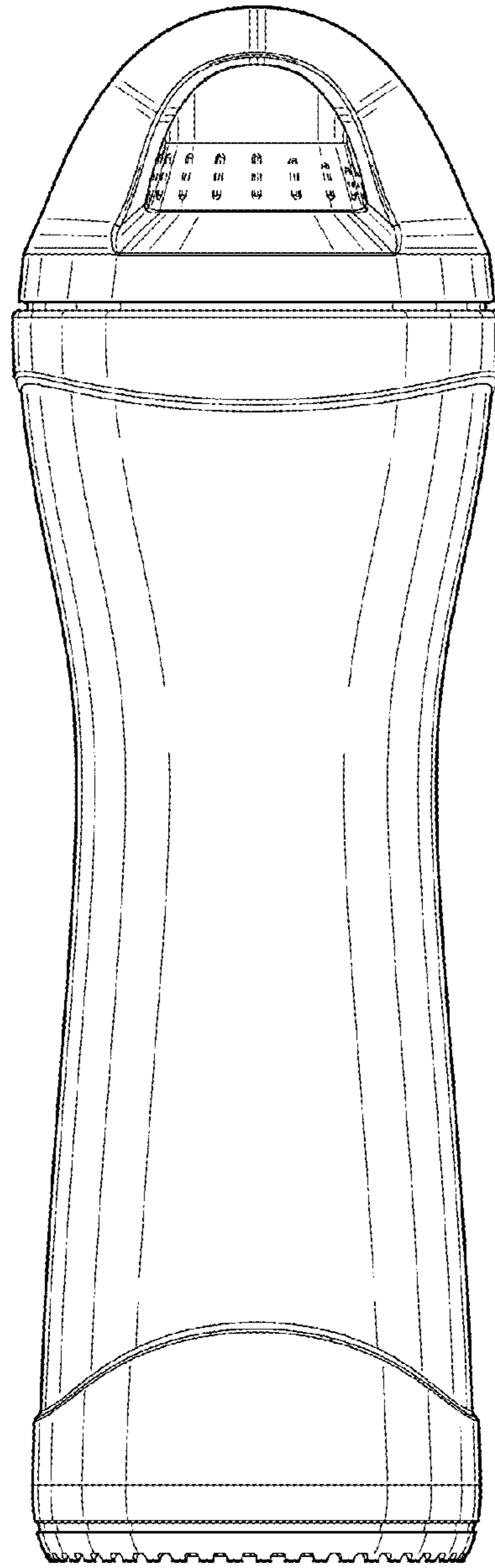

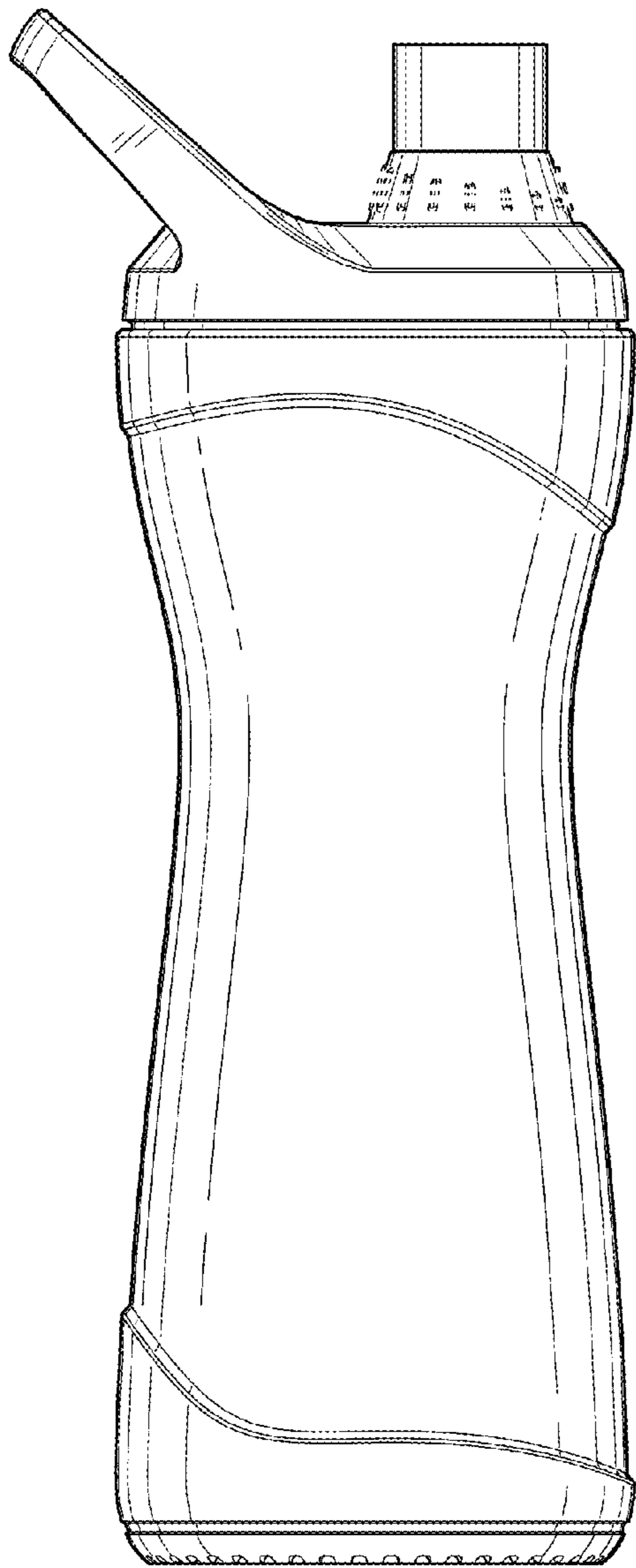

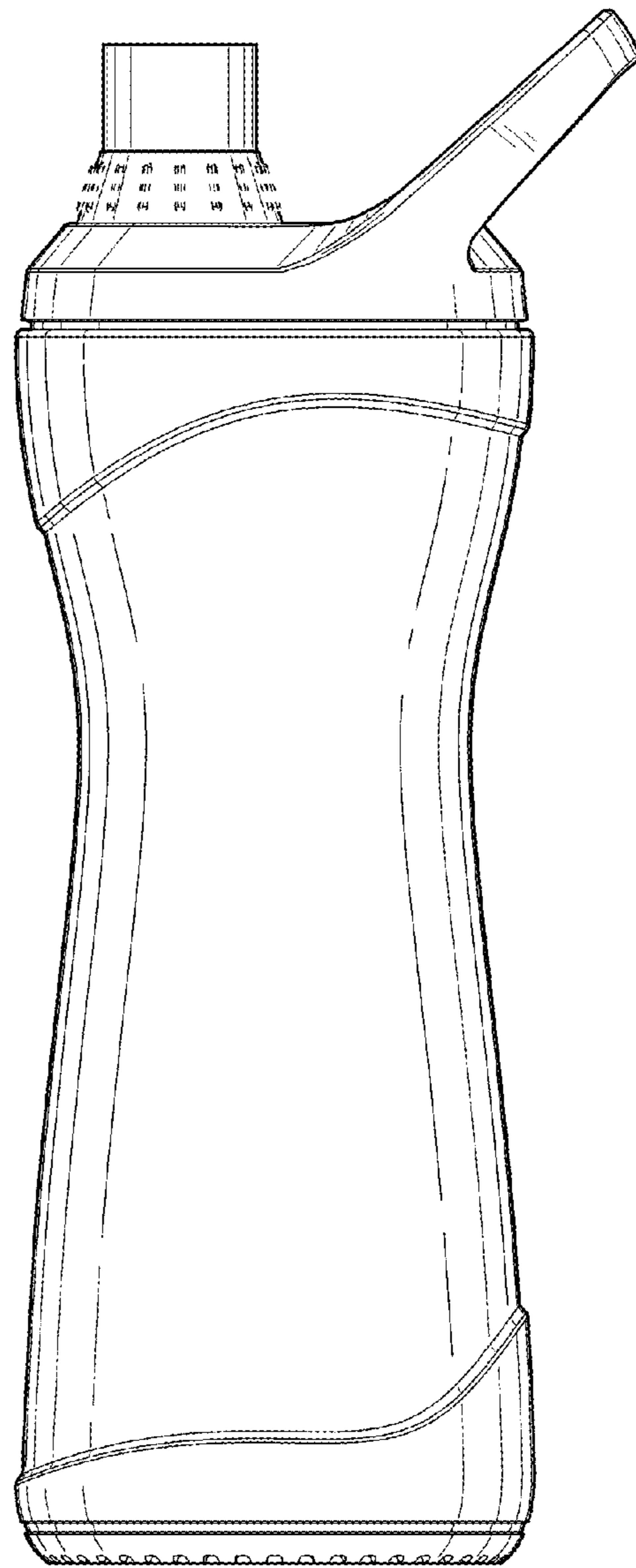

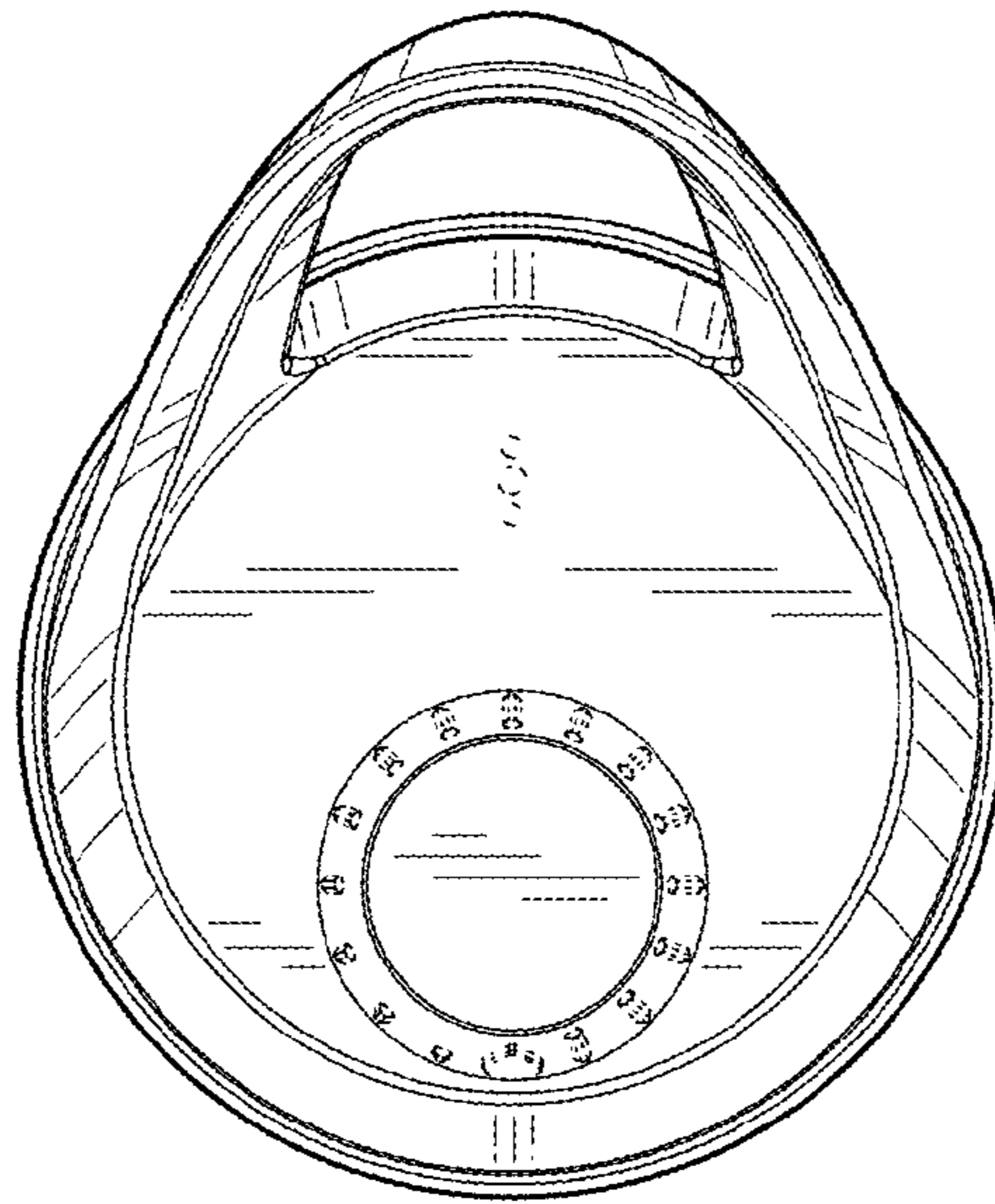

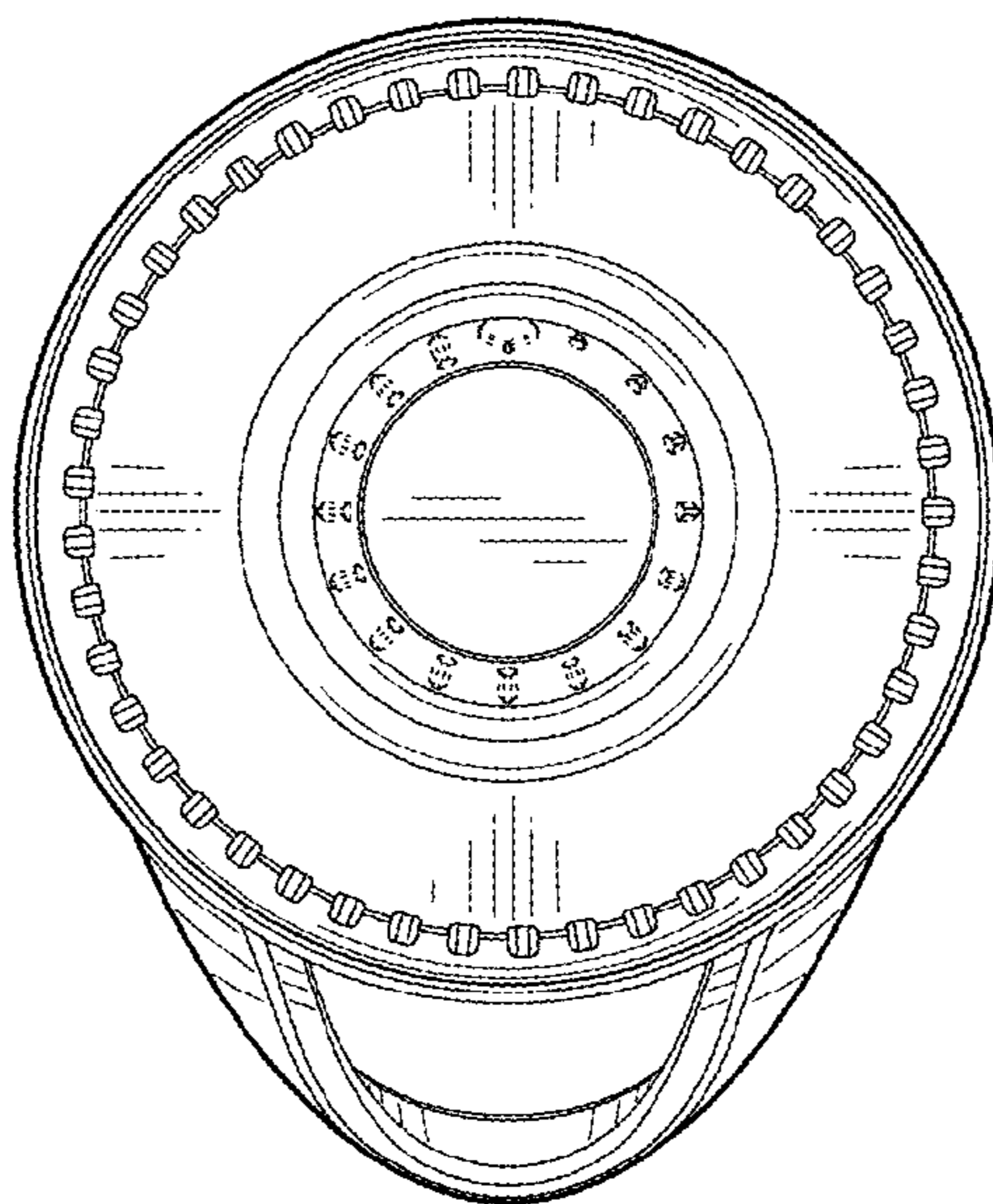

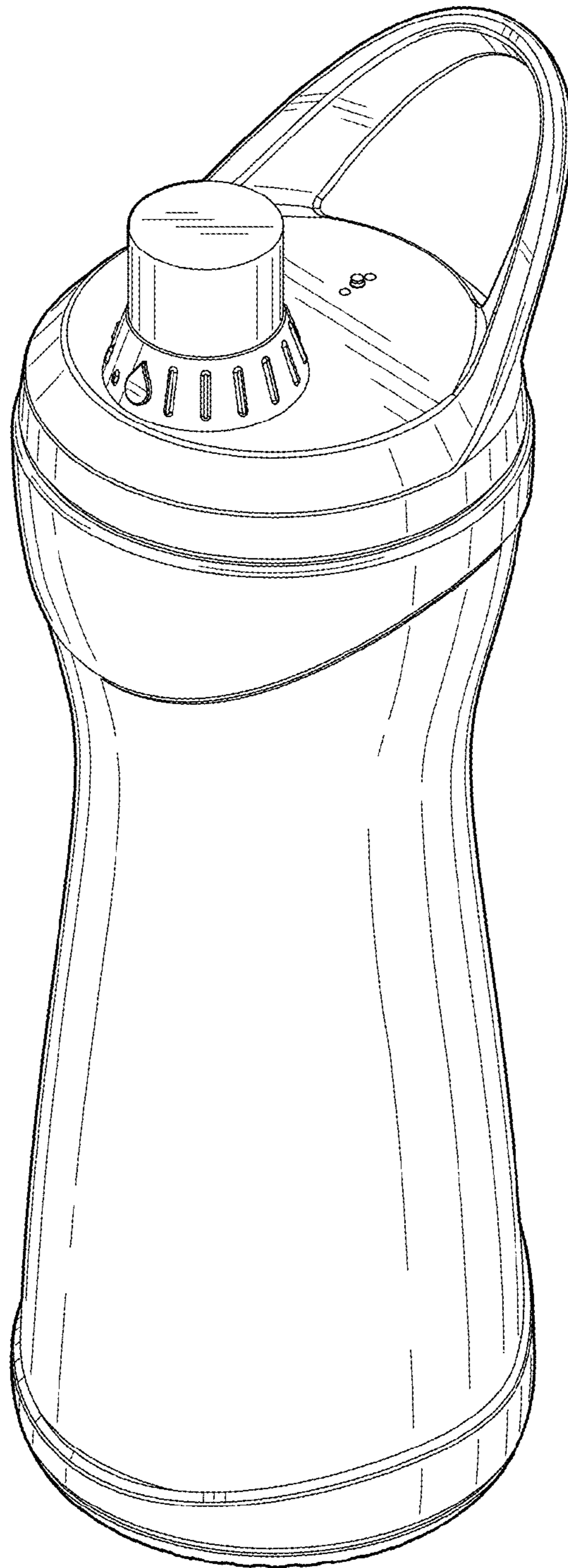

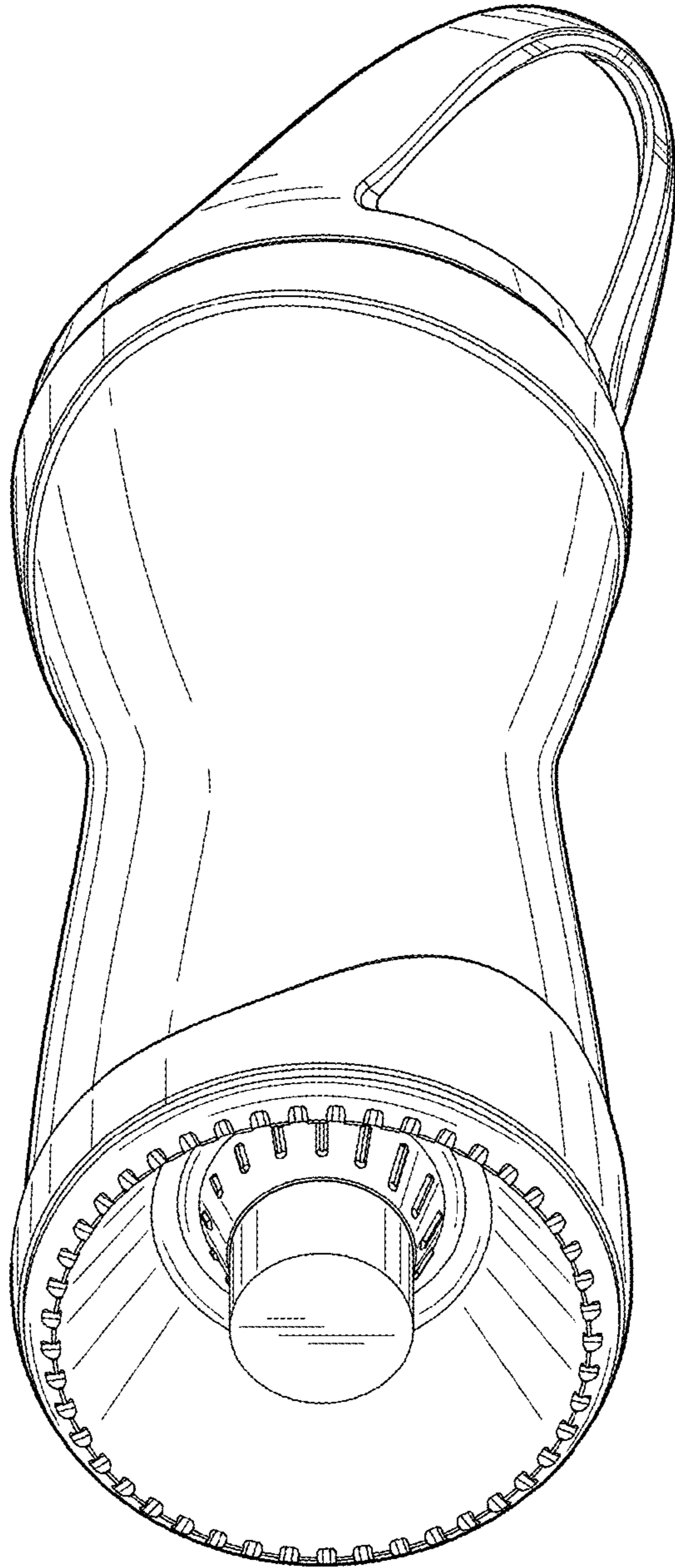

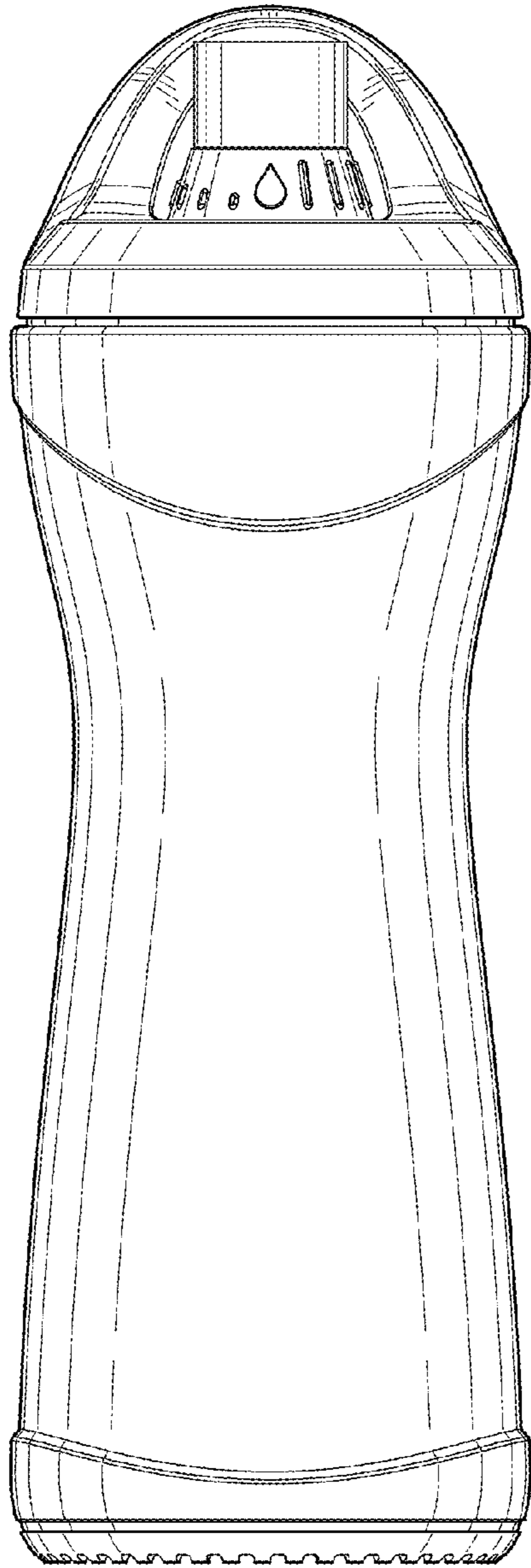

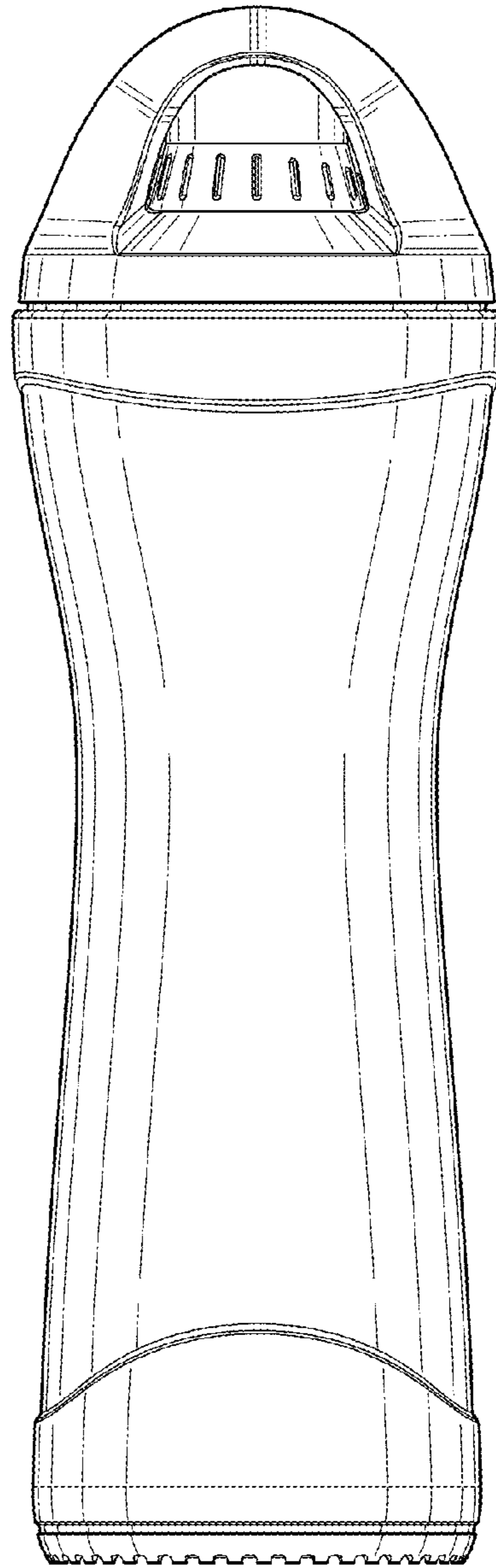

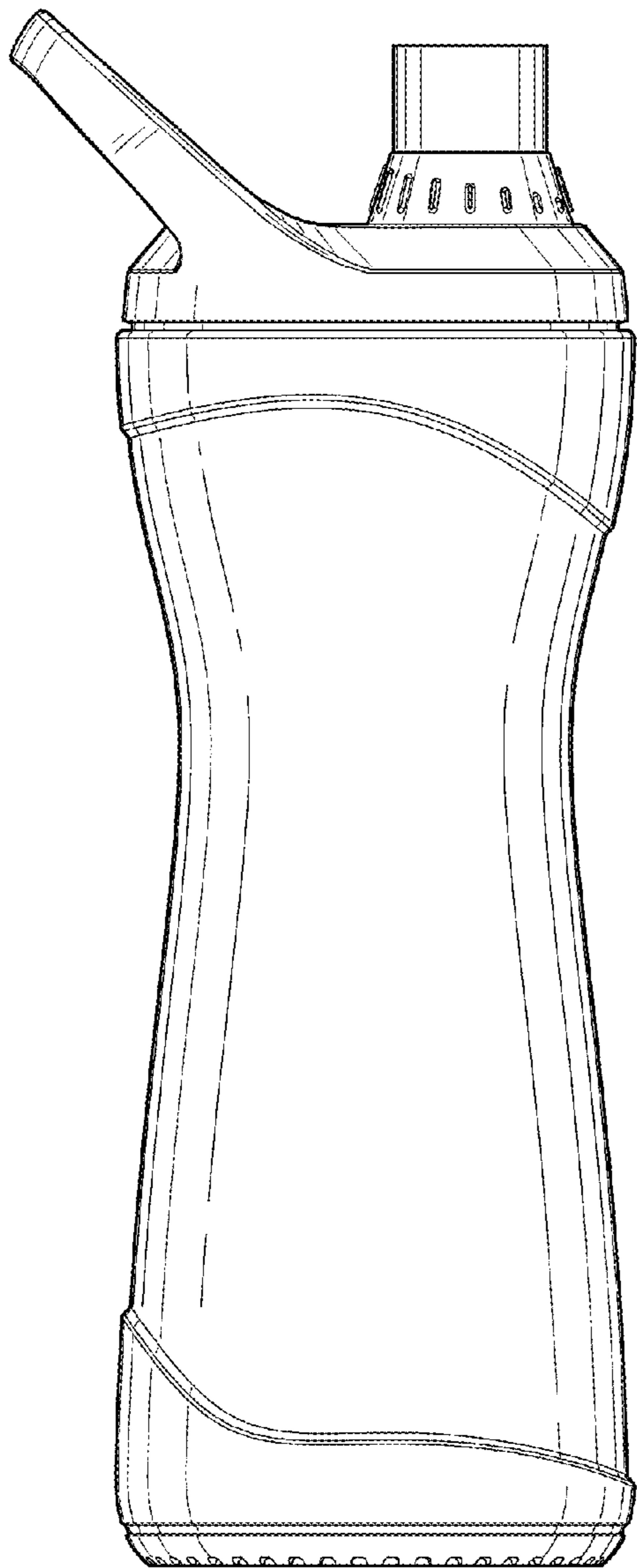

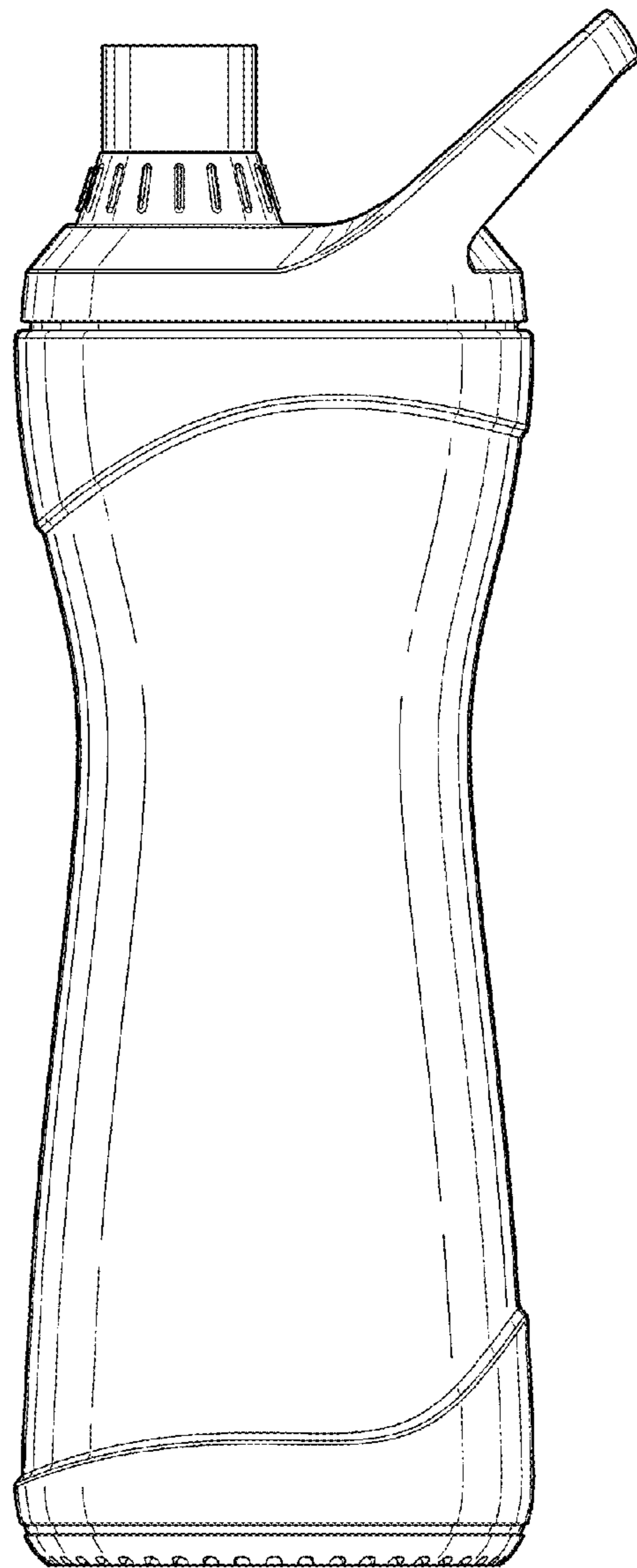

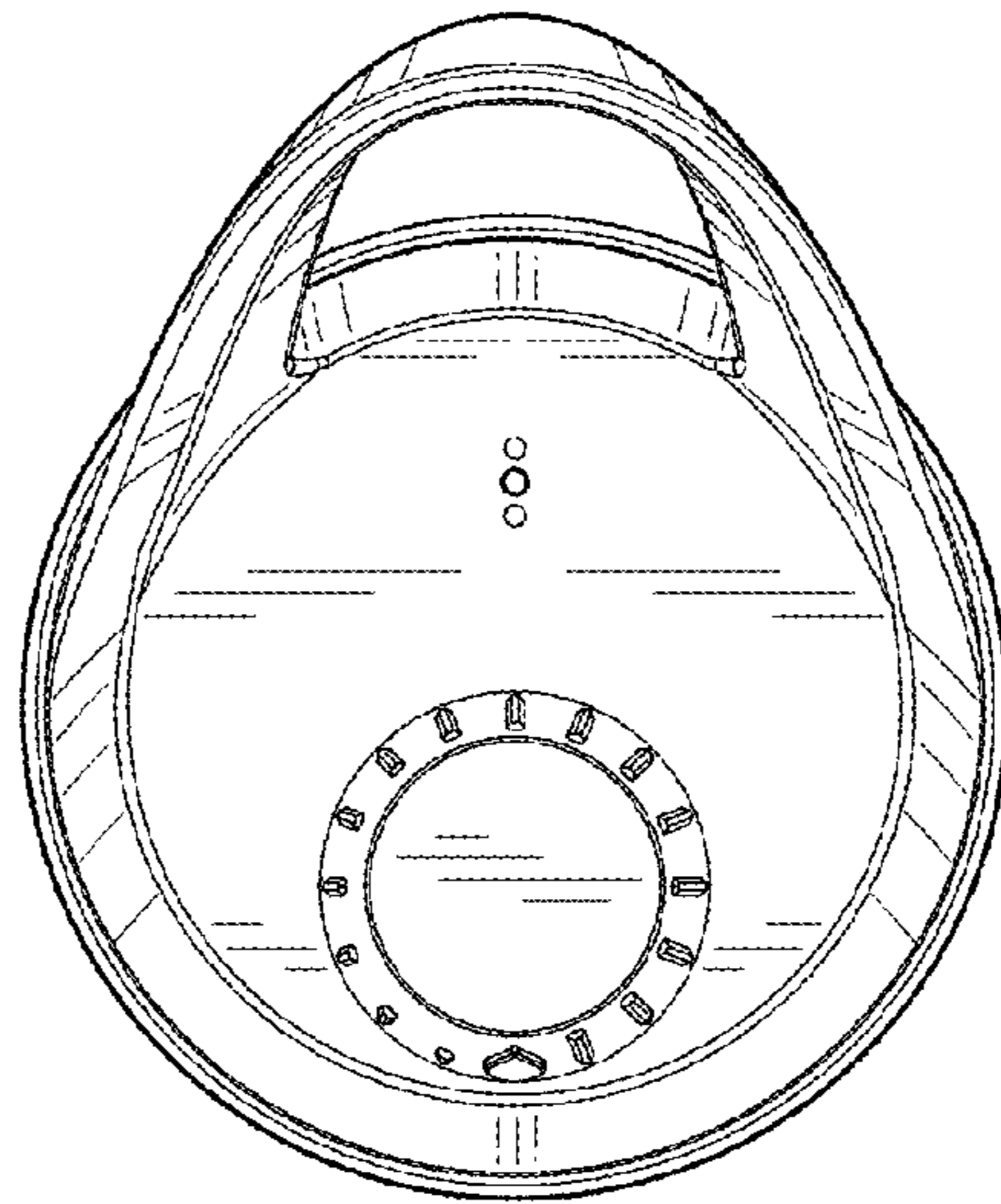

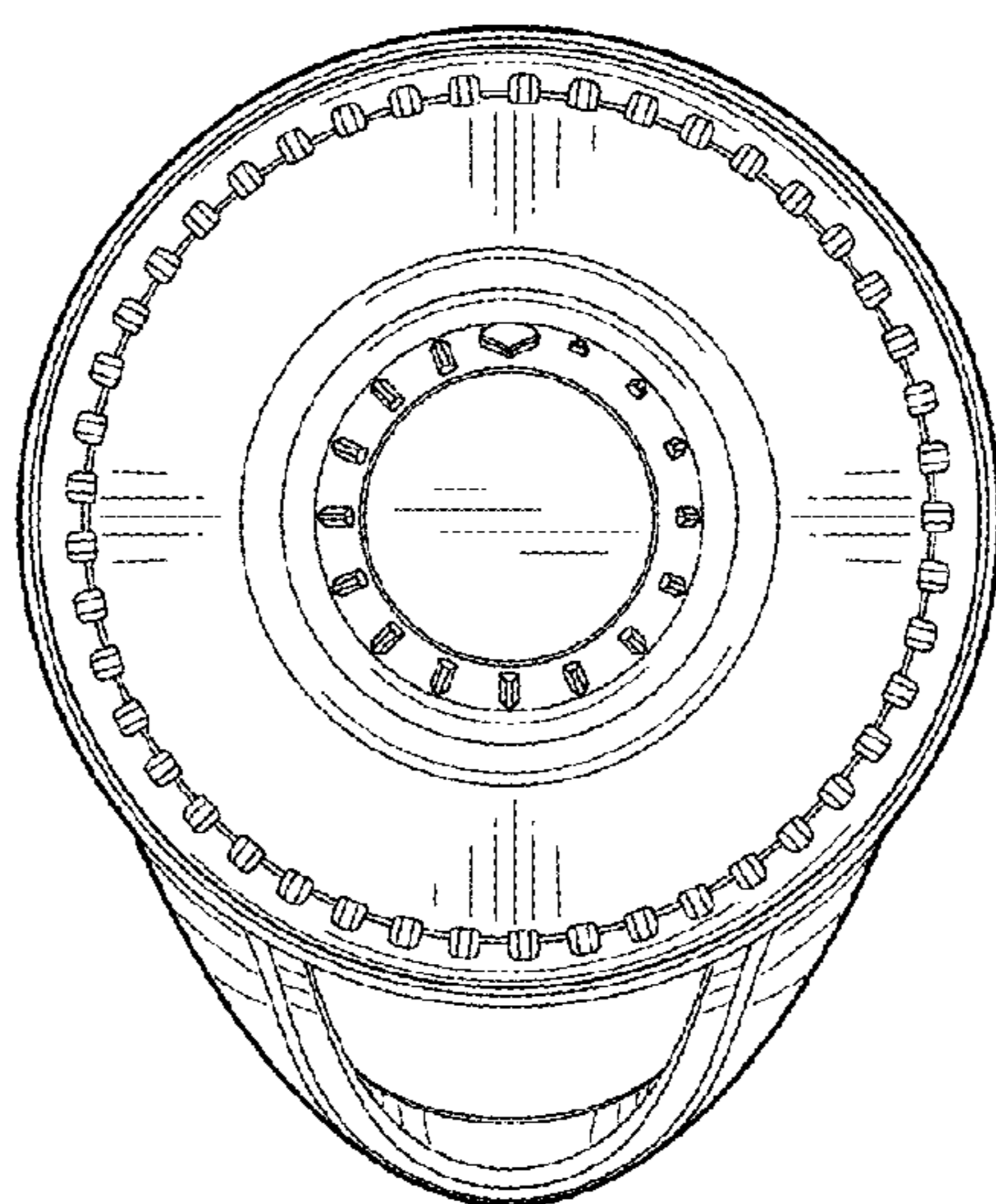
