The ornamental design for chopsticks, as shown and described.

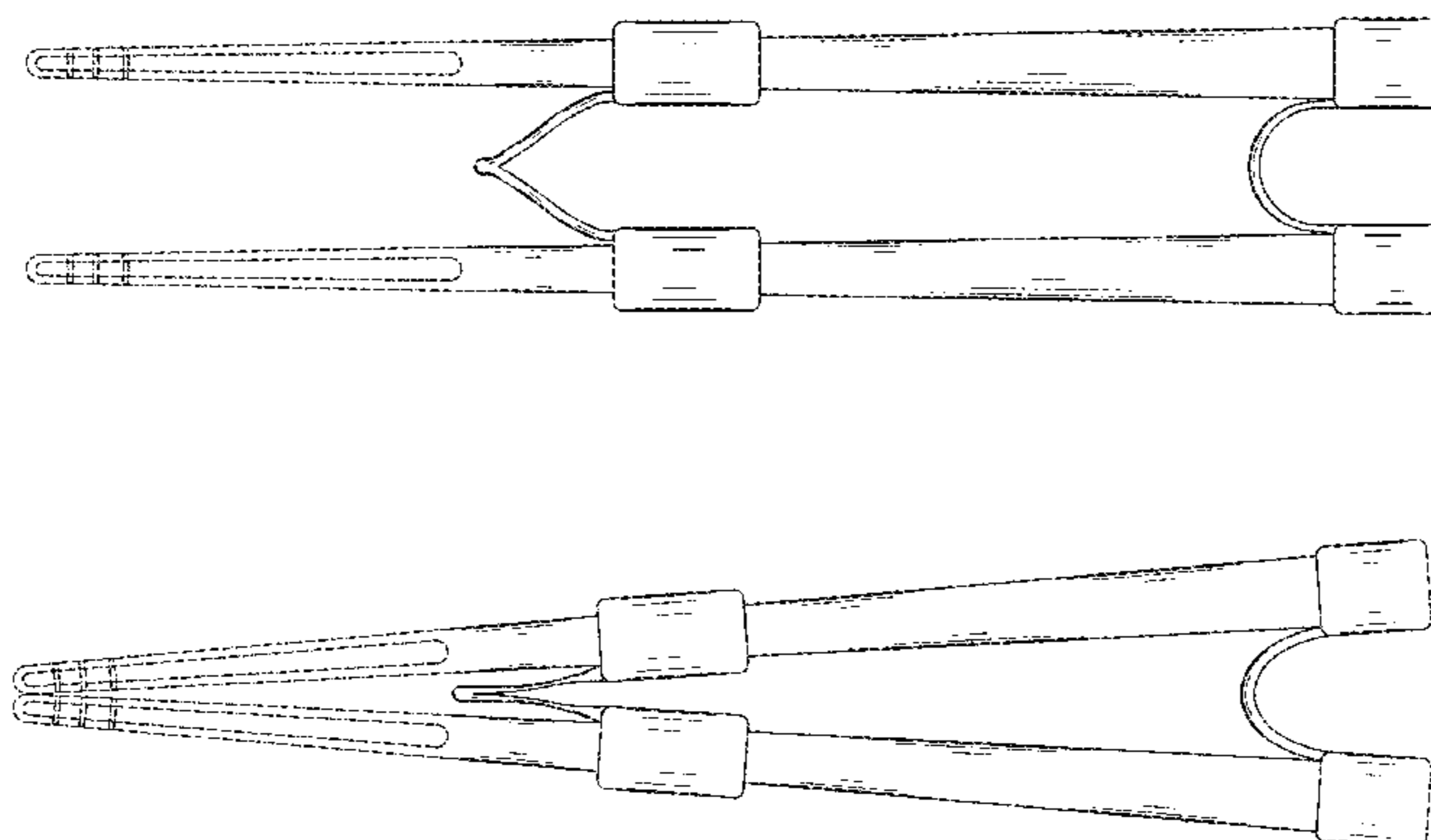
DESCRIPTION

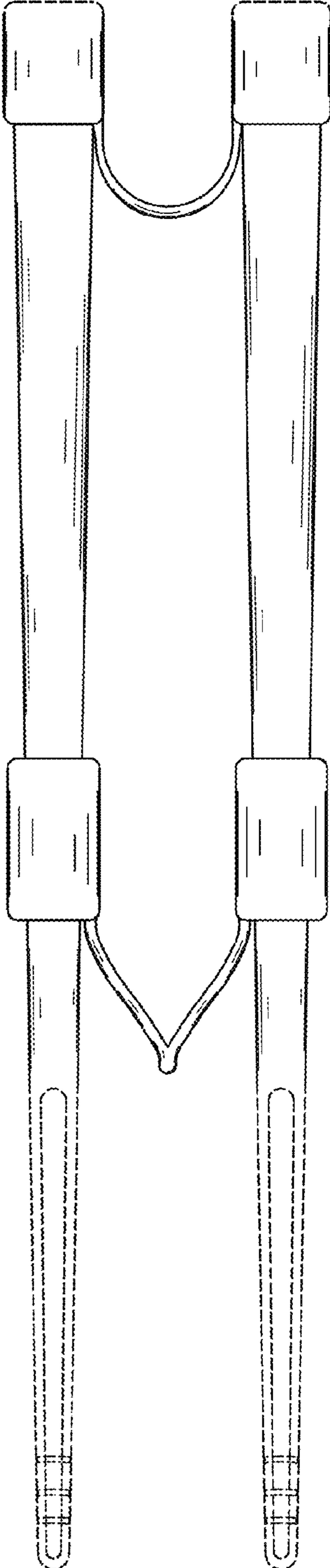

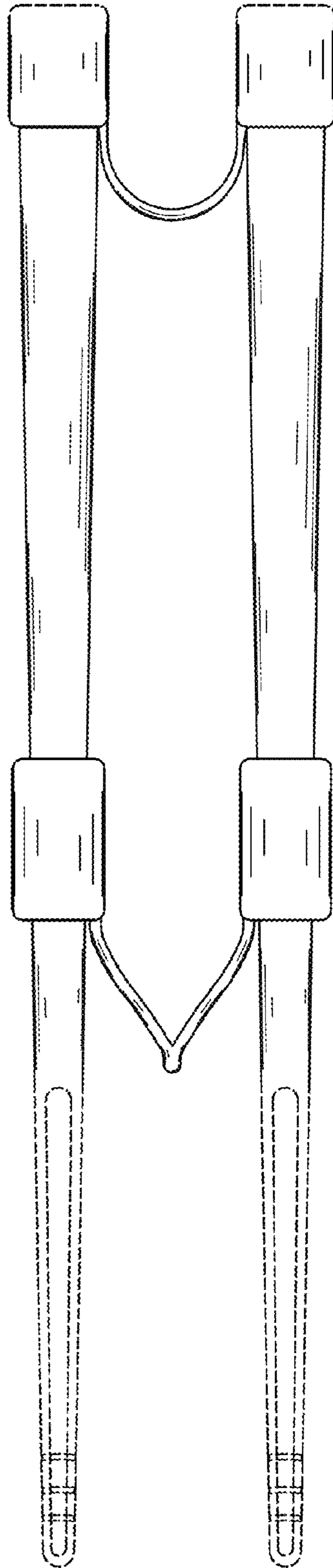

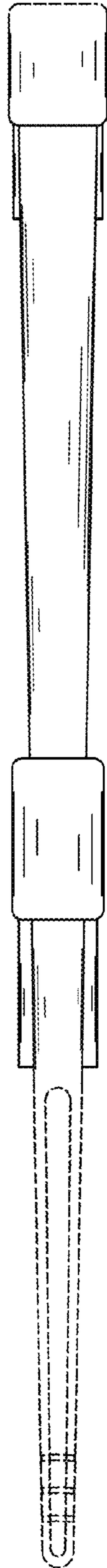

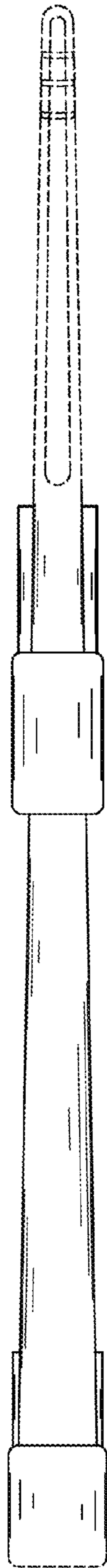

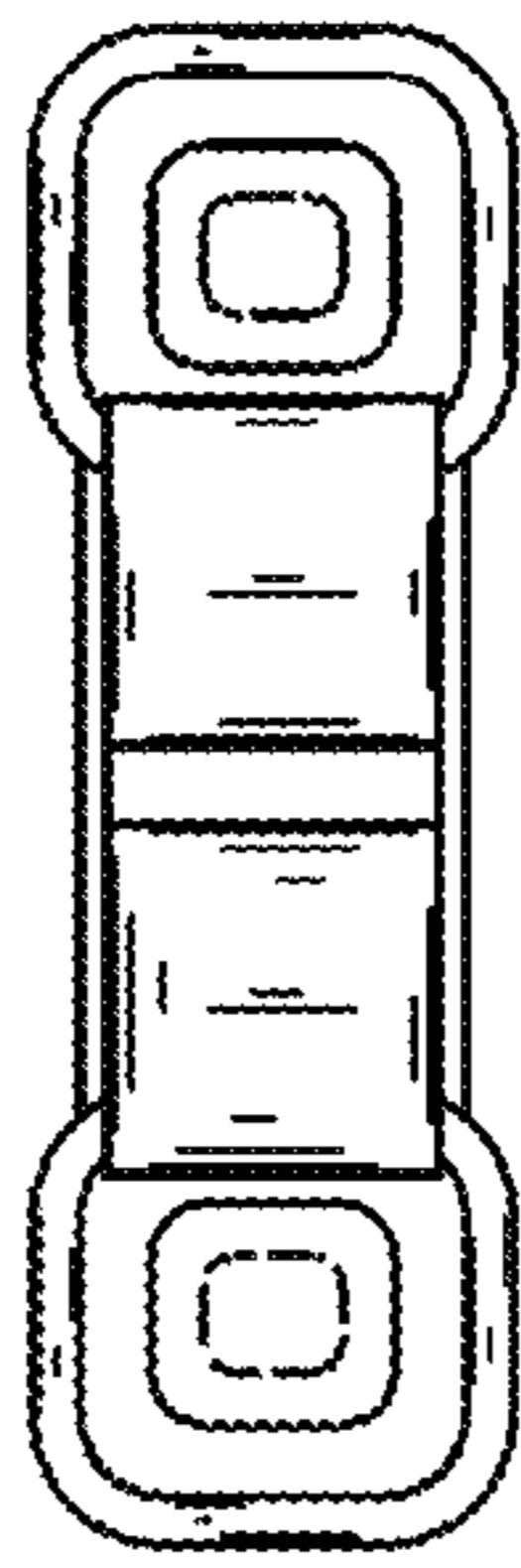

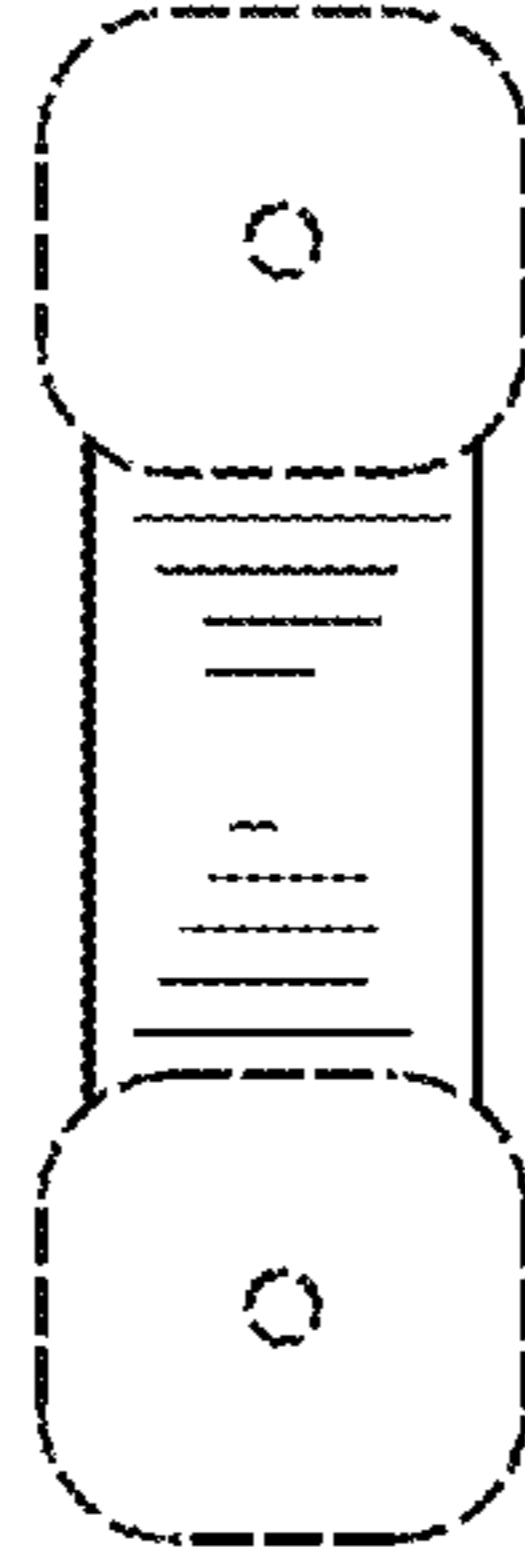

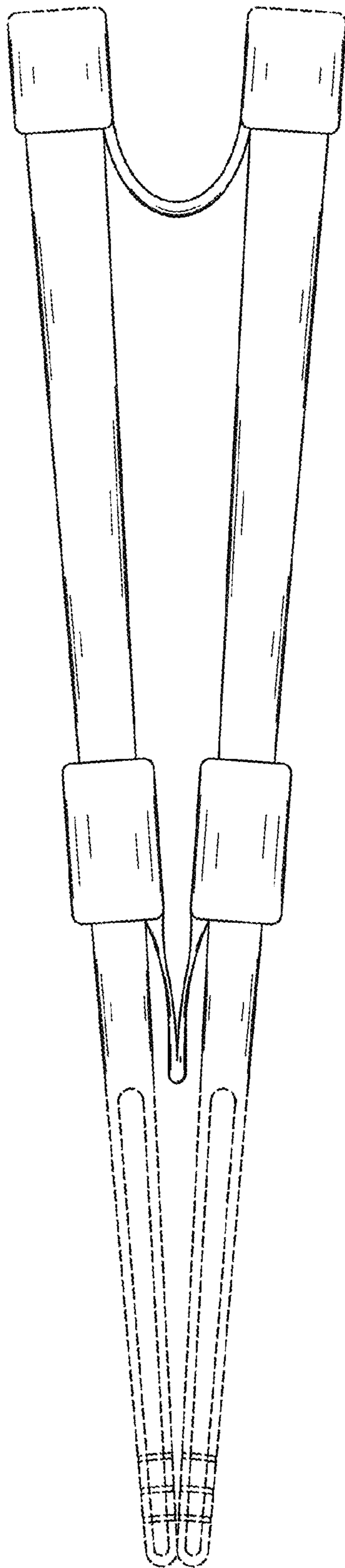
