FIG. 4 is a rear view of the bottle with cap of FIG. 1;

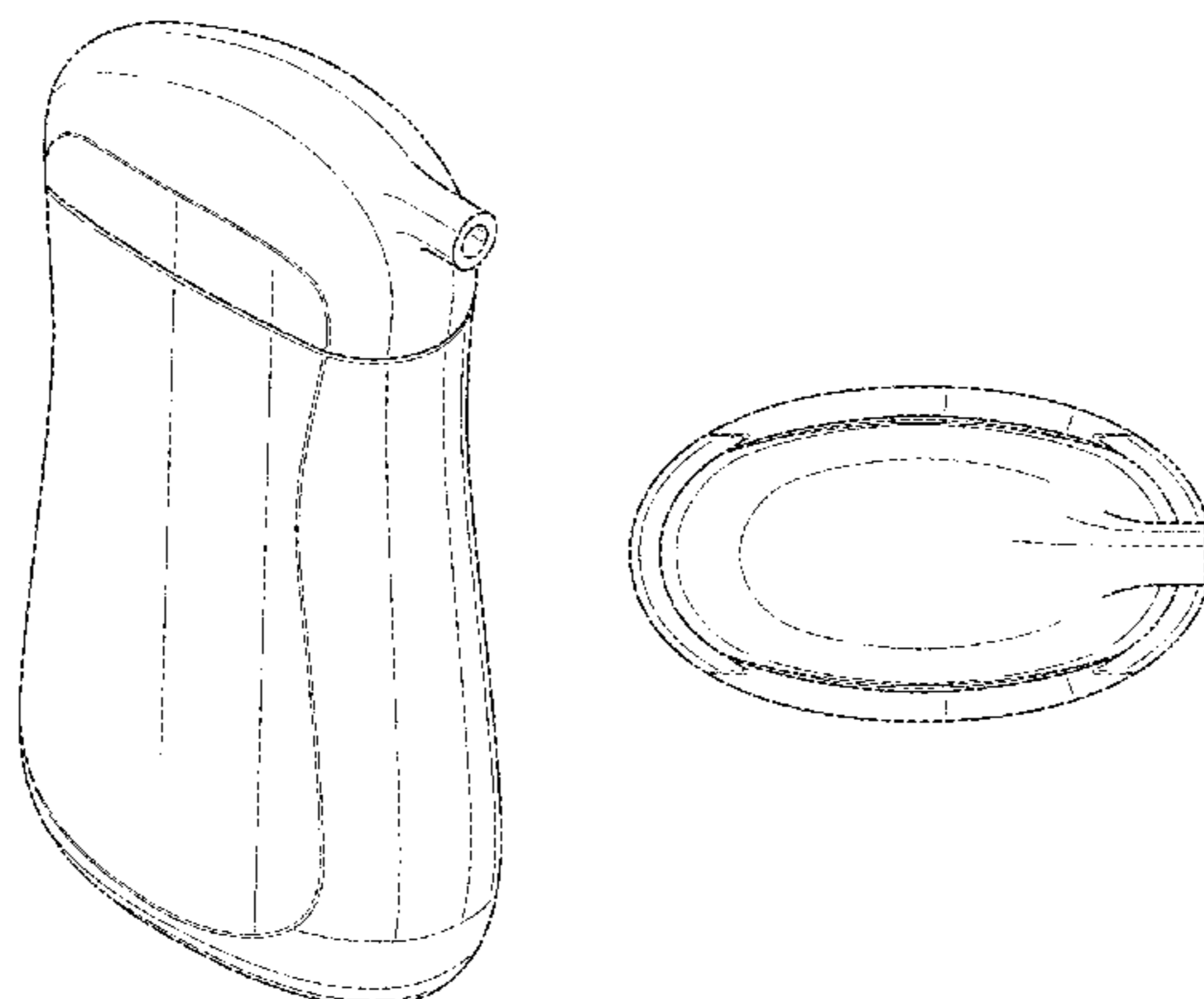
FIG. 5 is a front view of the bottle with cap of FIG. 1;

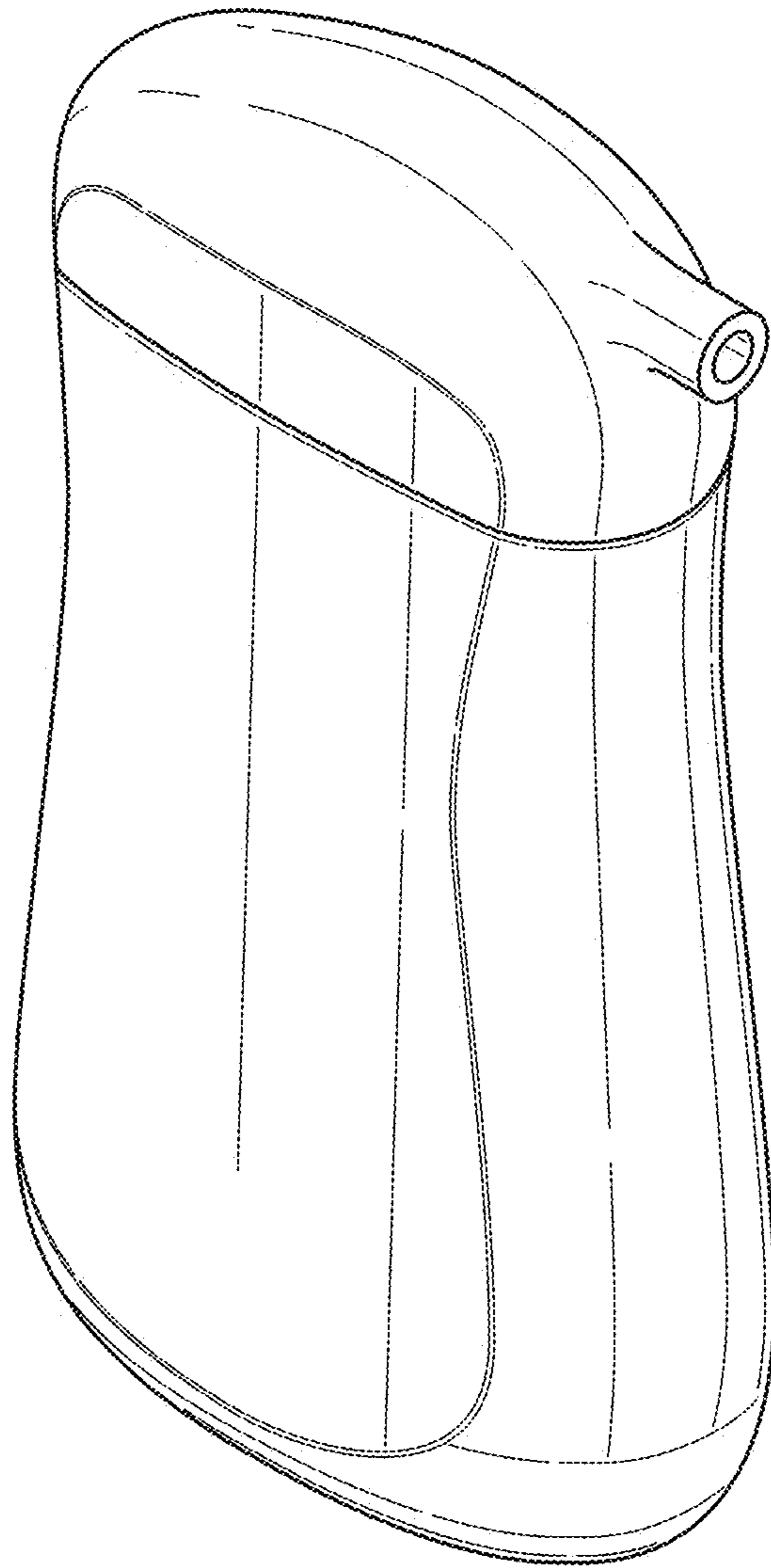

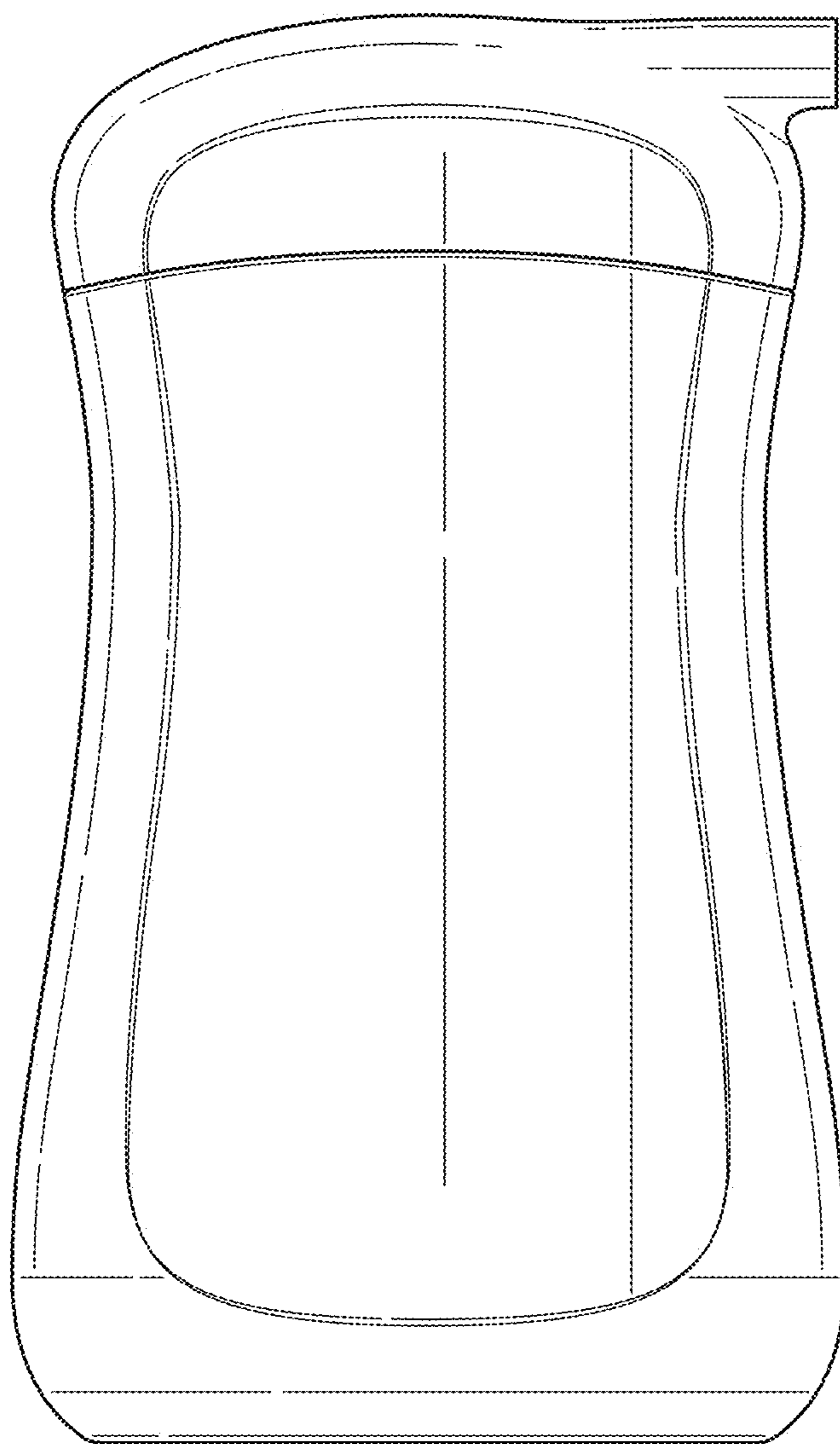

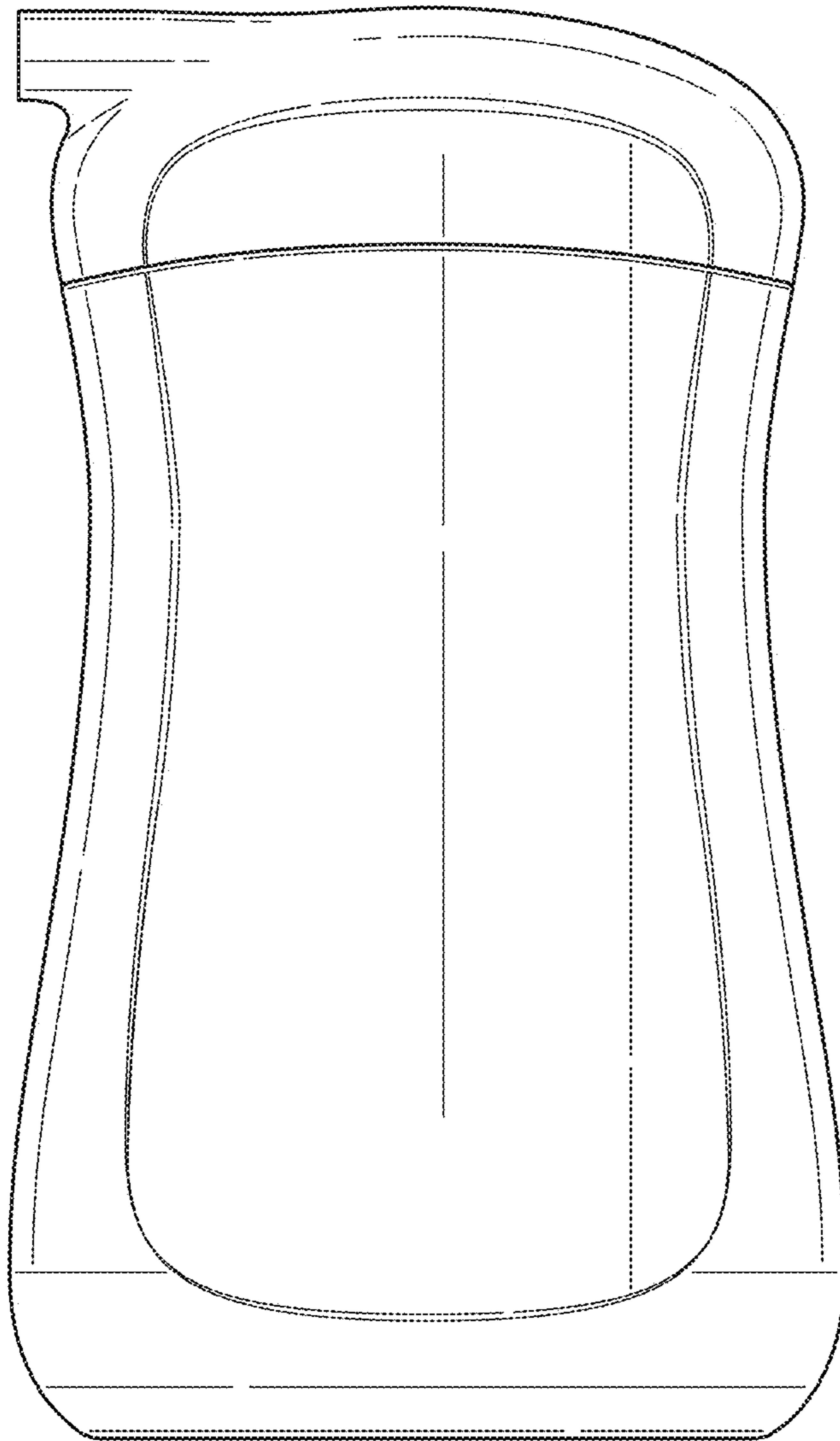

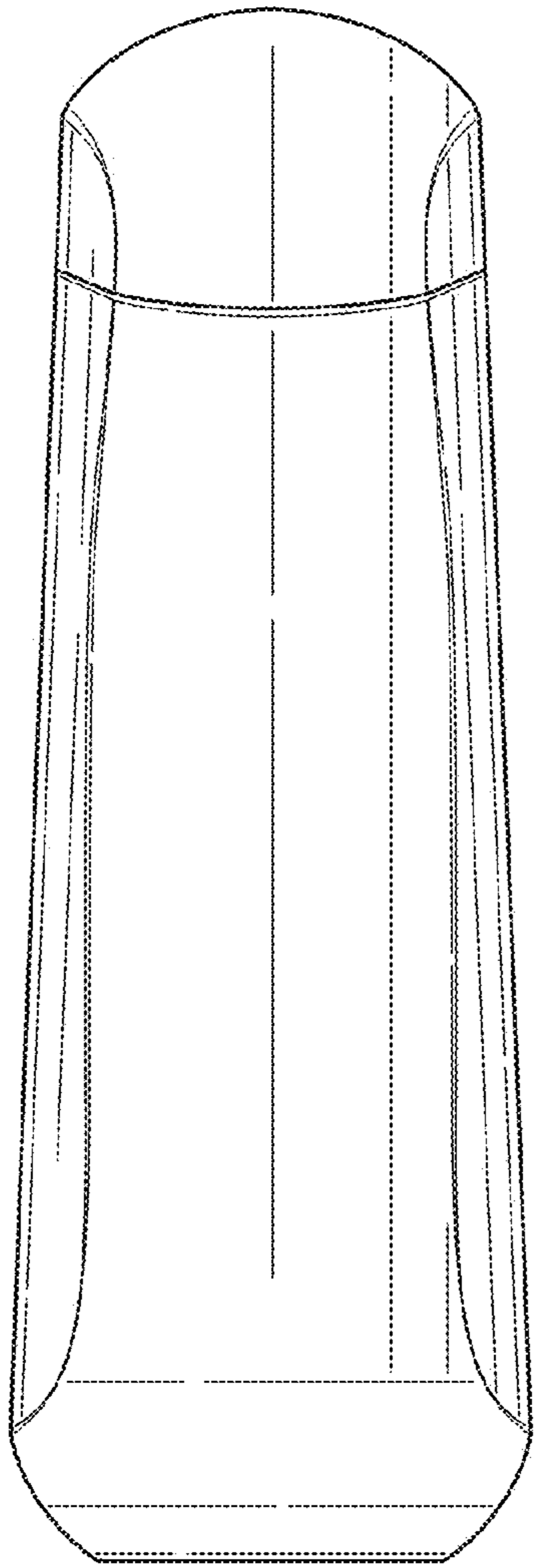

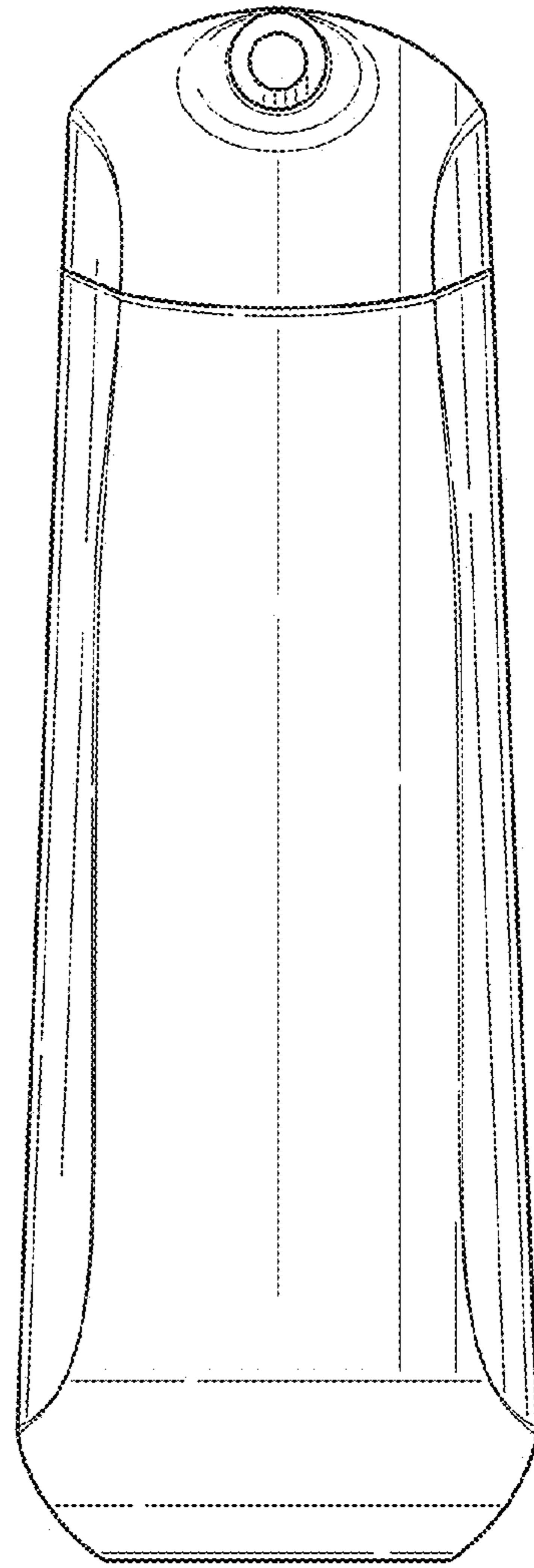

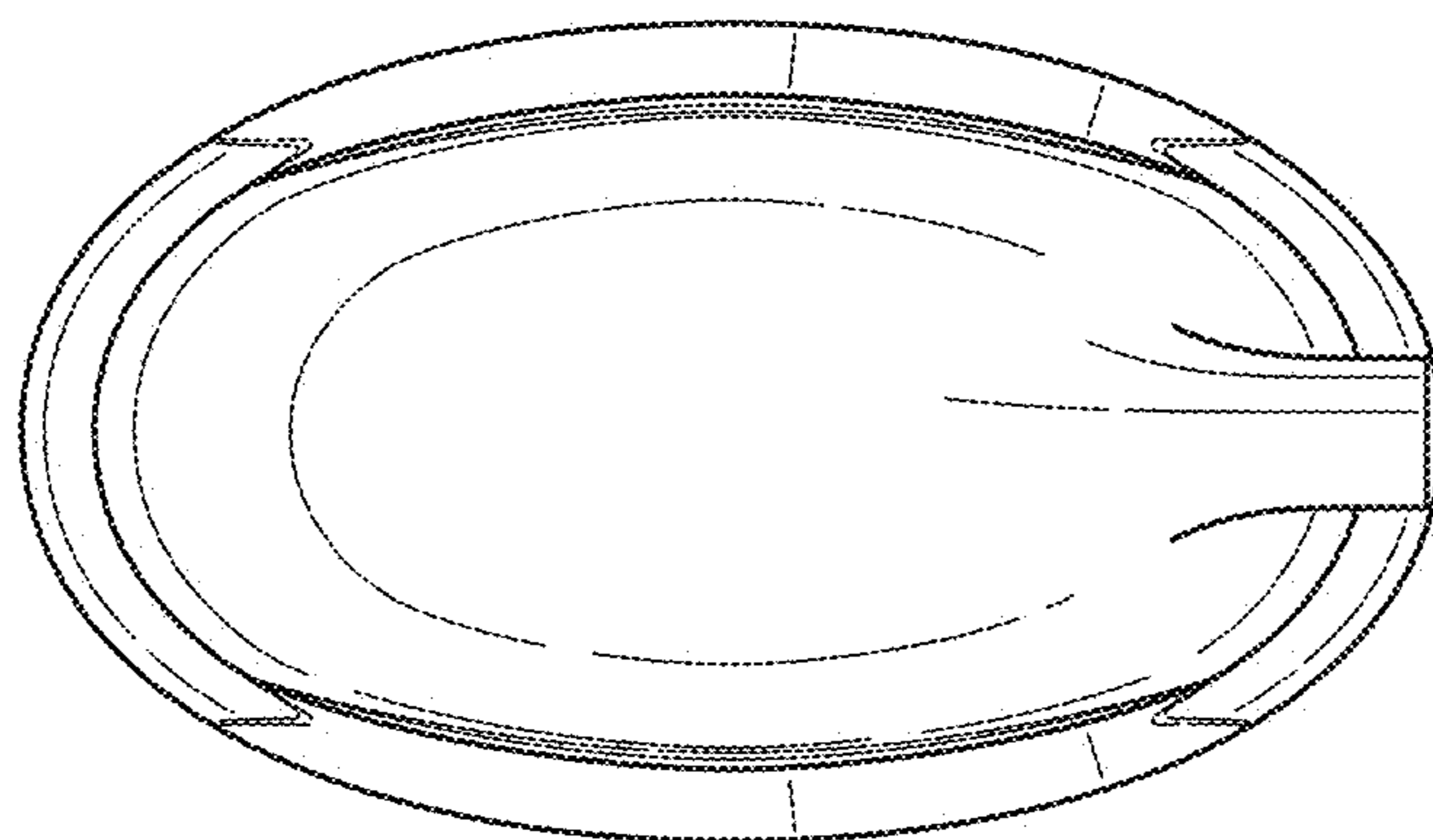

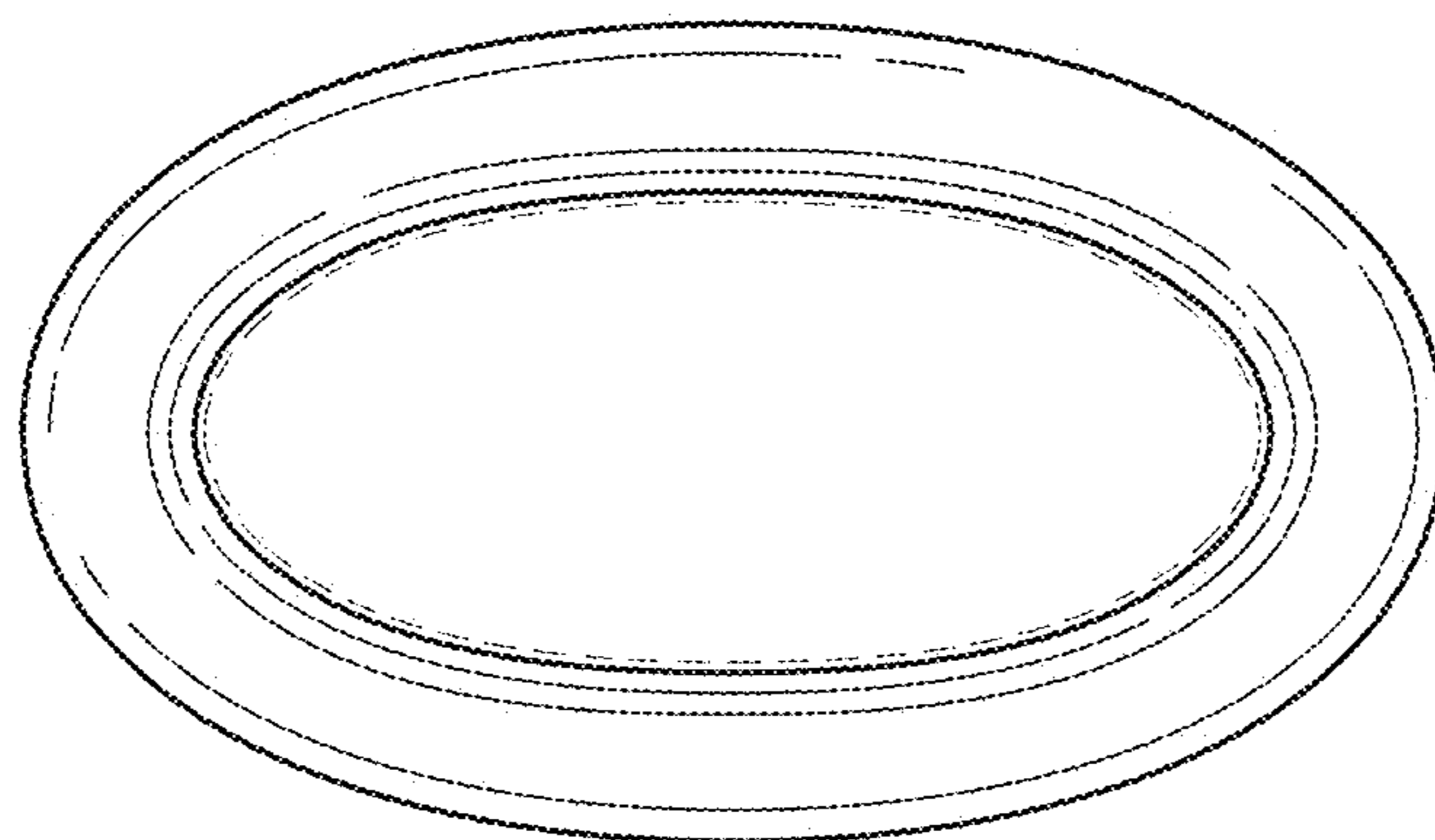
