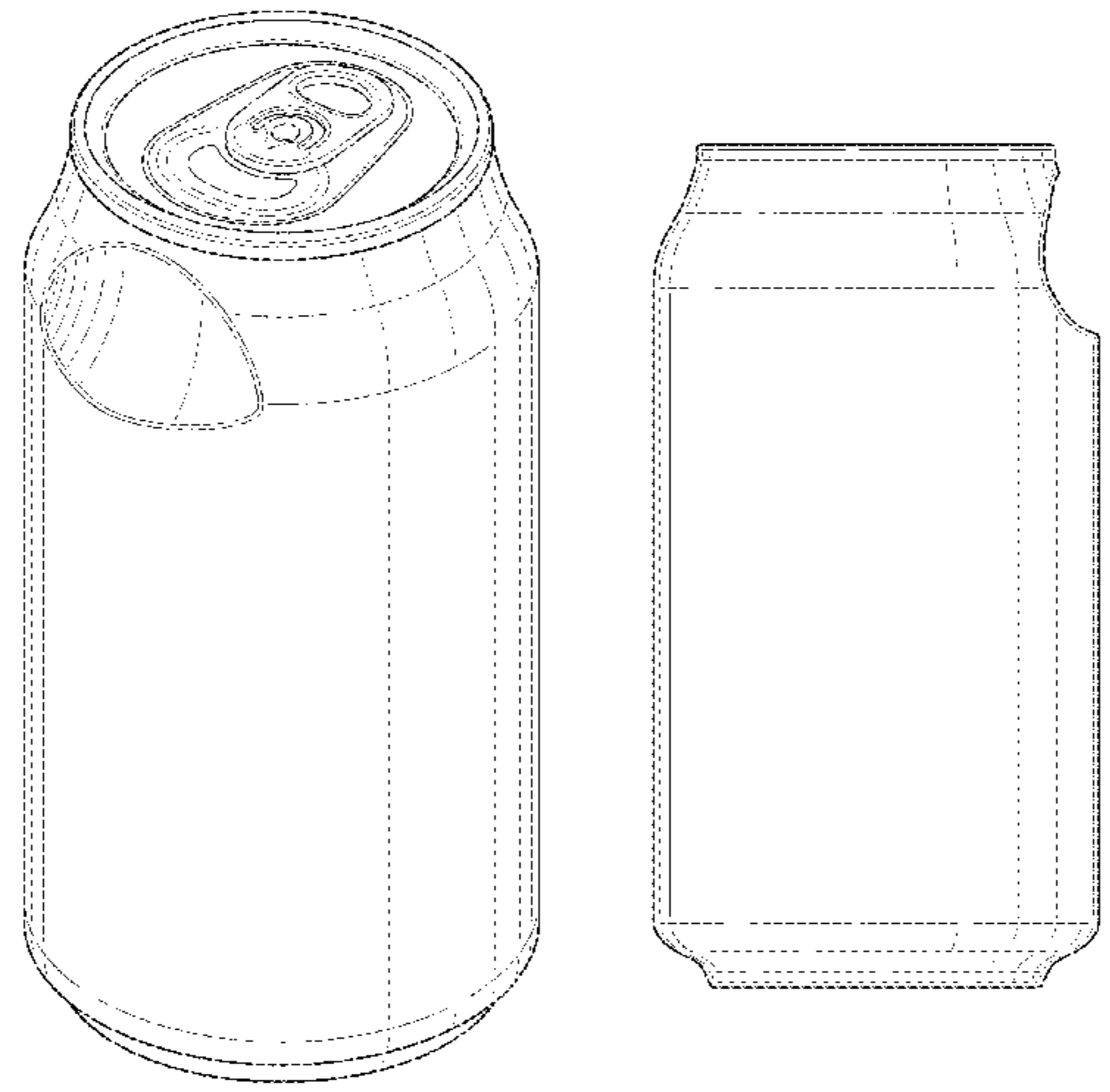

The ornamental design for a drinking can, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a drinking can having the inventive design;
FIG. 2 is a front view of the drinking can shown in FIG. 1;
FIG. 3 is a back view of the drinking can shown in FIG. 1;
FIG. 4 is a right side view of the drinking can shown in FIG. 1;
FIG. 5 is a left side view of the drinking can shown in FIG. 1;
FIG. 6 is a top view of the drinking can shown in FIG. 1; and,
FIG. 7 is a bottom view of the drinking can shown in FIG. 1.
The broken lines in the drawings are for the purpose of illustrating portions of the drinking can that form no part of the claimed design.

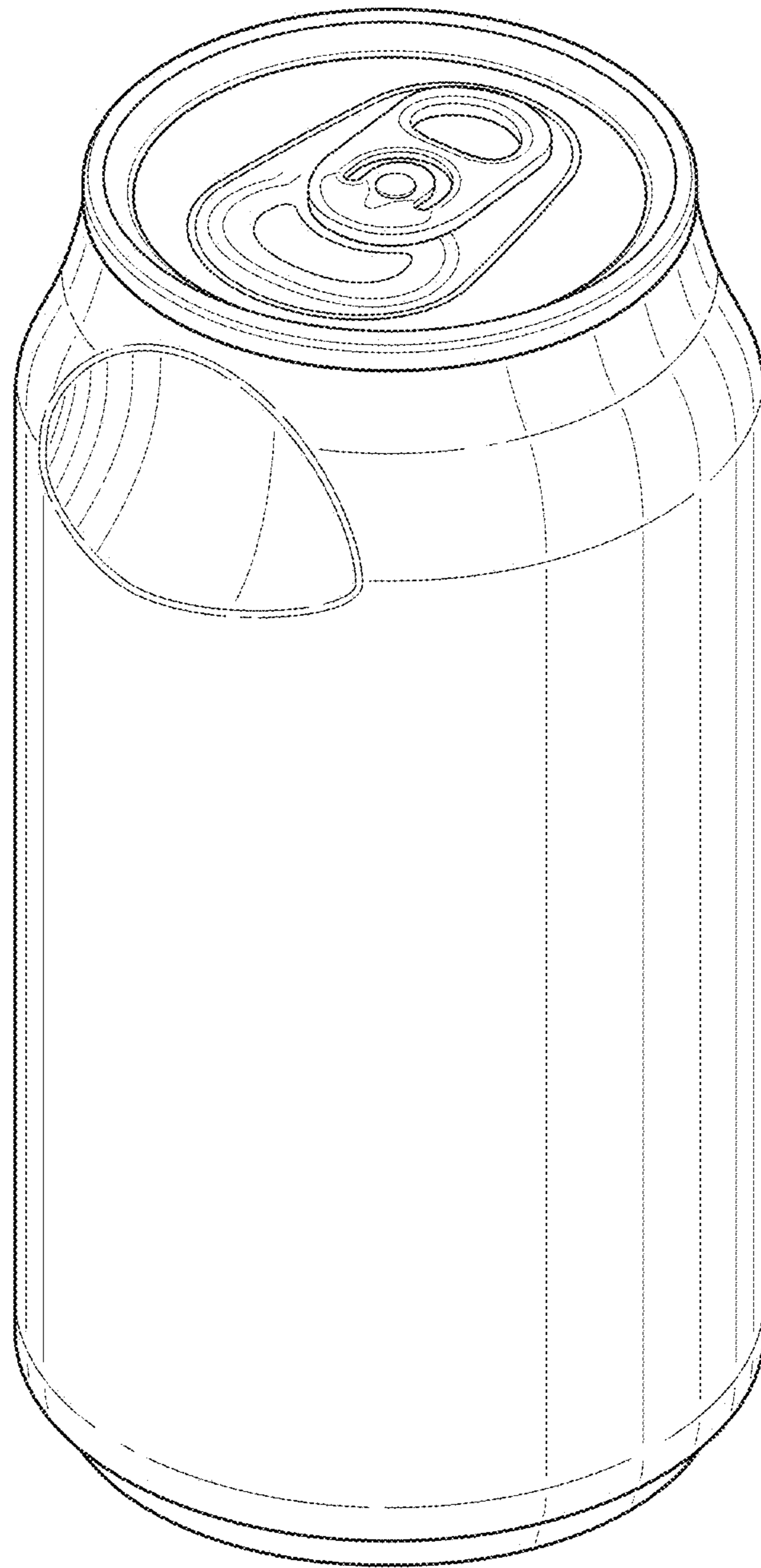

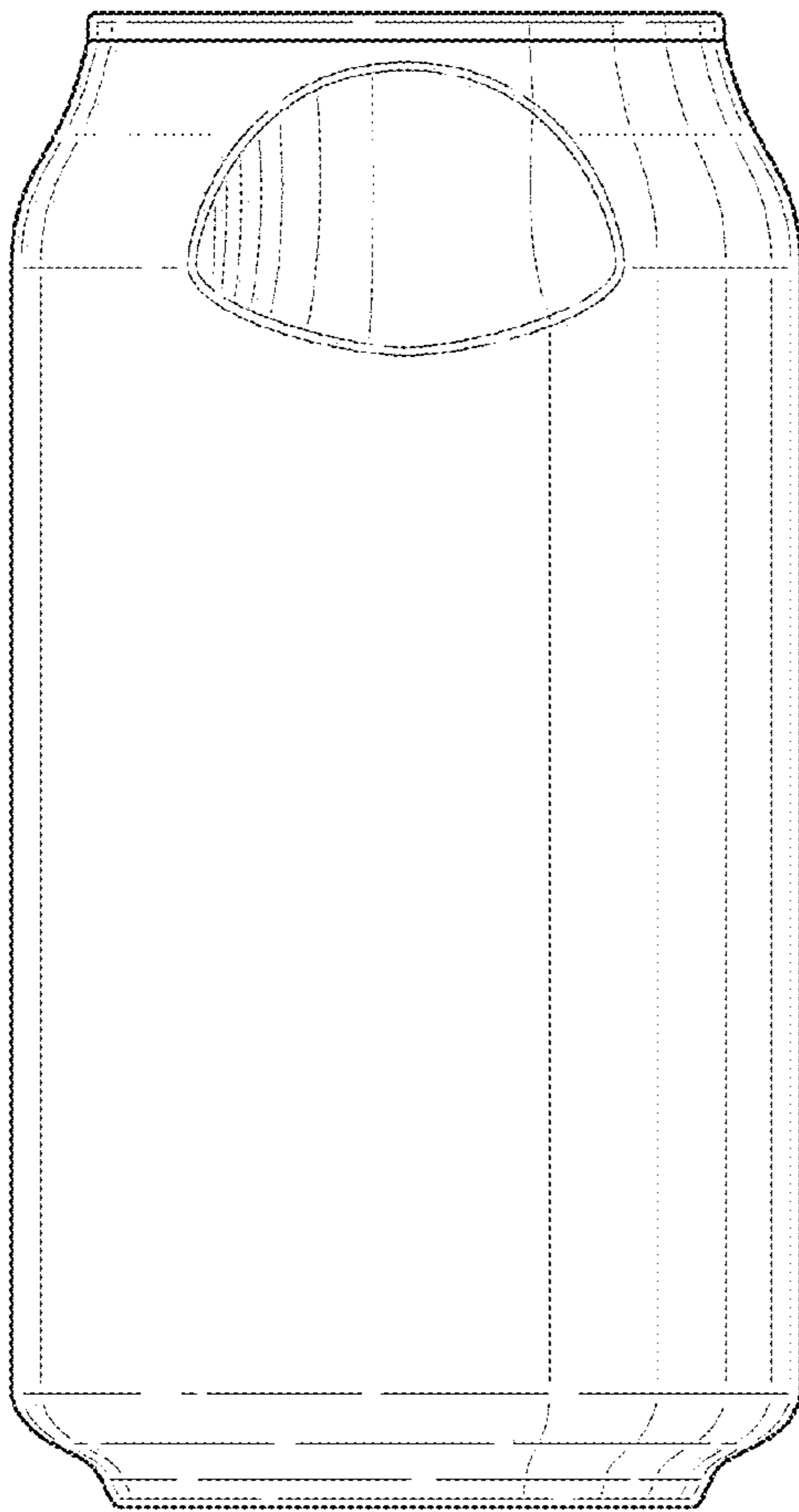

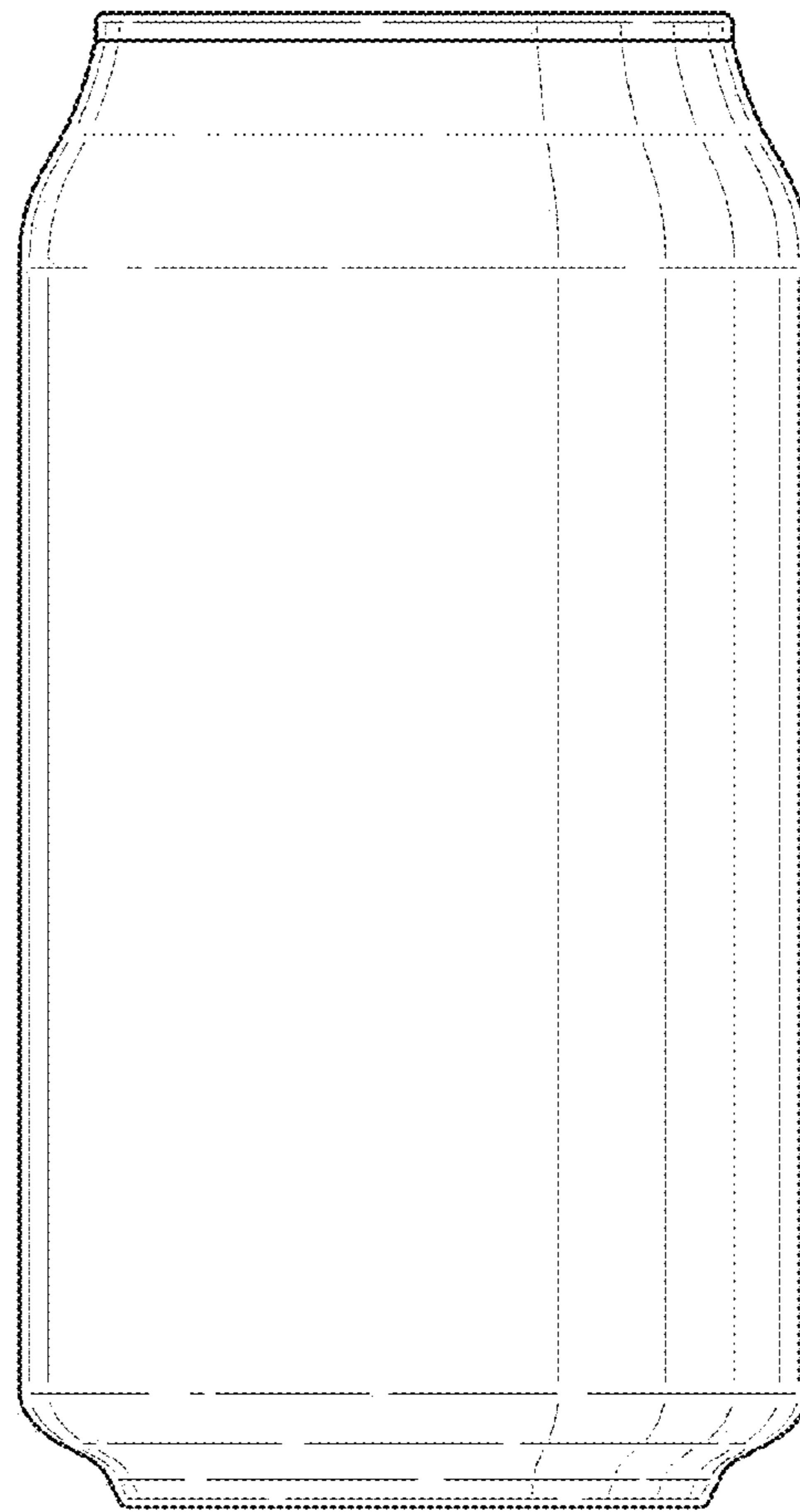

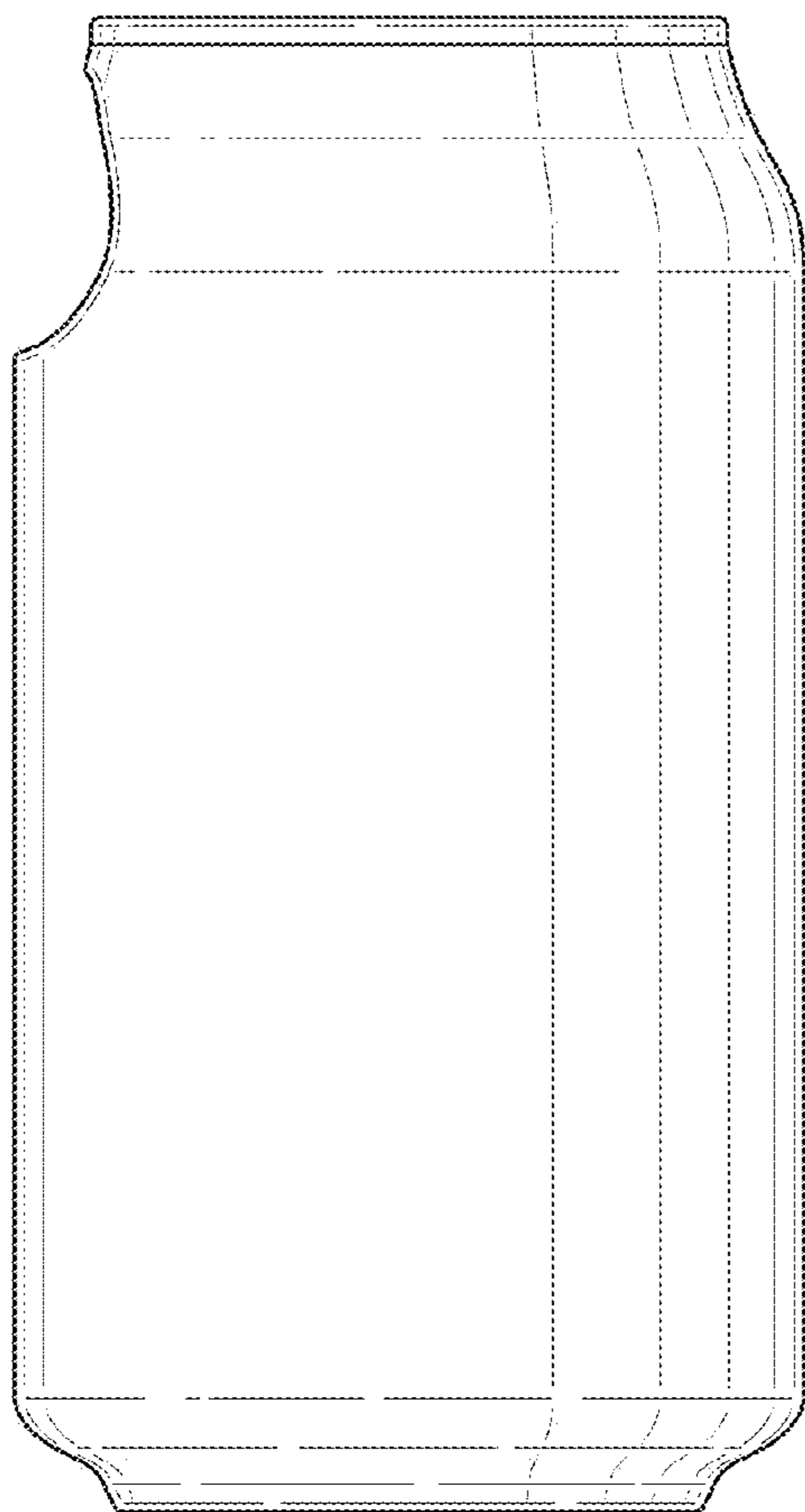

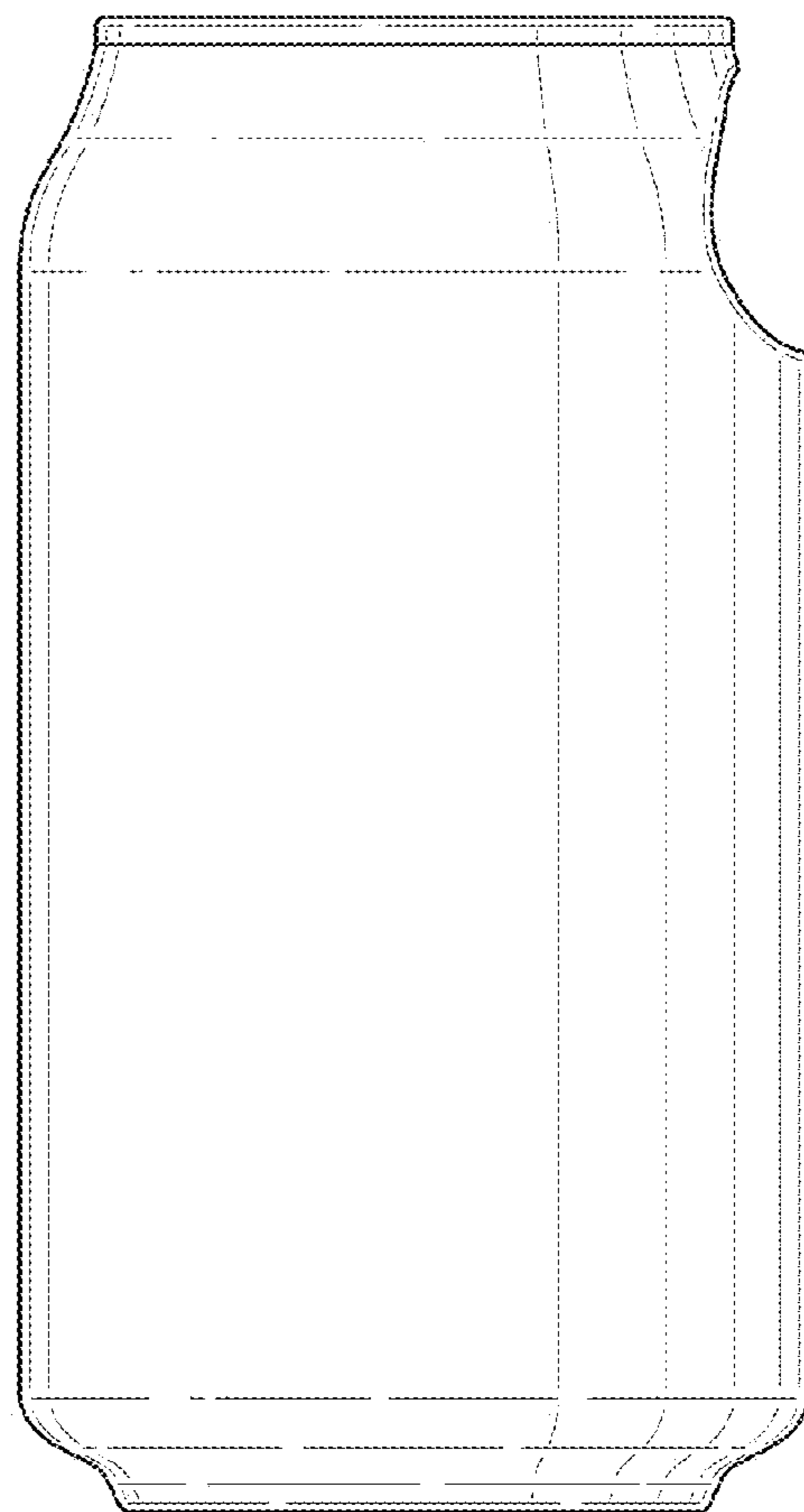

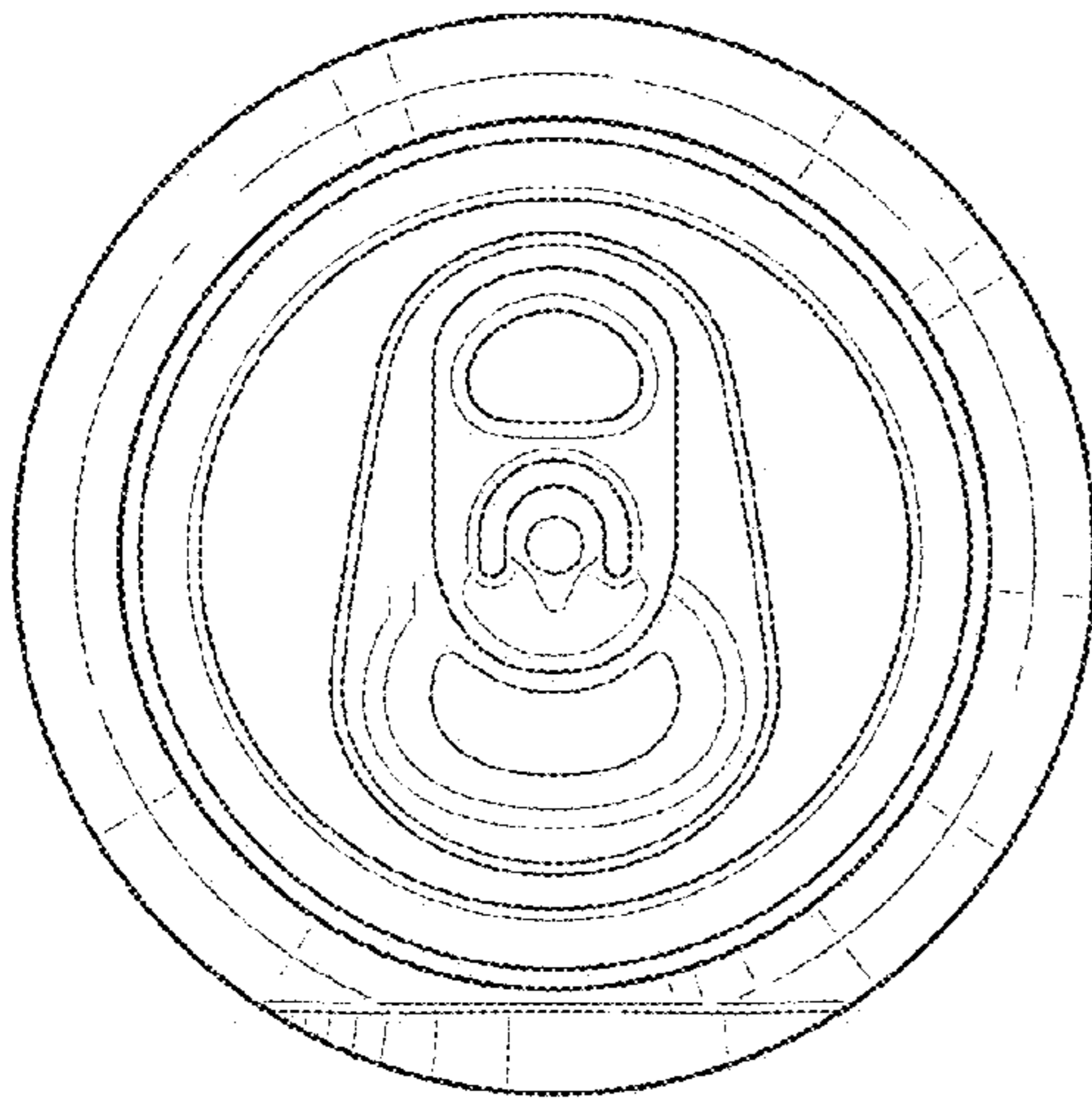

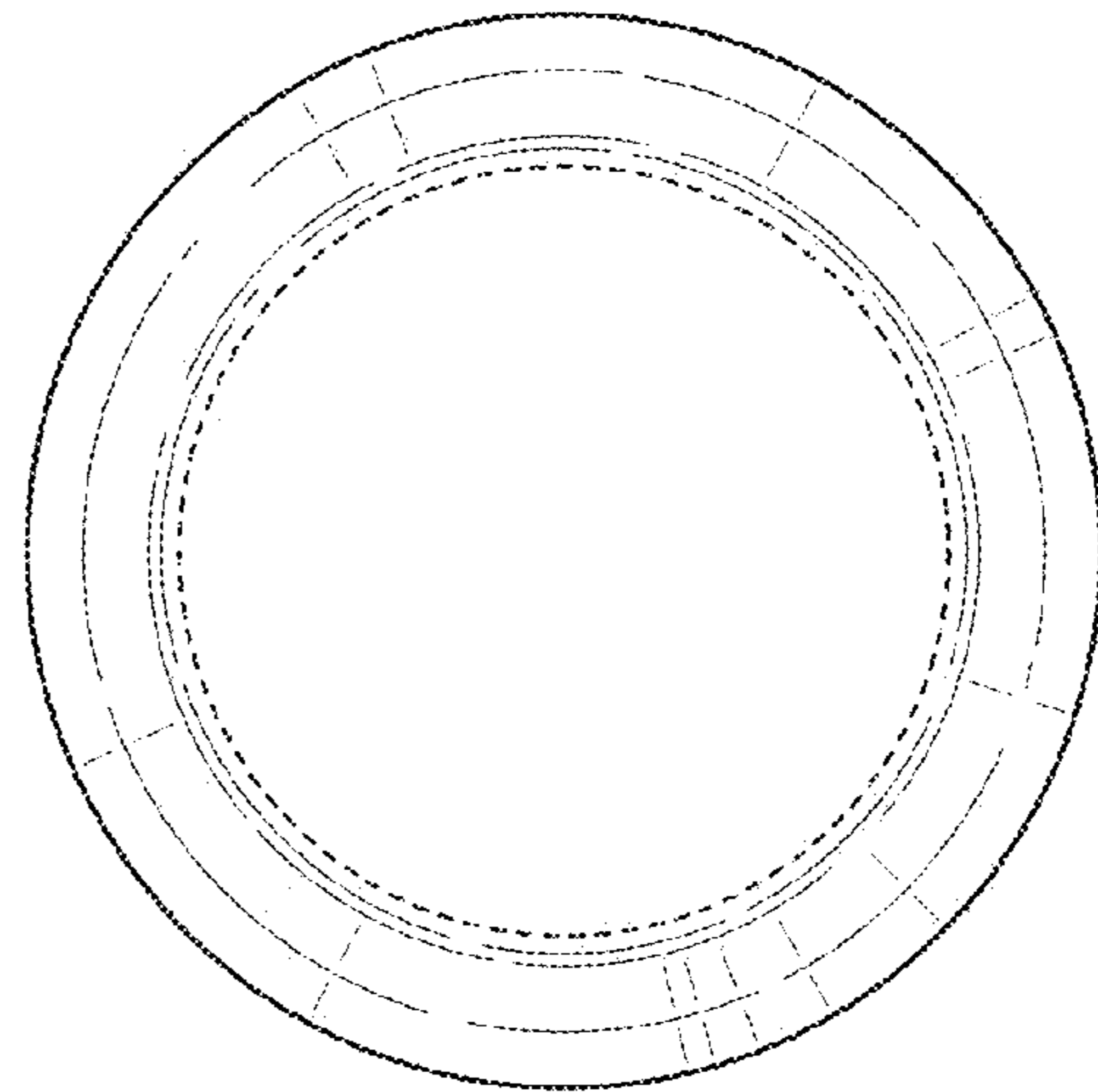
