The elements shown in broken lines form no part of the claimed design.

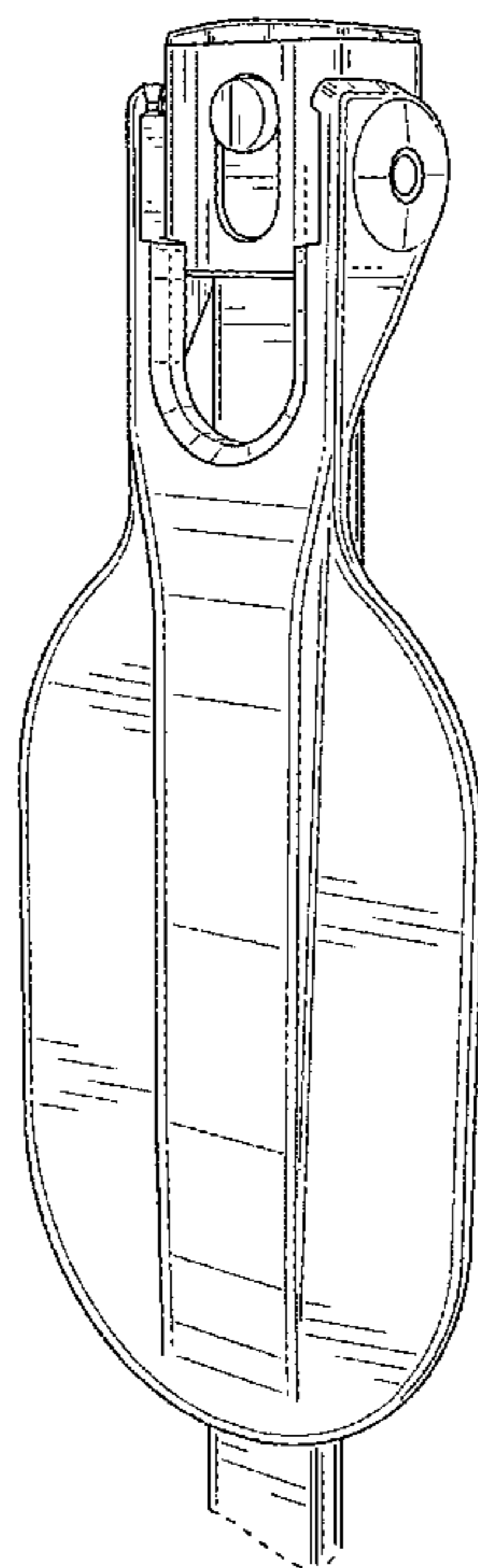
The article is shown with a symbolic break in its length. The appearance of any portion of the article shown below the break lines forms no part of the claimed design.

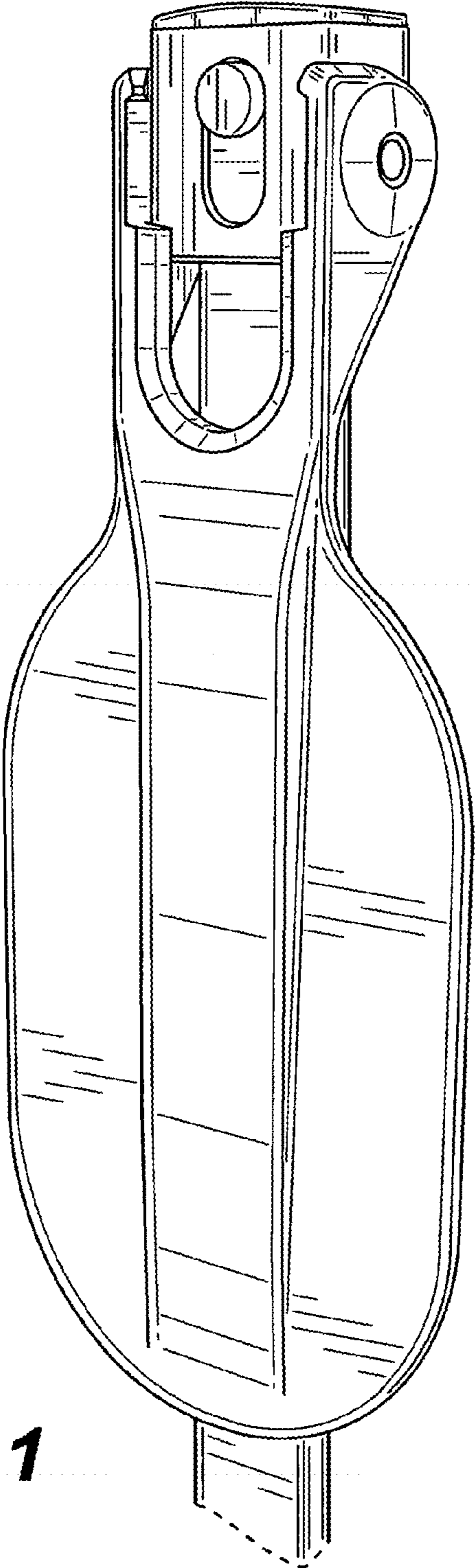

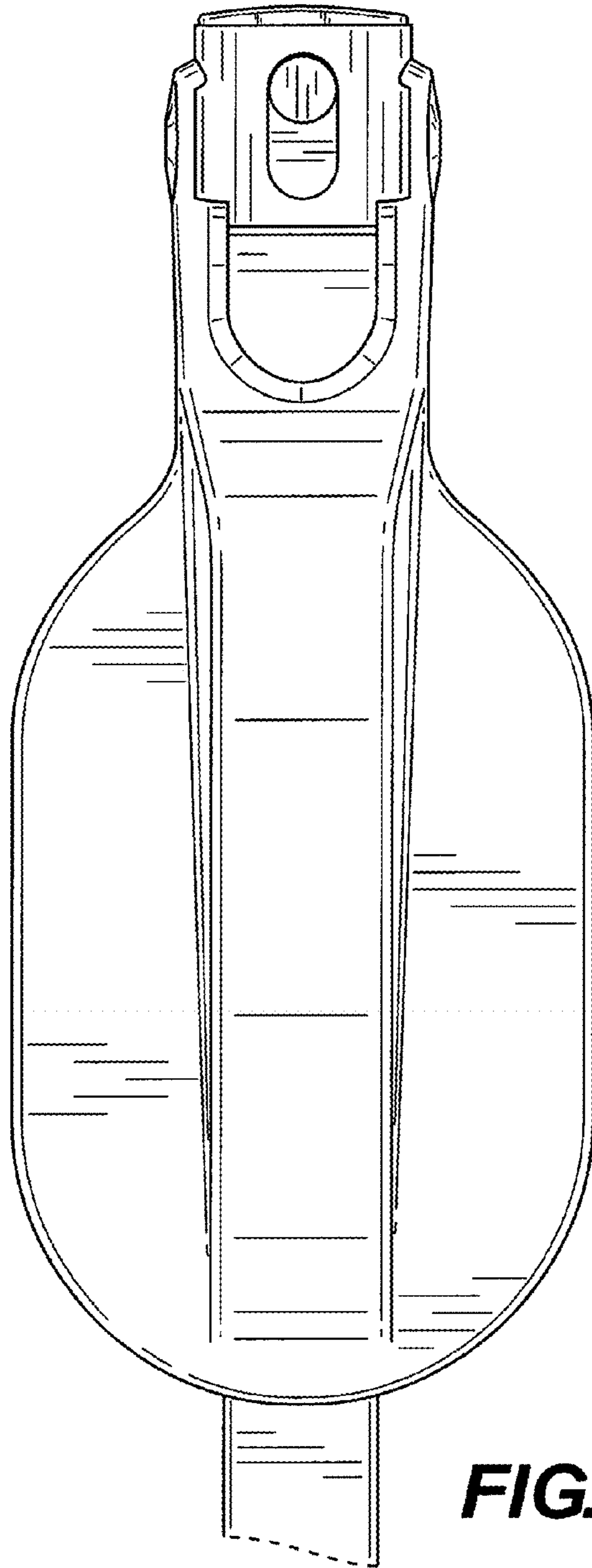

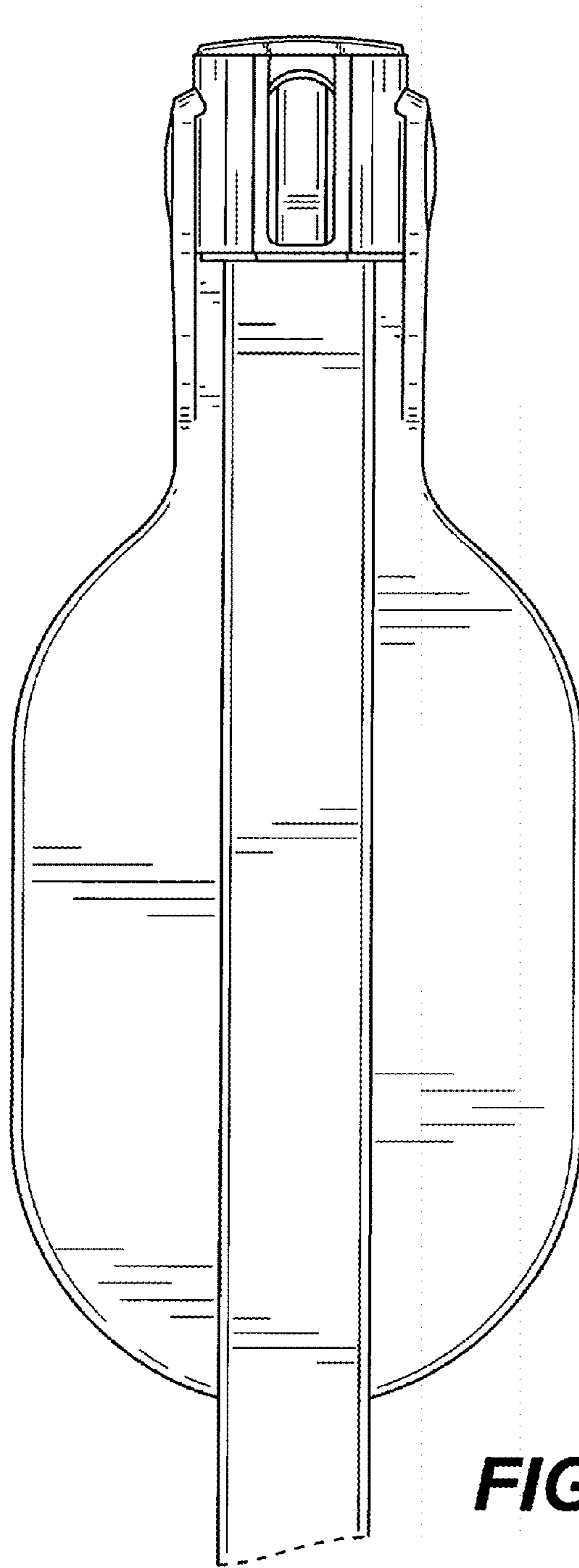

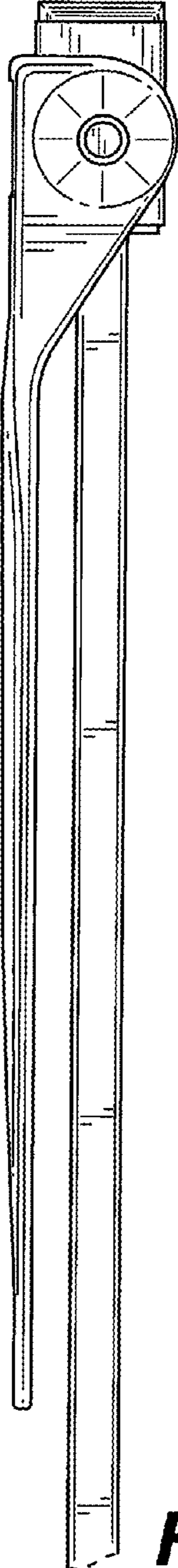

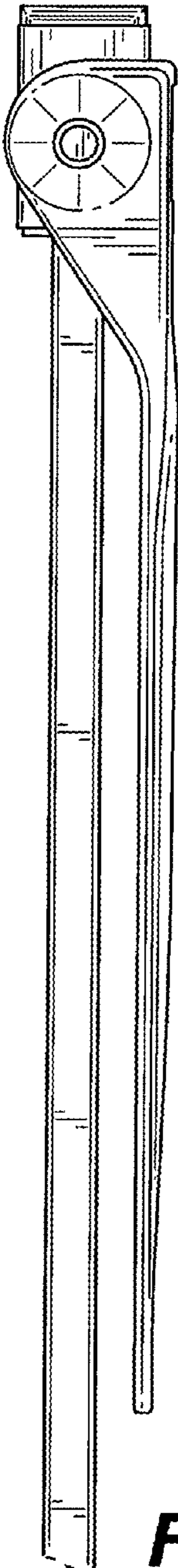

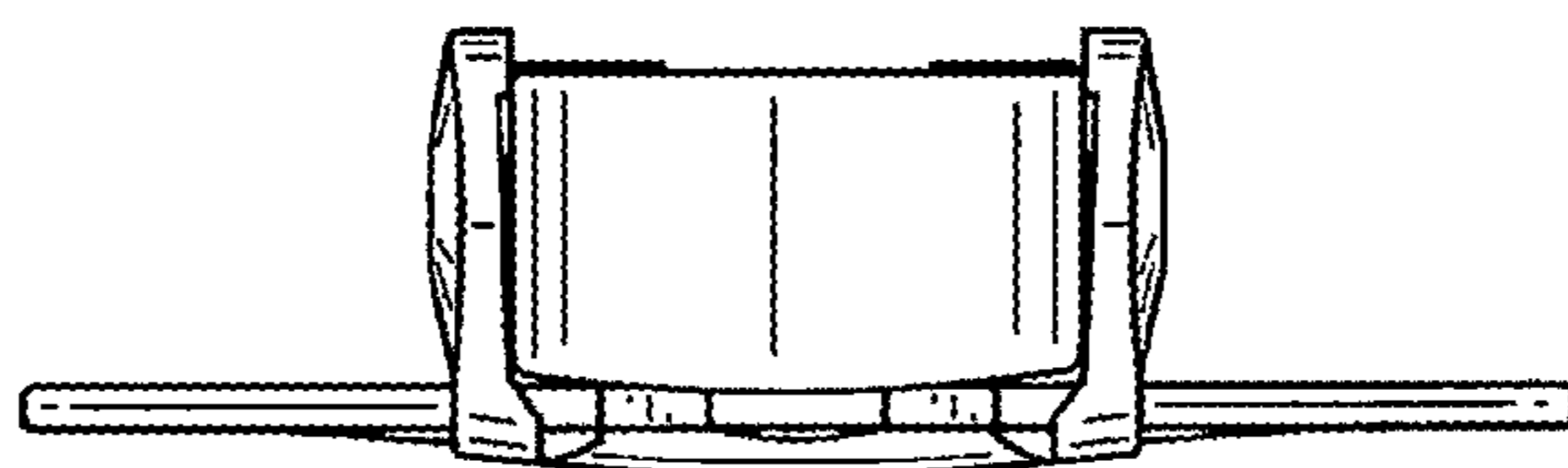

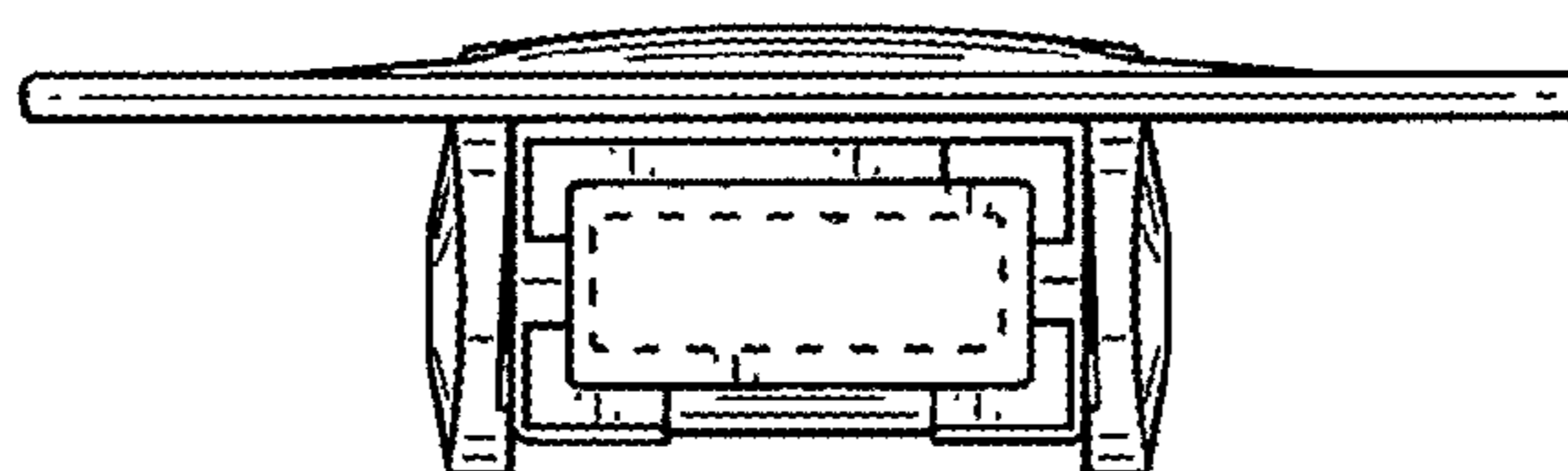

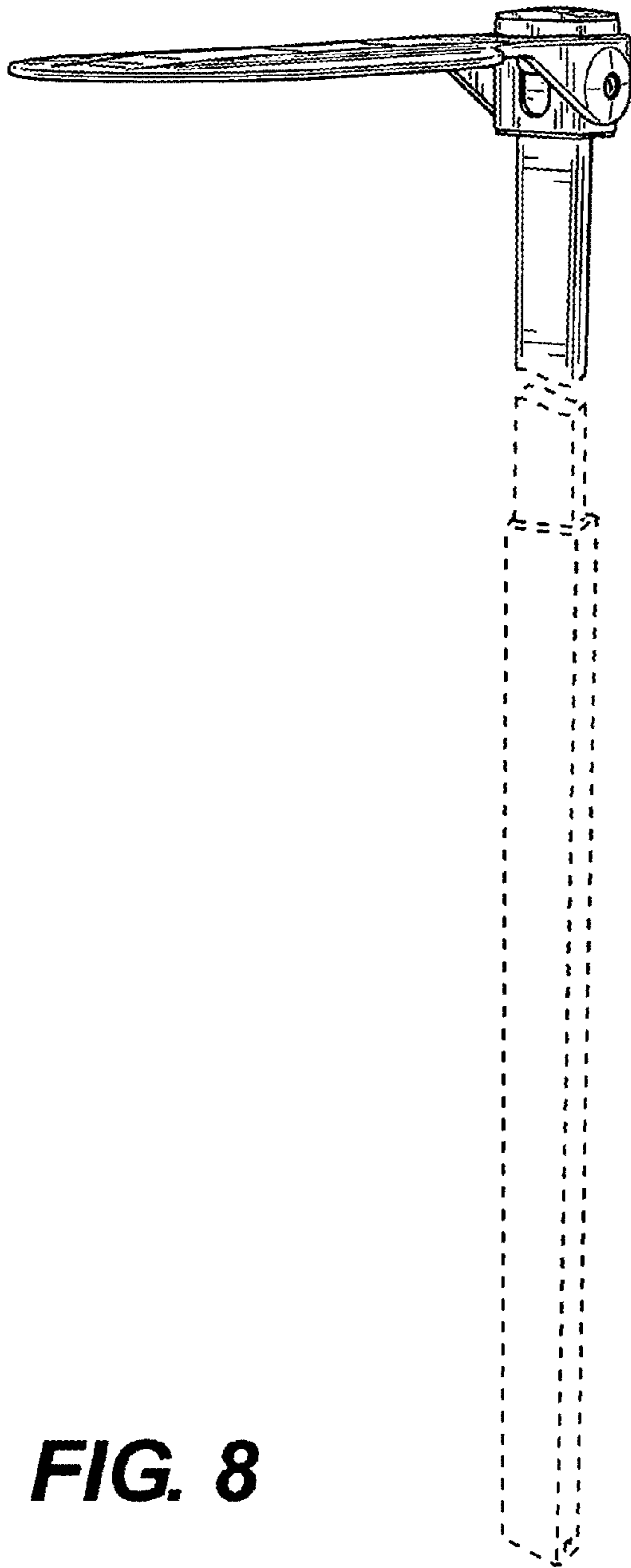

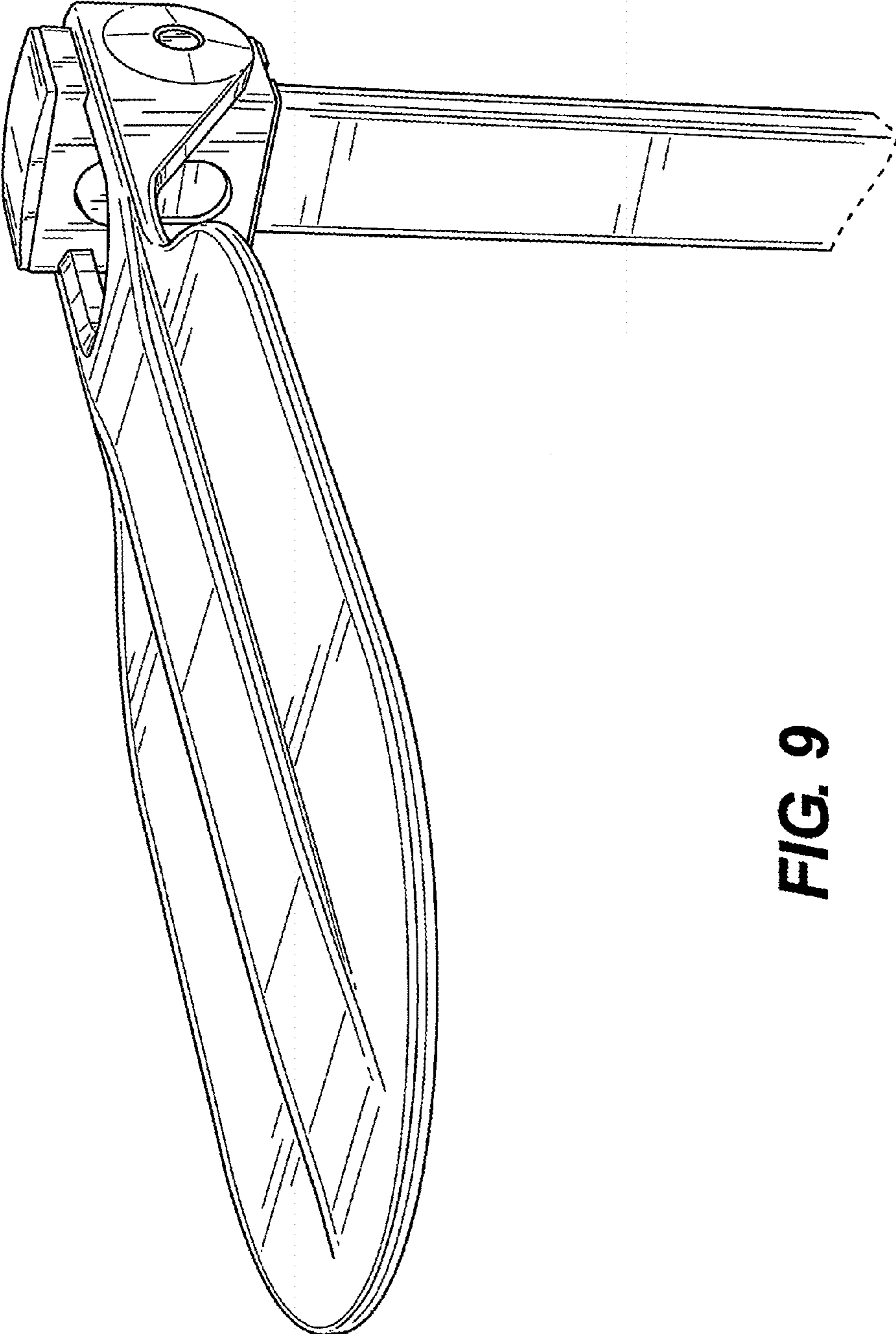
