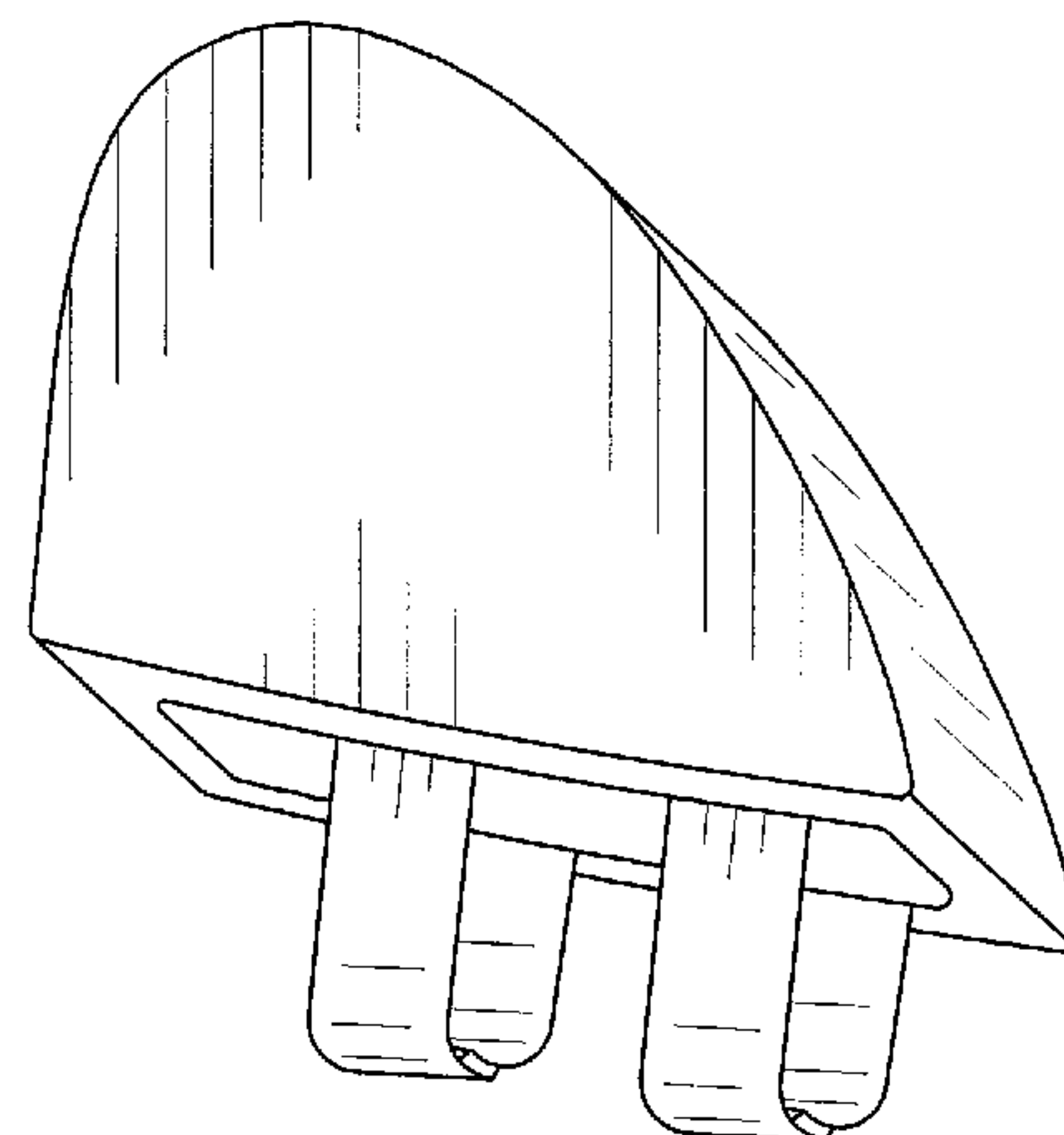
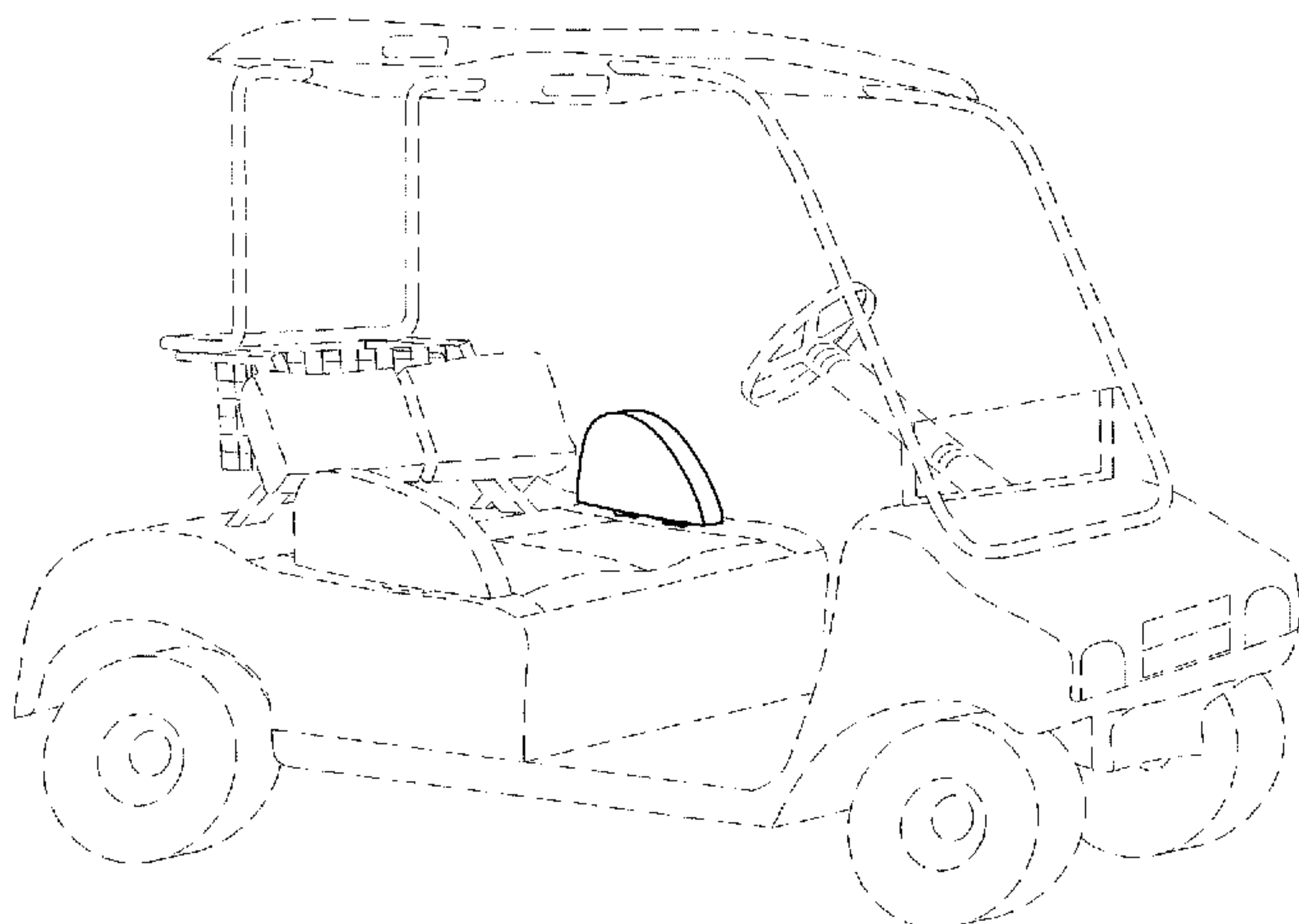
(57) **CLAIM**

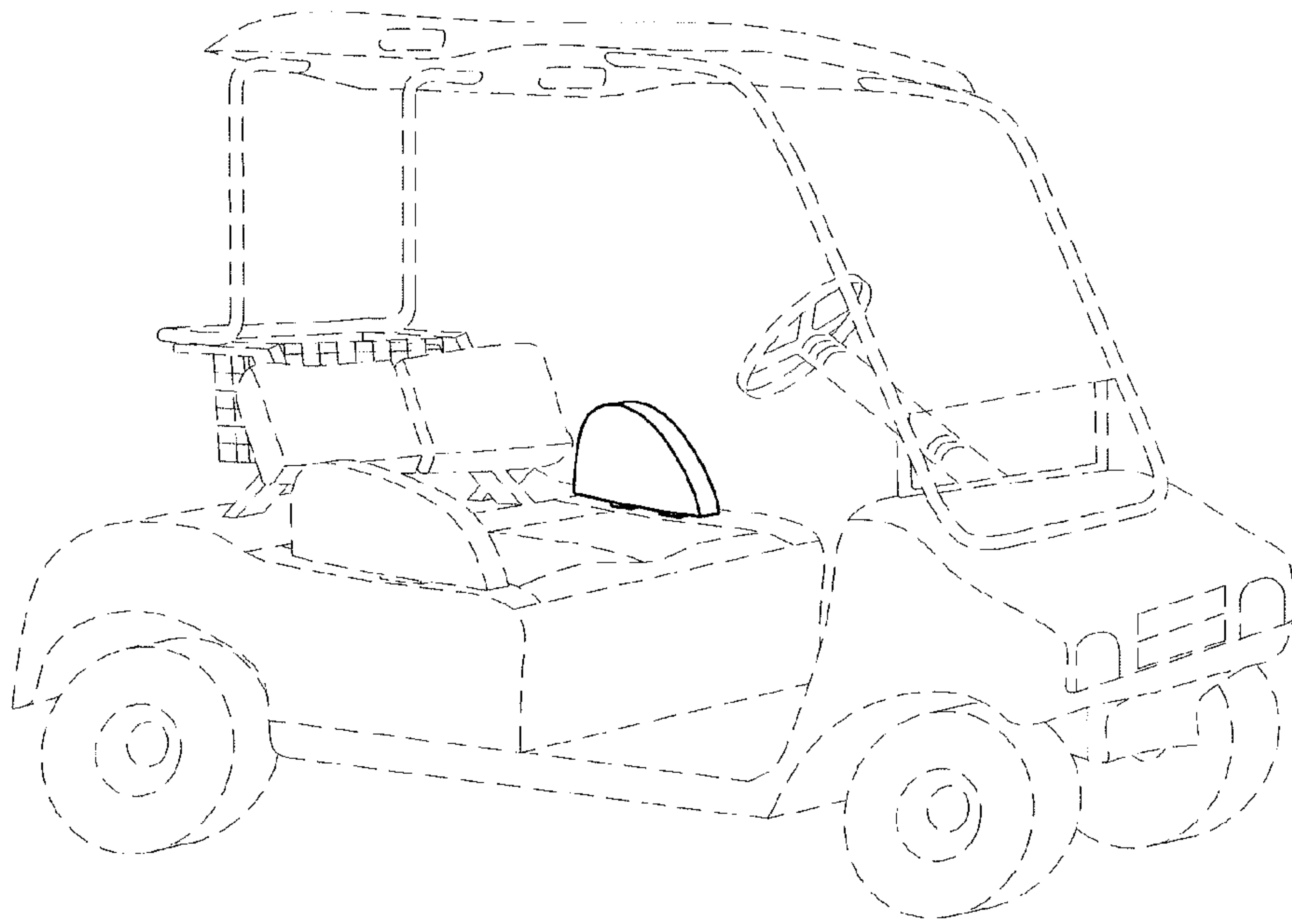
The ornamental design for a padded protective sleeve for hip restraints on golf and other transportation carts, as shown and described.

**DESCRIPTION**

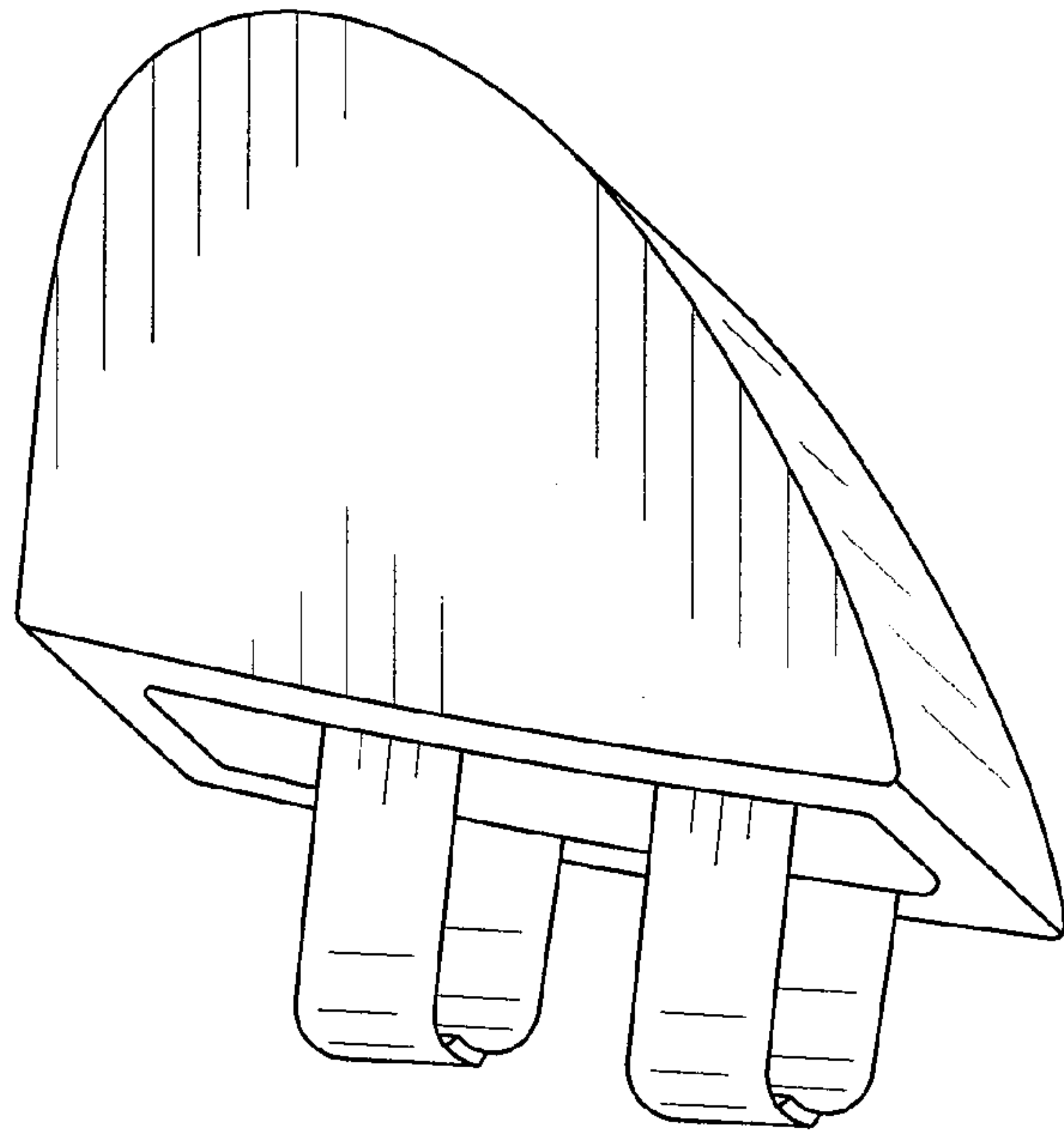

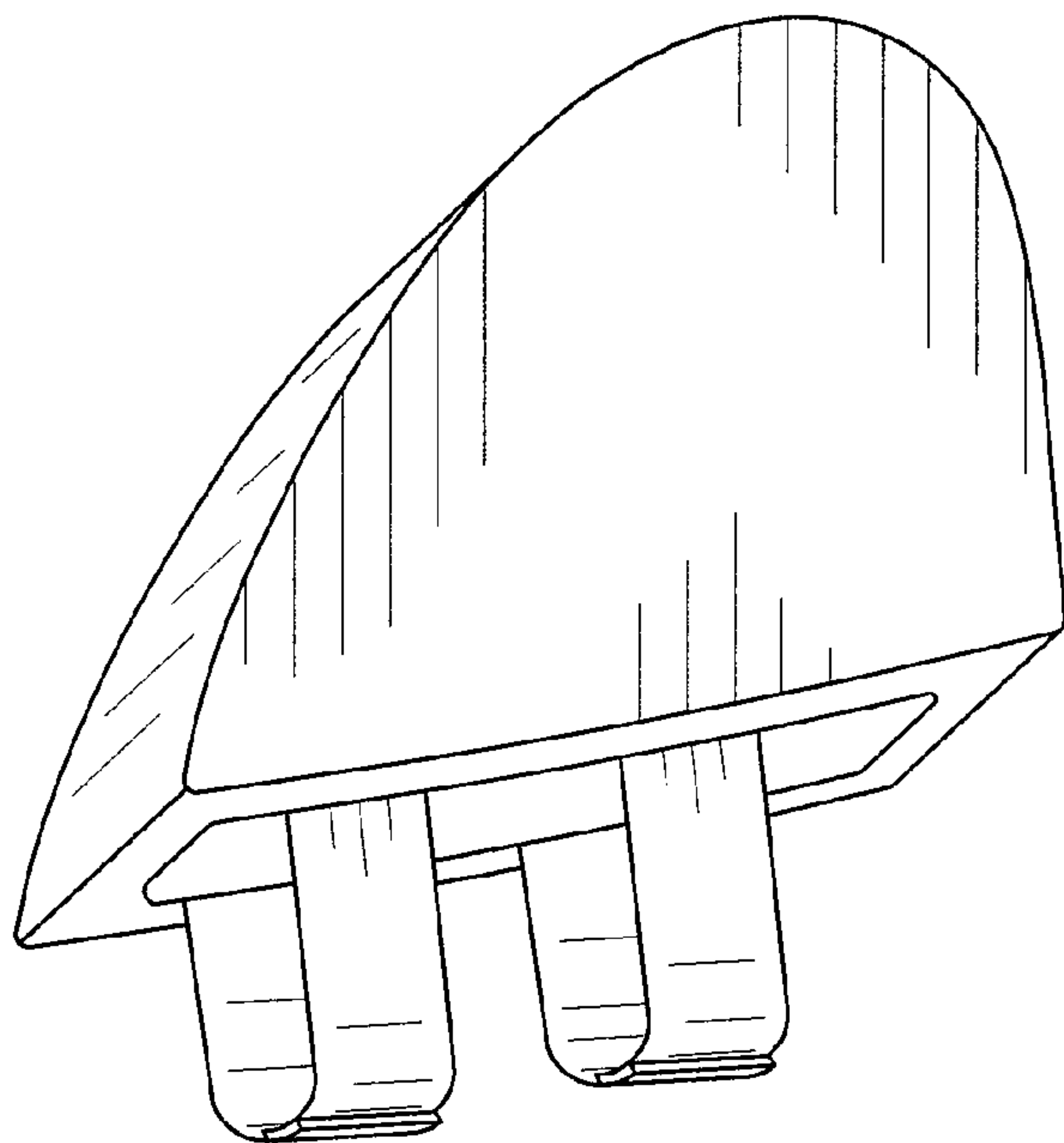




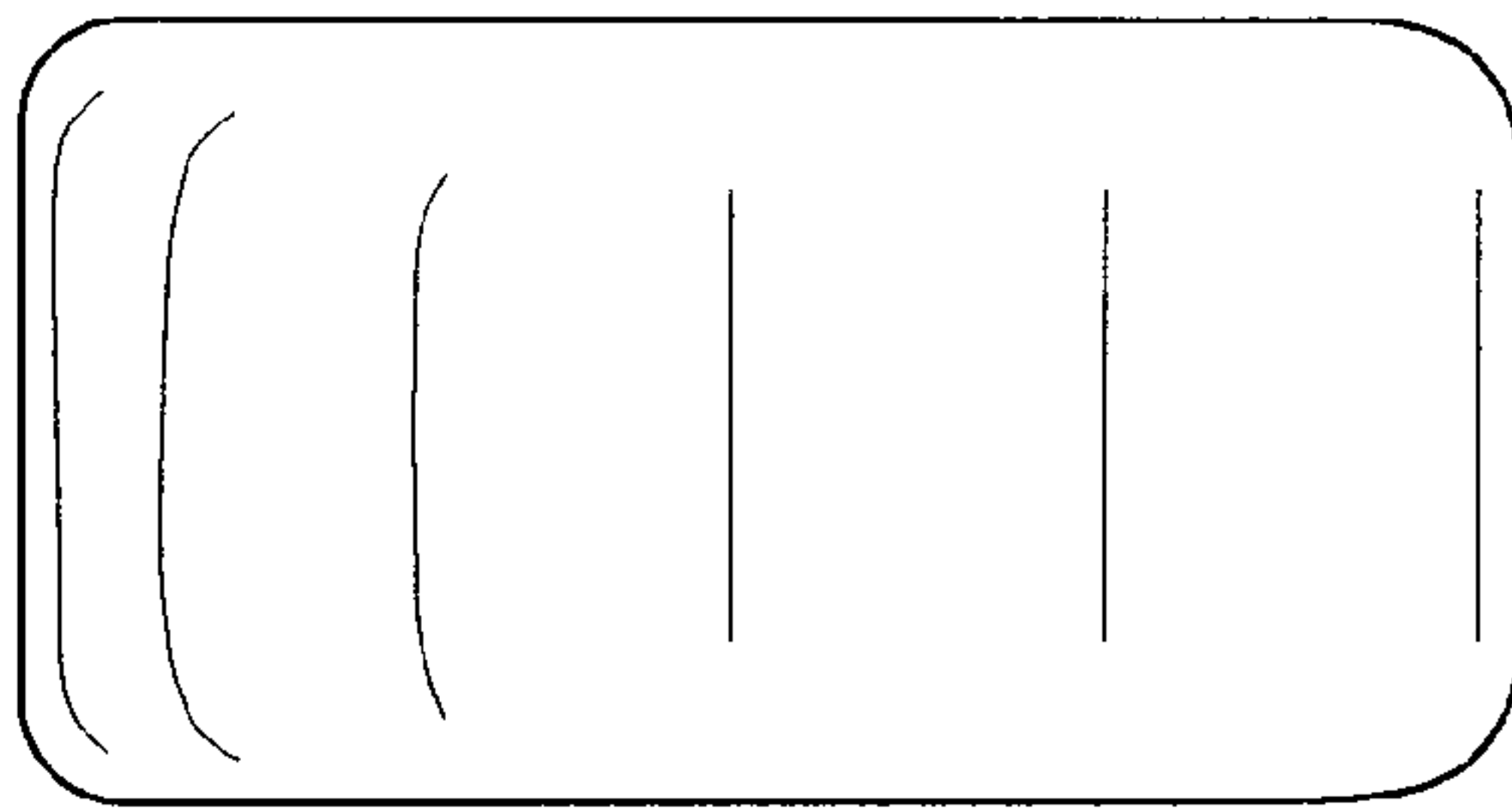

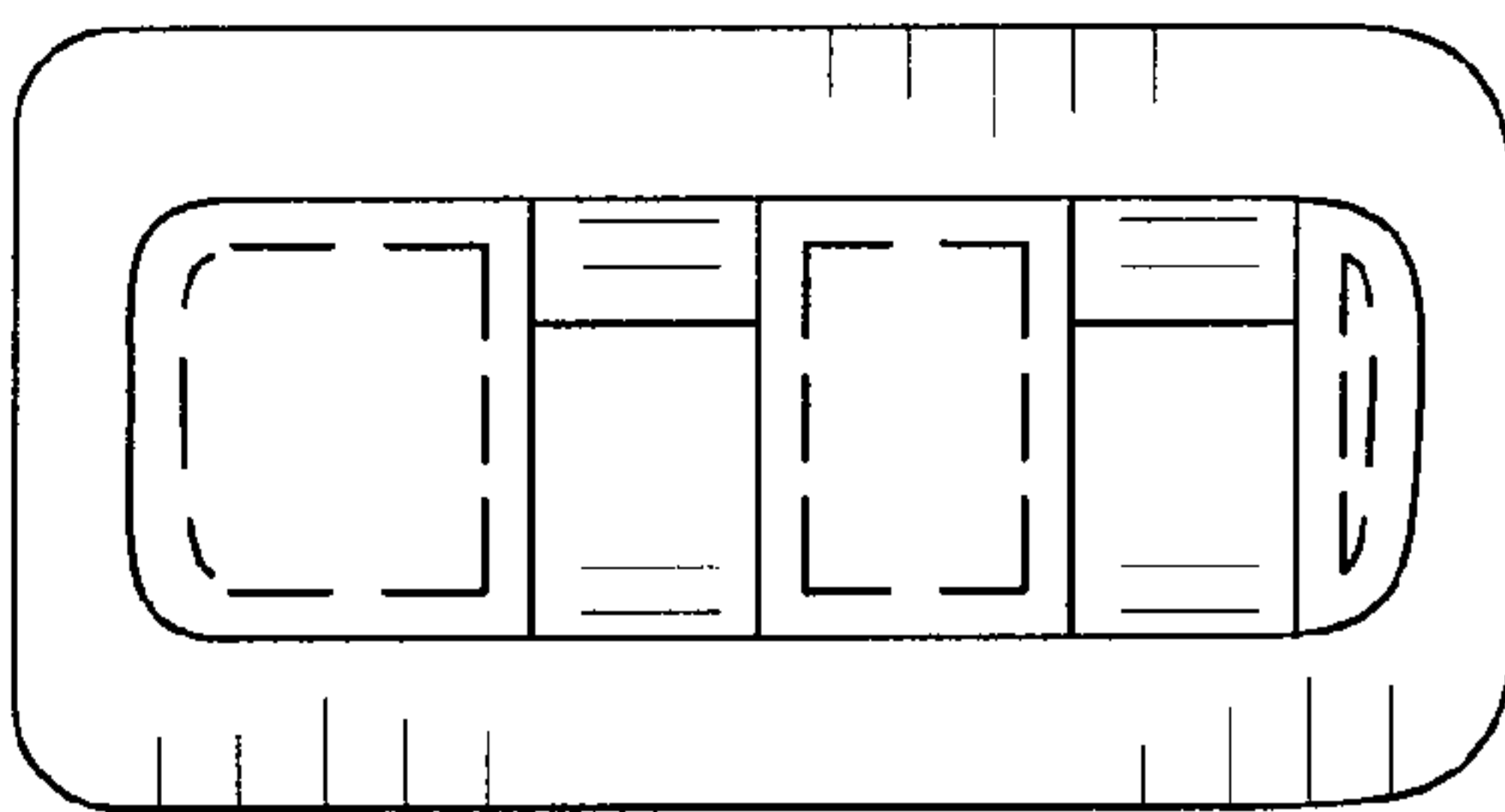

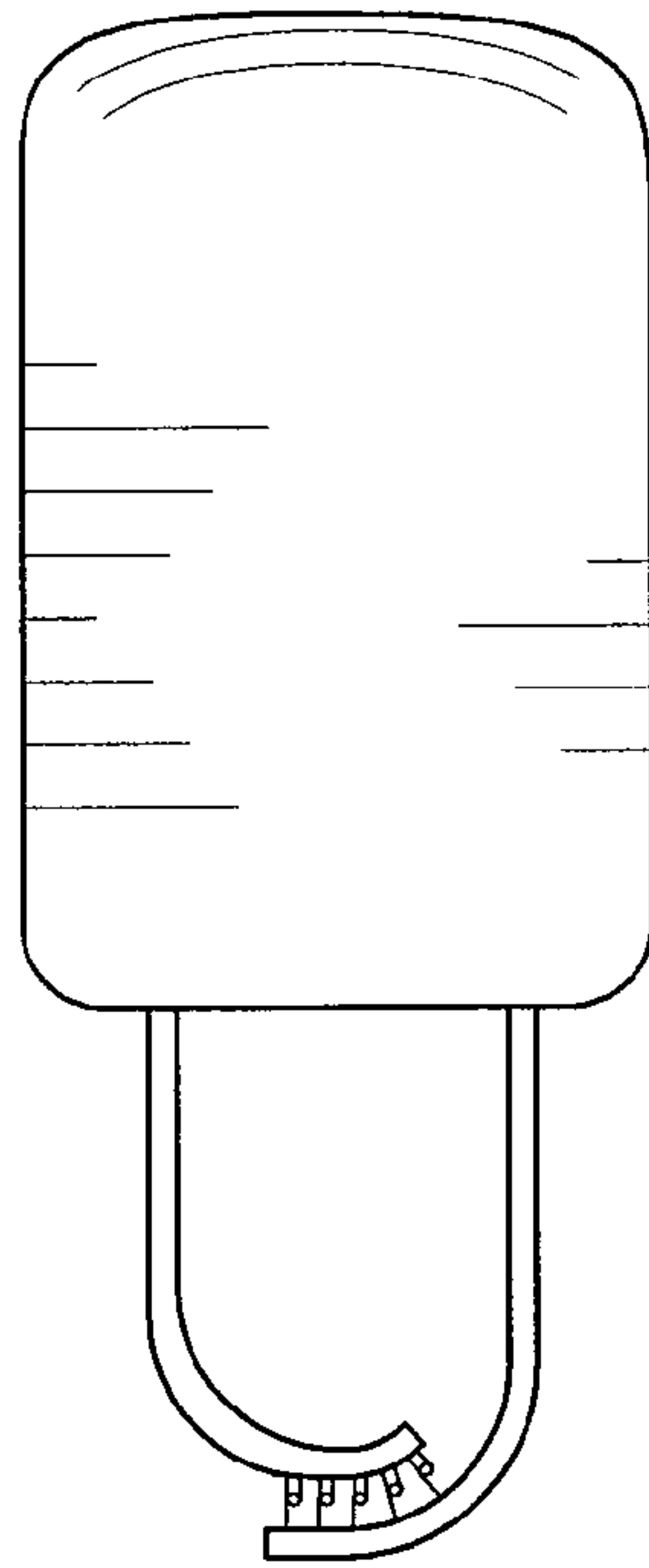

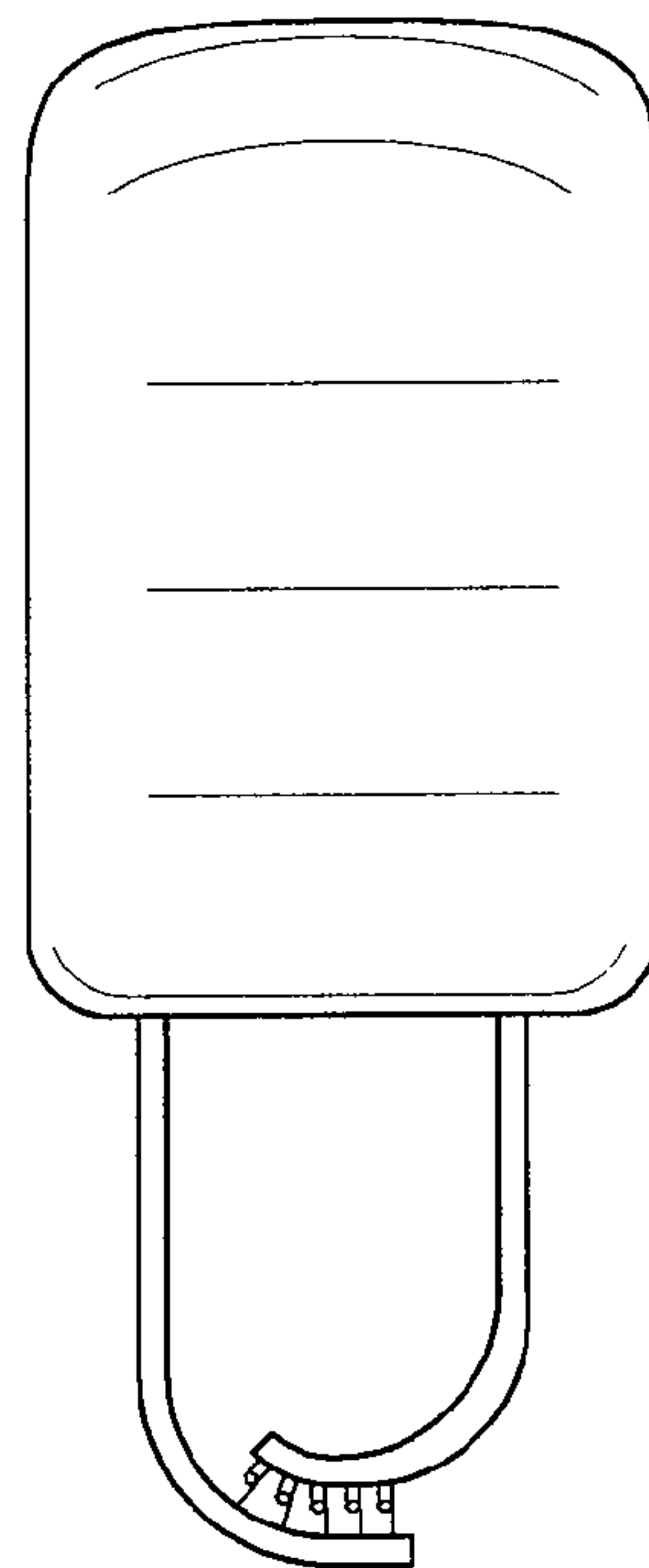
