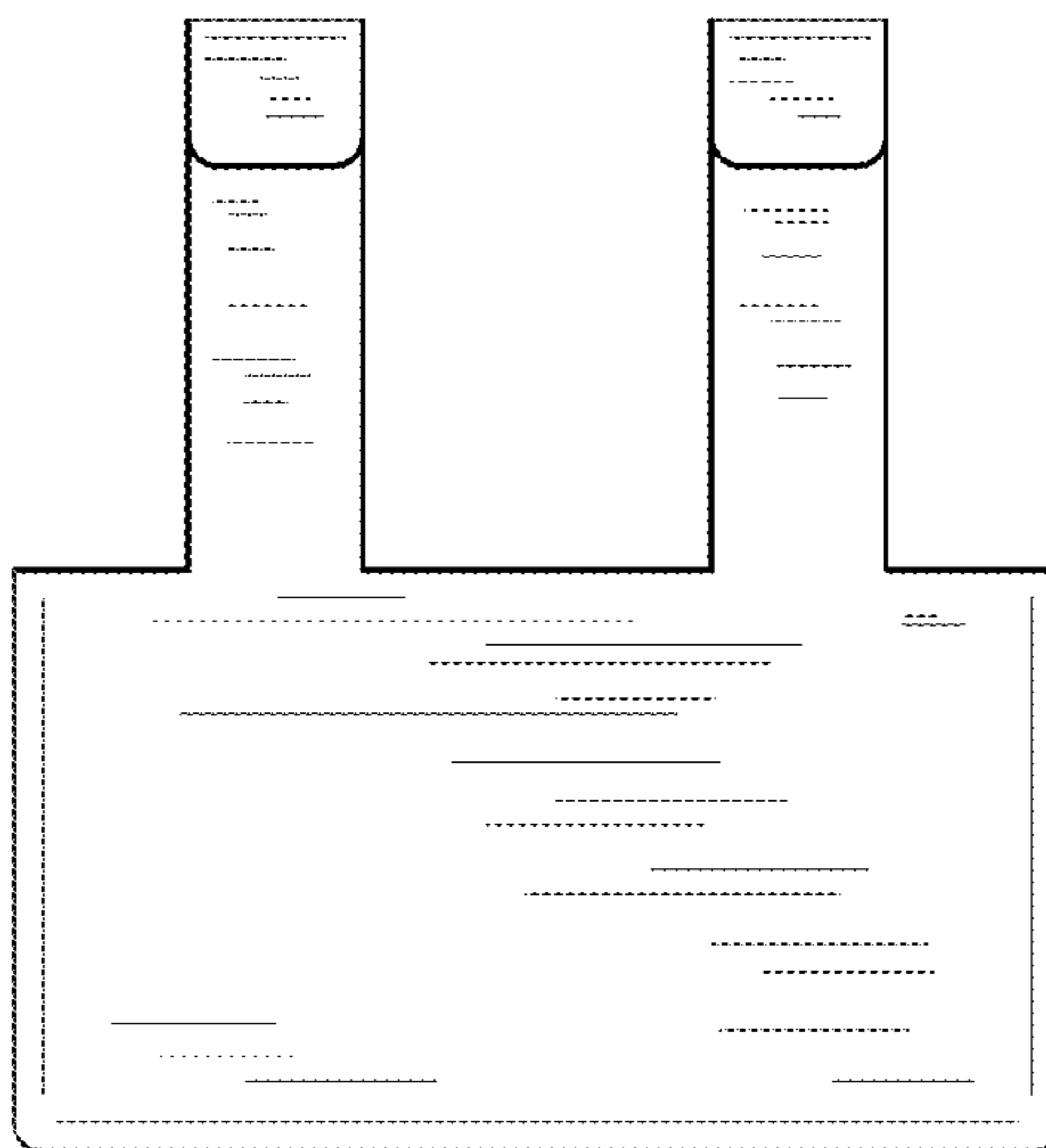
(57) **CLAIM**

The ornamental design for an item holder for use with an air conditioning system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the item holder for use with an air conditioning system in full lines.
FIG. 2 is a rear elevational view thereof.
FIG. 3 is a front elevational view thereof.
FIG. 4 is a top plan view thereof.
FIG. 5 is a bottom plan view thereof.
FIG. 6 is a right side elevational view thereof.
FIG. 7 is a left side elevational view thereof; and,
FIG. 8 is an alternate perspective view thereof shown with environment.

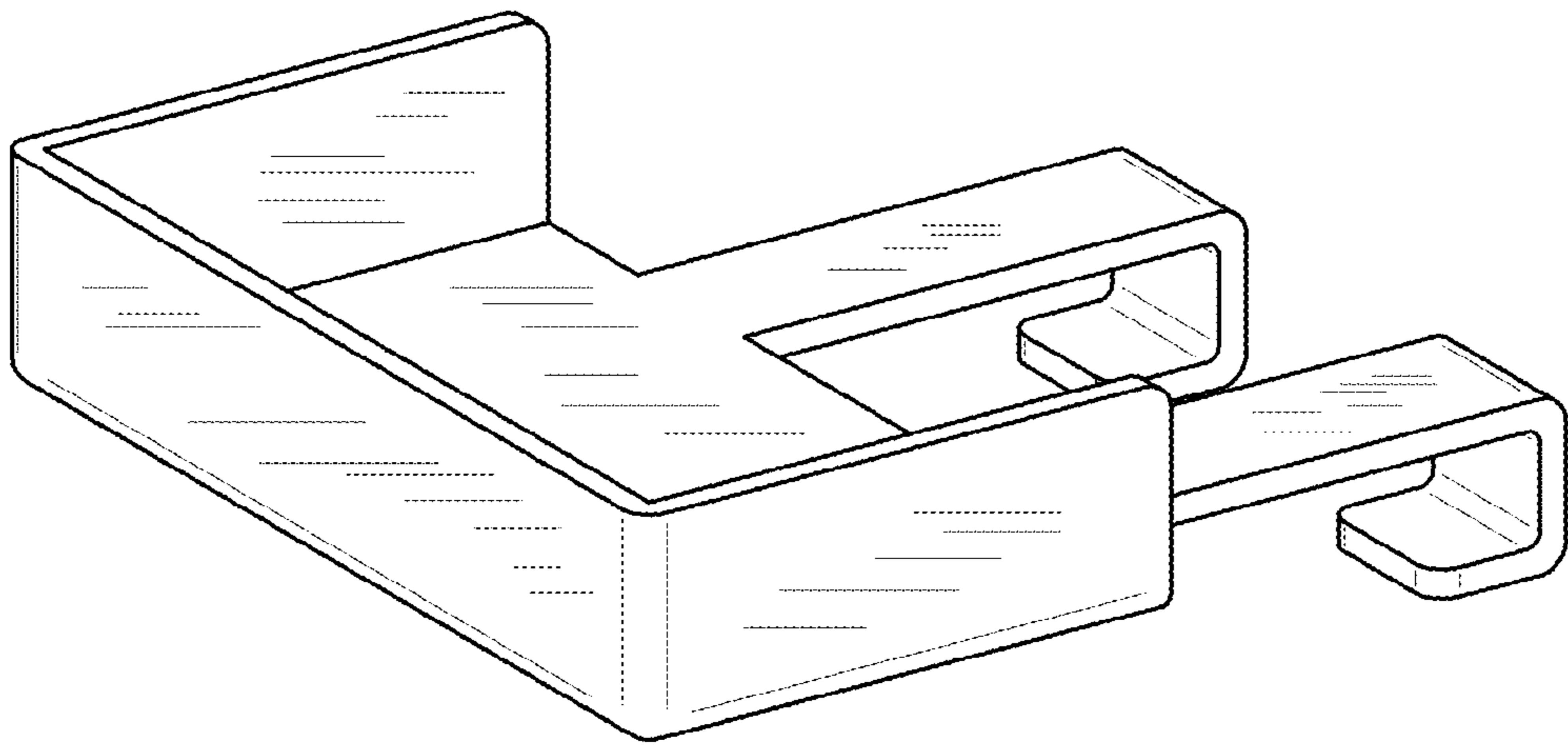

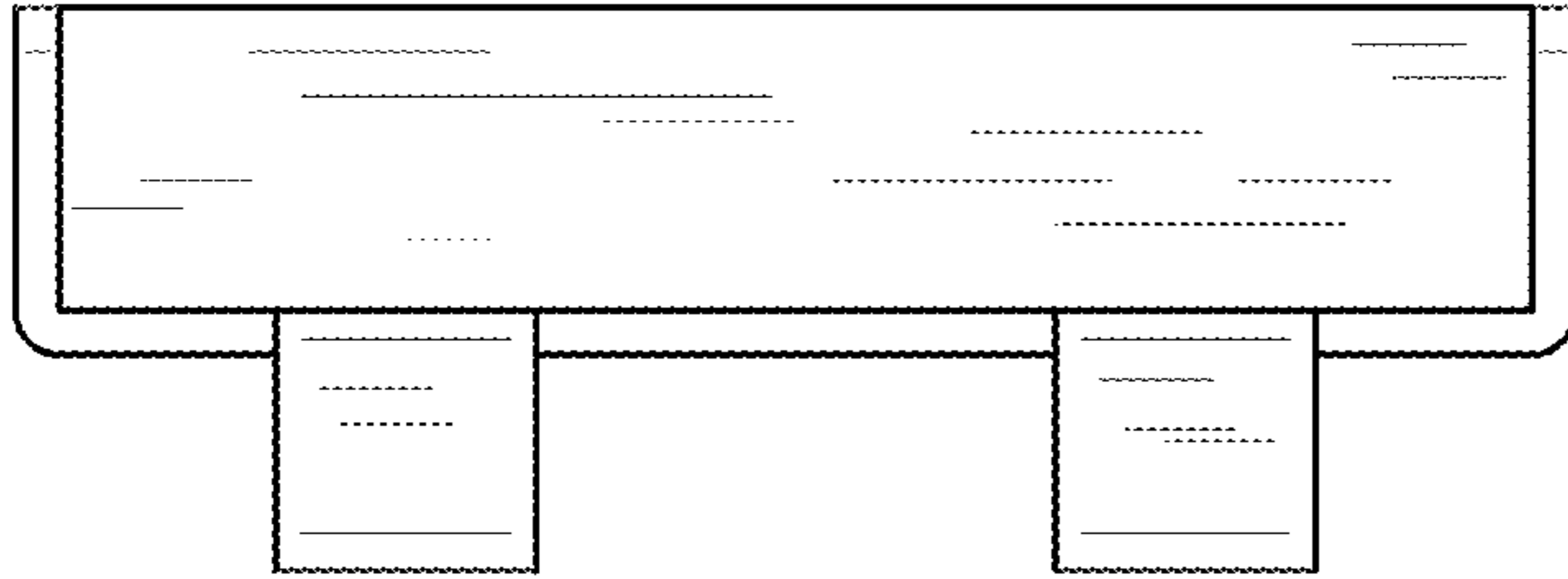

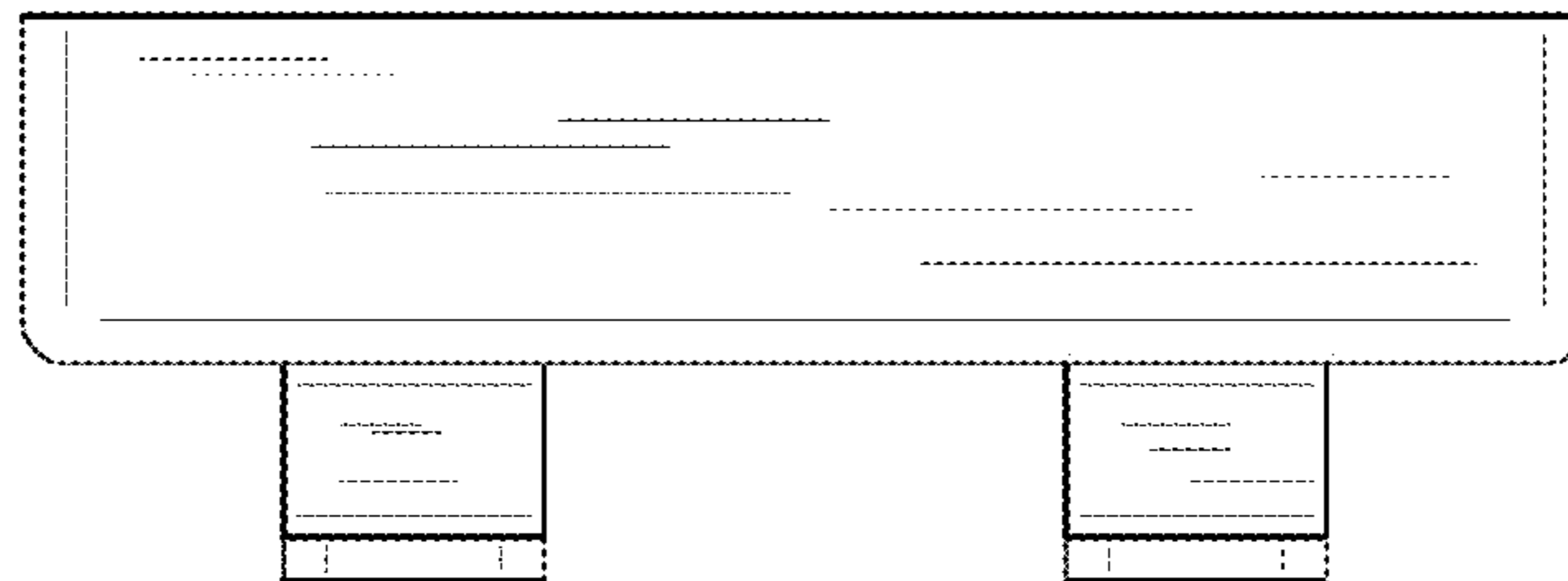

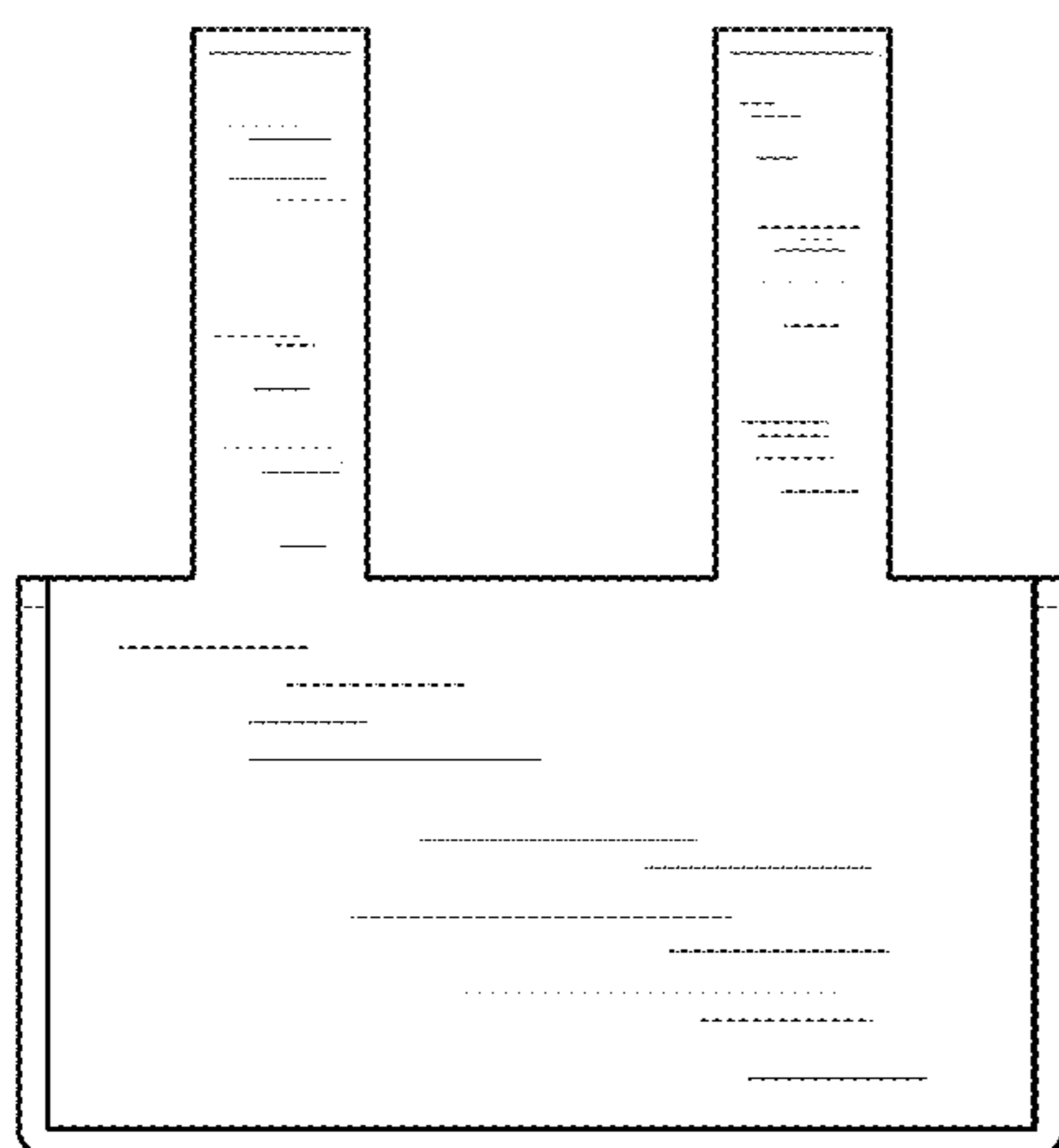

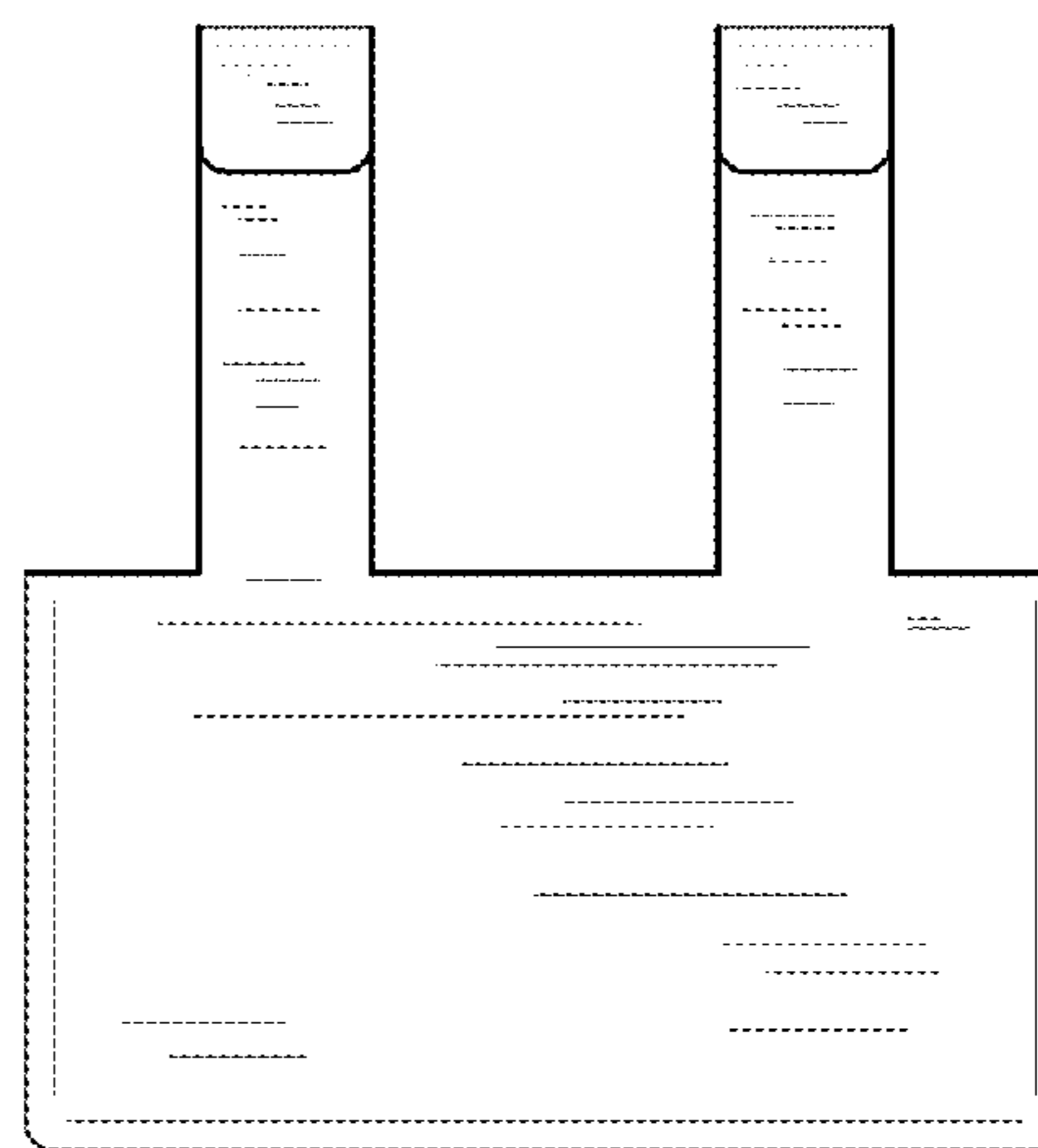

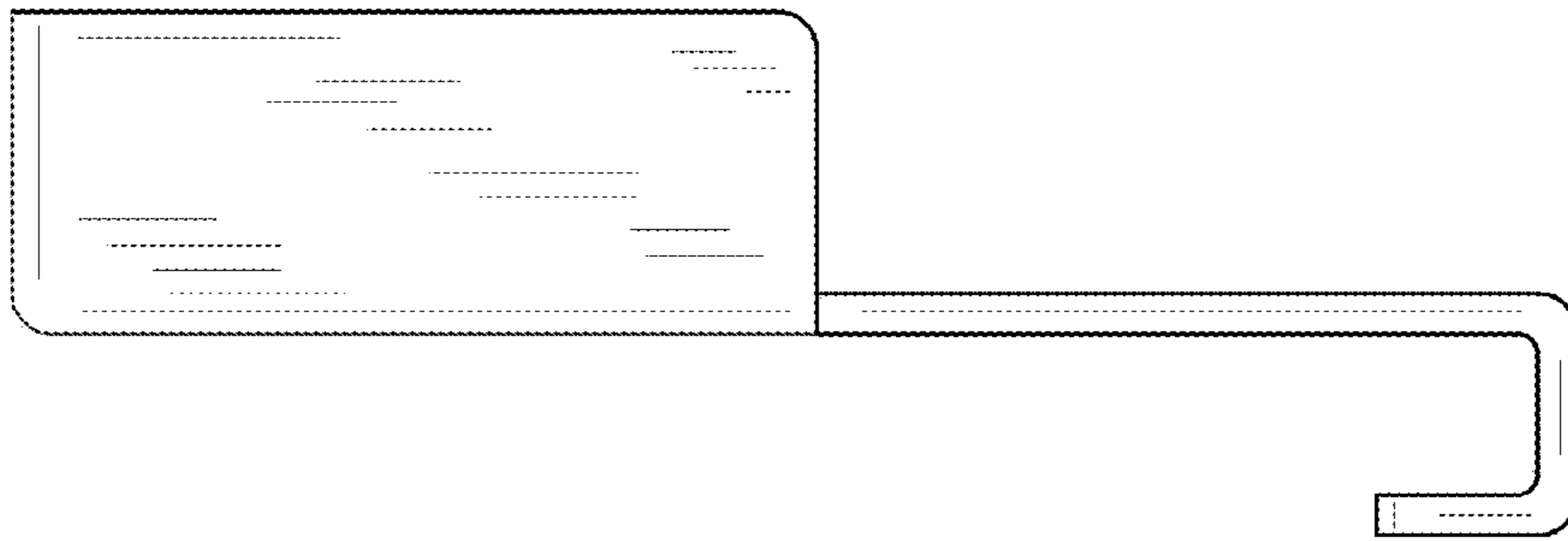

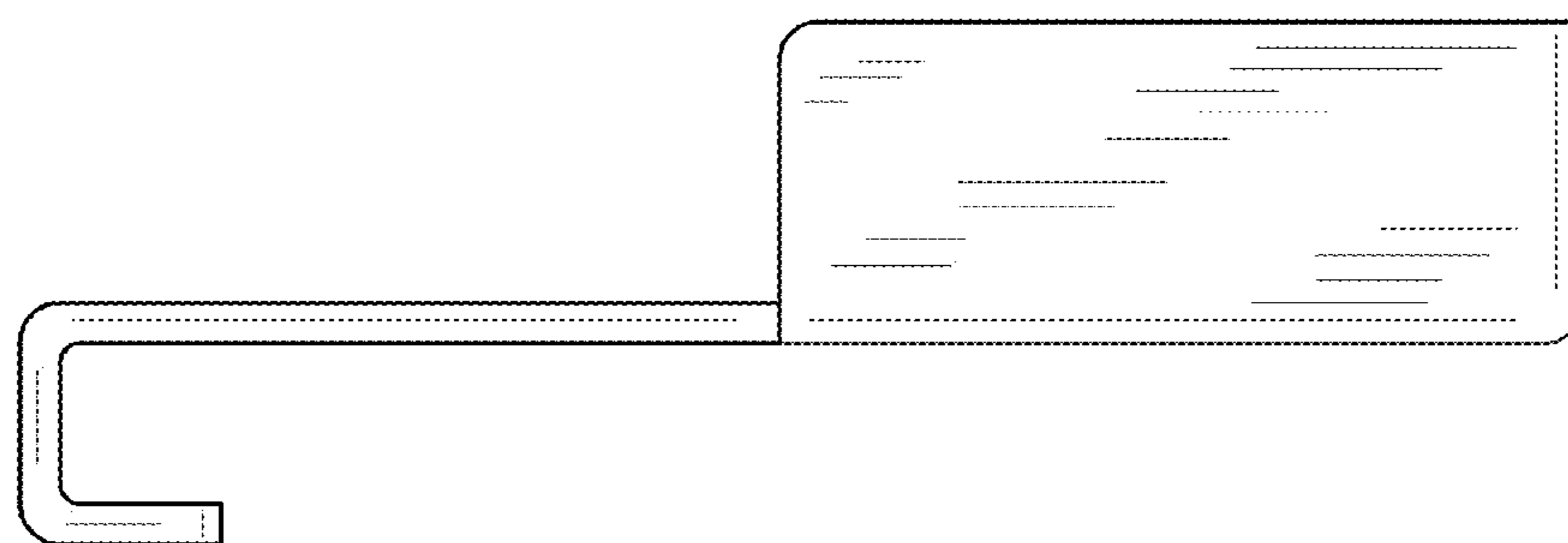

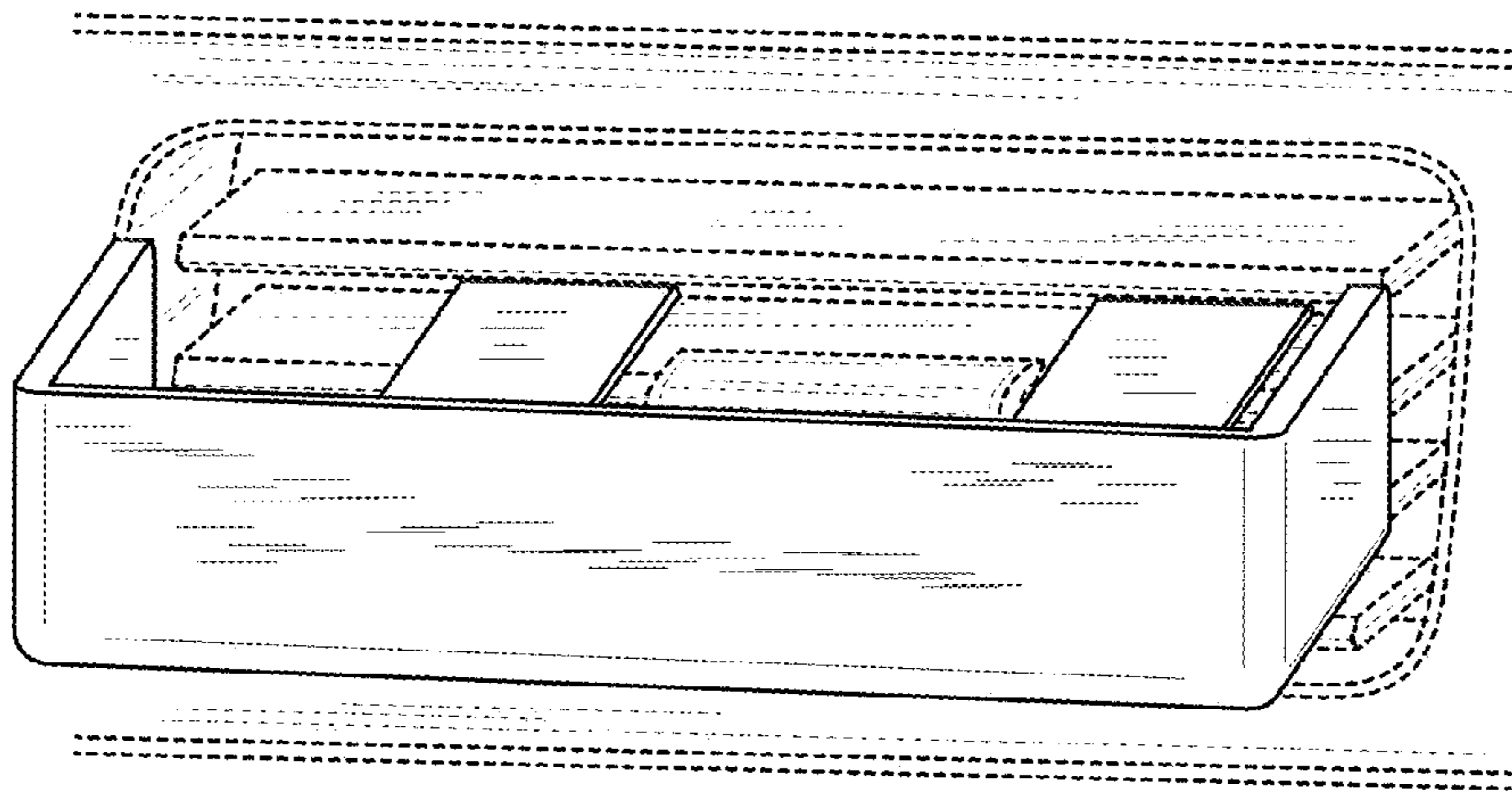
