I claim the ornamental design for a controller device for a heating kit, as shown and described.

FIG. 3 shows a left side view the controller device;

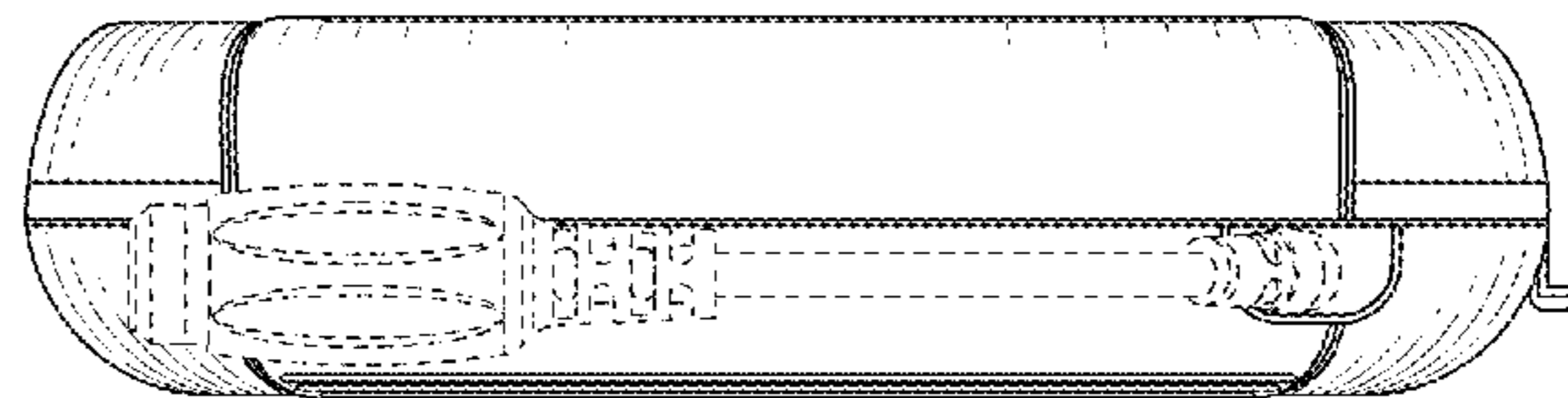
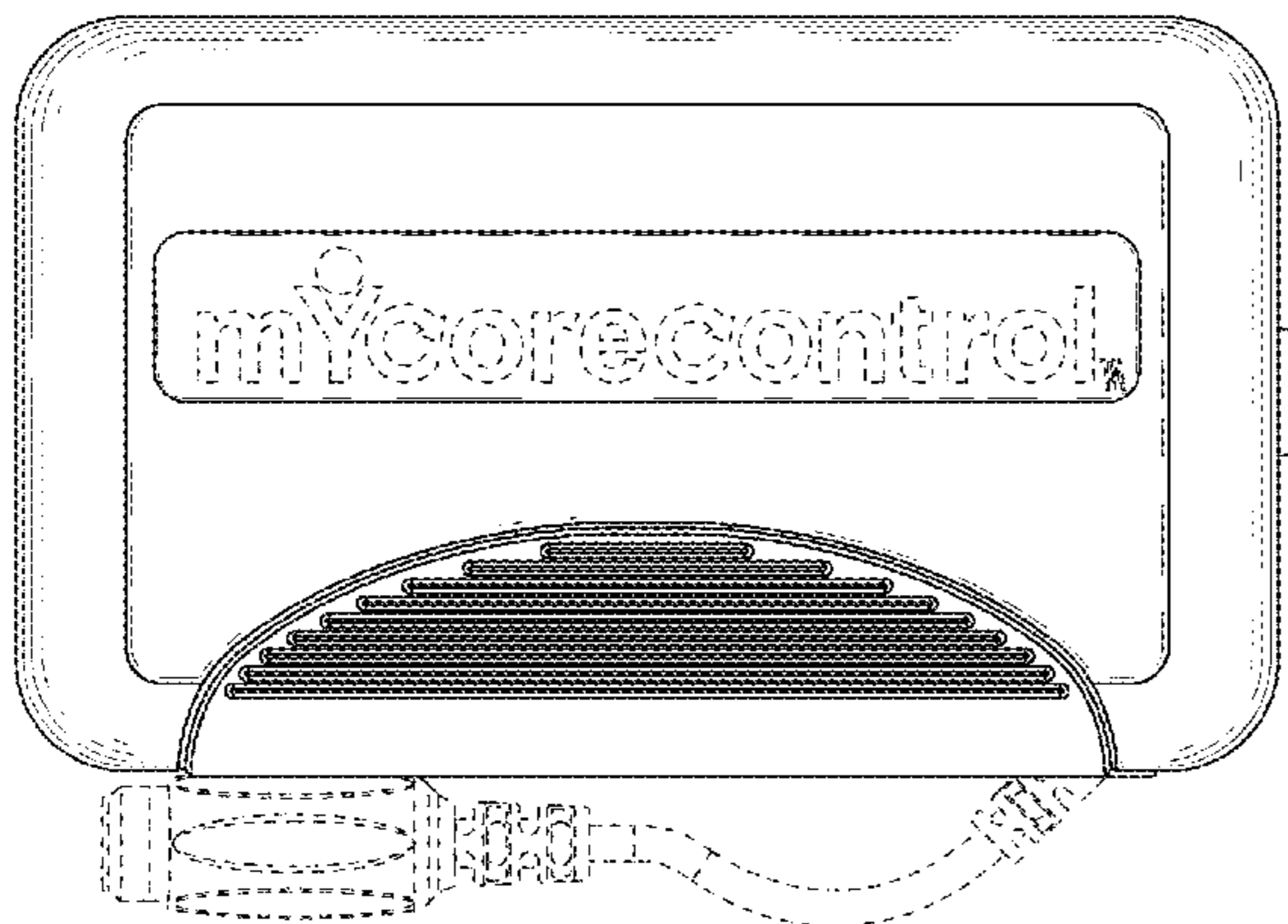
FIG. 4 shows a right side view the controller device;

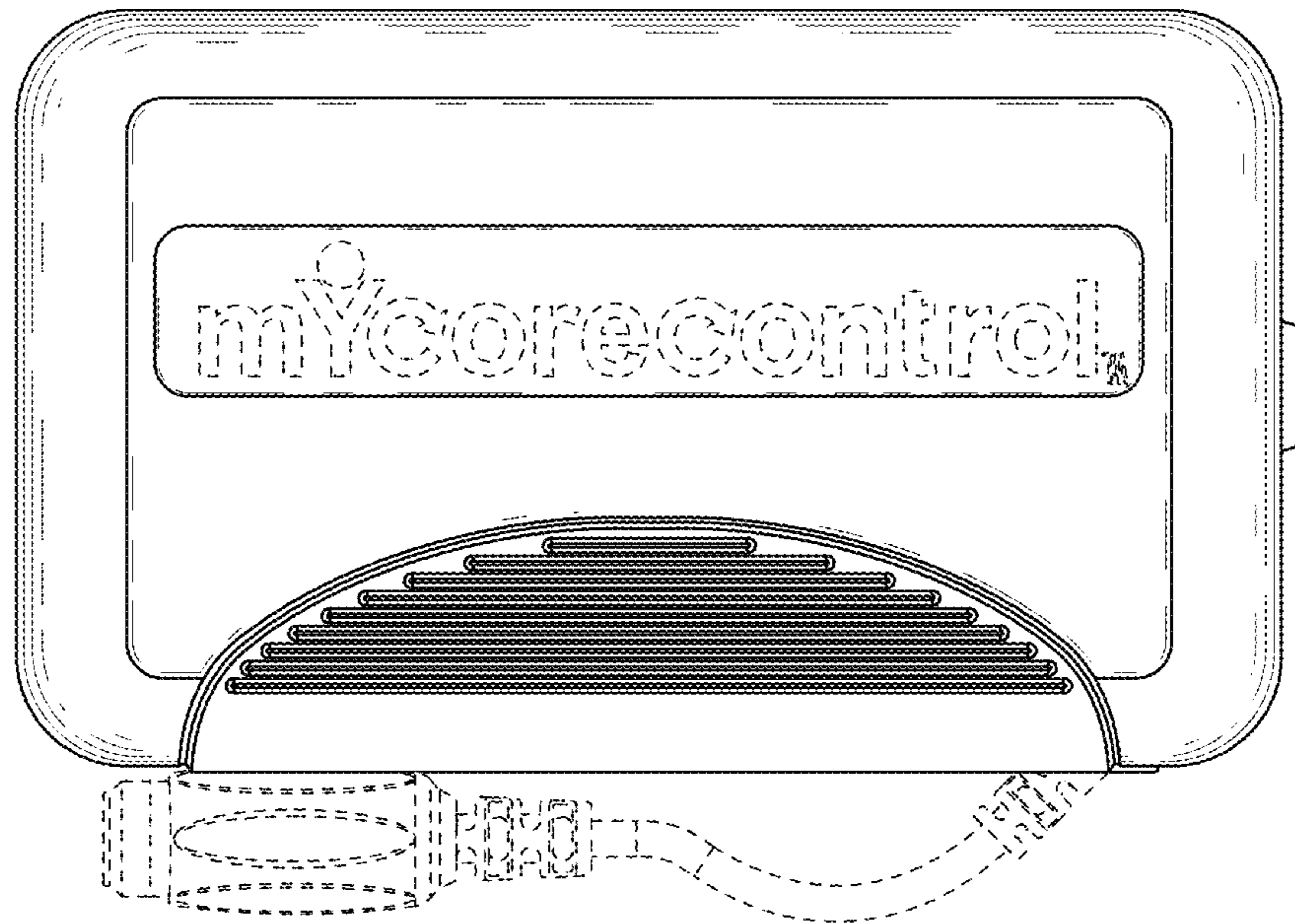

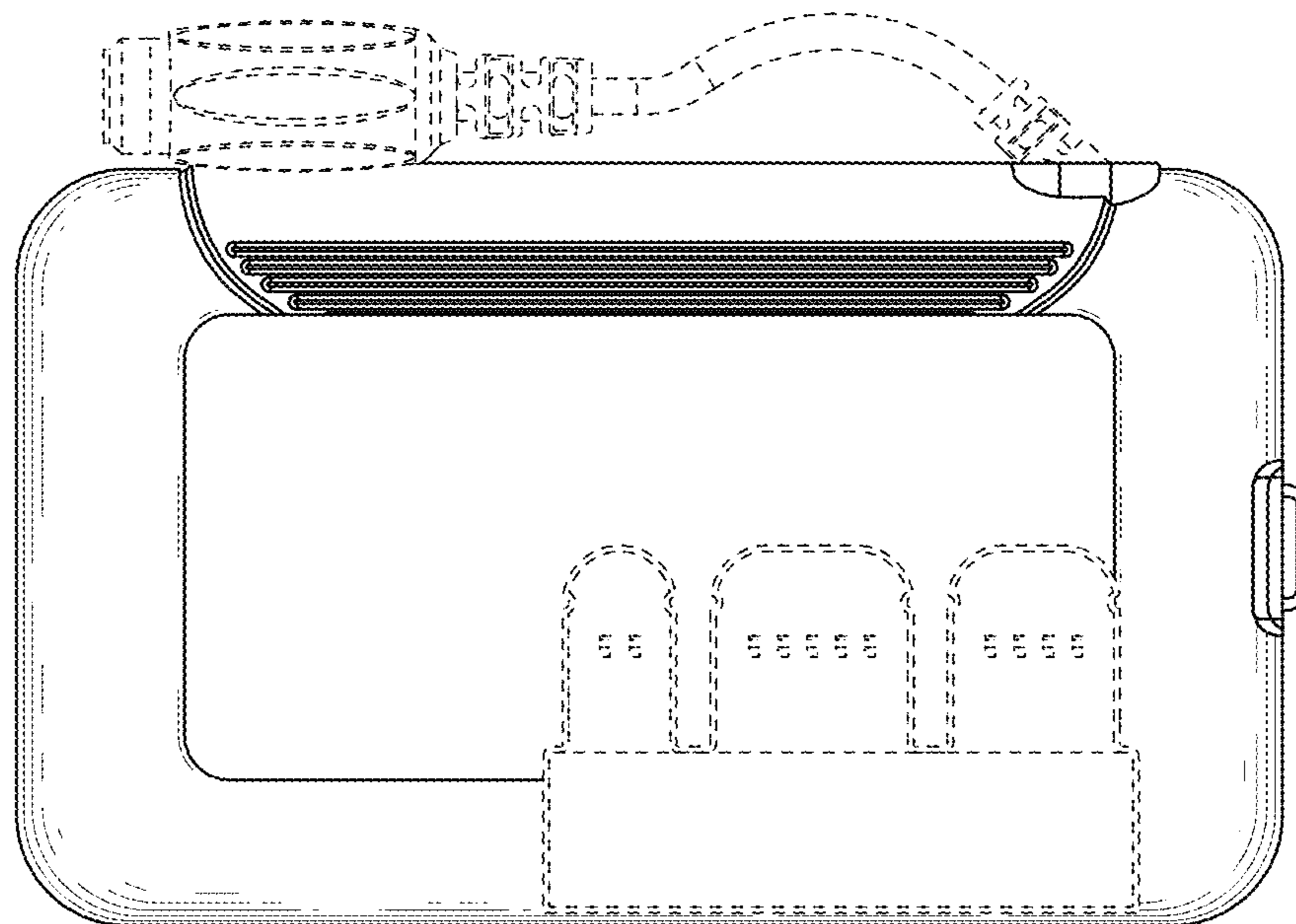

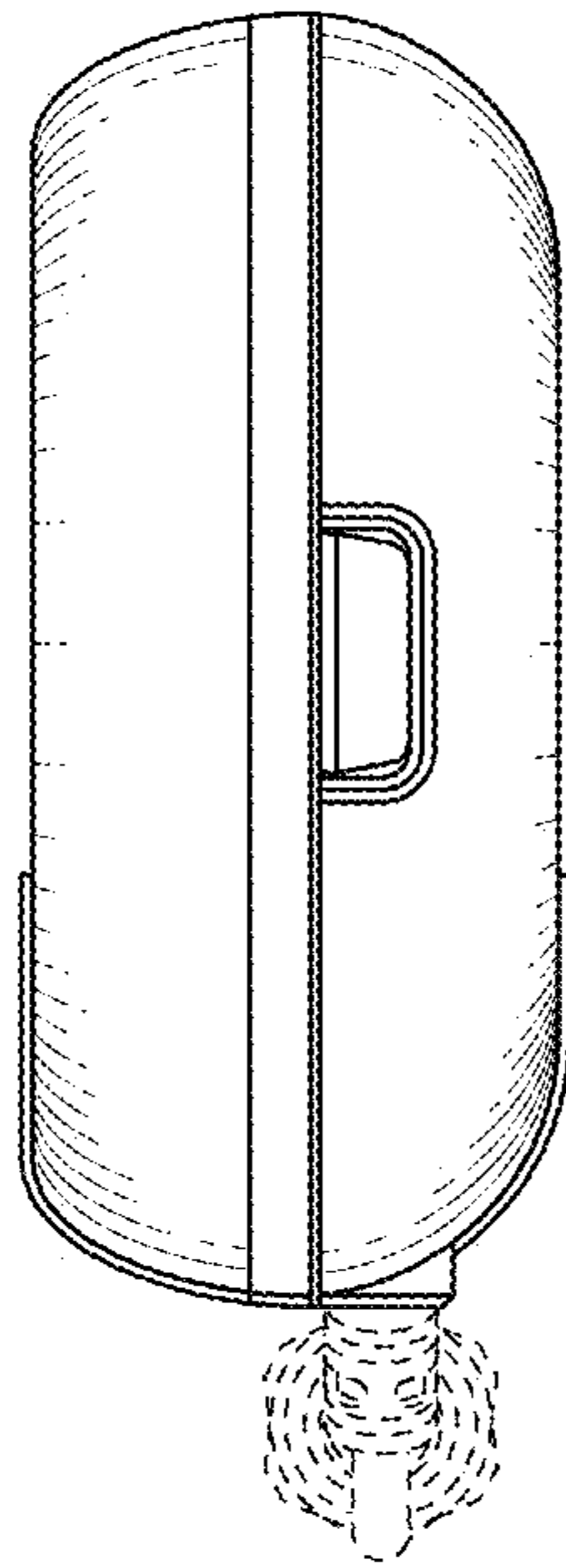

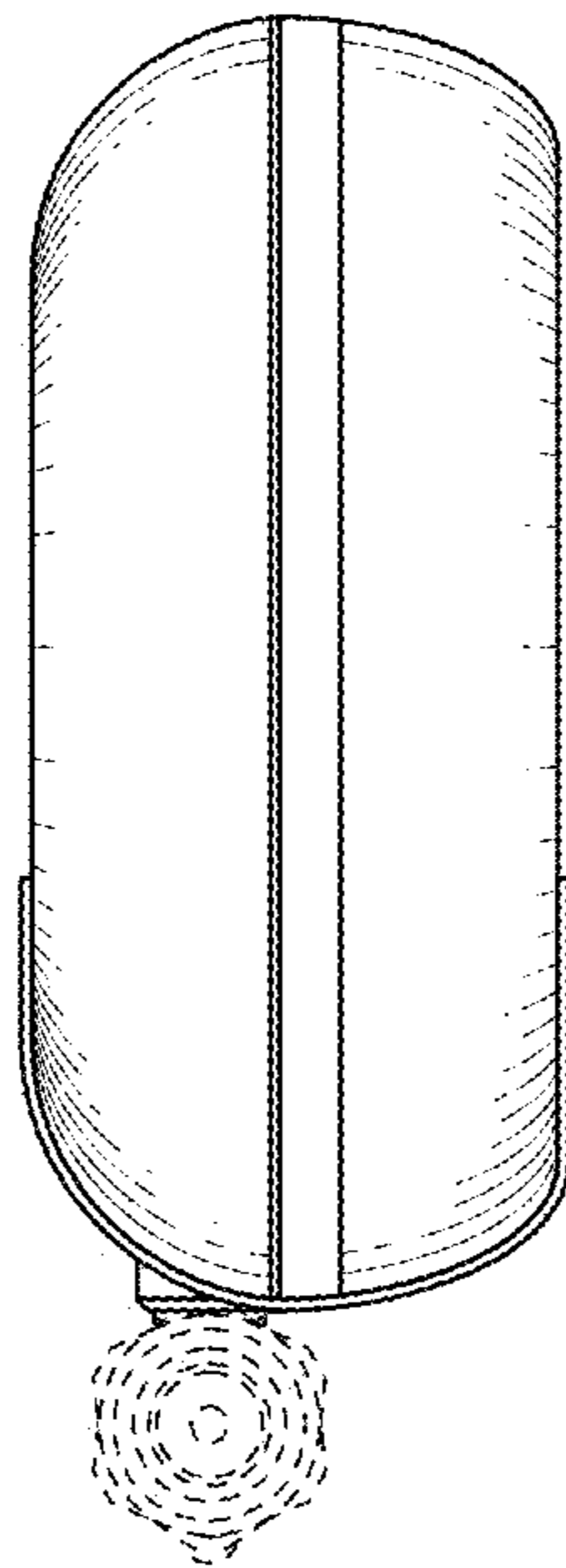

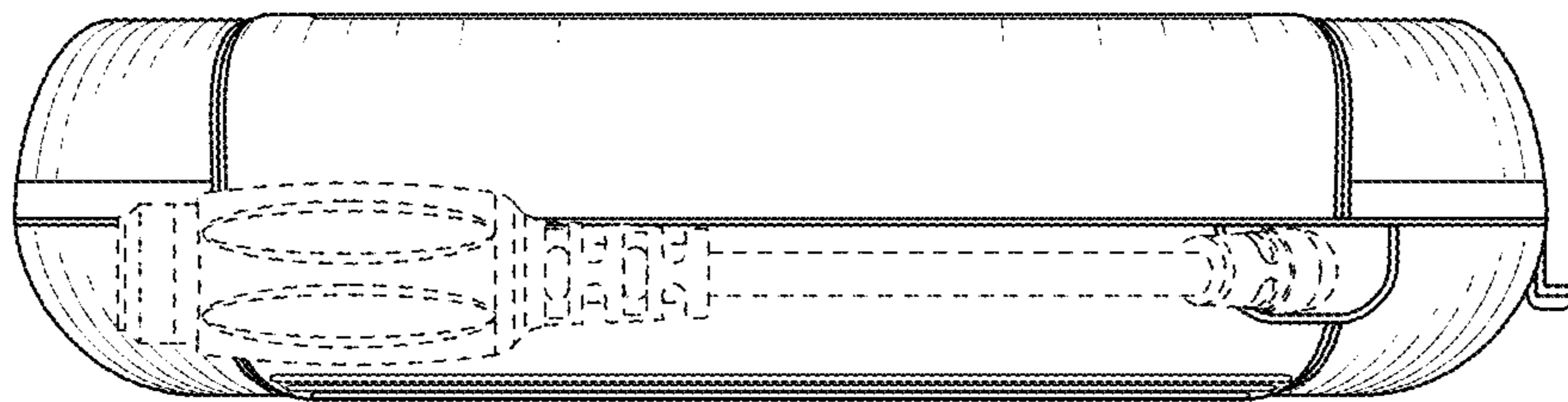
