FIG. 5 is a left side view of the mobile phone;

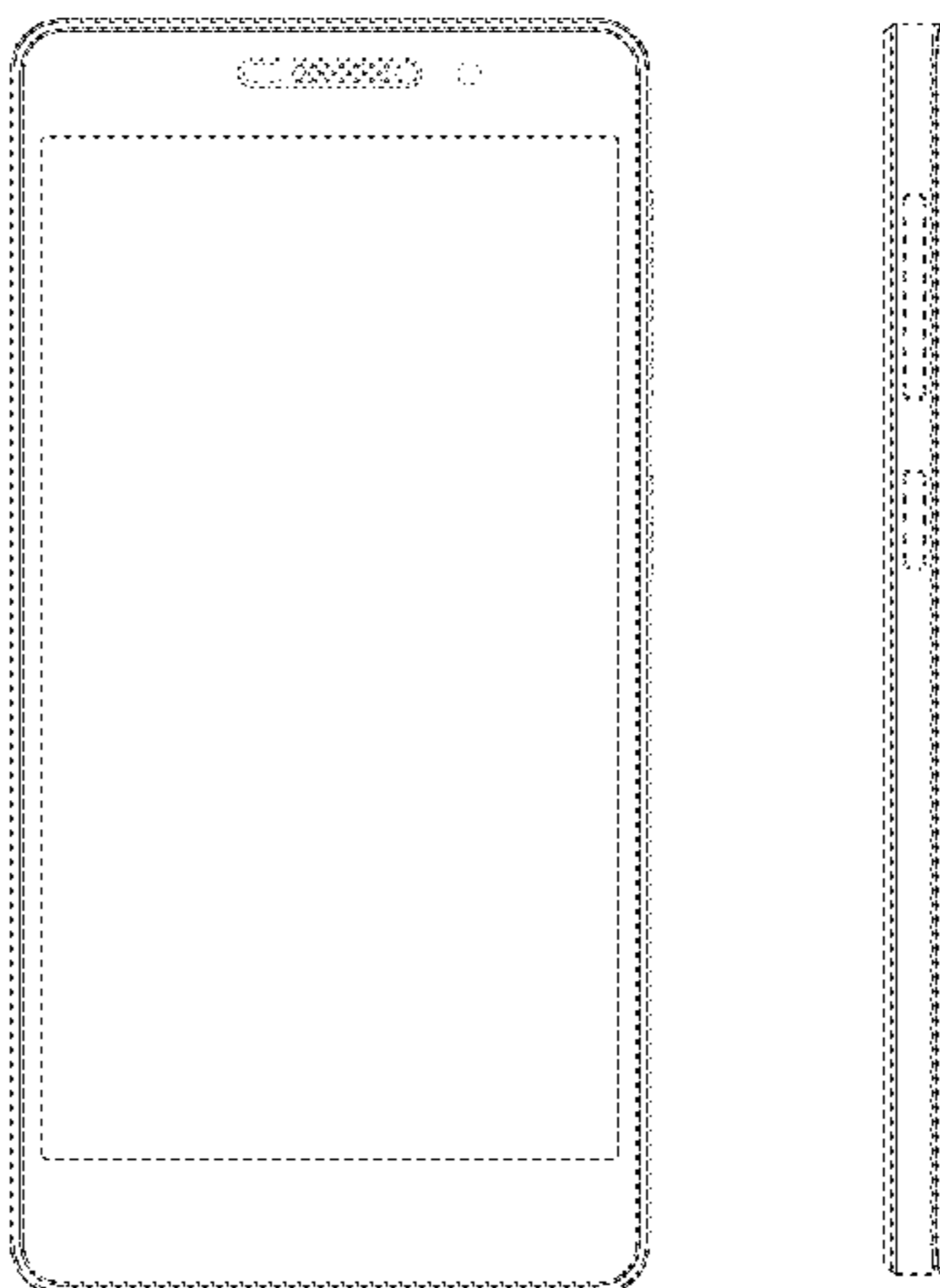
FIG. 6 is a back view of the mobile phone;

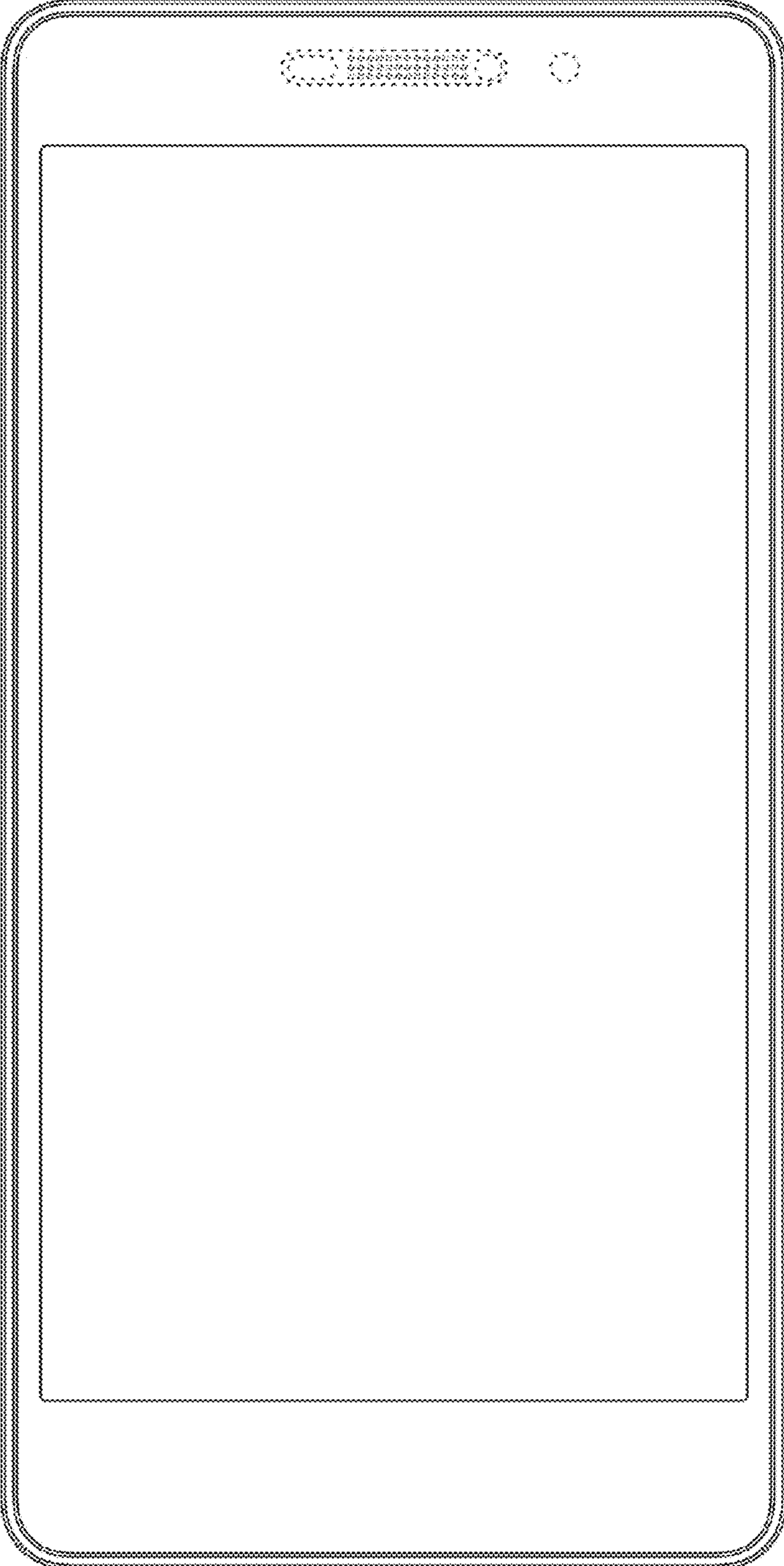

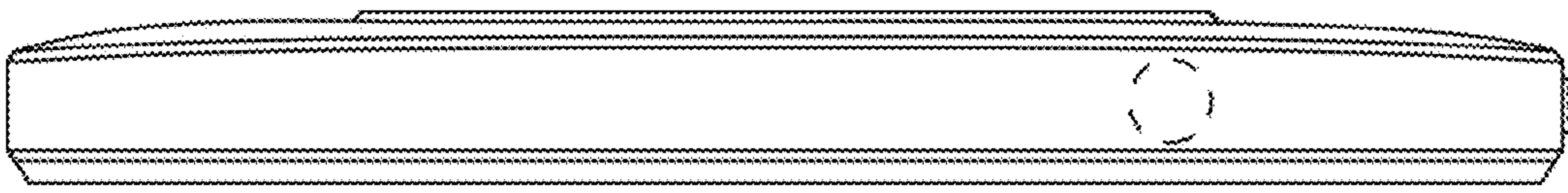

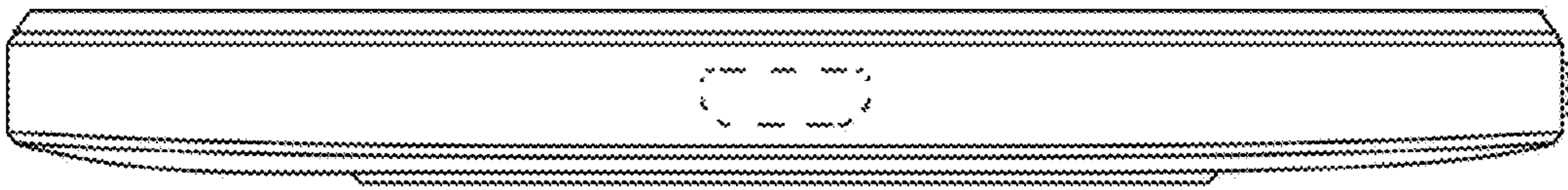

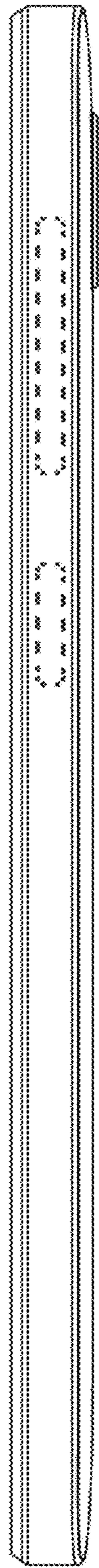

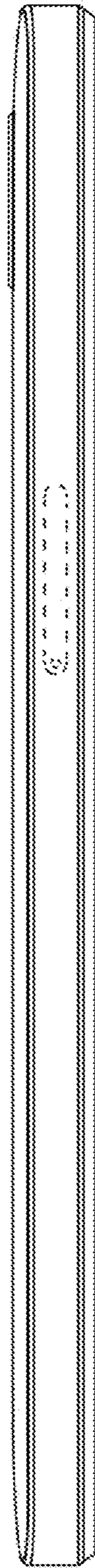

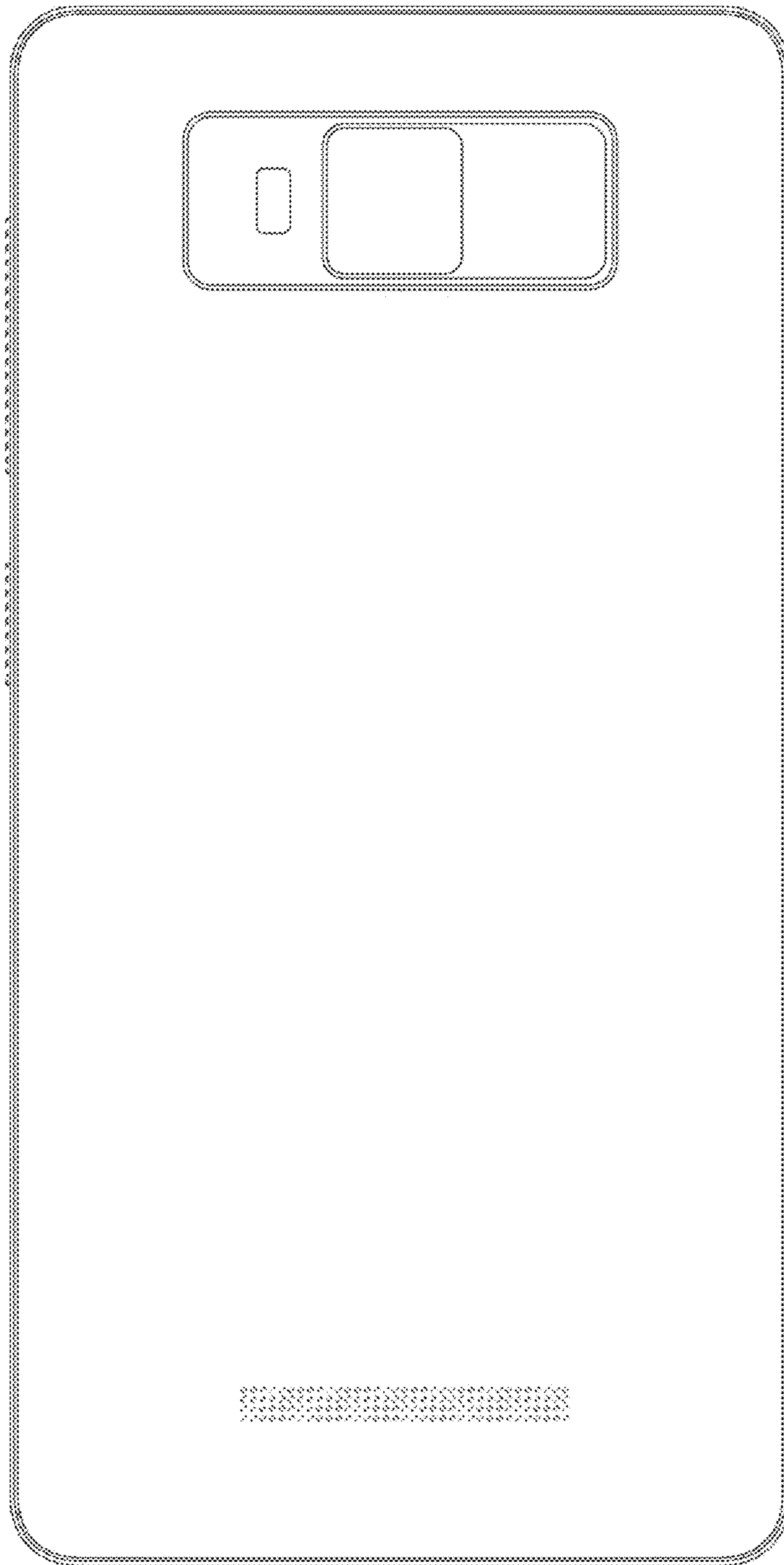

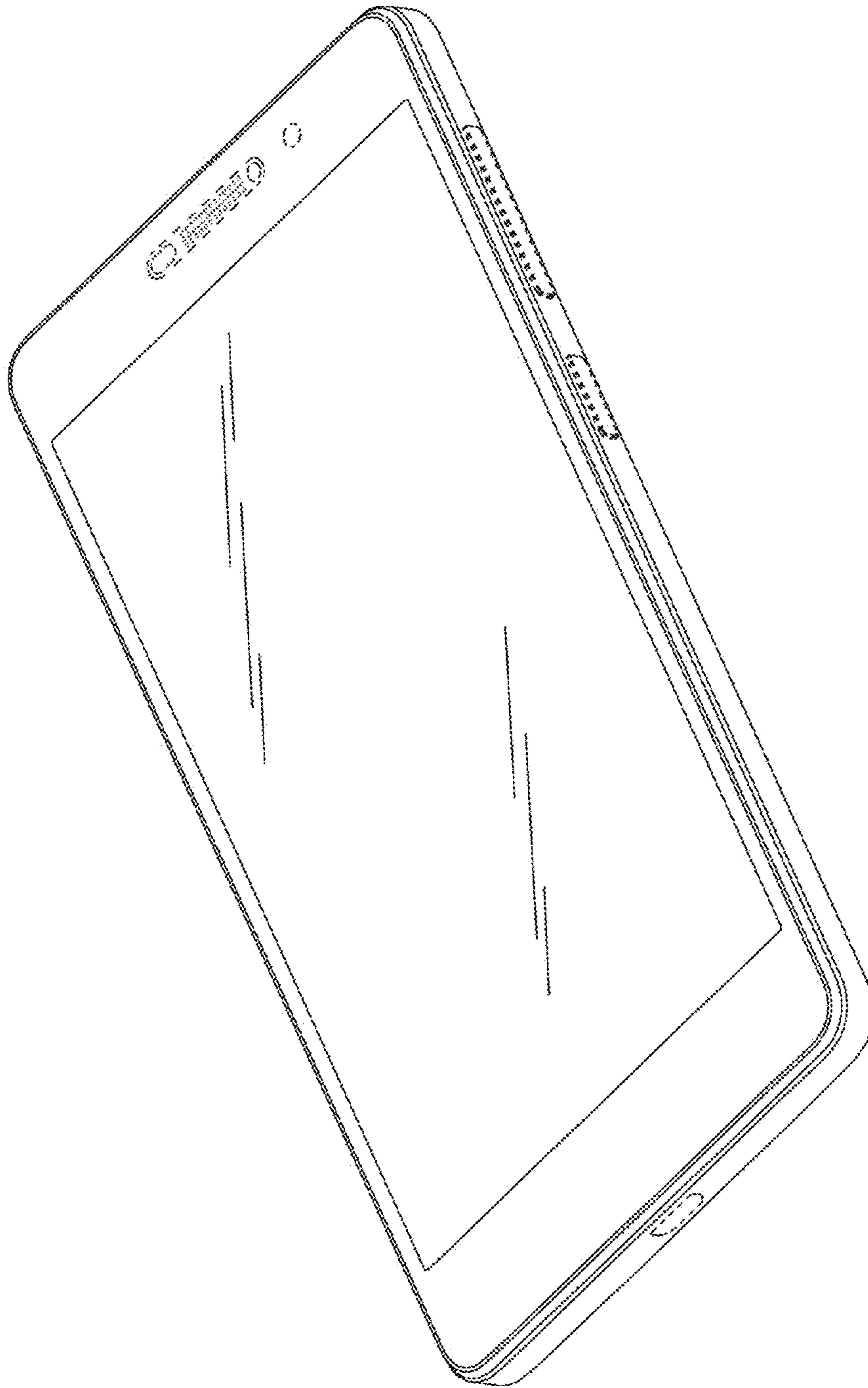

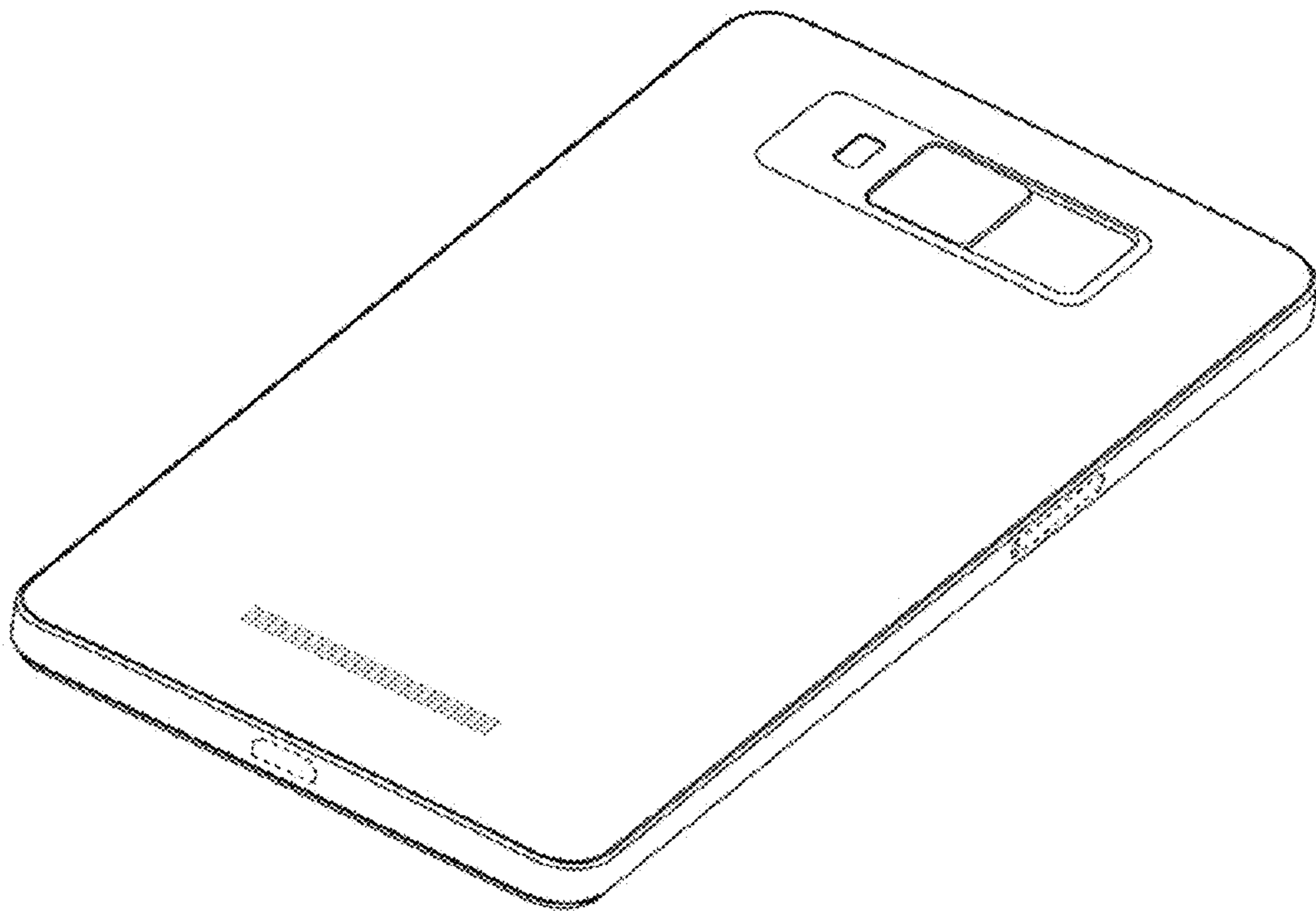
