The ornamental design for an electronic device cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the electronic device cover, taken from above. The broken lines represent a portion of the invention that forms no part of the claim.

FIG. 2 is a second perspective view of the electronic device cover of FIG. 1, taken from below;

FIG. 3 is a front view of the electronic device cover of FIG. 1;

FIG. 4 is a back view of the electronic device cover of FIG. 1;

FIG. 5 is a bottom view of the electronic device cover of FIG. 1;

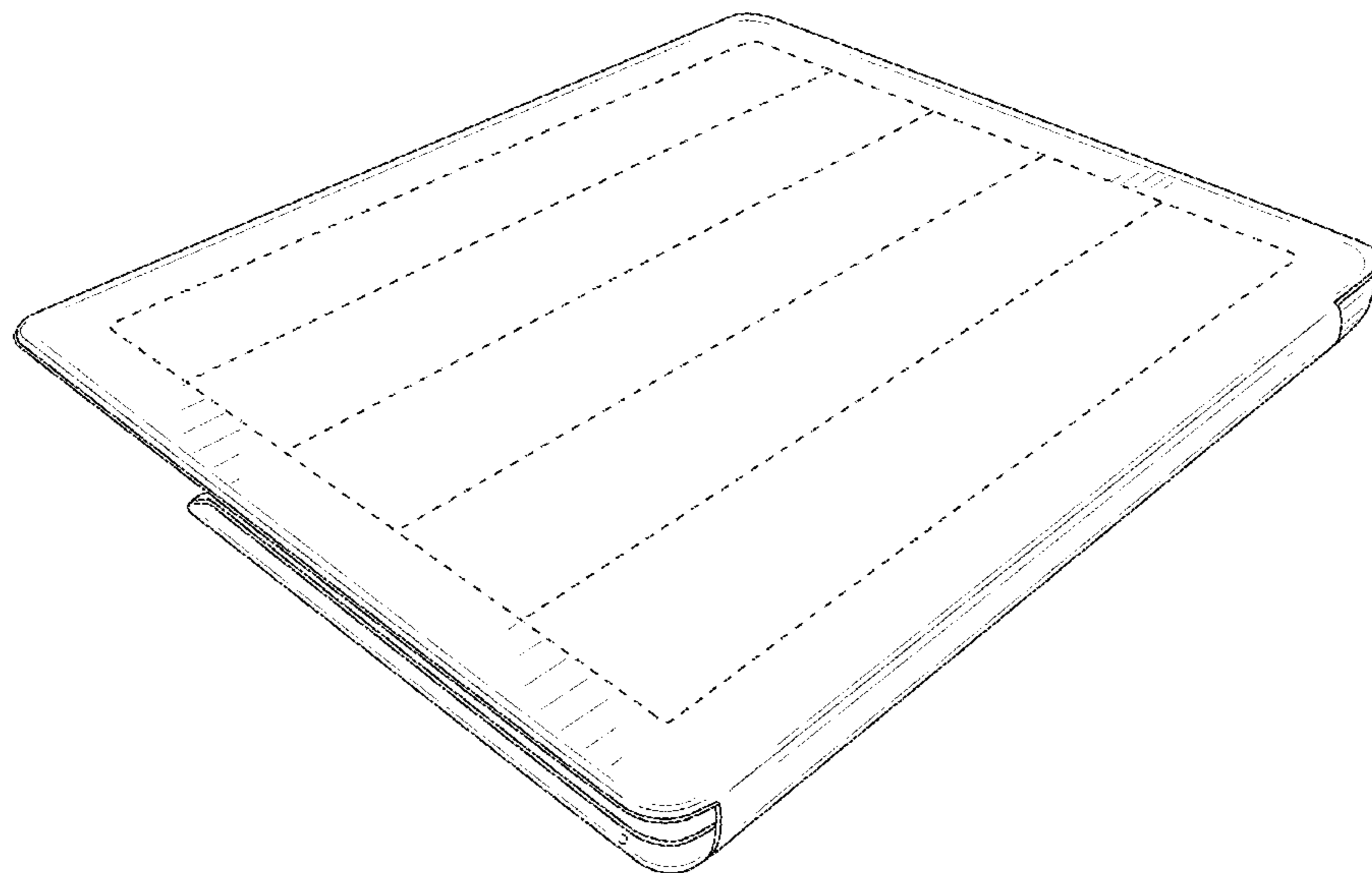
FIG. 6 is a top view of the electronic device cover of FIG. 1;

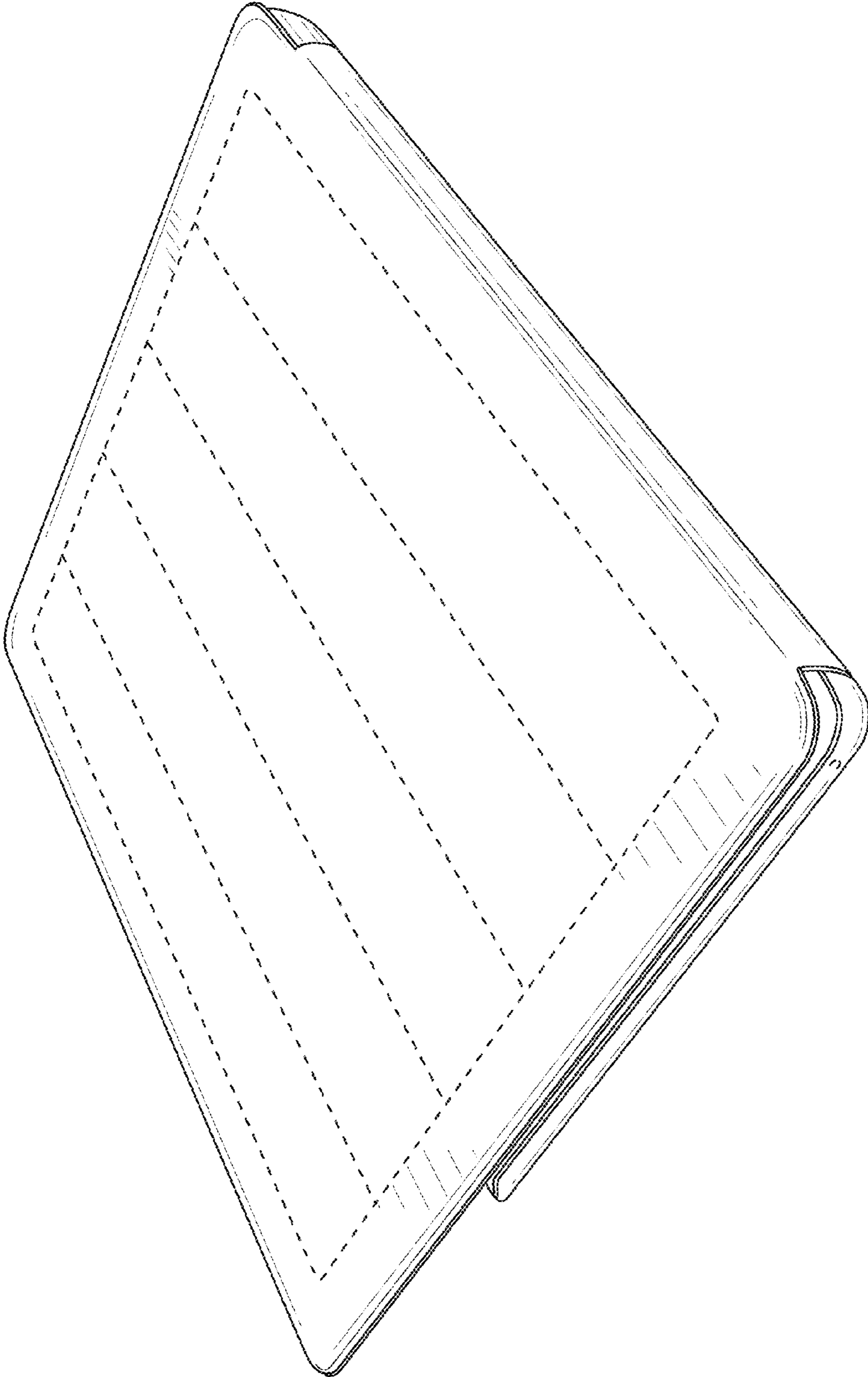

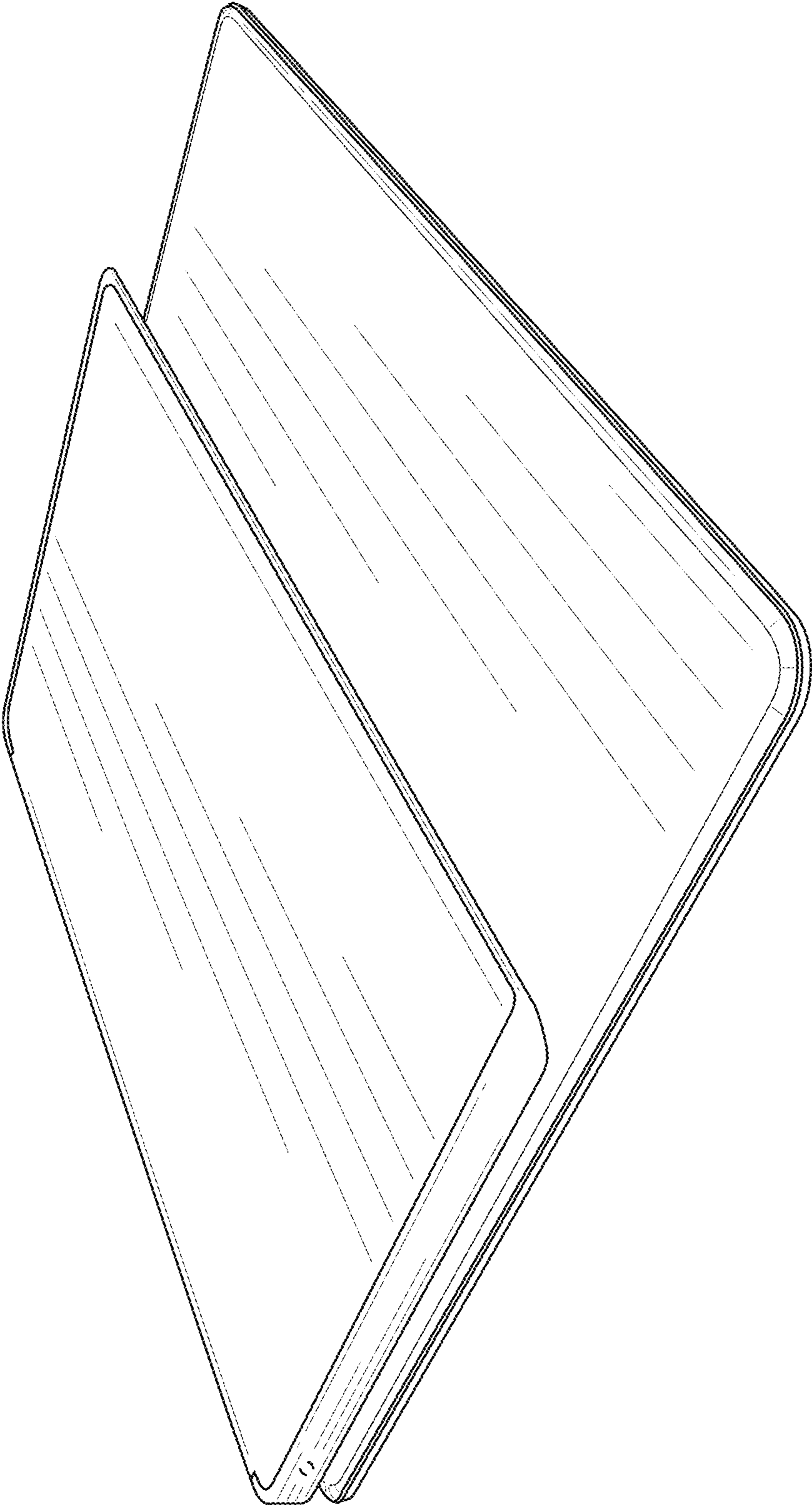

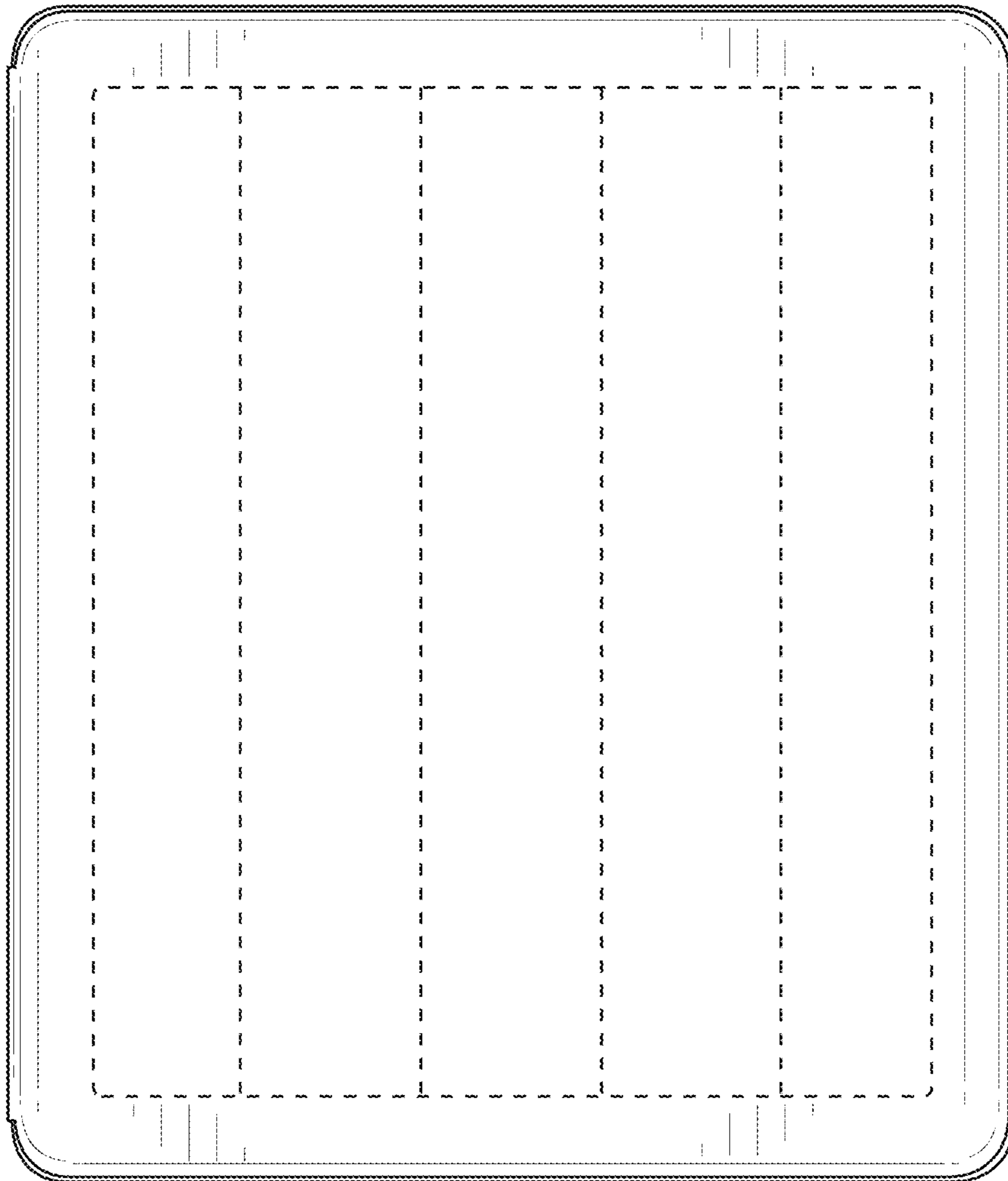

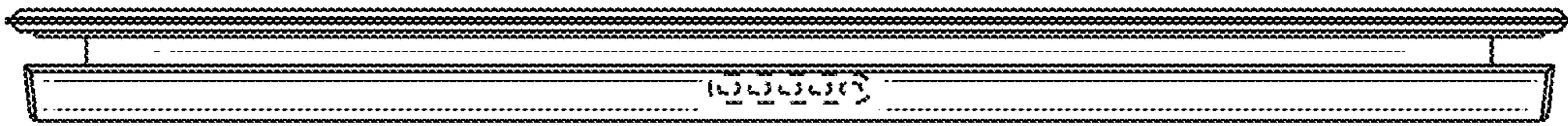

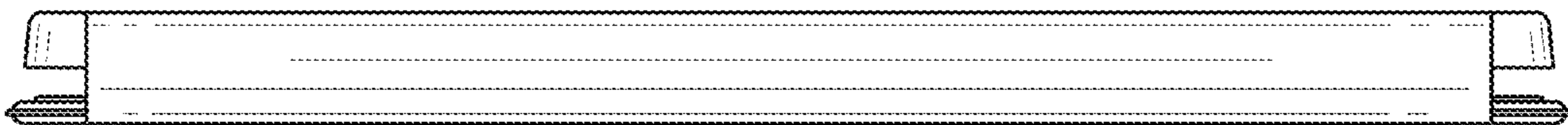

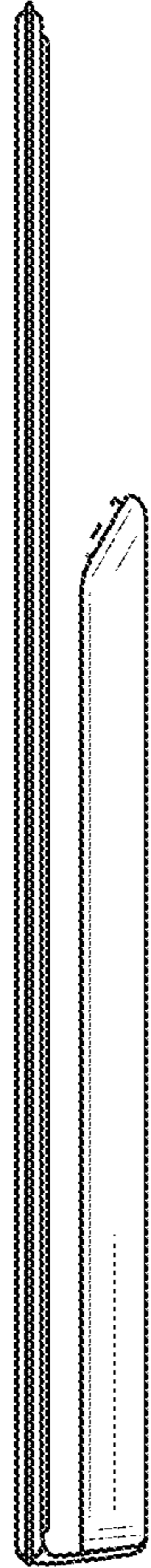

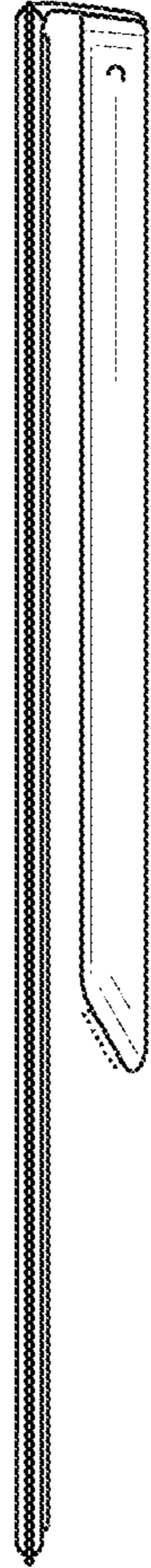
