(57) **CLAIM**

The ornamental design for a display screen portion with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a display screen with animated graphical user interface showing my new design;

FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof;

FIG. 4 is a front view of a second embodiment of a display screen portion with animated graphical user interface showing my new design;

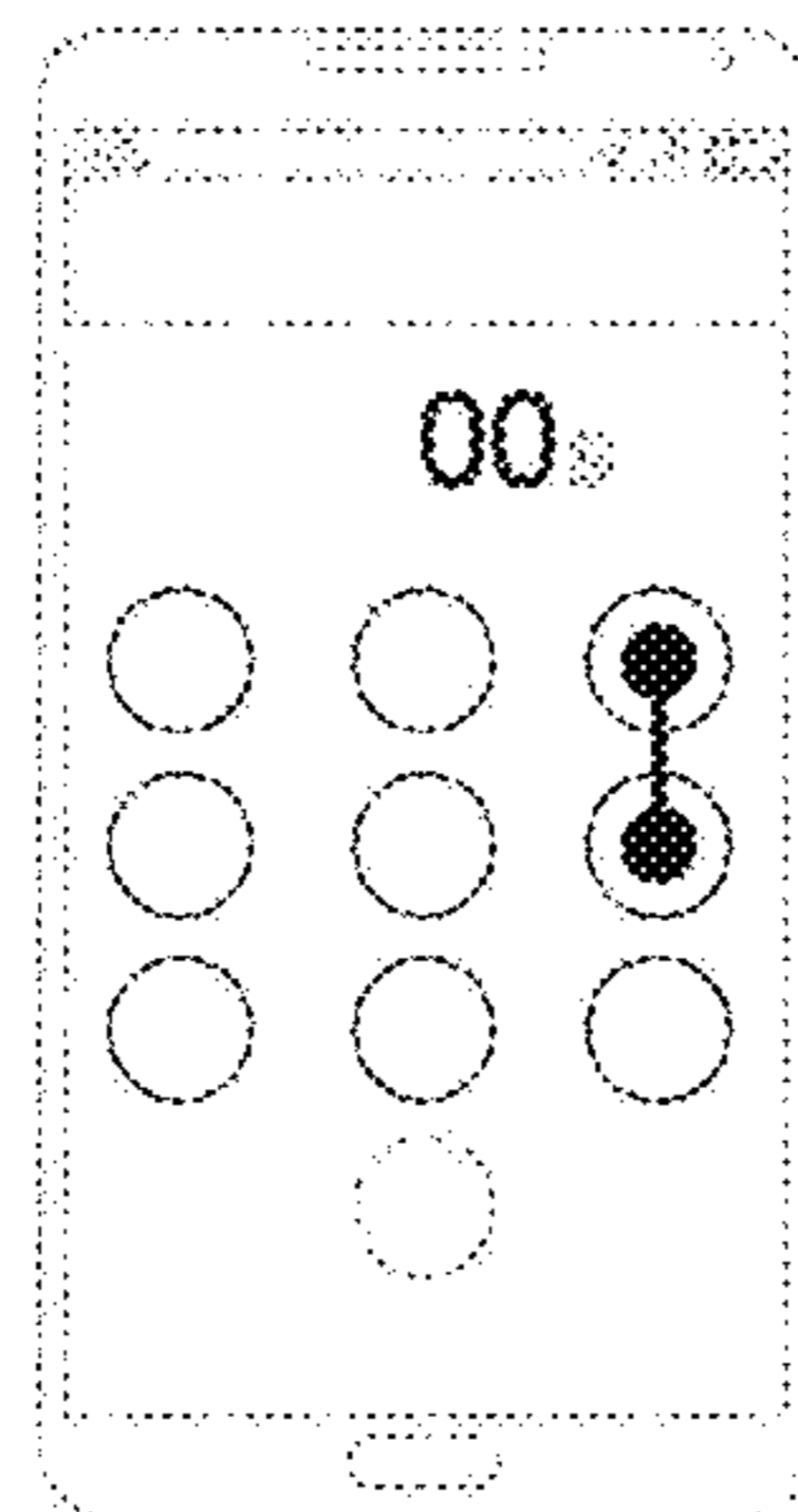
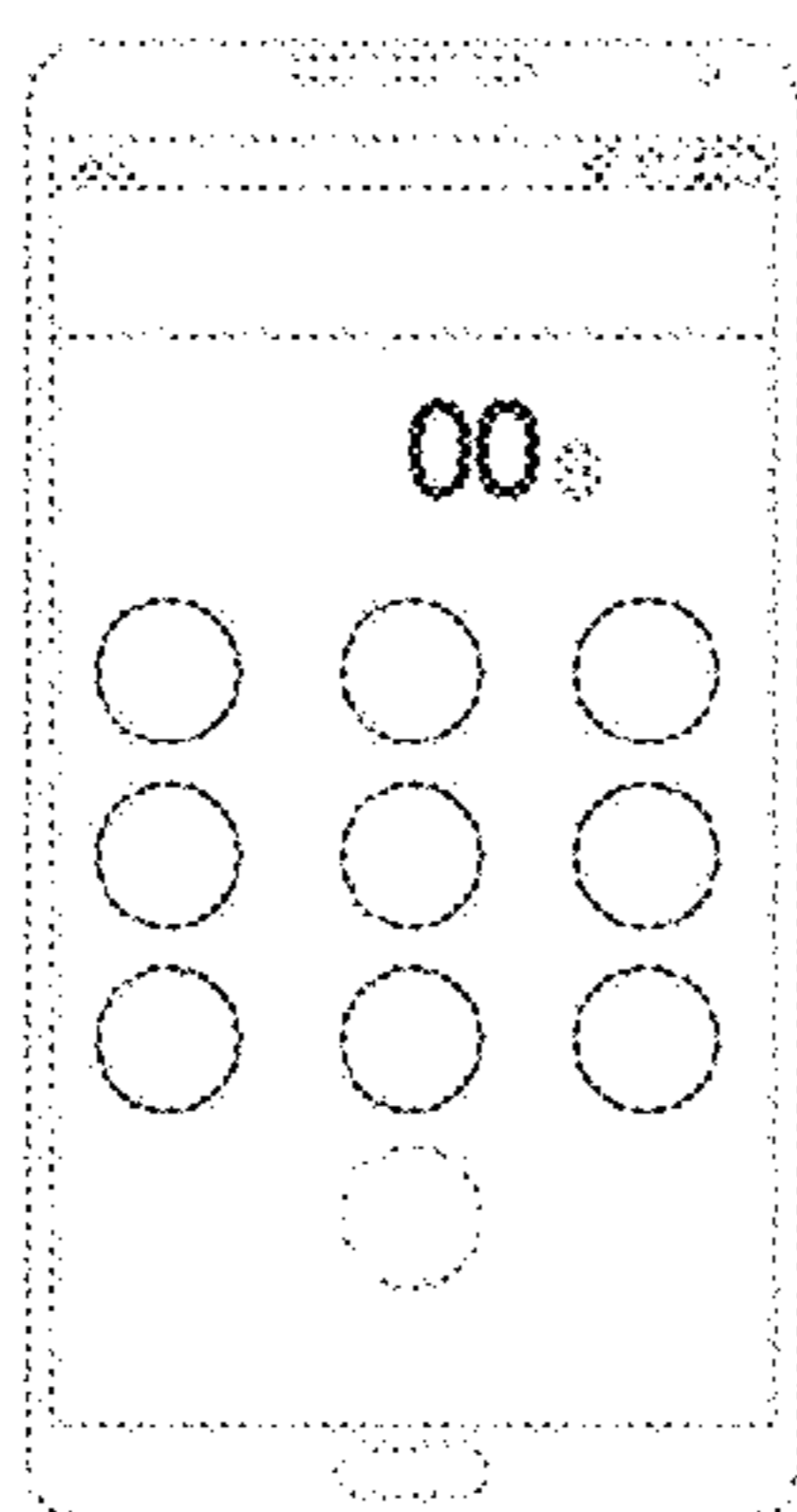
FIG. 5 is a front view of a second image thereof; and,

FIG. 6 is a front view of a third image thereof.

In the first embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 through 3. In the second embodiment, the appearance of the transitional image sequentially transitions between the images shown in FIGS. 4 through 6. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken line showing of the display screen in FIGS. 1 through 6 forms no part of the claimed design. The broken line showing of the remainder of the graphical user interface in FIGS. 1 through 6 represents environmental subject matter and forms no part of the claimed design.

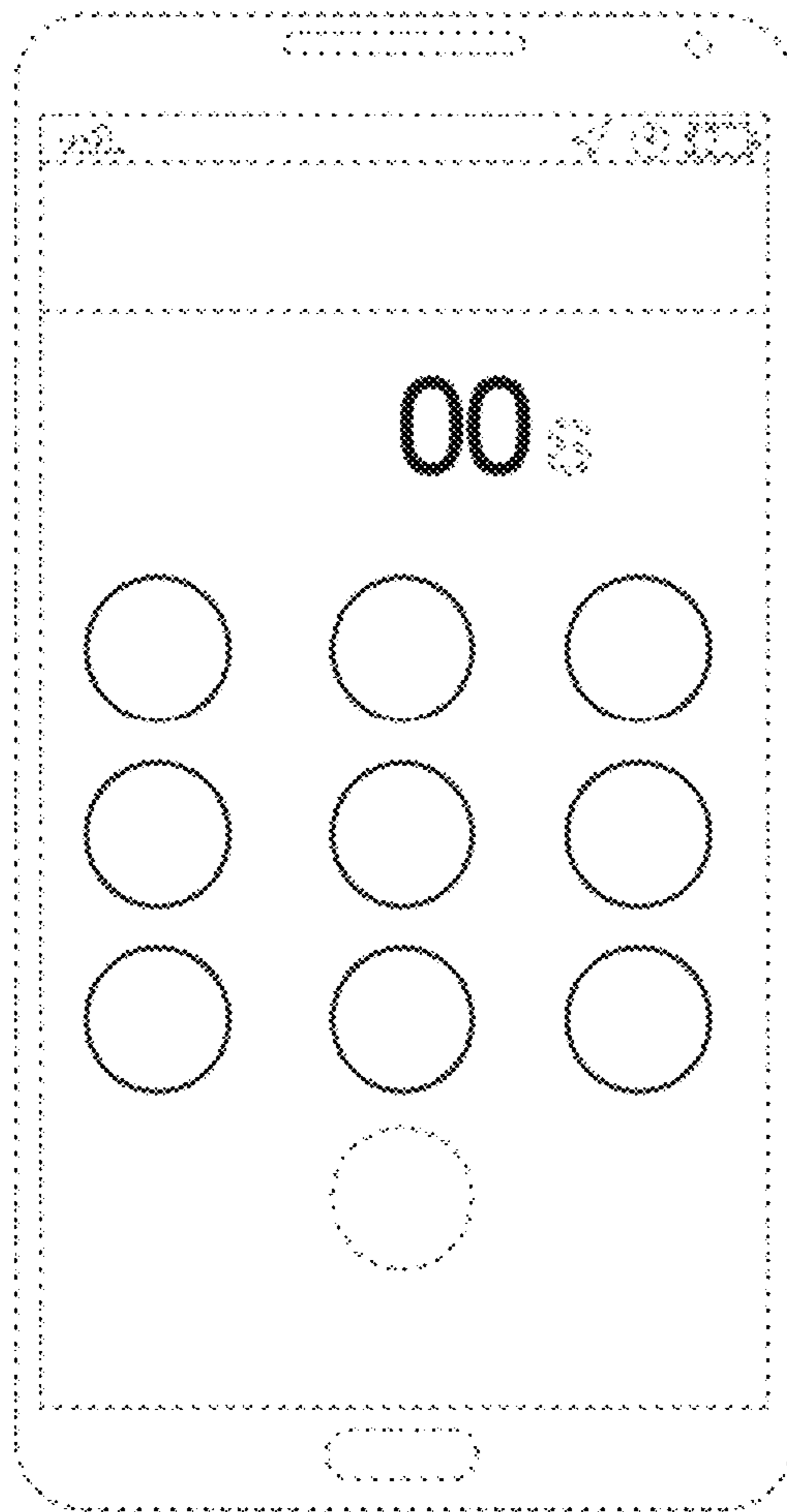

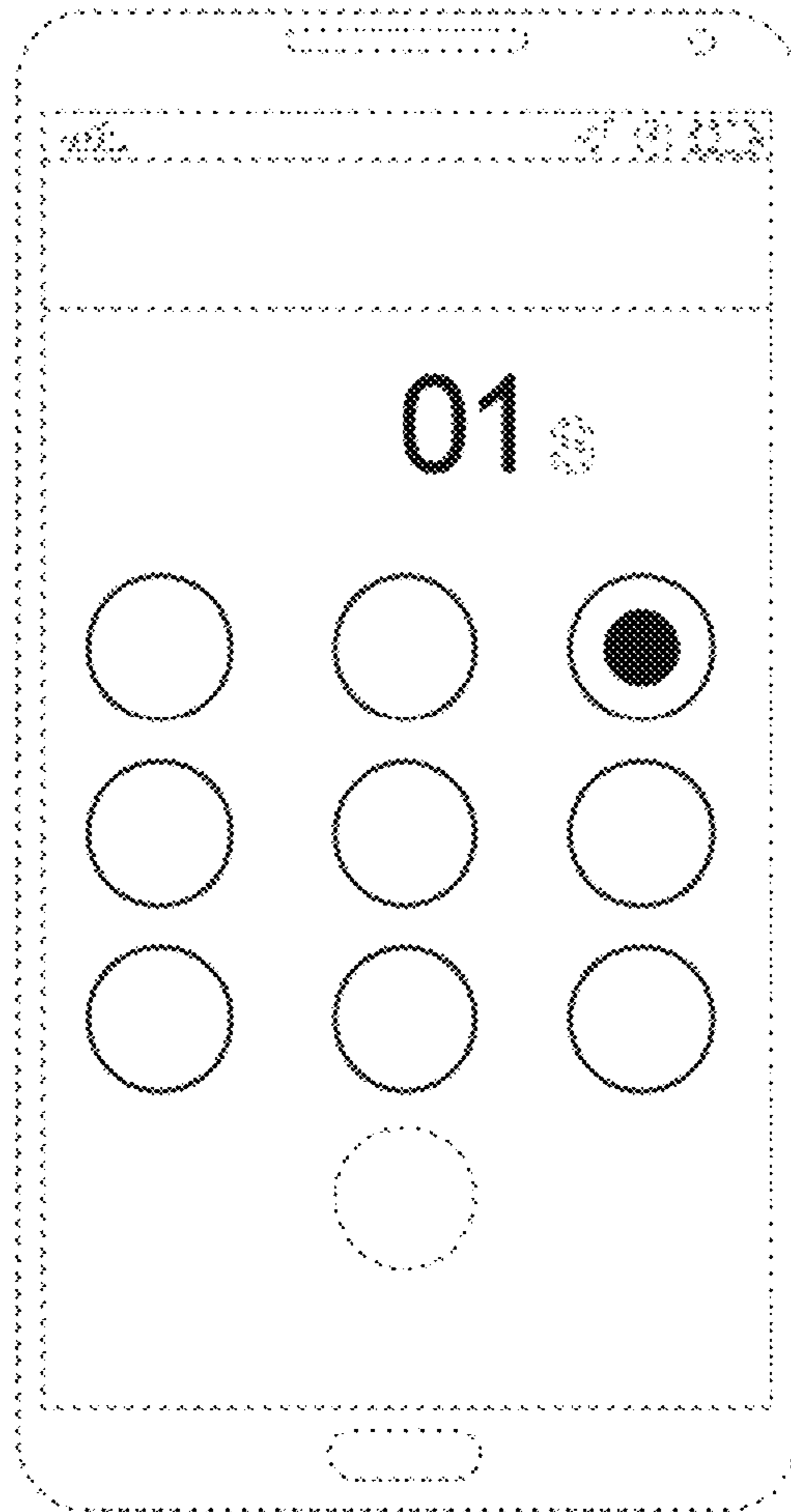

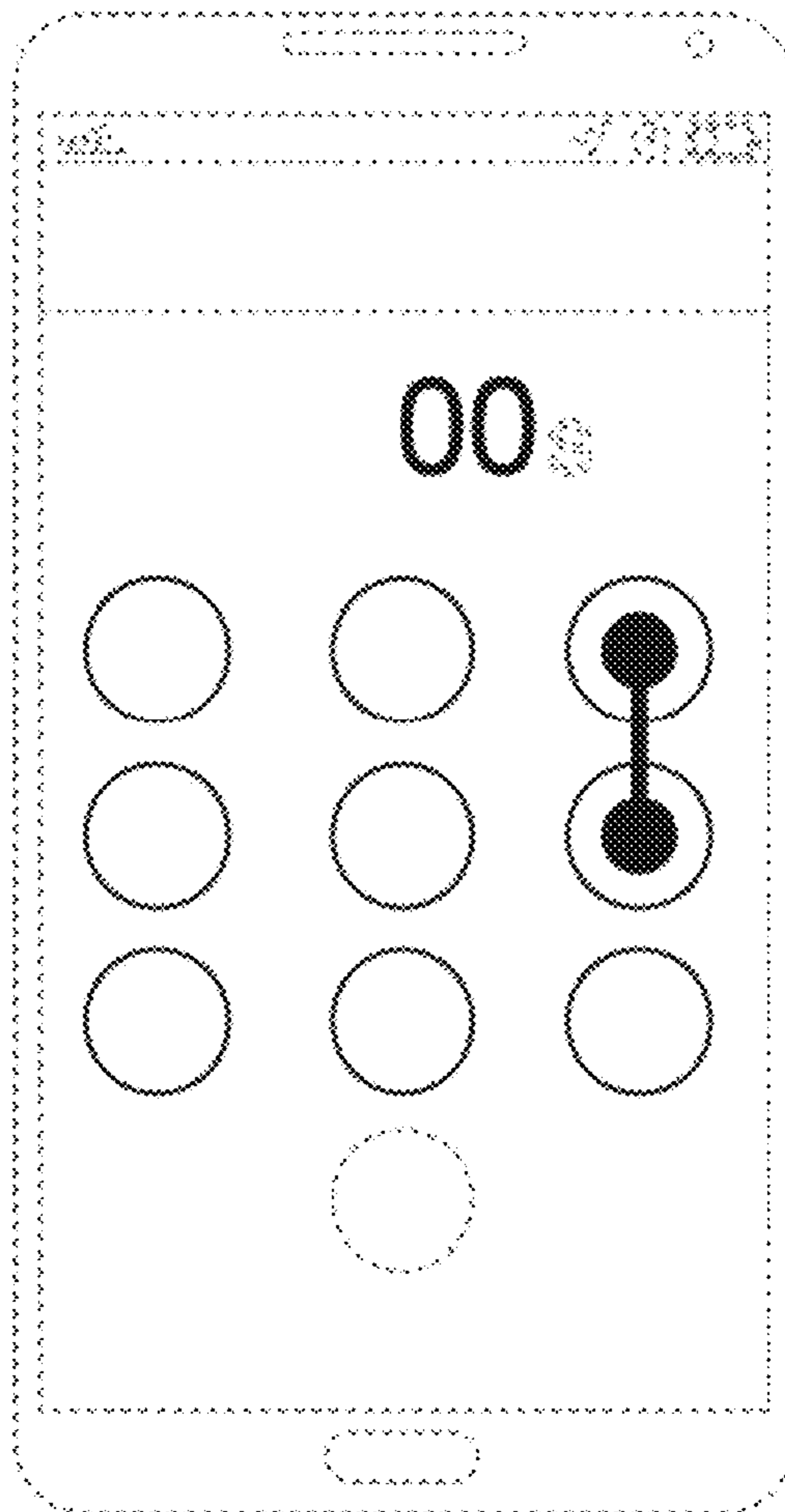

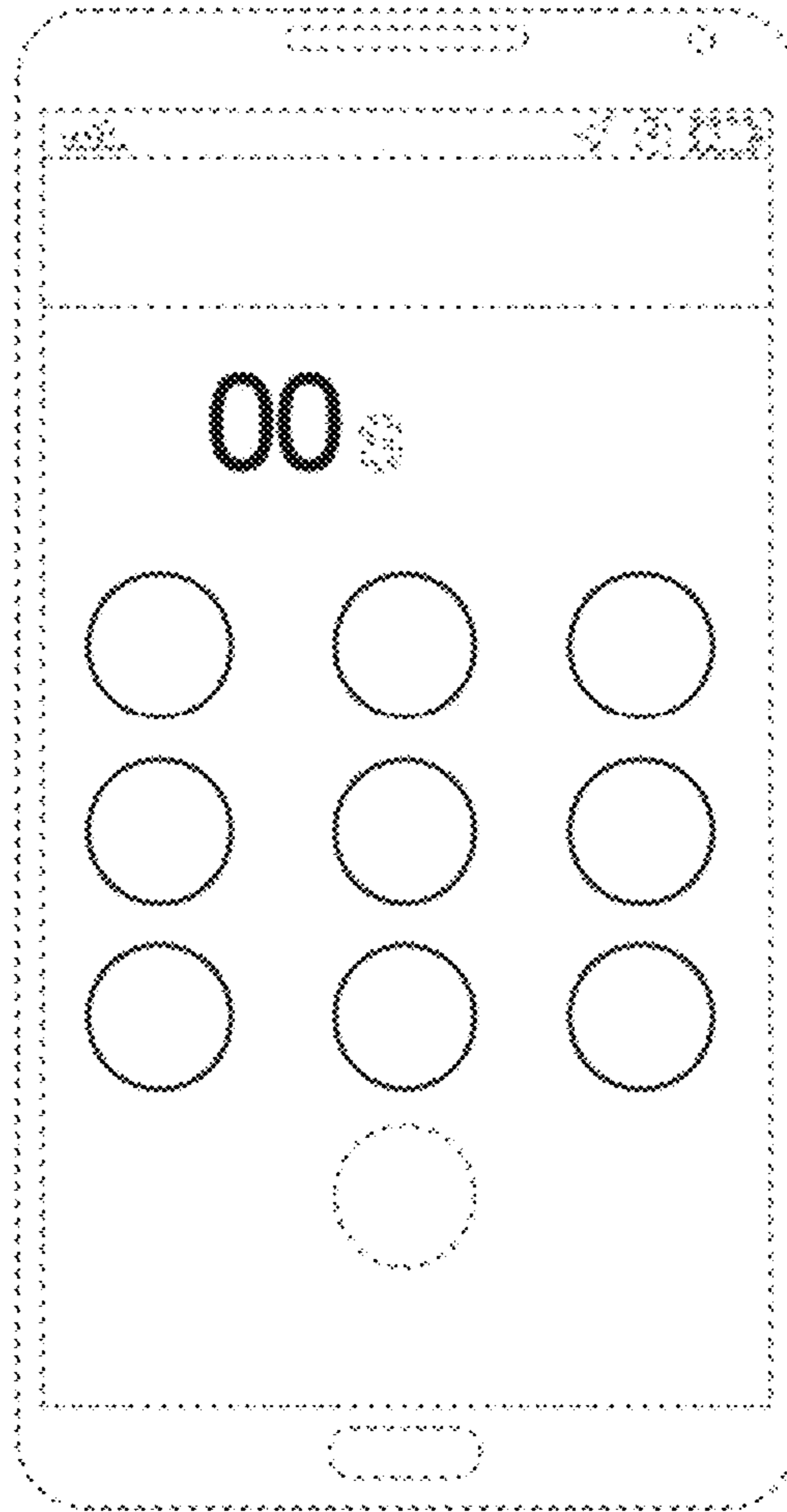

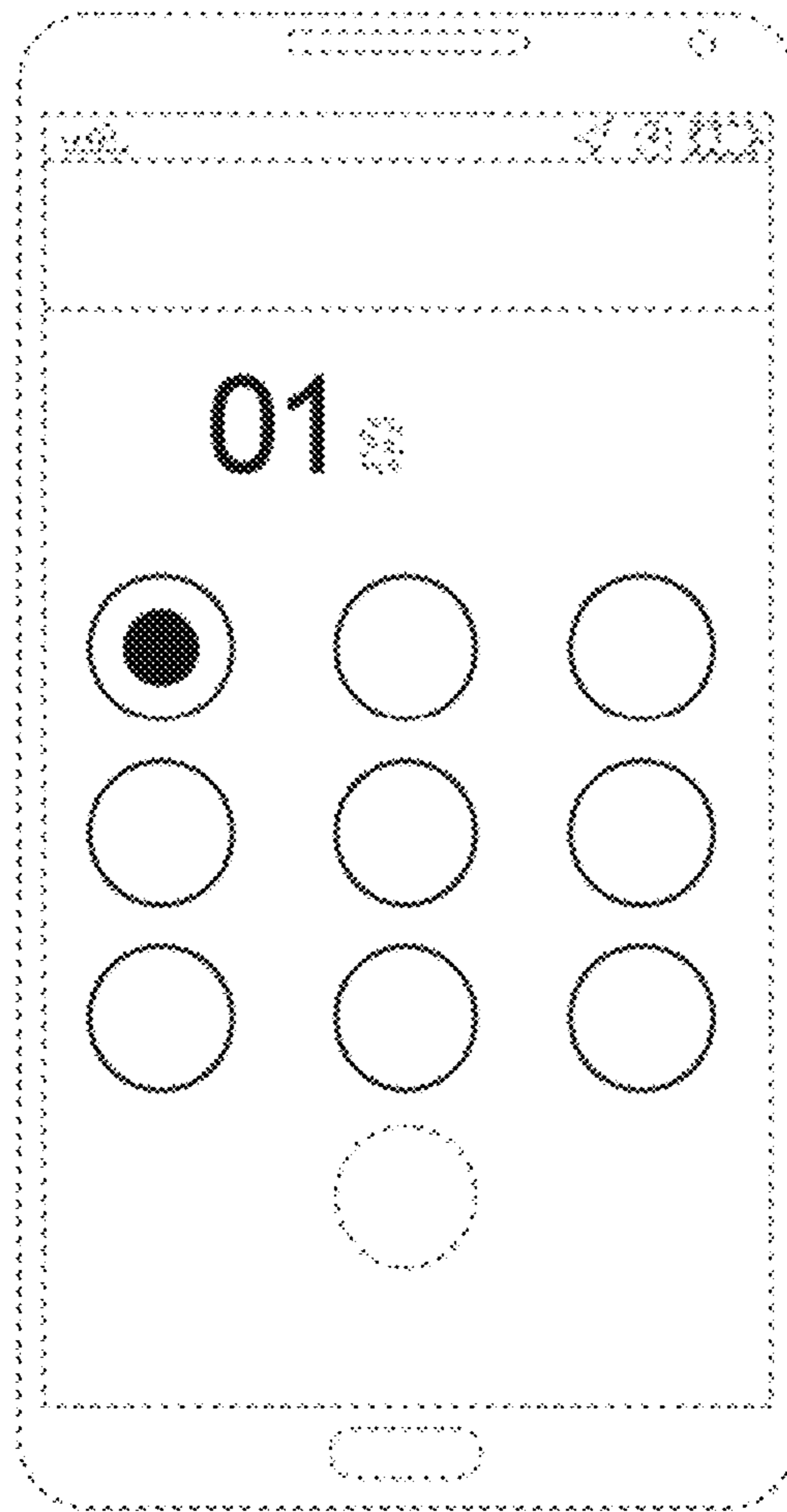

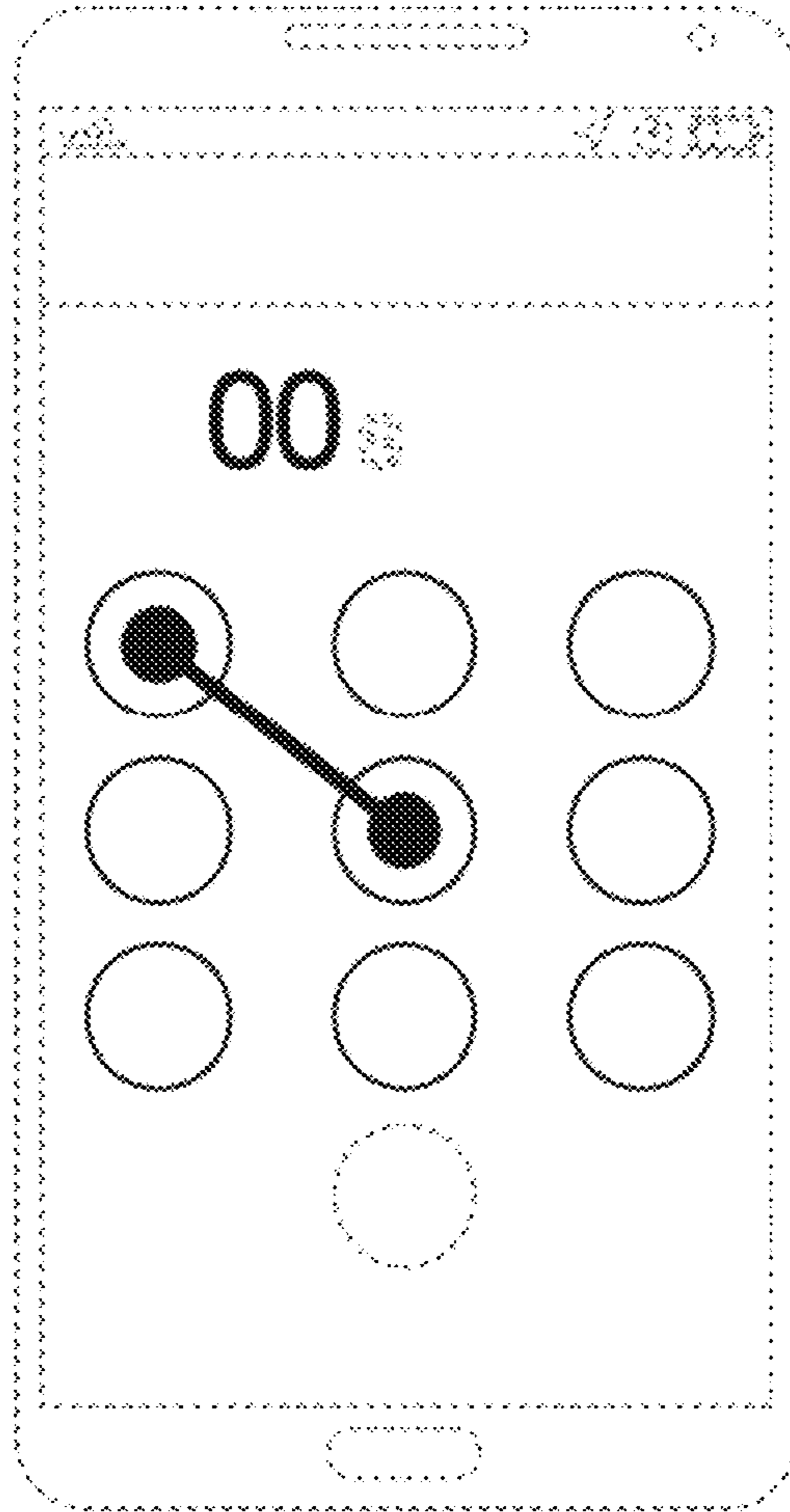
