The ornamental design for a reticle system, as shown and described.

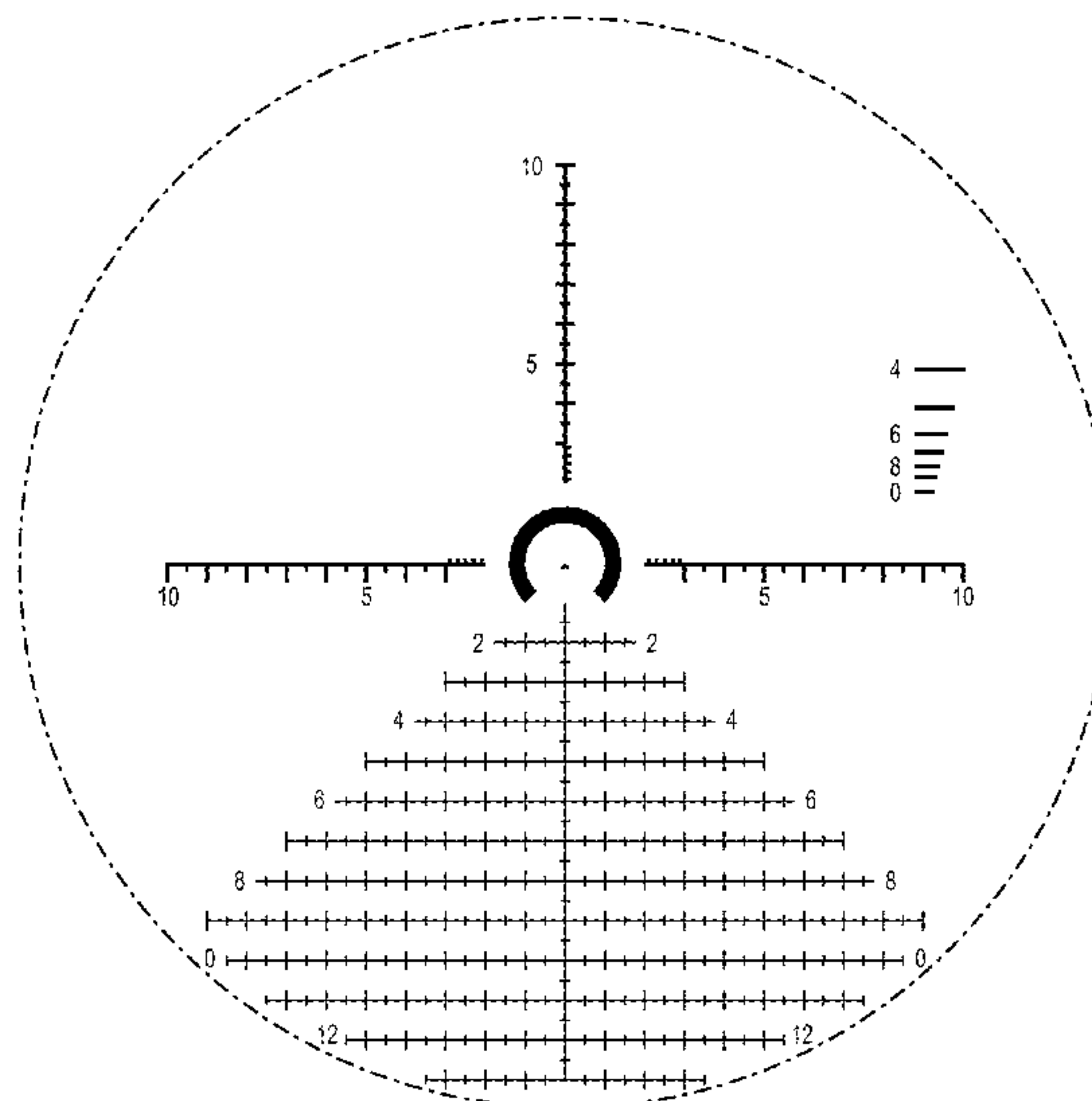
DESCRIPTION

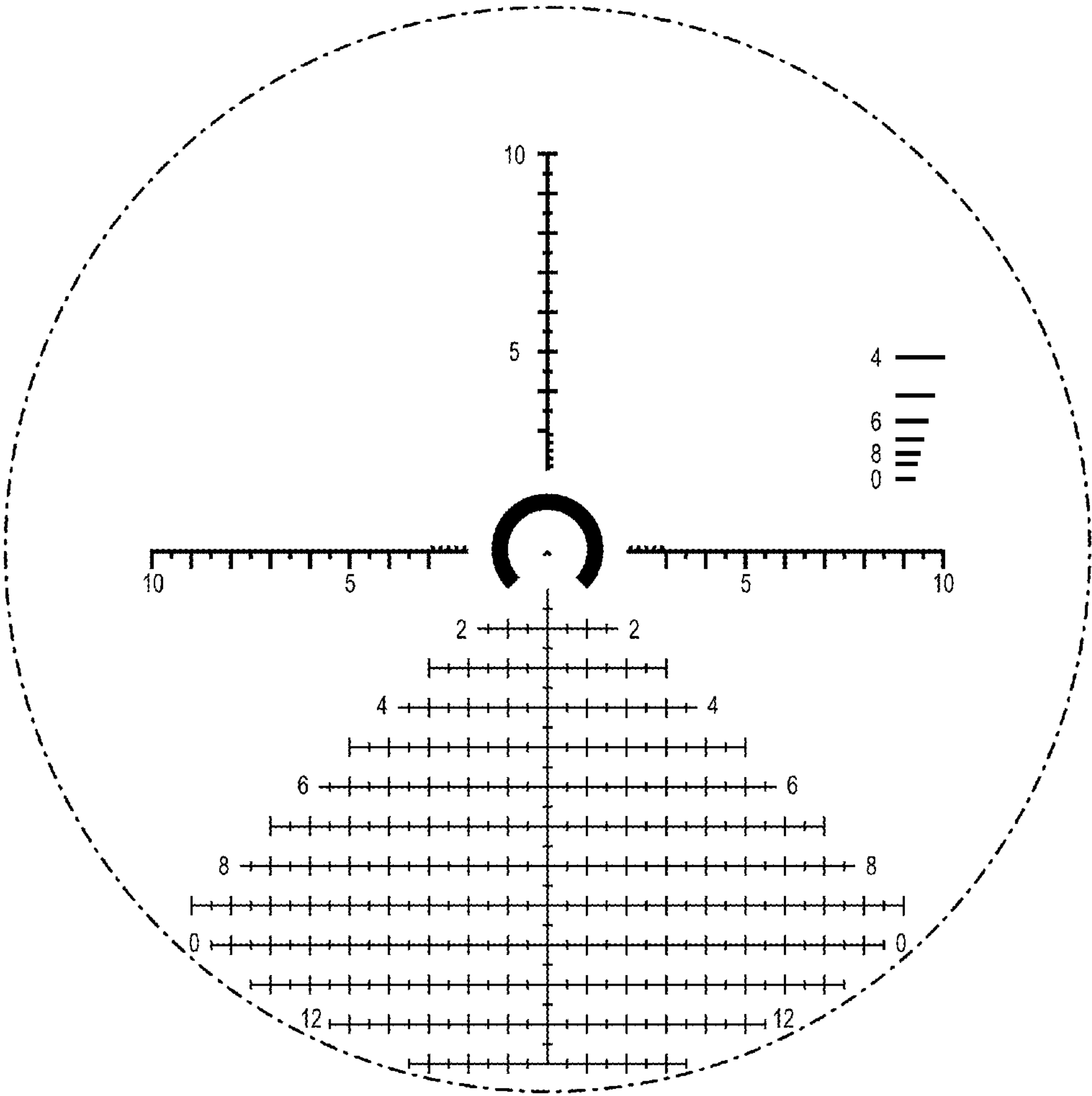

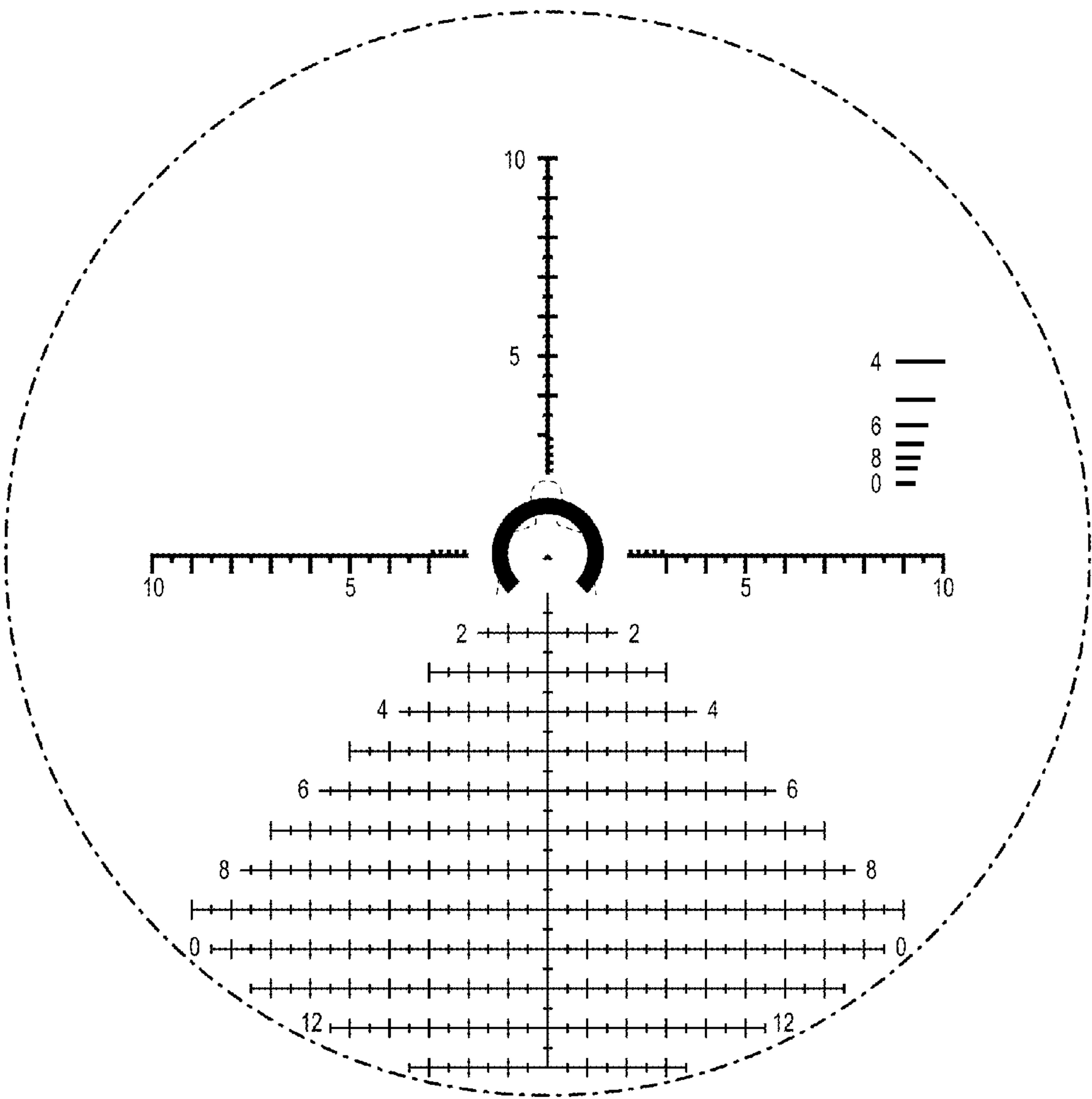
