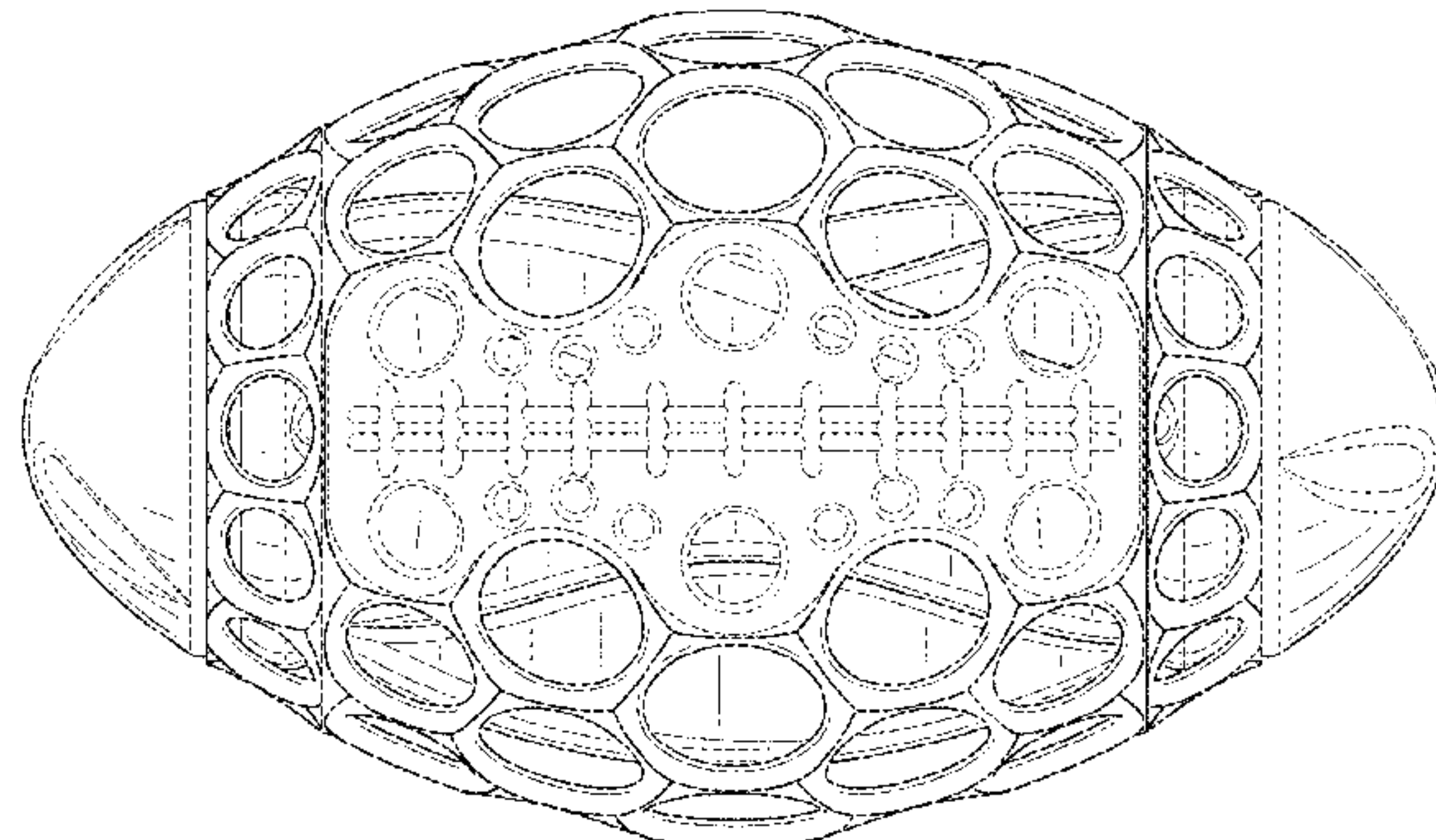
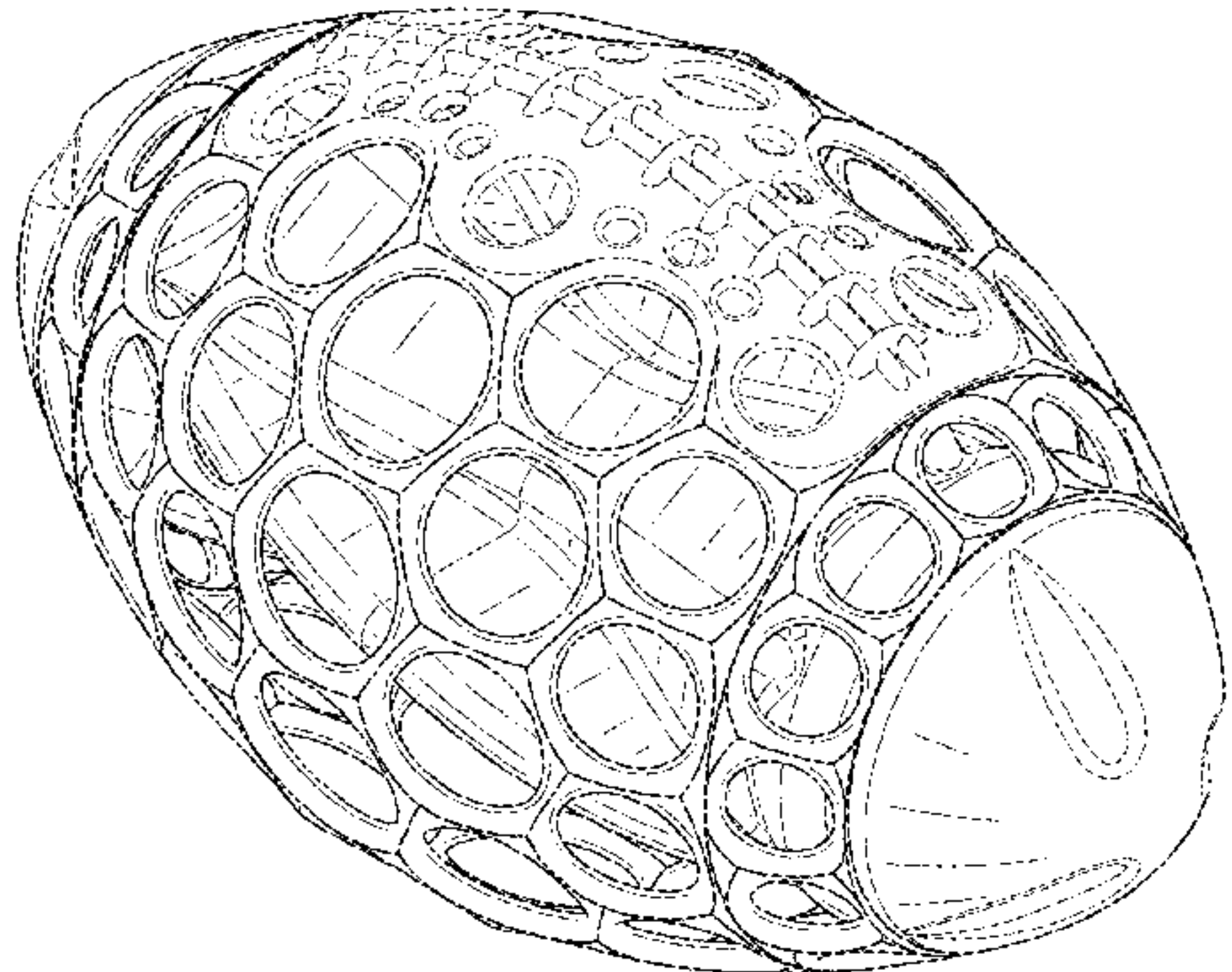

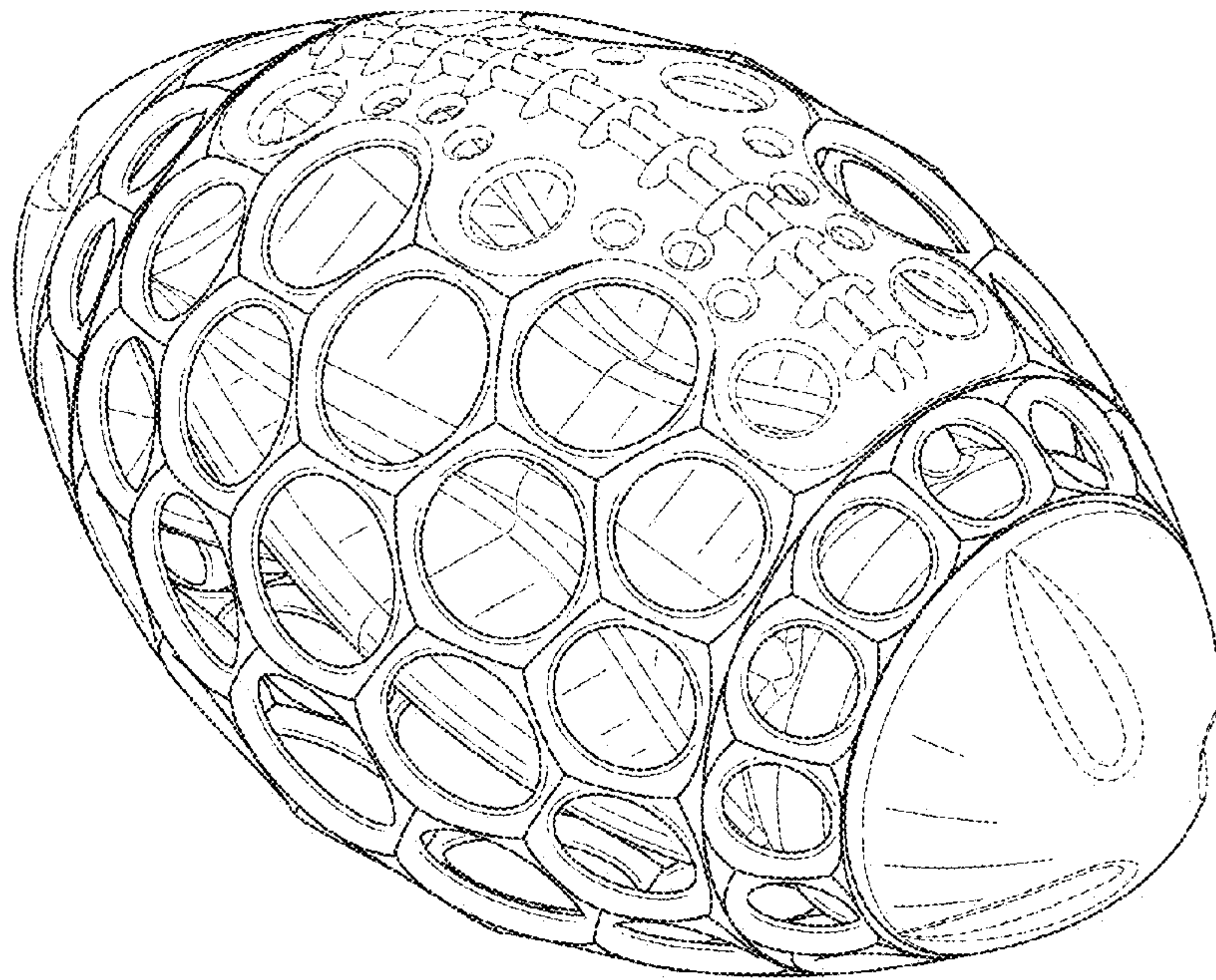
(57) **CLAIM**

only and form no part of the claimed design.

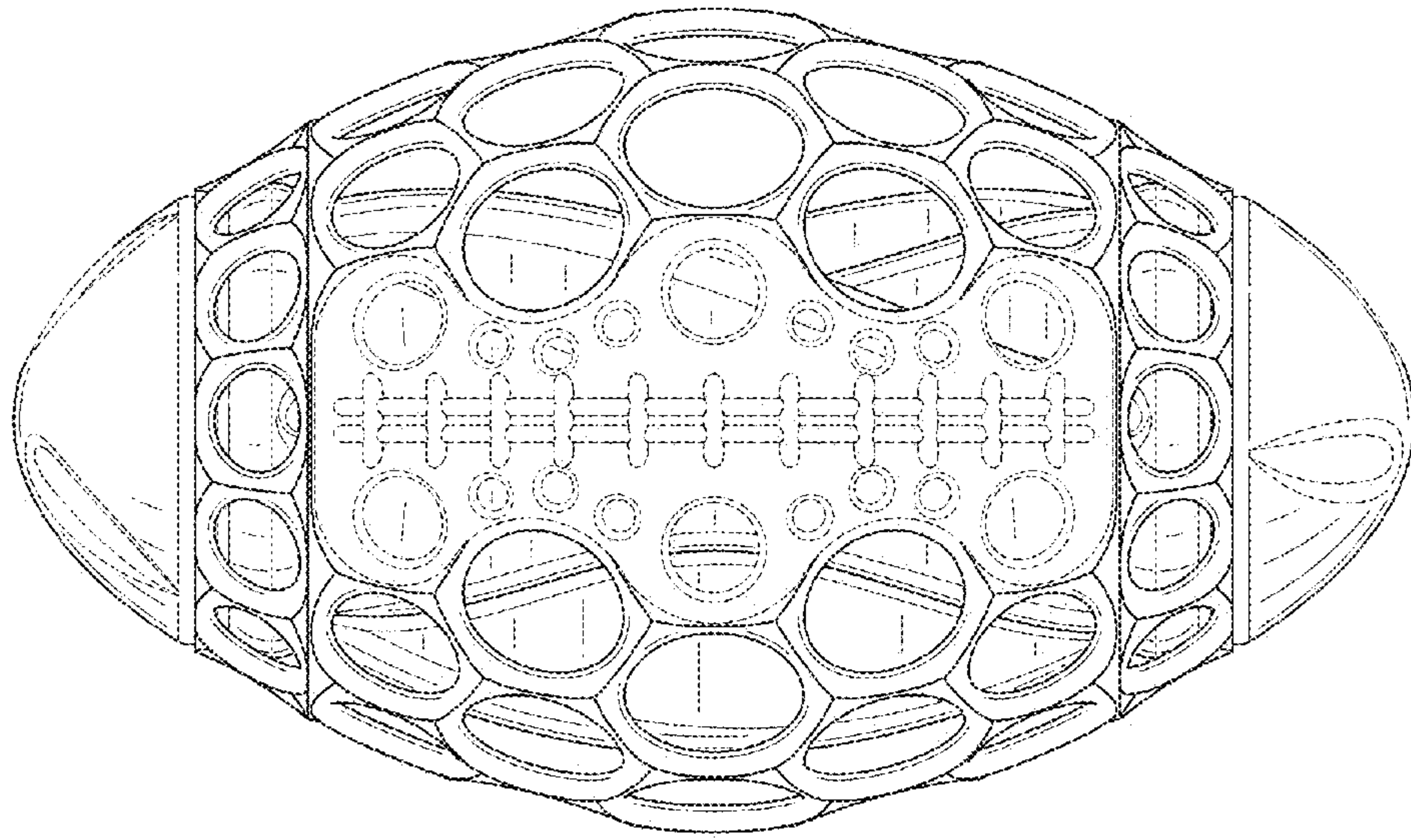

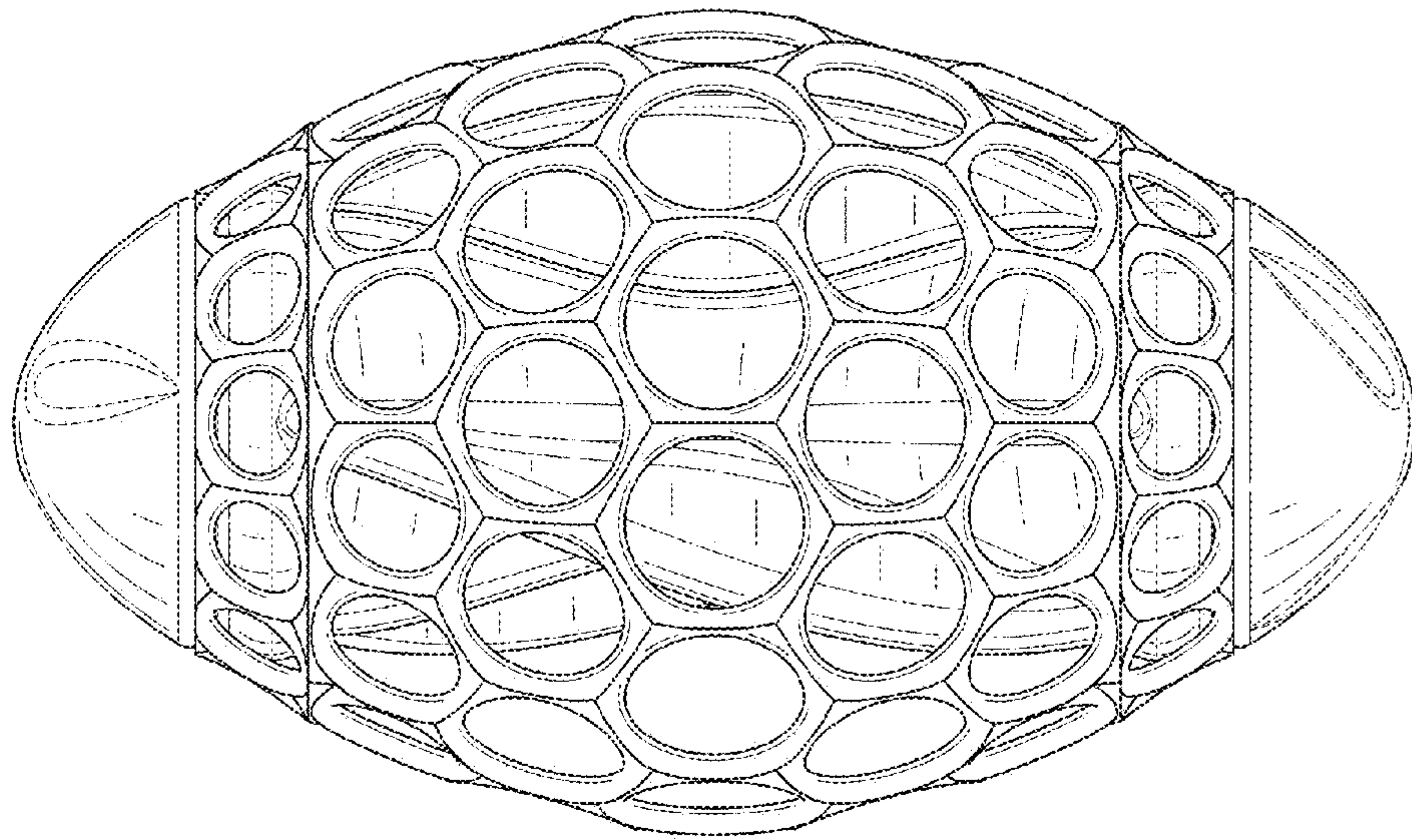

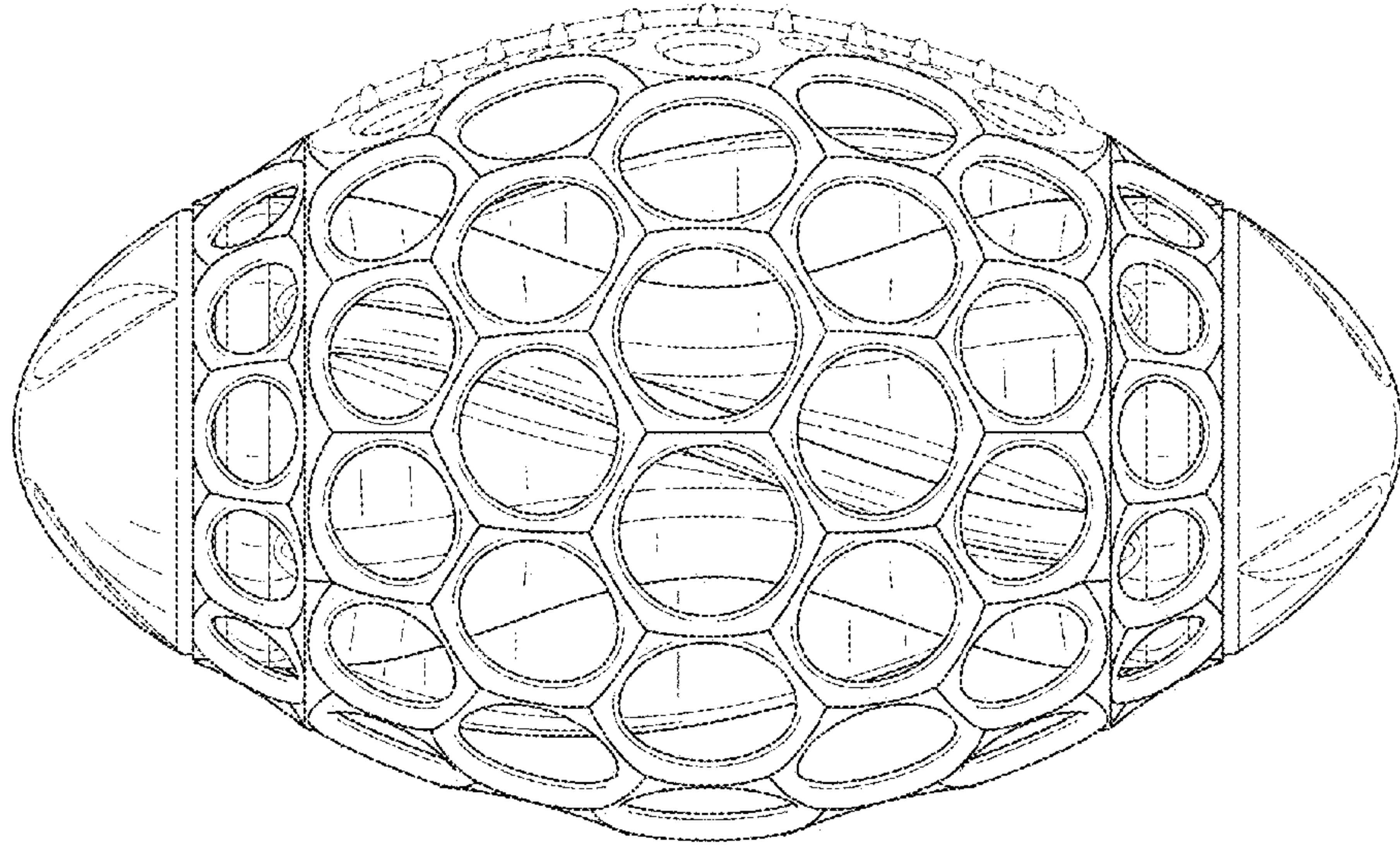




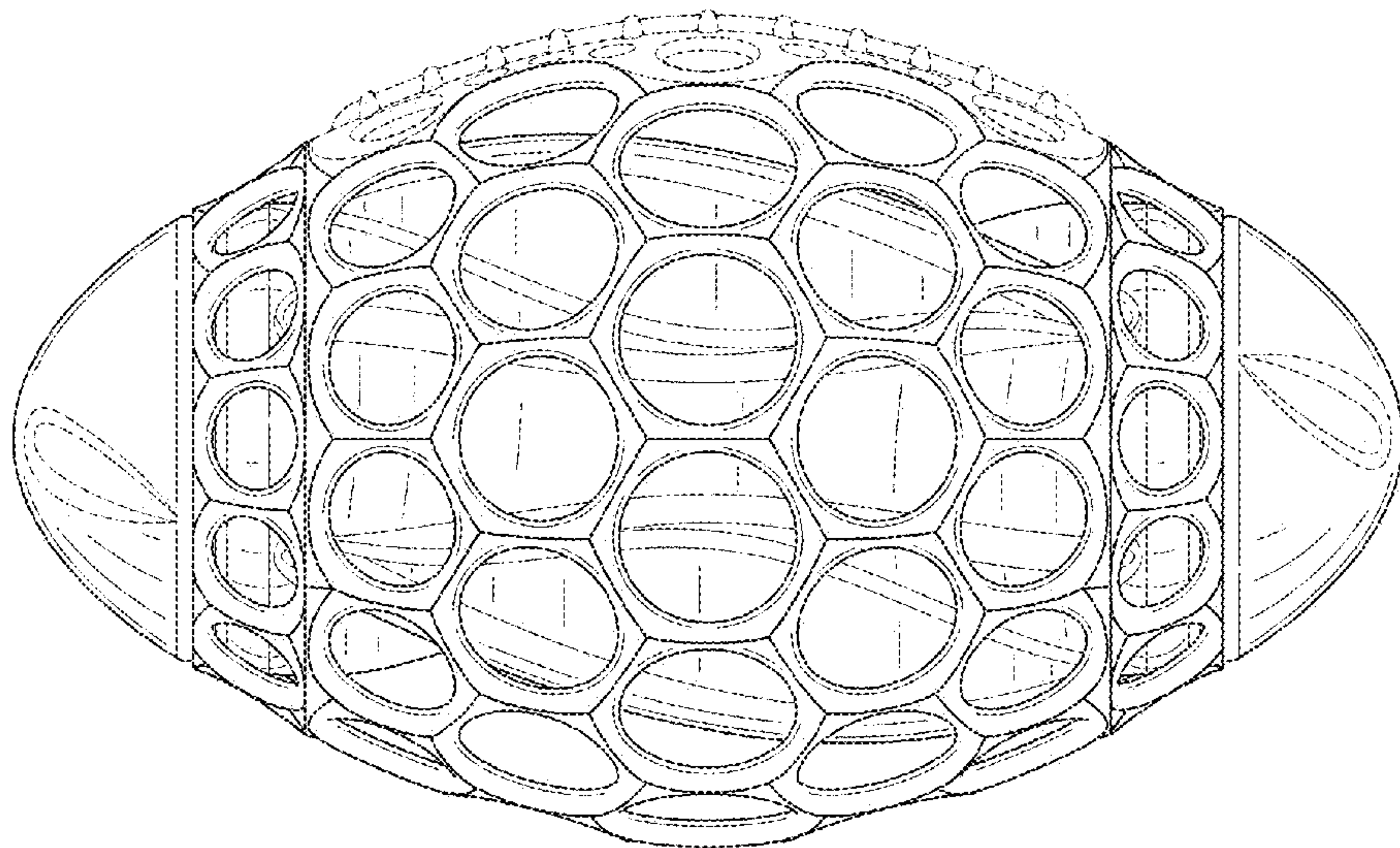

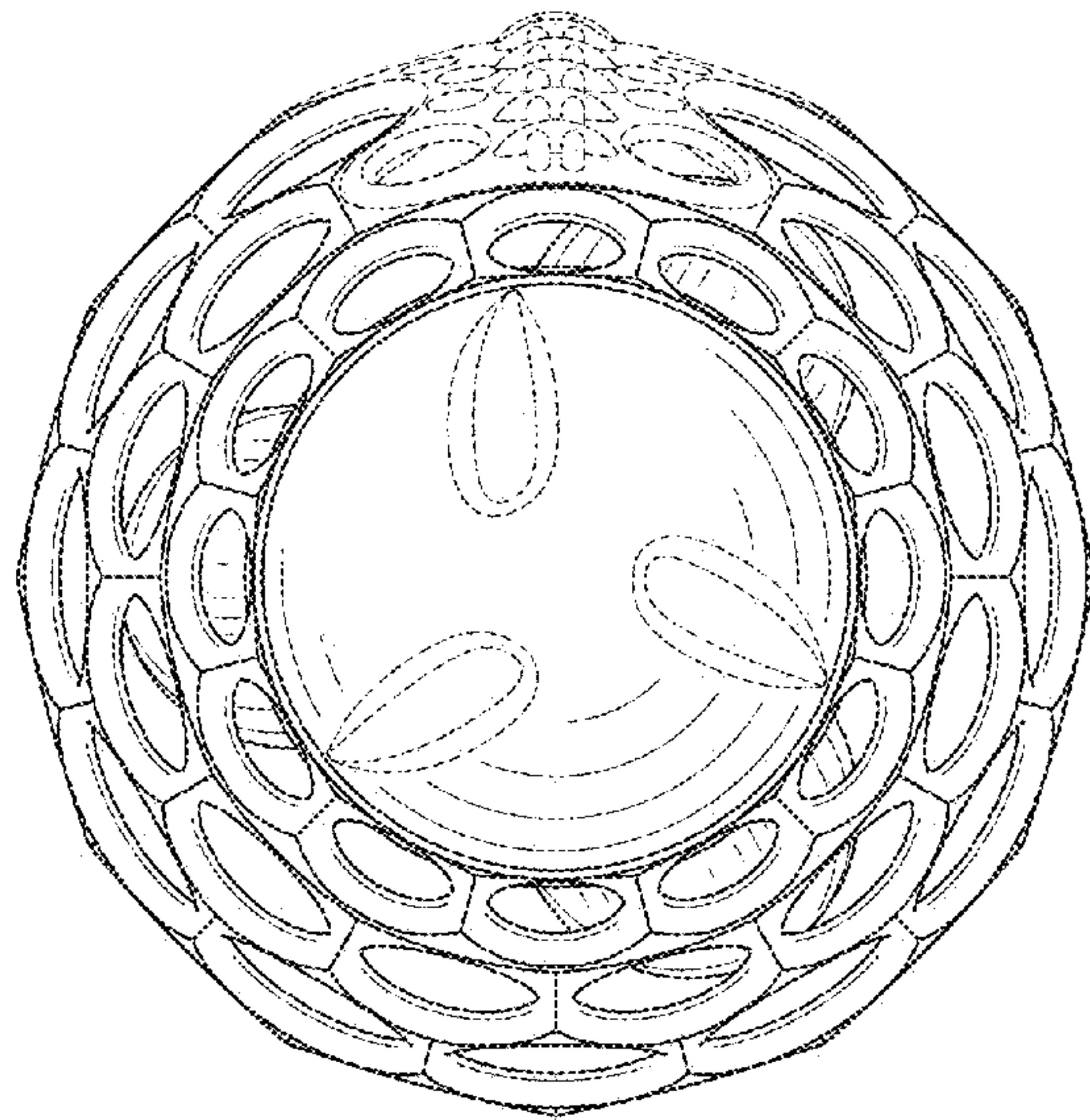

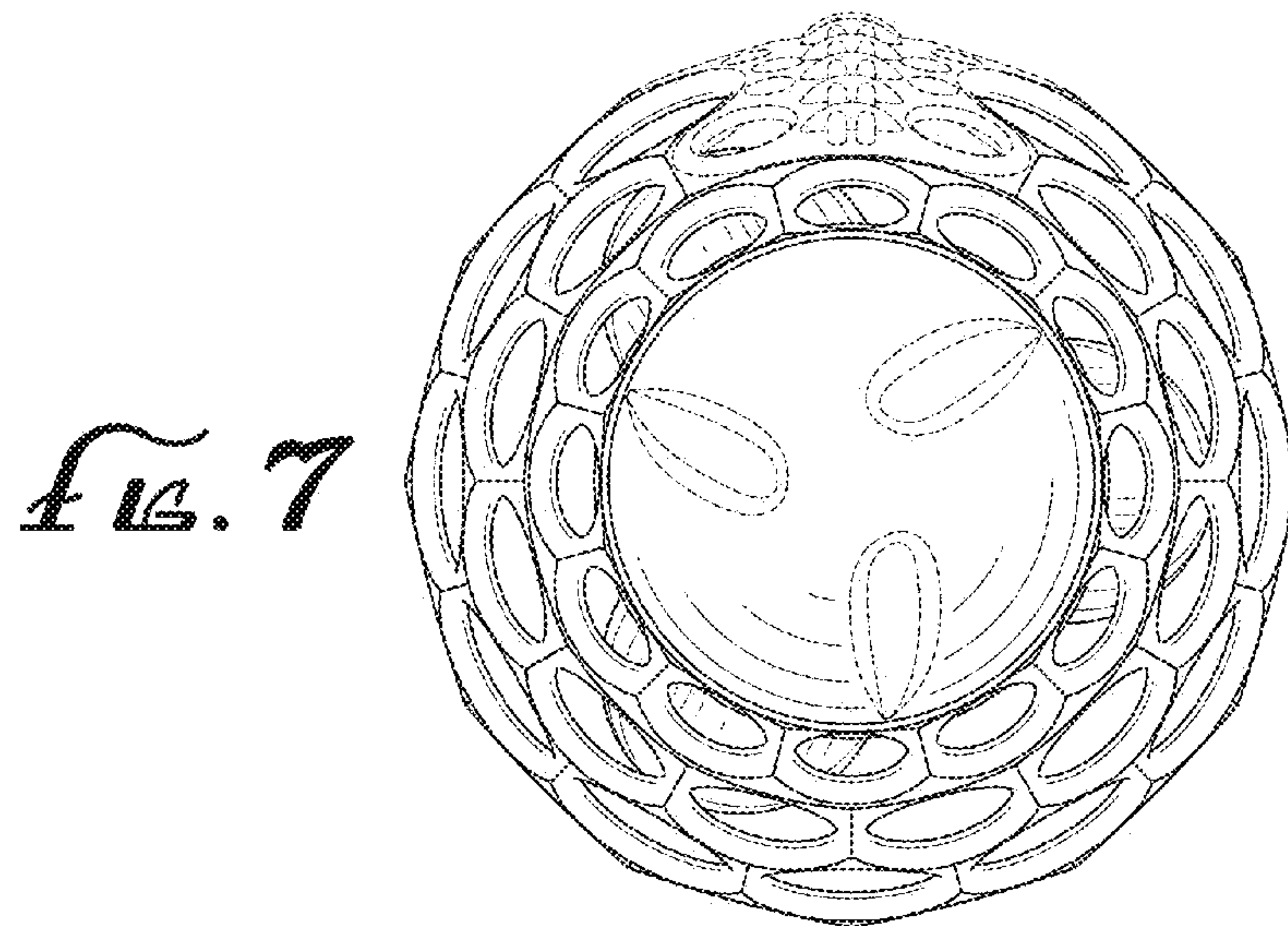
