DESCRIPTION

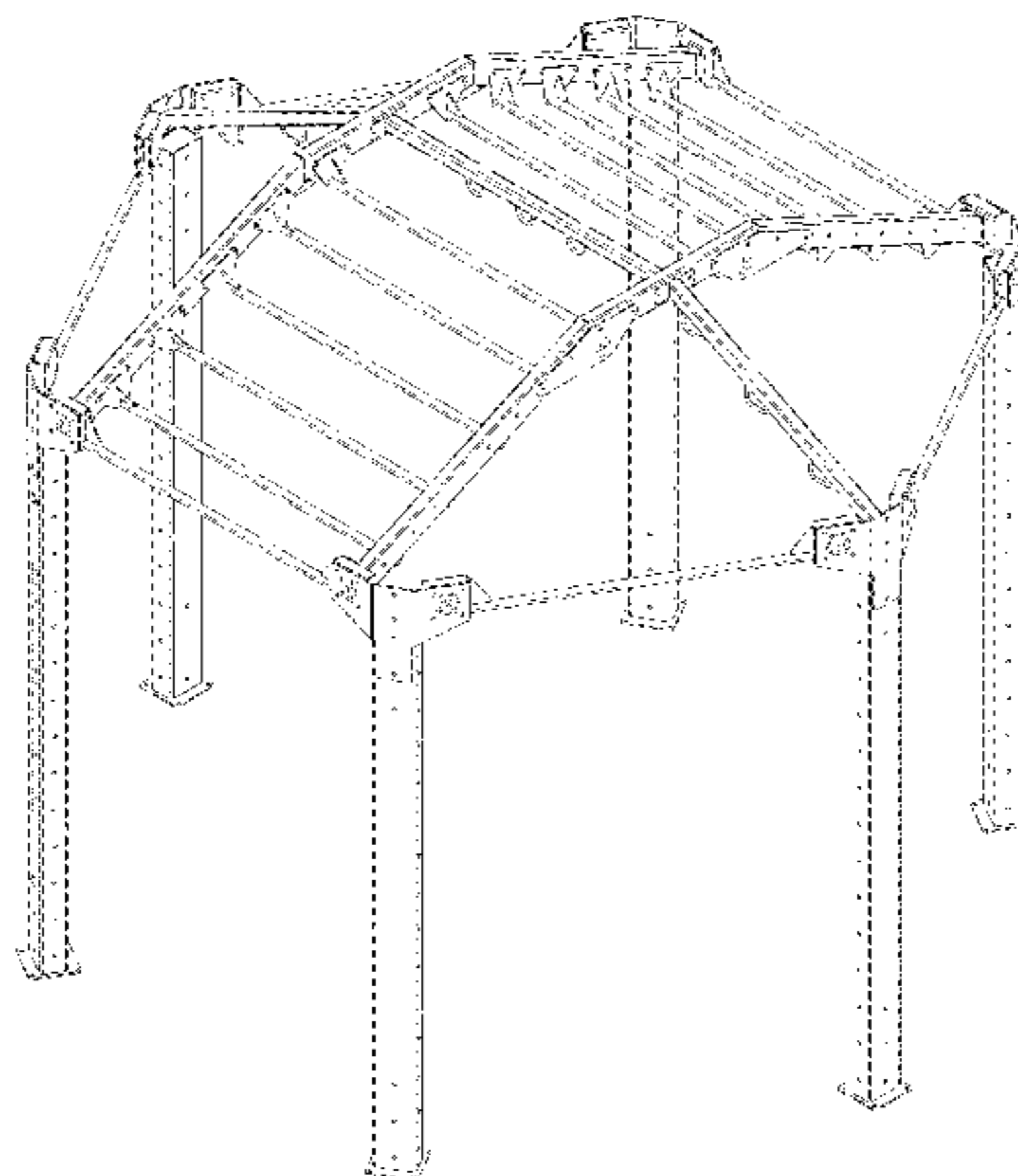
FIG. 1 is a front perspective view of the training station of Applicant's invention.

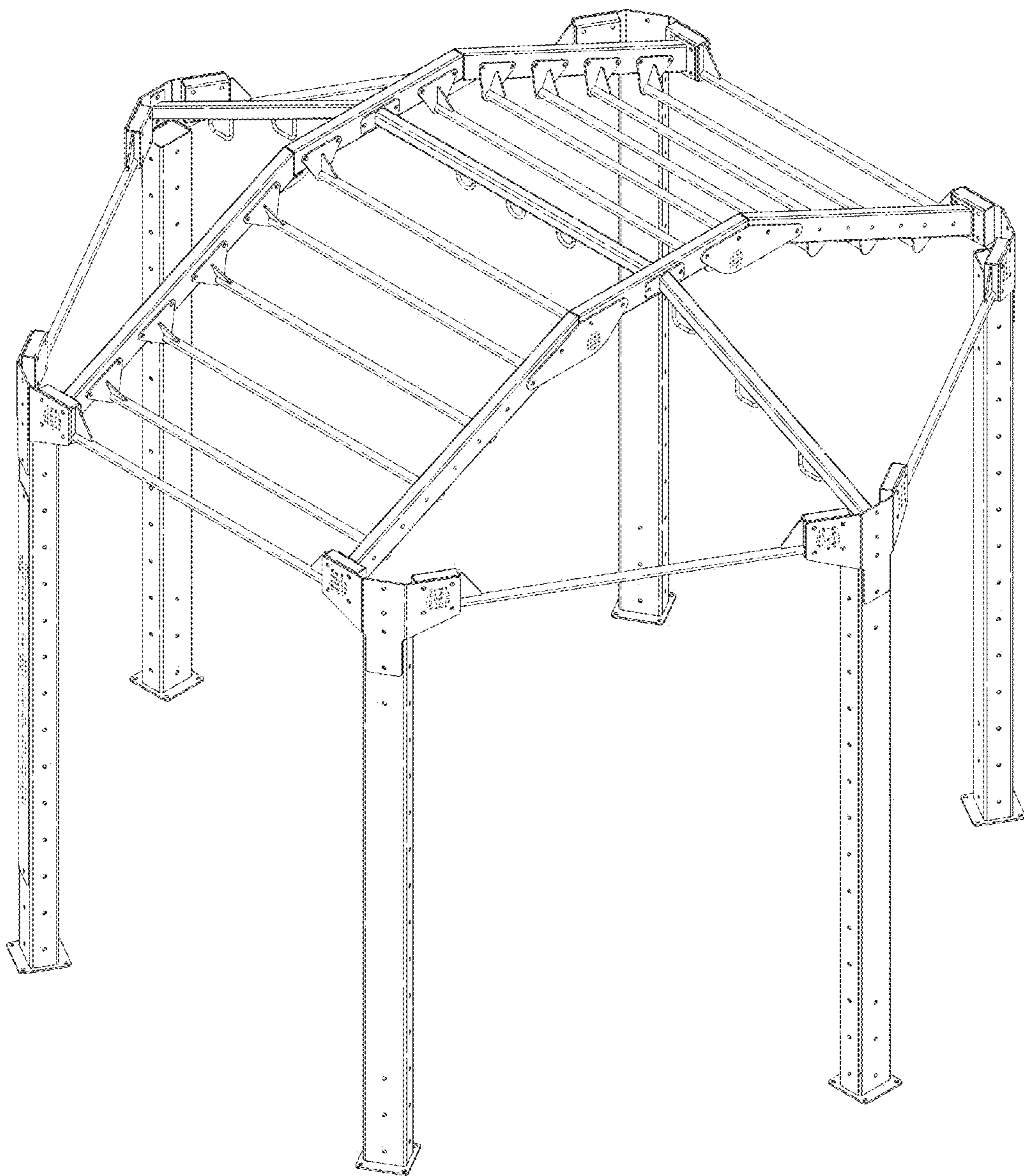

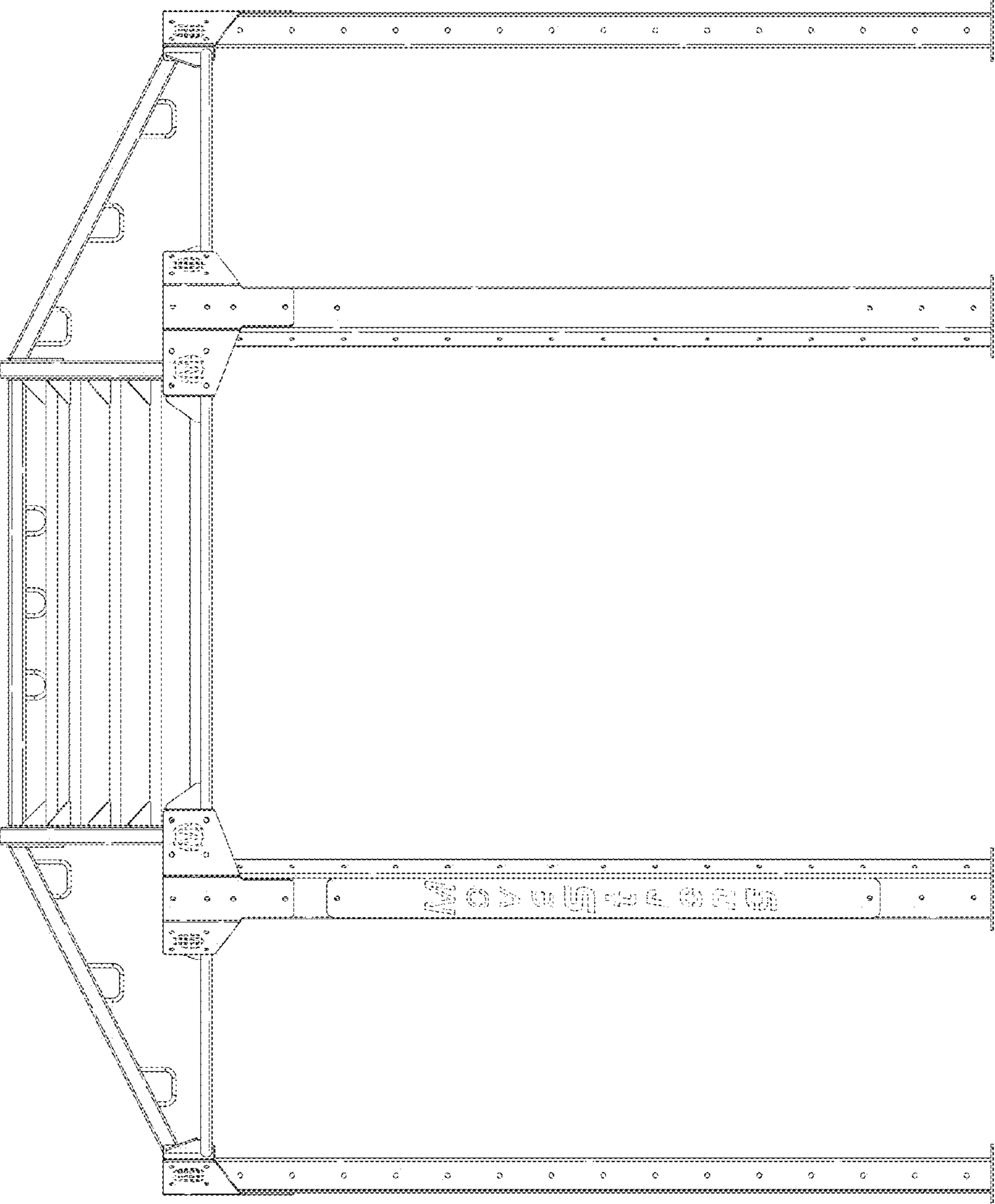

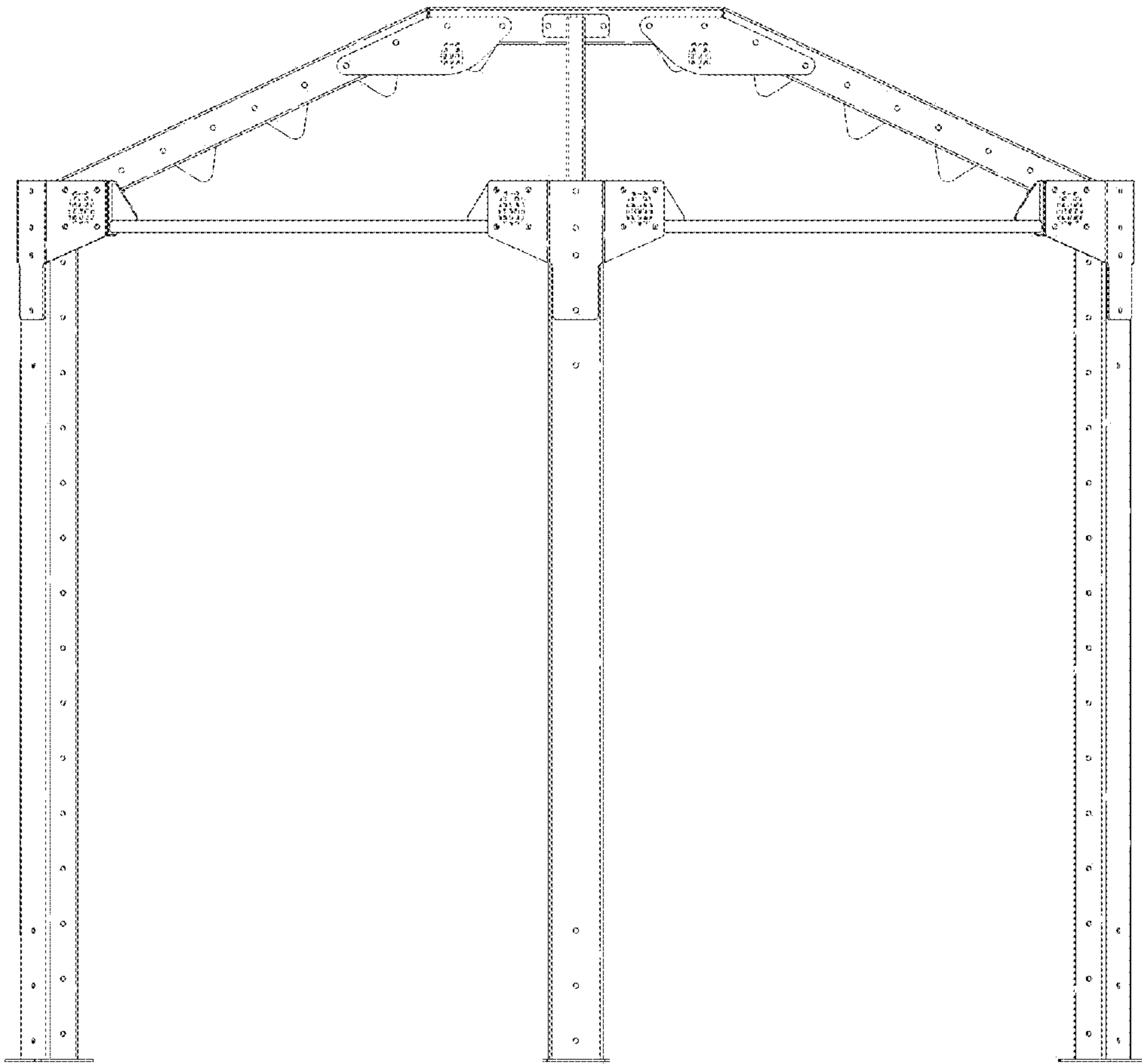

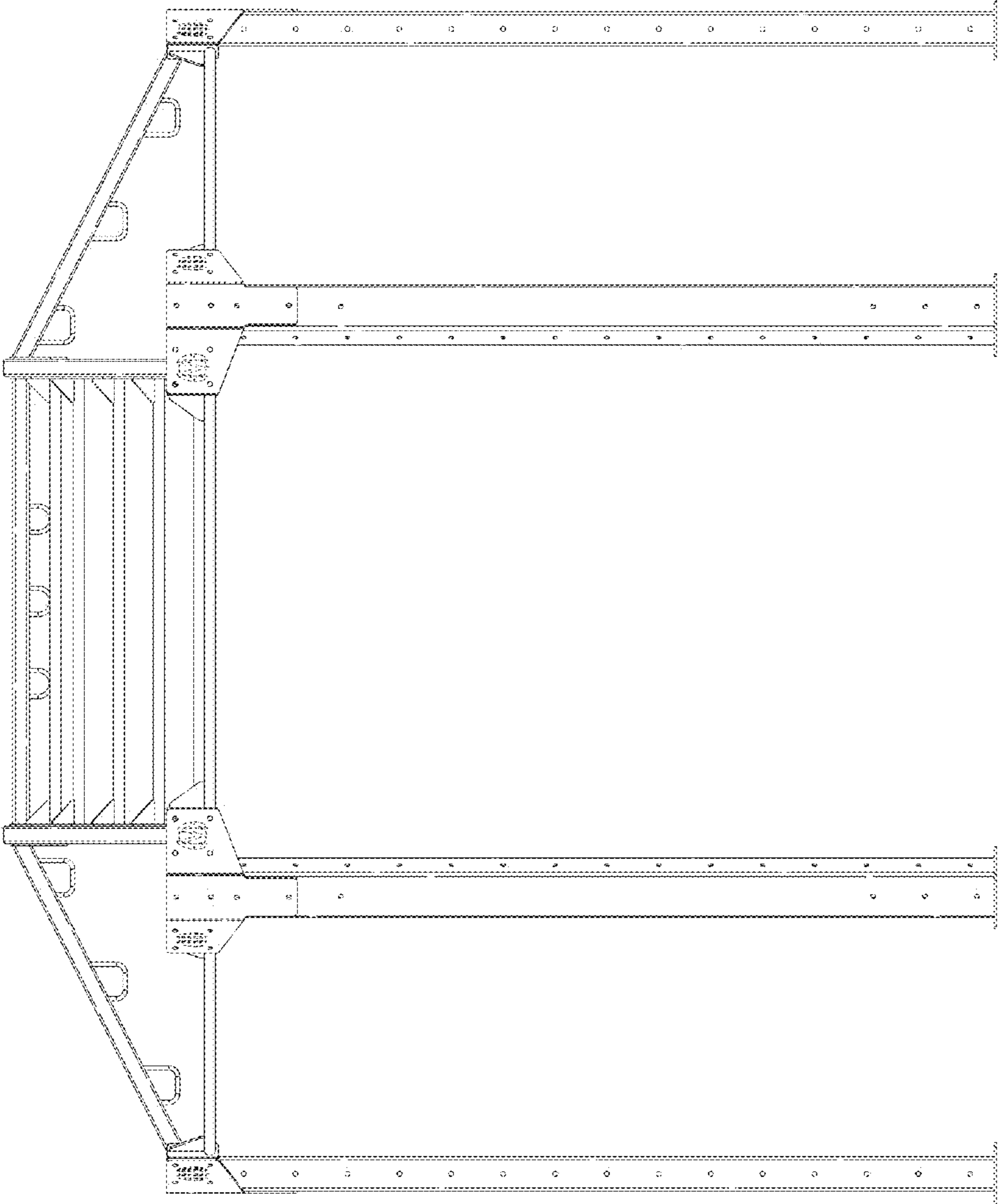

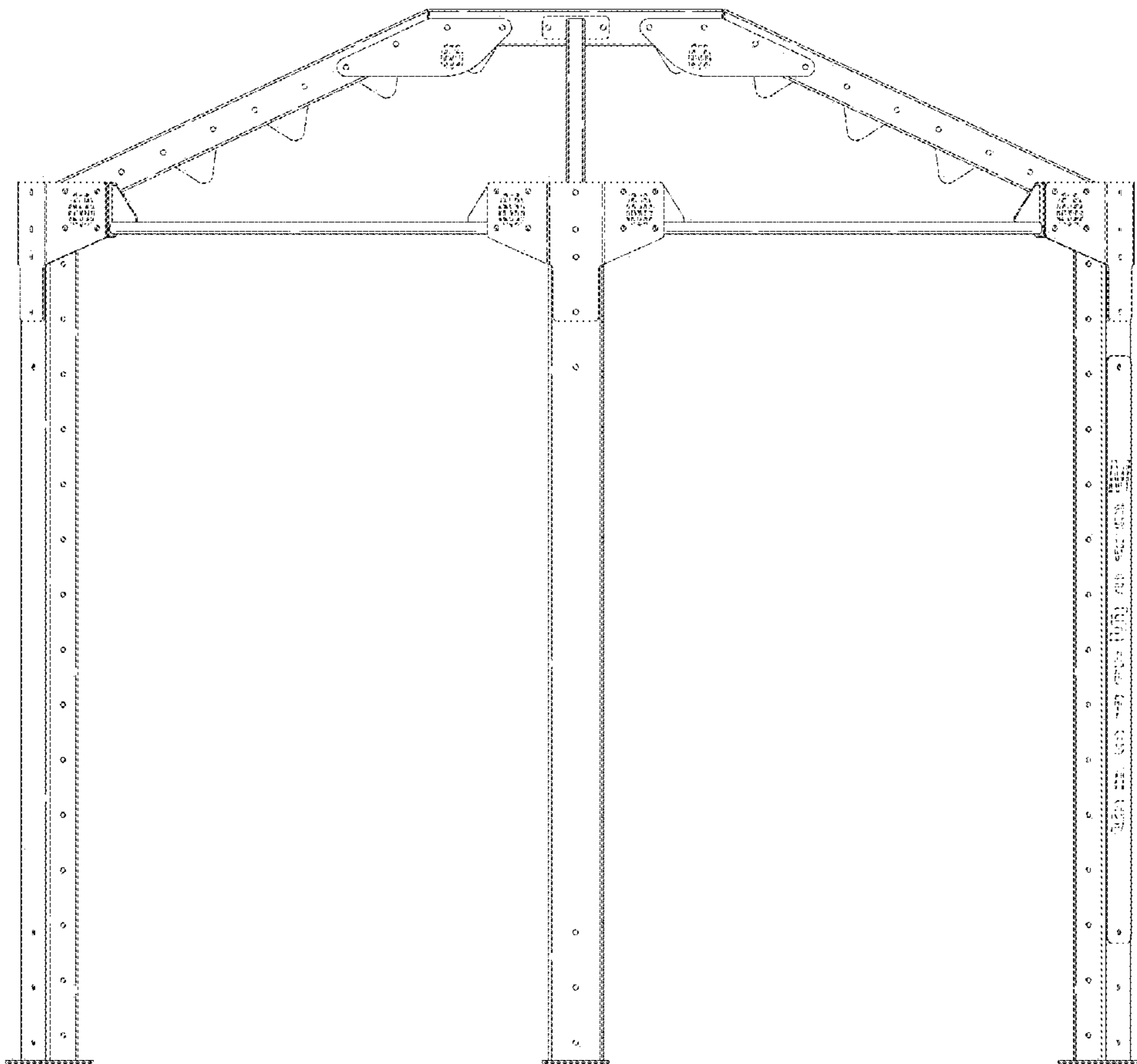

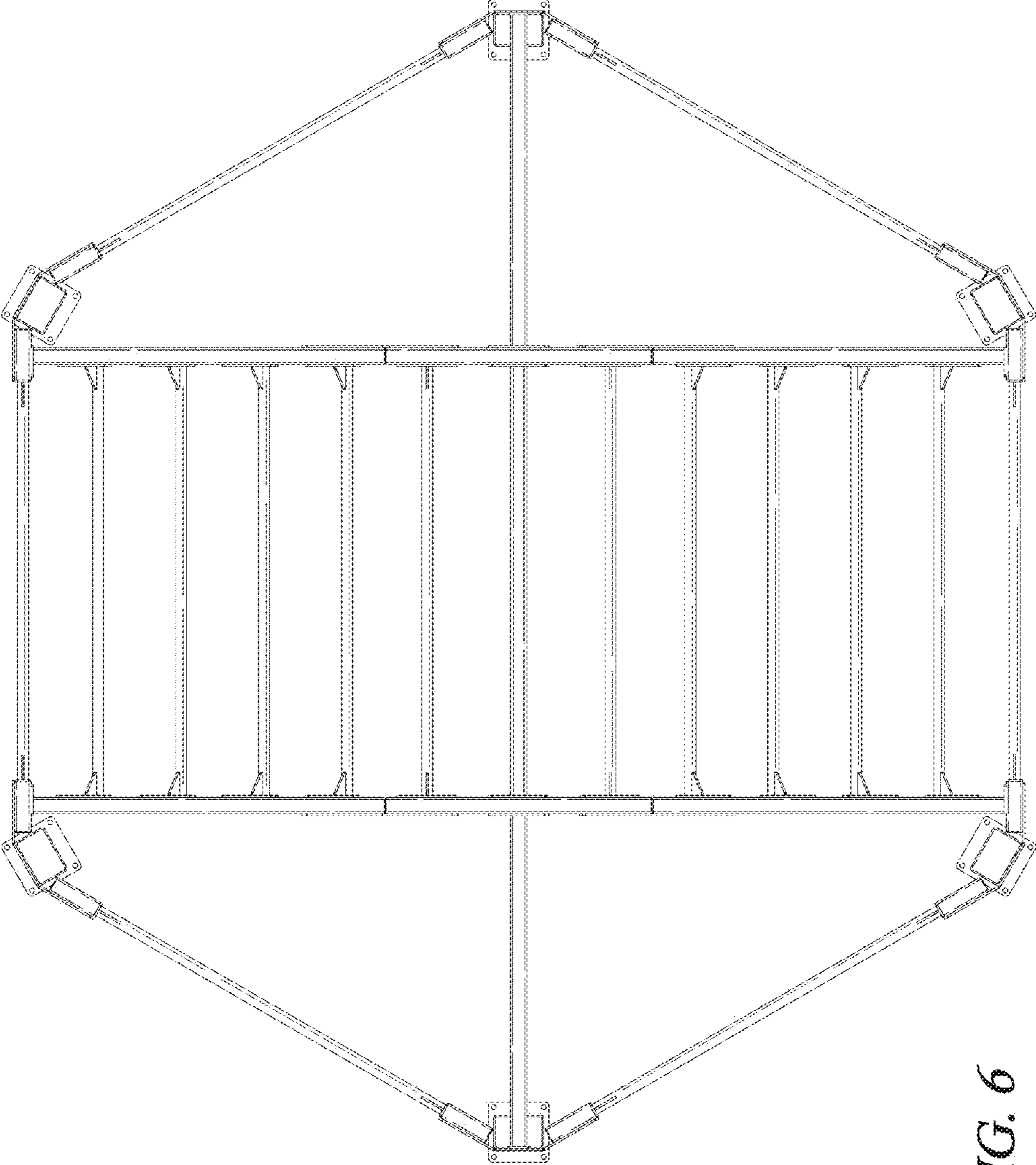

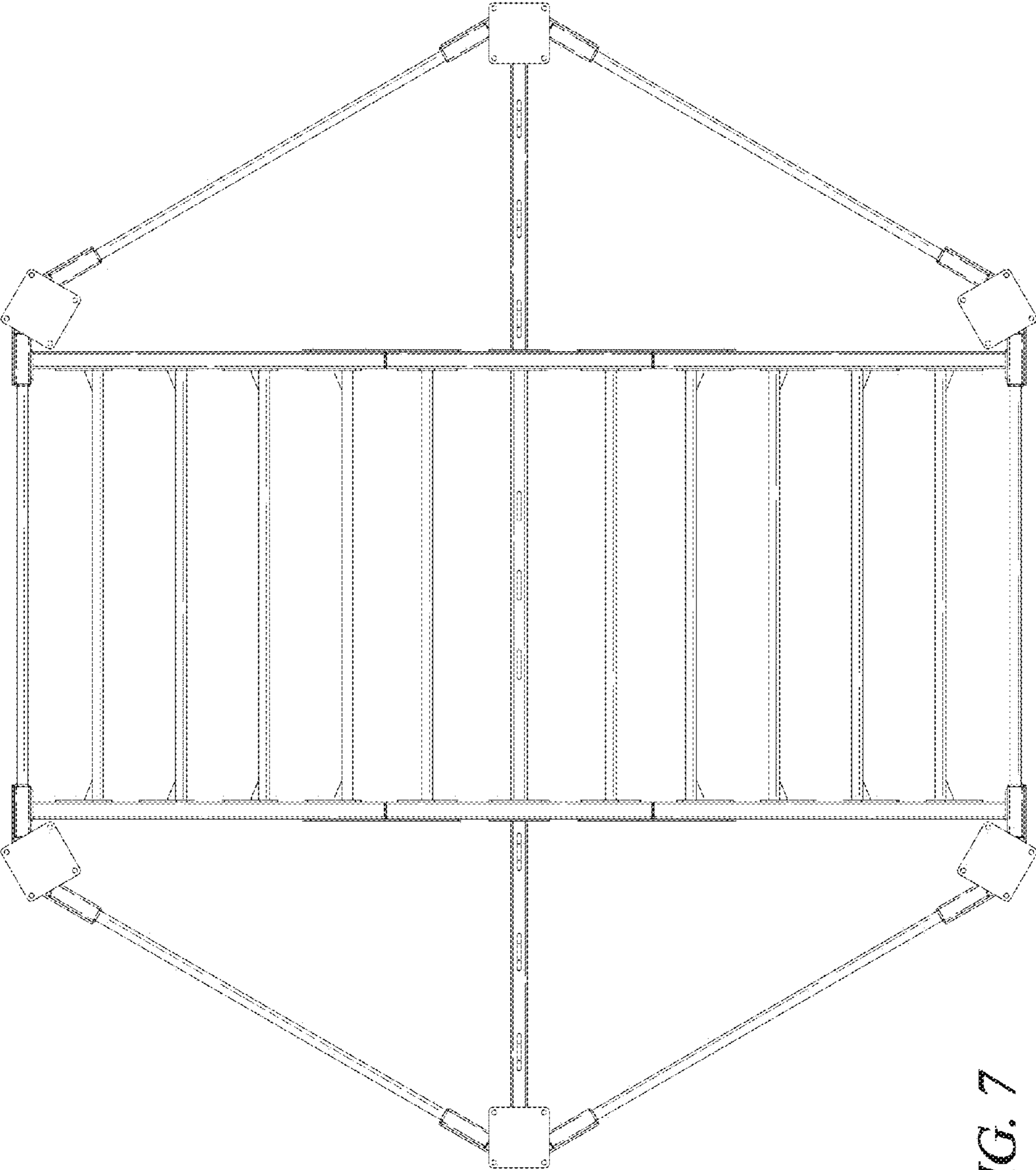
