FIG. 1 is a top back perspective view of our new iron golf club head;
FIG. 2 is a back view thereof;

FIG. 5 is a front view thereof;
FIG. 6 is a heel side view thereof; and,
FIG. 7 is a toe side view thereof.

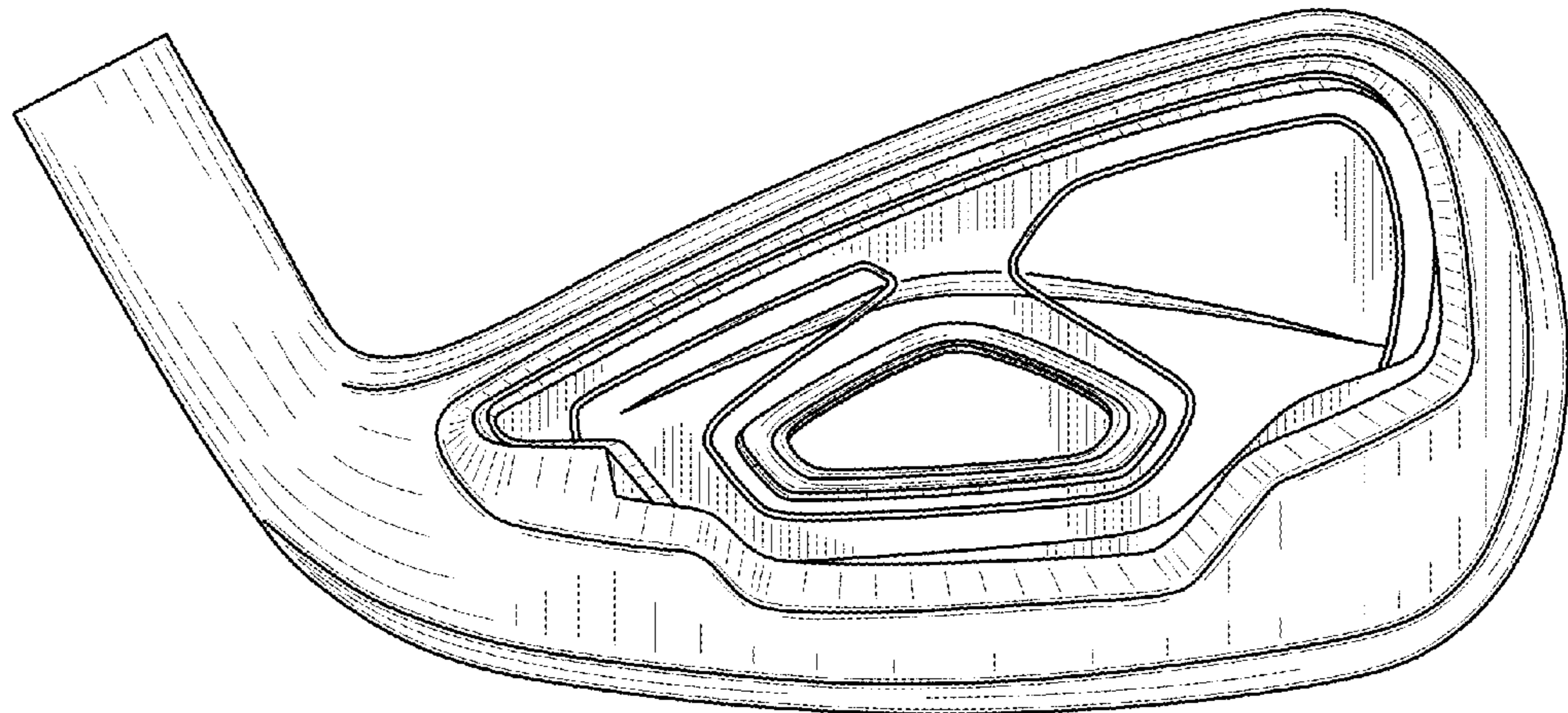

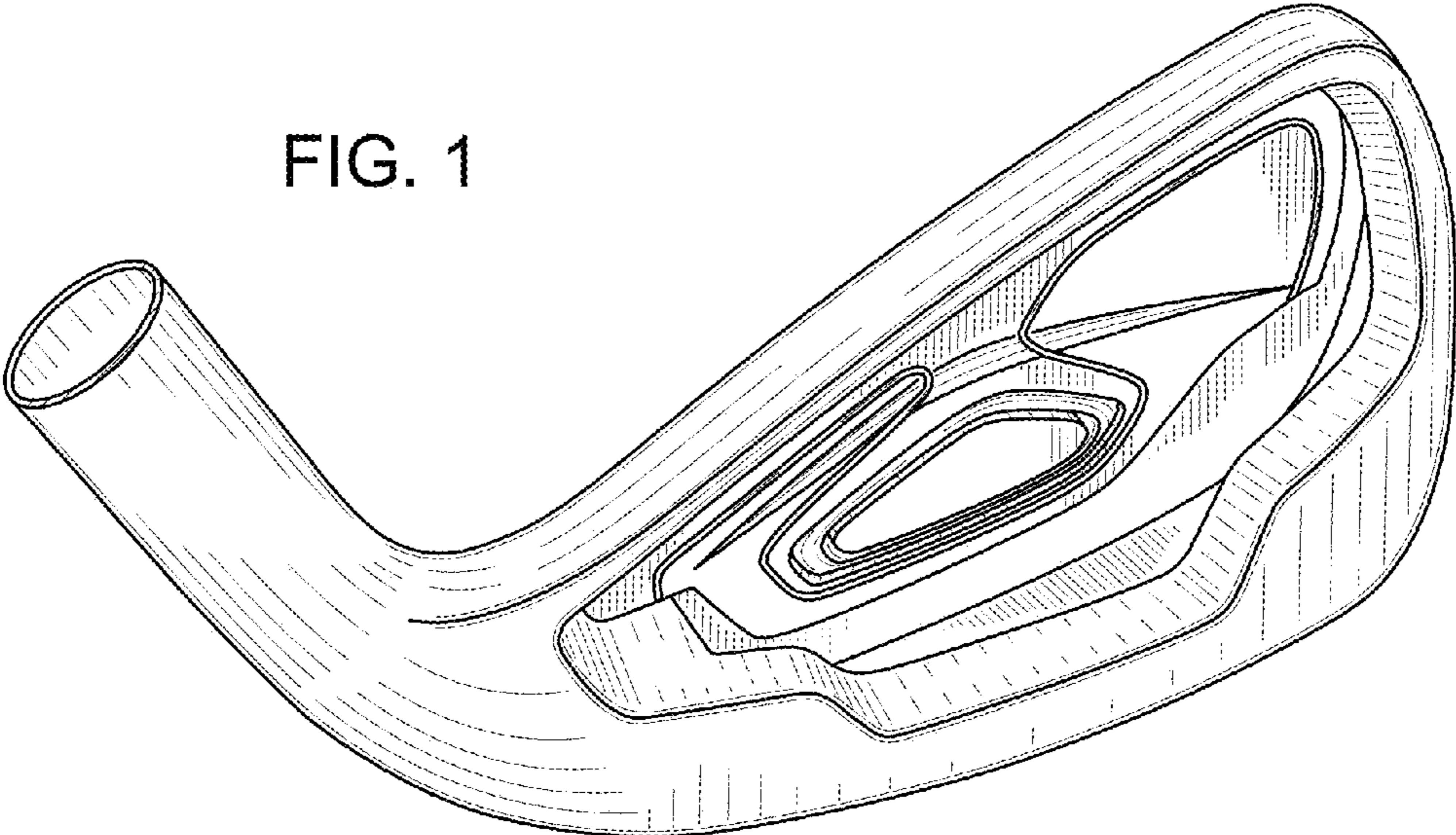

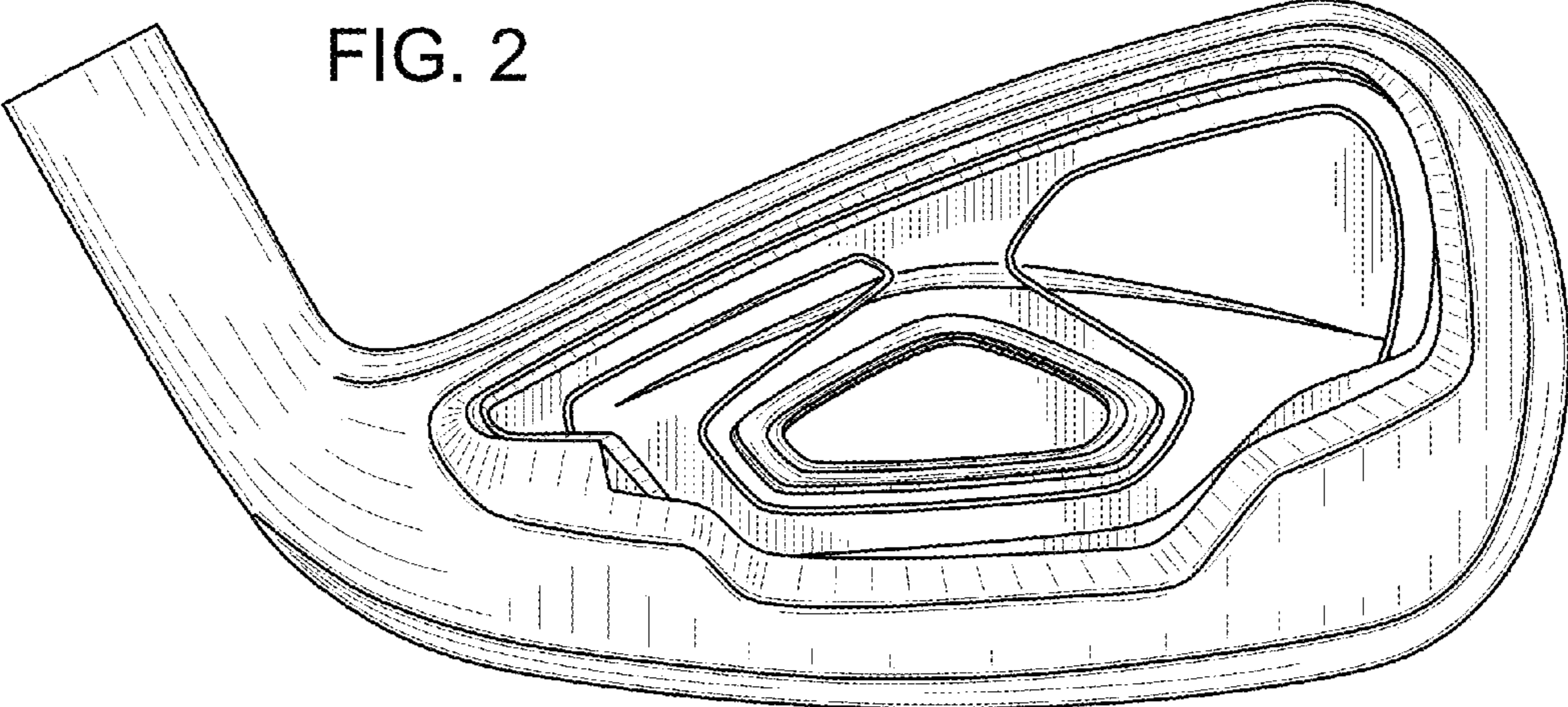

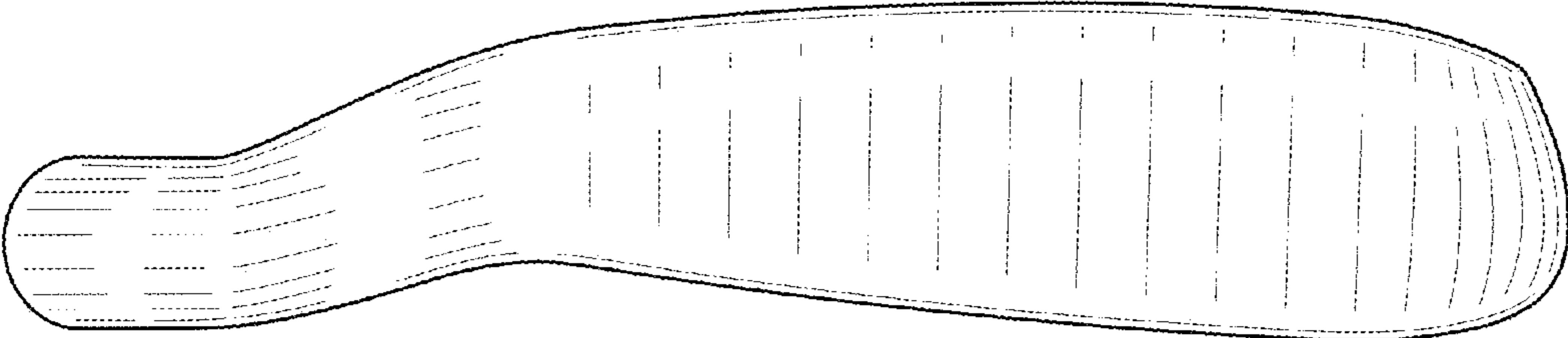

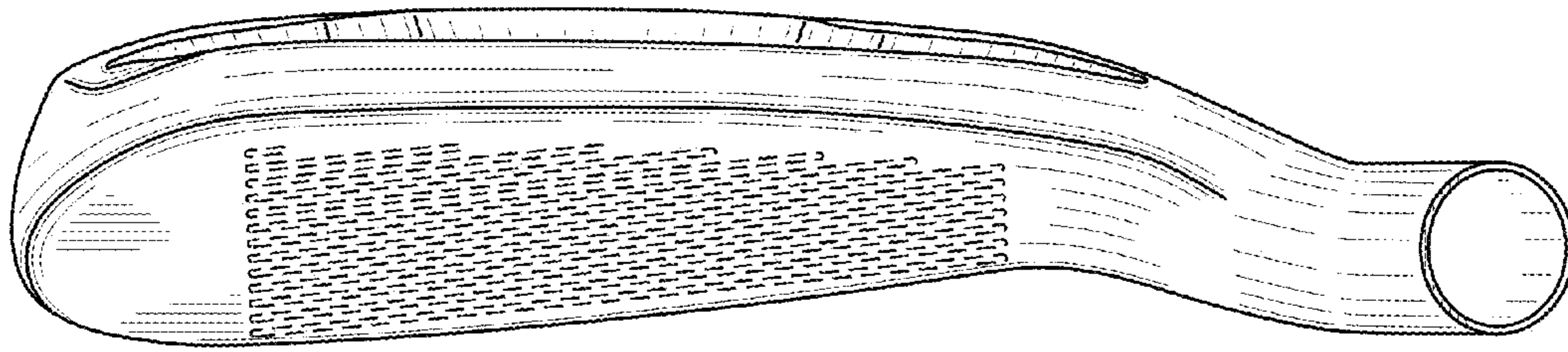

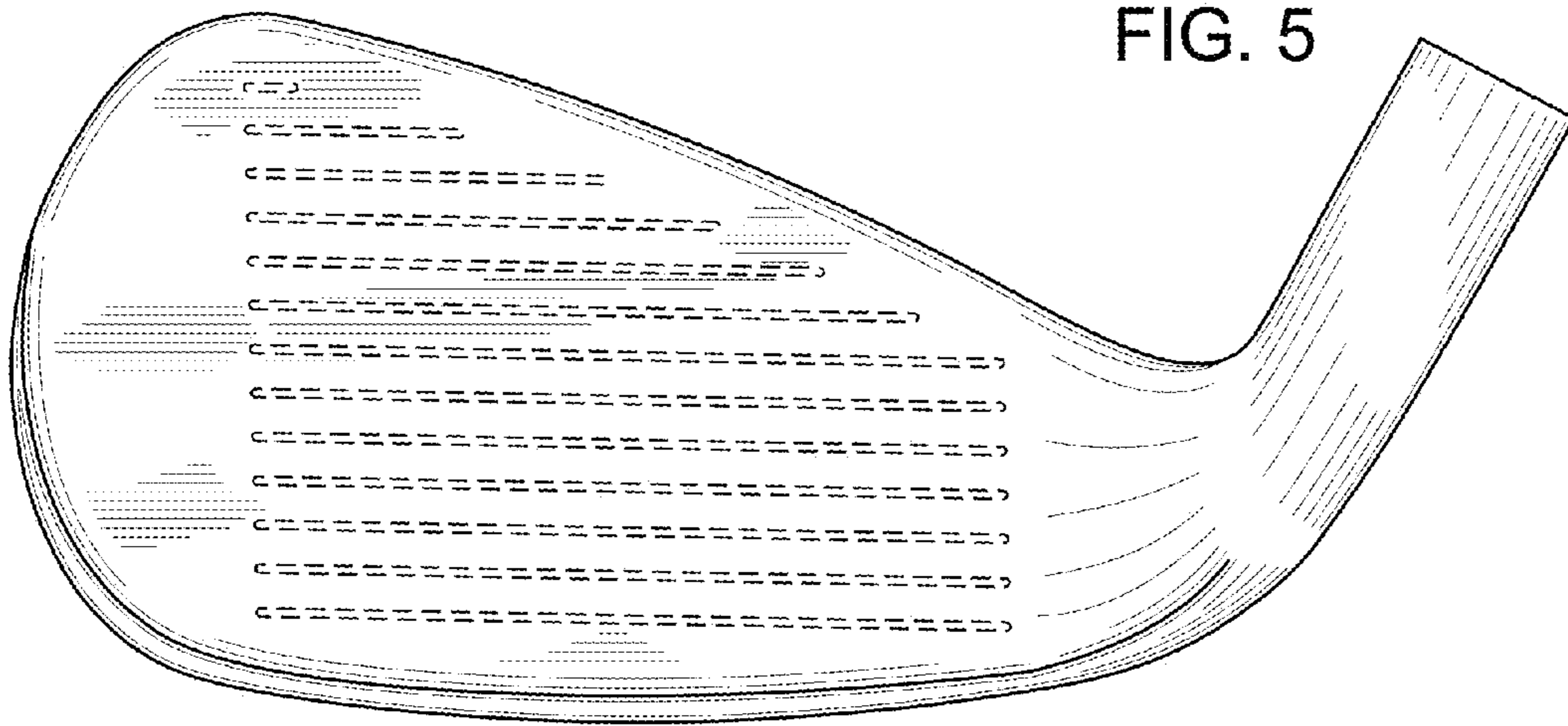

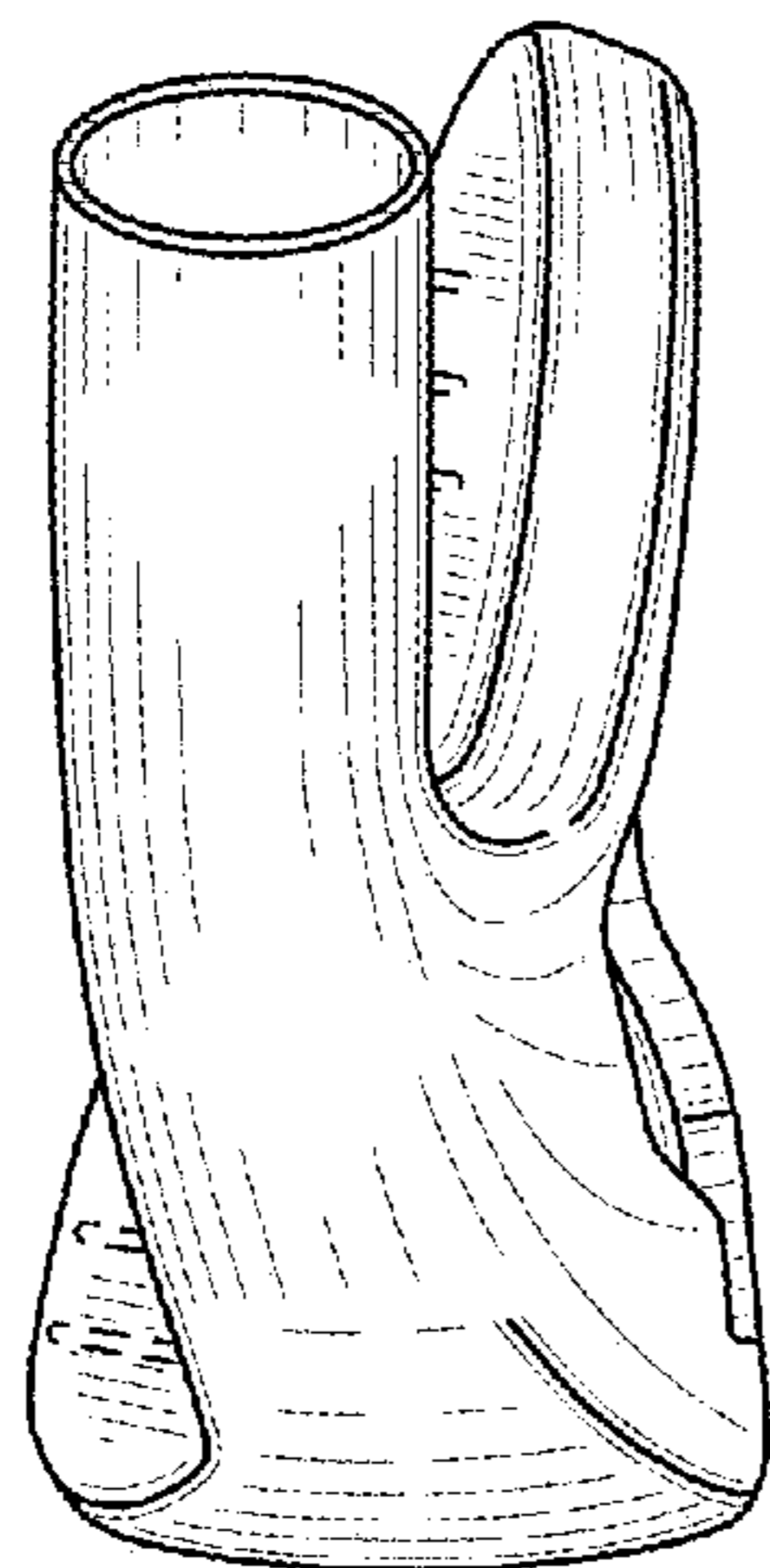
