**DESCRIPTION**

FIG. 1 is a bottom plan view of the golf club head showing my new design;

FIG. 4 is an inverted right side view thereof;

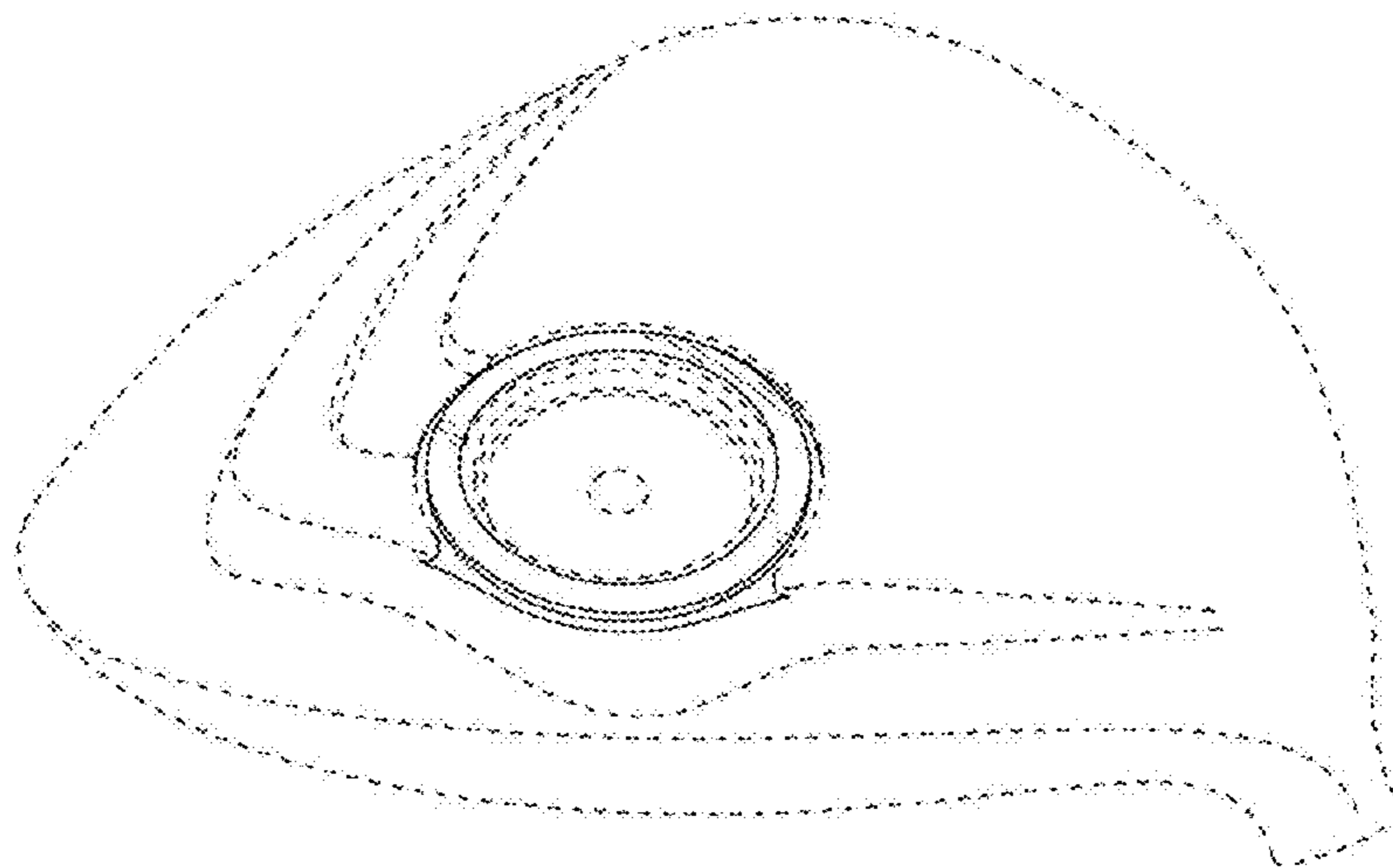
FIG. 5 is a front elevational view thereof;

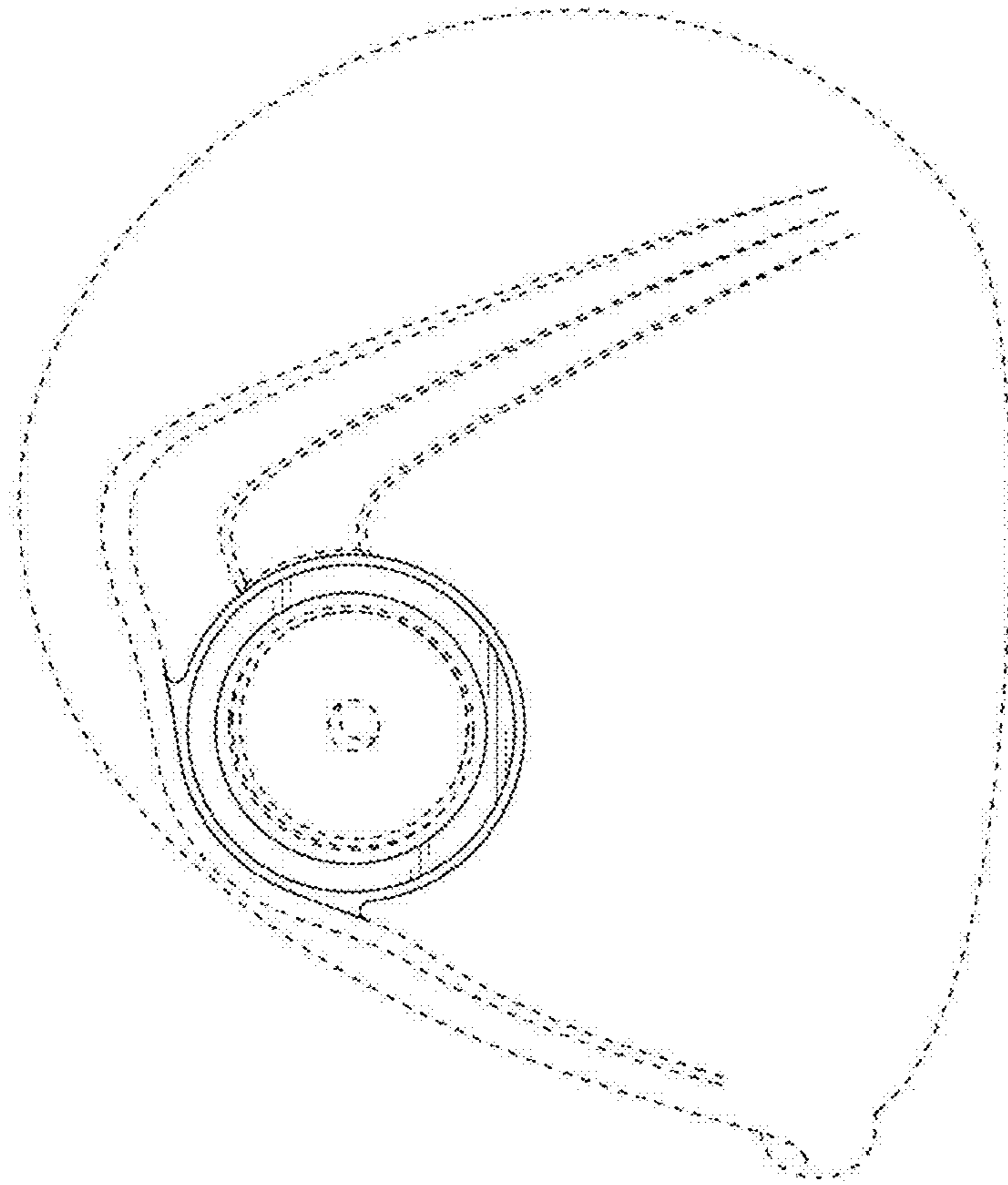

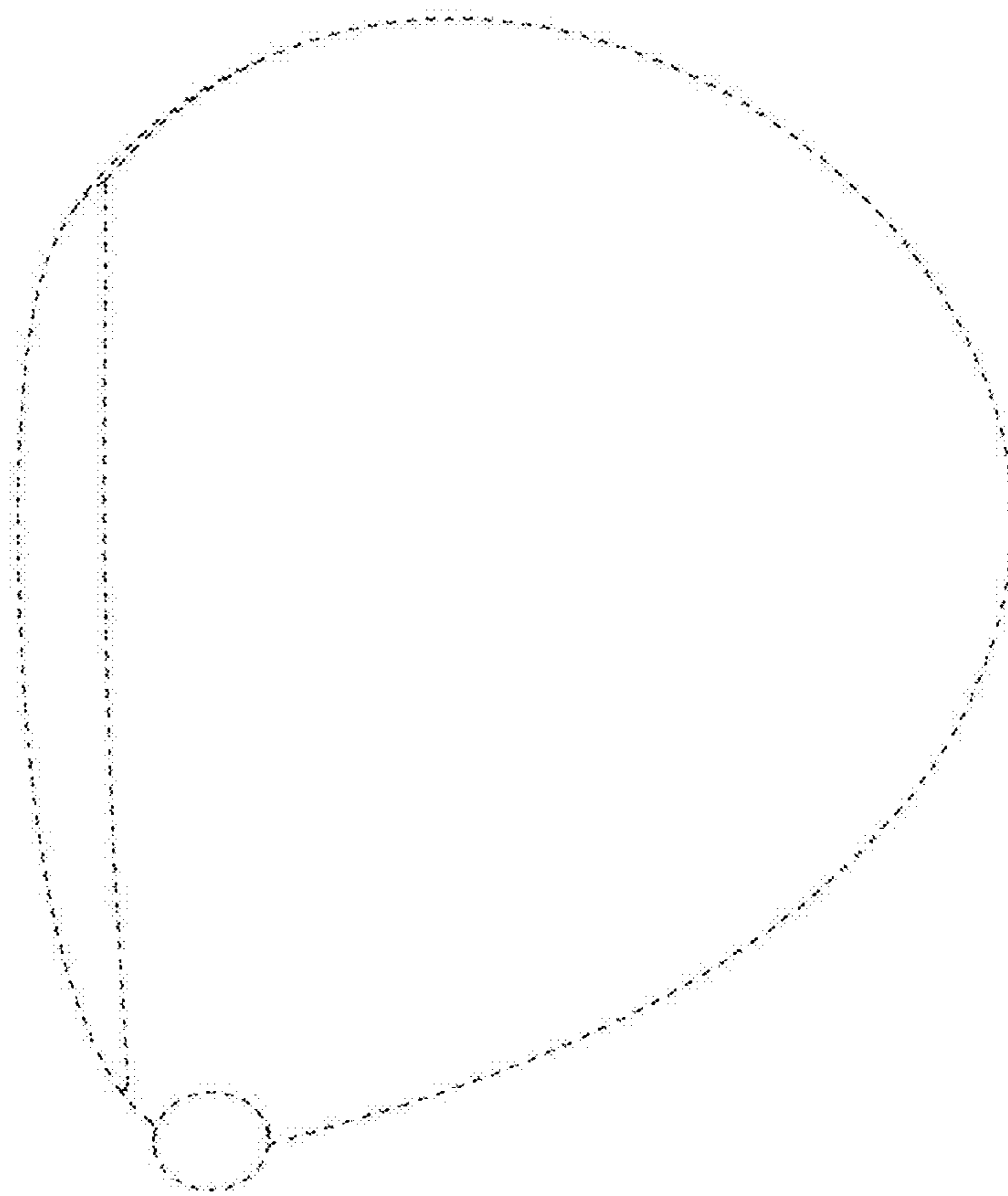

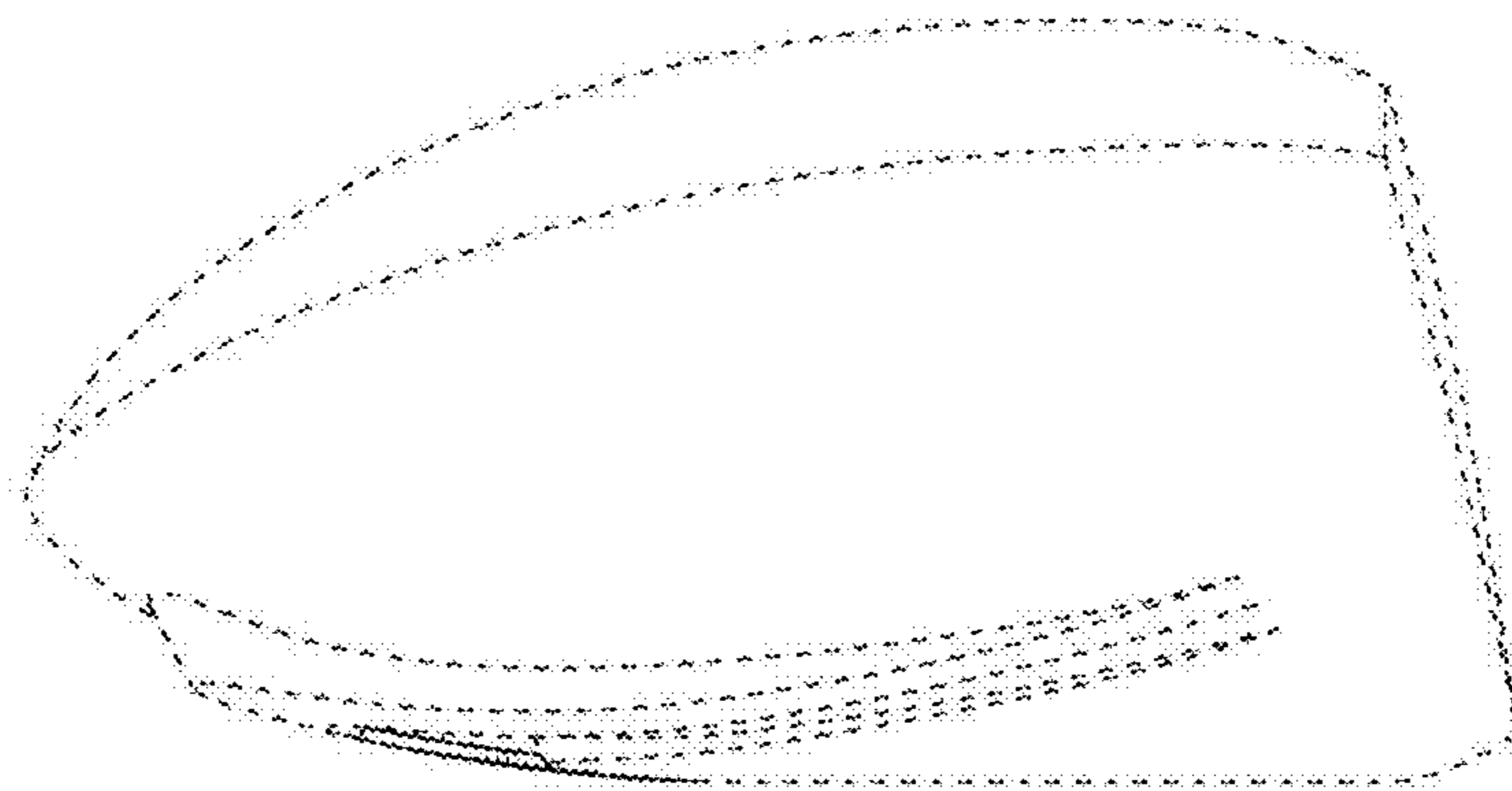

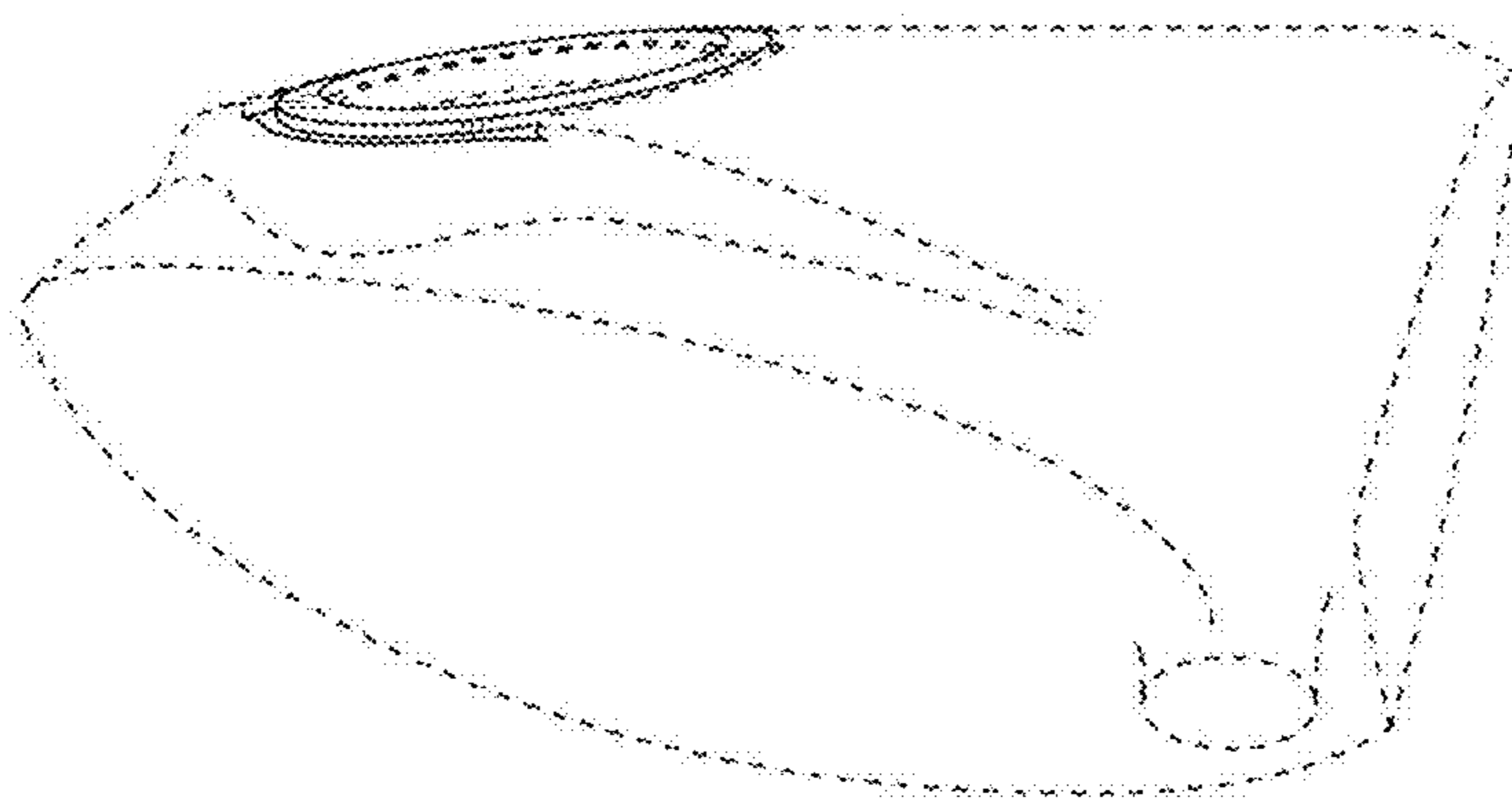

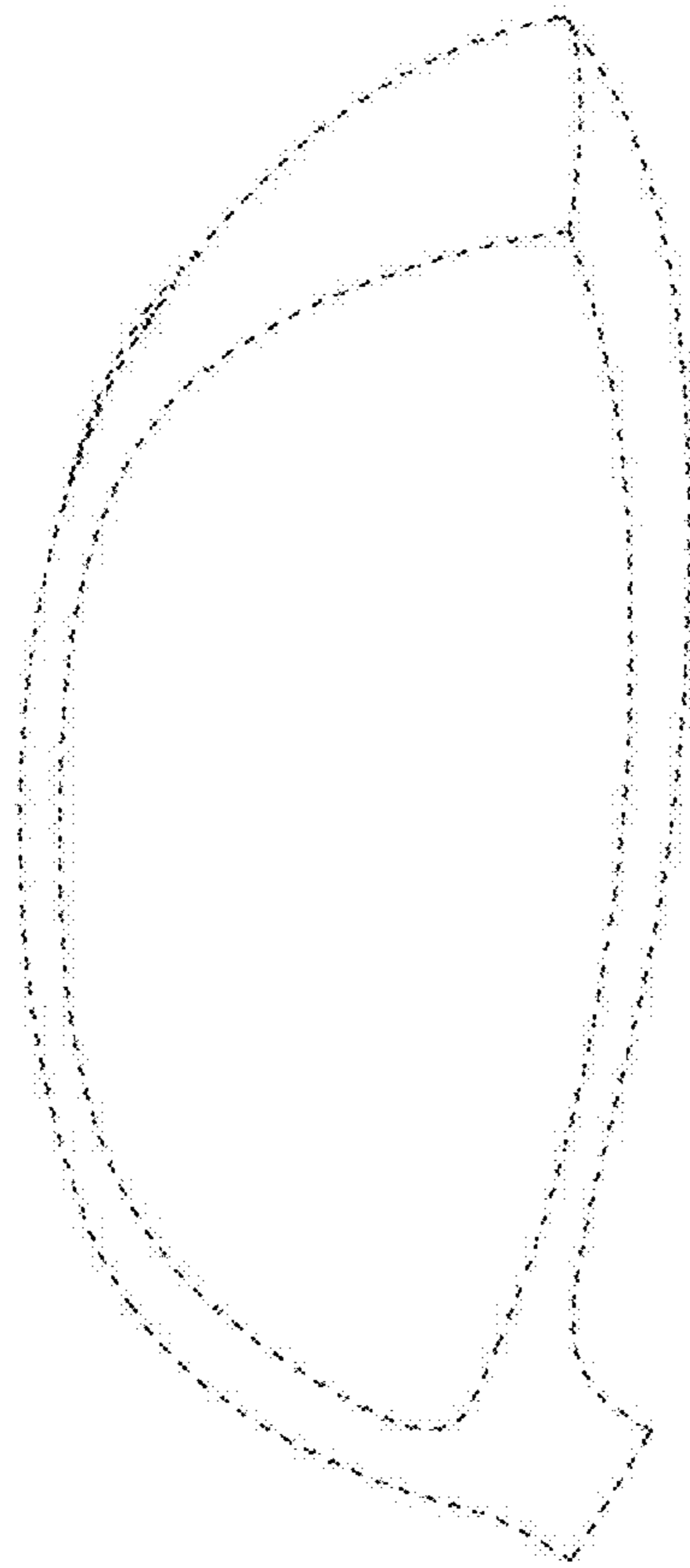

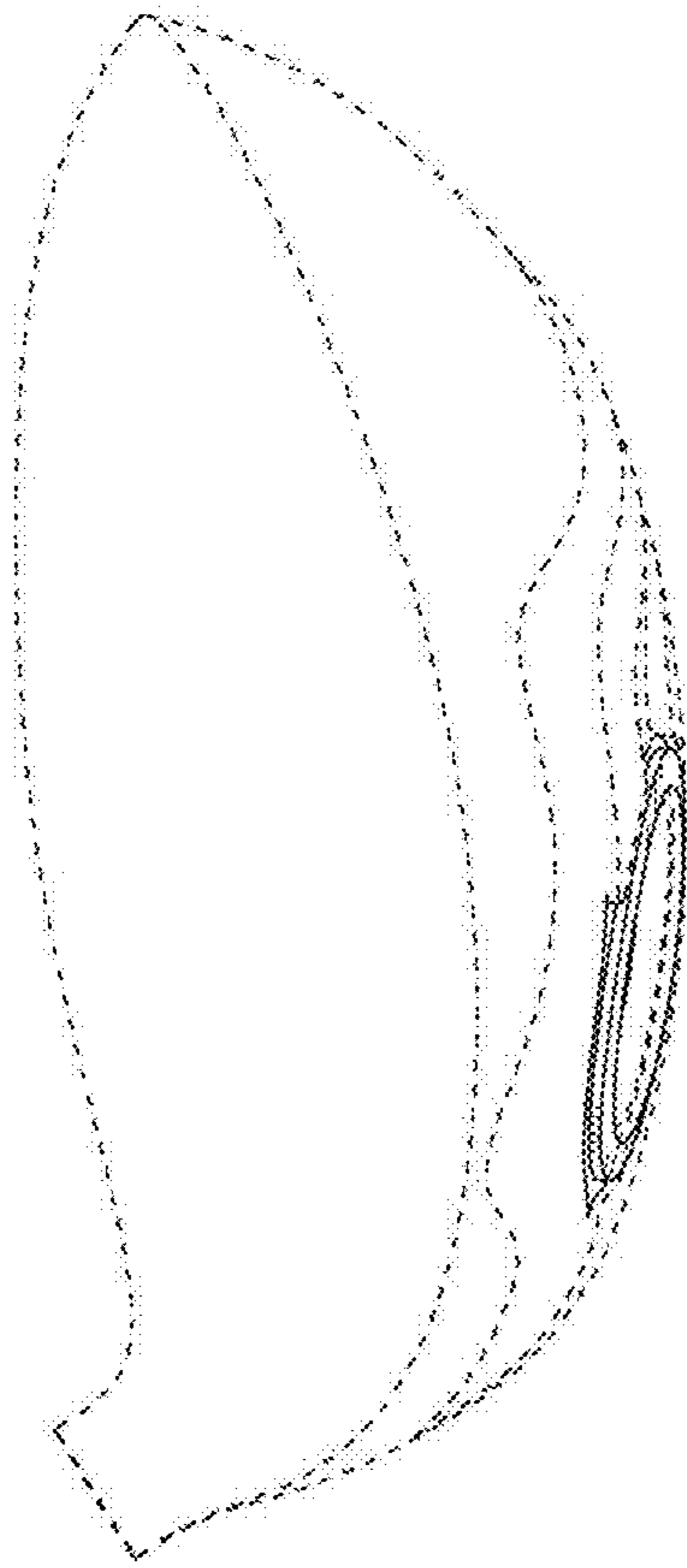

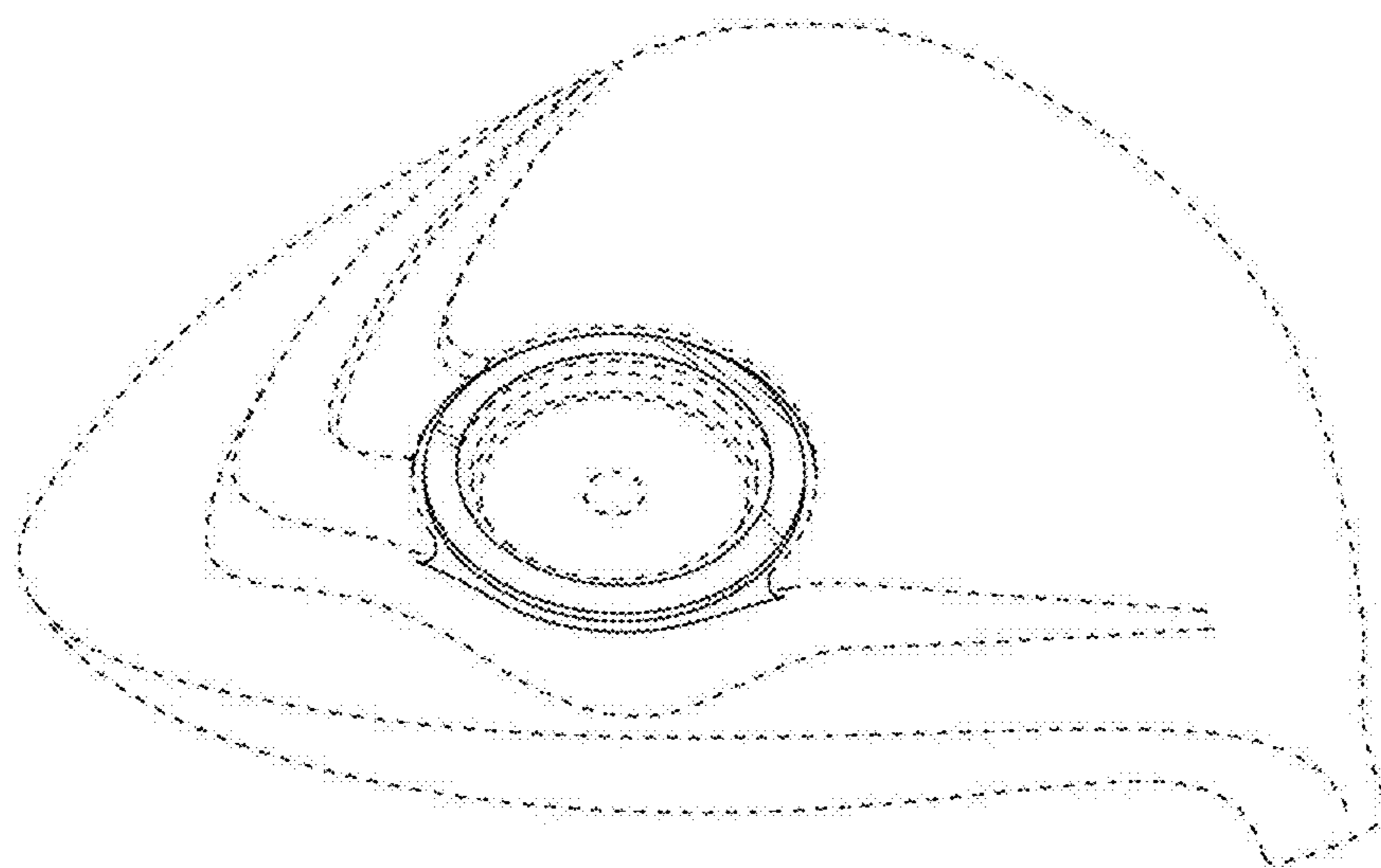
