(57) **CLAIM**  
We claim the ornamental design for a firearm sound suppressor, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of our design for a firearm sound suppressor;  
FIG. 2 is a right side view of the design for the firearm sound suppressor shown in FIG. 1;  
FIG. 3 is a left side view of the design for the firearm sound suppressor shown in FIG. 1;  
FIG. 4 is a front view of the design for the firearm sound suppressor shown in FIG. 1; and,  
FIG. 5 is a rear view of the design for the firearm sound suppressor shown in FIG. 1.
