FIG. 6 is a top view of the airbrush grip of FIG. 1; and

FIG. 7 is a bottom view of the airbrush grip of FIG. 1;

FIG. 8 is a top view of the airbrush grip disassembled from the airbrush;

FIG. 9 is a left side view of the airbrush grip disassembled from the airbrush;

FIG. 10 is a rear view of the airbrush grip disassembled from the airbrush;

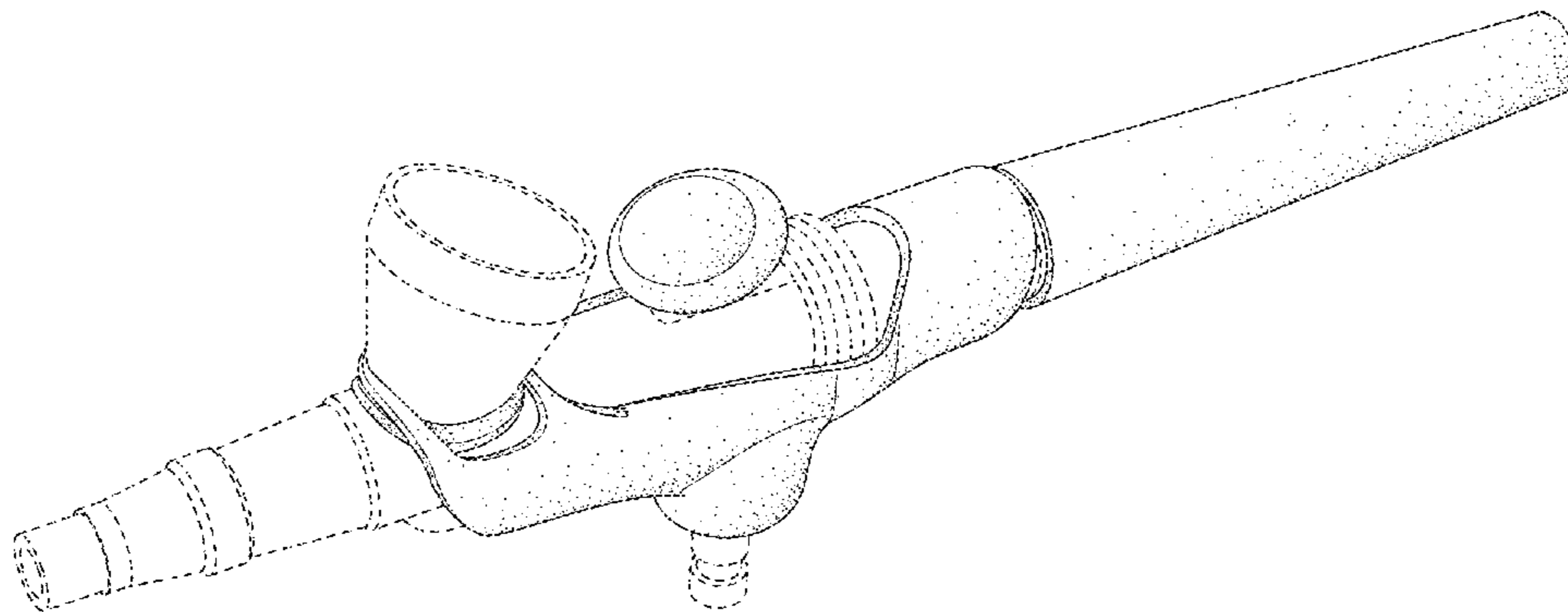
FIG. 11 is a perspective view of the airbrush grip disassembled from the airbrush and viewed from the front and above;

FIG. 12 is a perspective view of the airbrush grip disassembled from the airbrush and viewed from the rear and above; and,

FIG. 13 is a perspective view of the airbrush grip disassembled from the airbrush and viewed from the front and below.

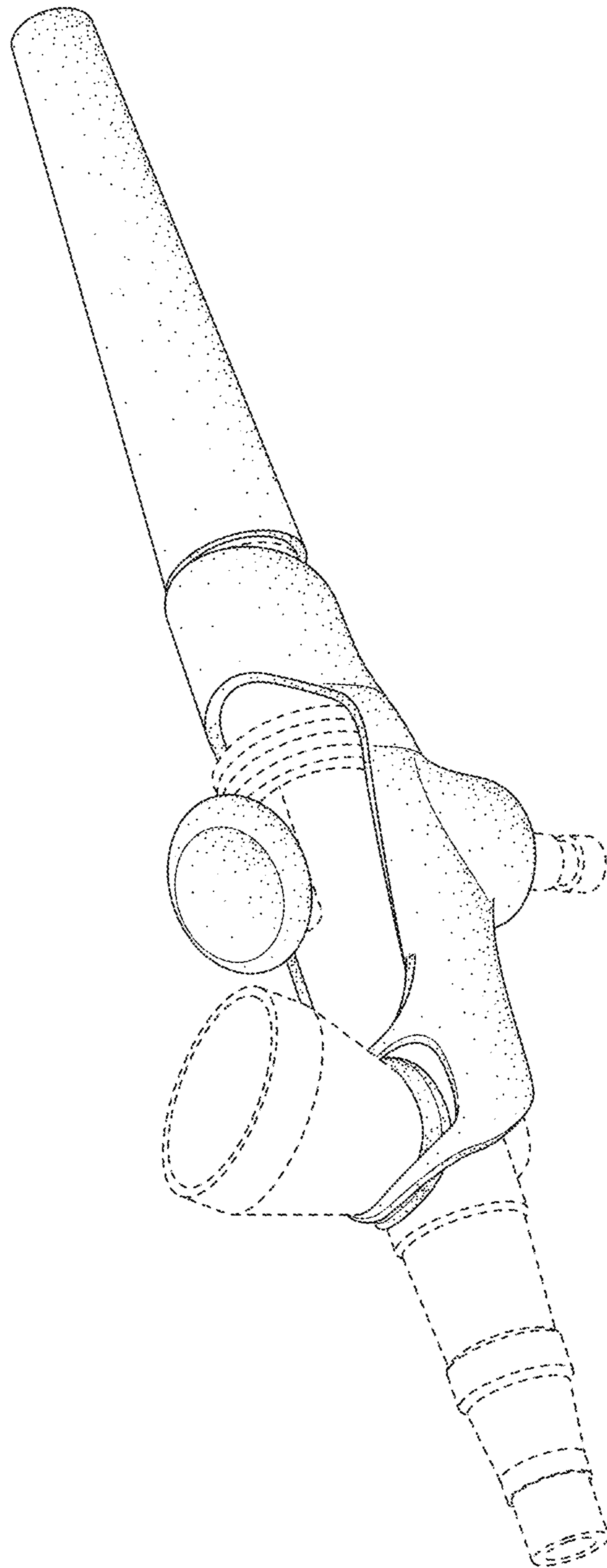

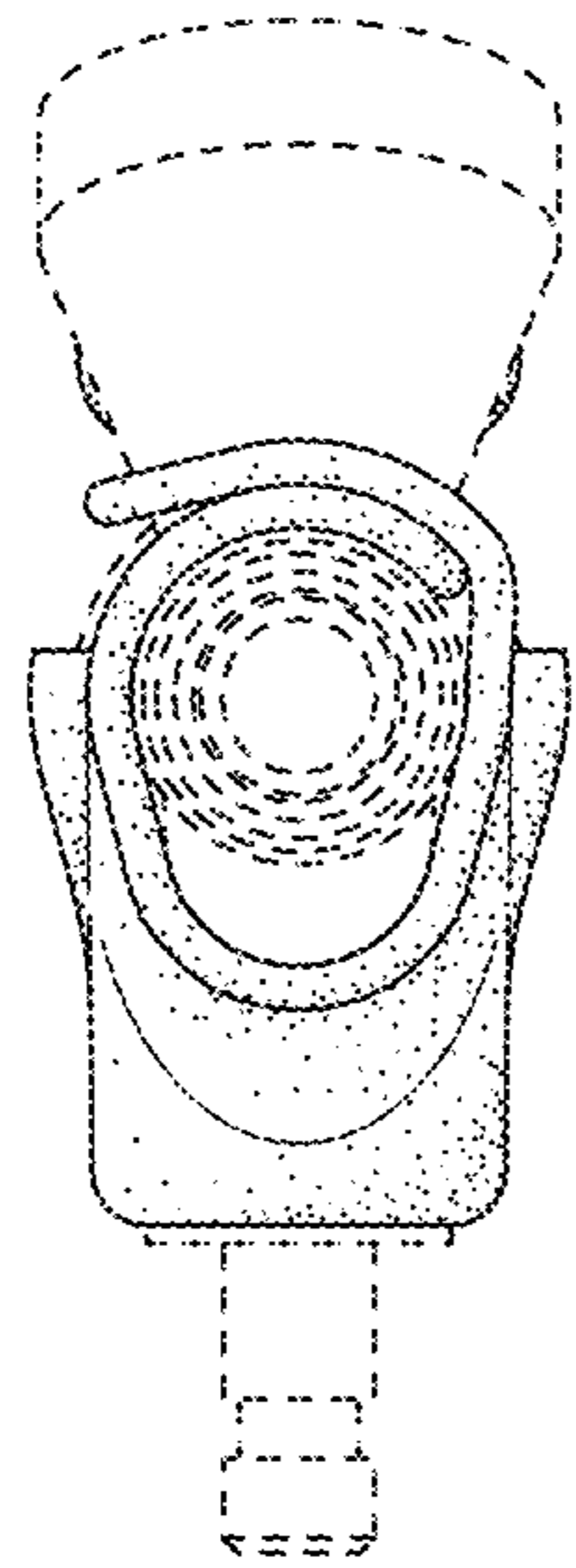

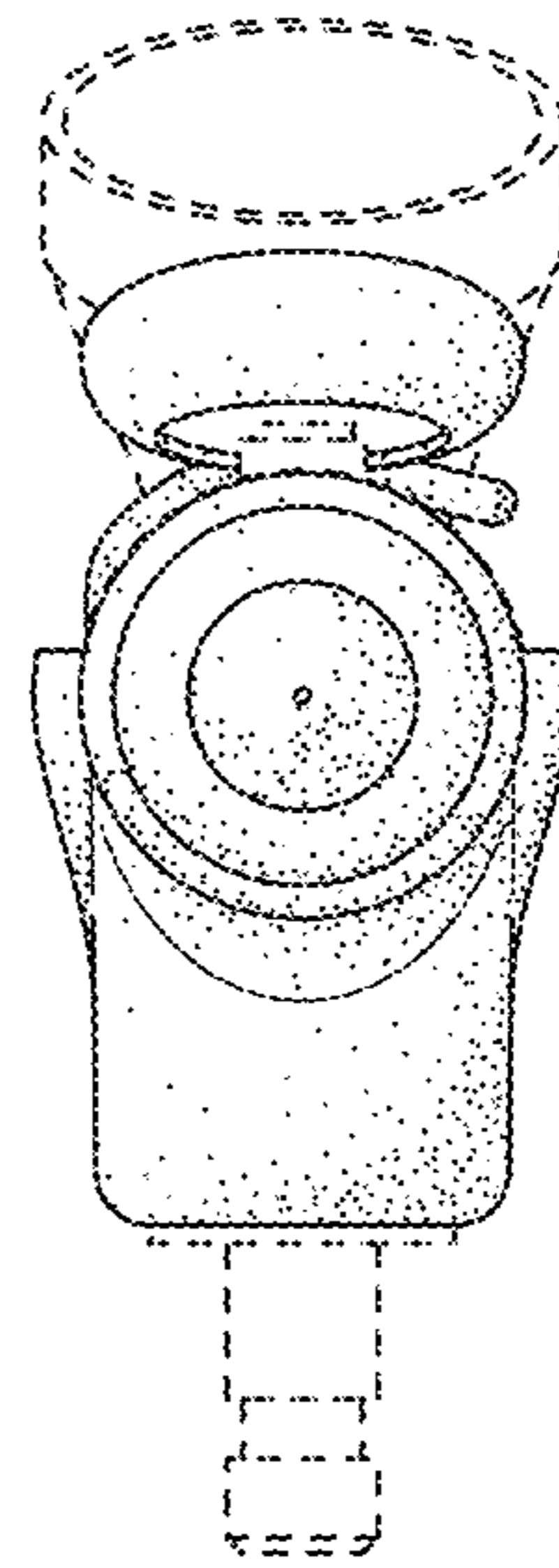

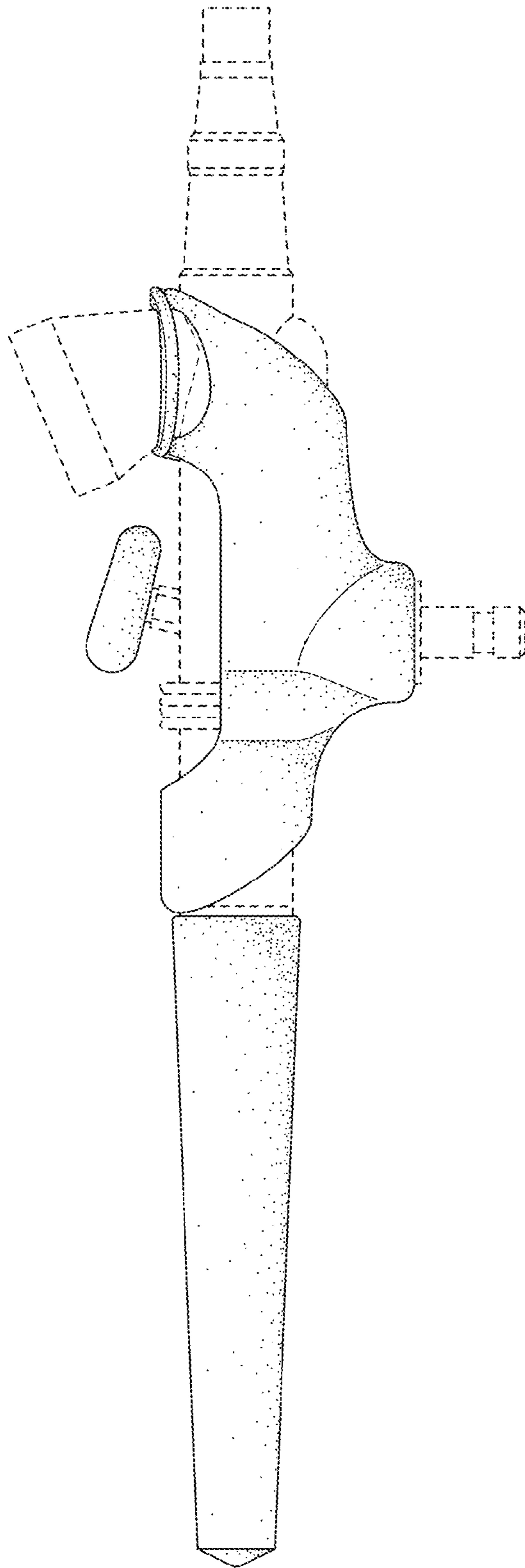

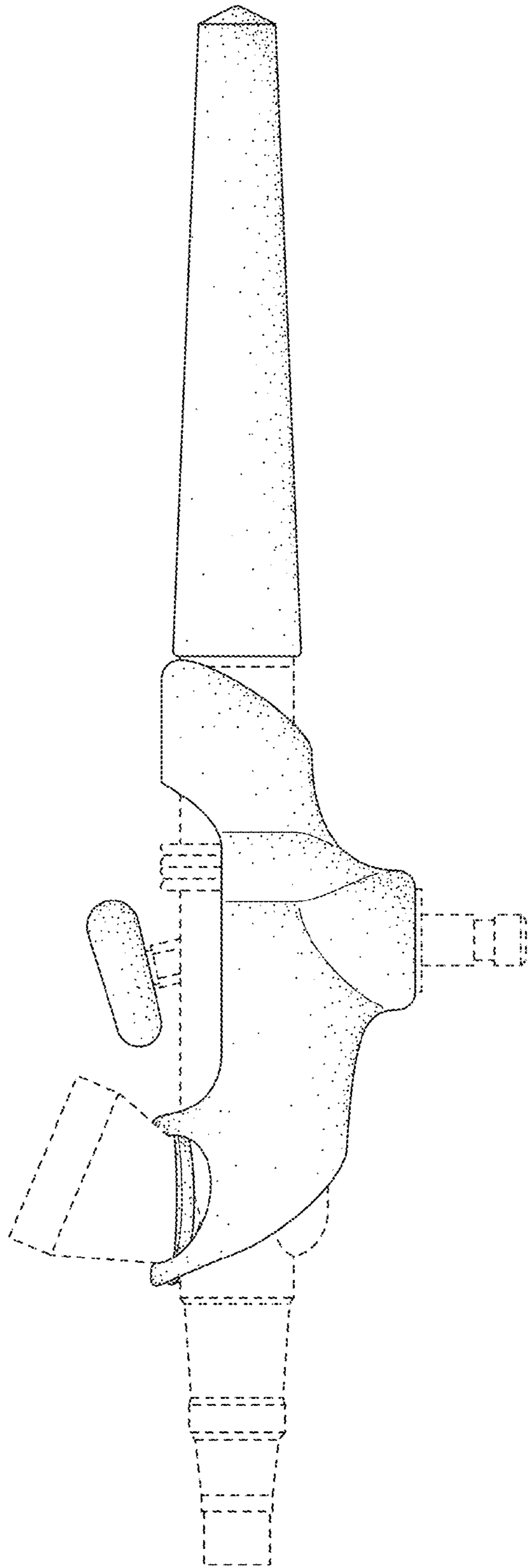

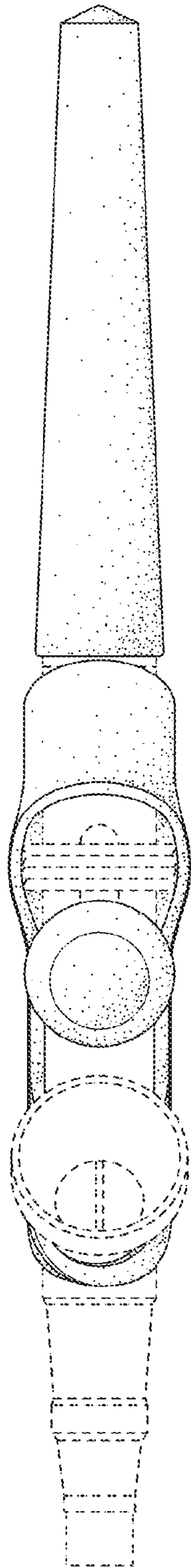

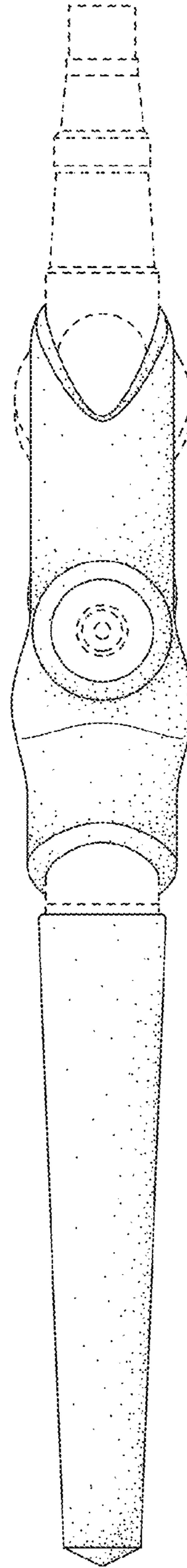

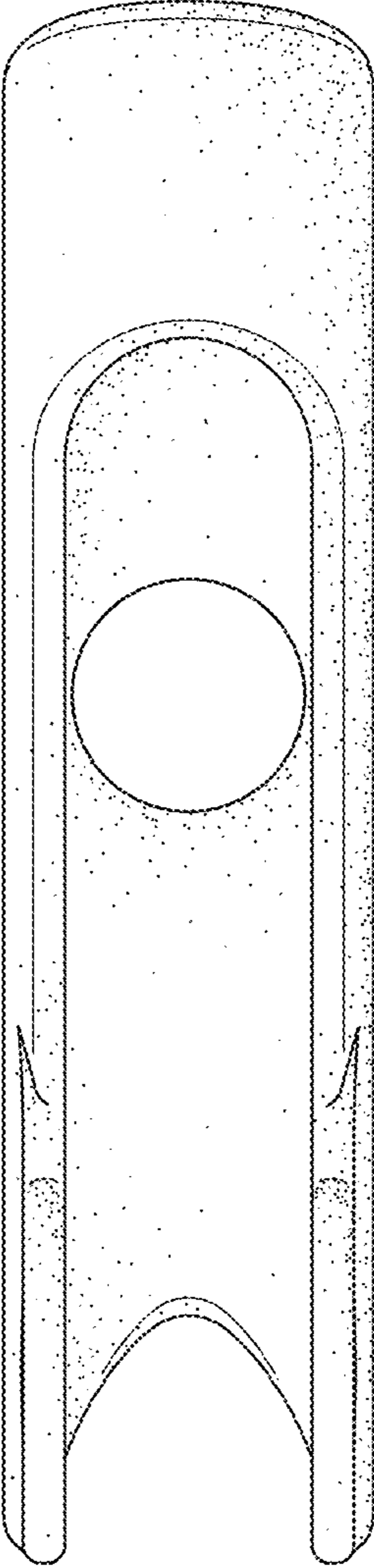

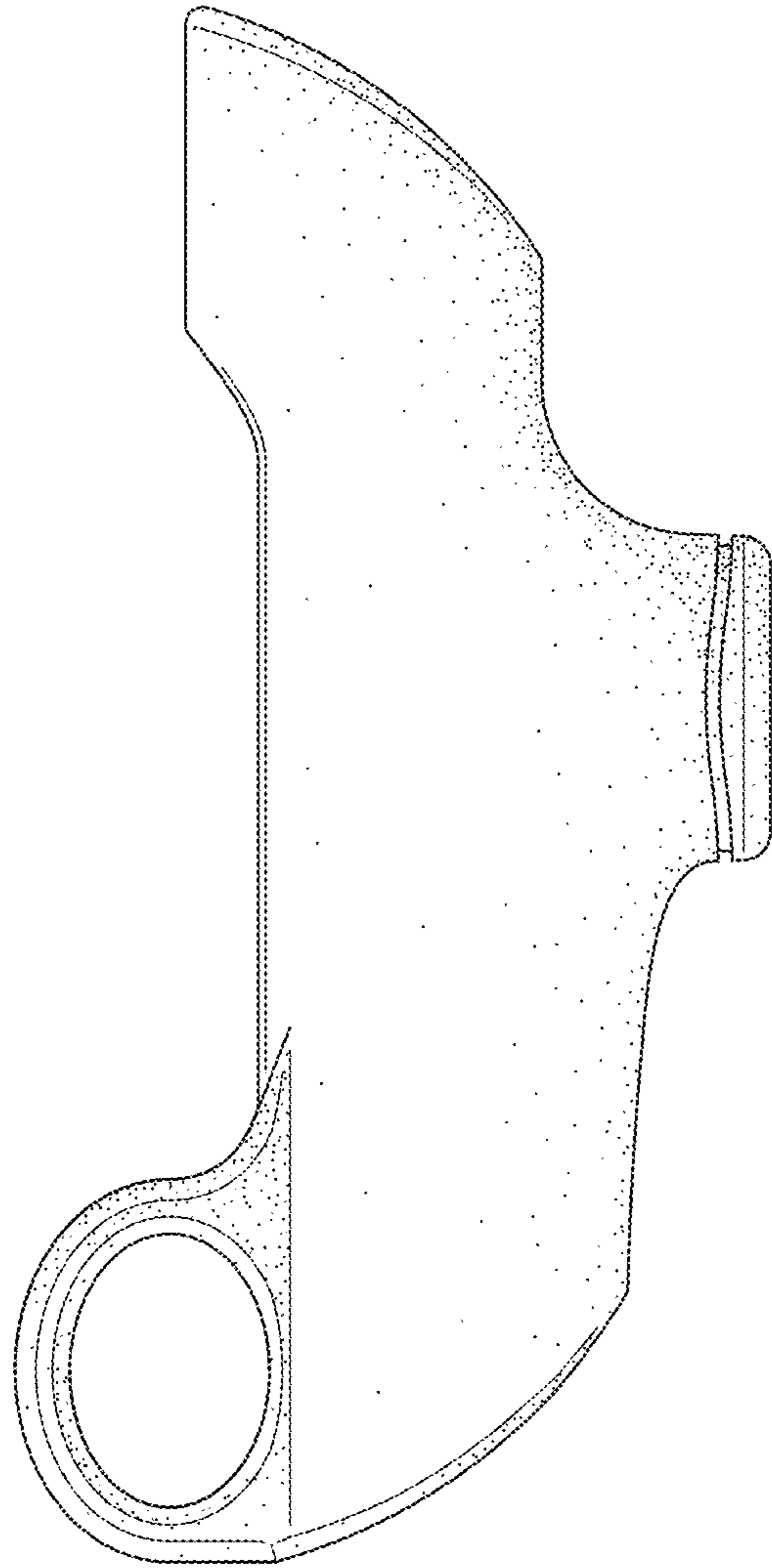

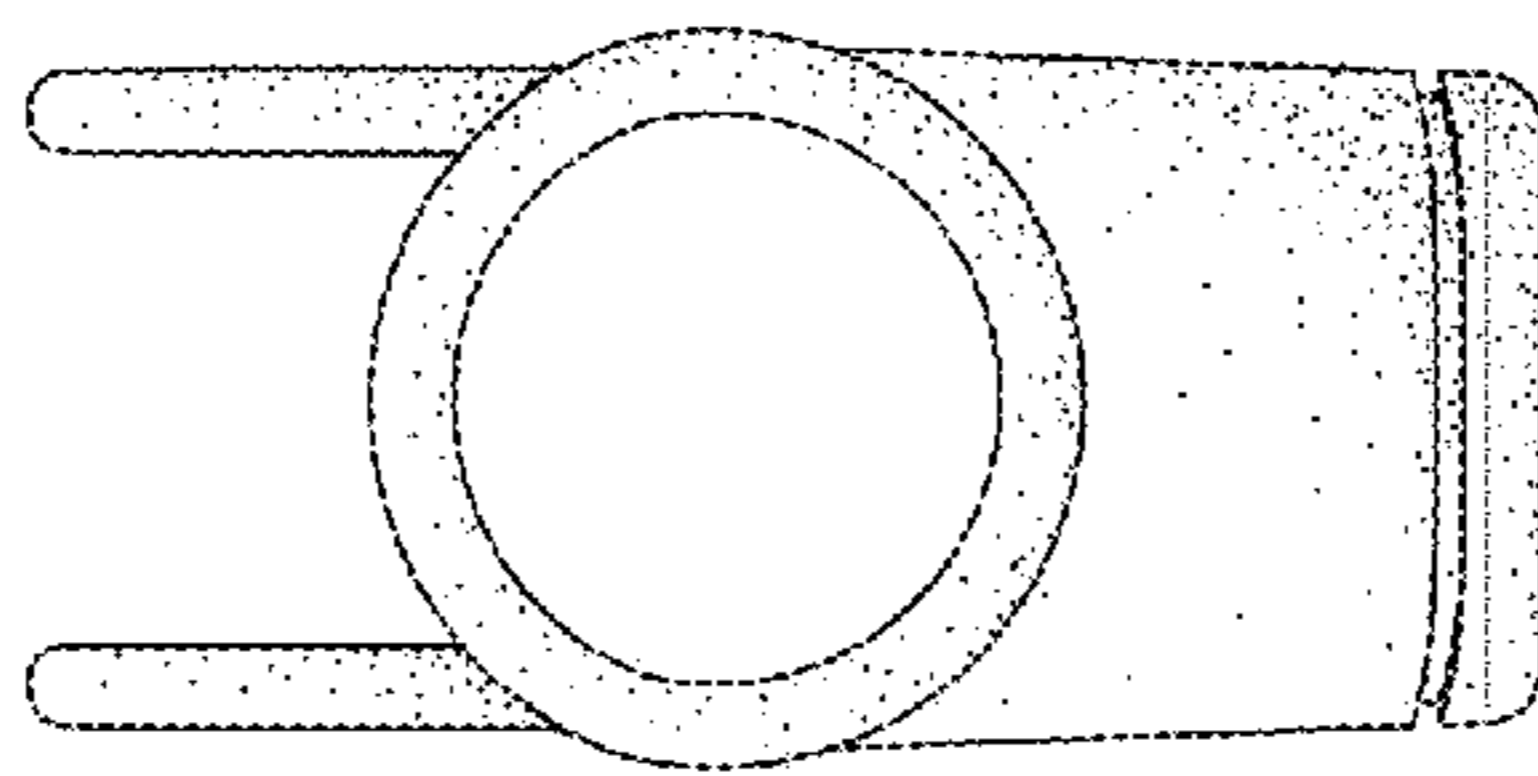

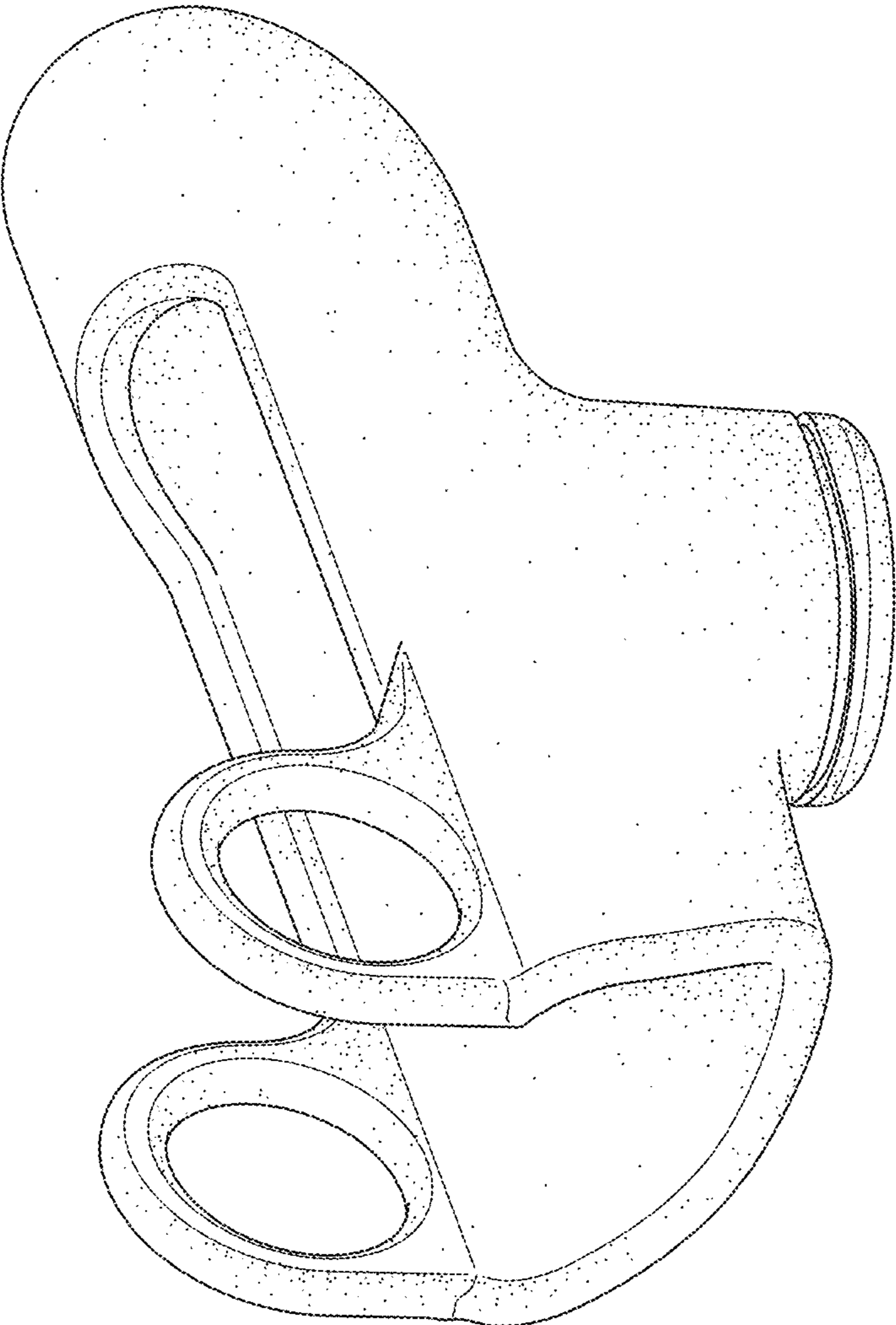

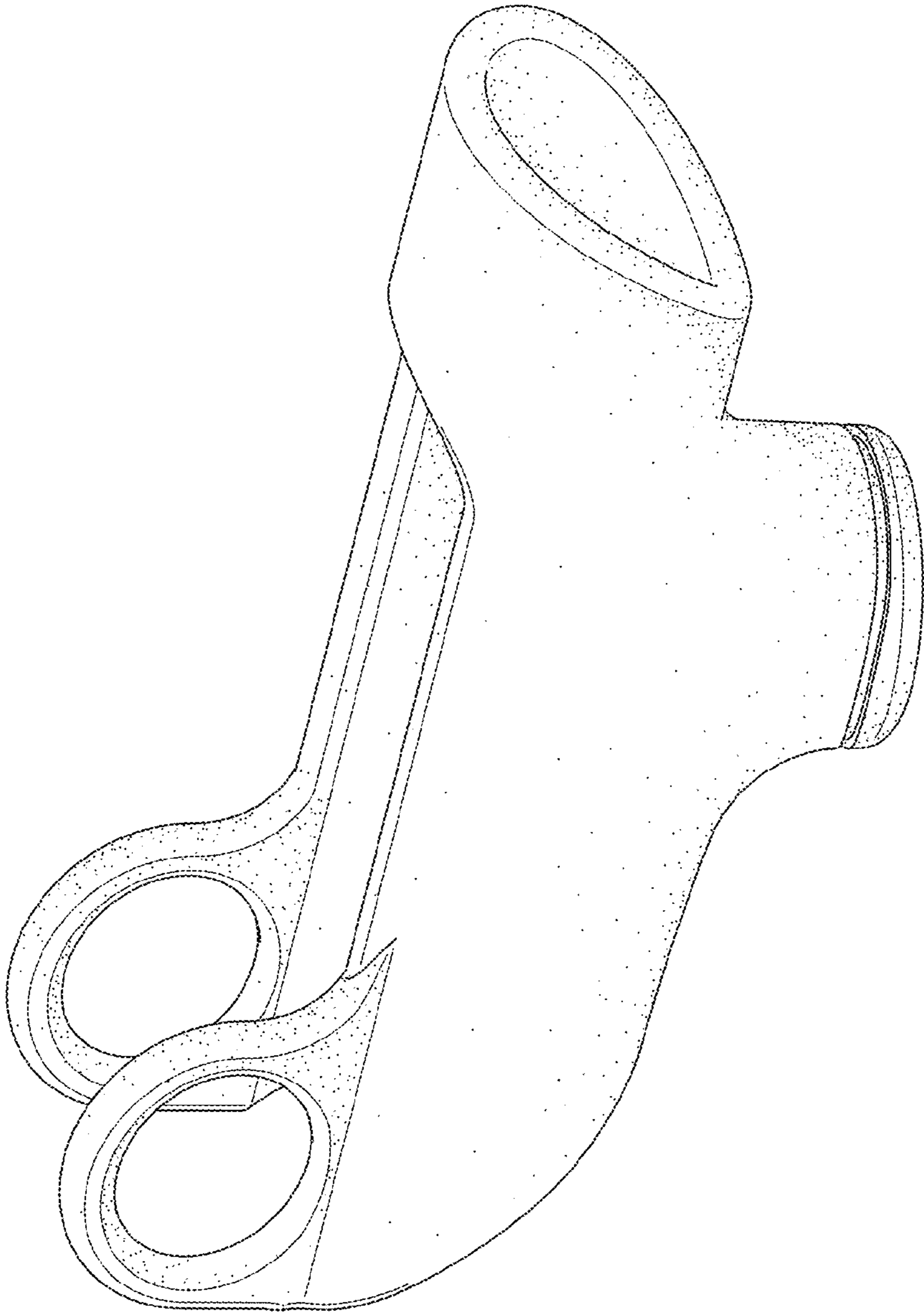

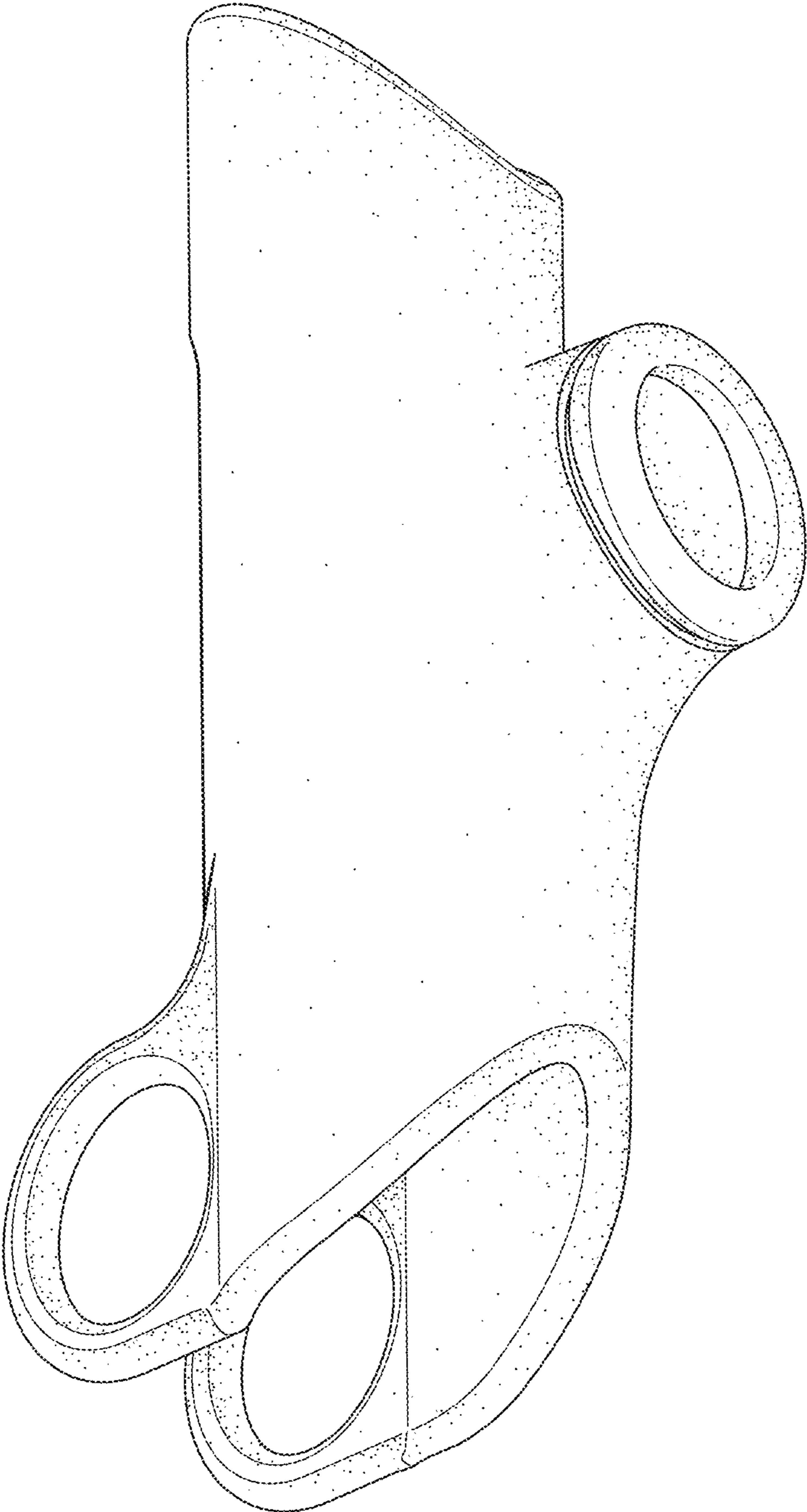
