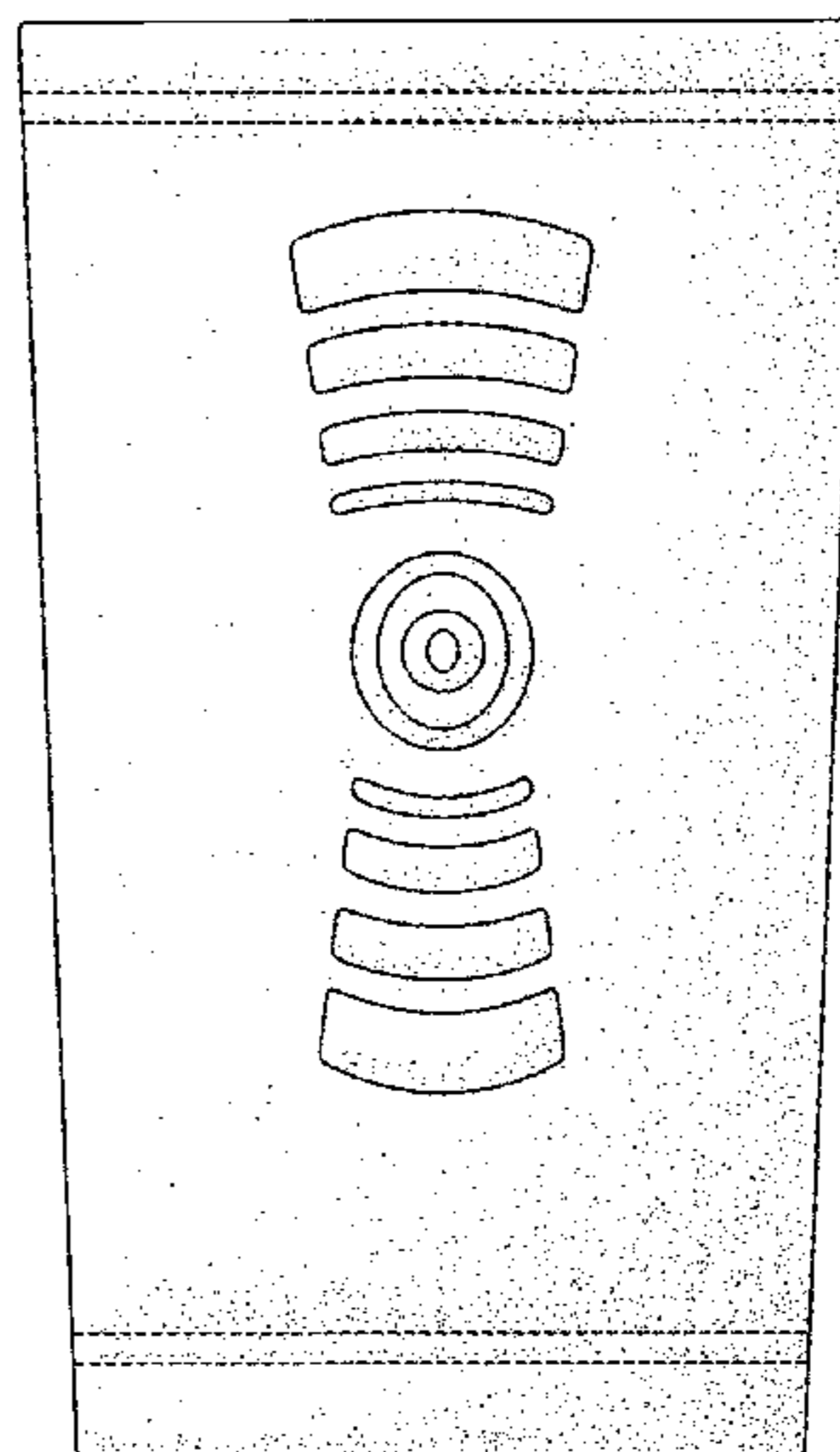
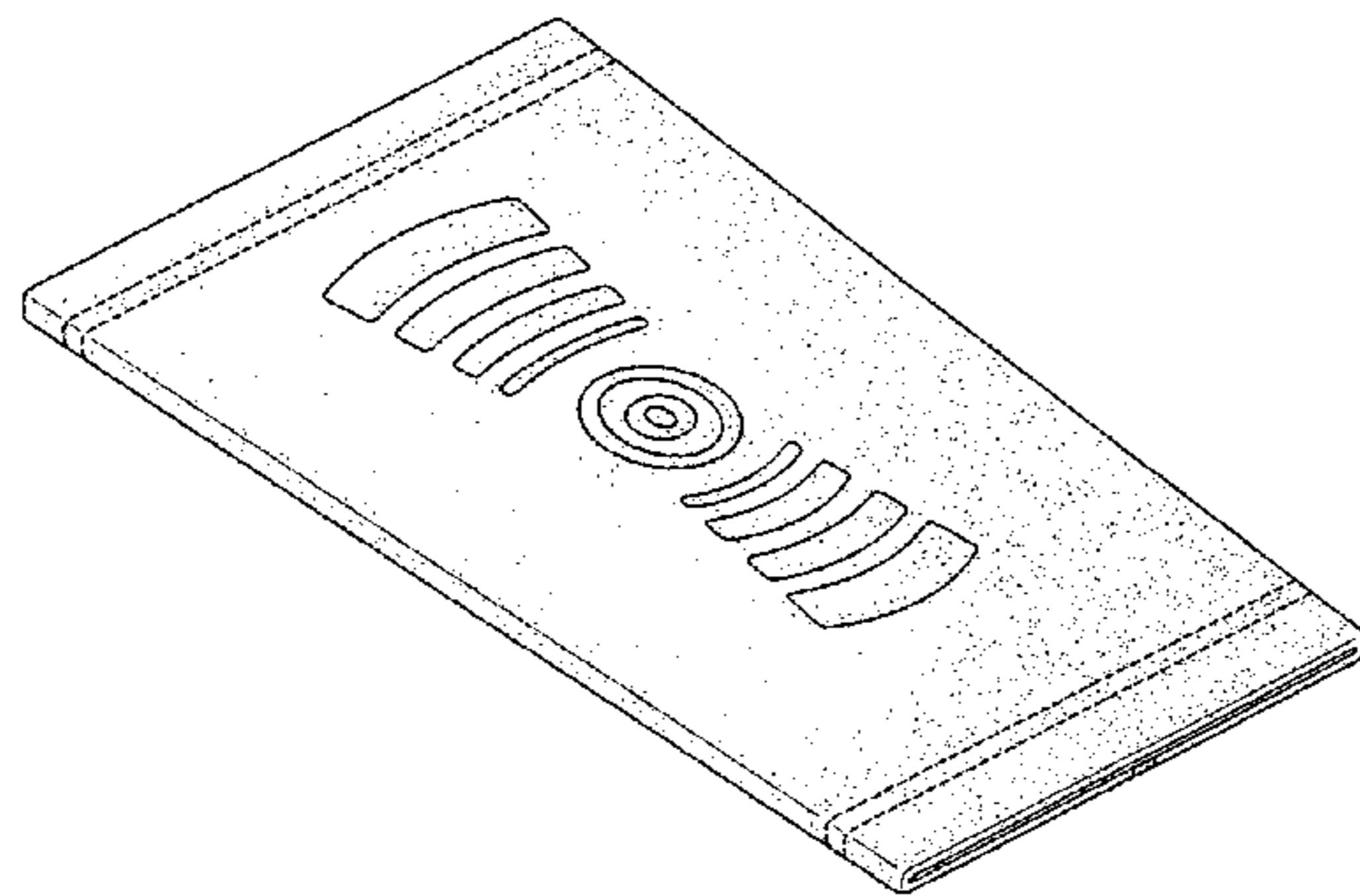
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of the sleeve of the present invention showing my new design;
FIG. 2 is a front side elevation view thereof;
FIG. 3 is back side elevation view thereof;
FIG. 4 is a side elevation view thereof;
FIG. 5 is another side elevation view thereof
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view of the sleeve in use.

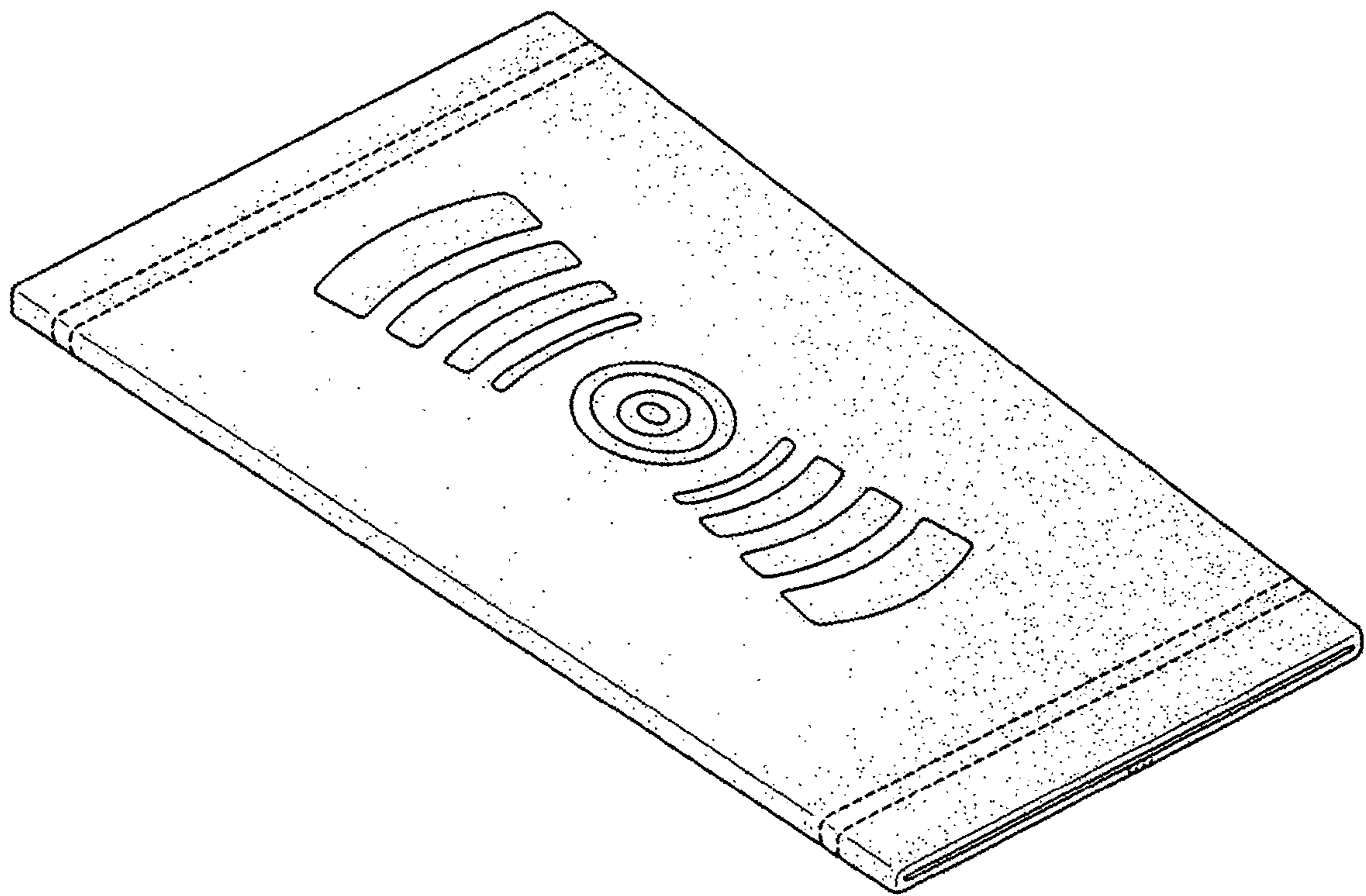

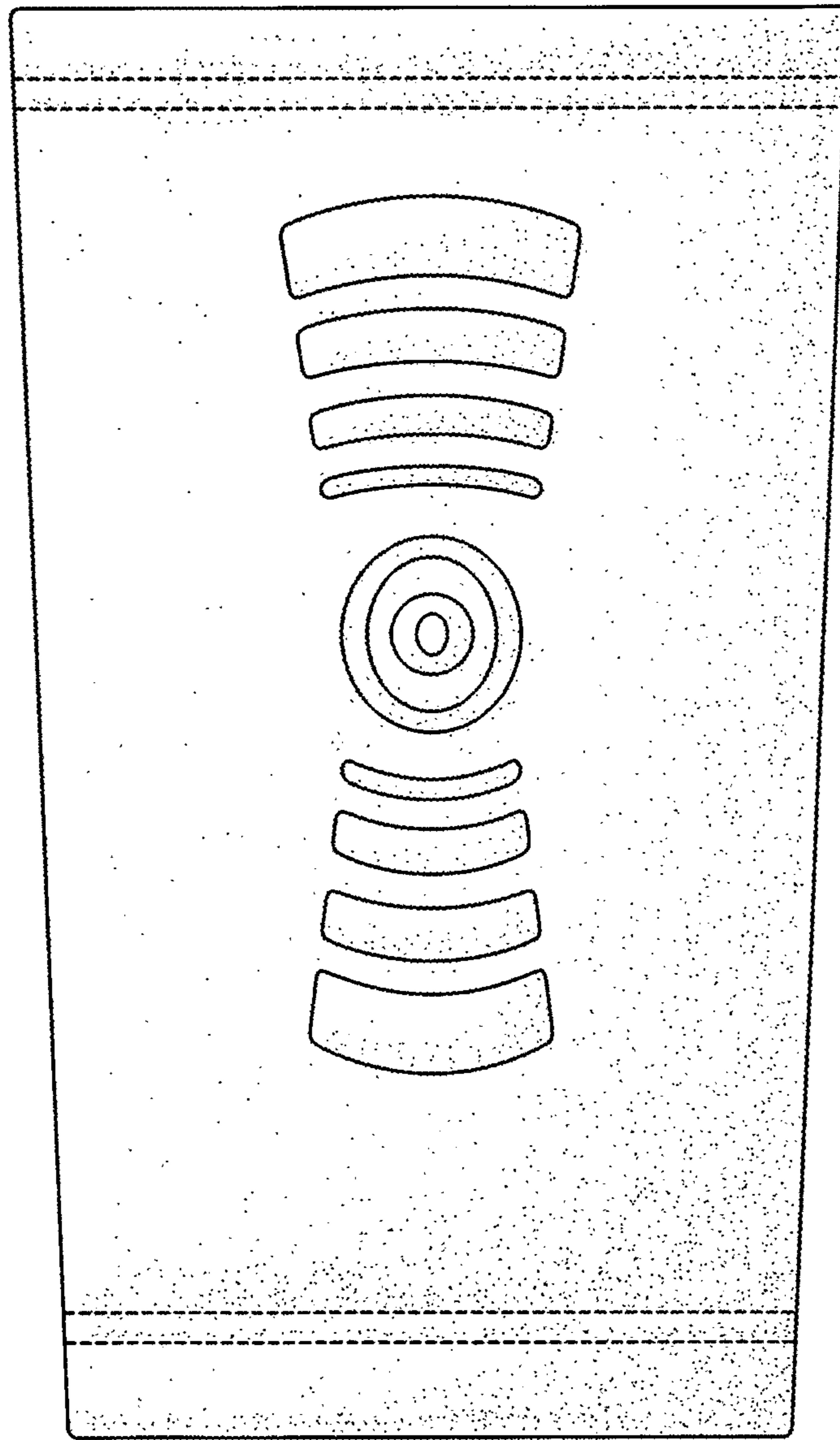

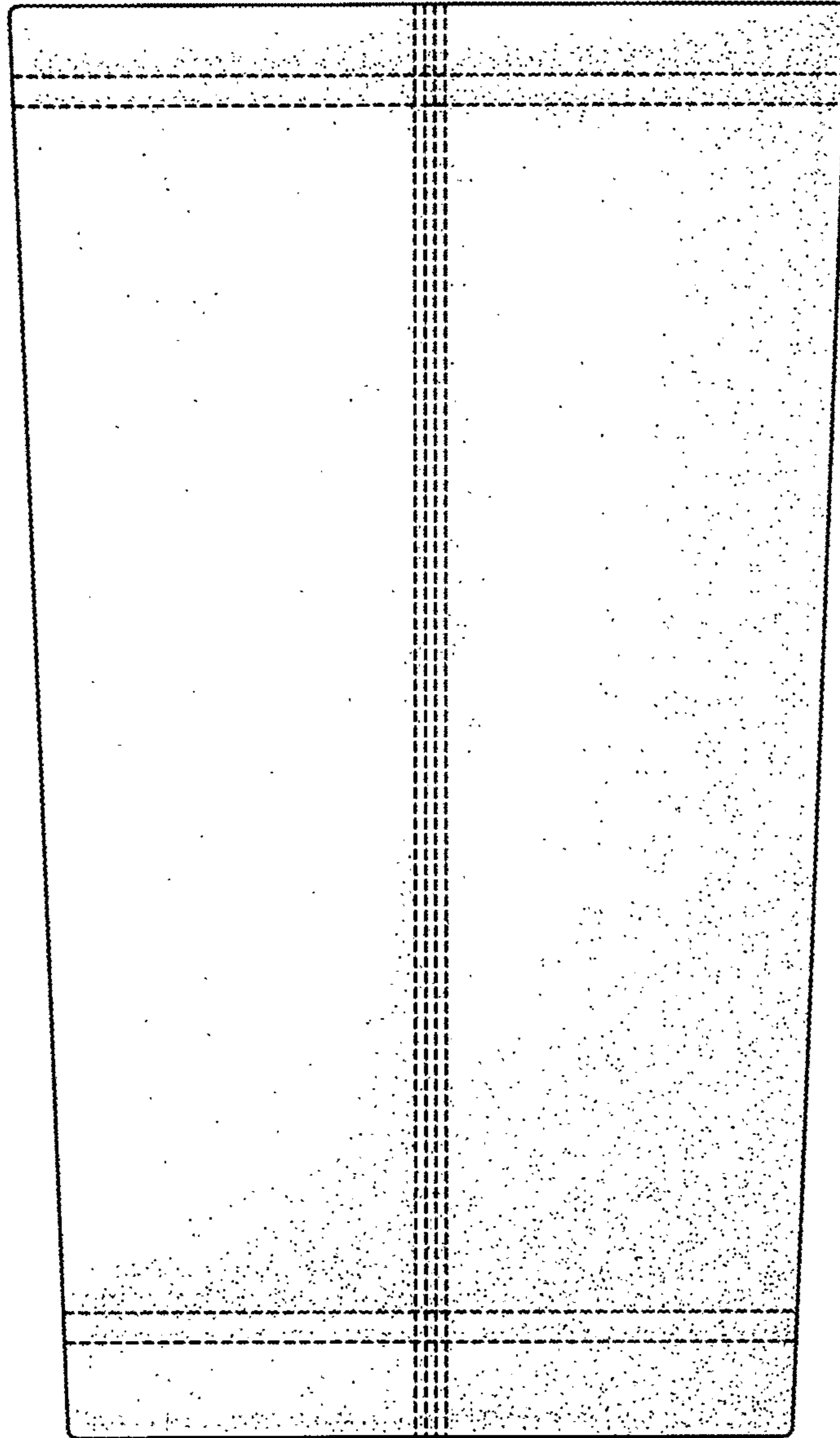

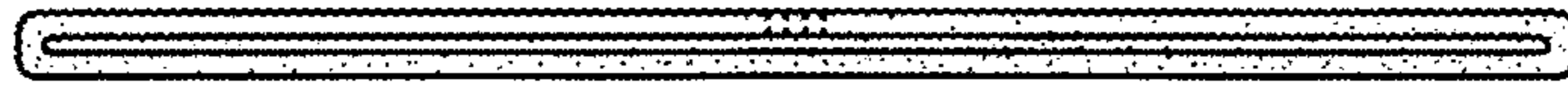

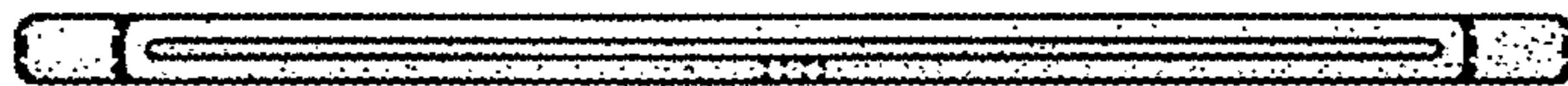

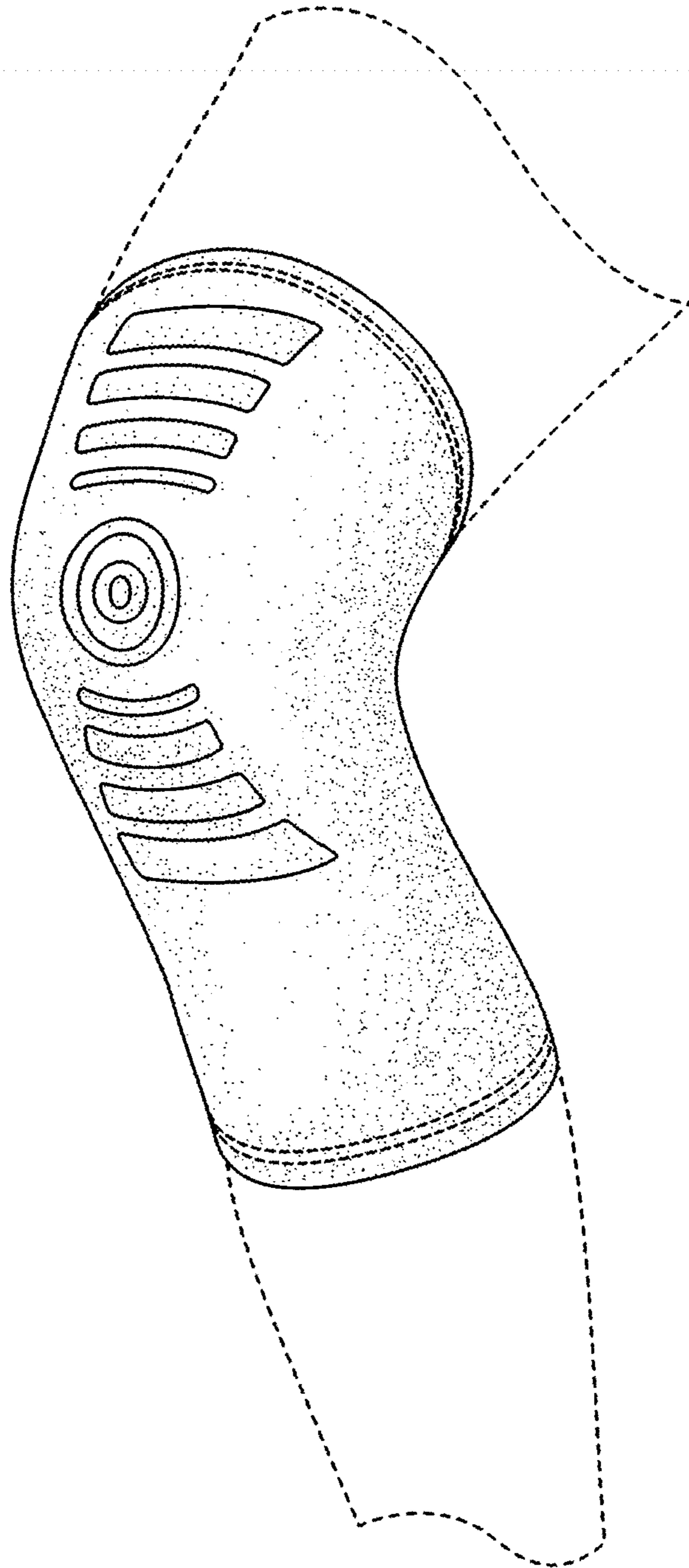
