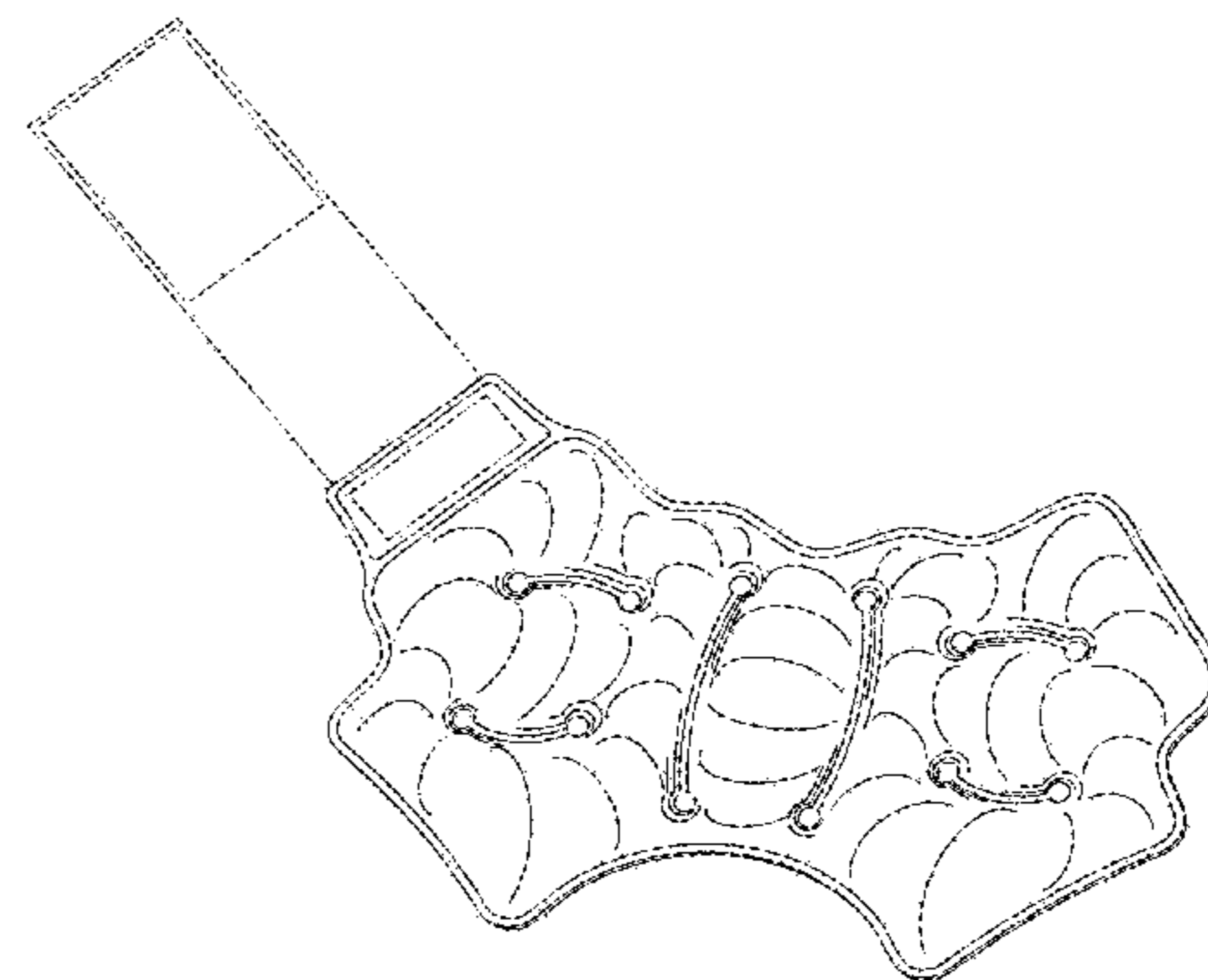
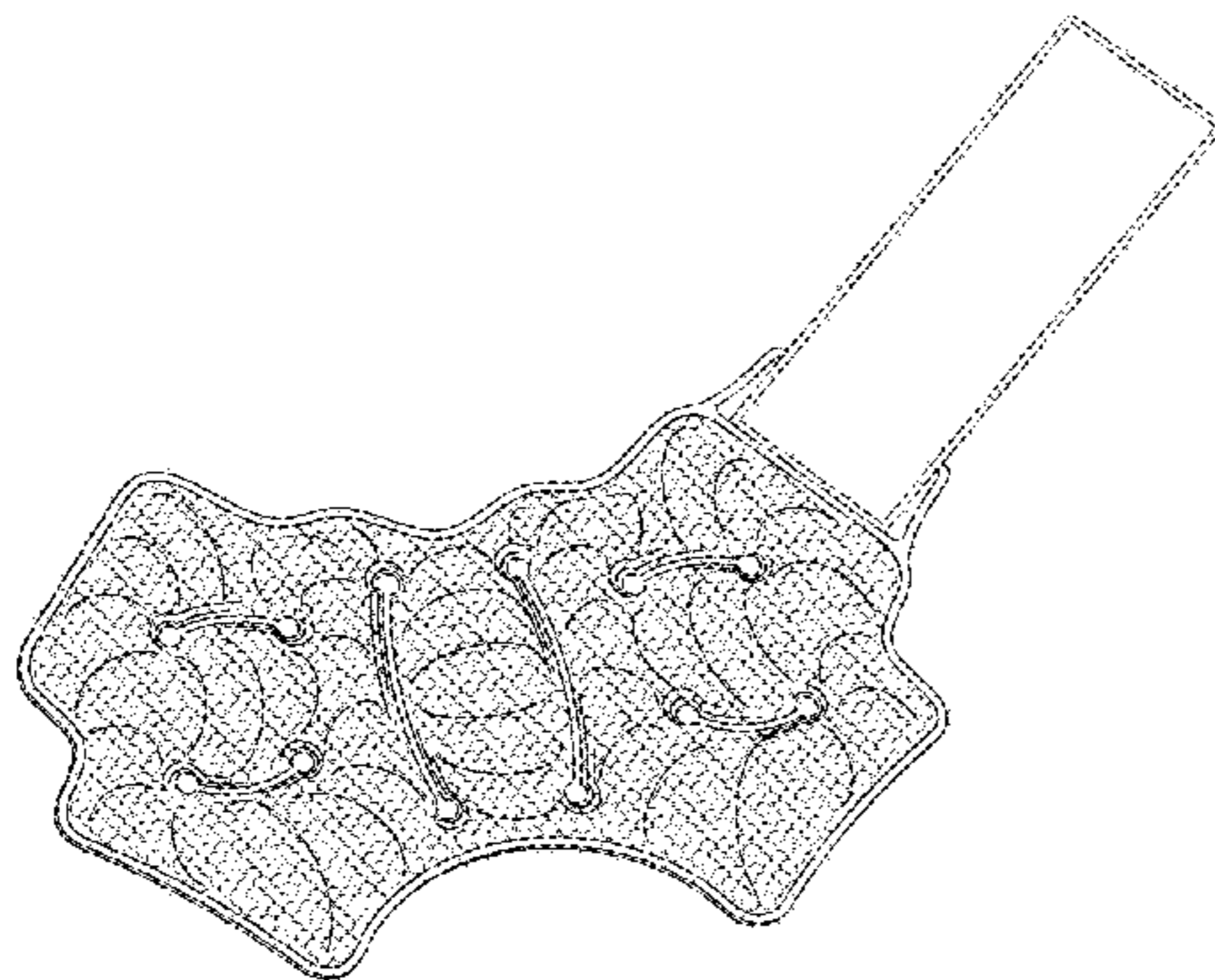
The ornamental design for a hot/cold pack for ankle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a hot/cold pack for ankle showing my new design;
FIG. 2 is a rear elevational view thereof;

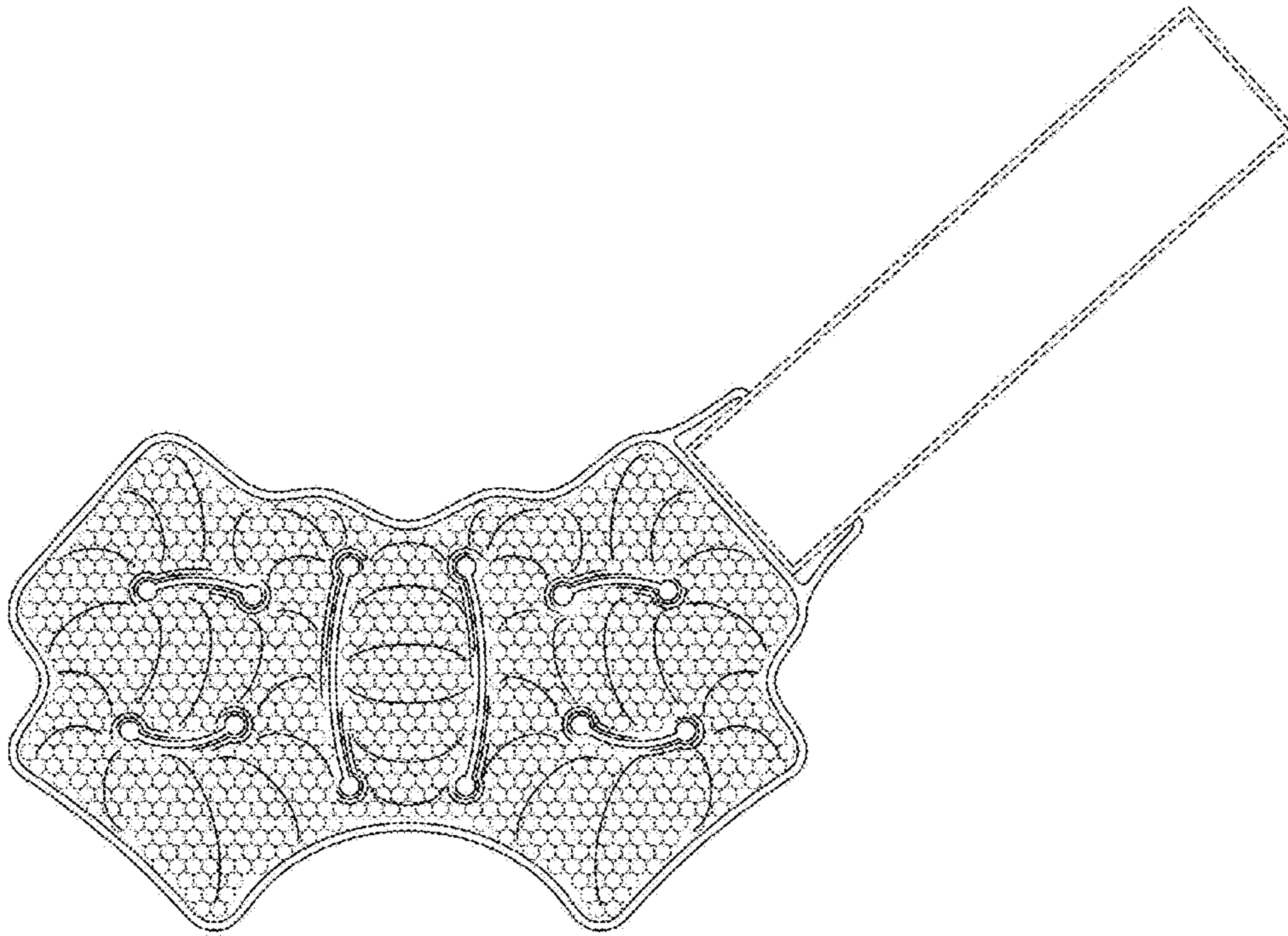

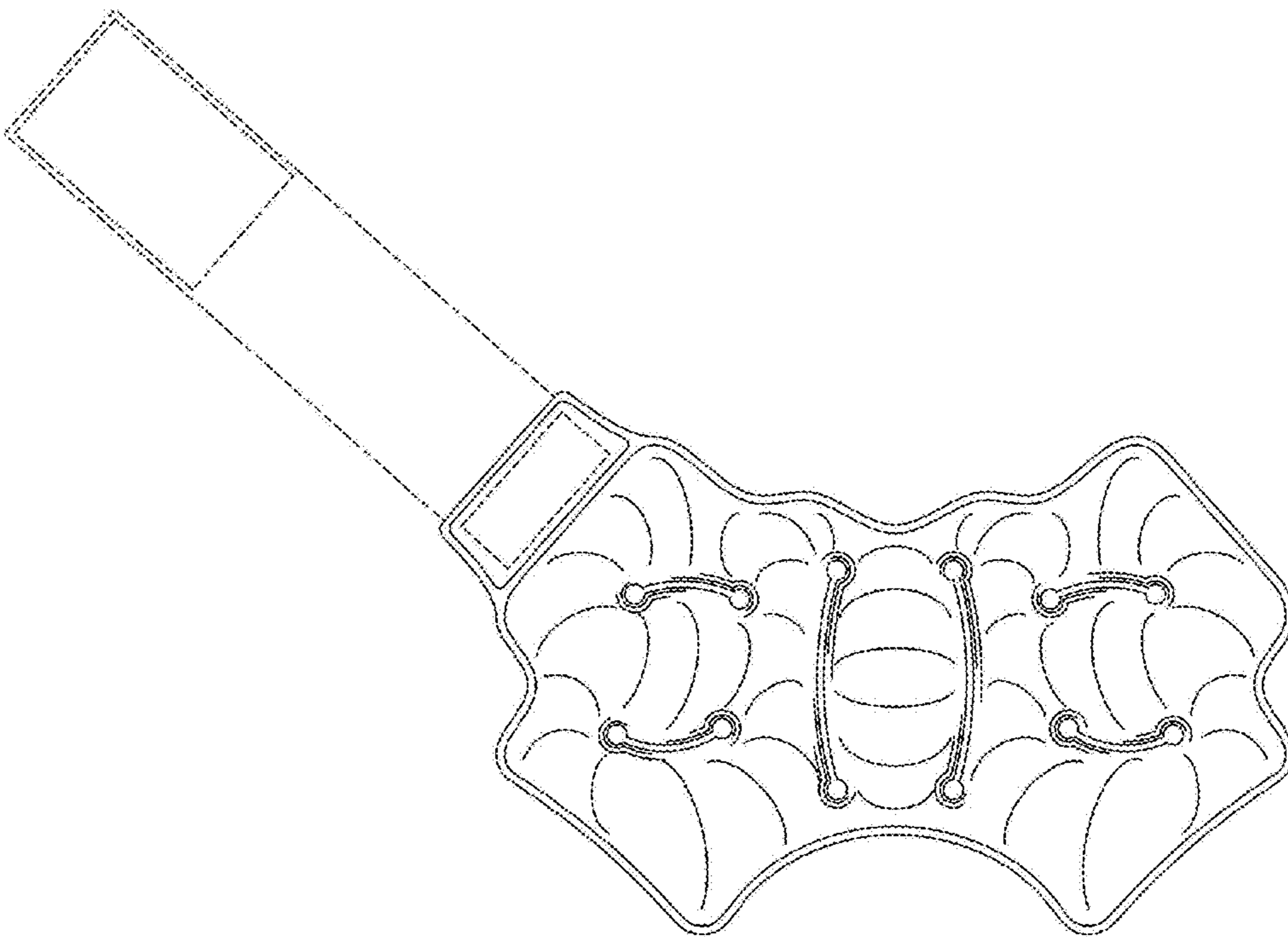

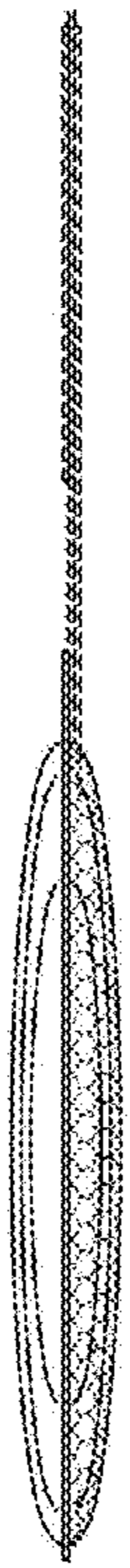

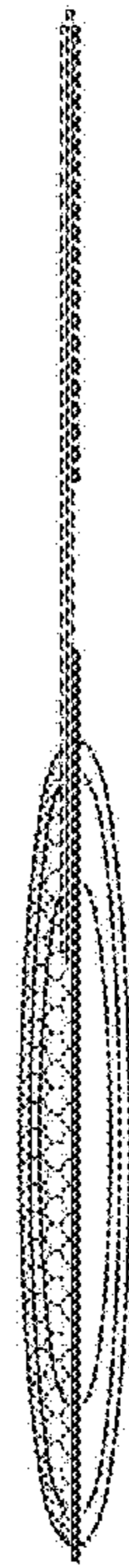

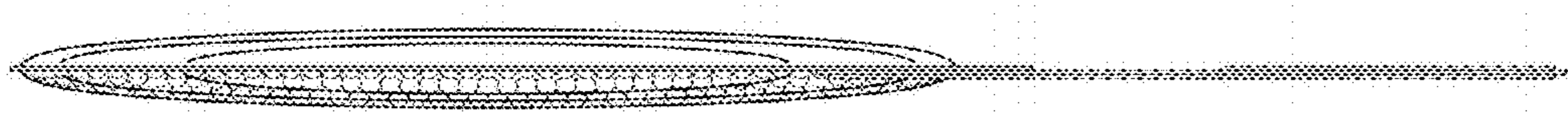

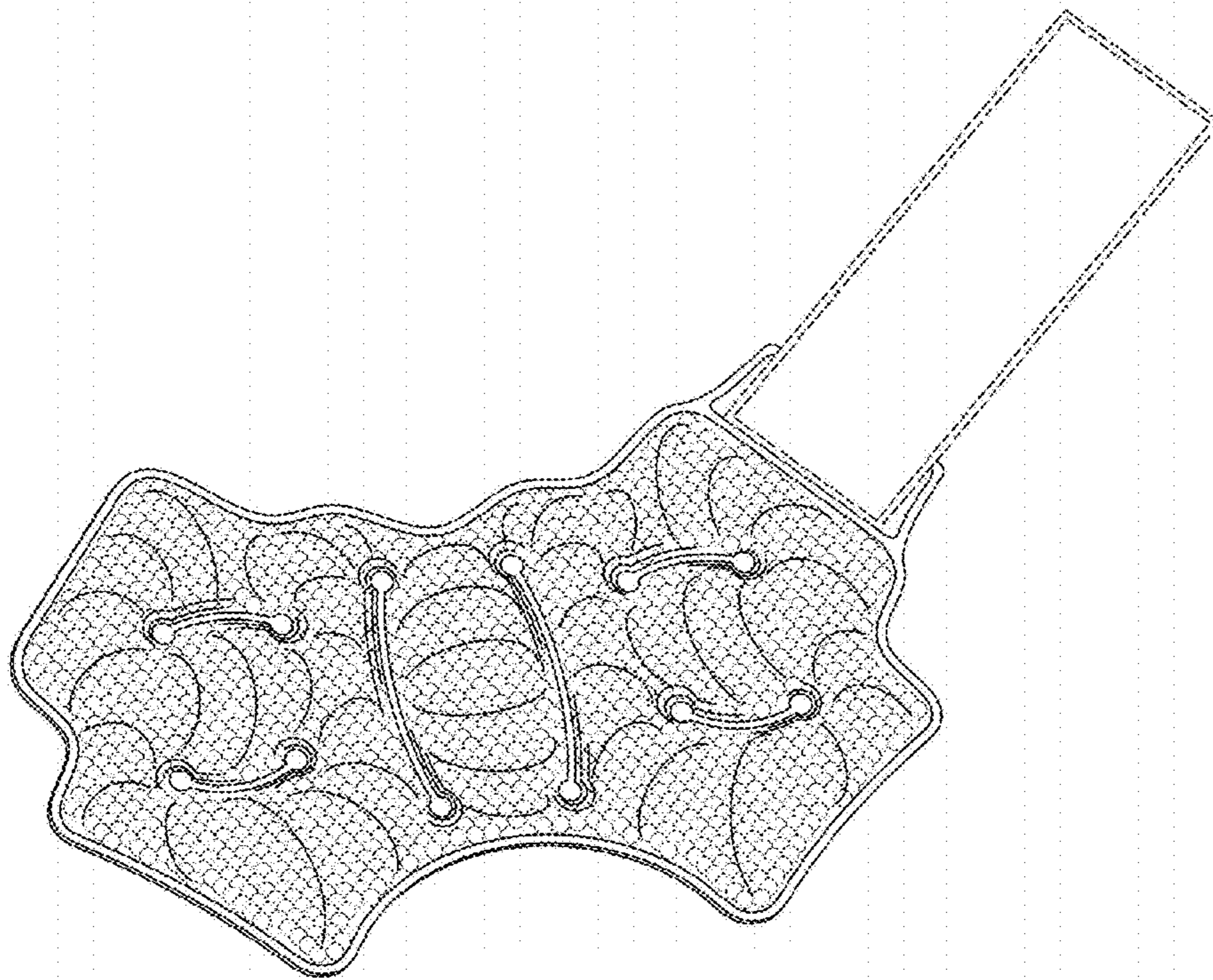

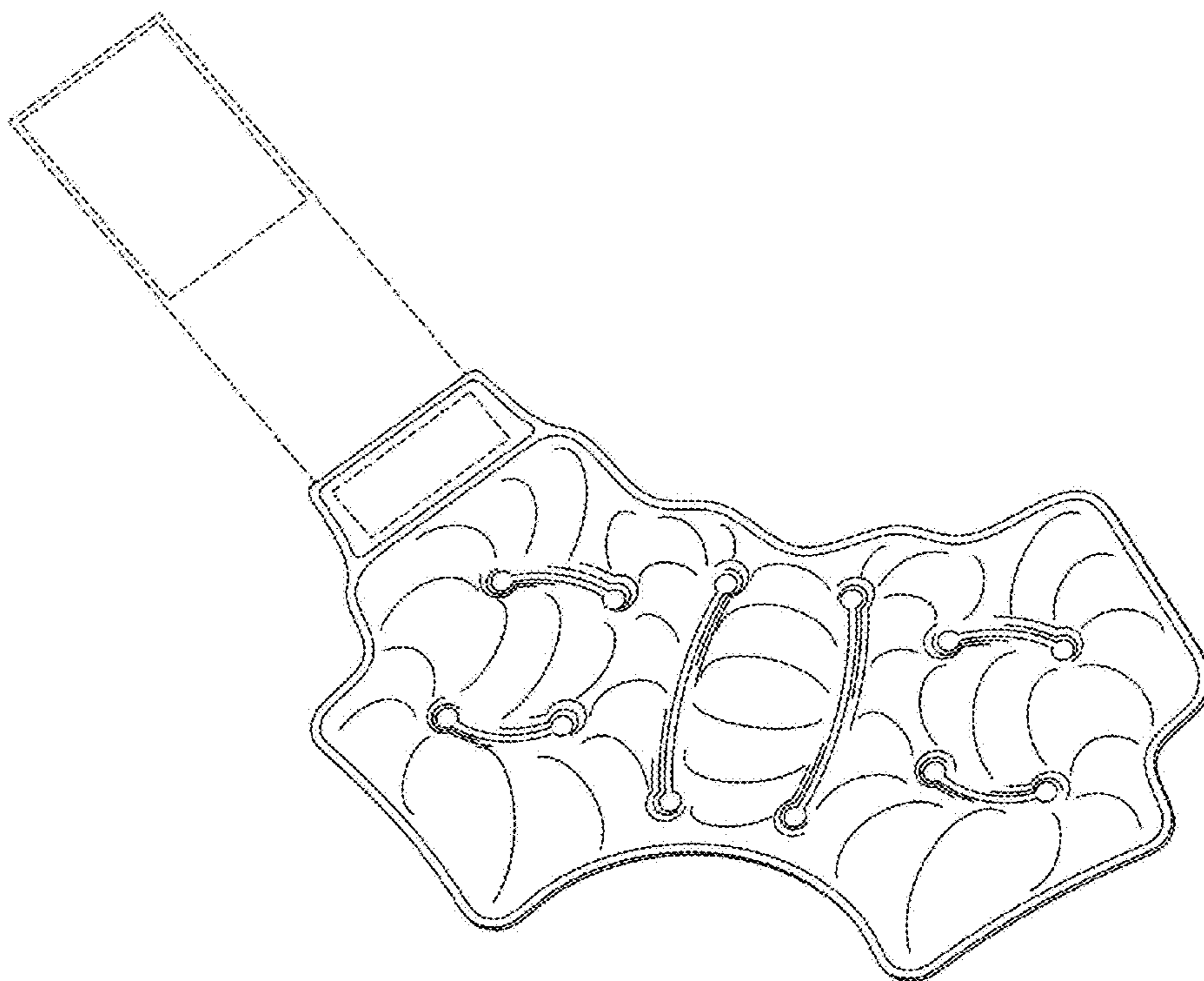
