(57) **CLAIM**

We claim the ornamental design for a vaporizer, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a vaporizer showing my new design;

FIG. 2 is a left side elevational view thereof, the right side elevational being a mirror image thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is perspective view thereof, with the electronic battery member removed;

FIG. 7 is a front elevational view thereof, the rear elevational view being identical thereof;

FIG. 8 is a left side elevational view thereof, the right side elevational being identical thereof;

FIG. 9 is a top plan view thereof;

FIG. 10 is a bottom plan view thereof;

FIG. 11 is an exploded perspective view thereof illustrating the components of the vaporizer;

FIG. 12 is a front elevational view of an alternative embodiment of a vaporizer showing the vent sleeve rotated to a partially closed position;

FIG. 13 is a left side elevational view thereof, the right side elevational being a mirror image thereof;

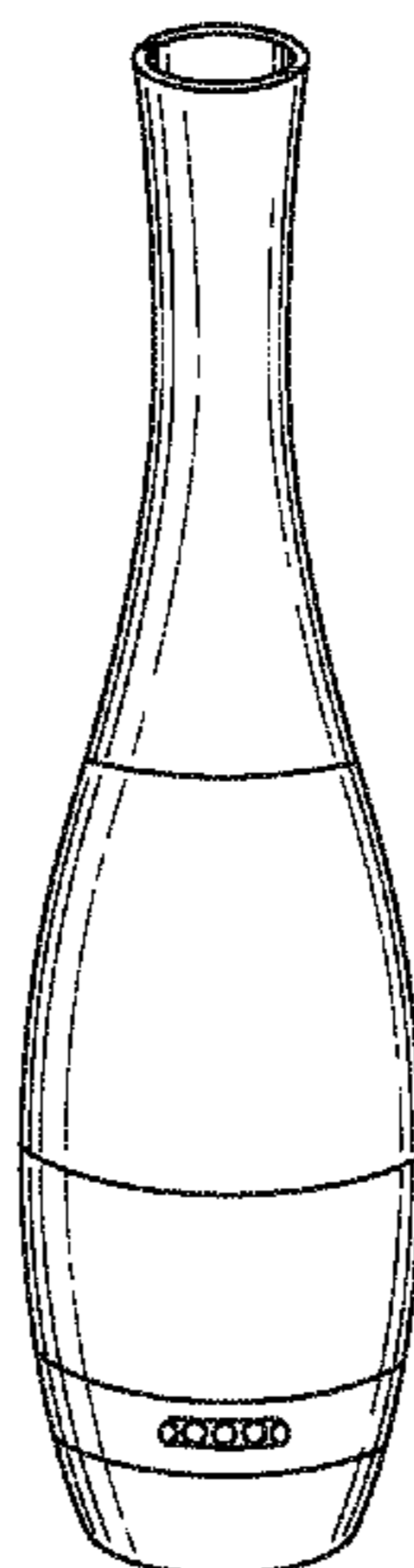
FIG. 14 is a rear elevational view thereof;

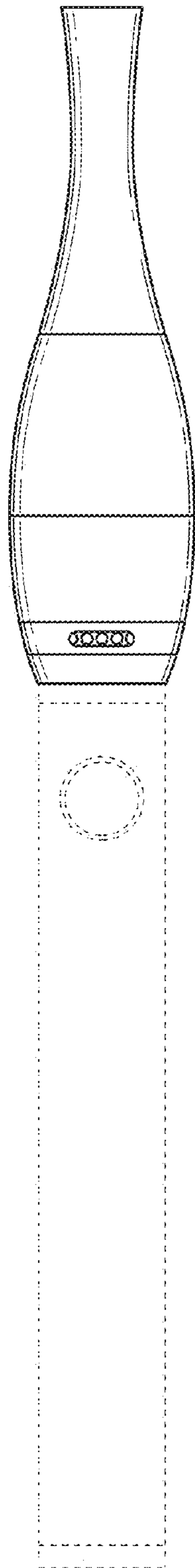

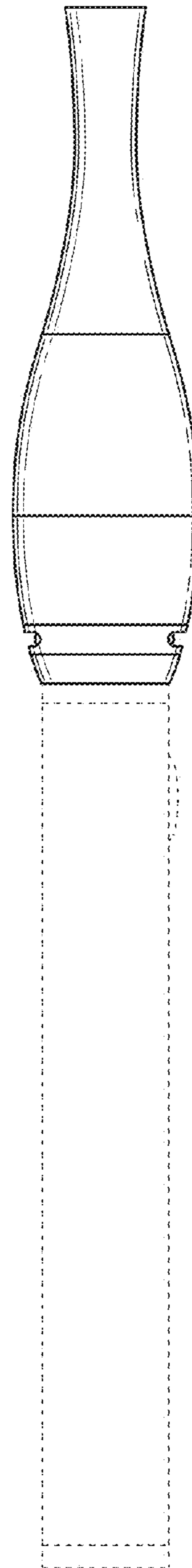

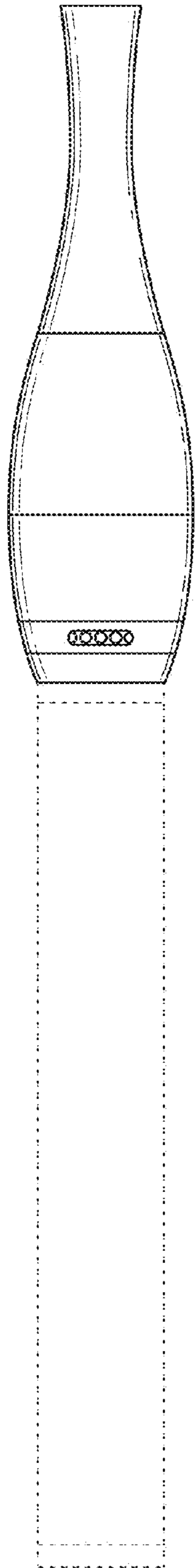

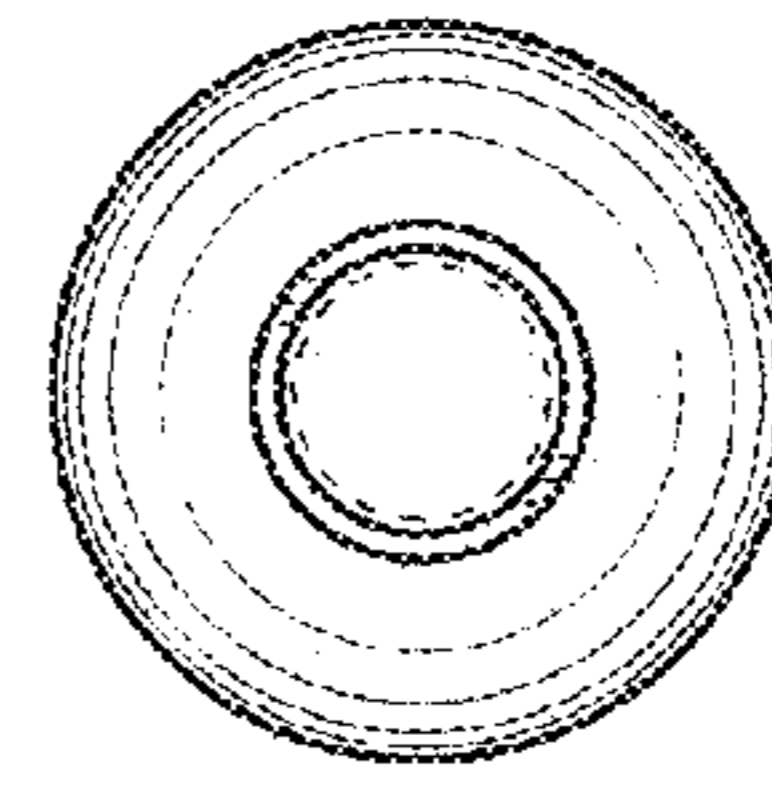

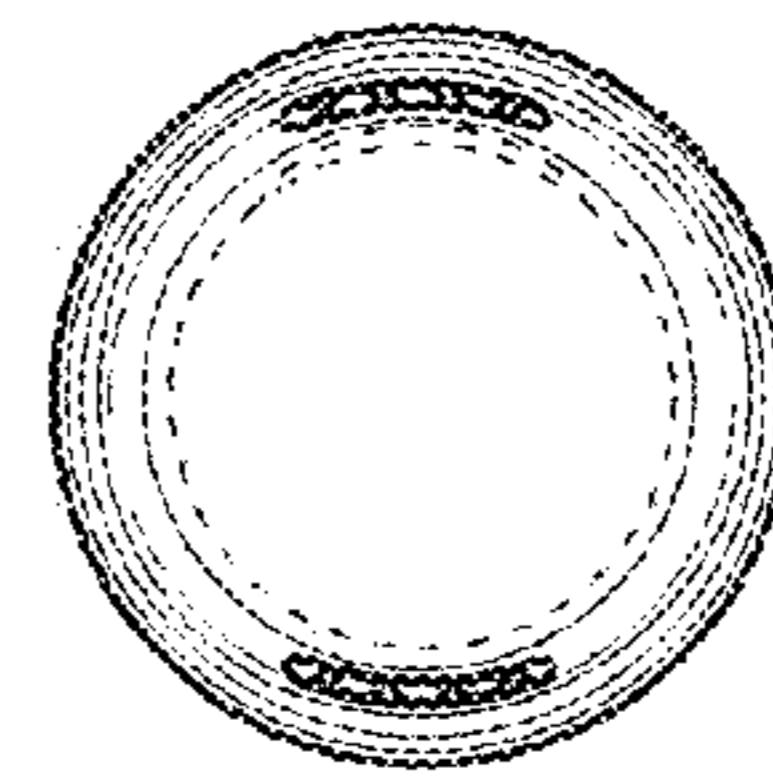

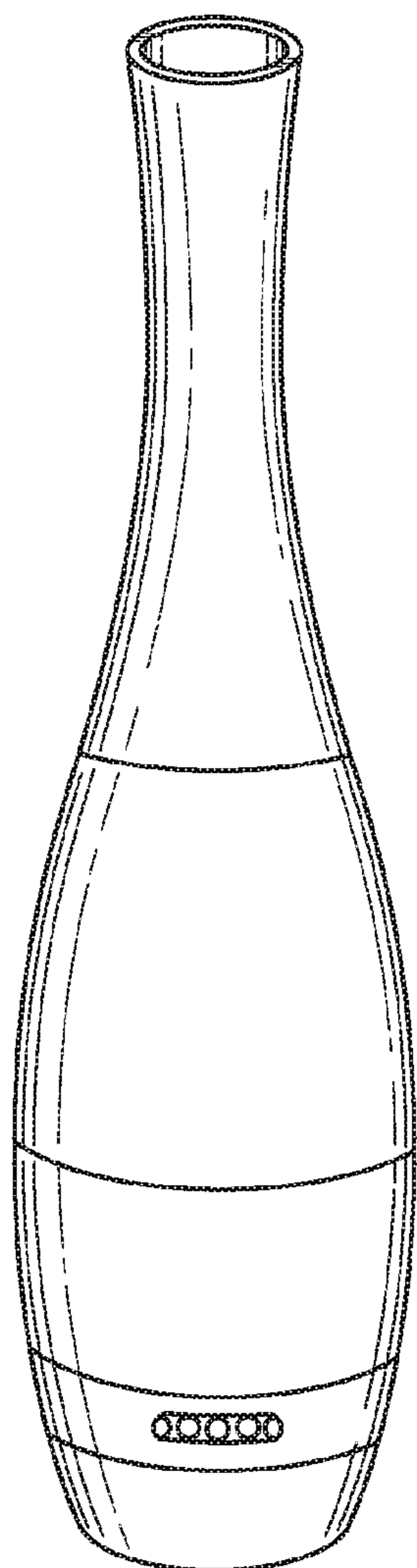

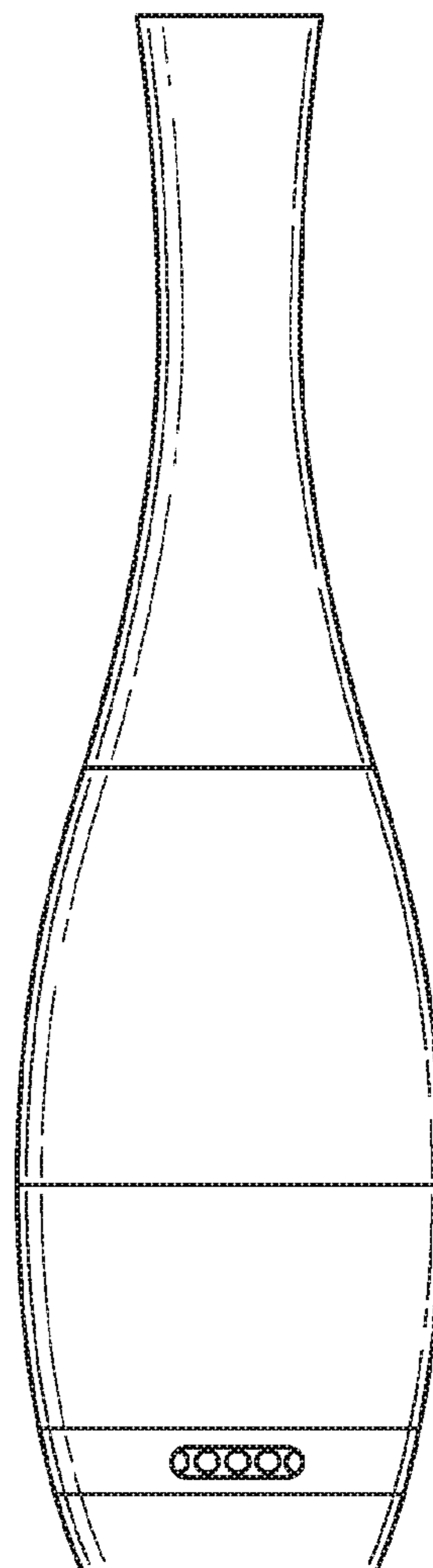

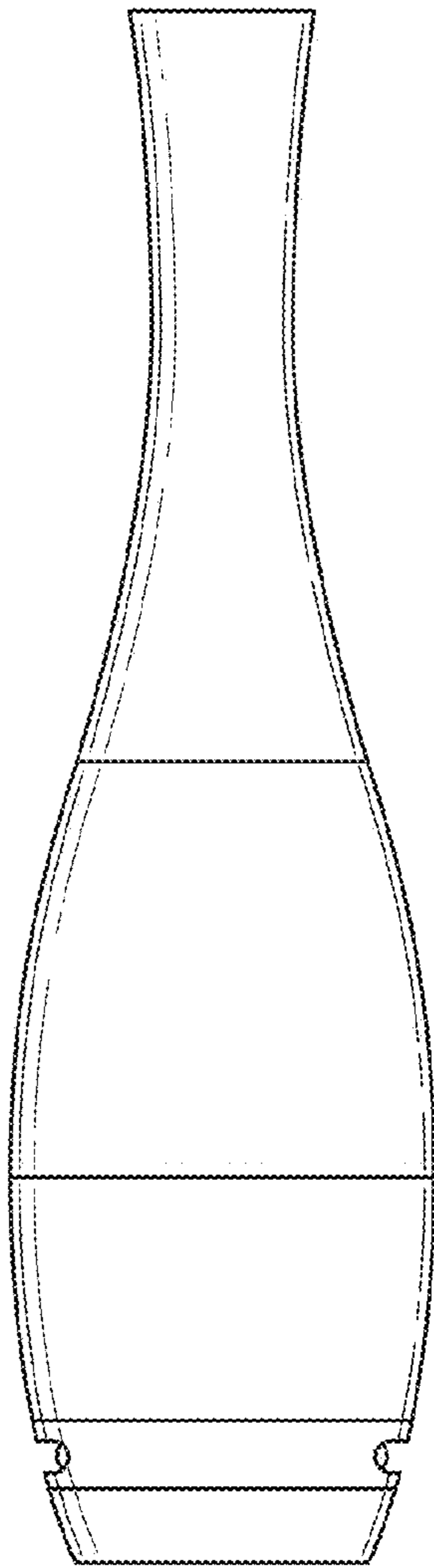

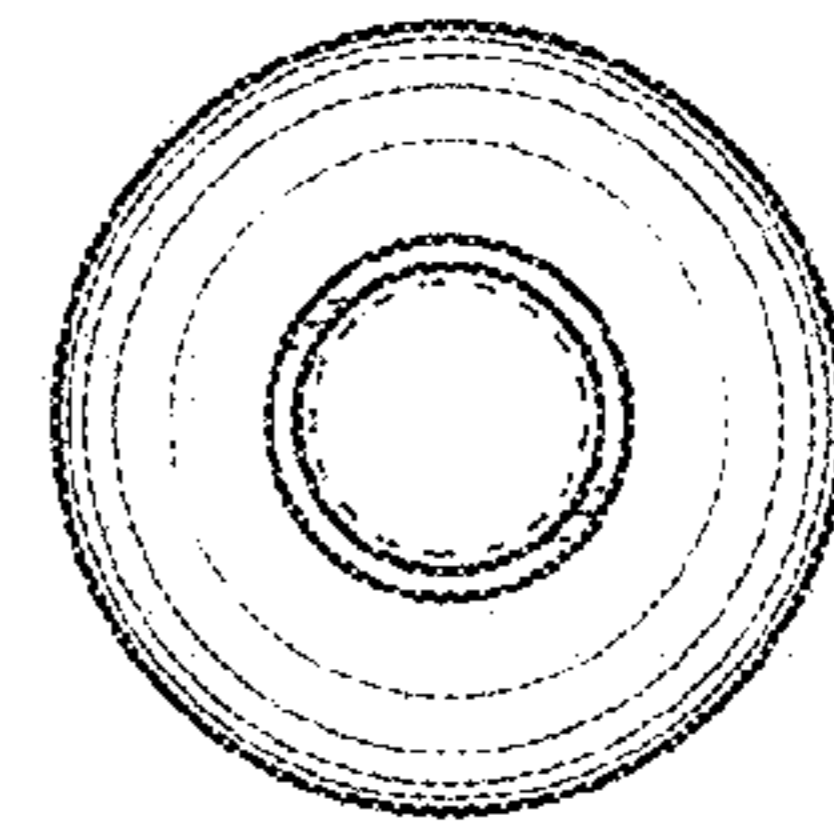

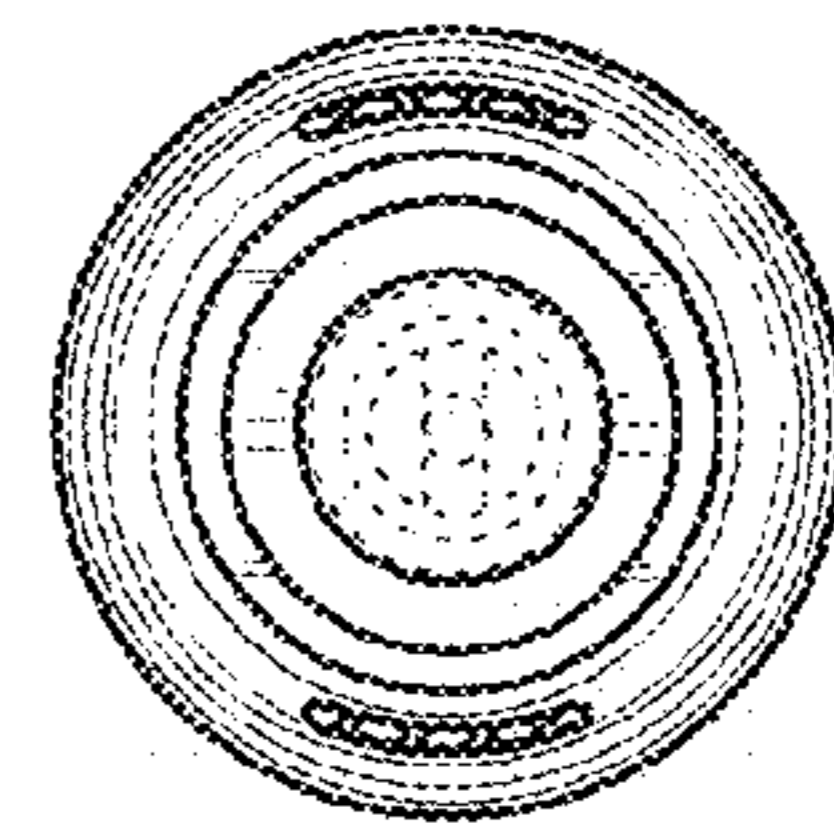
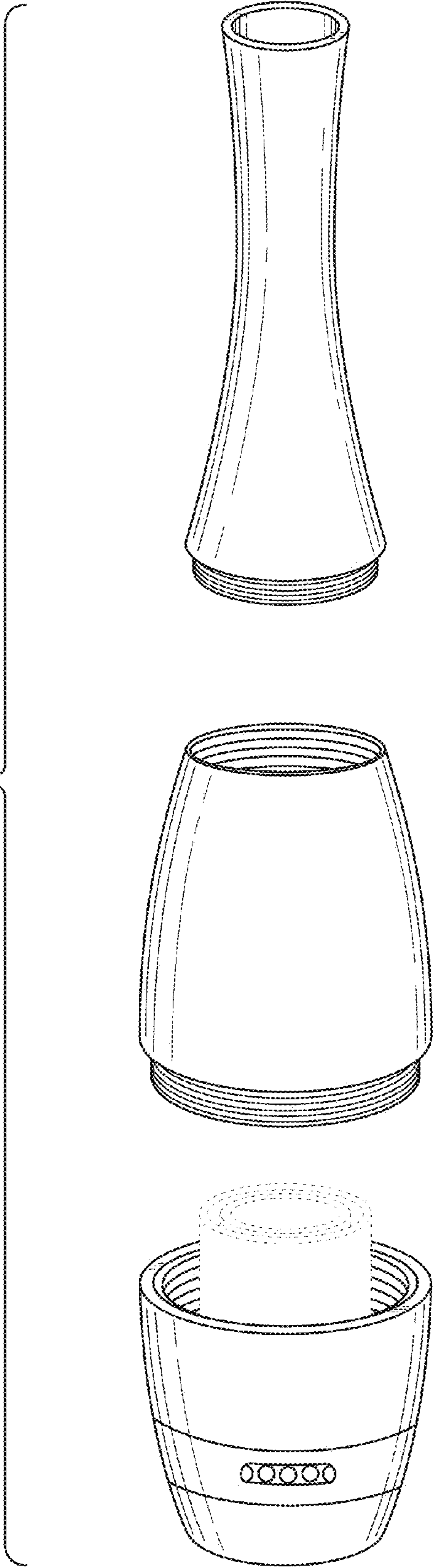

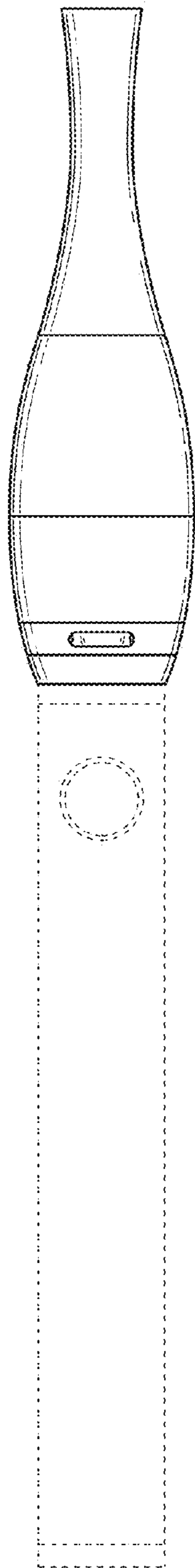

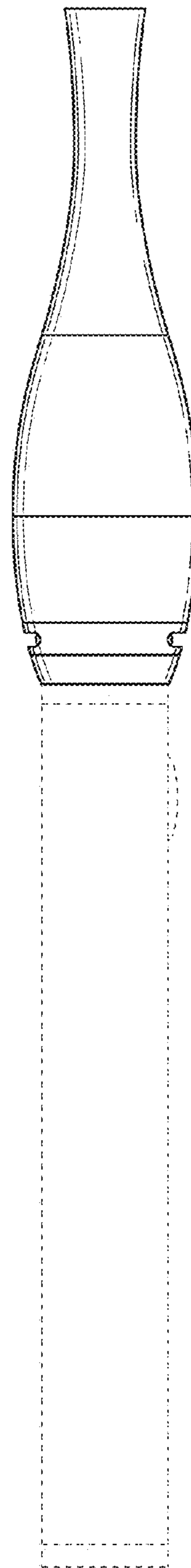

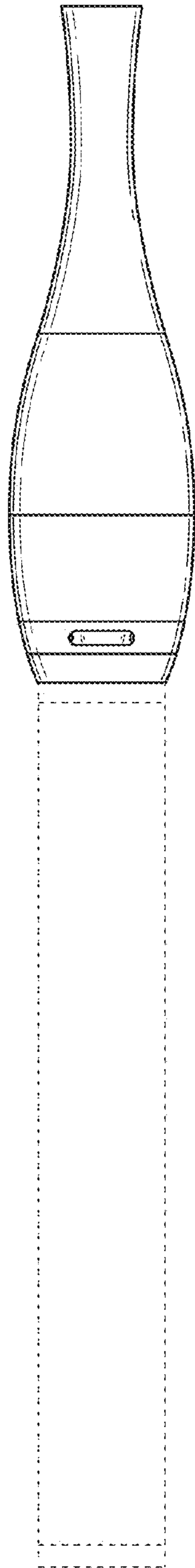

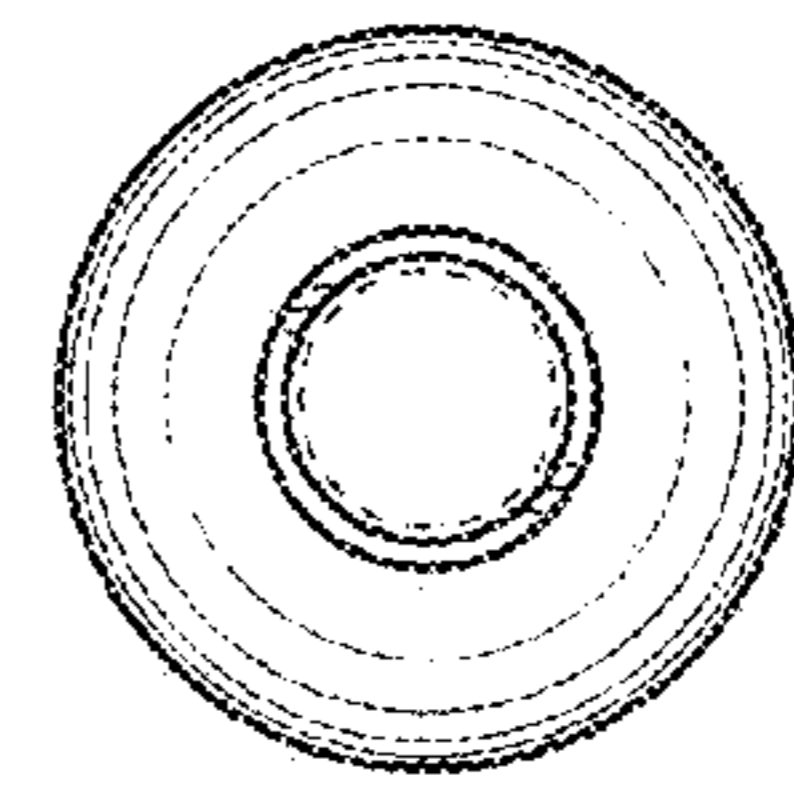

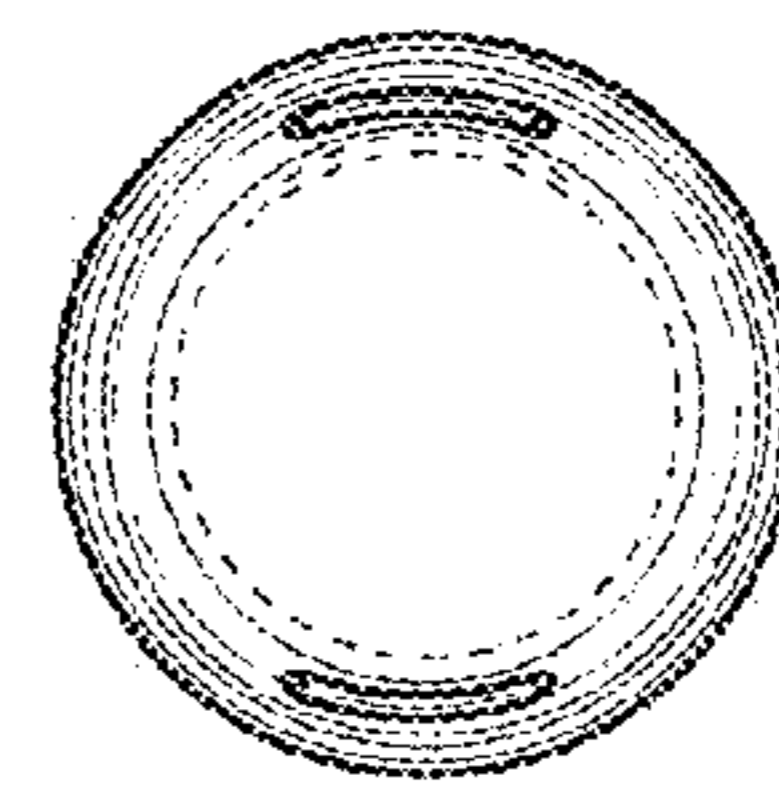
