DESCRIPTION

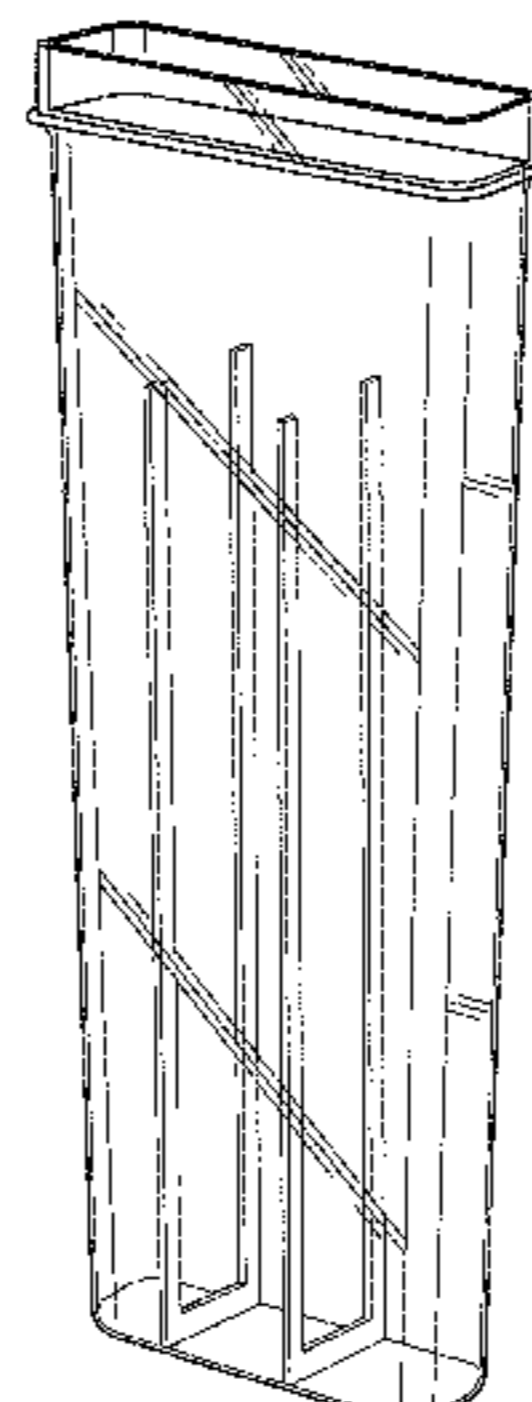
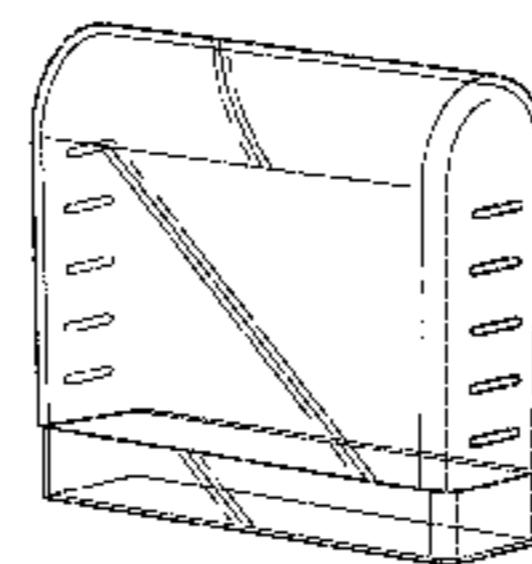
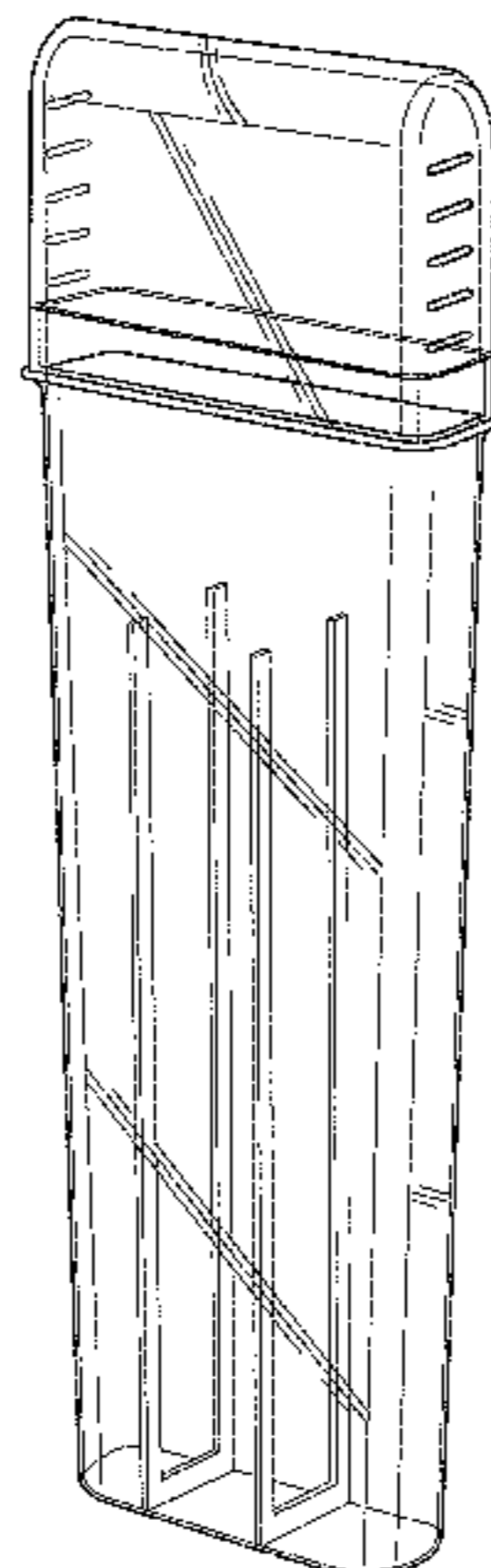
FIG. 1 is a front perspective view of a transparent plastic cigar pack, showing my new design;

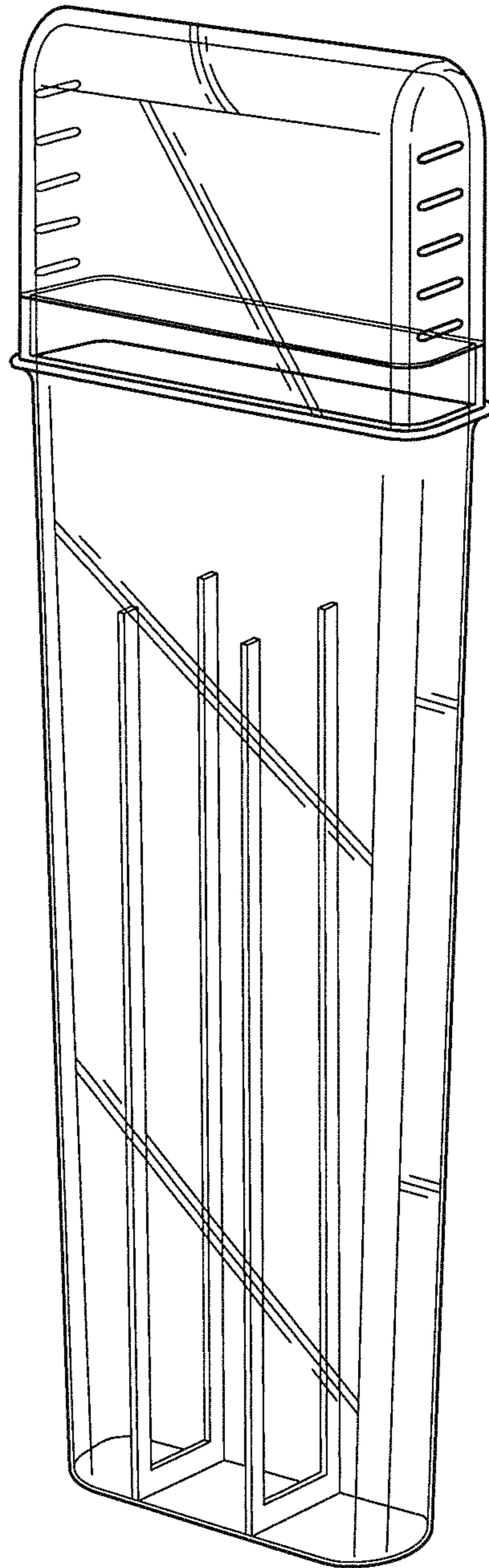

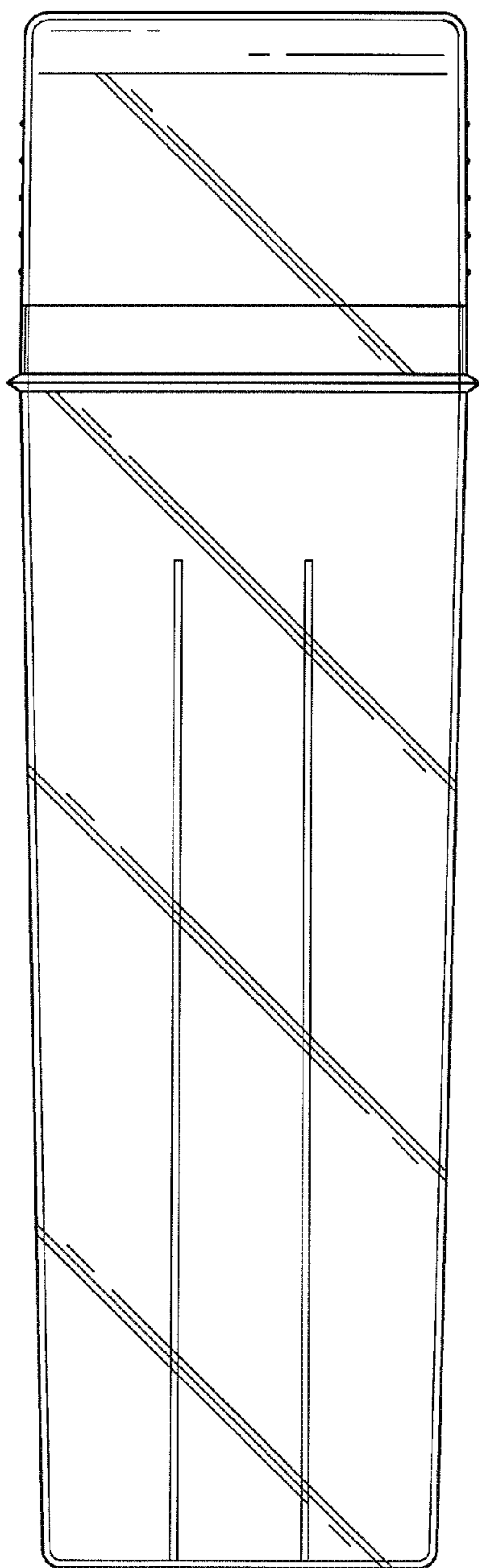

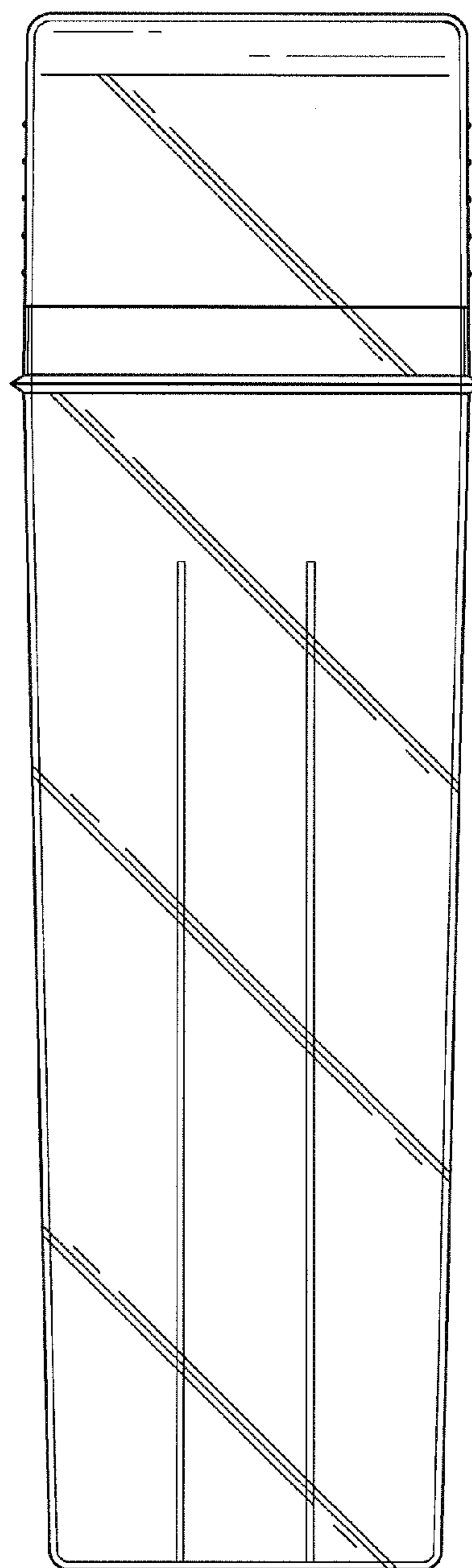

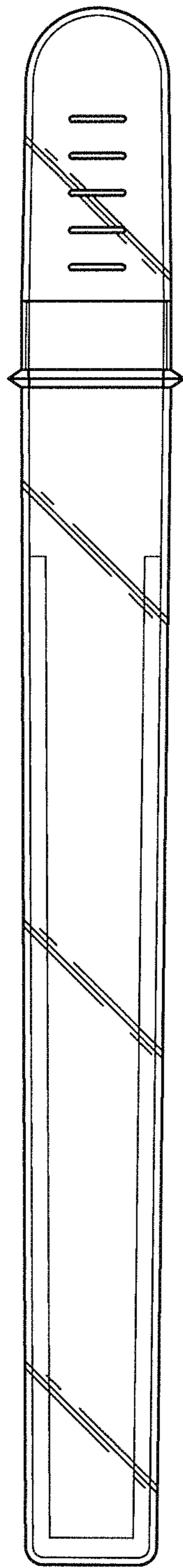

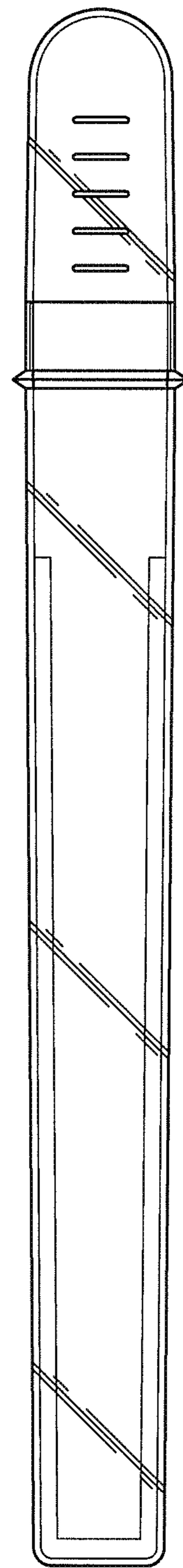

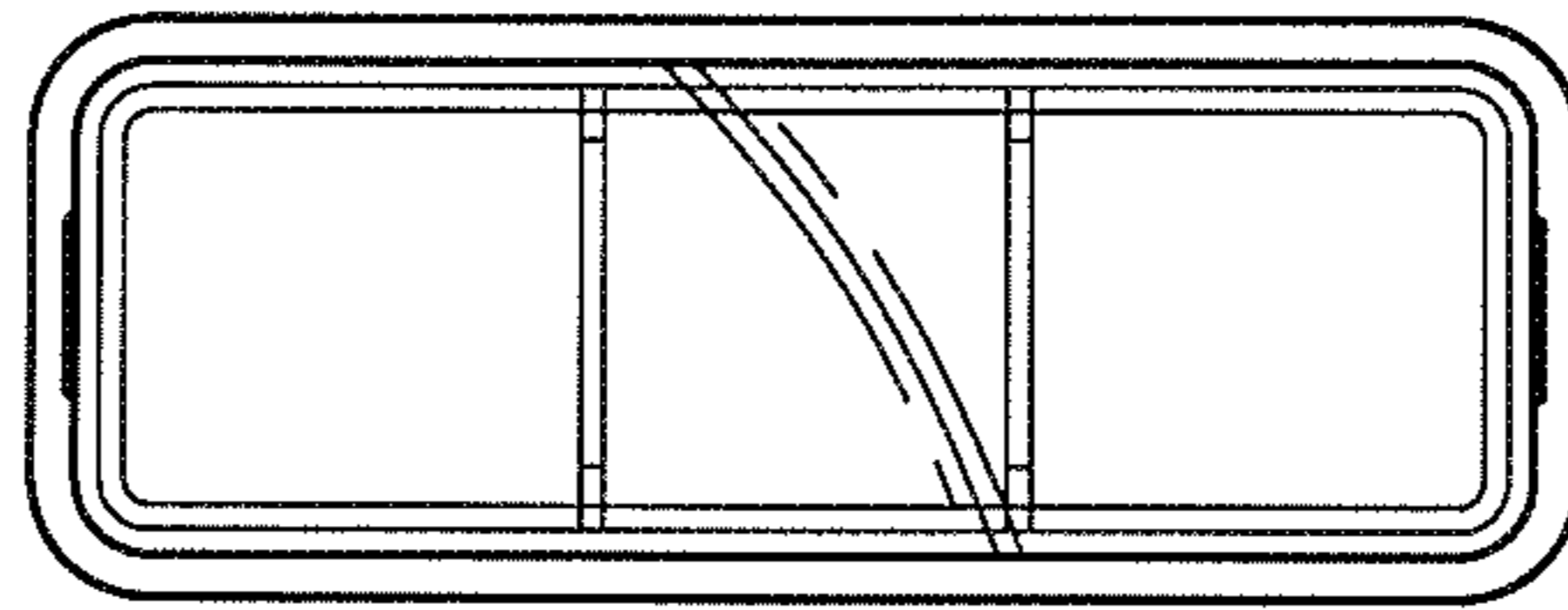

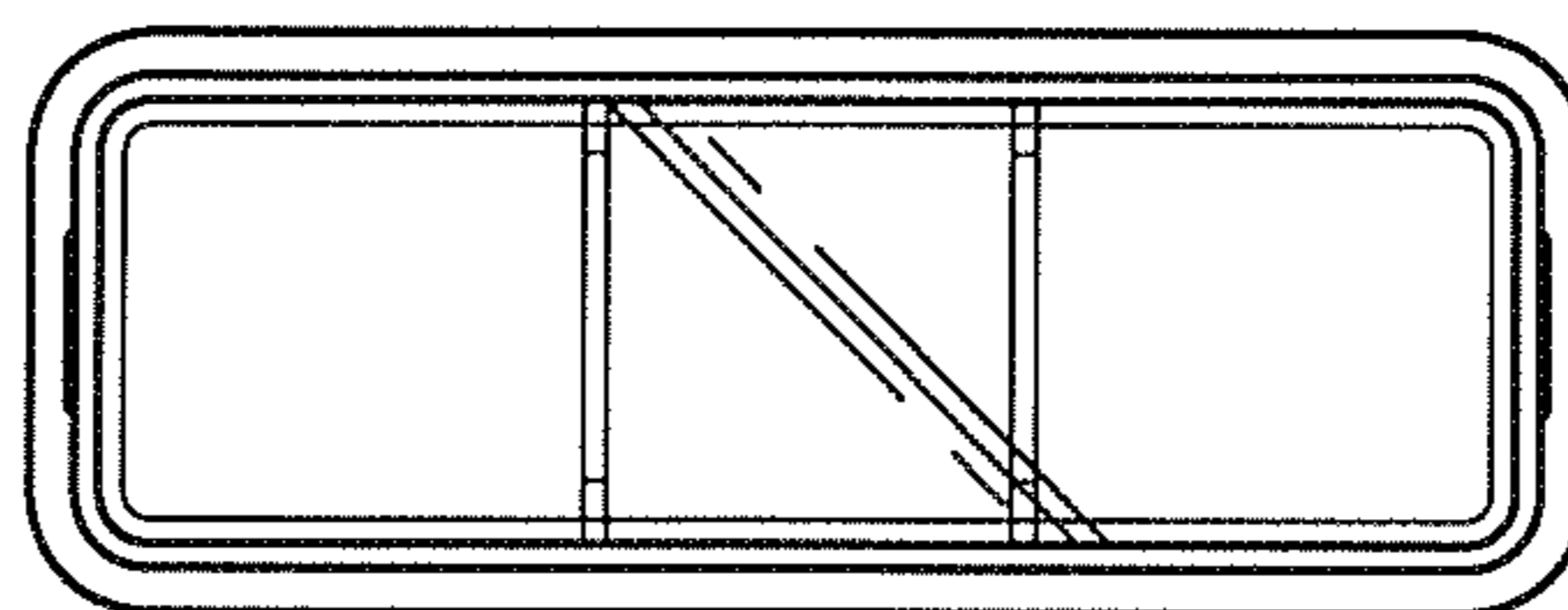
