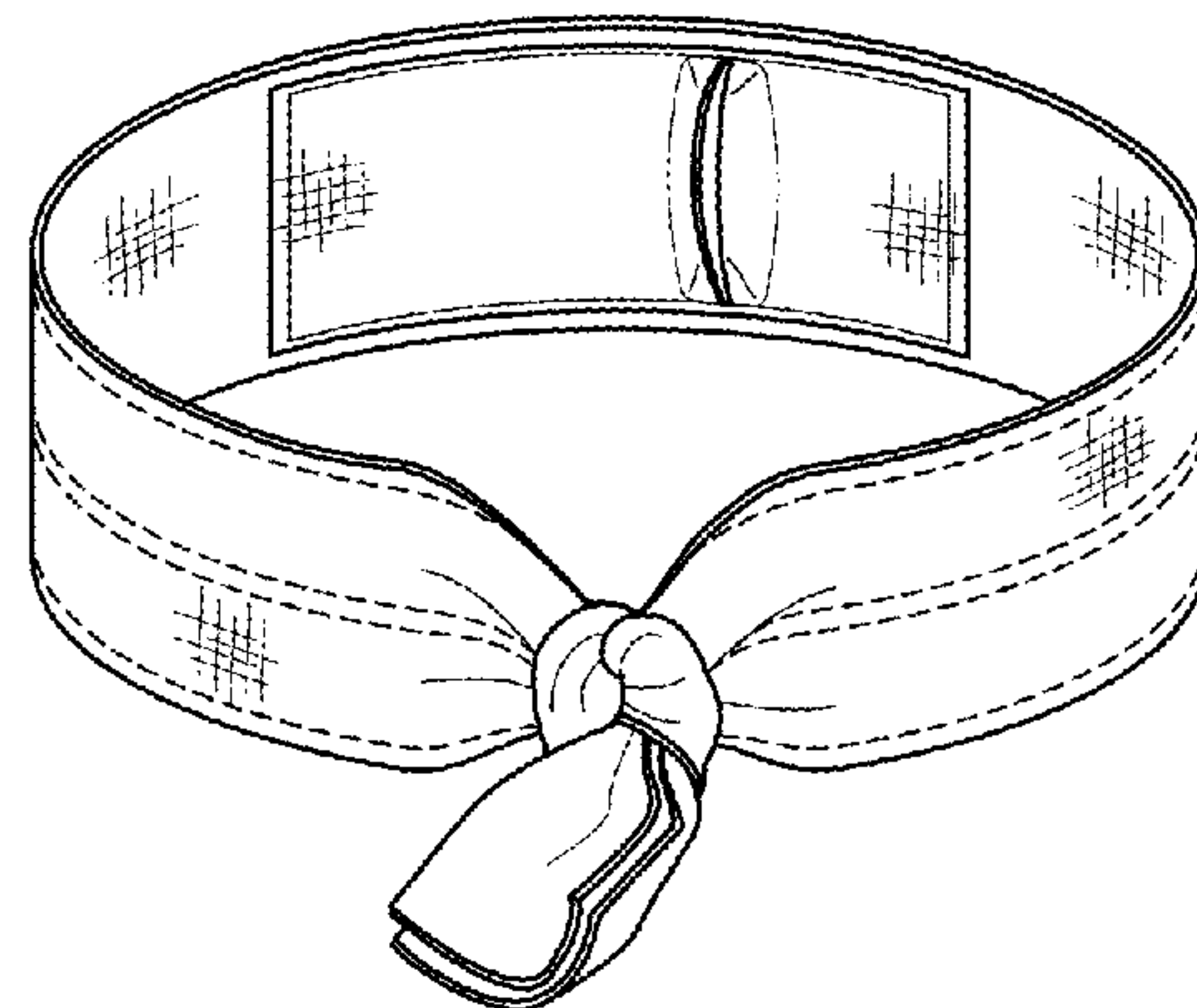
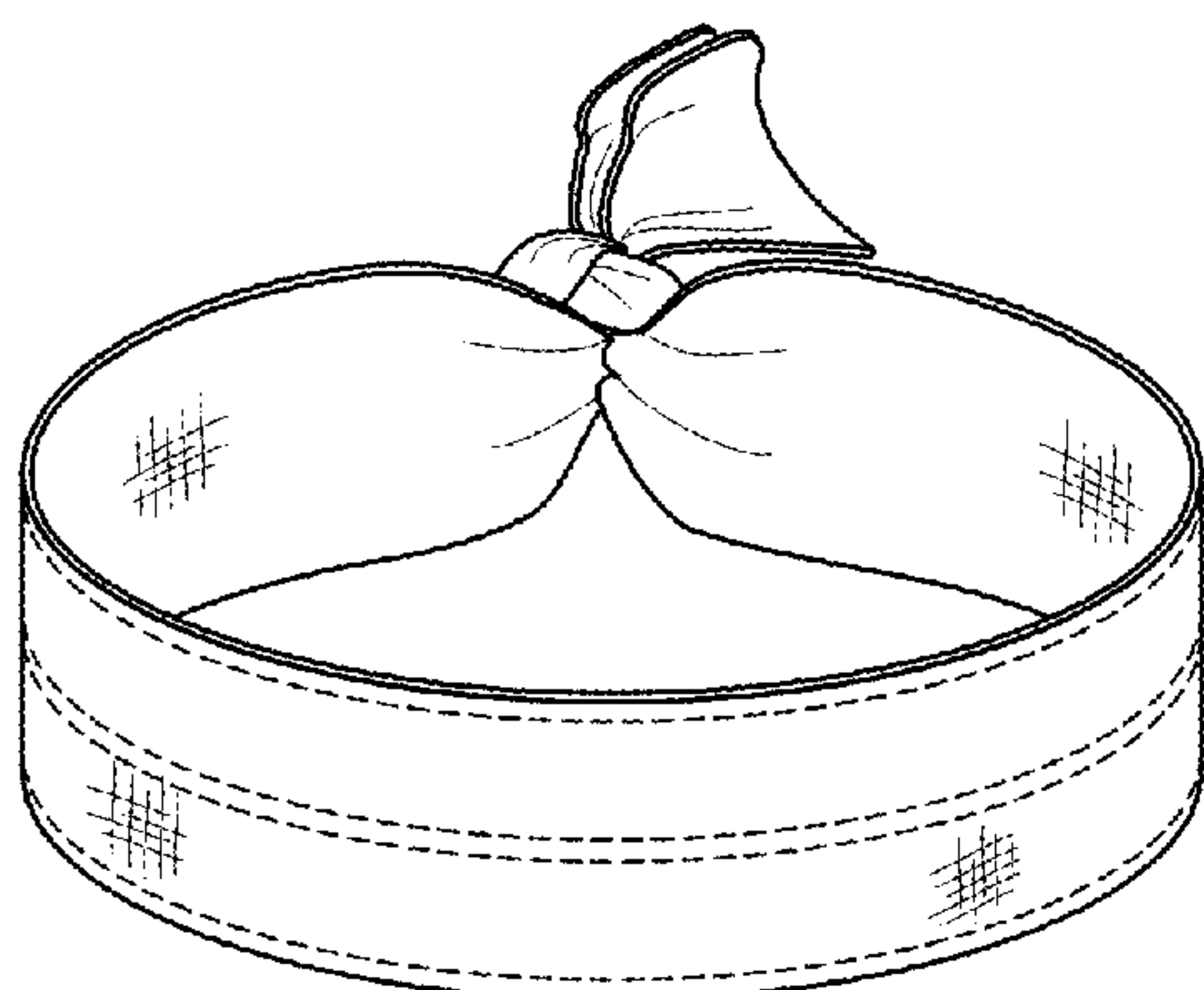
(57) **CLAIM**

The ornamental design for a wristband, as shown and
described.

DESCRIPTION

FIG. 1 is an isometric front view showing the new design for
a wristband in the closed position;
FIG. 2 is an isometric back view showing the new design for
a wristband in the closed position;
FIG. 3 is a front elevation view showing the wristband in the
open position;
FIG. 4 is a back elevation view of the wristband in the open
position;
FIG. 5 is a right side elevation view of the wristband in the
open position, the left side being mirror image thereof; and,
FIG. 6 is a top plan view of the wristband in the open
position. The dashed lines represent environmental subject
matter, and form no part of the claimed design.

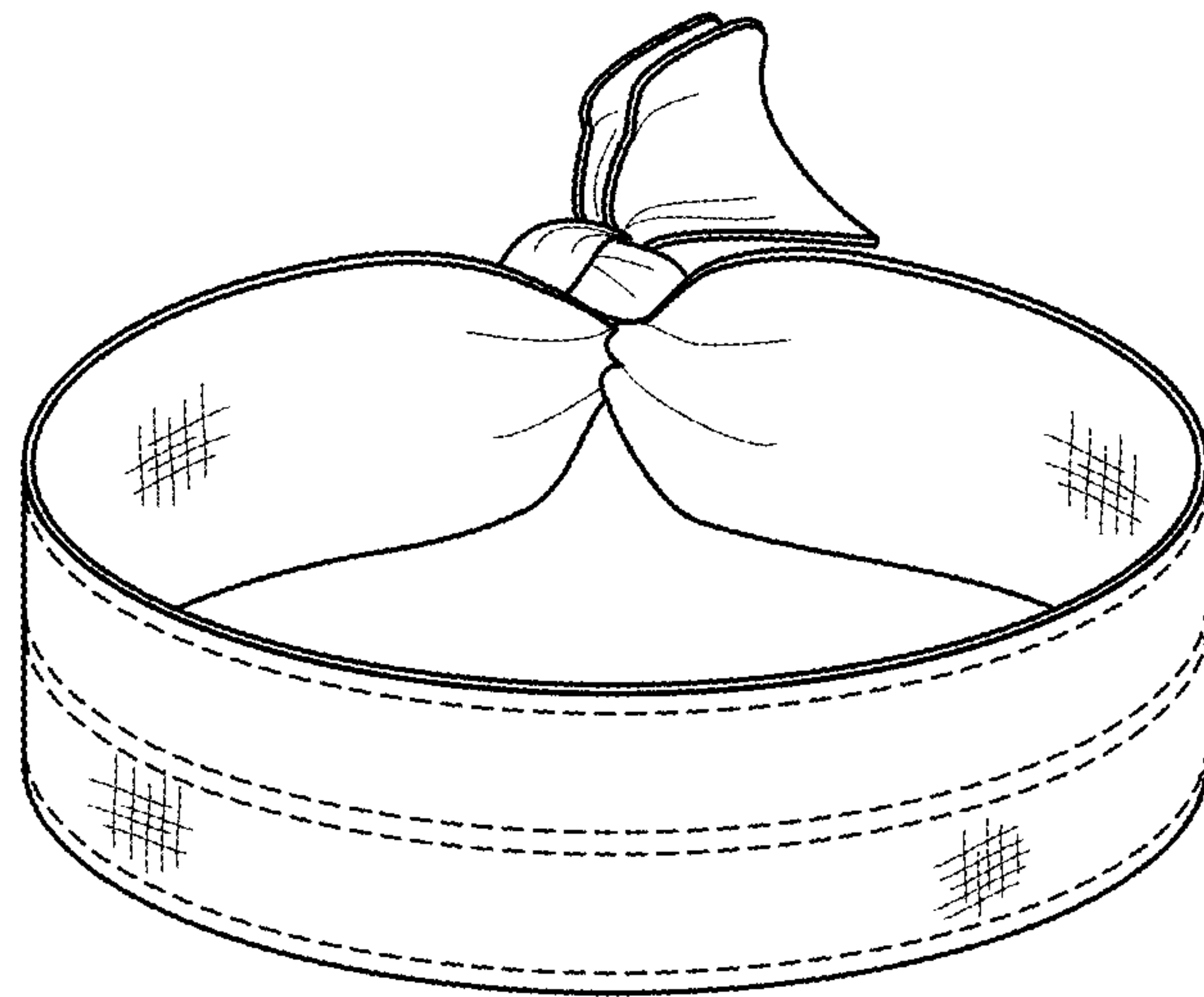

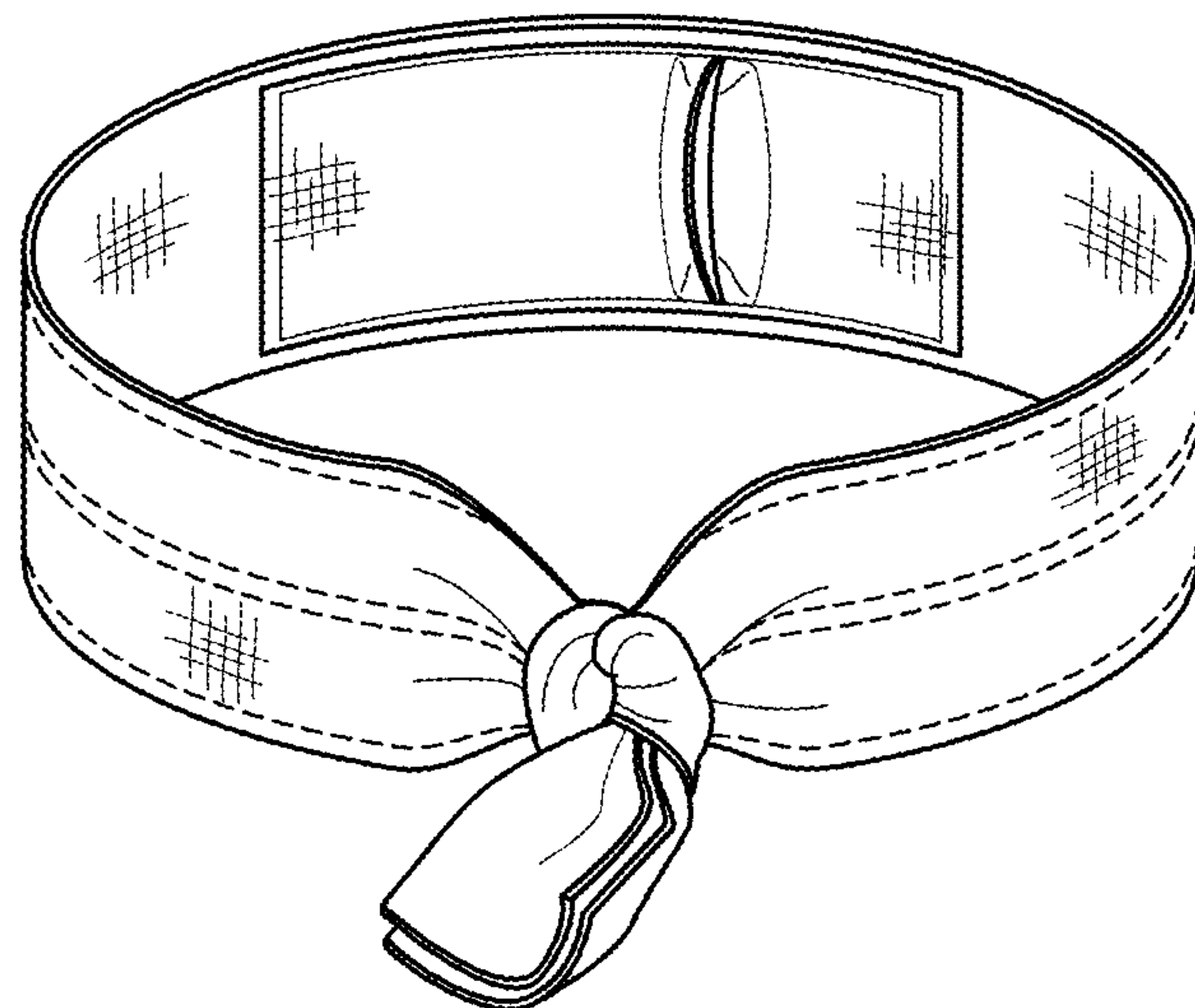

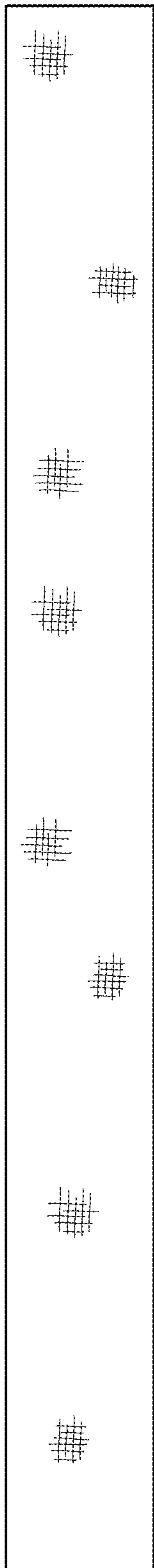

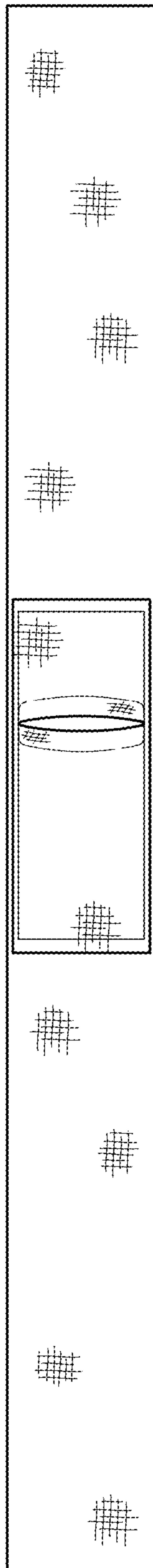
