The ornamental design for a dress, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a dress showing my new design;

FIG. 2 is a front view thereof;

FIG. 5 is a right side view thereof;

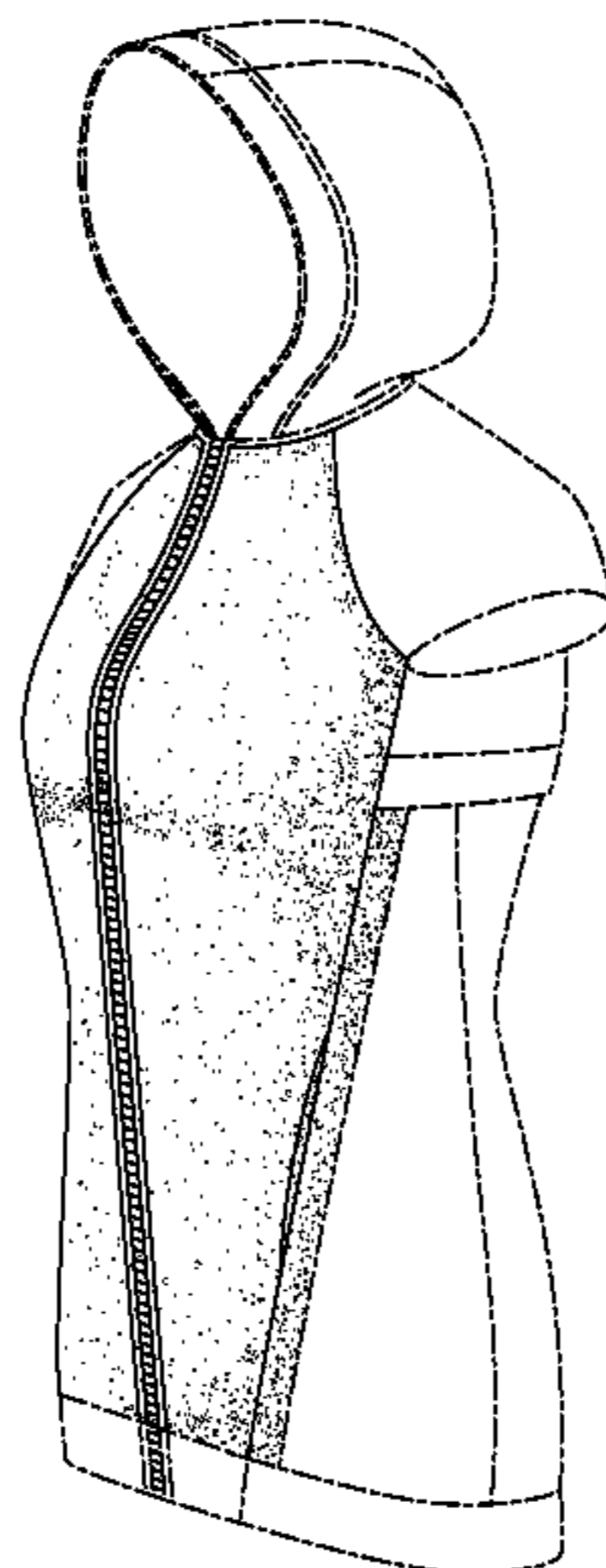
FIG. 6 is a top view thereof; and,

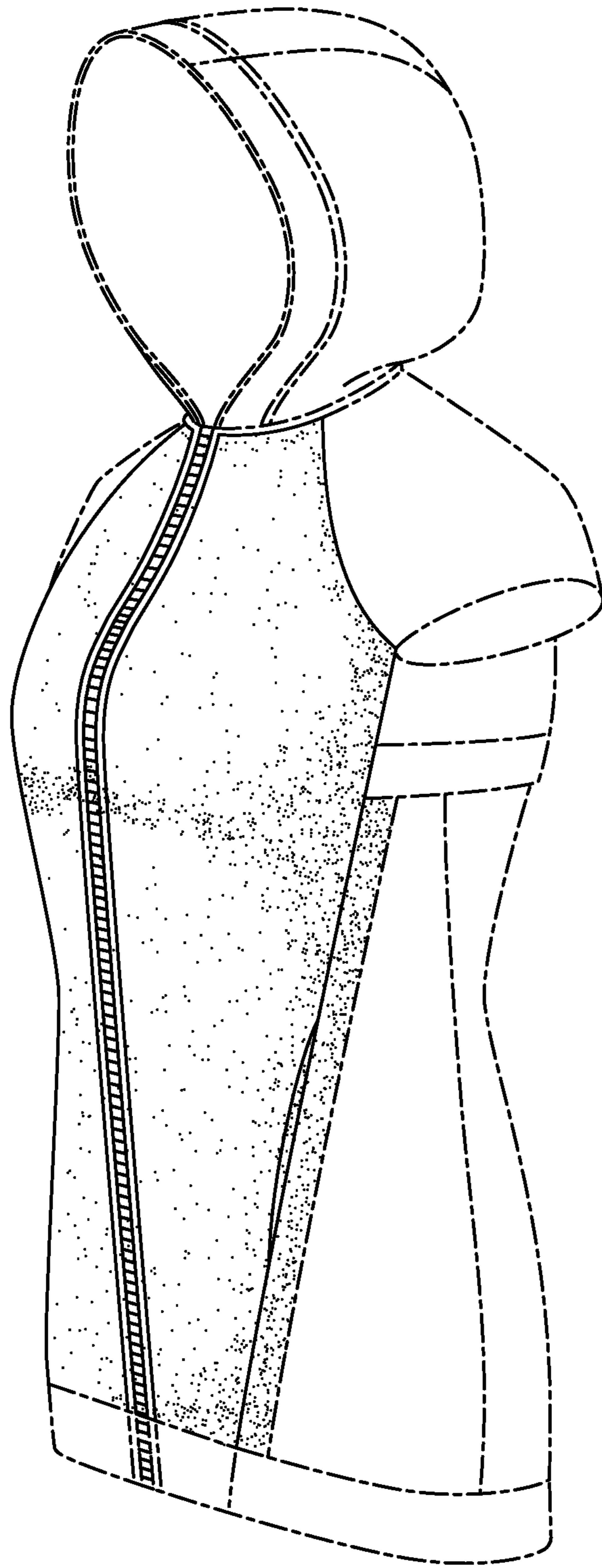

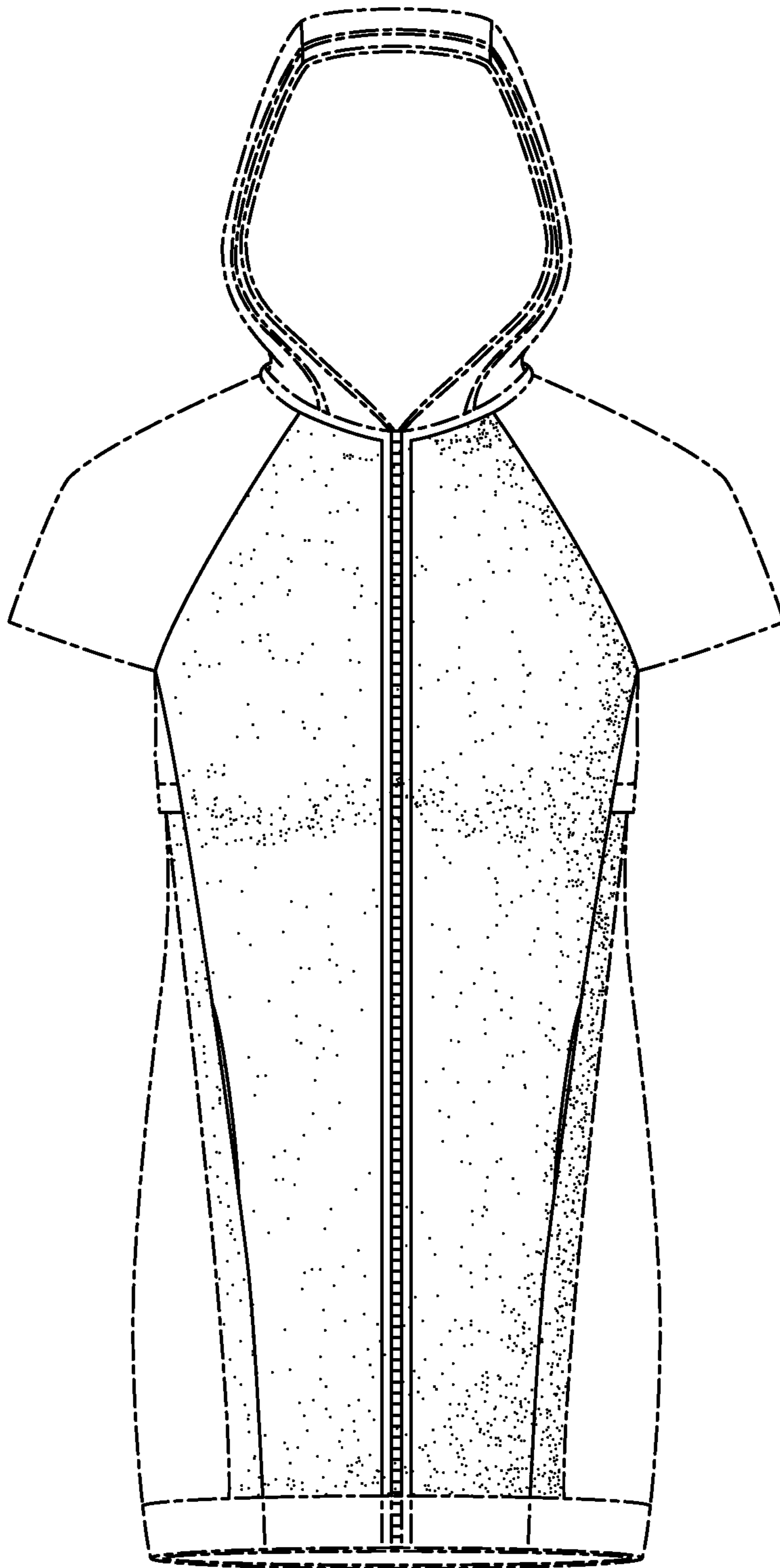

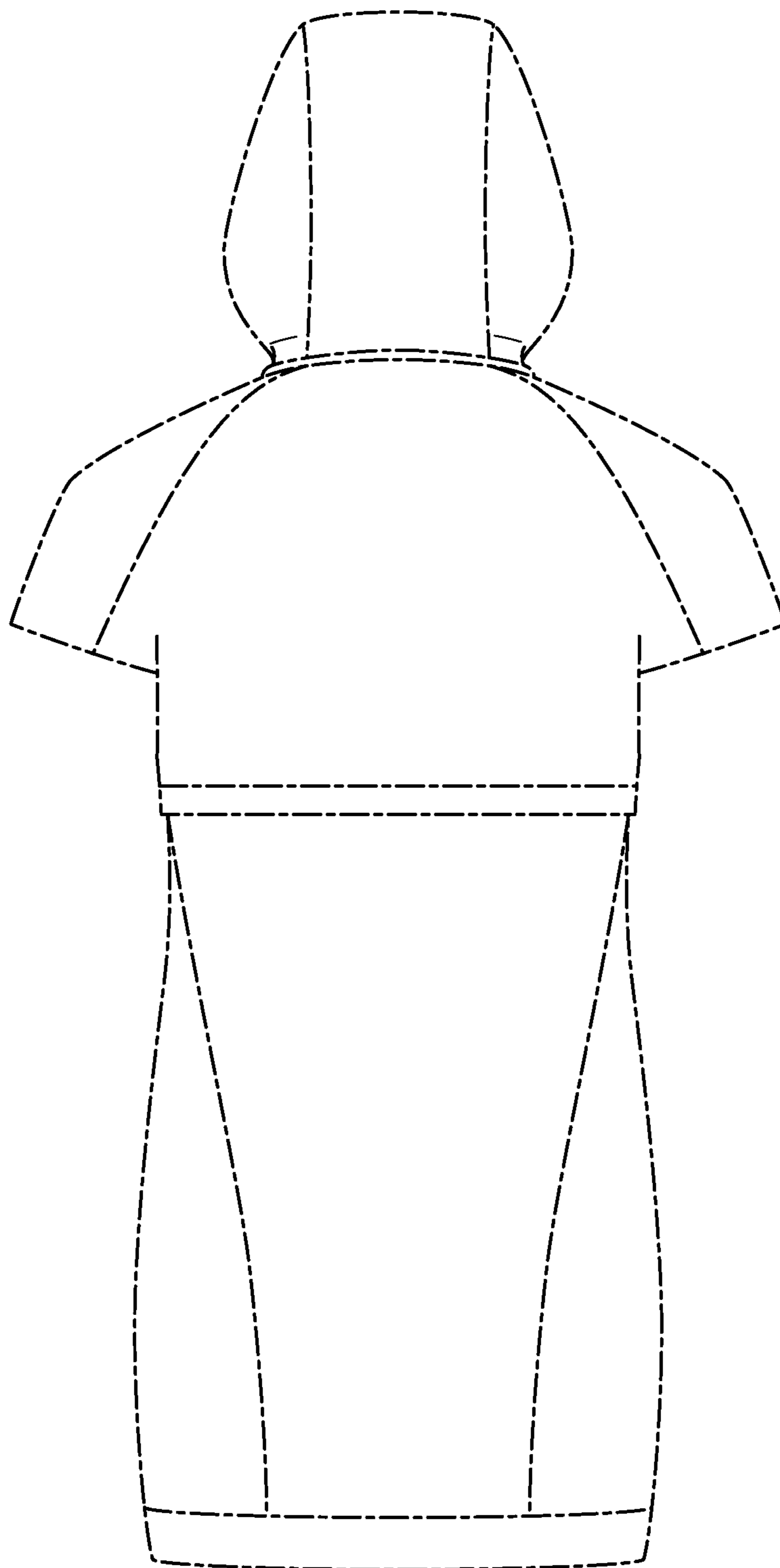

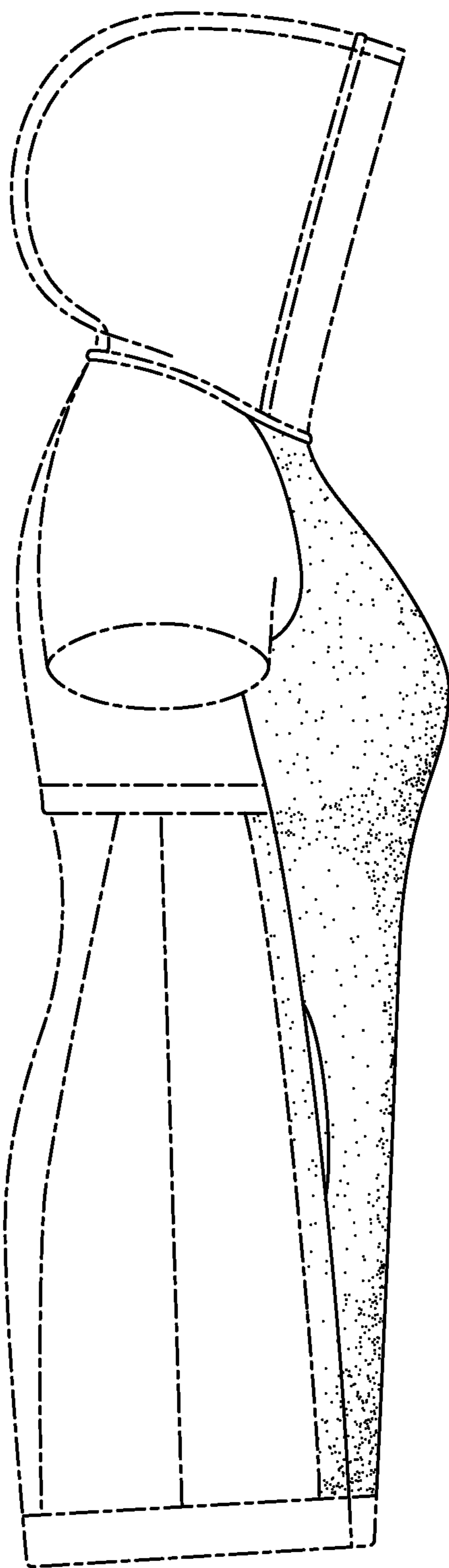

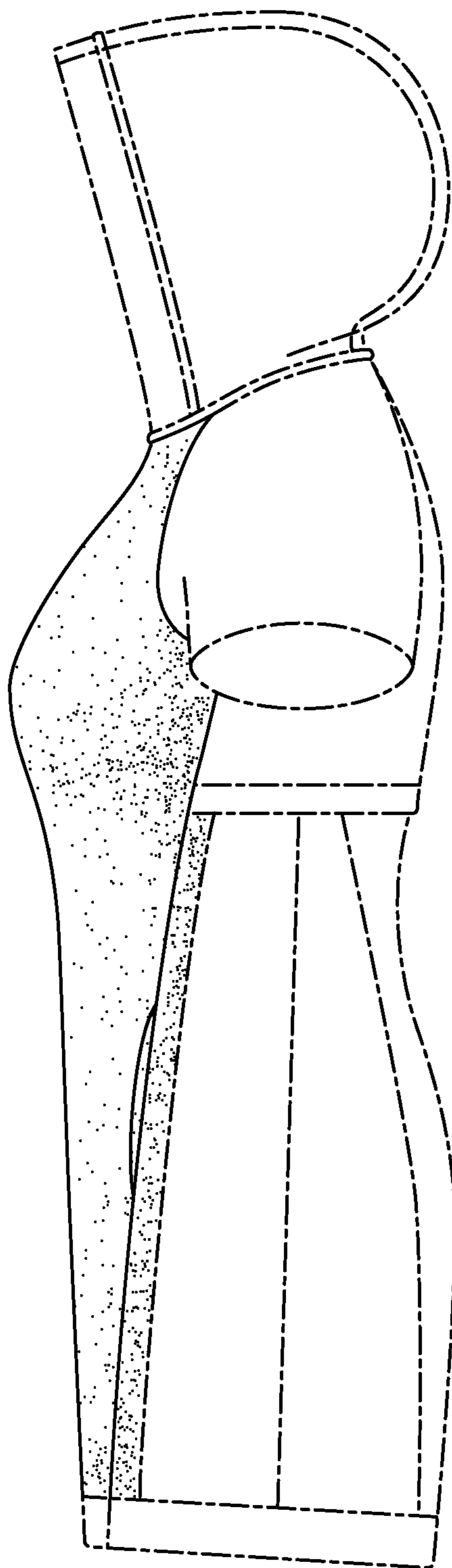

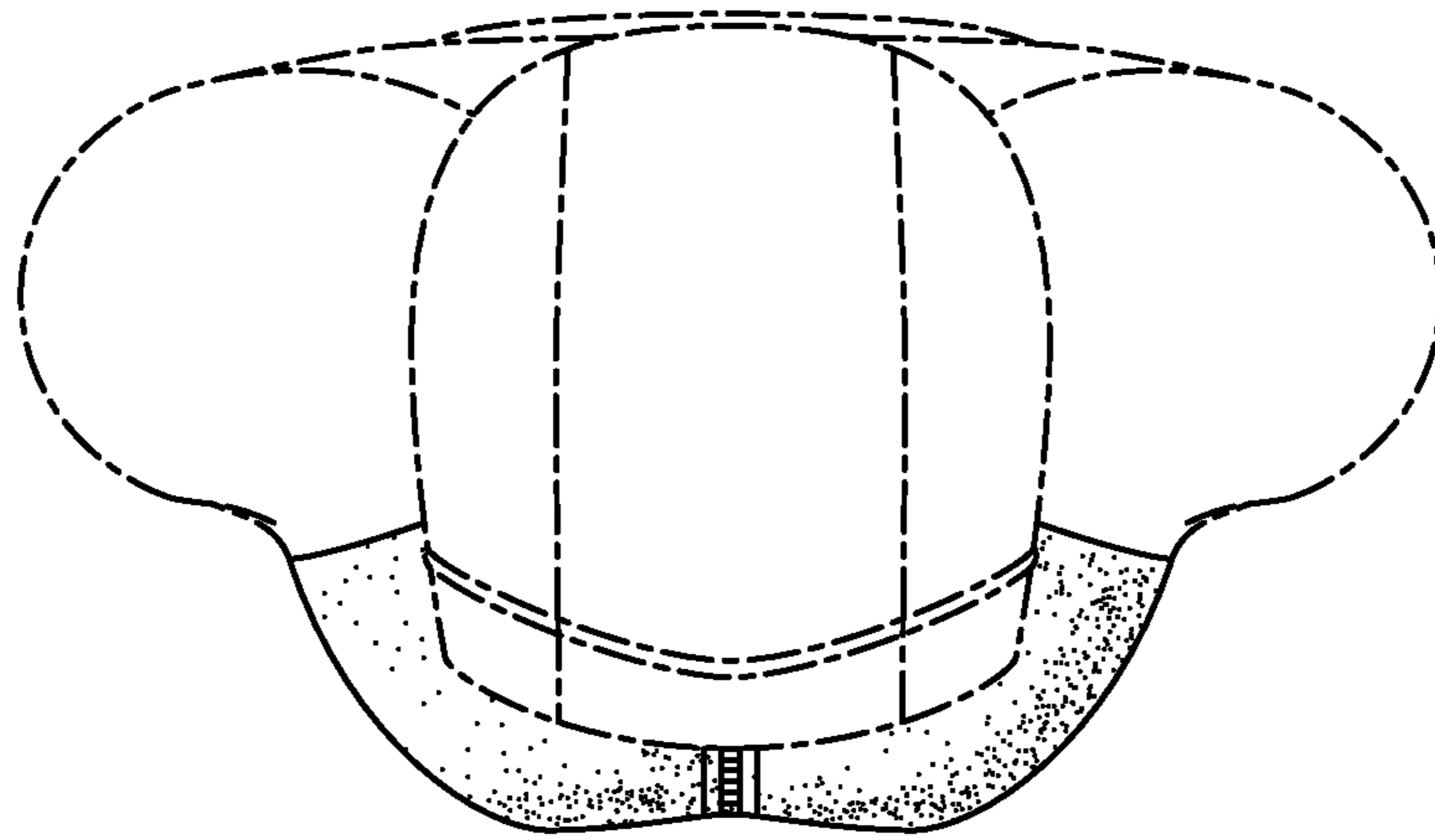

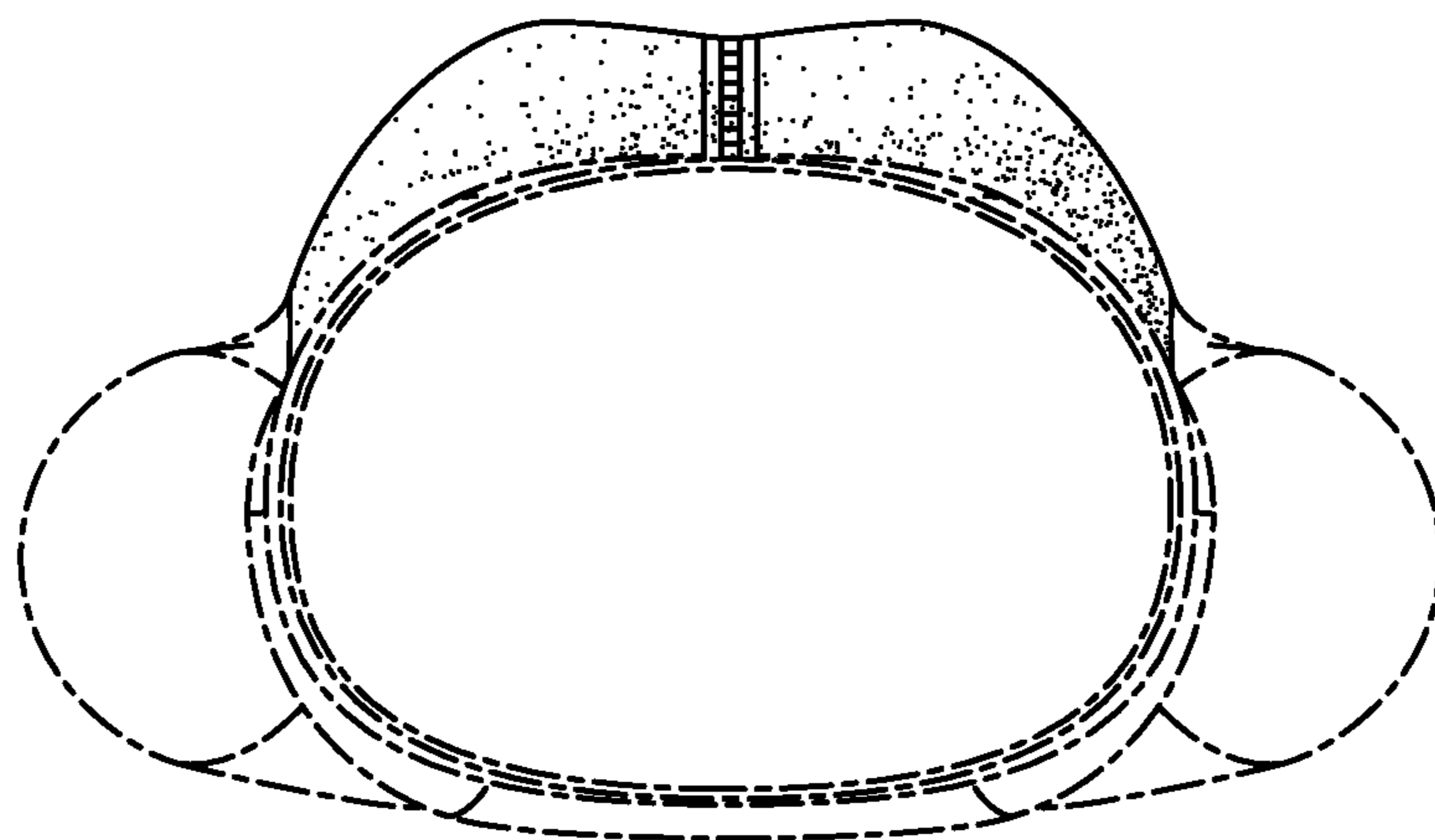
