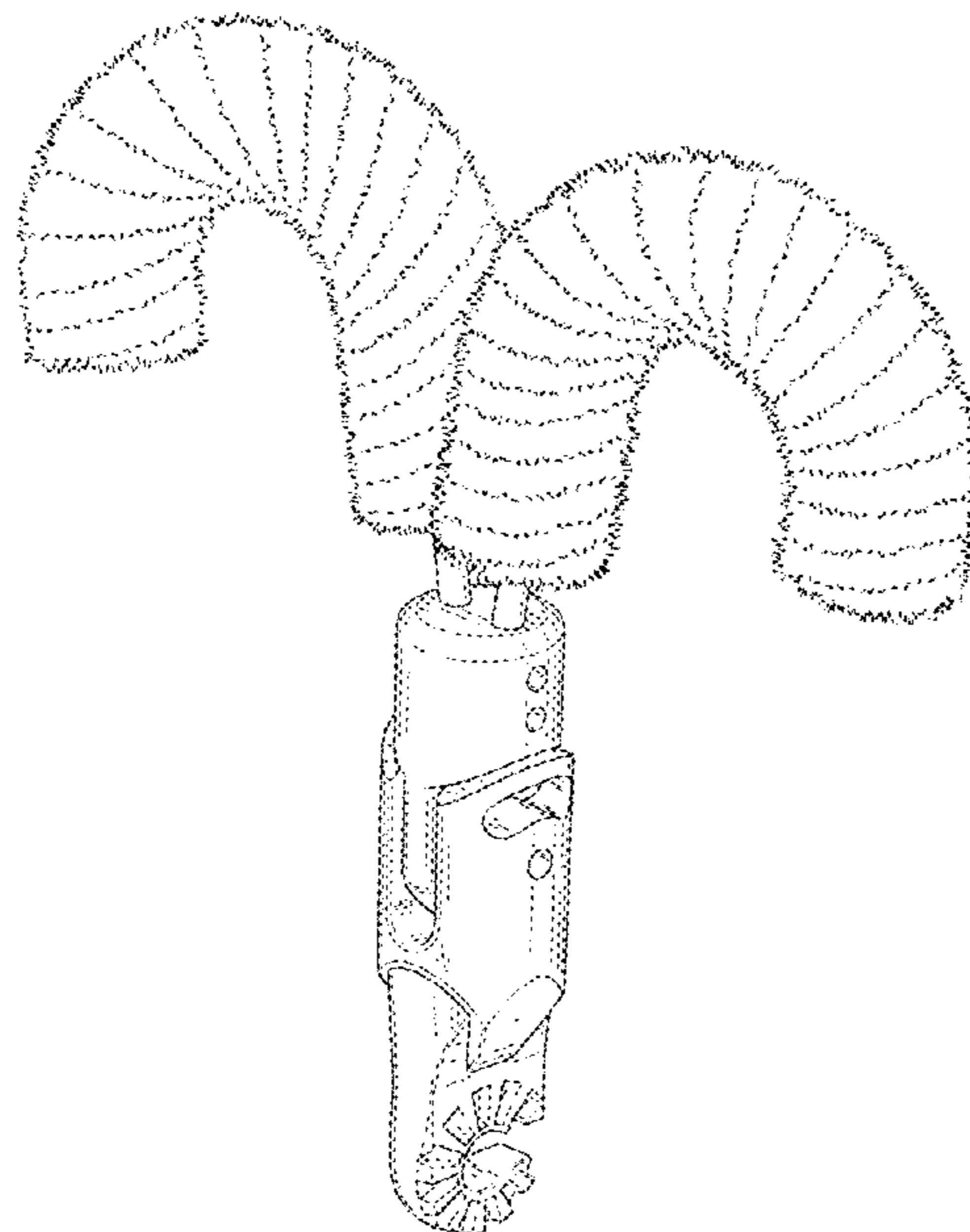
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a wire brush, showing my design;
FIG. 2 is a front elevational view of the wire brush of FIG. 1;
FIG. 3 is a rear elevational view of the wire brush of FIG. 1;
FIG. 4 is a right side elevational view of the wire brush of FIG. 1;

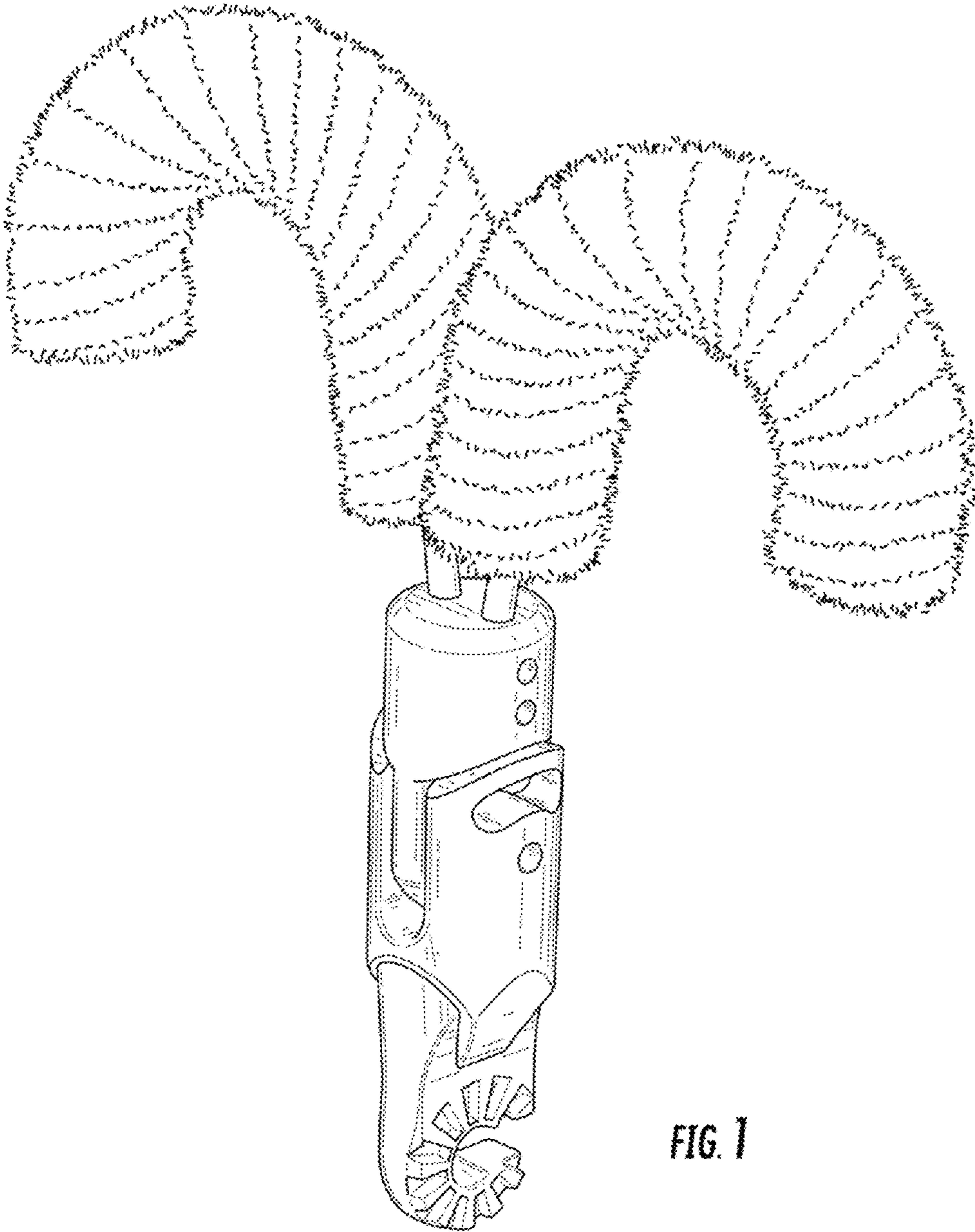

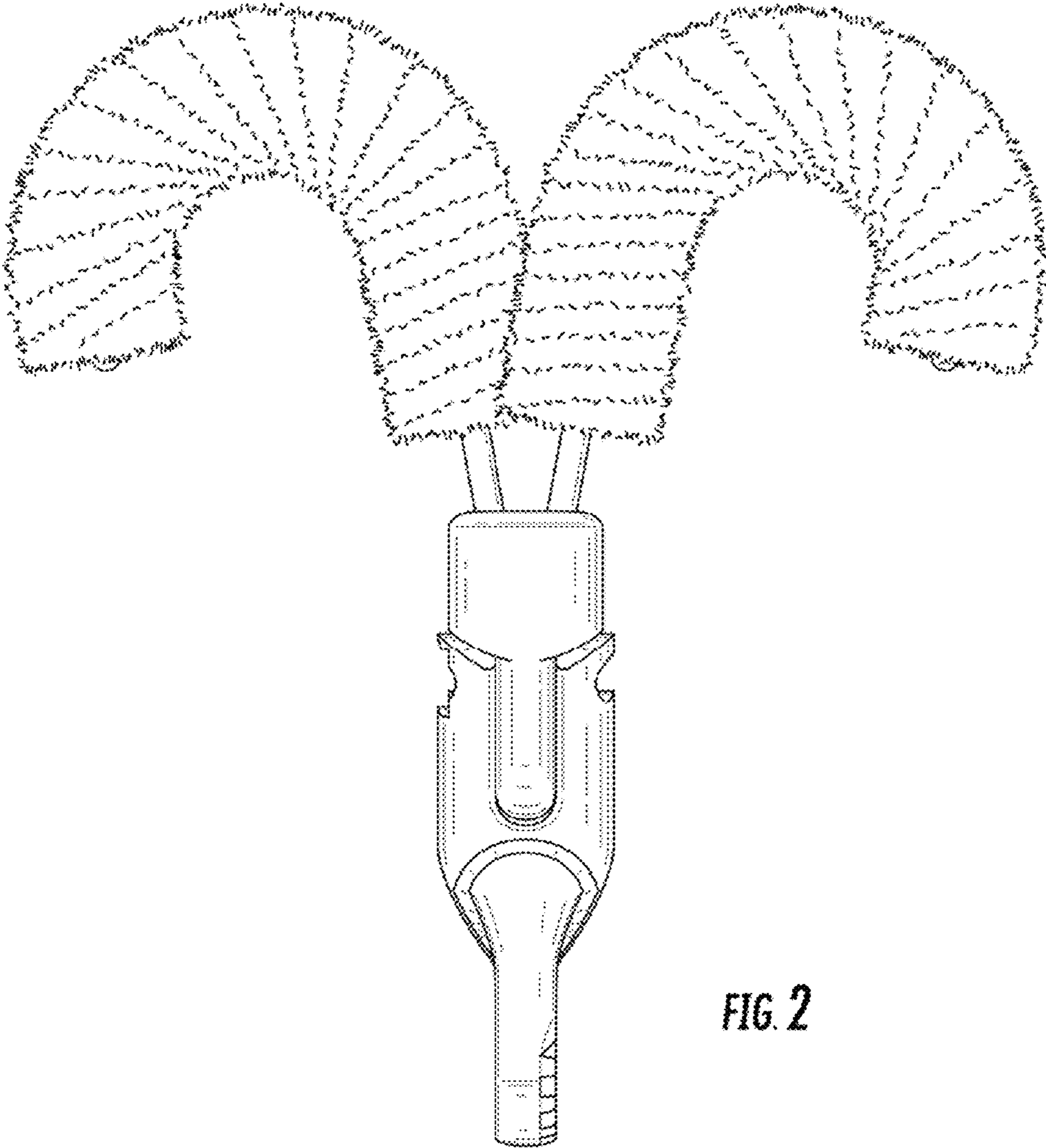

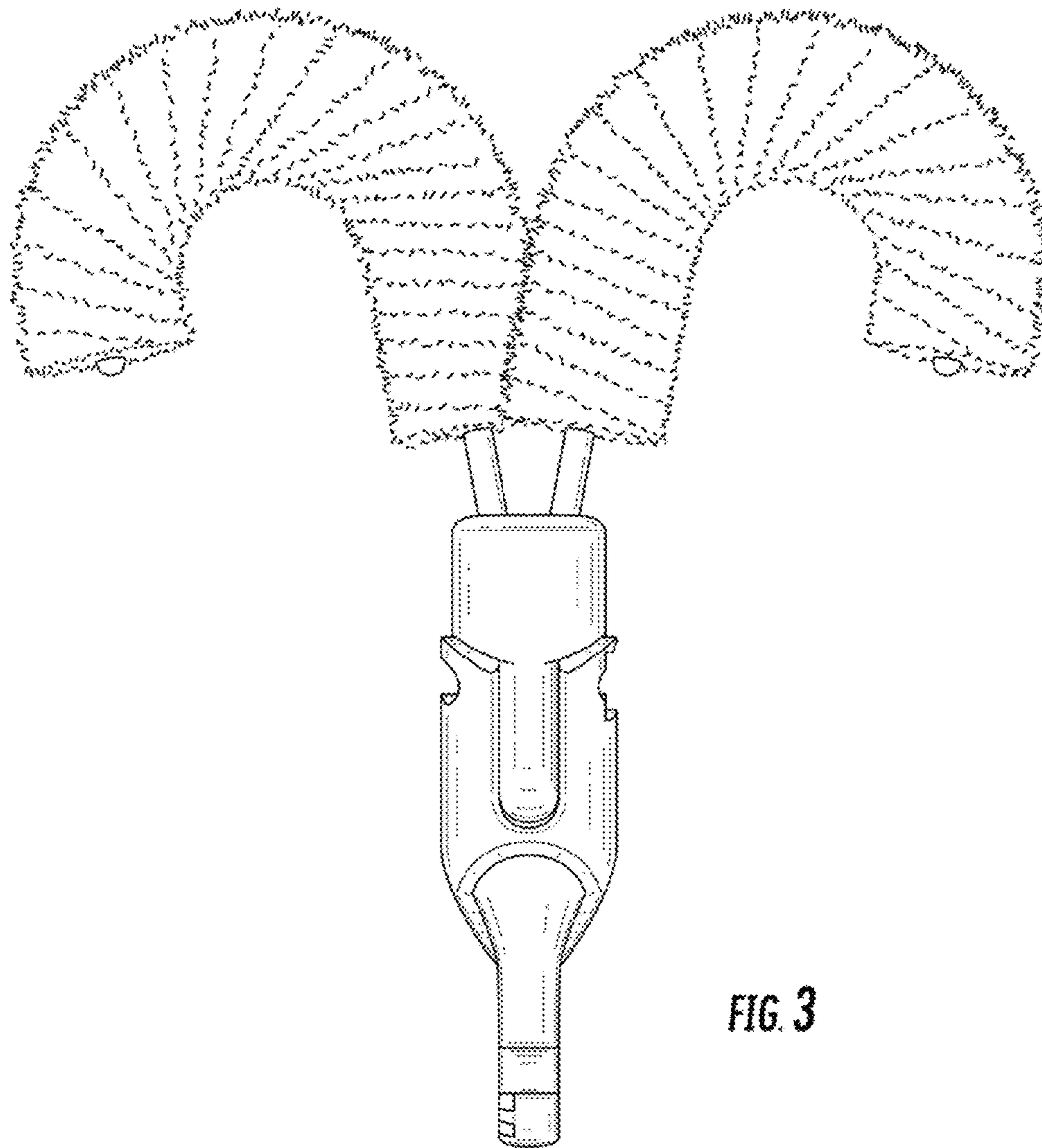

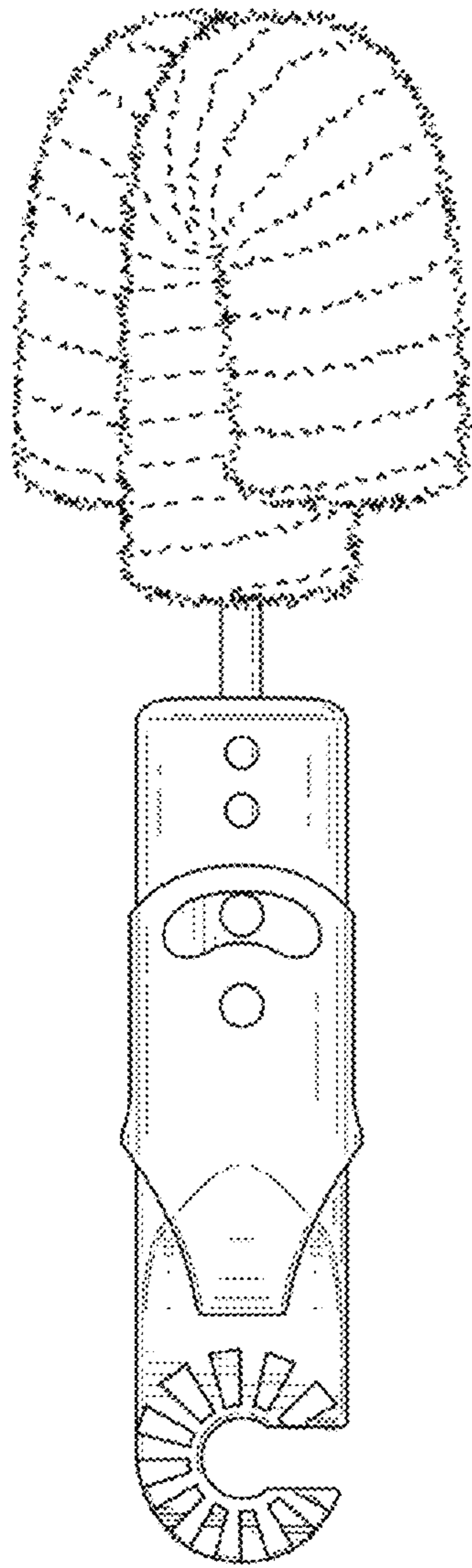

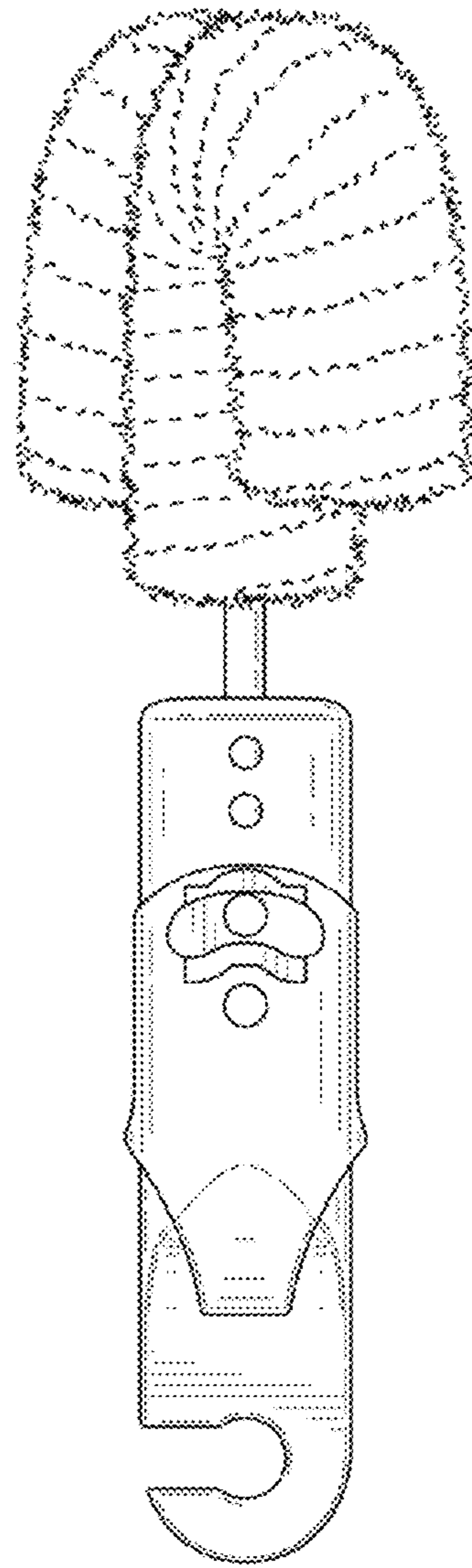

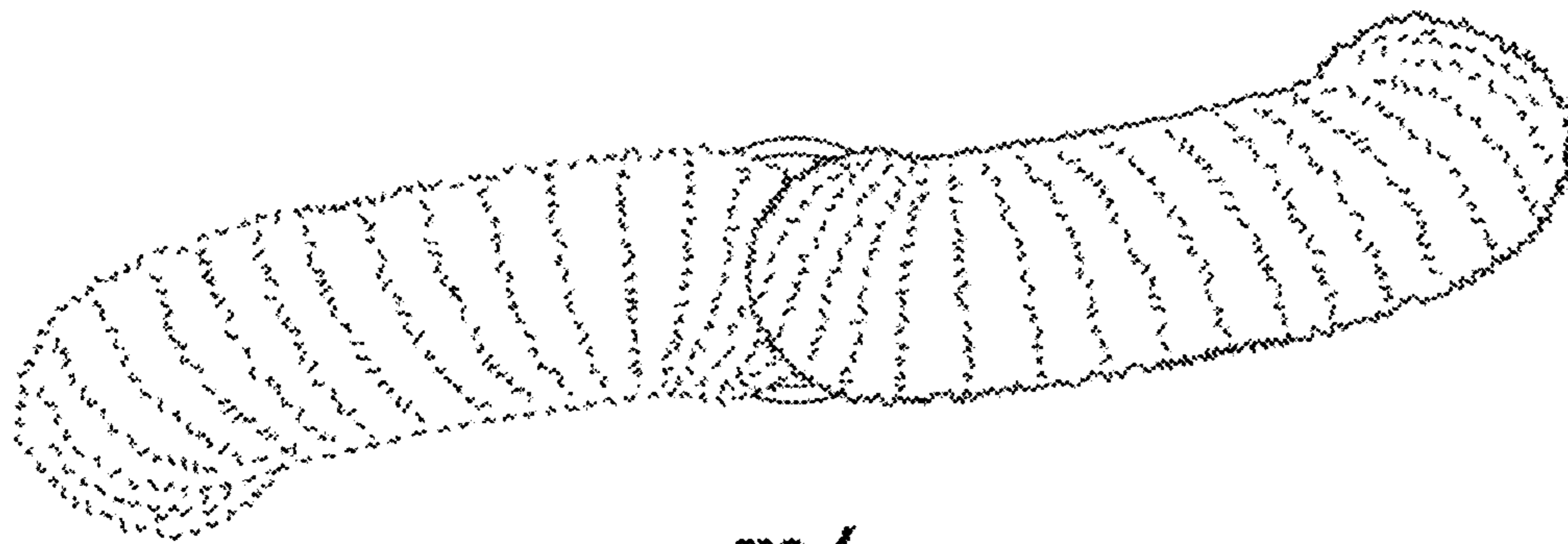

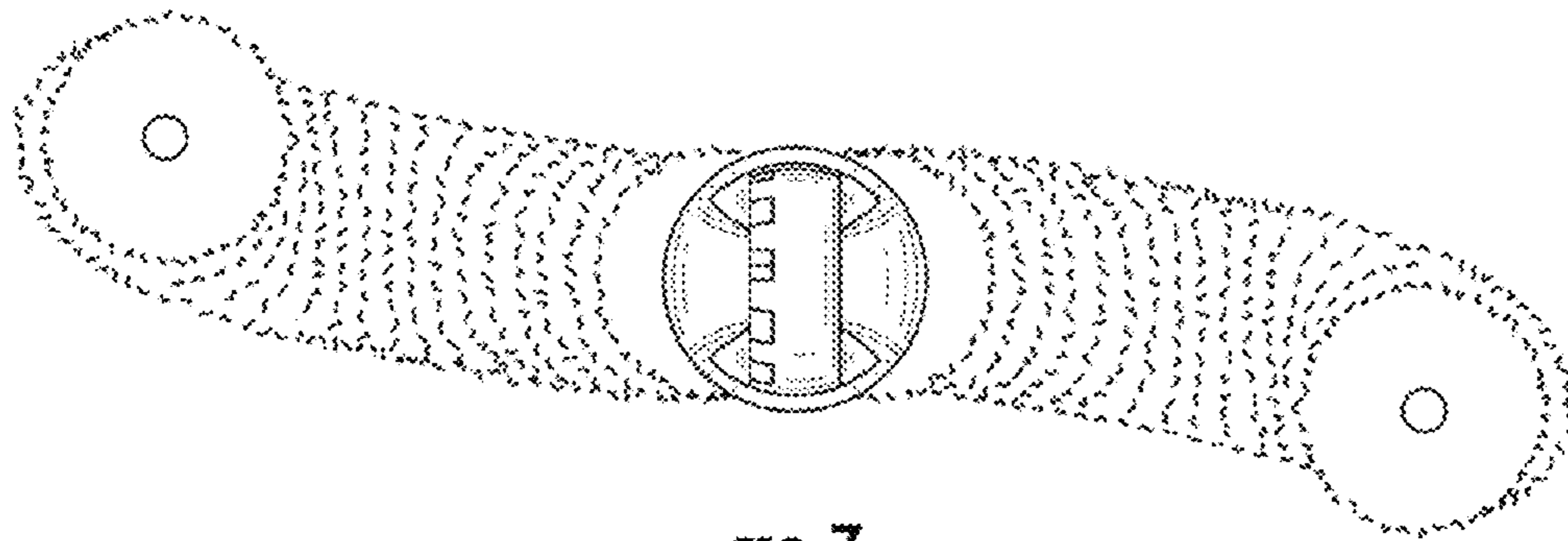
