DESCRIPTION

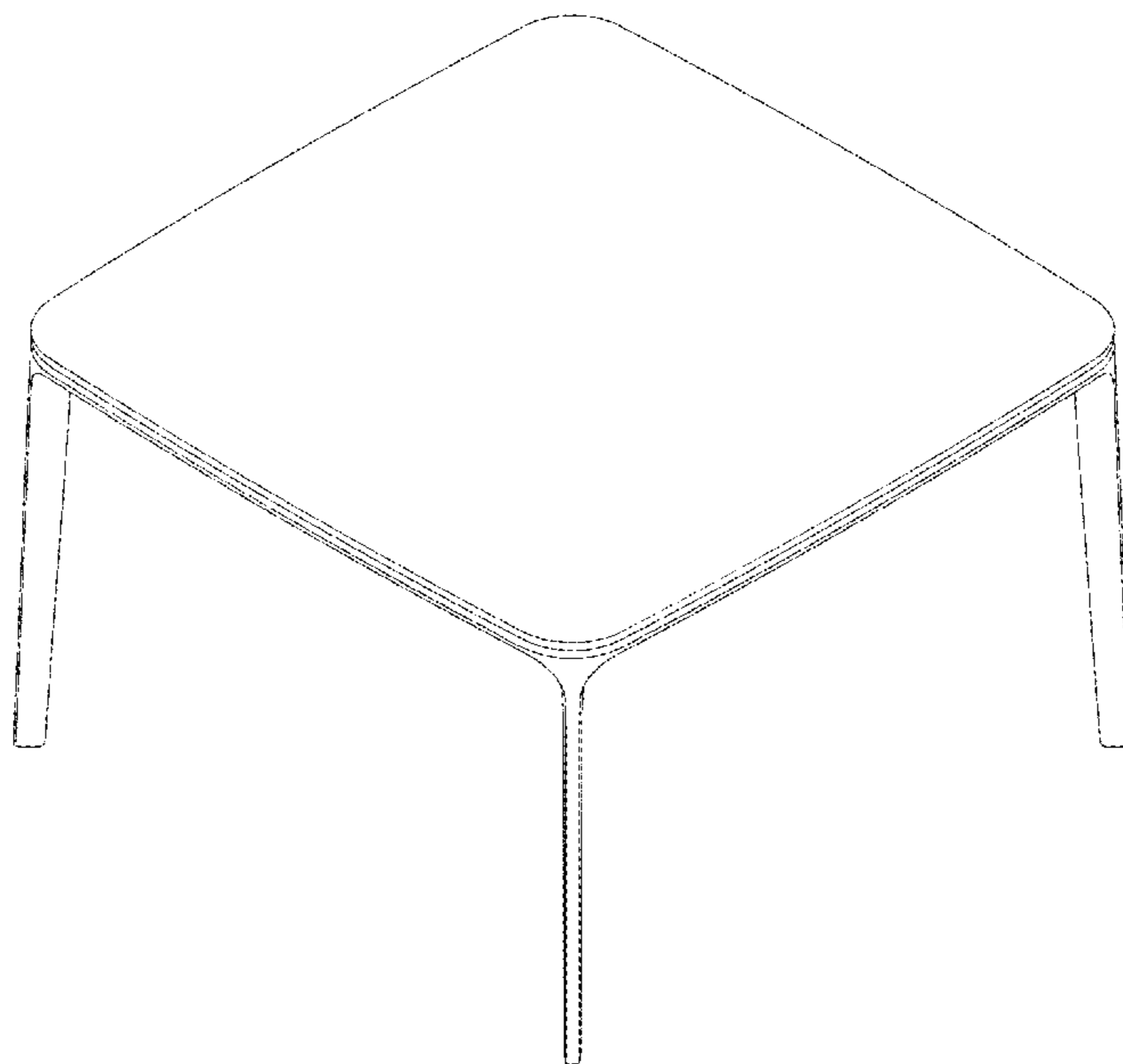
FIG. 1 is a perspective view of the table of the present design;

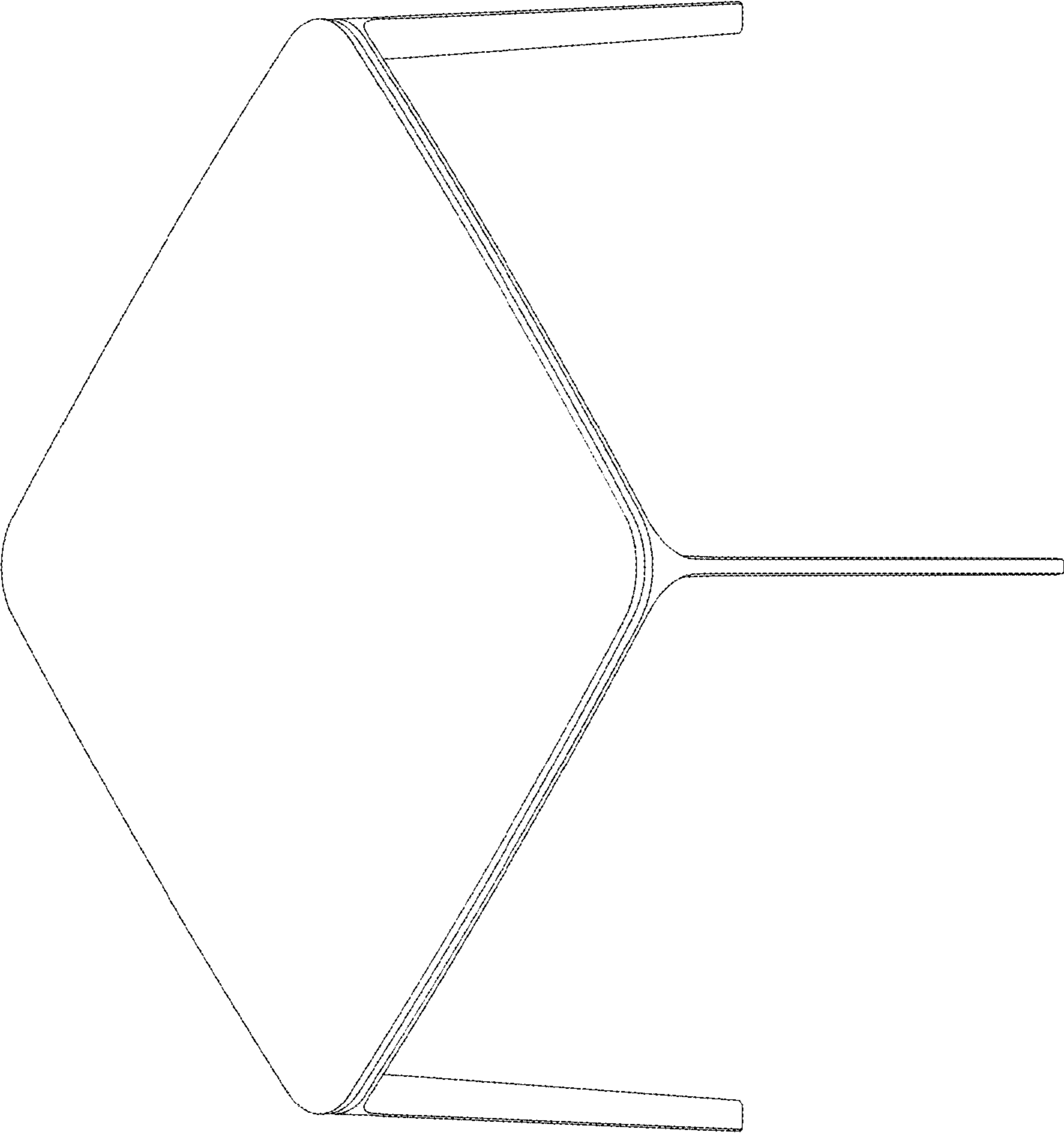

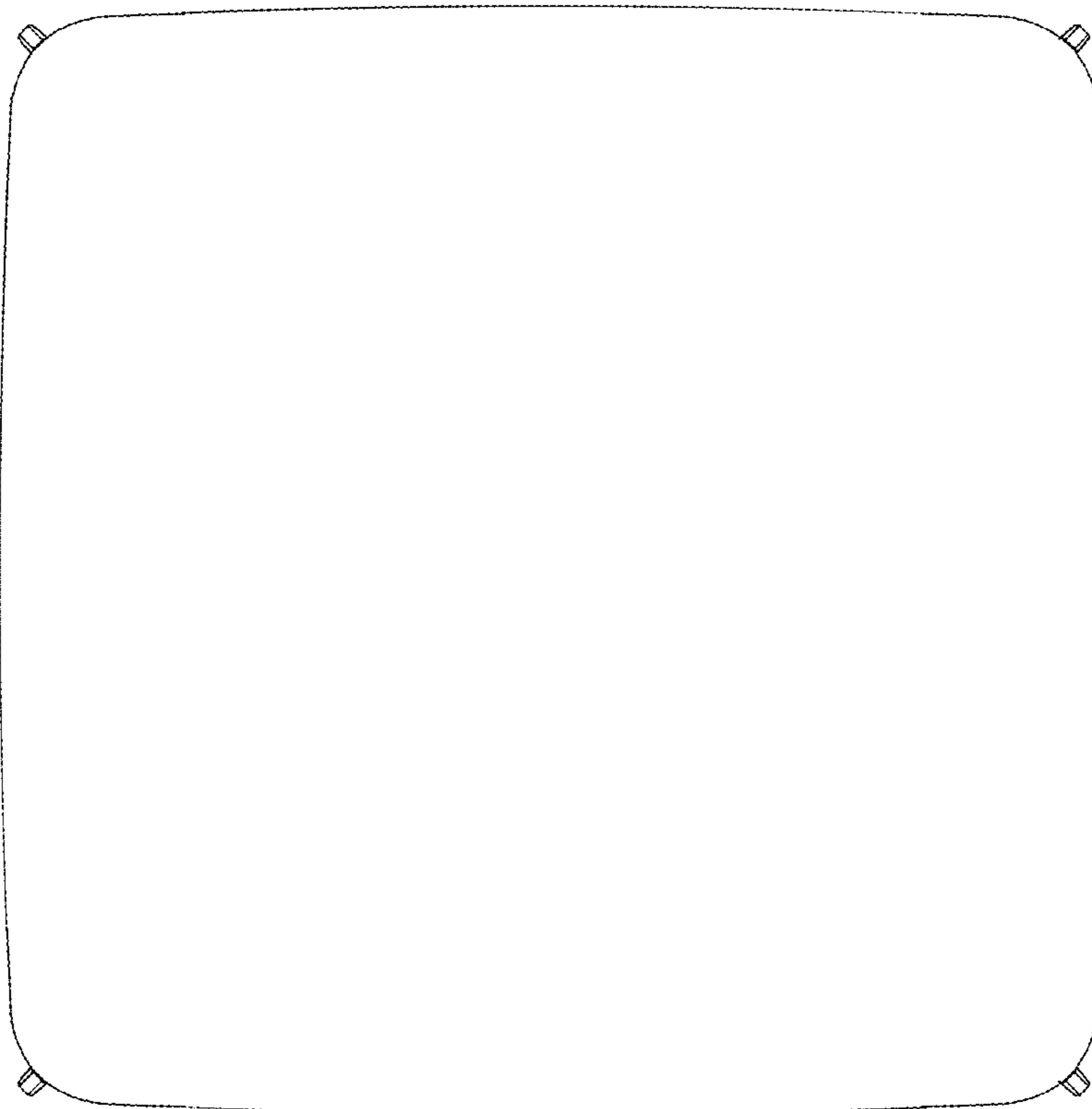
