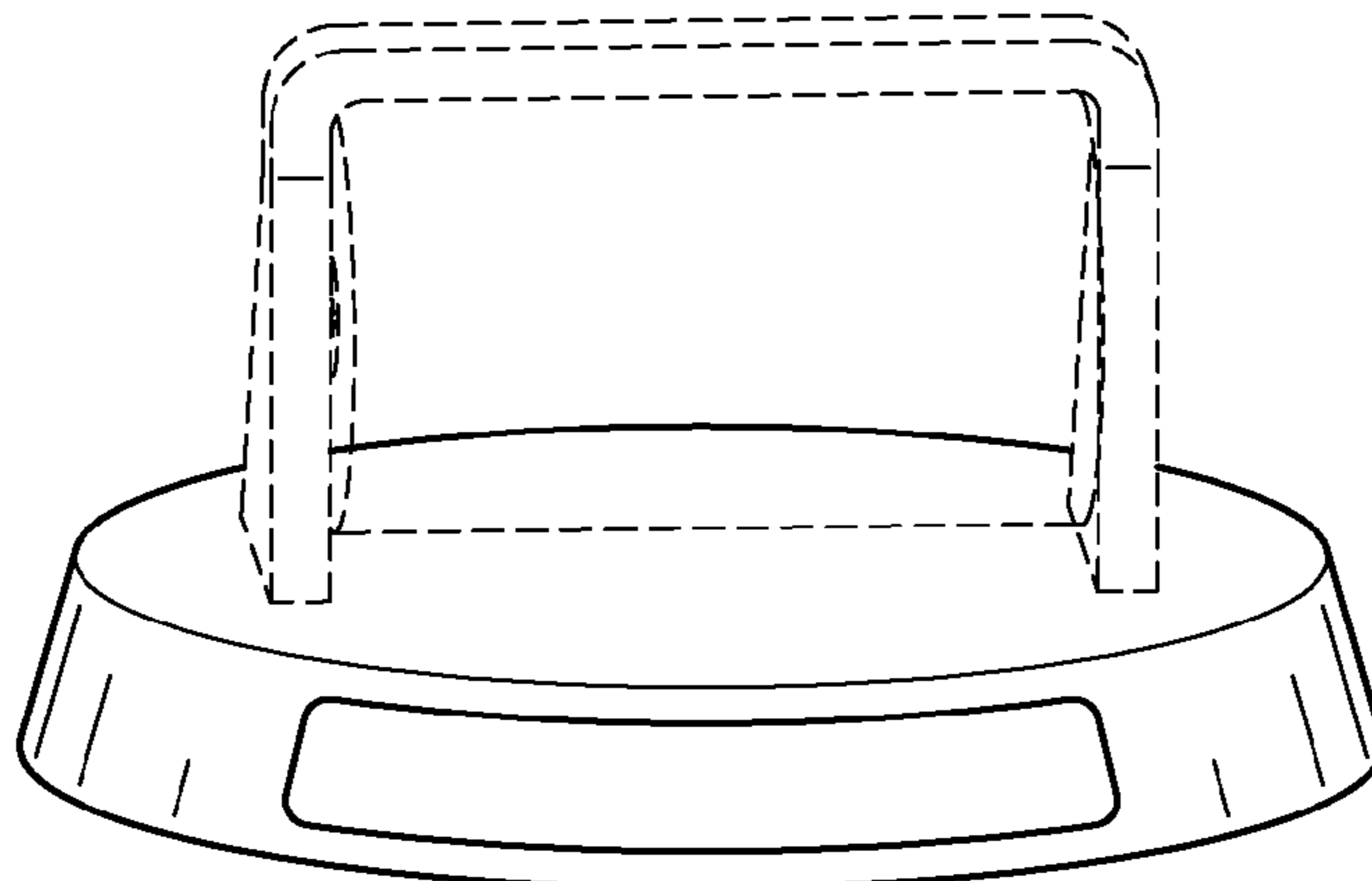
(57) **CLAIM**

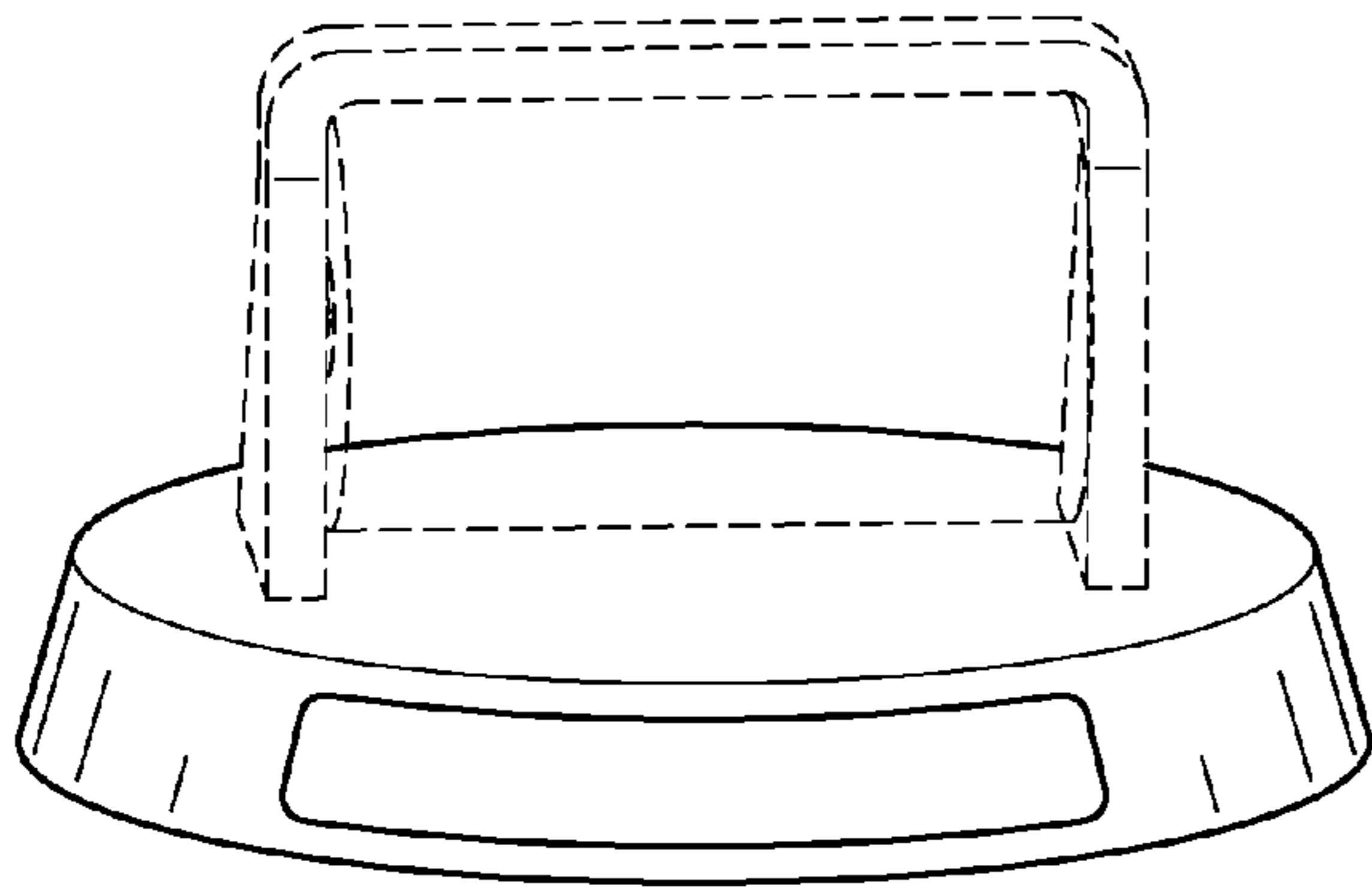
We claim, the ornamental design for a portable caddy, as shown and described.

**DESCRIPTION**

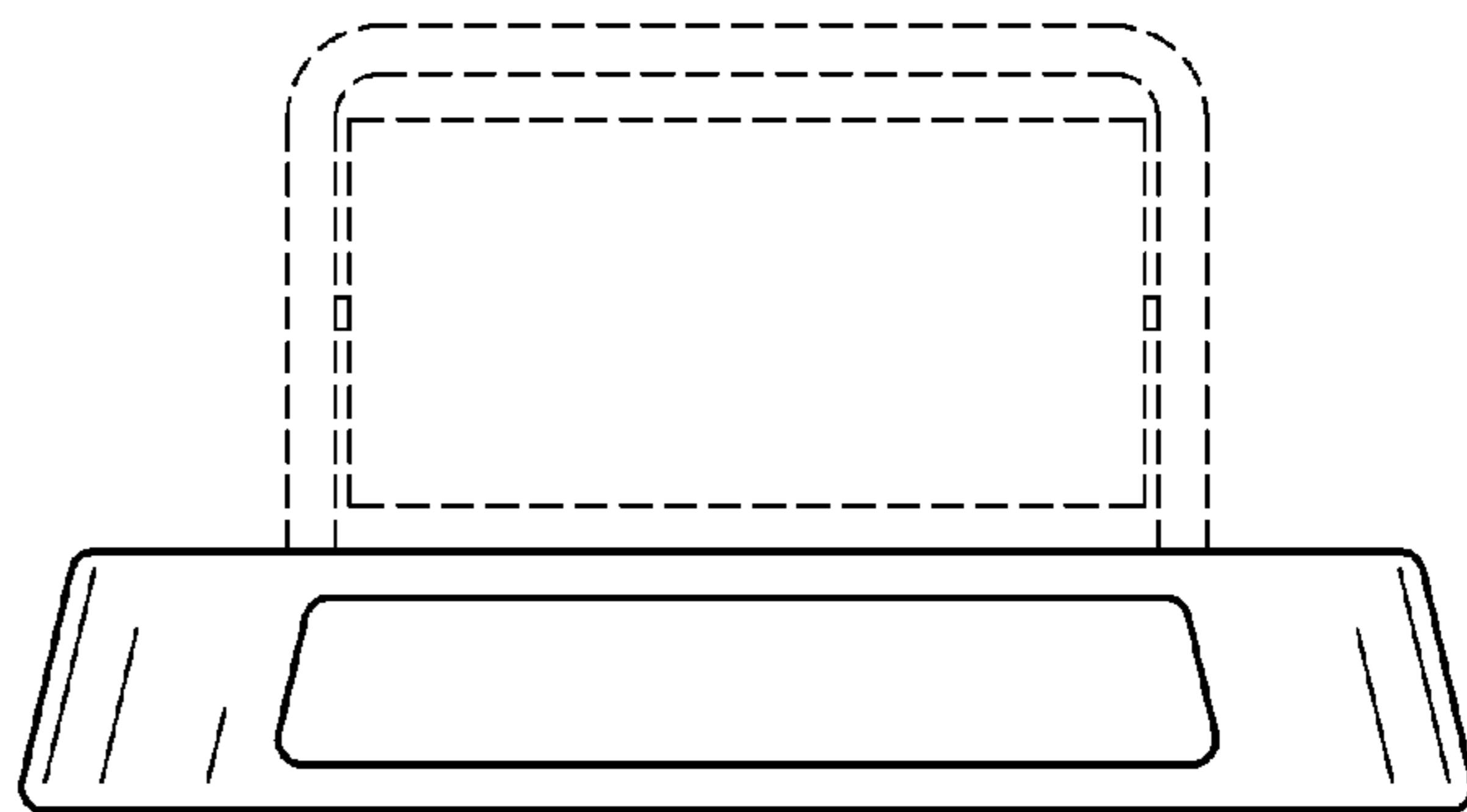
FIG. 1 is a perspective view of a portable caddy showing our new design;

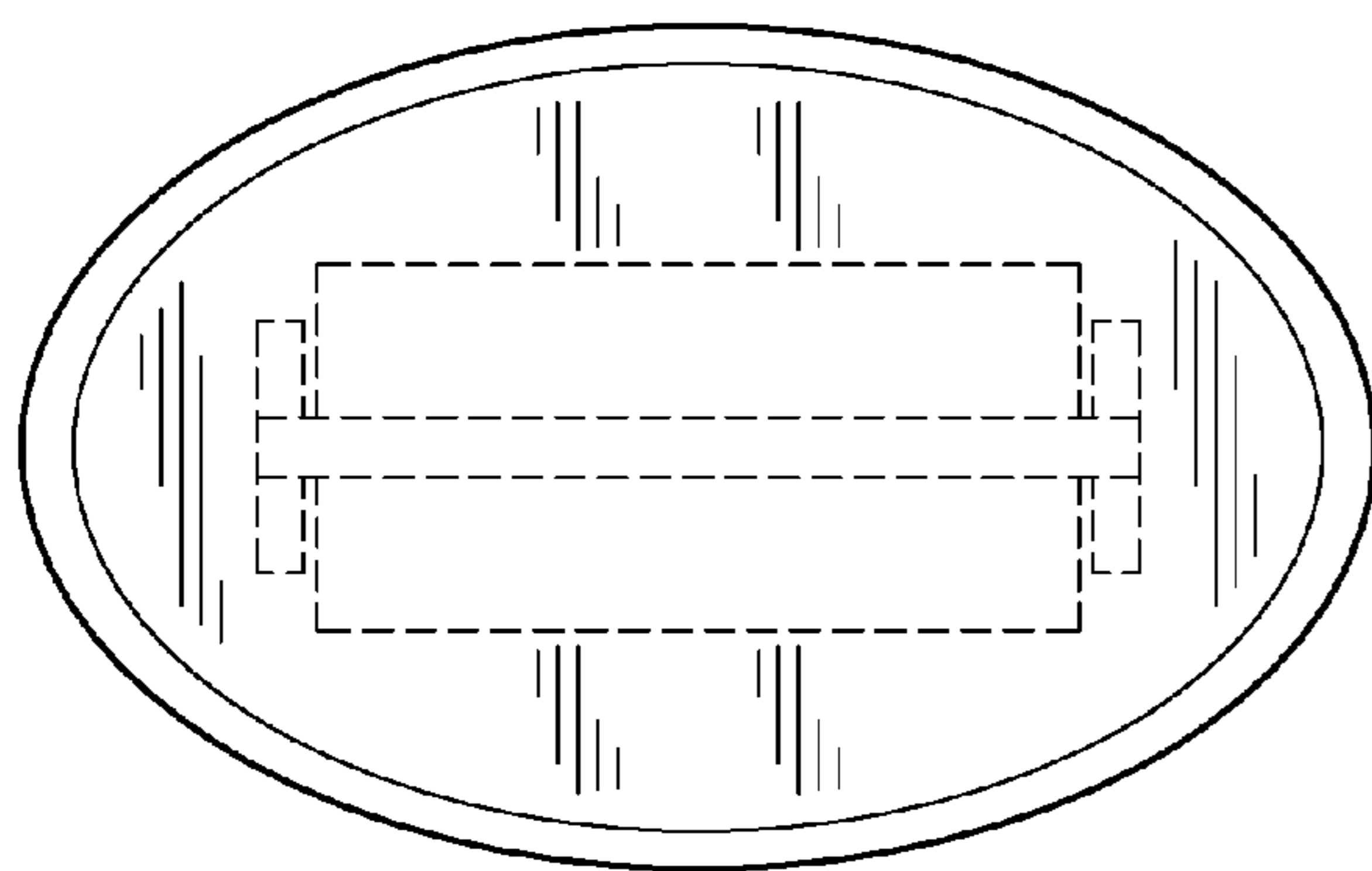




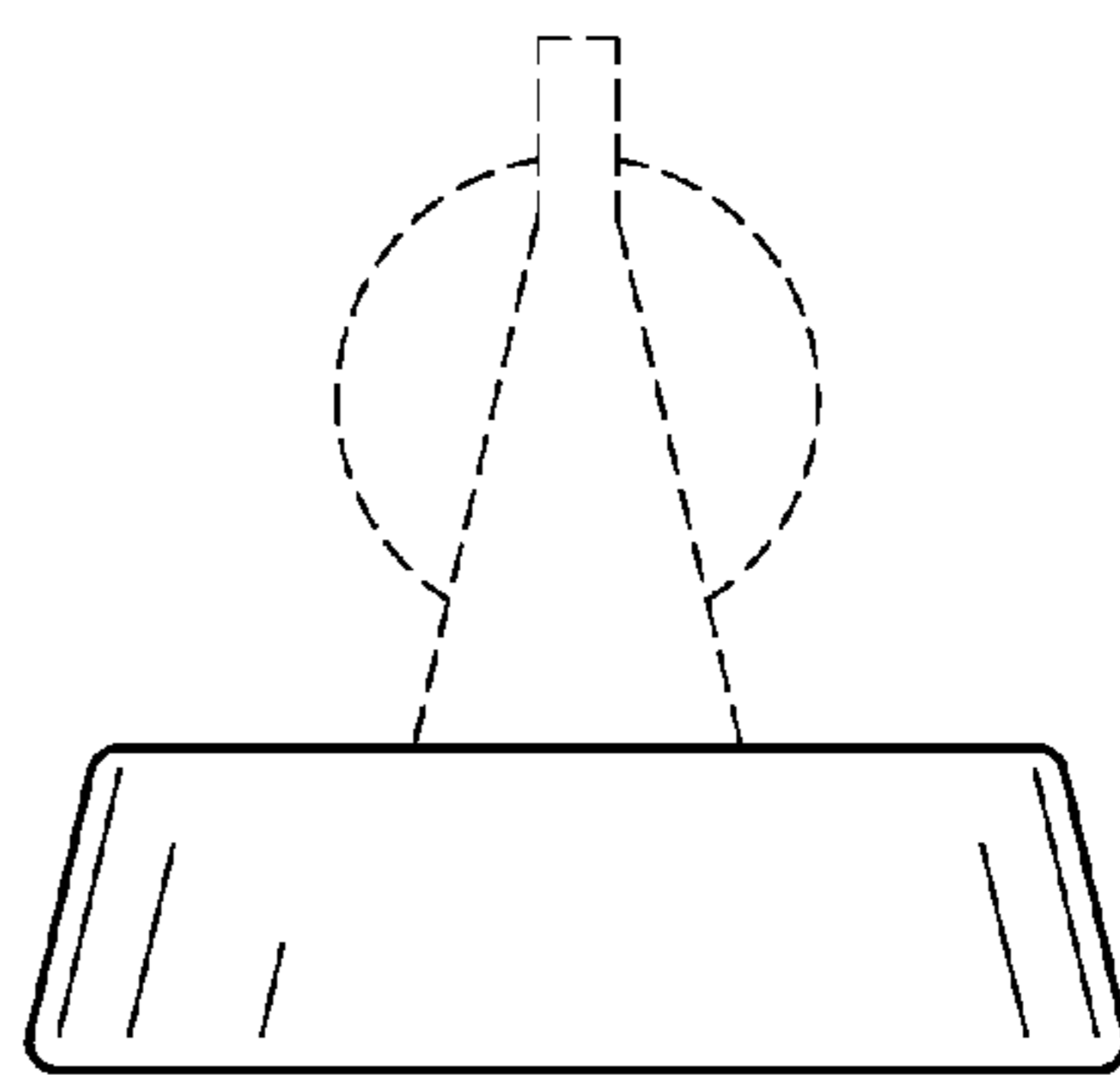
