DESCRIPTION

FIG. 11 is a front elevation view of the tool of FIG. 8;

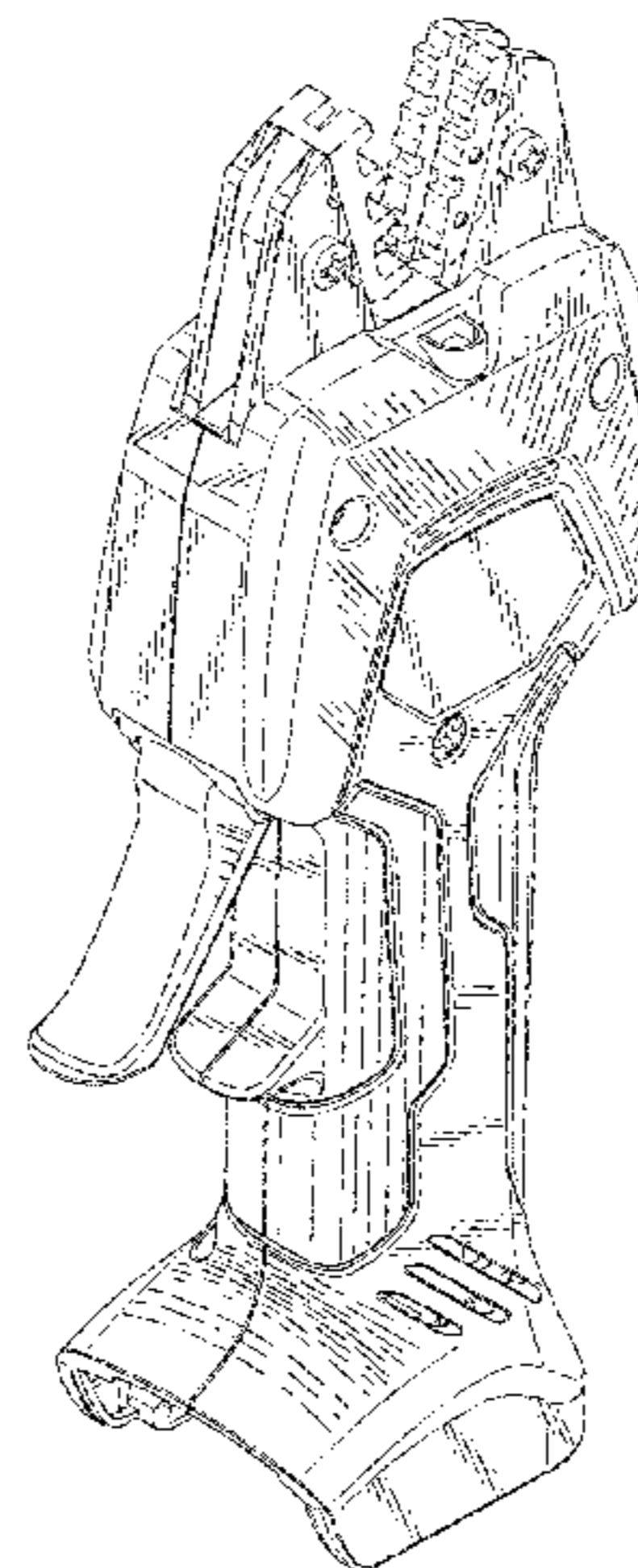
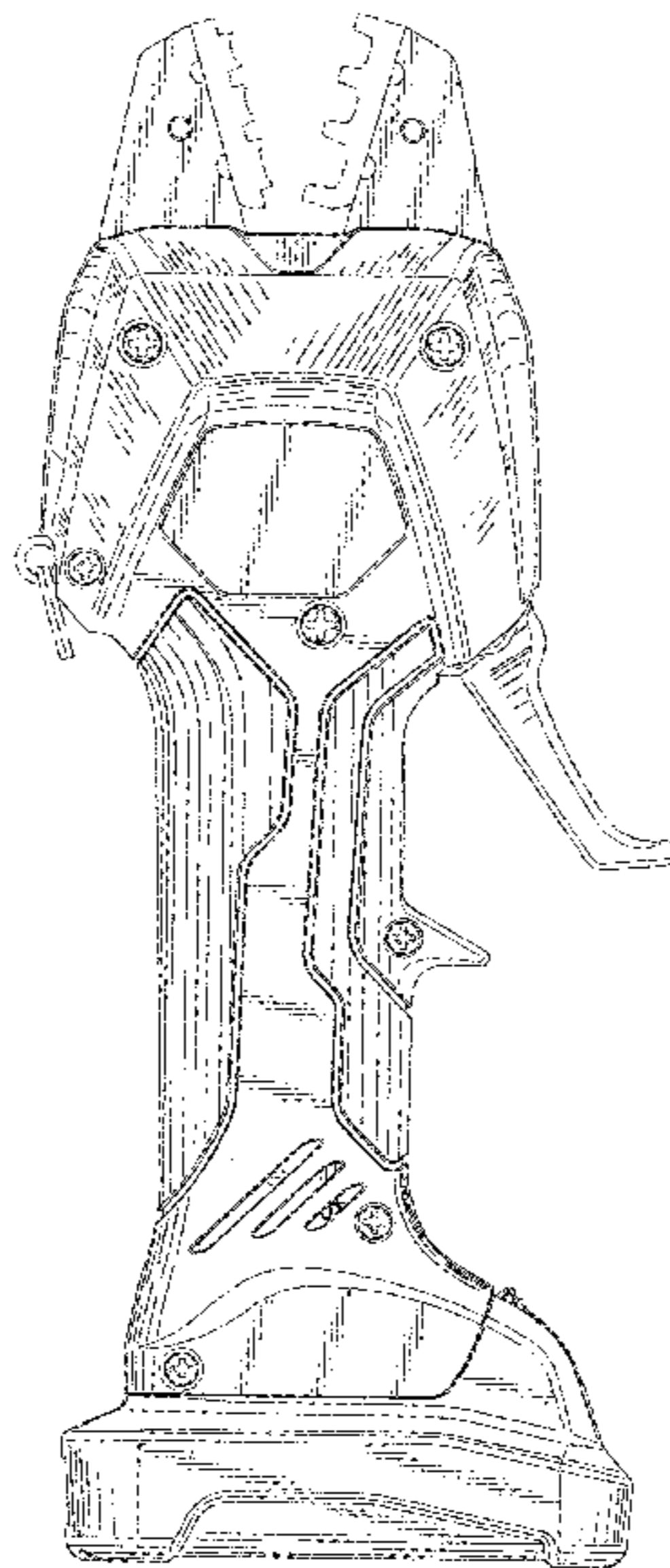
FIG. 12 is a top plan view of the tool of FIG. 8;

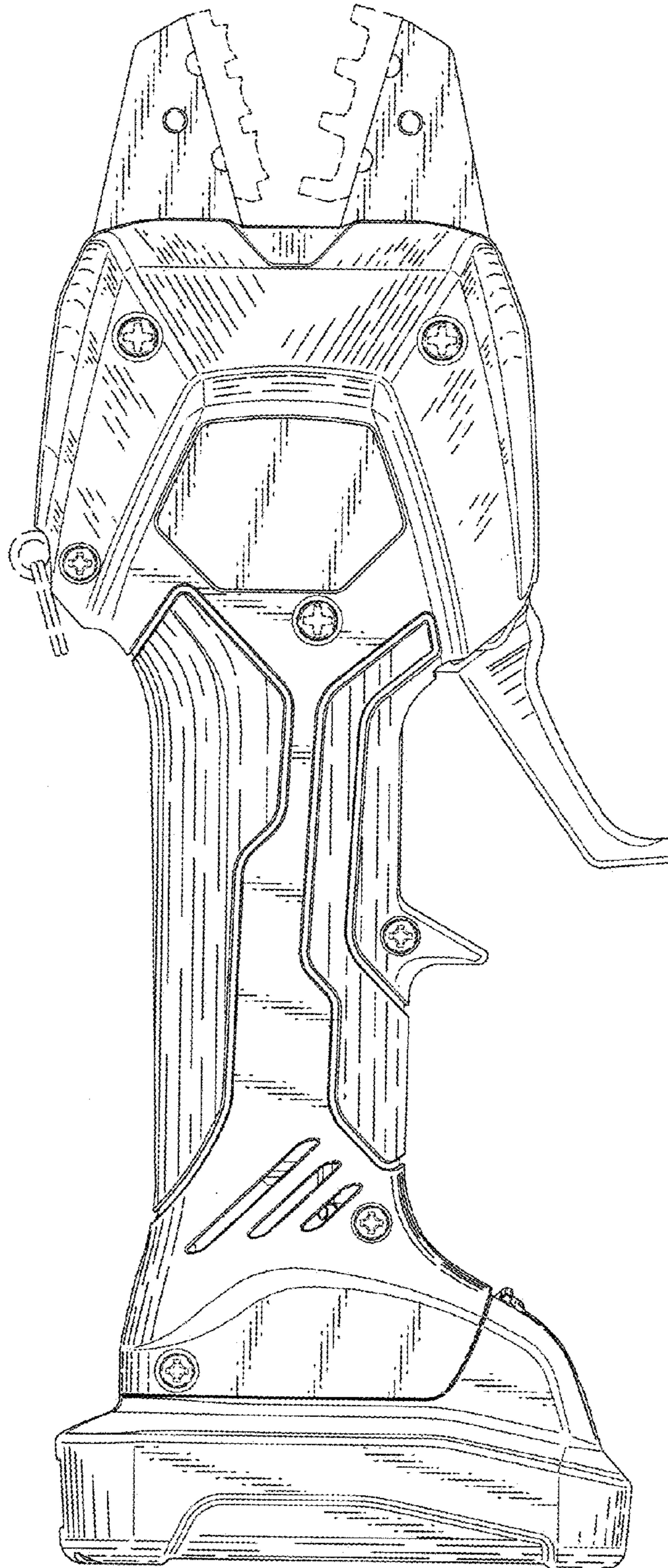

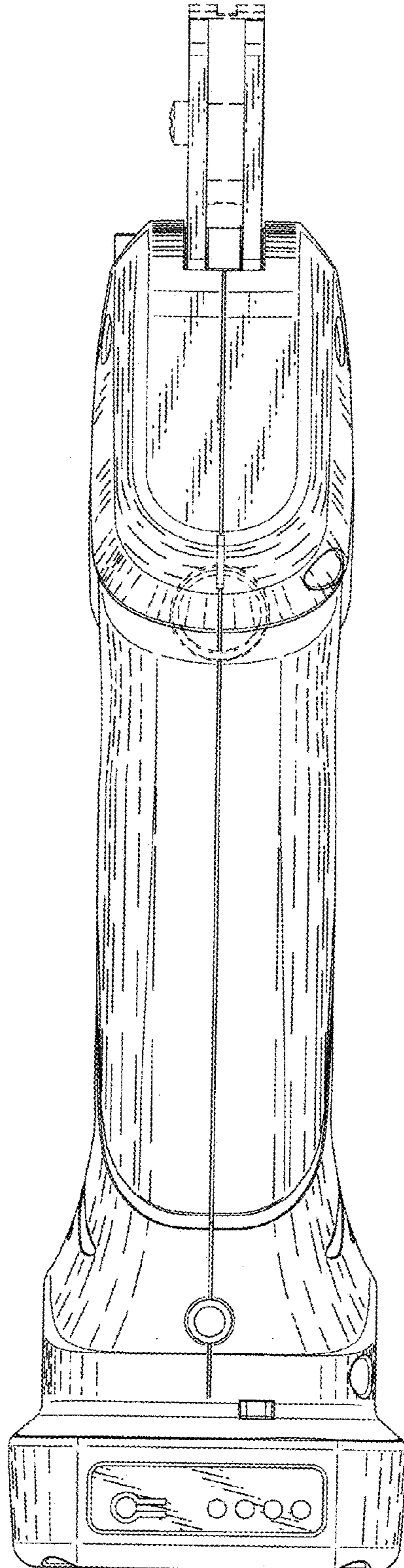

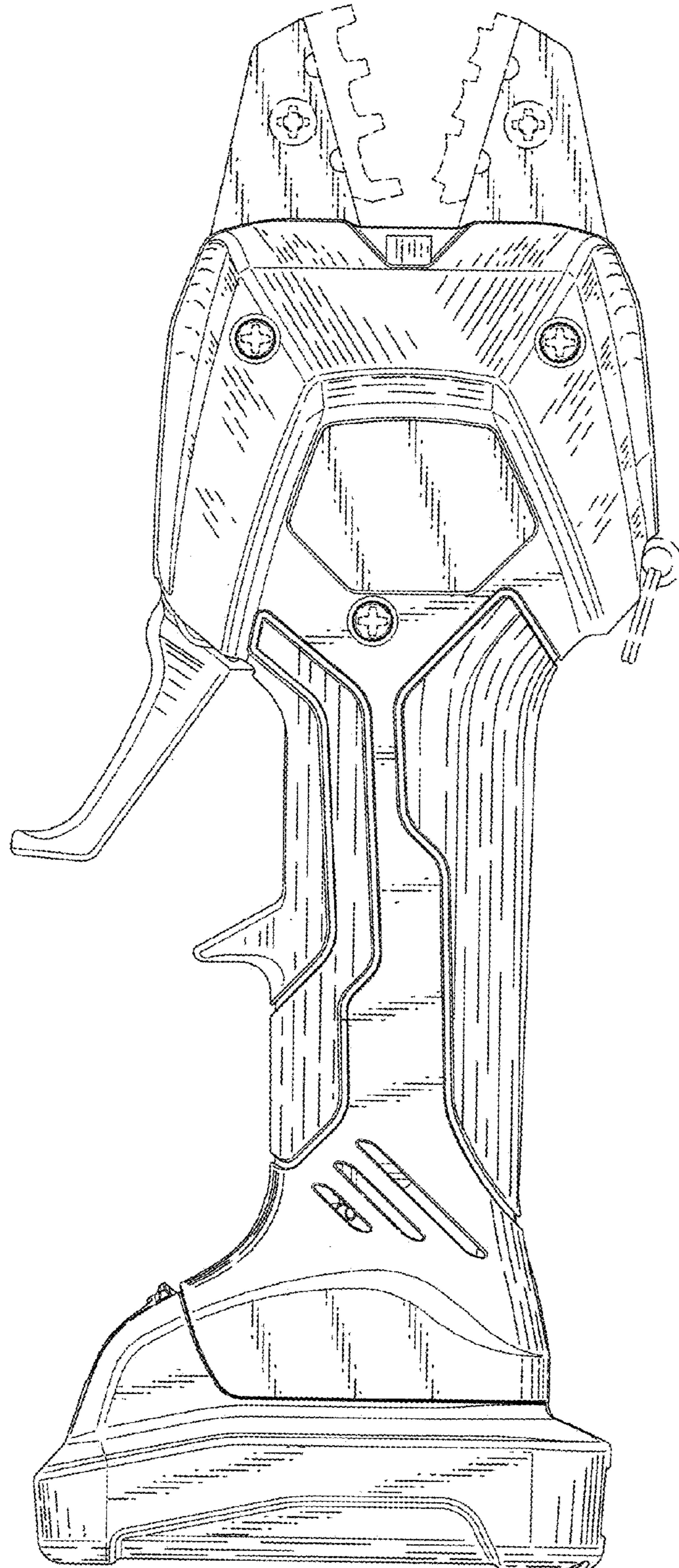

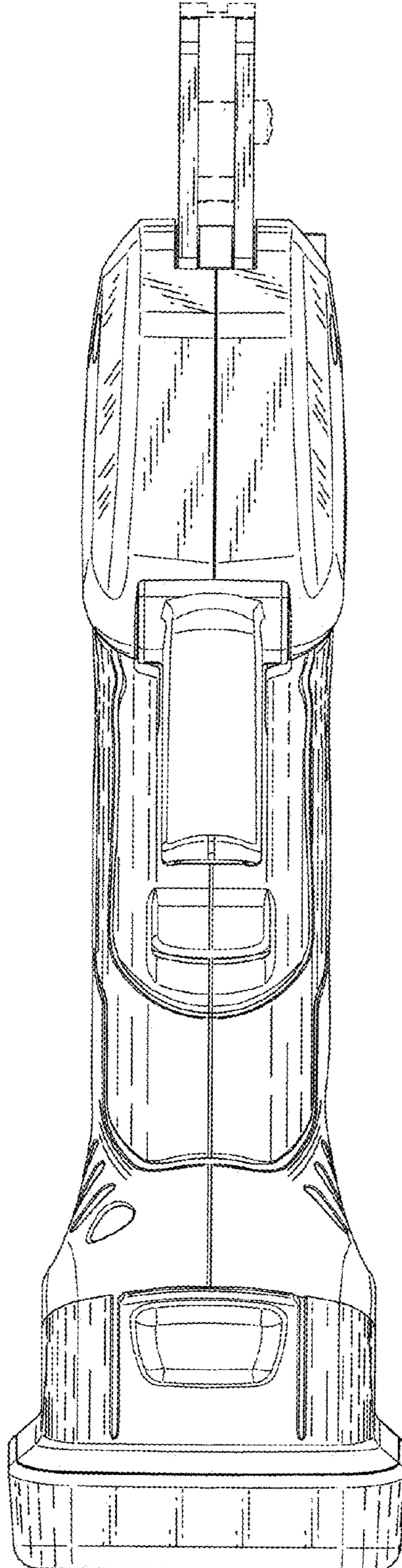

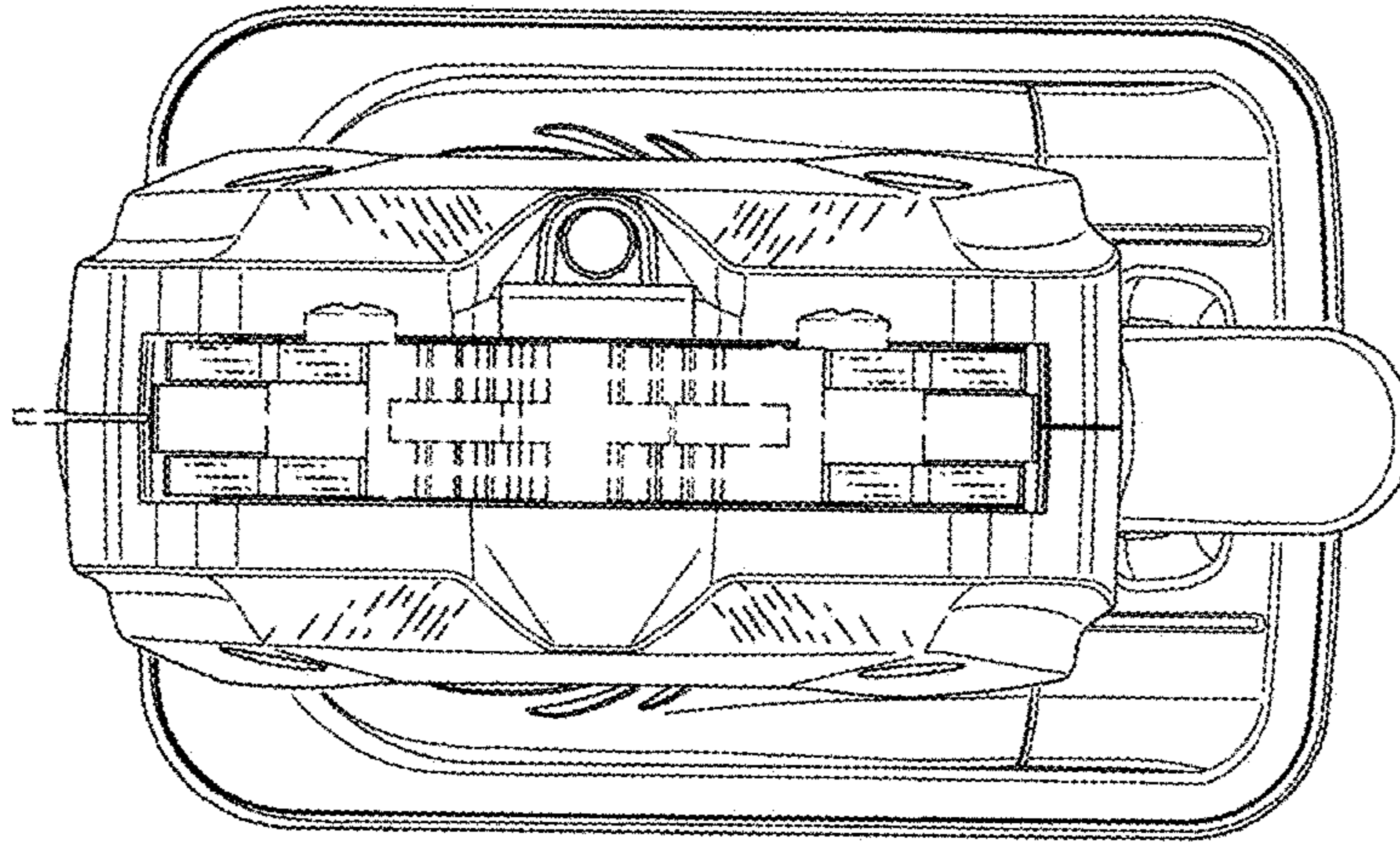

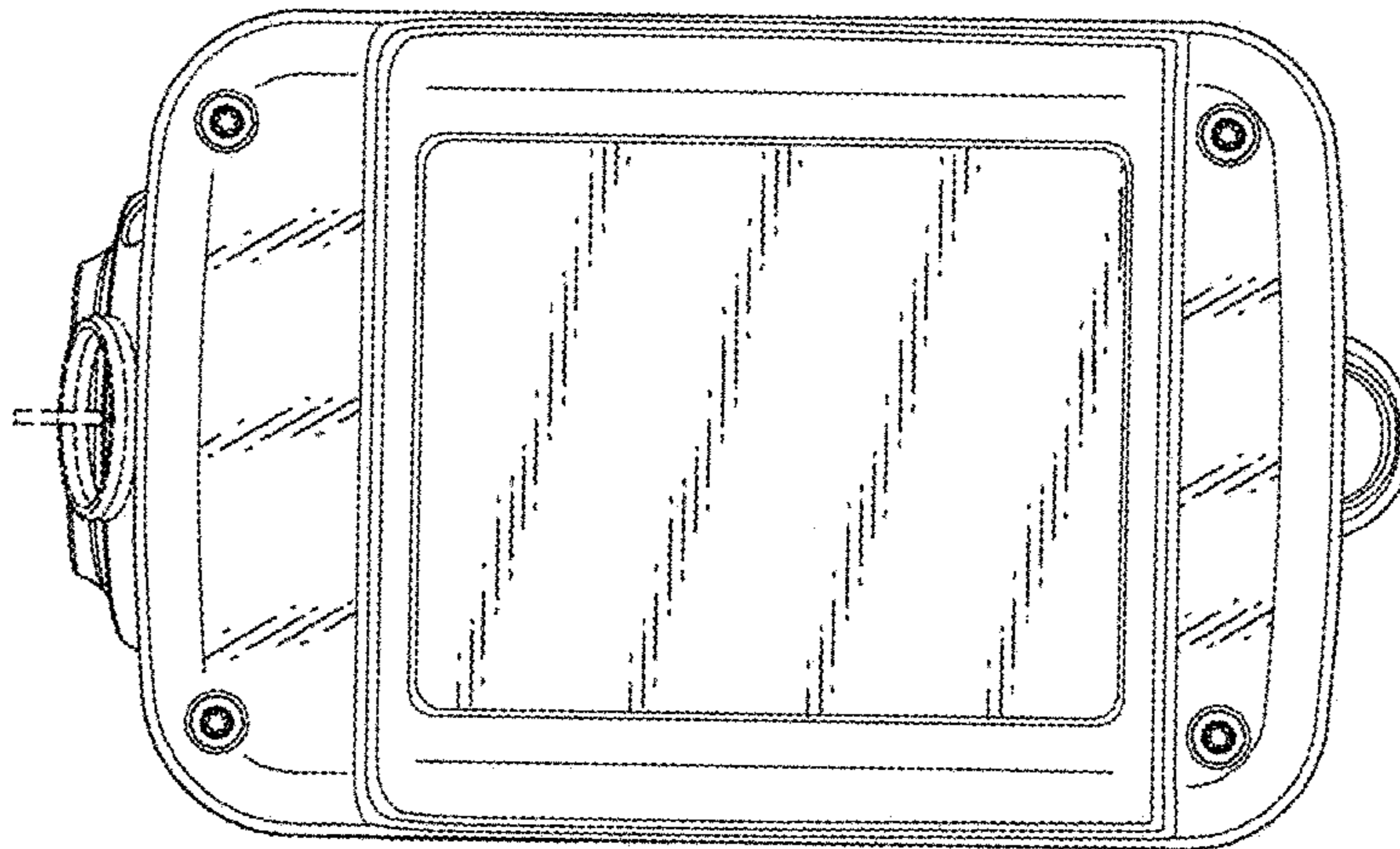

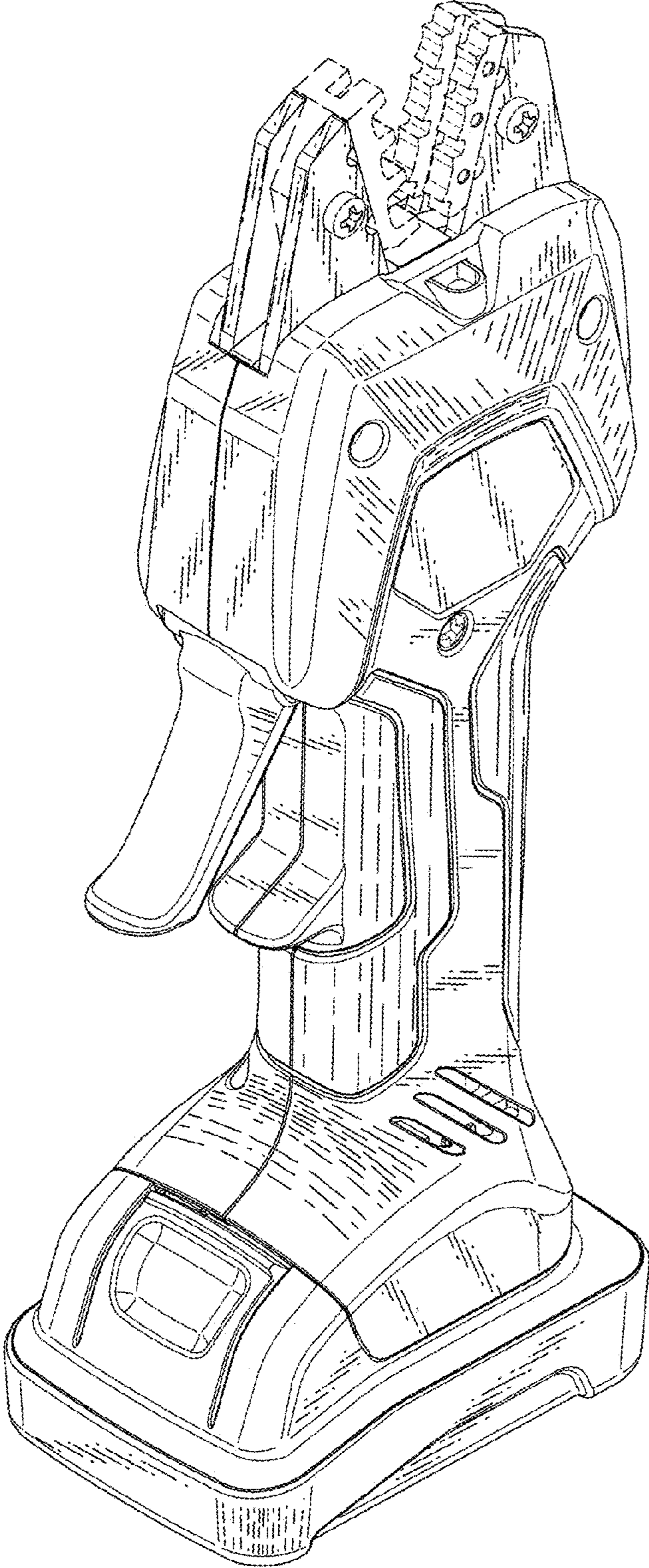

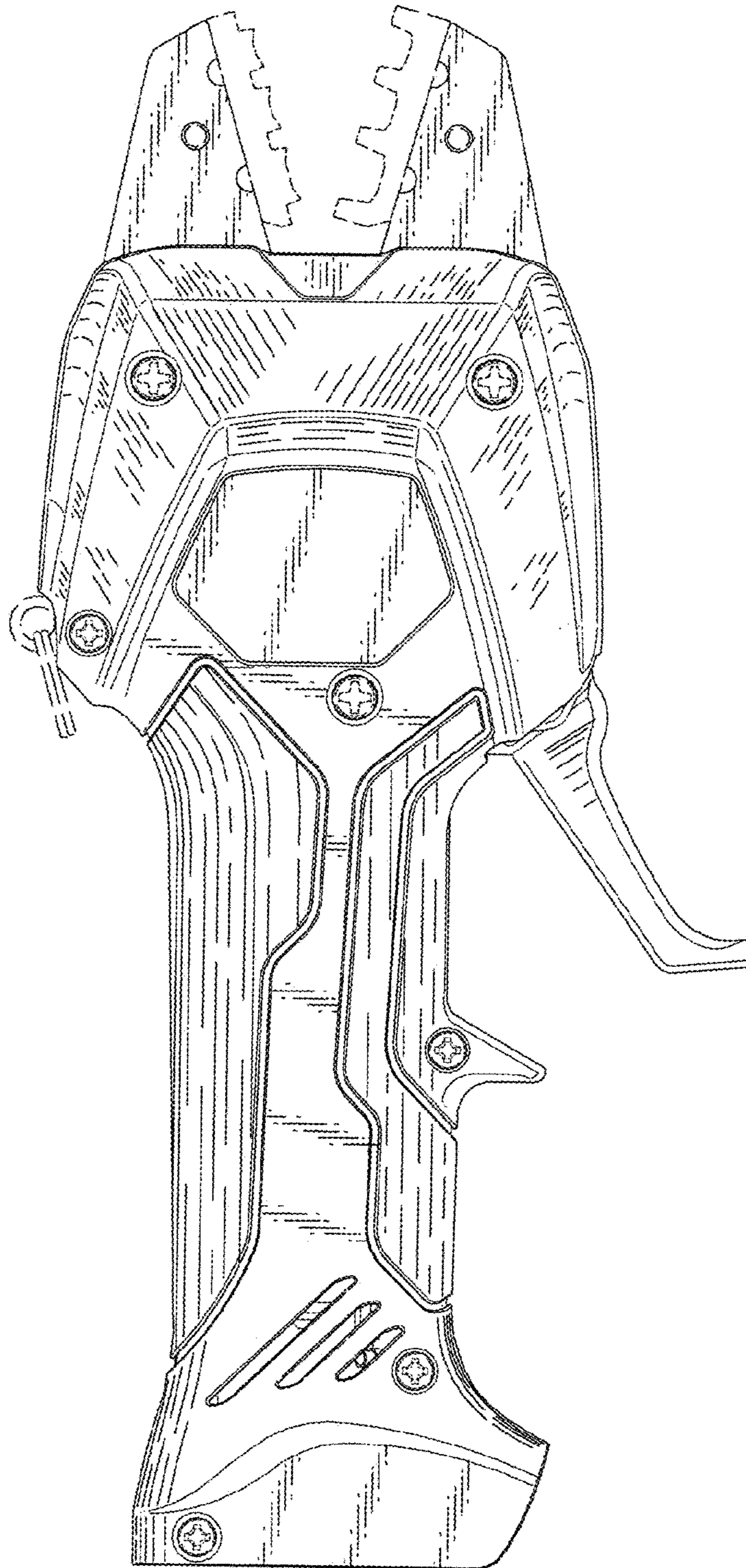

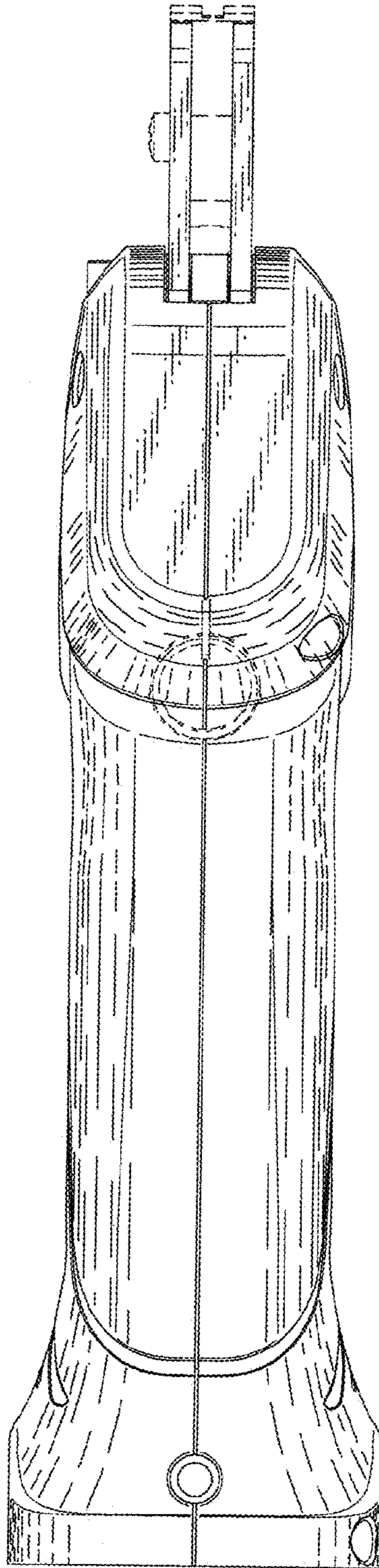

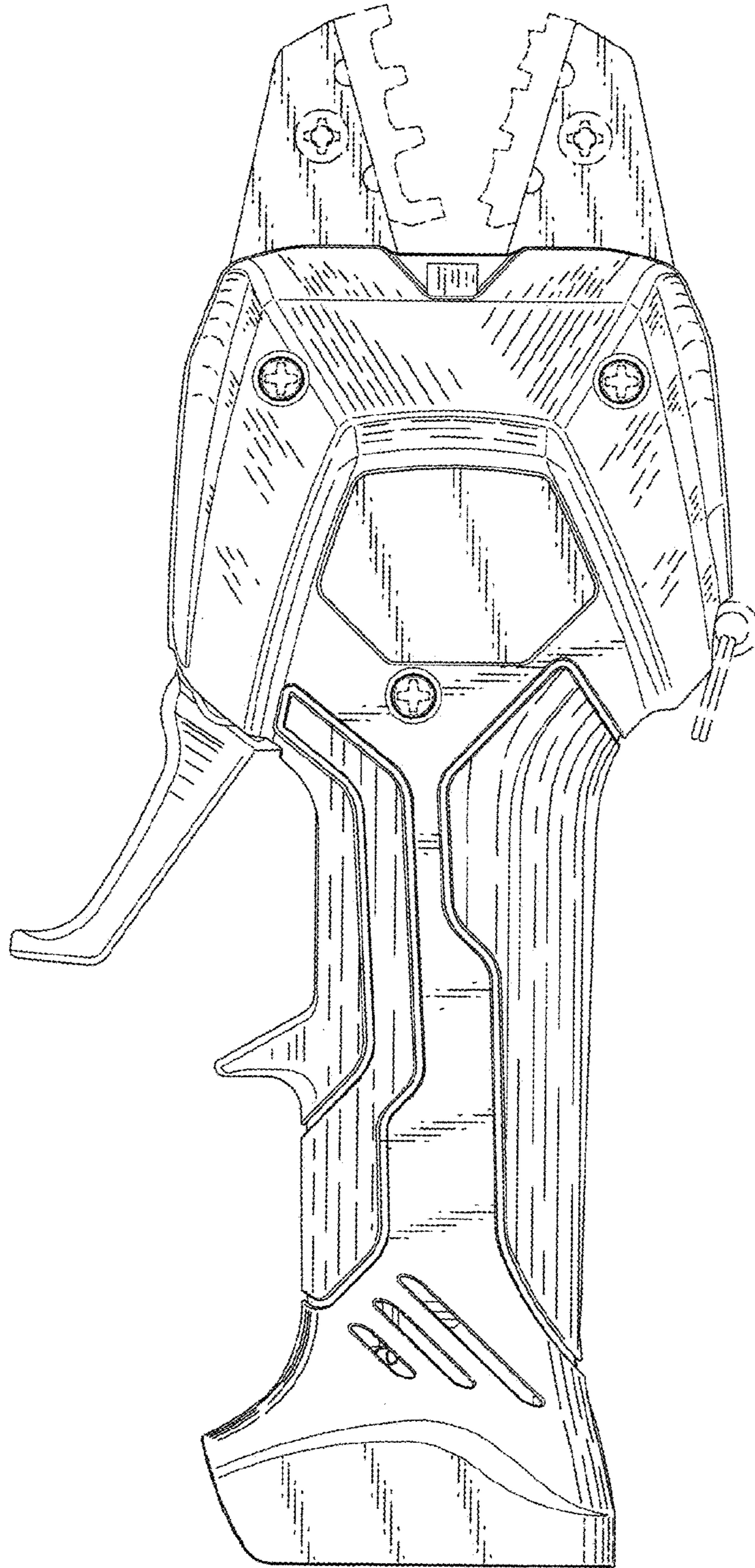

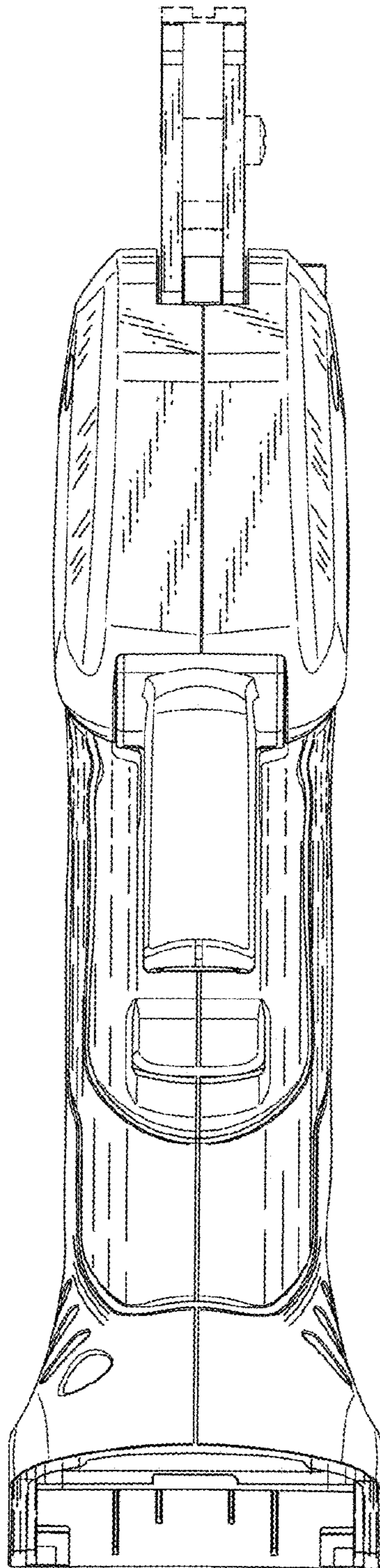

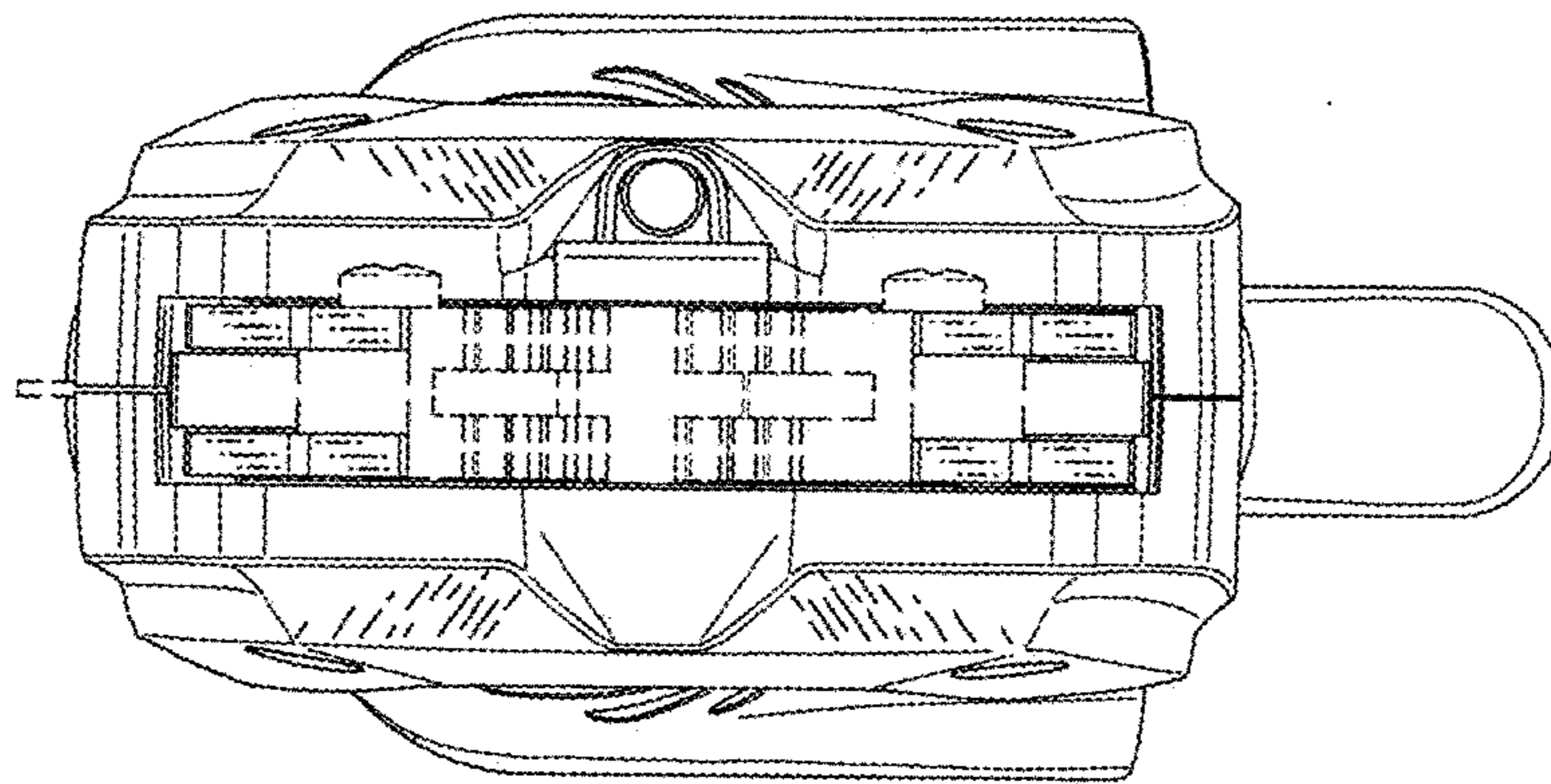

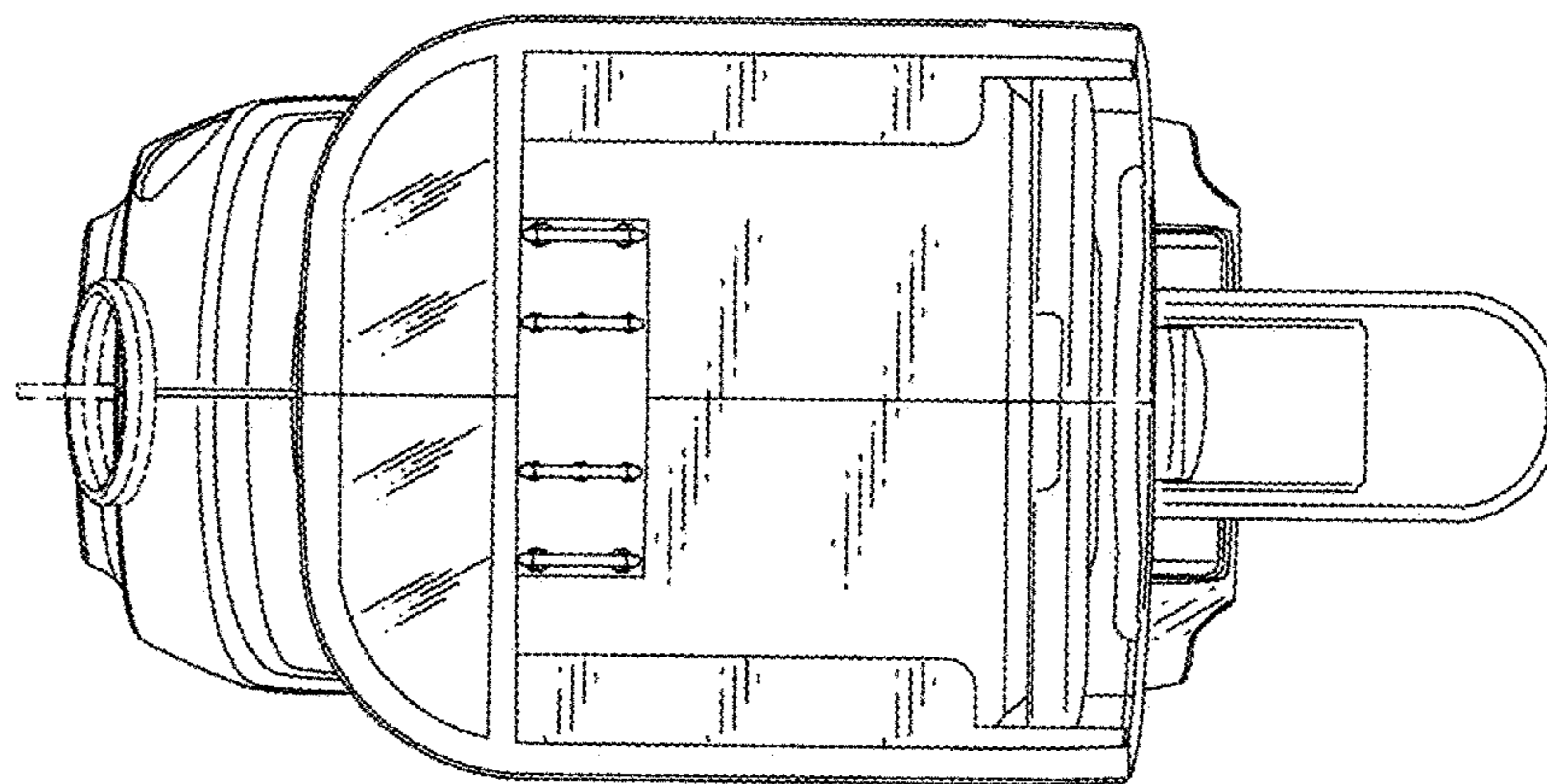
