(57) **CLAIM**

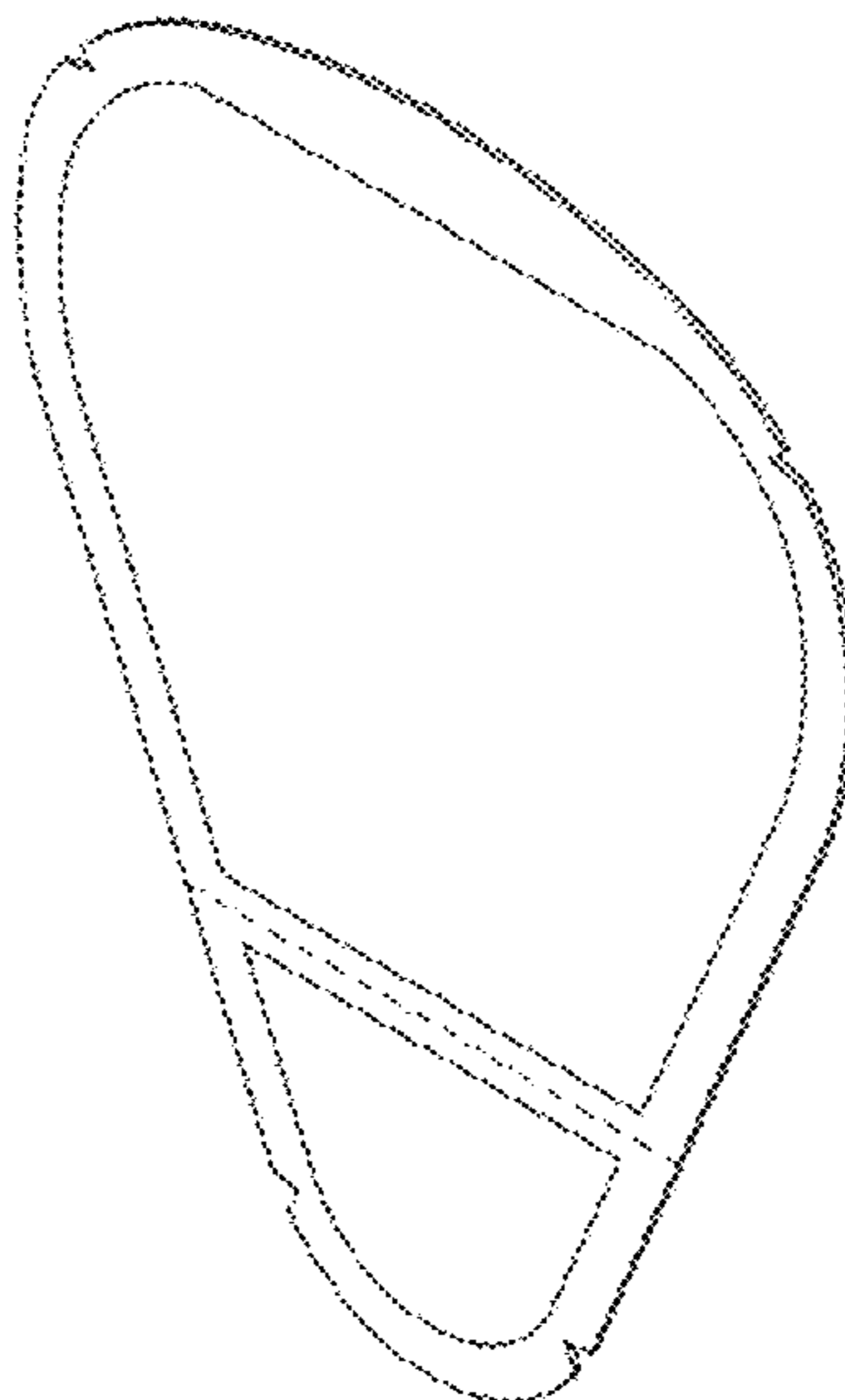
The ornamental design for a pouch for packaging, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pouch for packaging, showing my new design;
FIG. 2 is a front view of the pouch for packaging shown in FIG. 1;
FIG. 3 is a rear view of the pouch for packaging shown in FIG. 1;
FIG. 4 is a left view of the pouch for packaging shown in FIG. 1;
FIG. 5 is a right view of the pouch for packaging shown in FIG. 1;
FIG. 6 is a top view of the pouch for packaging shown in FIG. 1; and,
FIG. 7 is a bottom view of the pouch for packaging shown in FIG. 1.

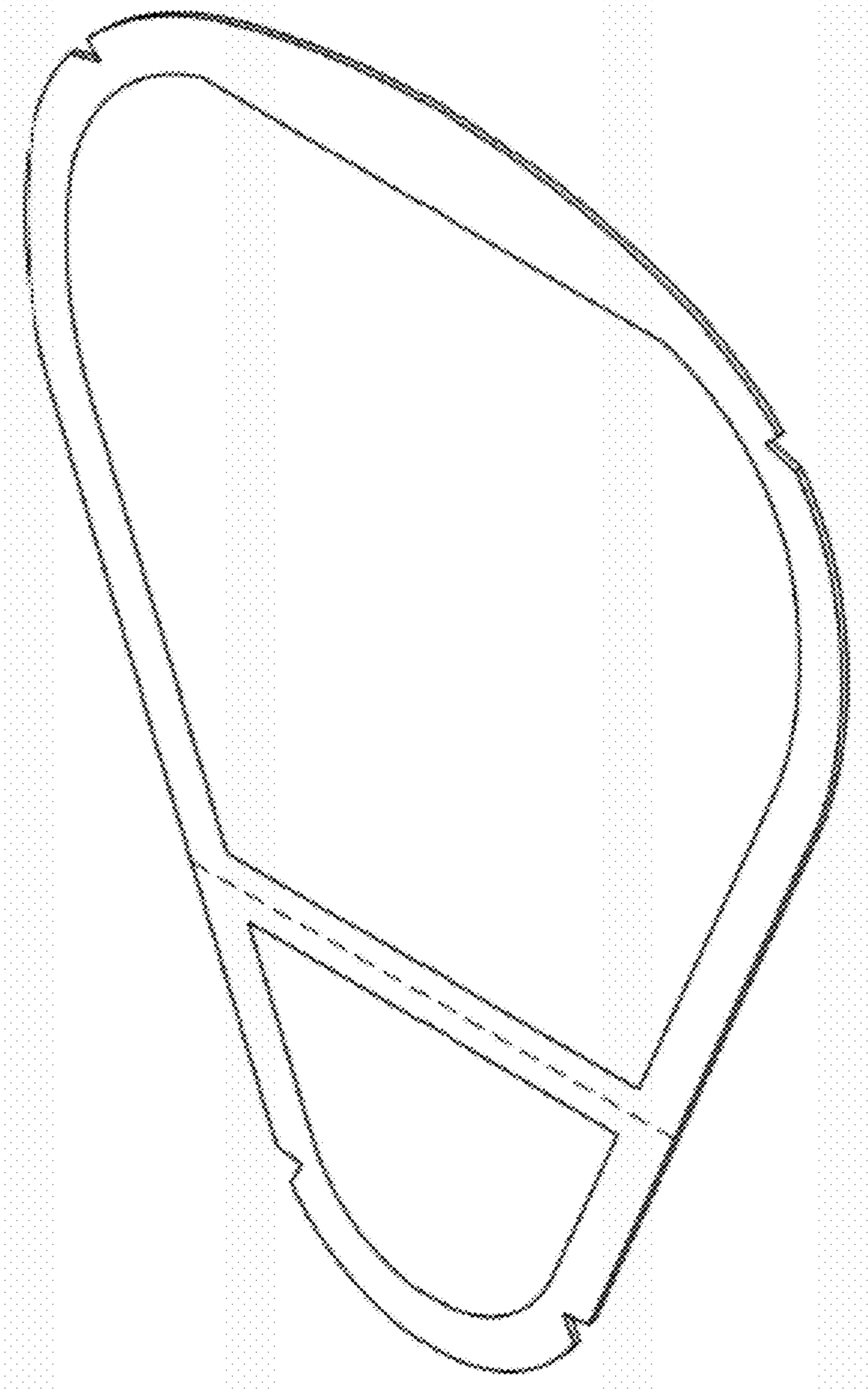

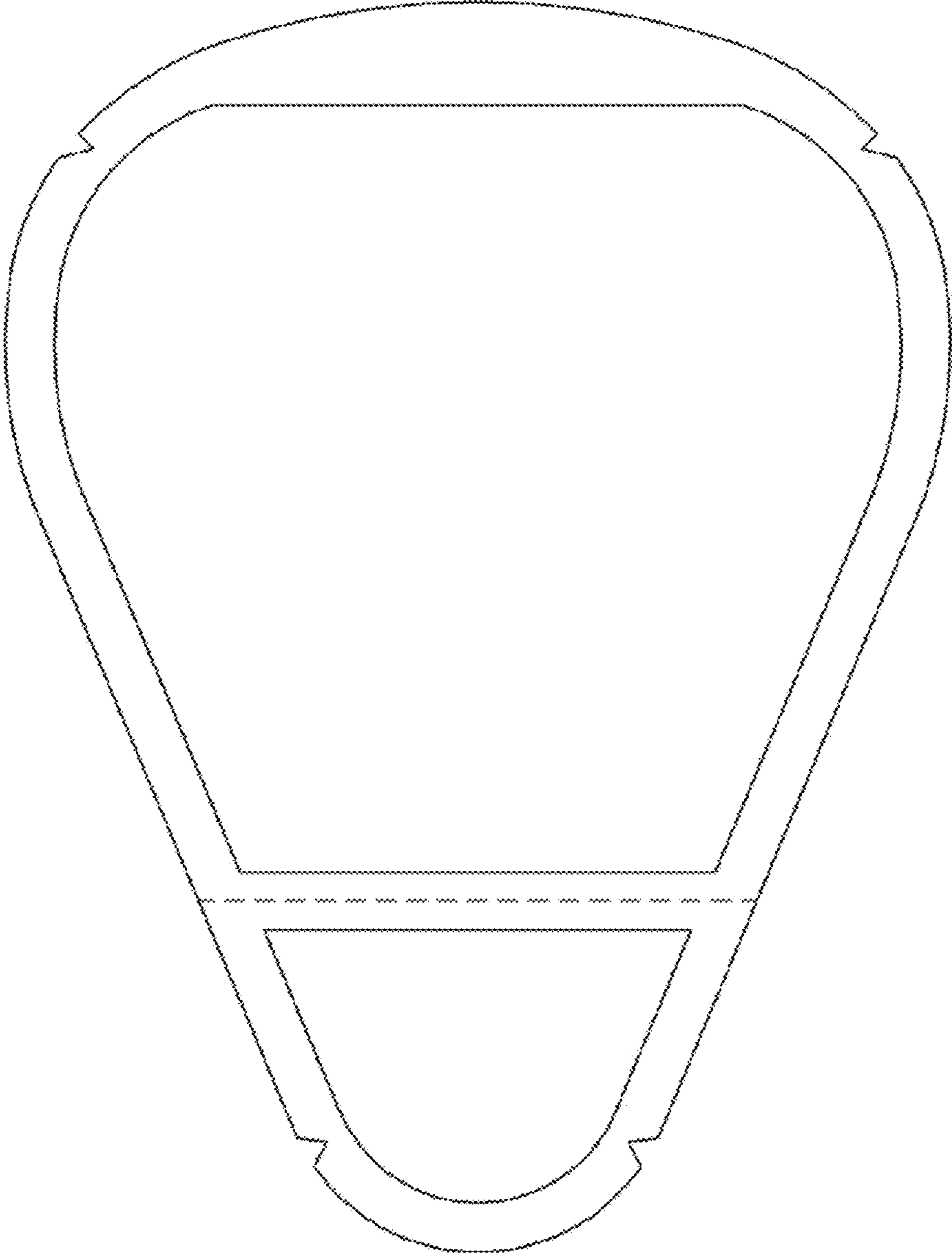

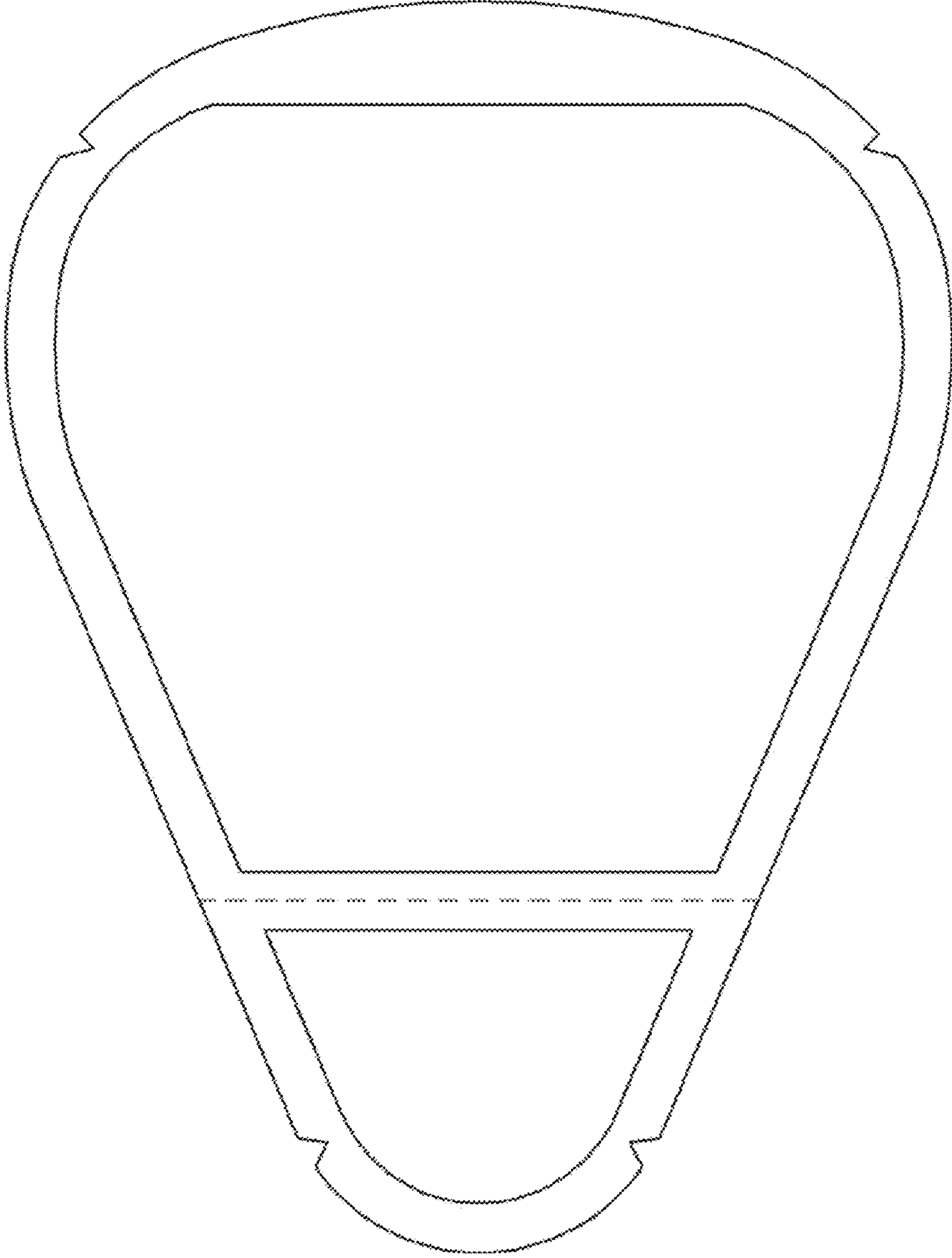

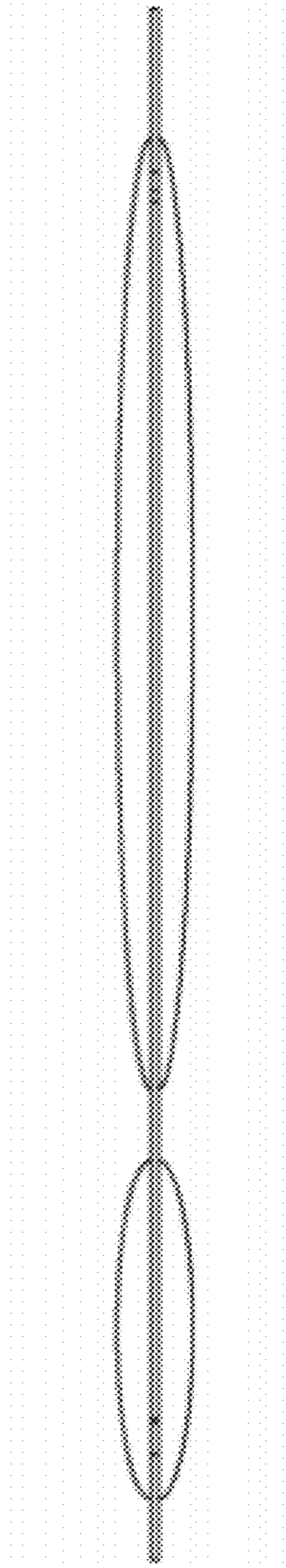

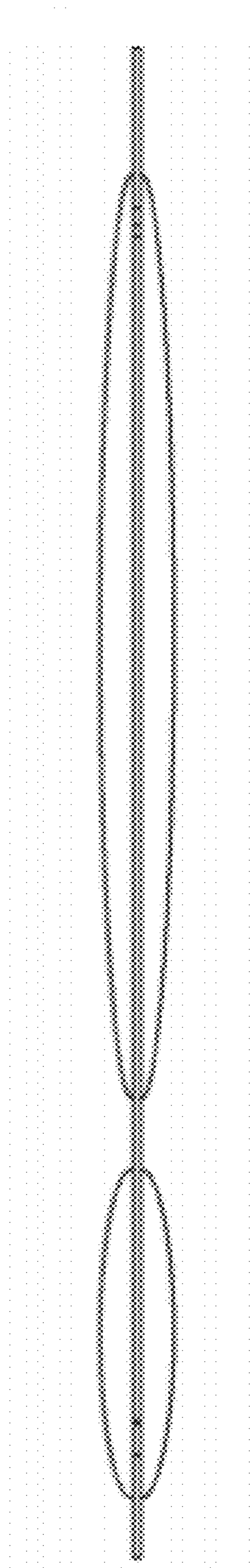

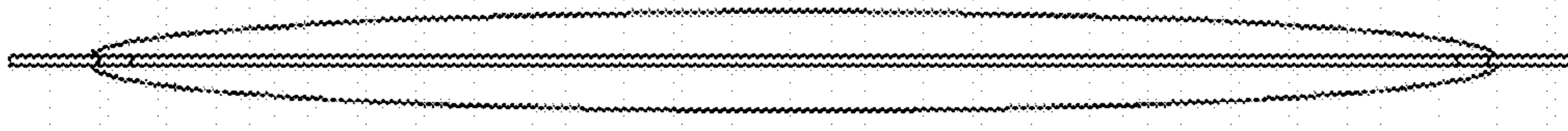

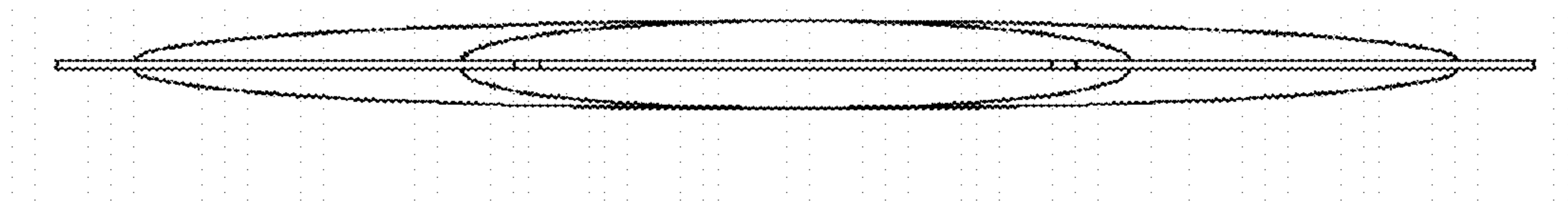
