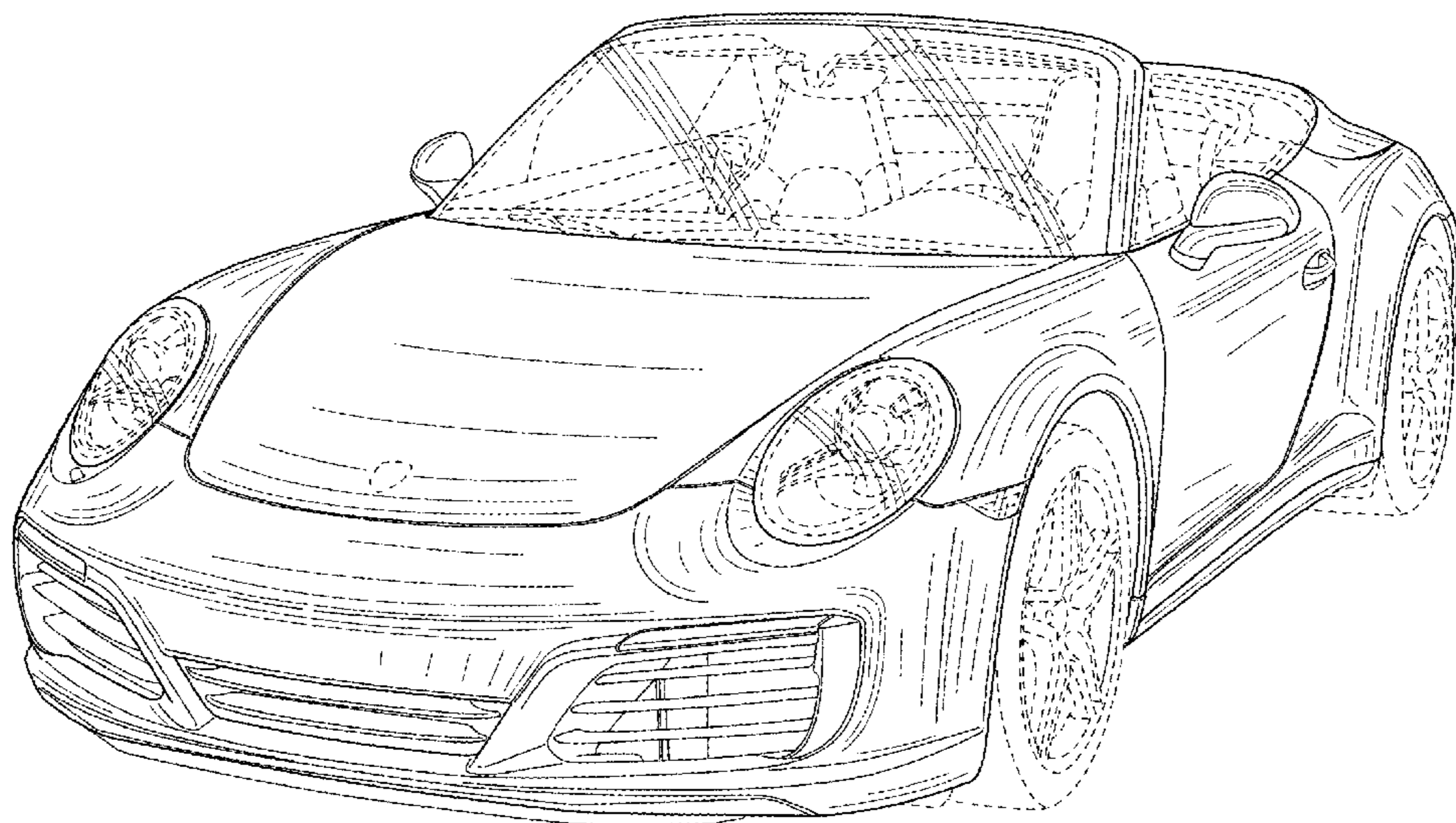
FIG. 11 is a side elevational view taken from the right side in FIG. 8;

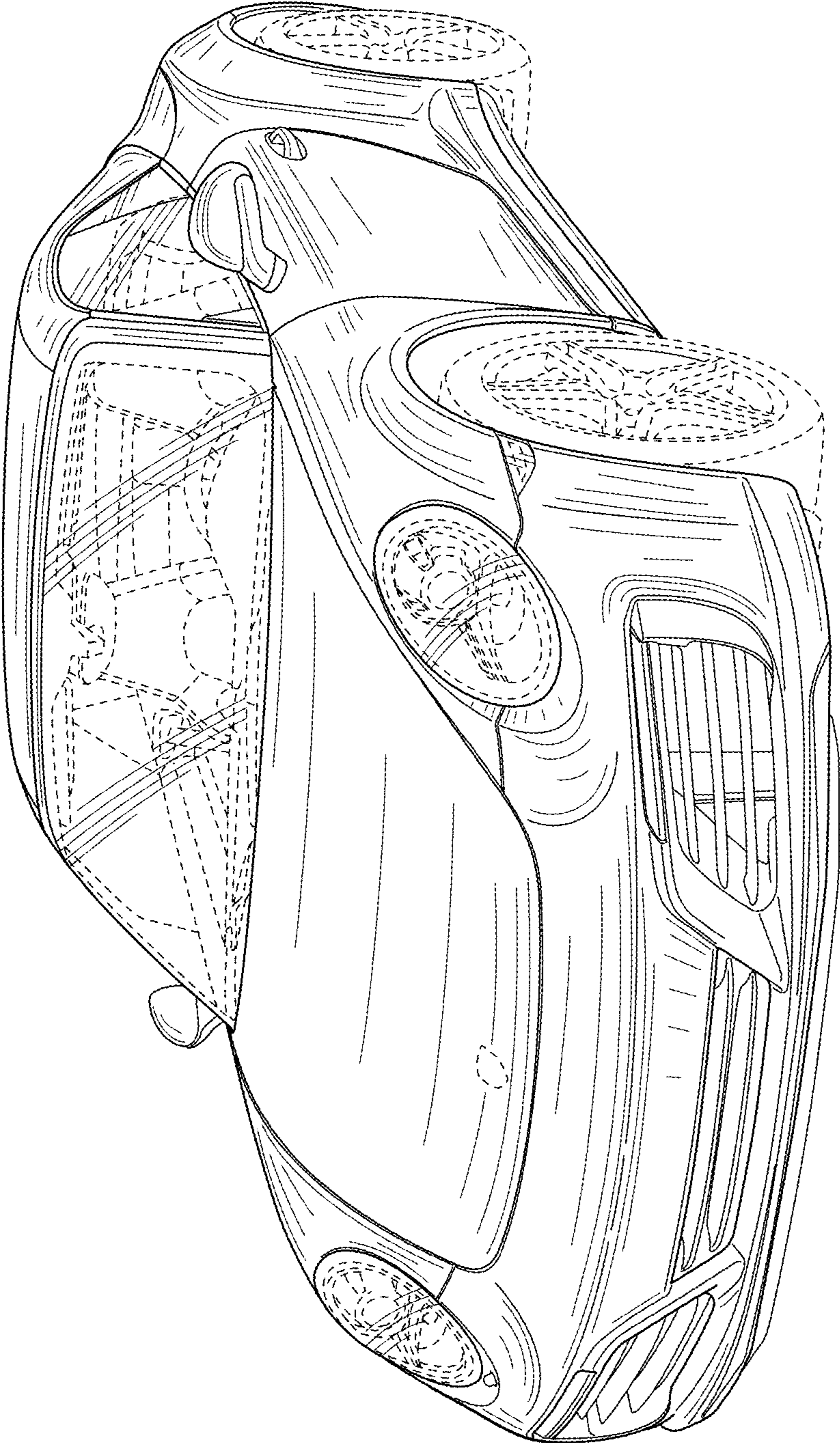
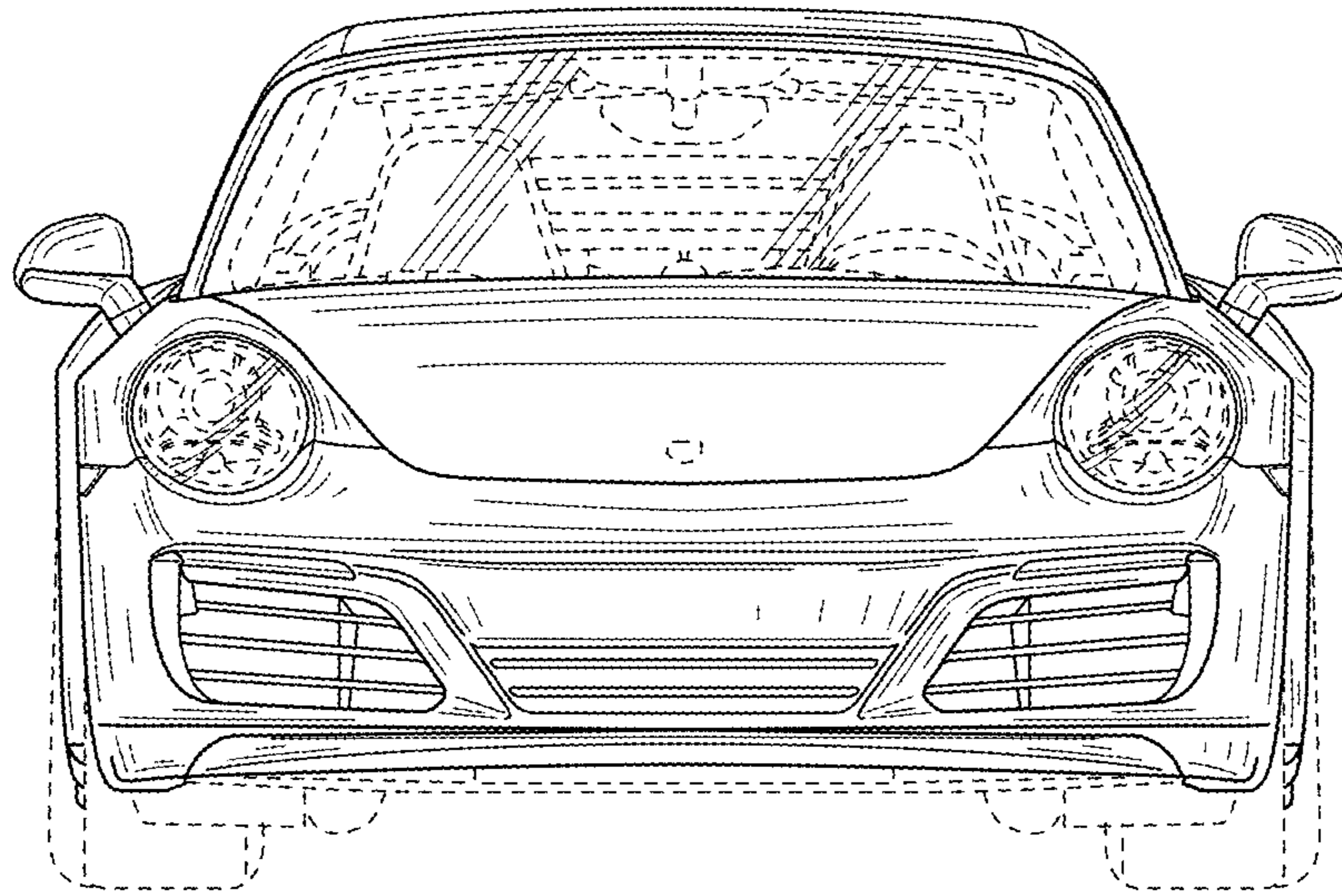
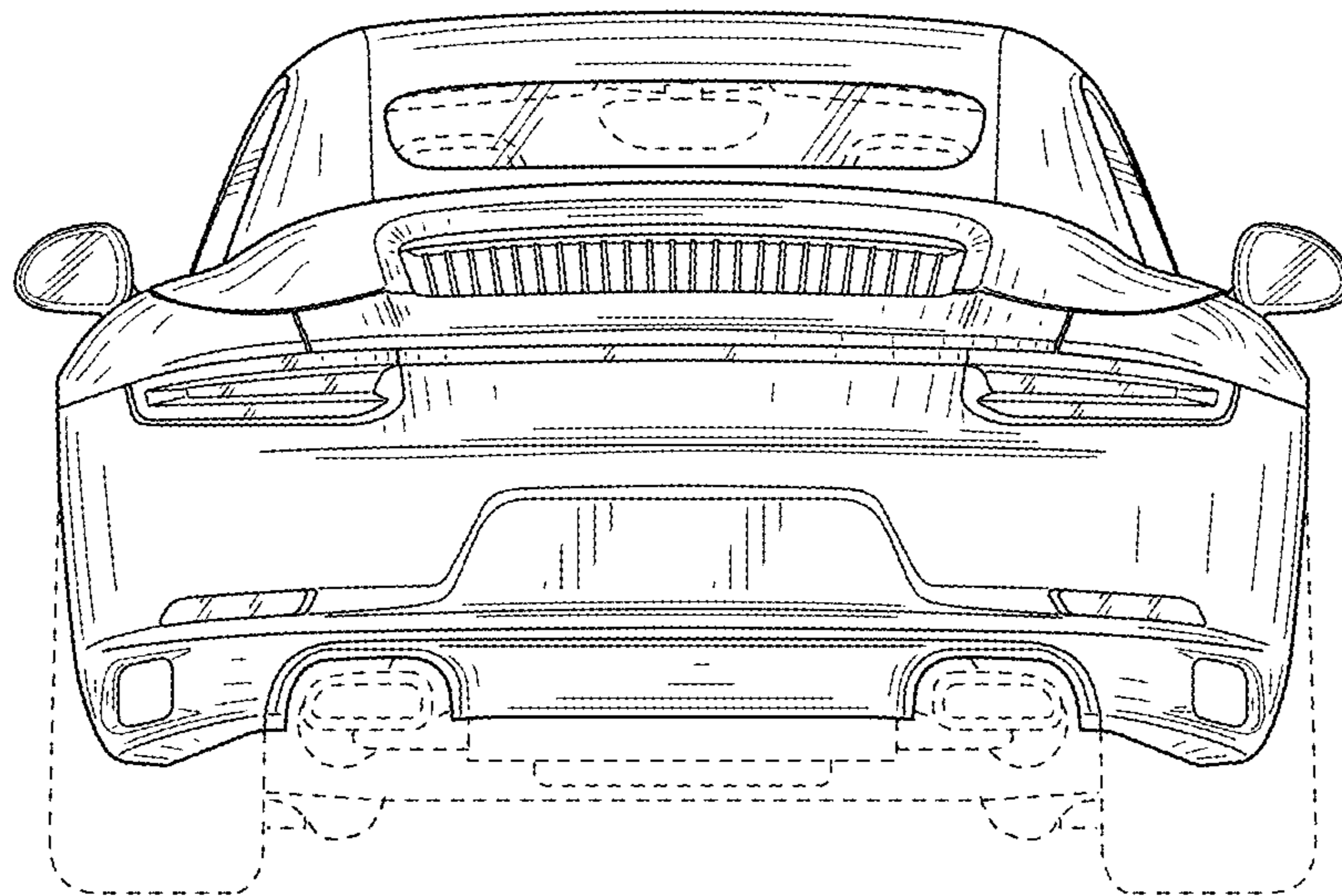

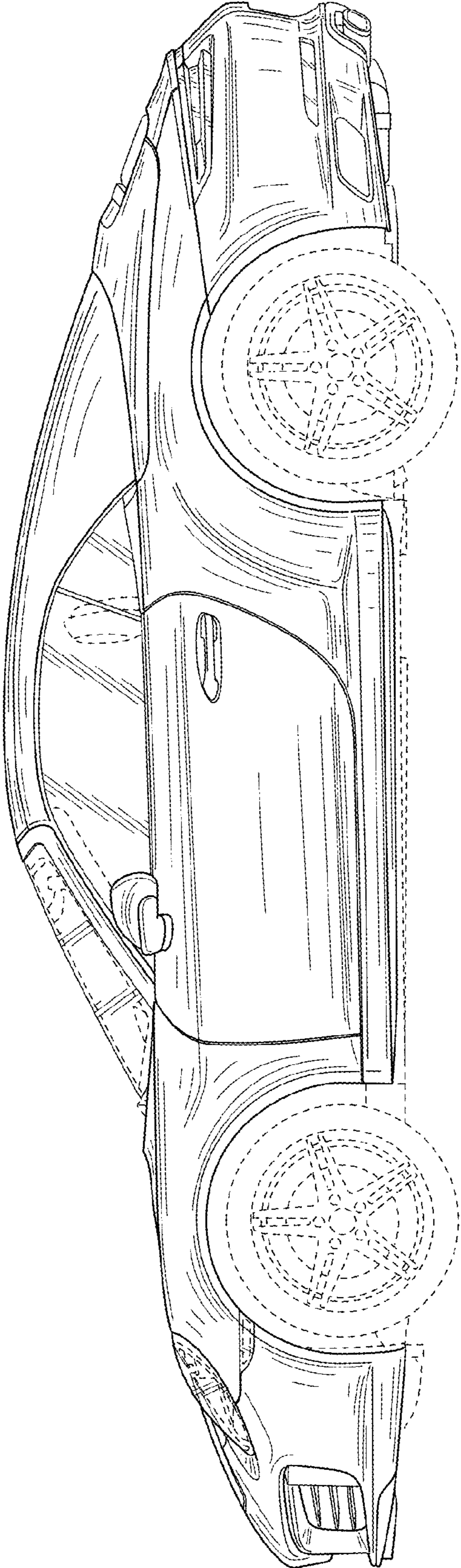

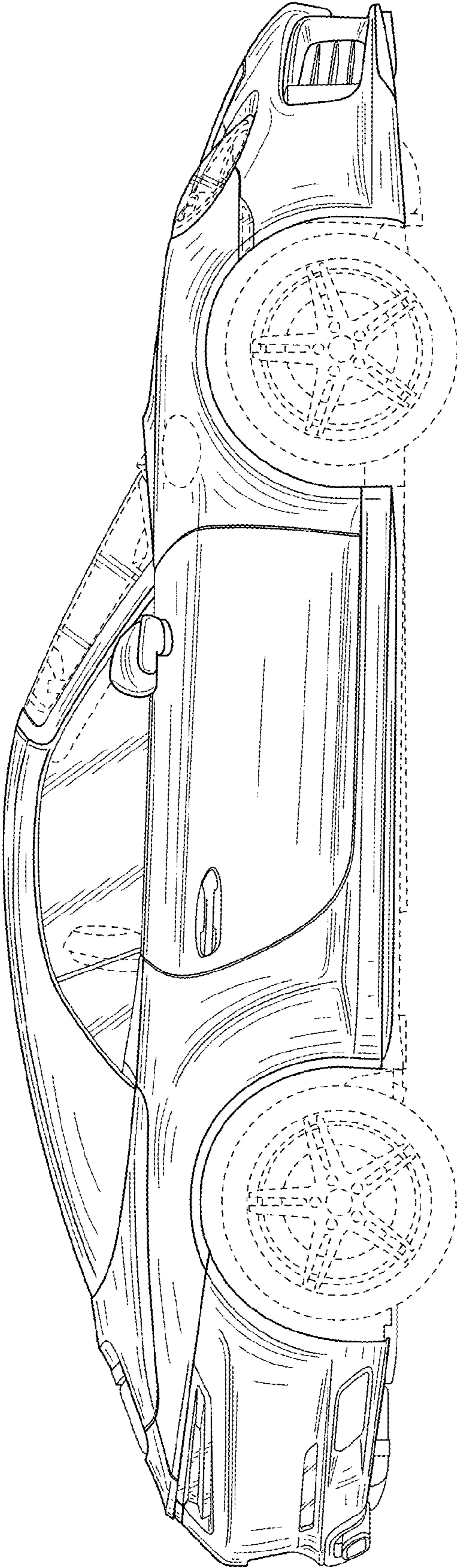

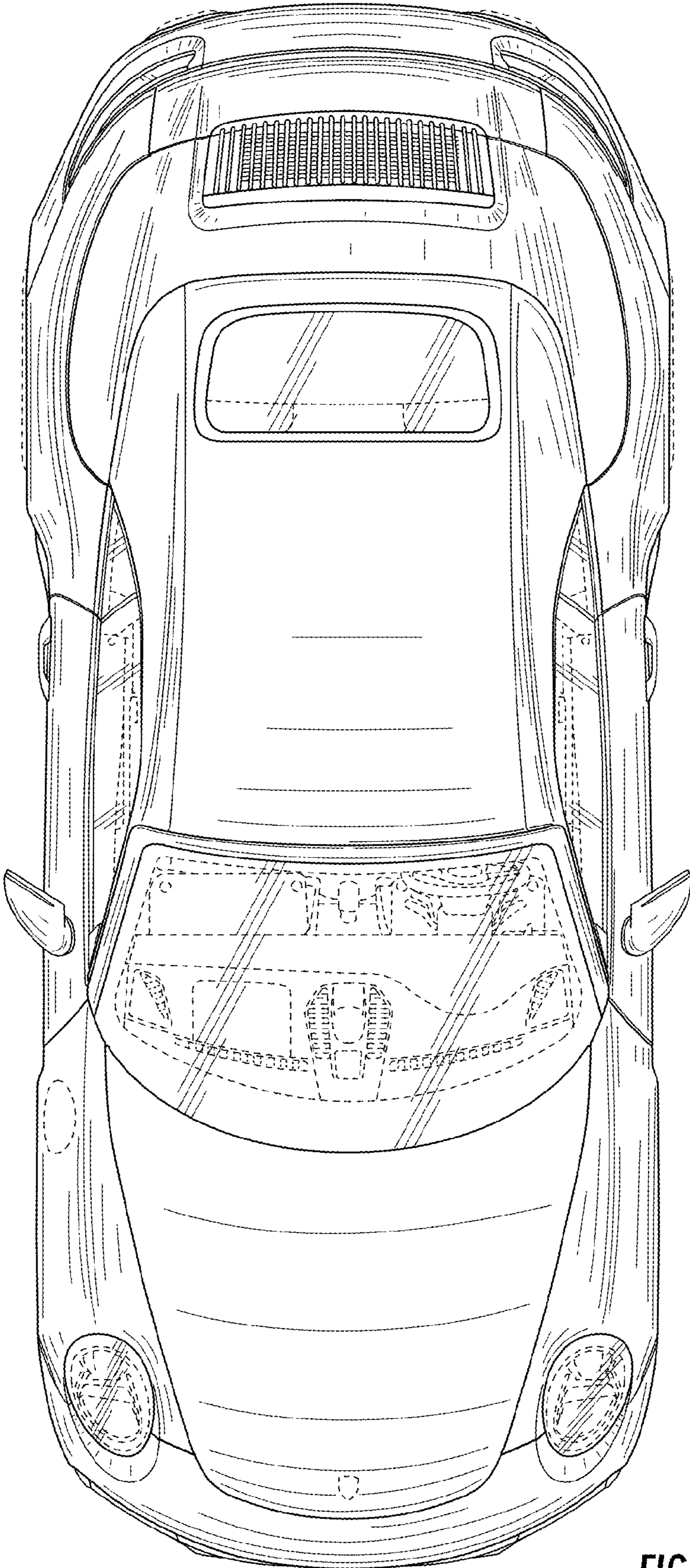

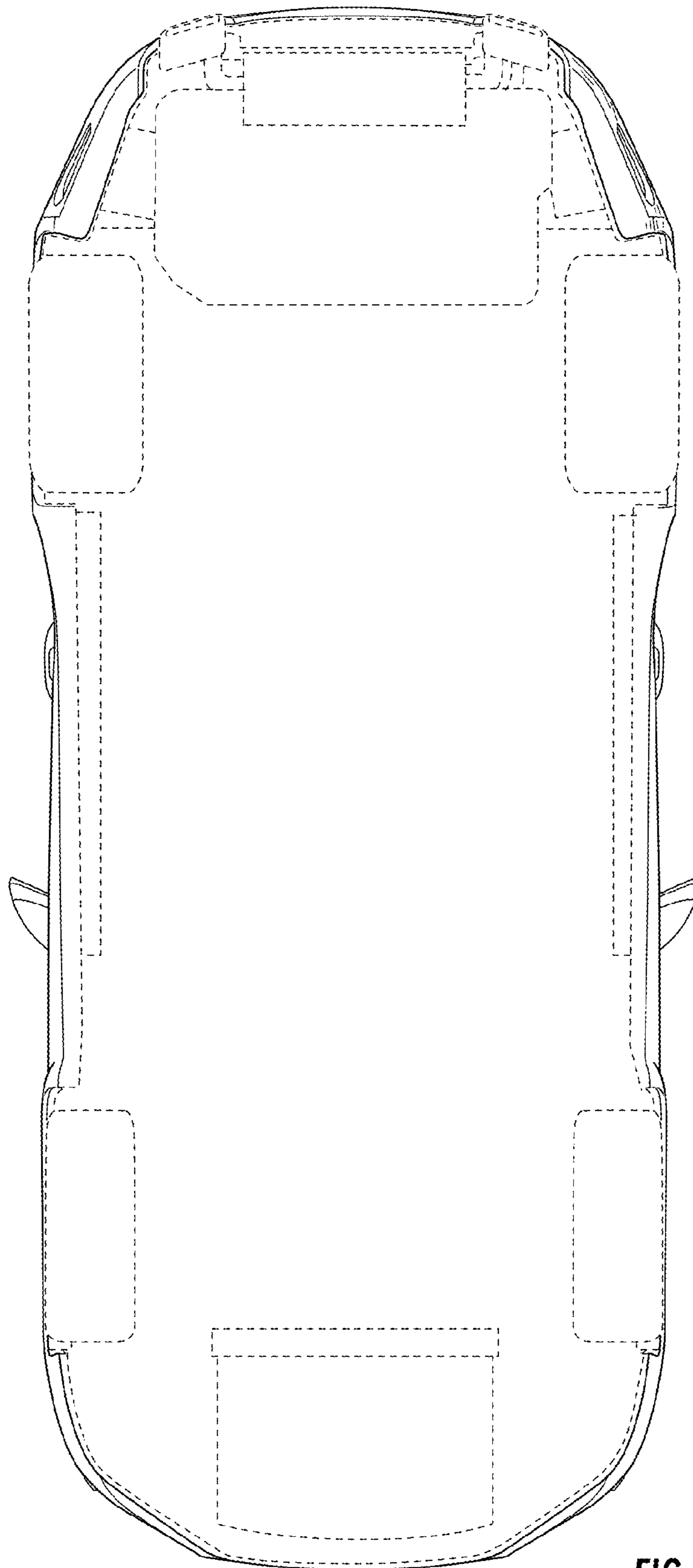

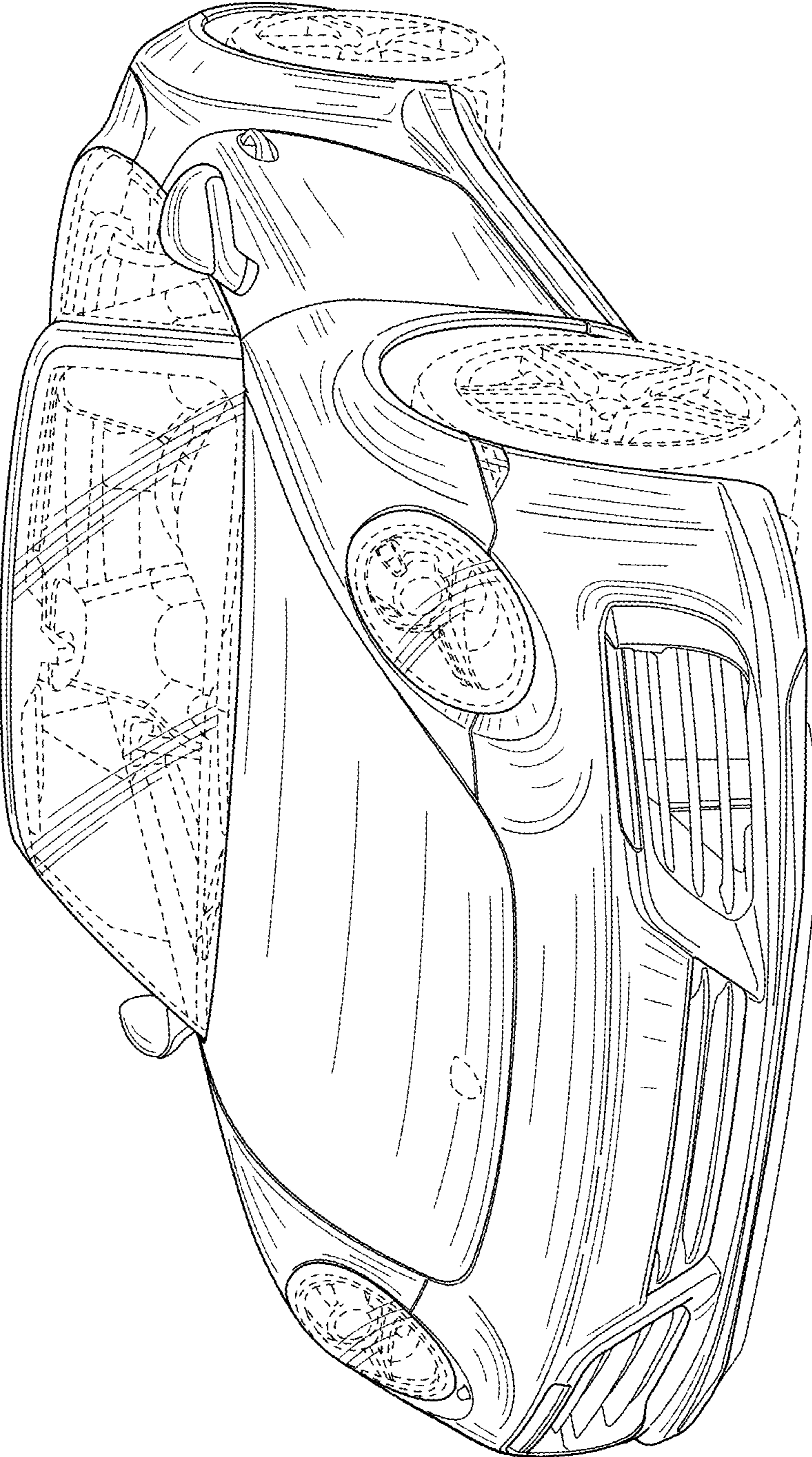
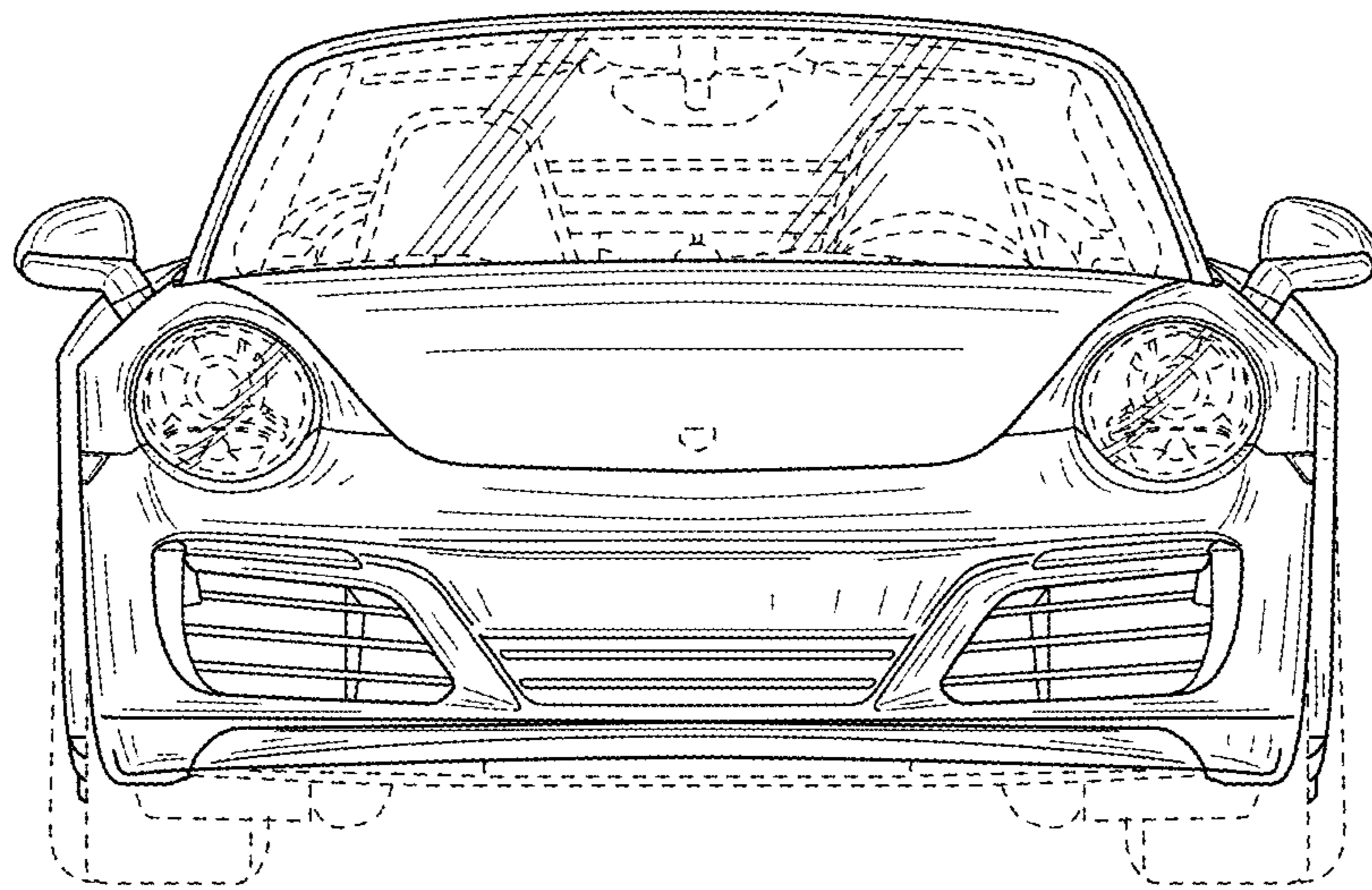
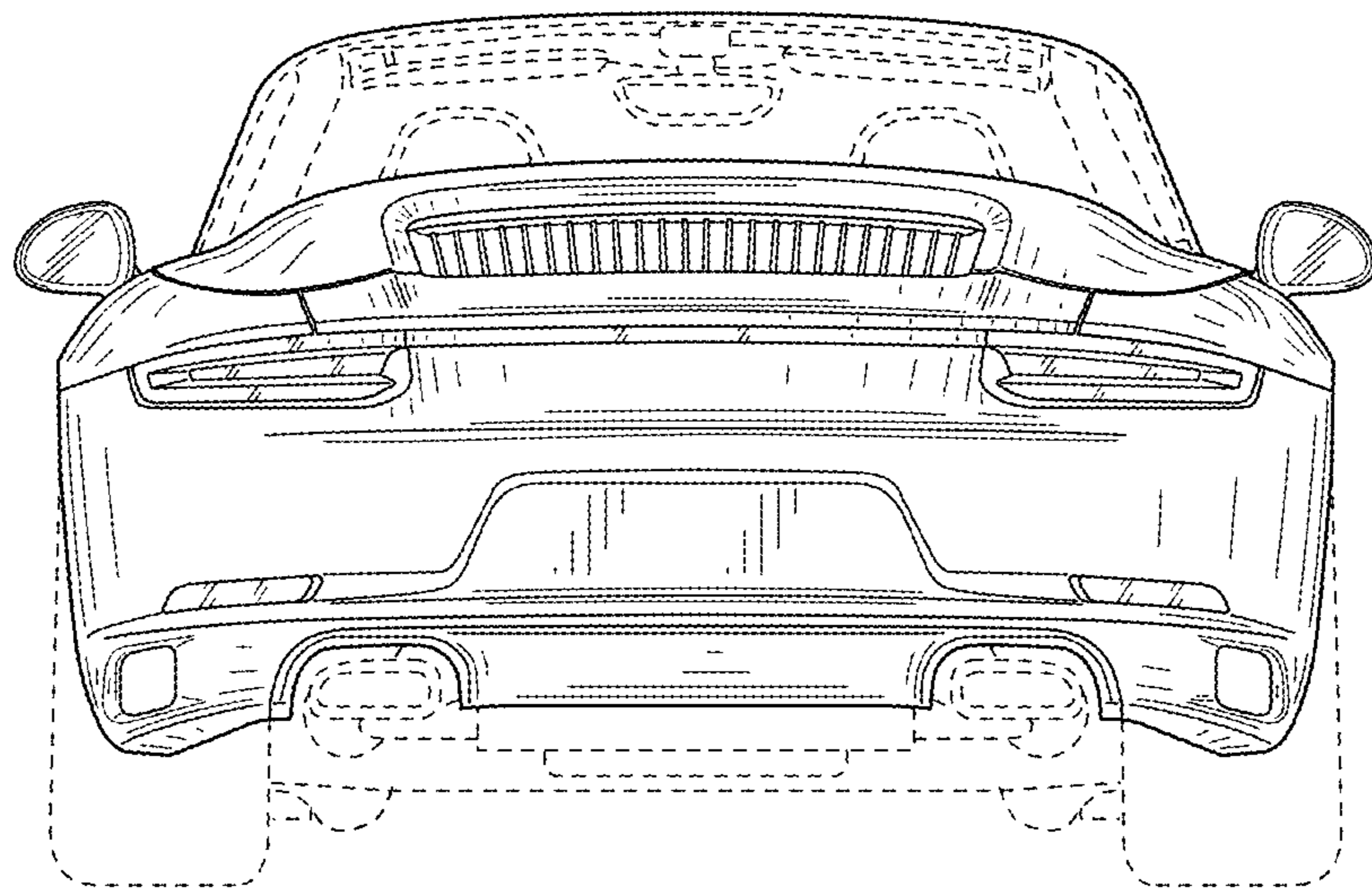

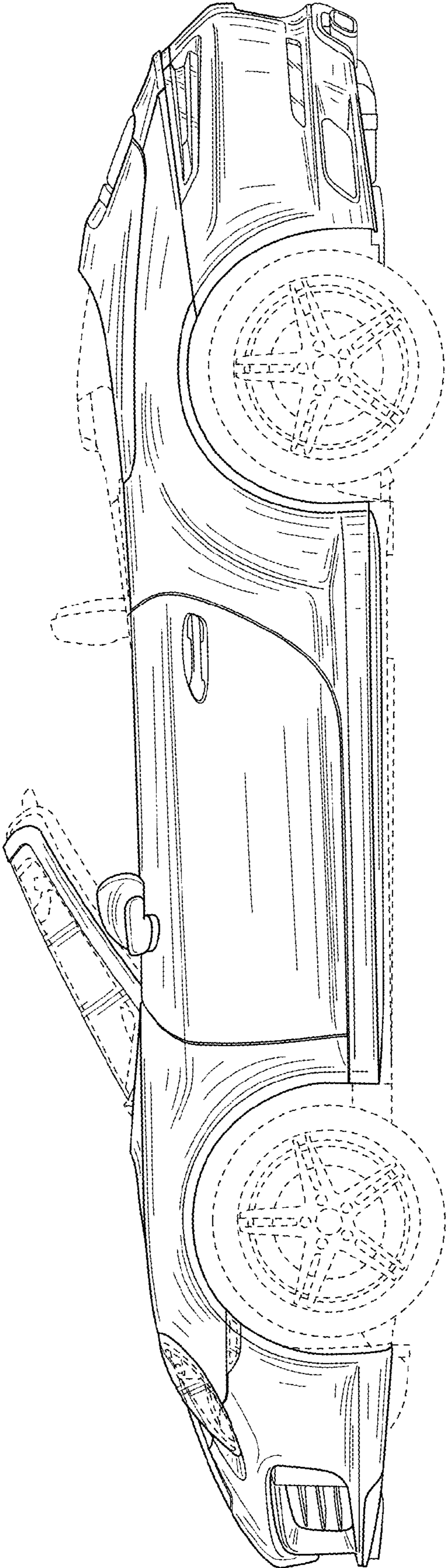

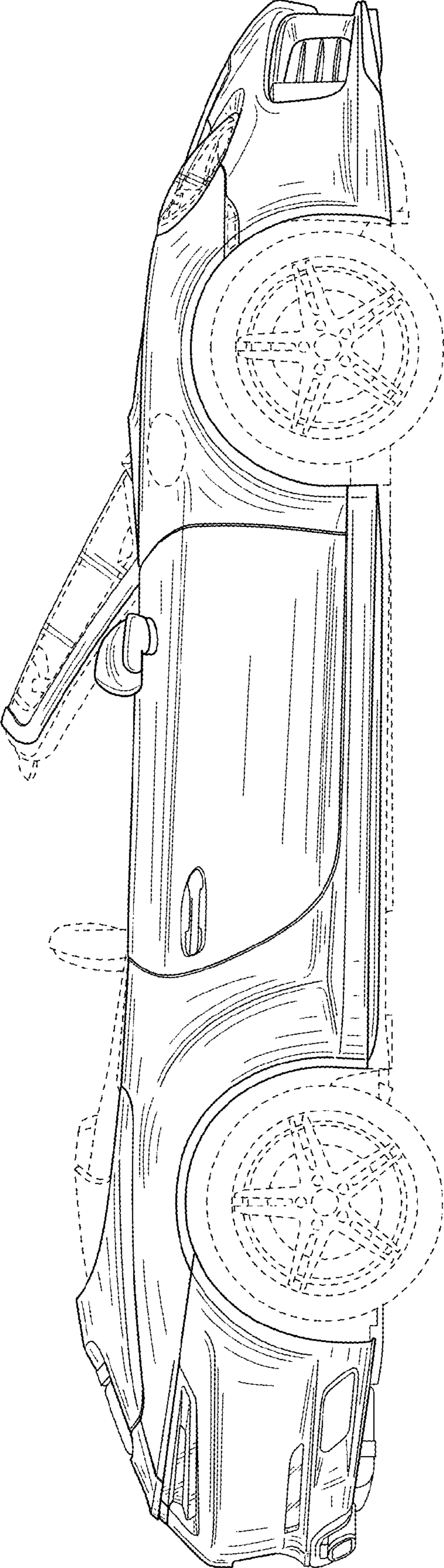

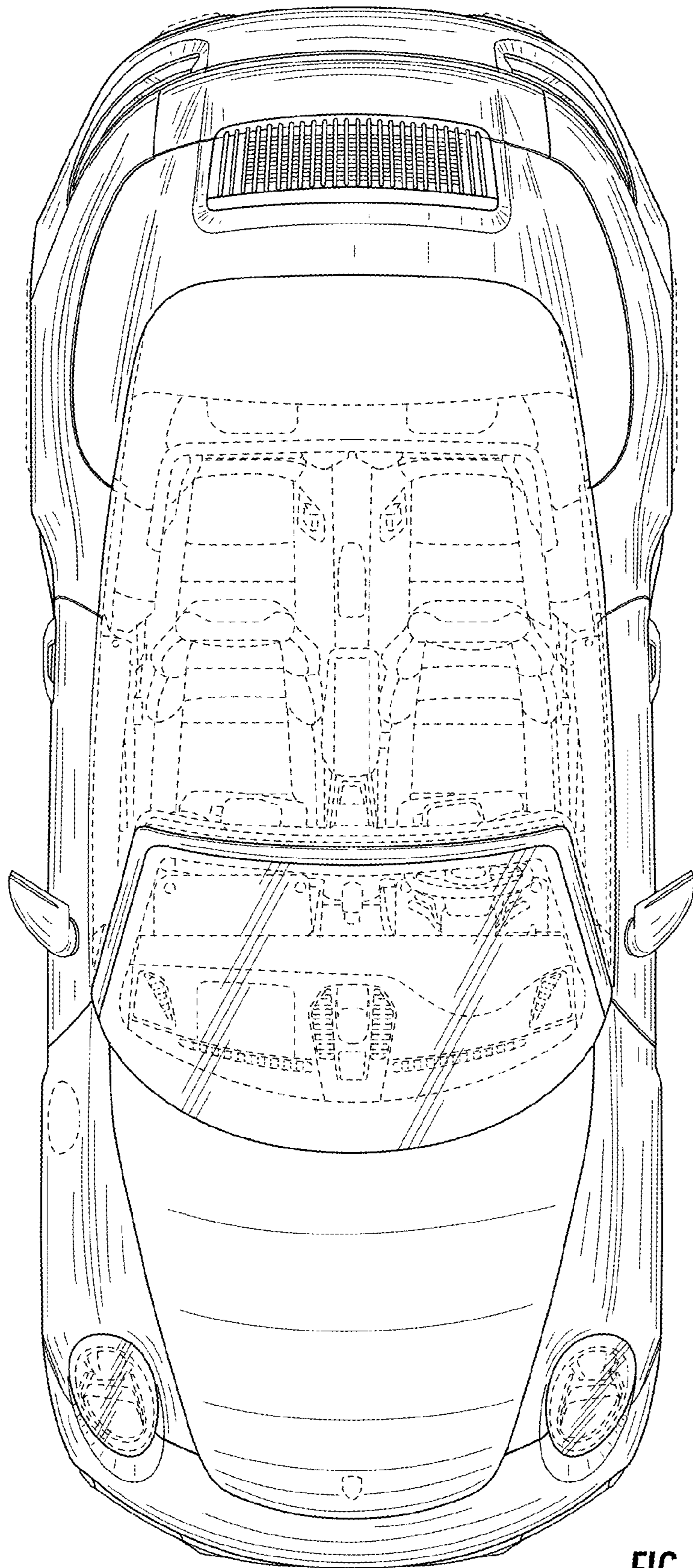
